(57) **CLAIM**

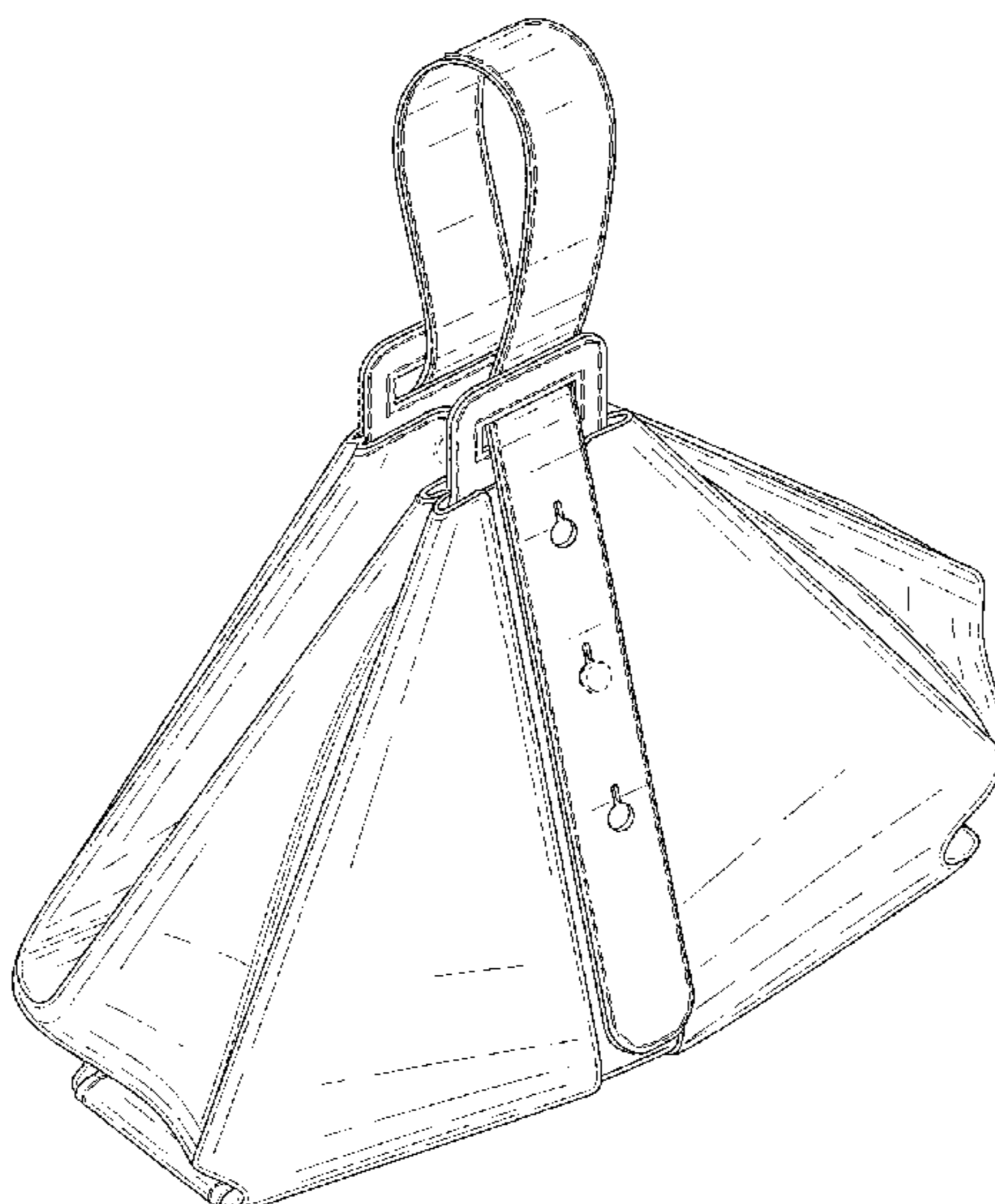
The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a handbag showing my new design, in a closed position; FIG. 2 is a front view of the handbag of FIG. 1, shown in an alternate open position; FIG. 3 is a back view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view of thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom view thereof.

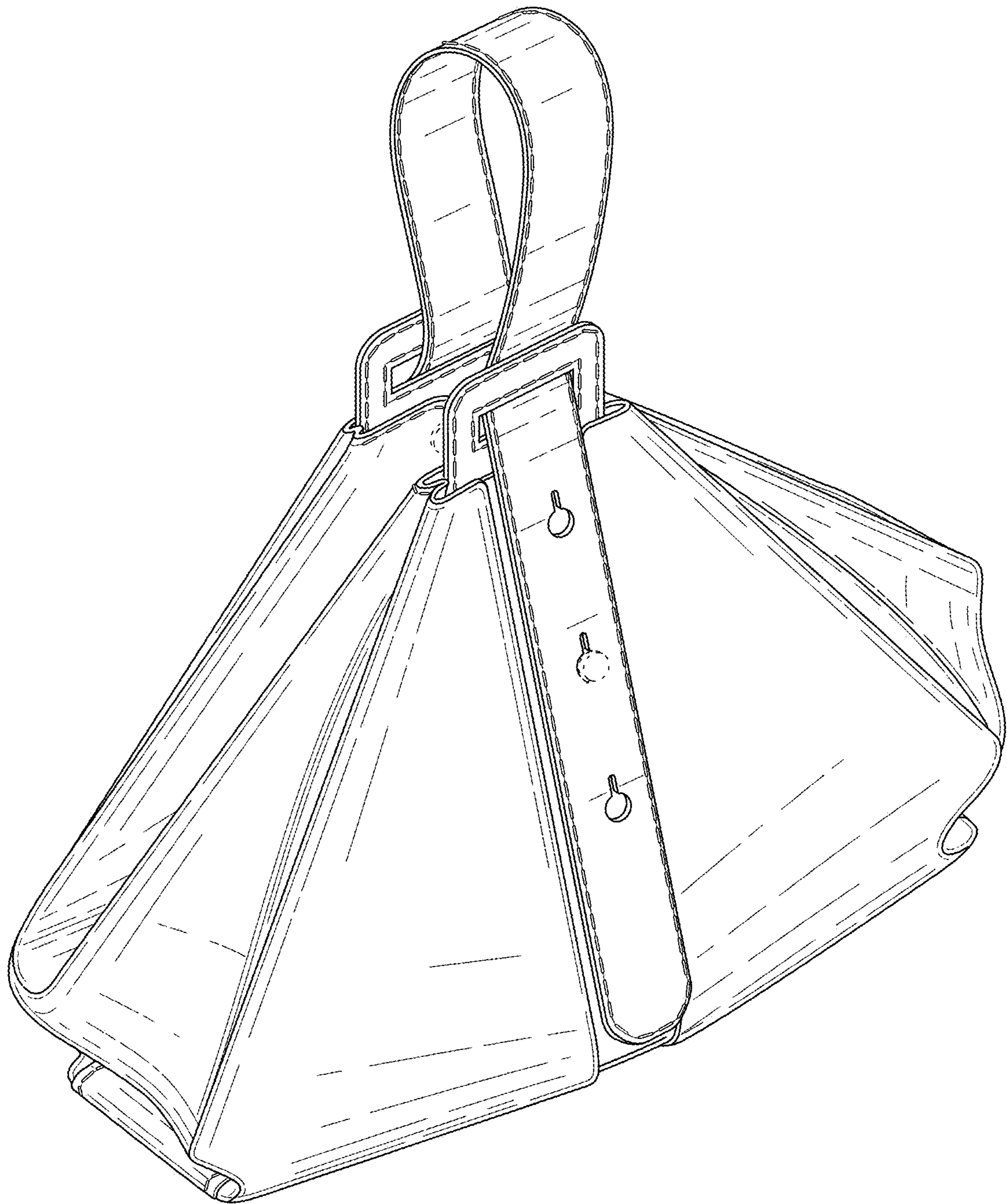

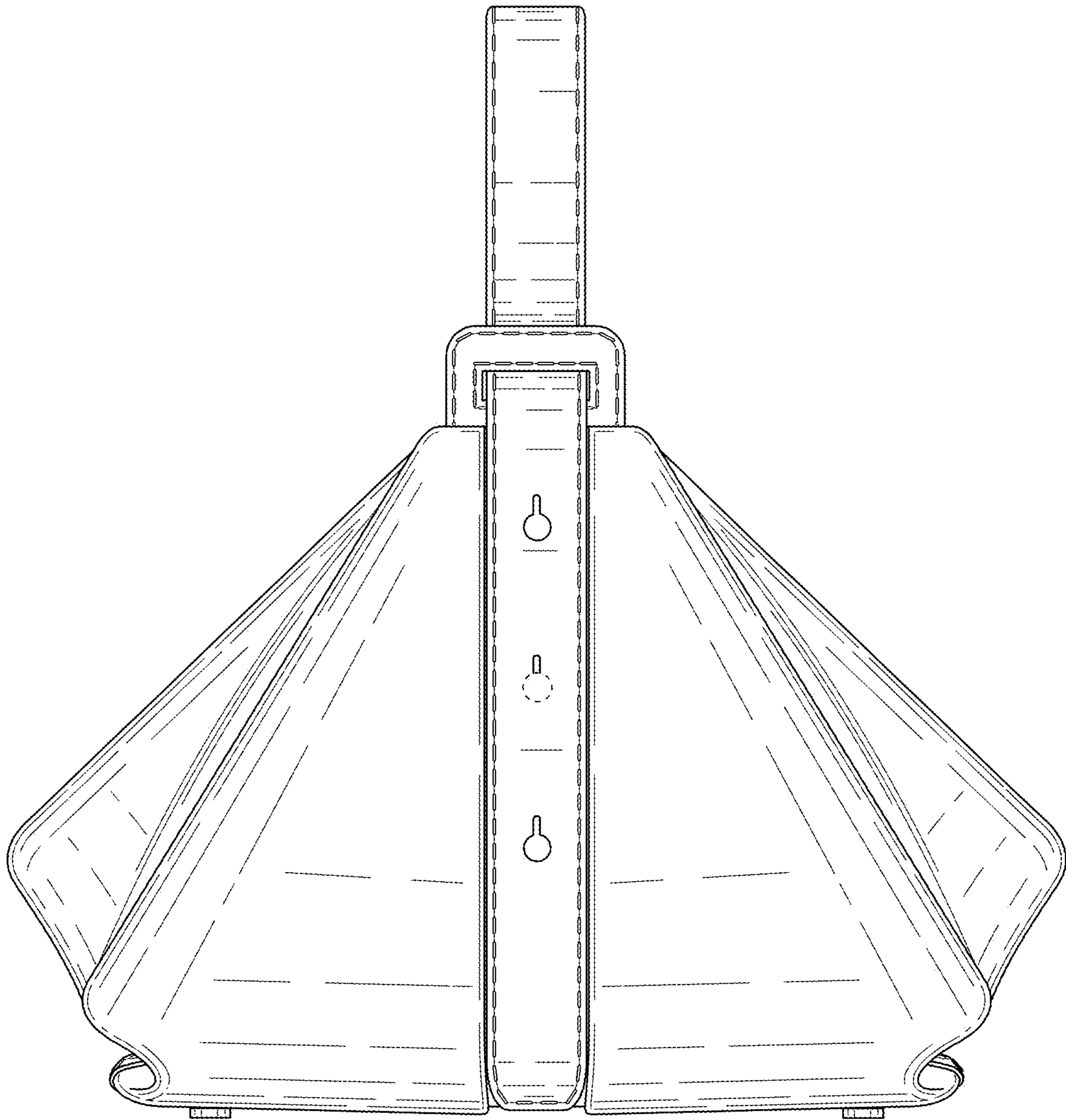

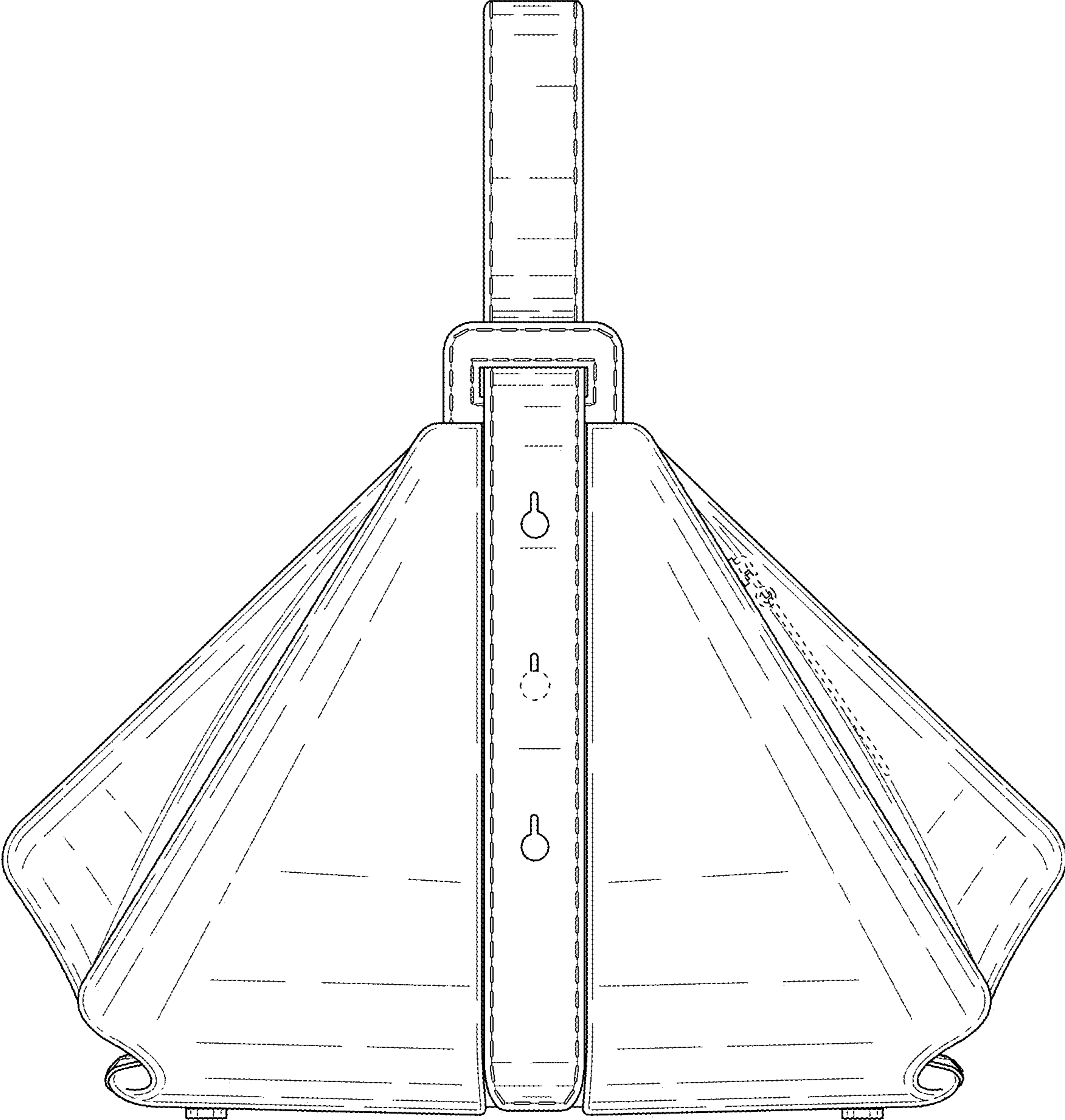

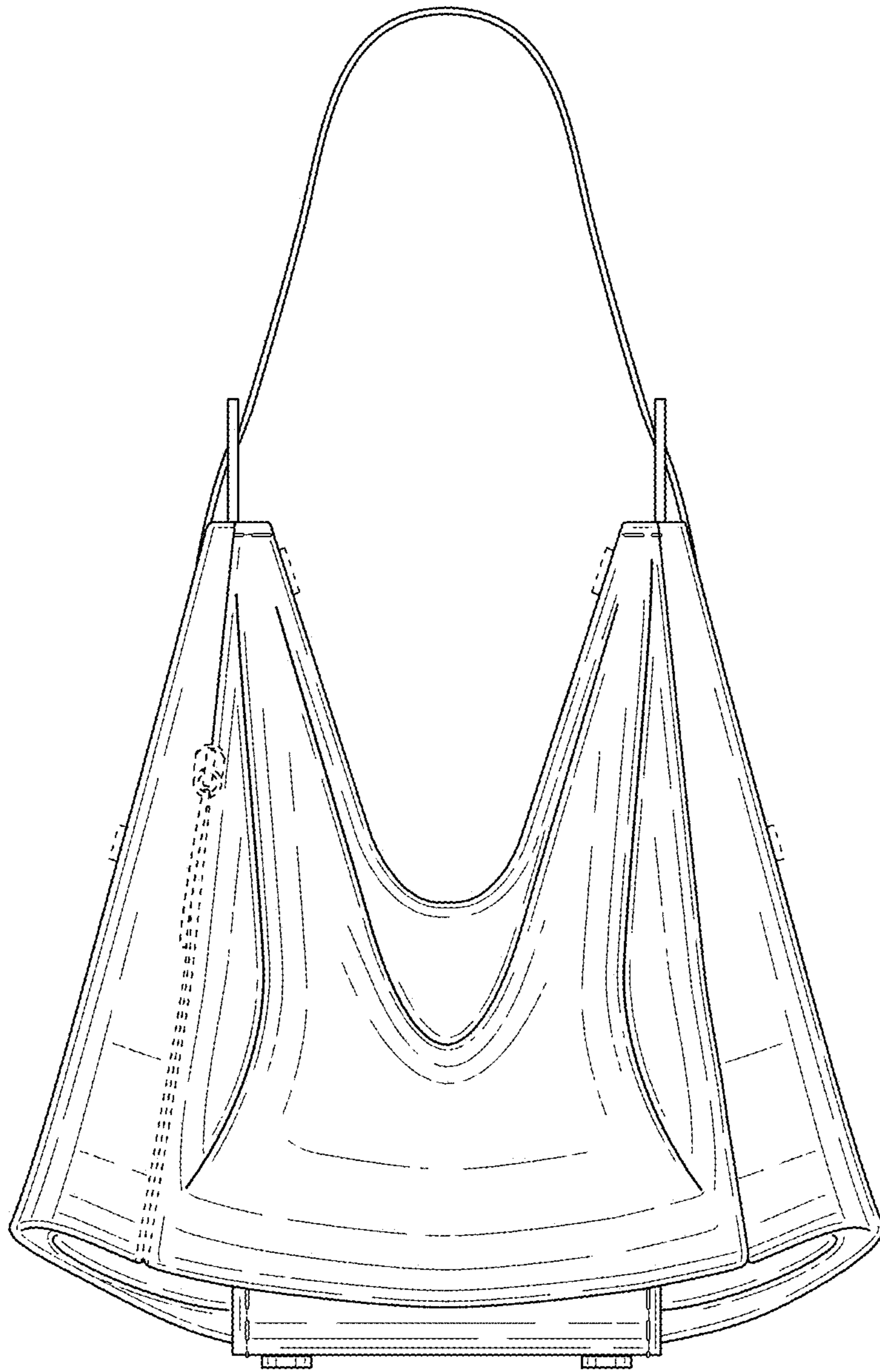

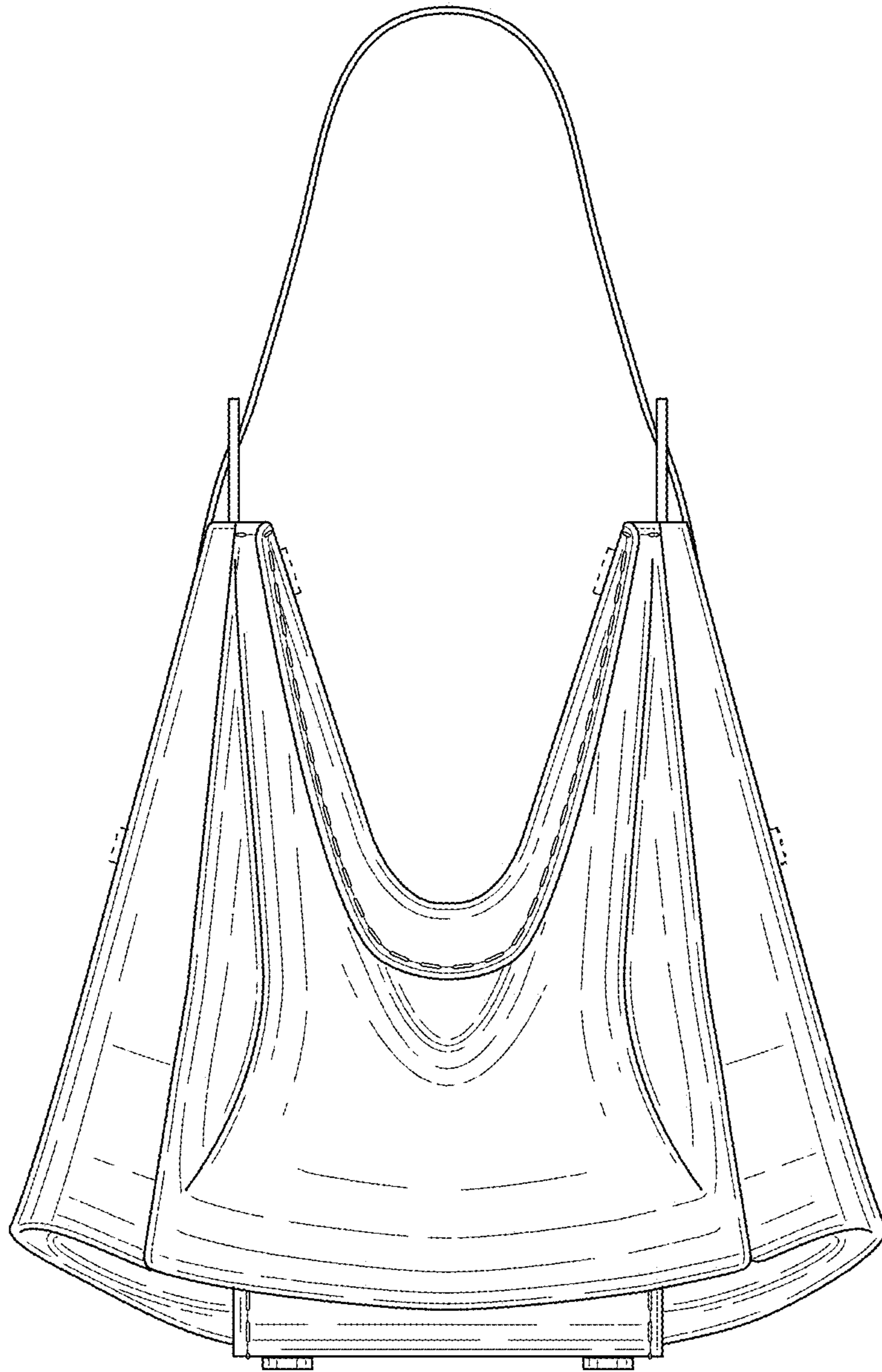

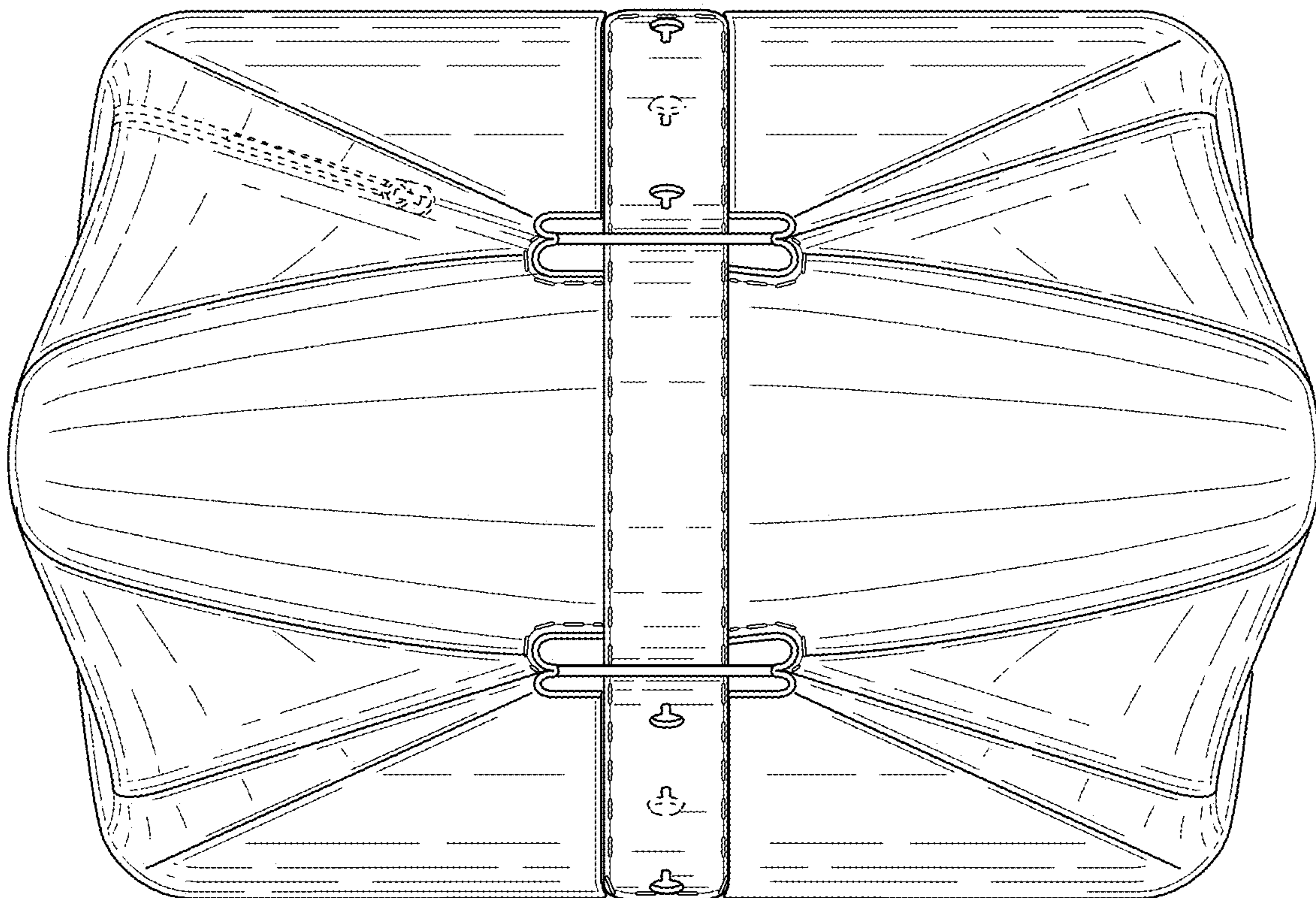

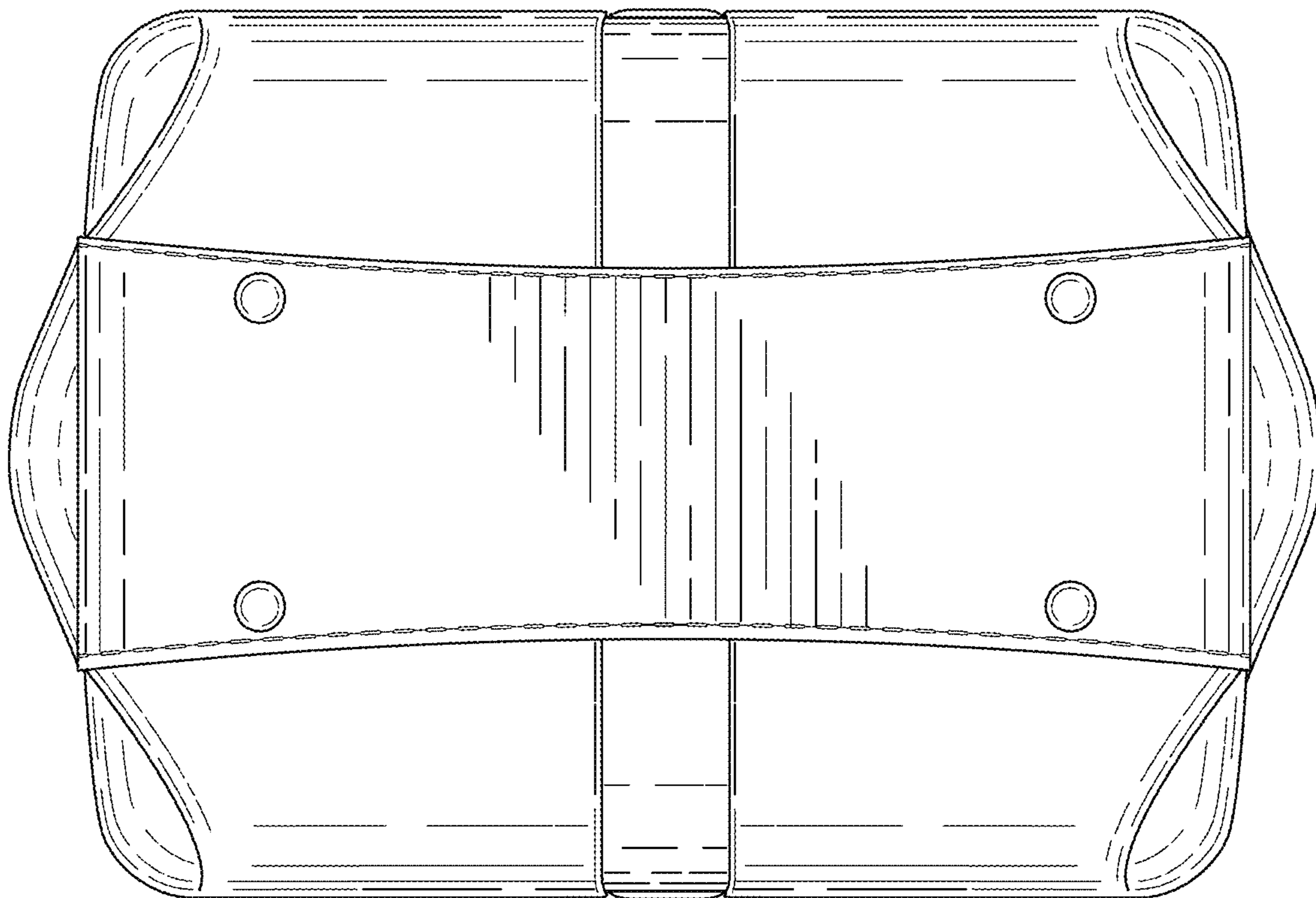
