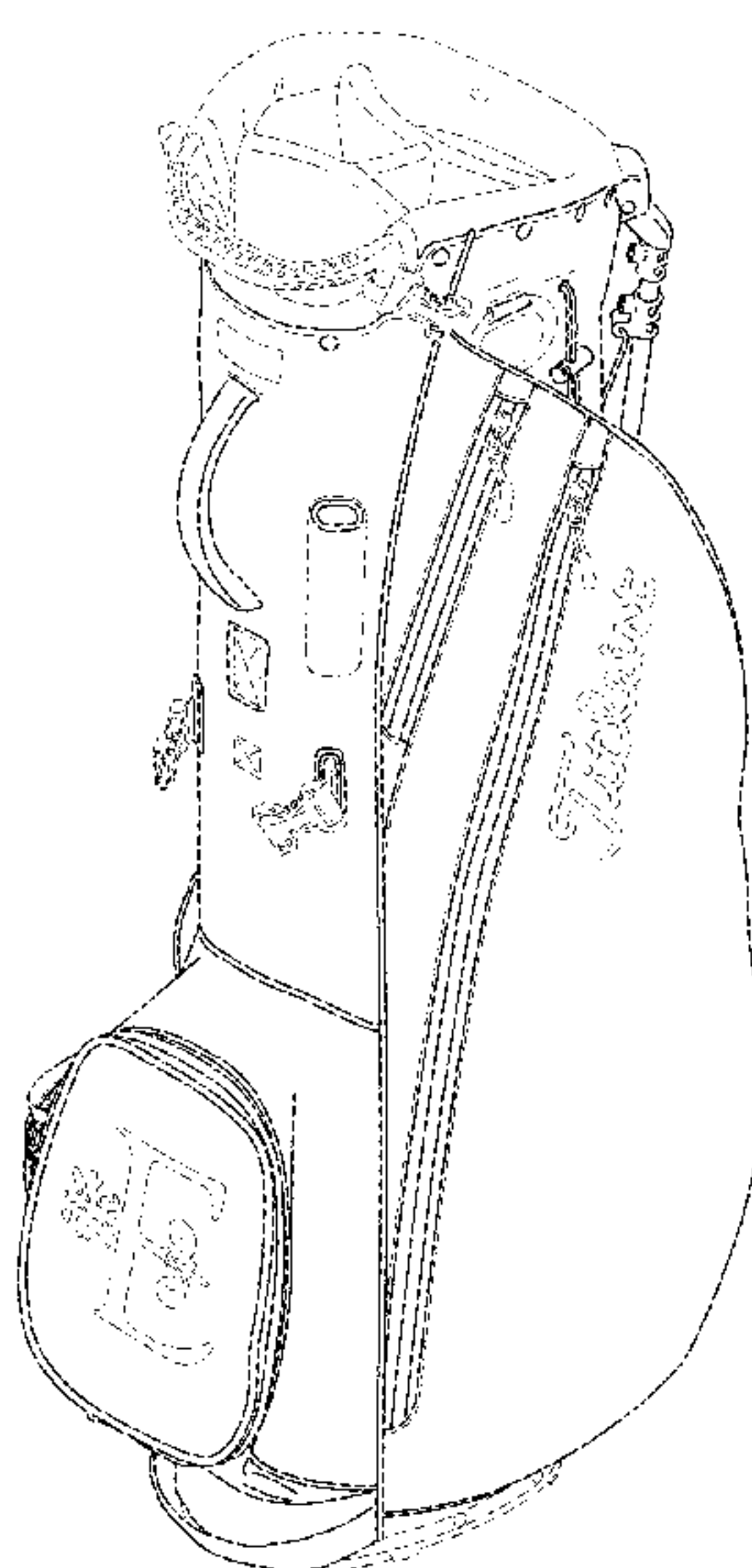
(57) **CLAIM**

The ornamental designs for portions of a golf bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf bag, showing our new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a first side view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is a second side view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines showing portions of the golf bag, stitching and logos form no part of the claim. The logo “TITLEIST” is a registered trademark of Acushnet Company.

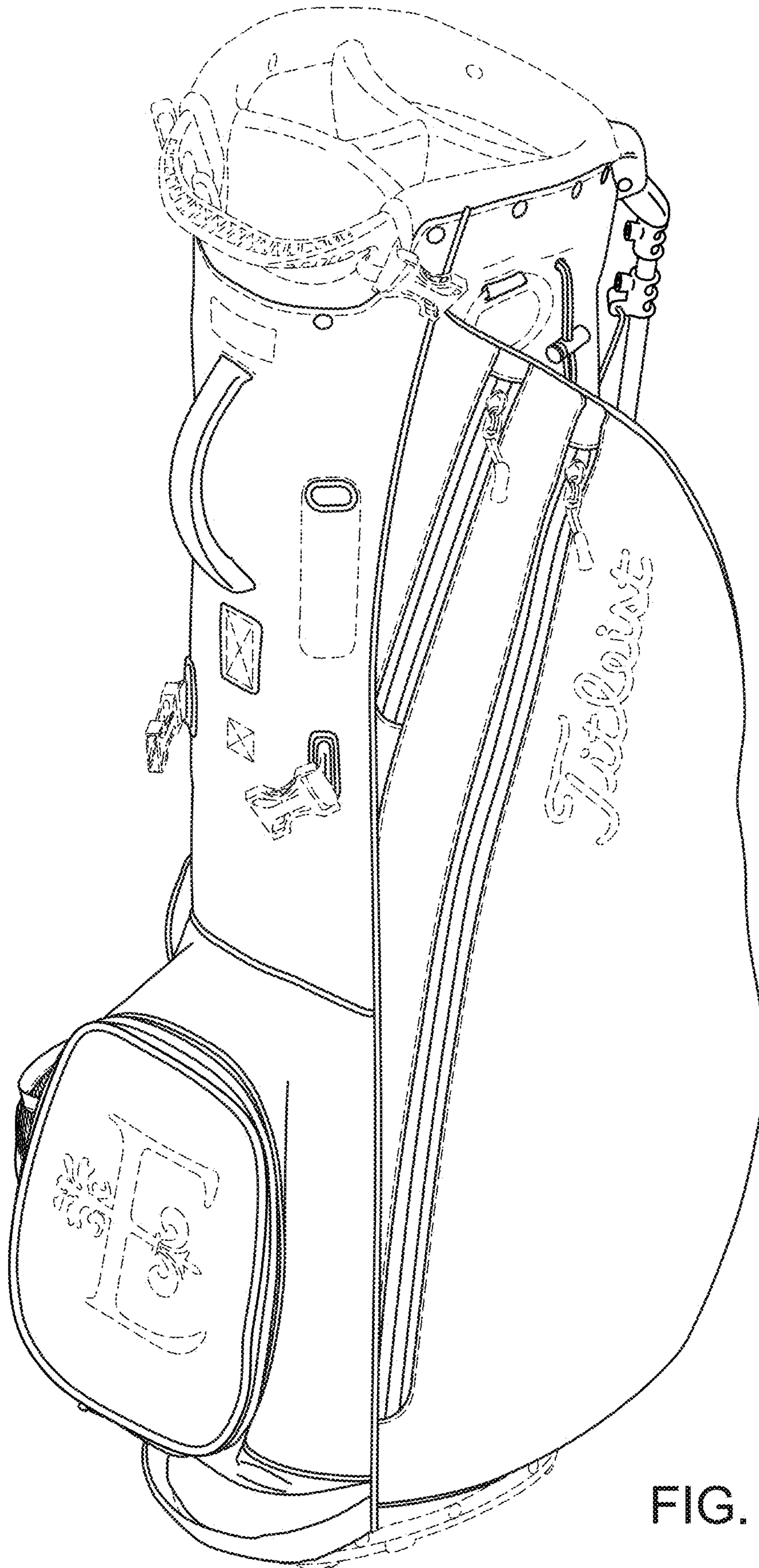

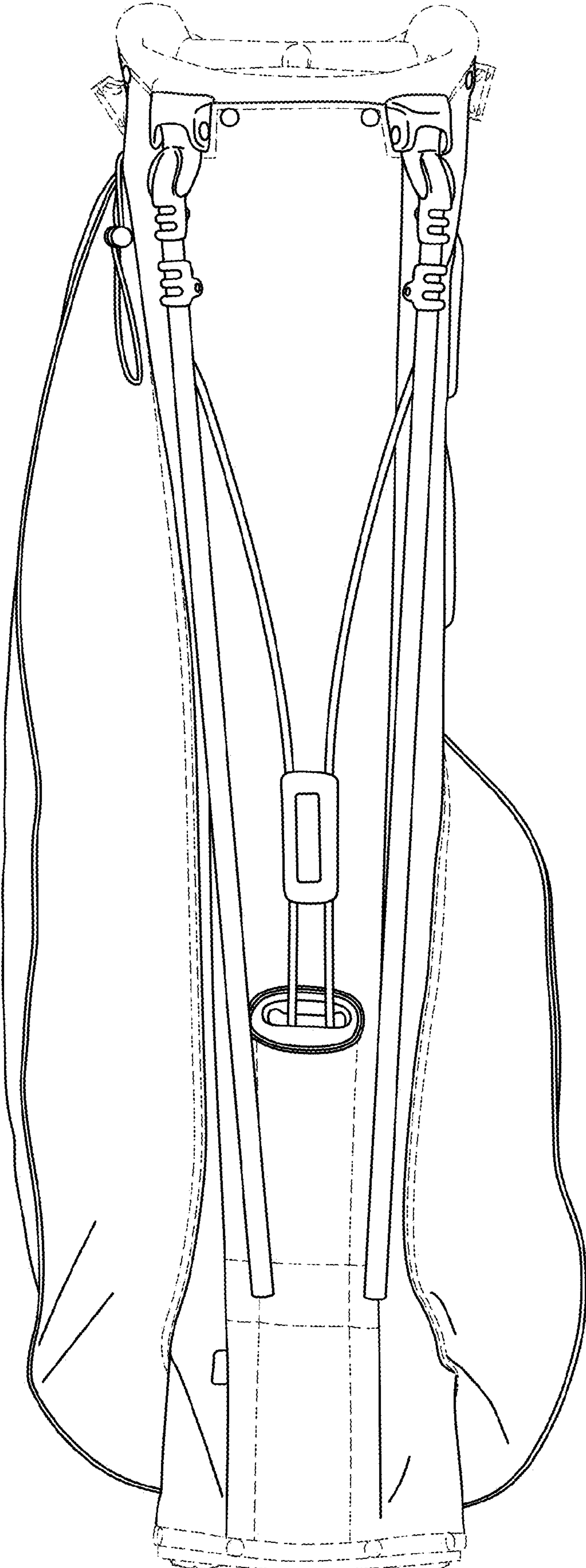

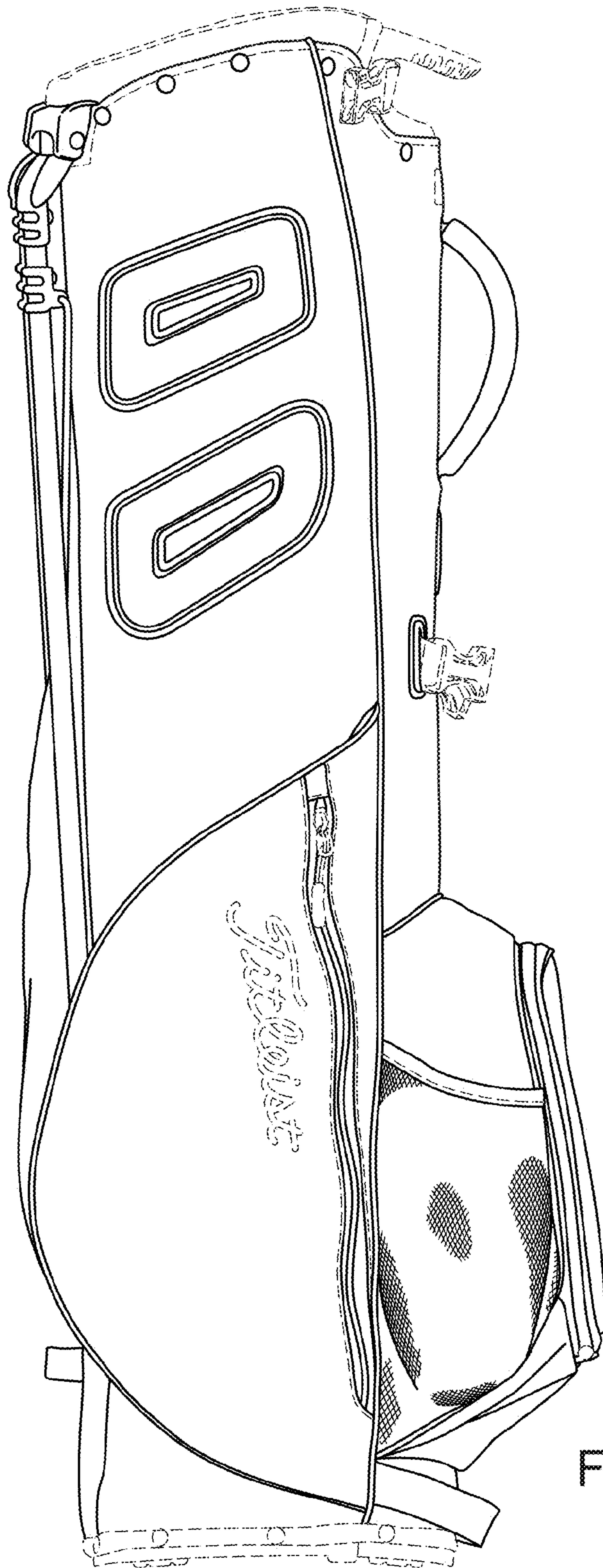

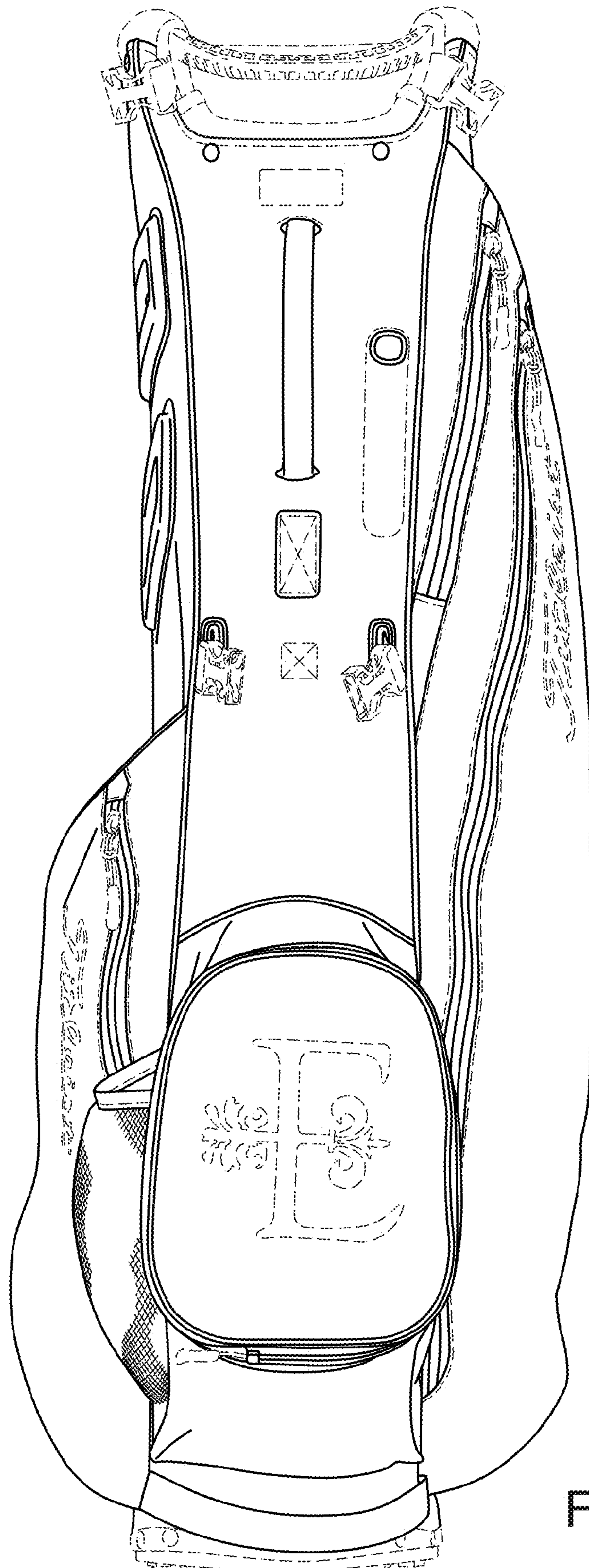

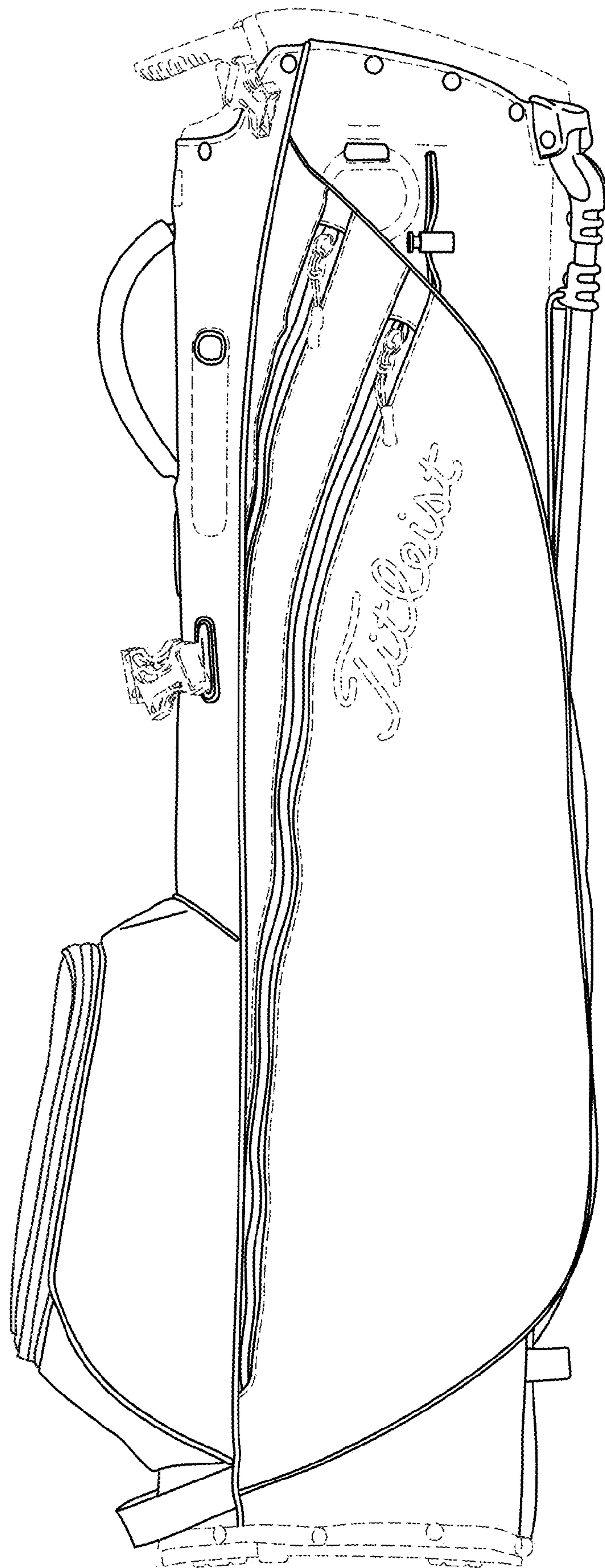

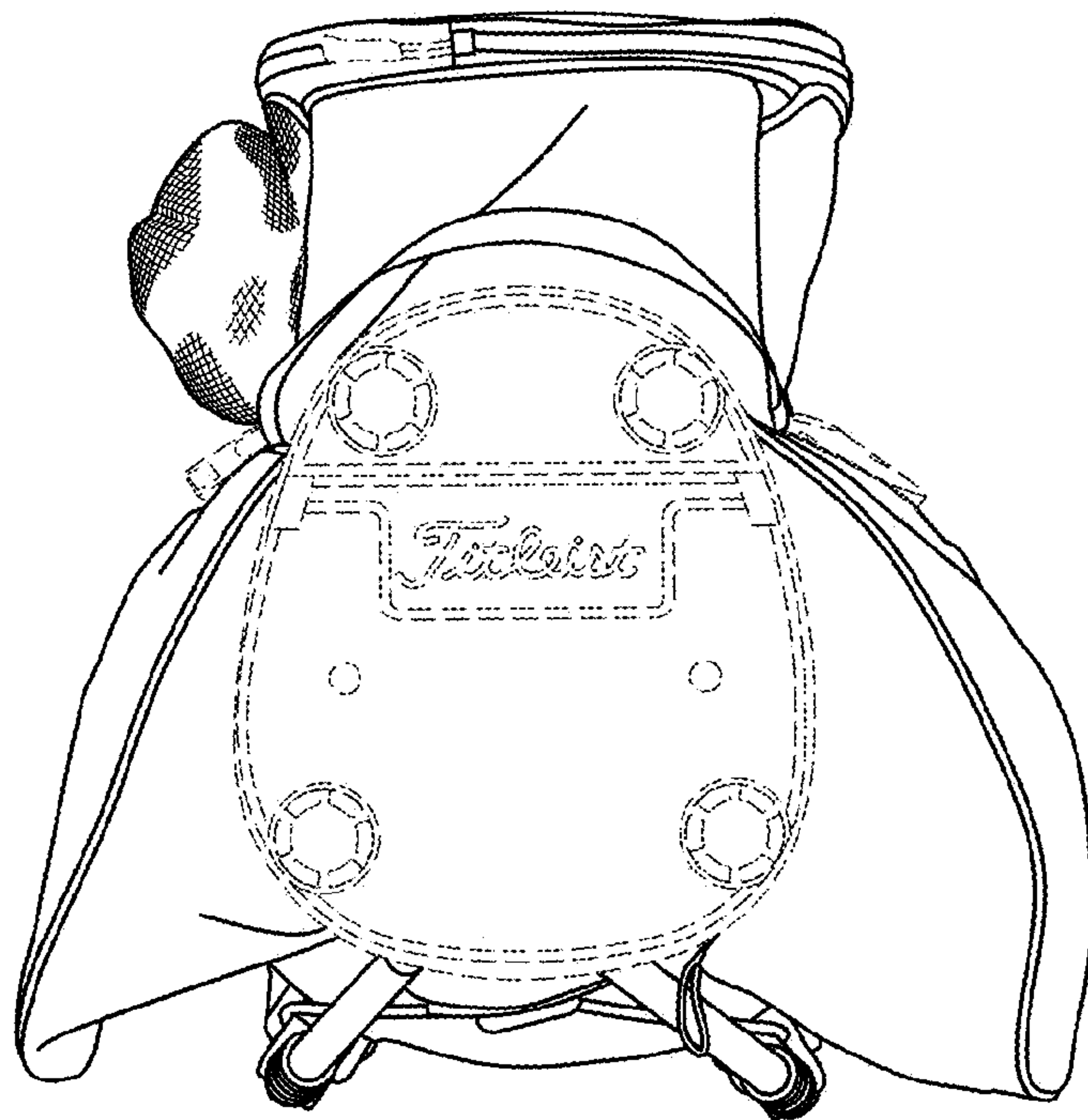
