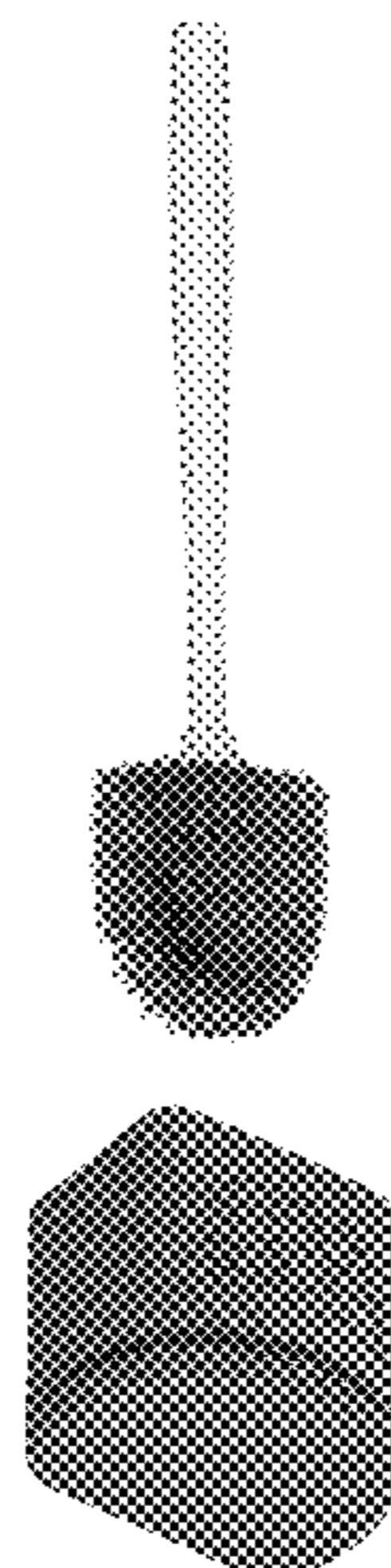

(57) **CLAIM**

The ornamental design for a combination toilet brush with holder, as shown and described.

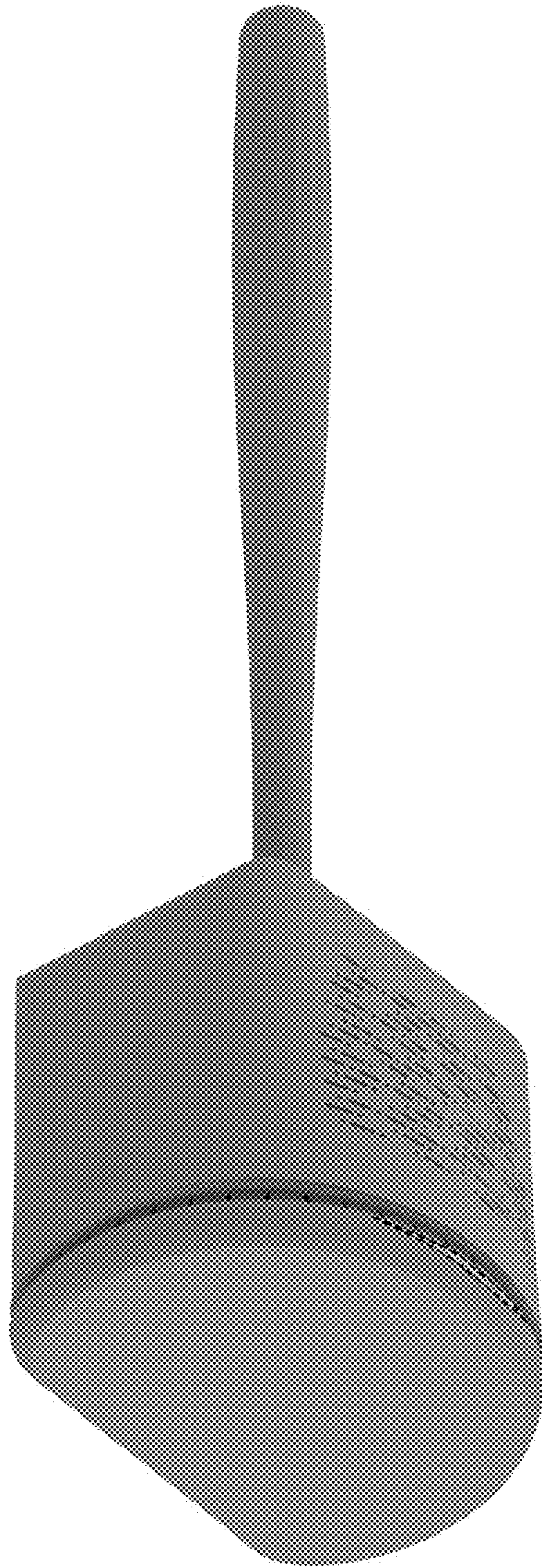

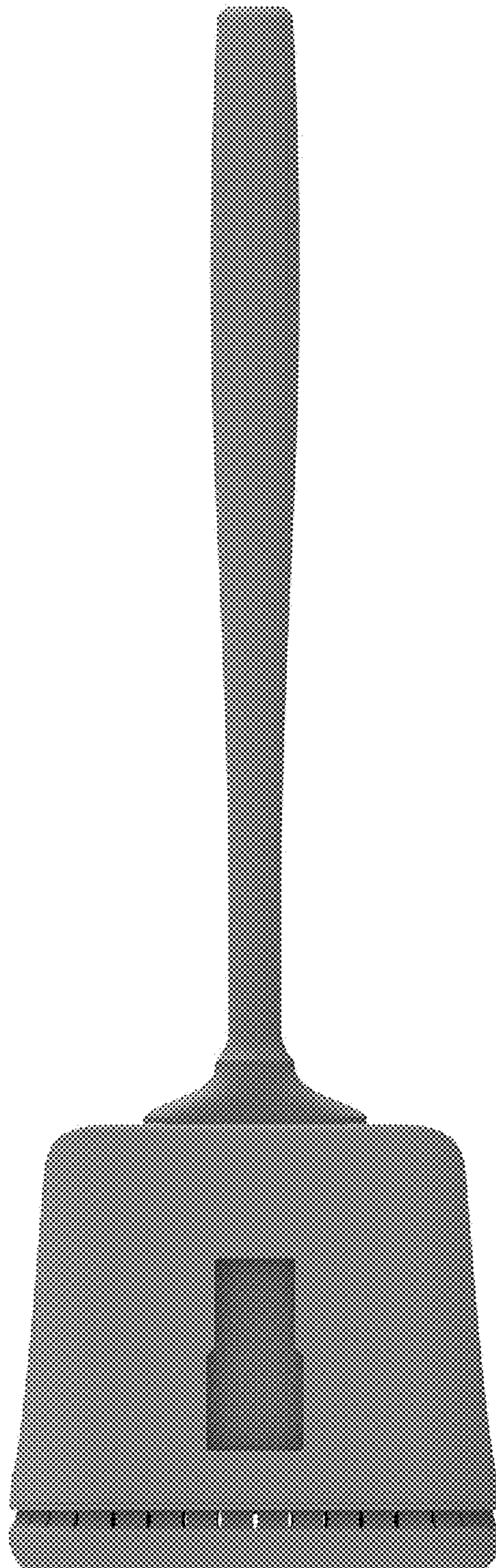

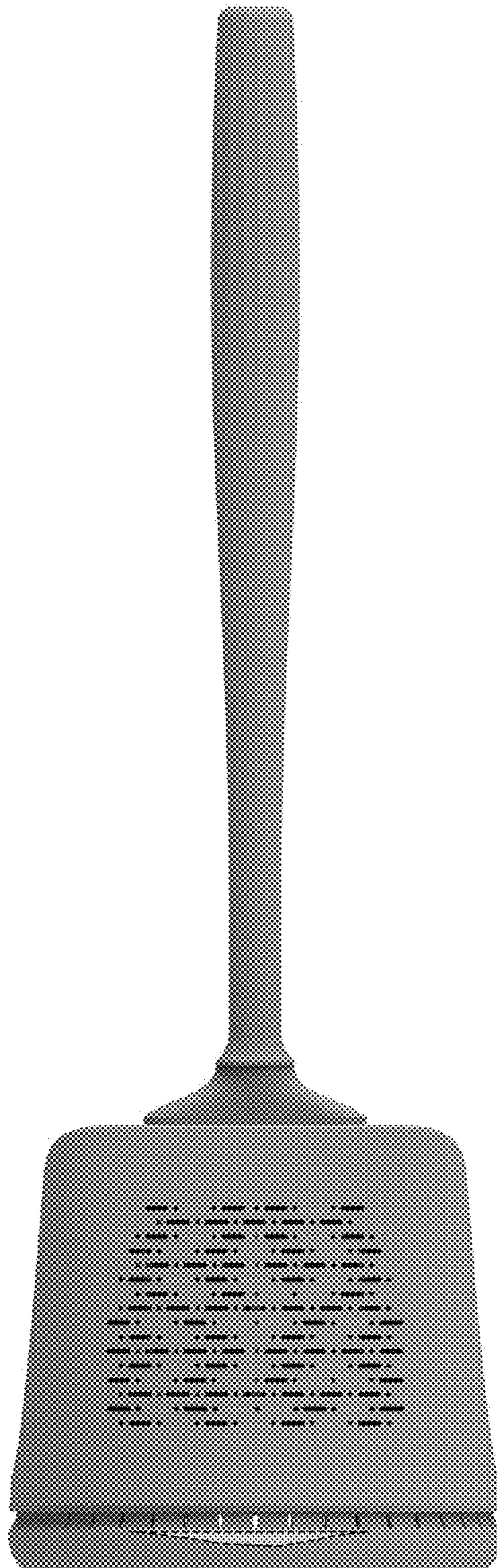

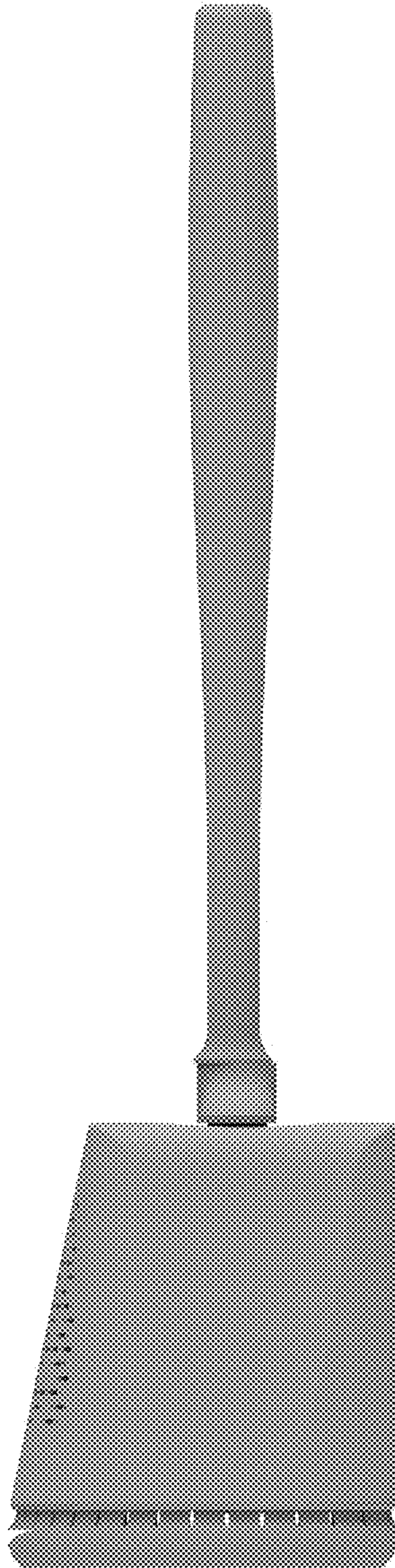

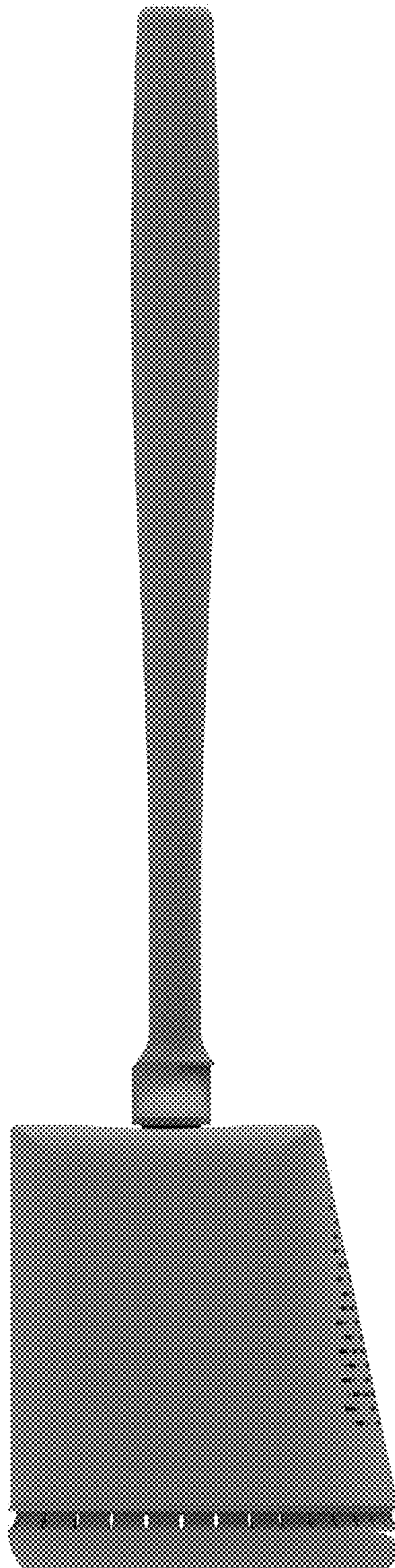

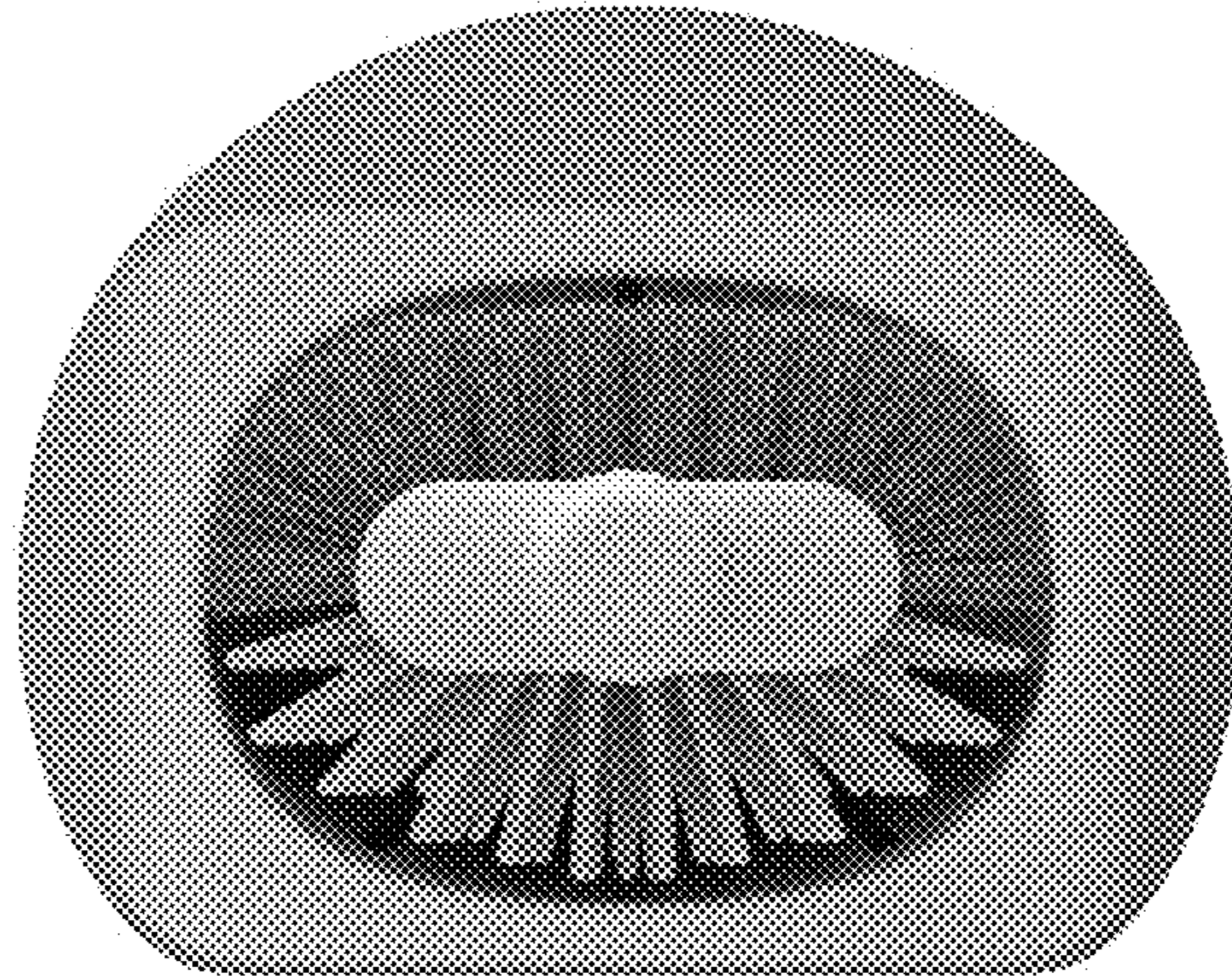

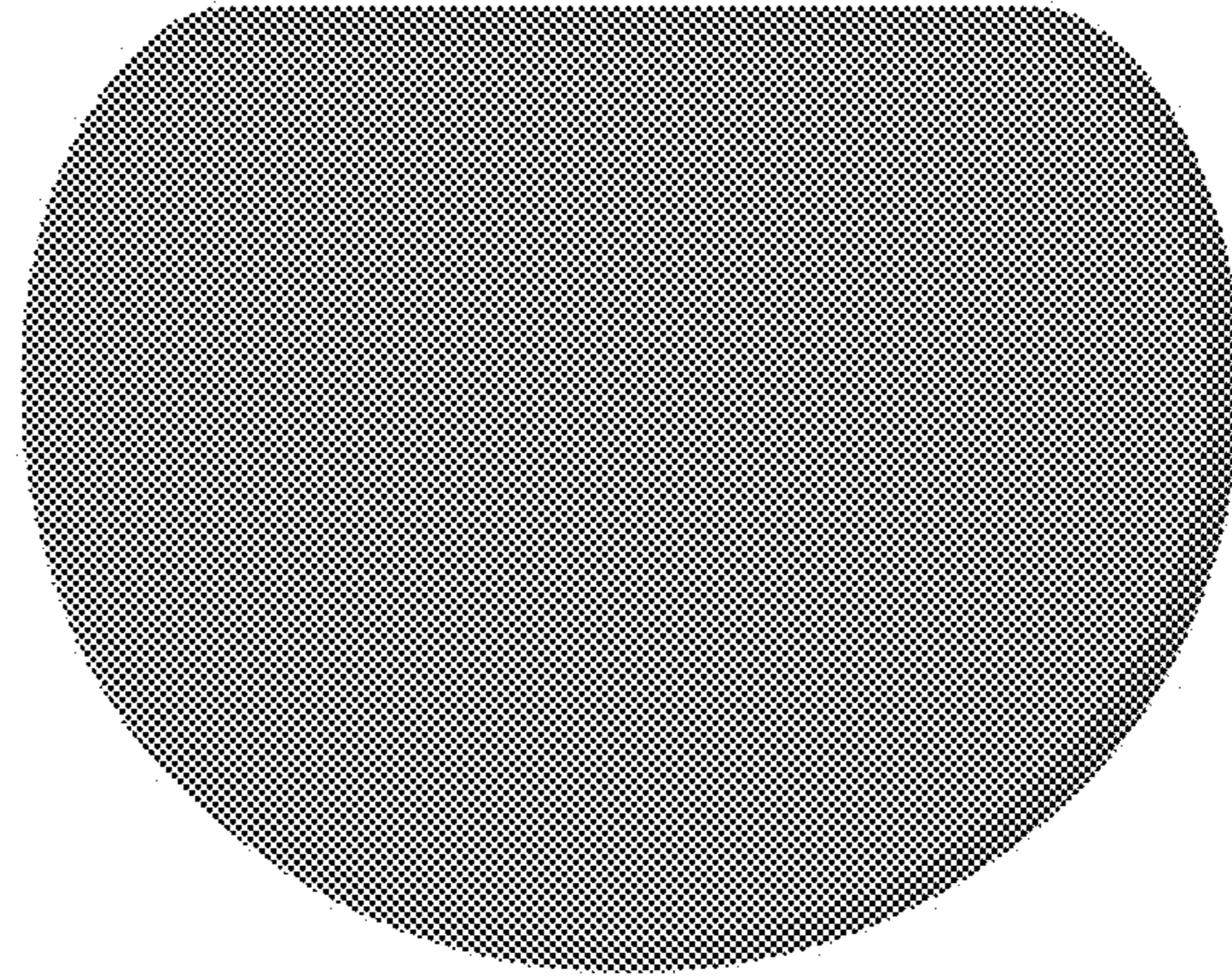

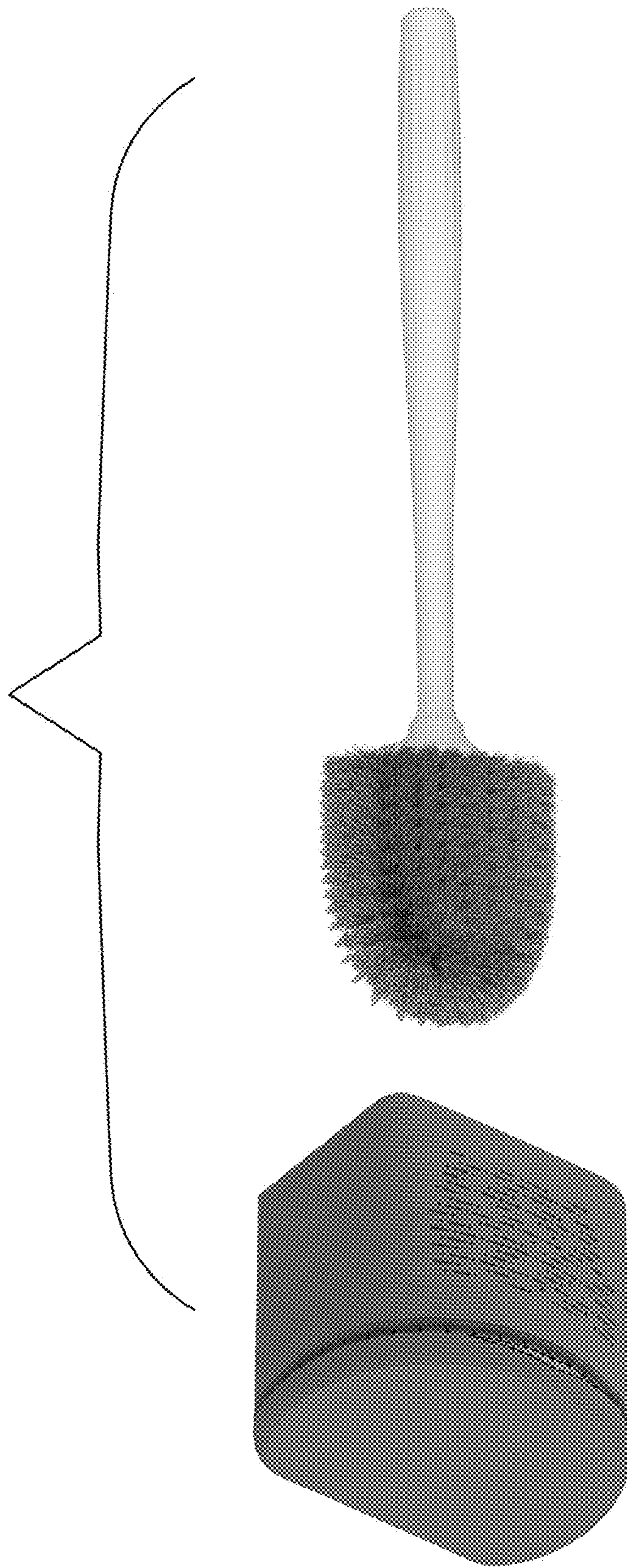

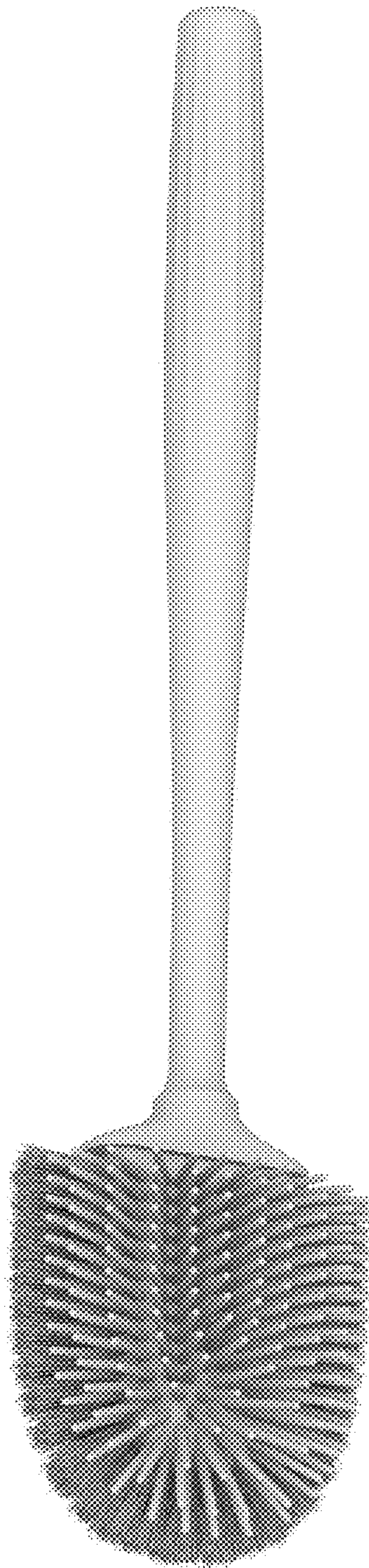

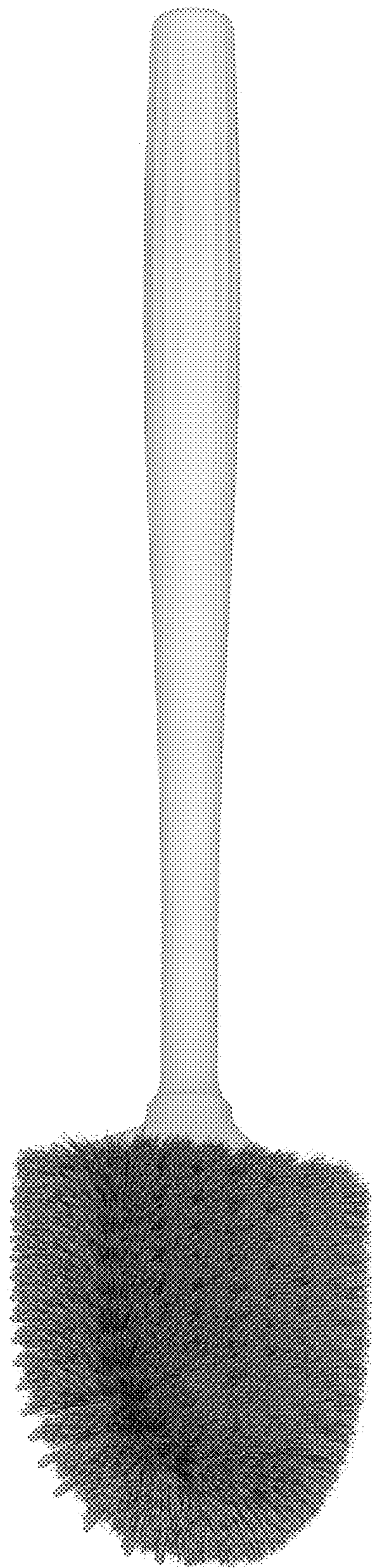

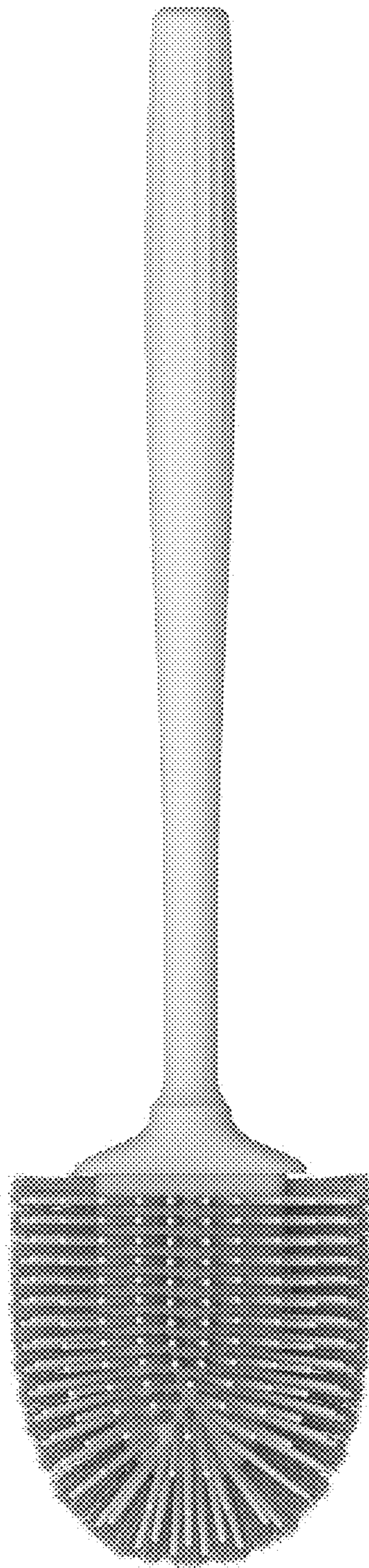

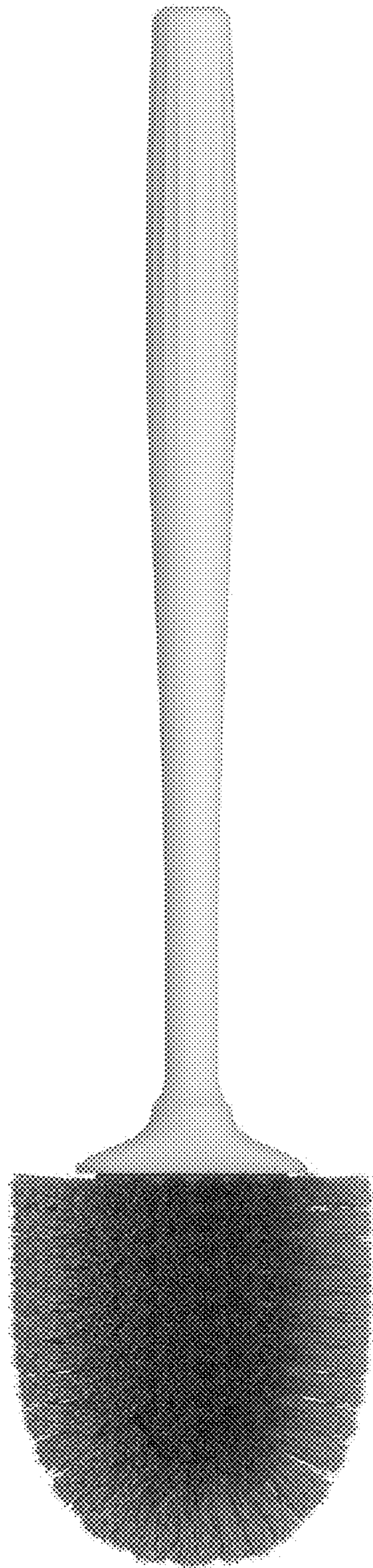

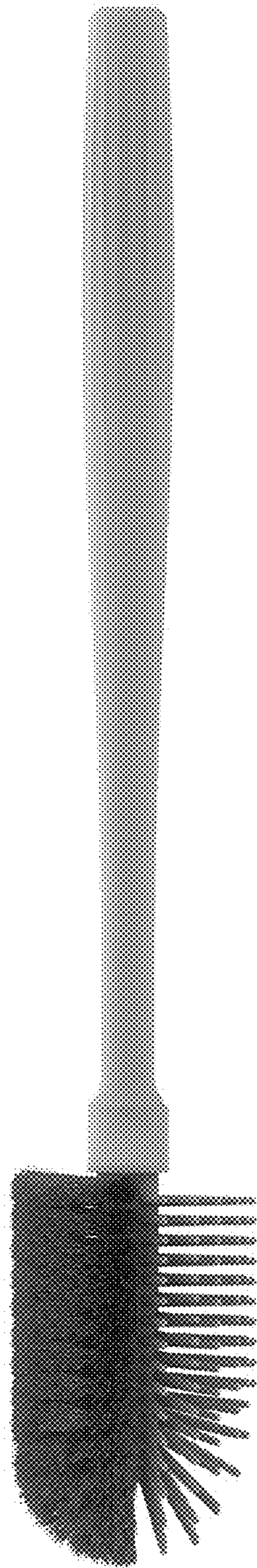

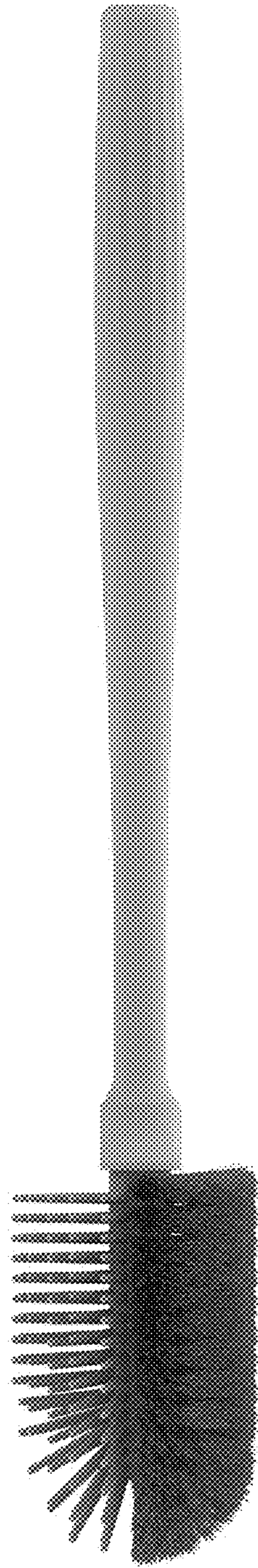

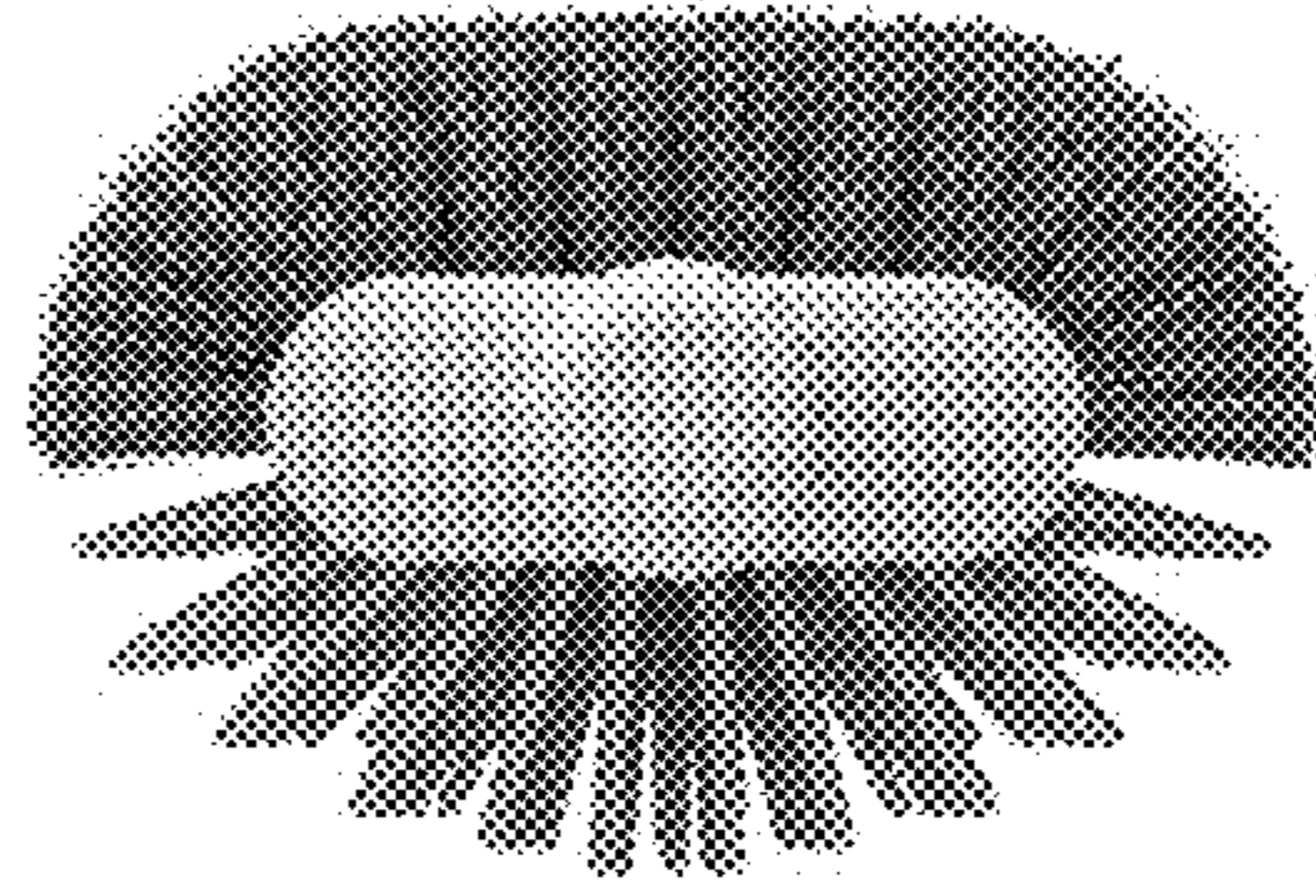

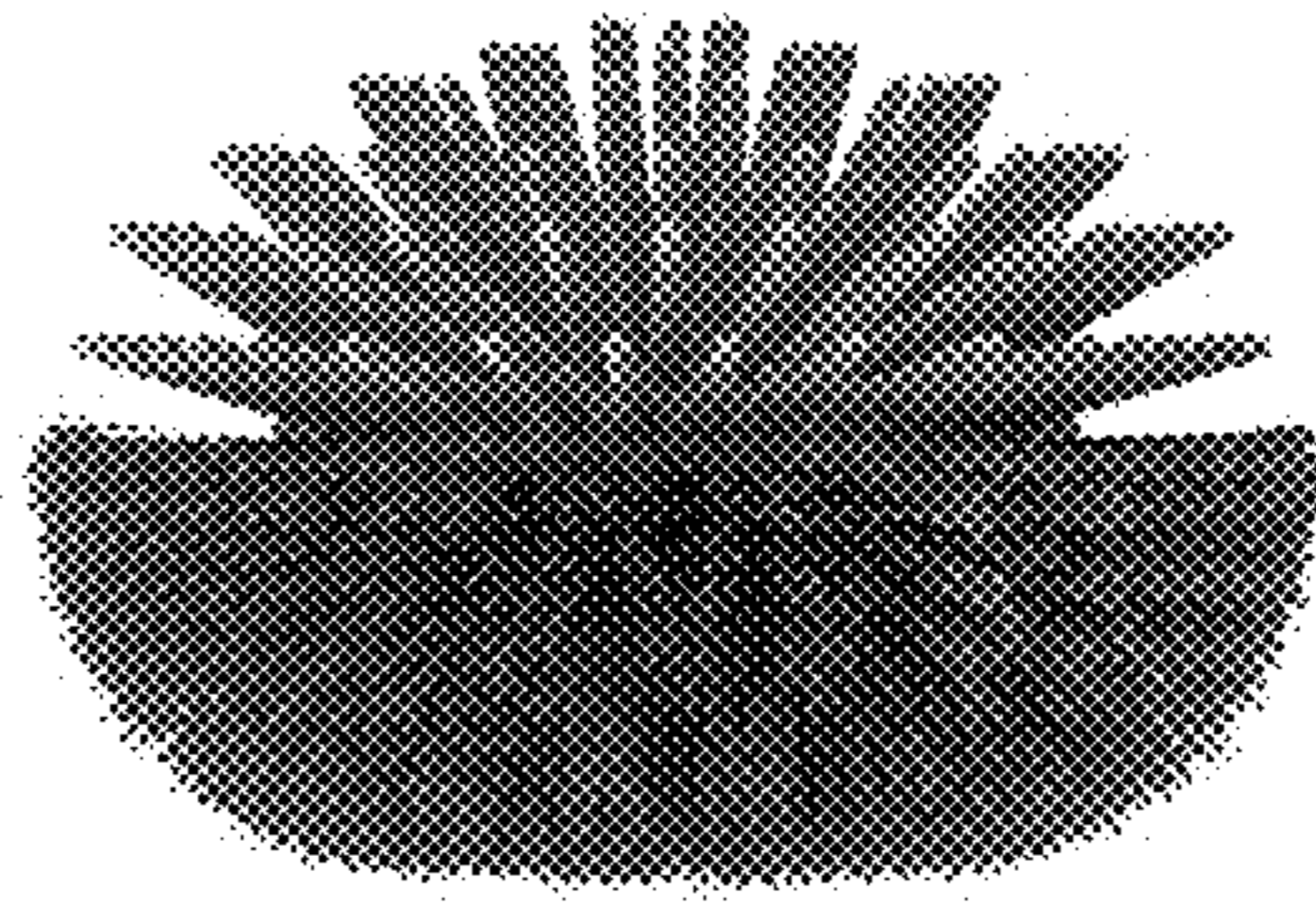

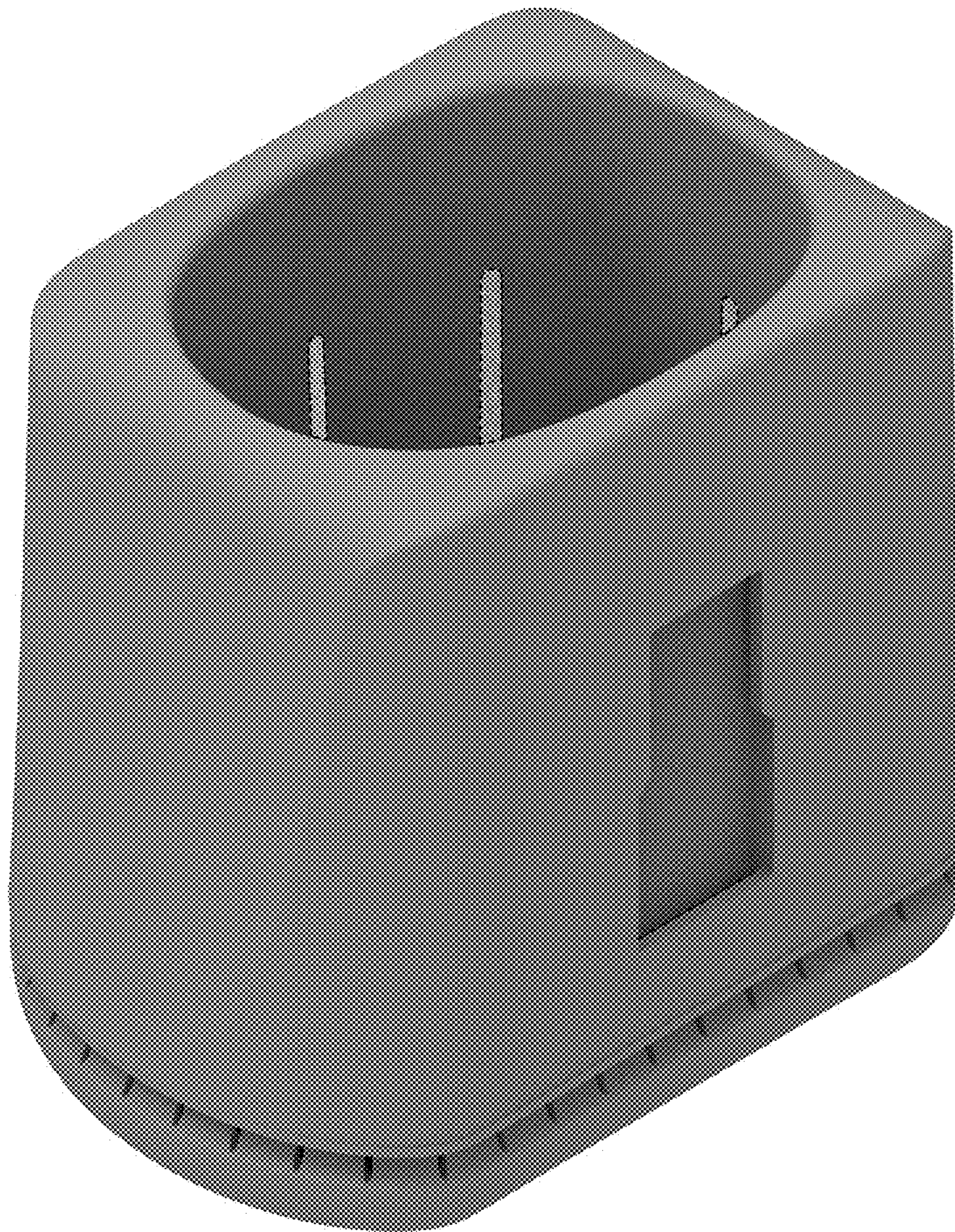

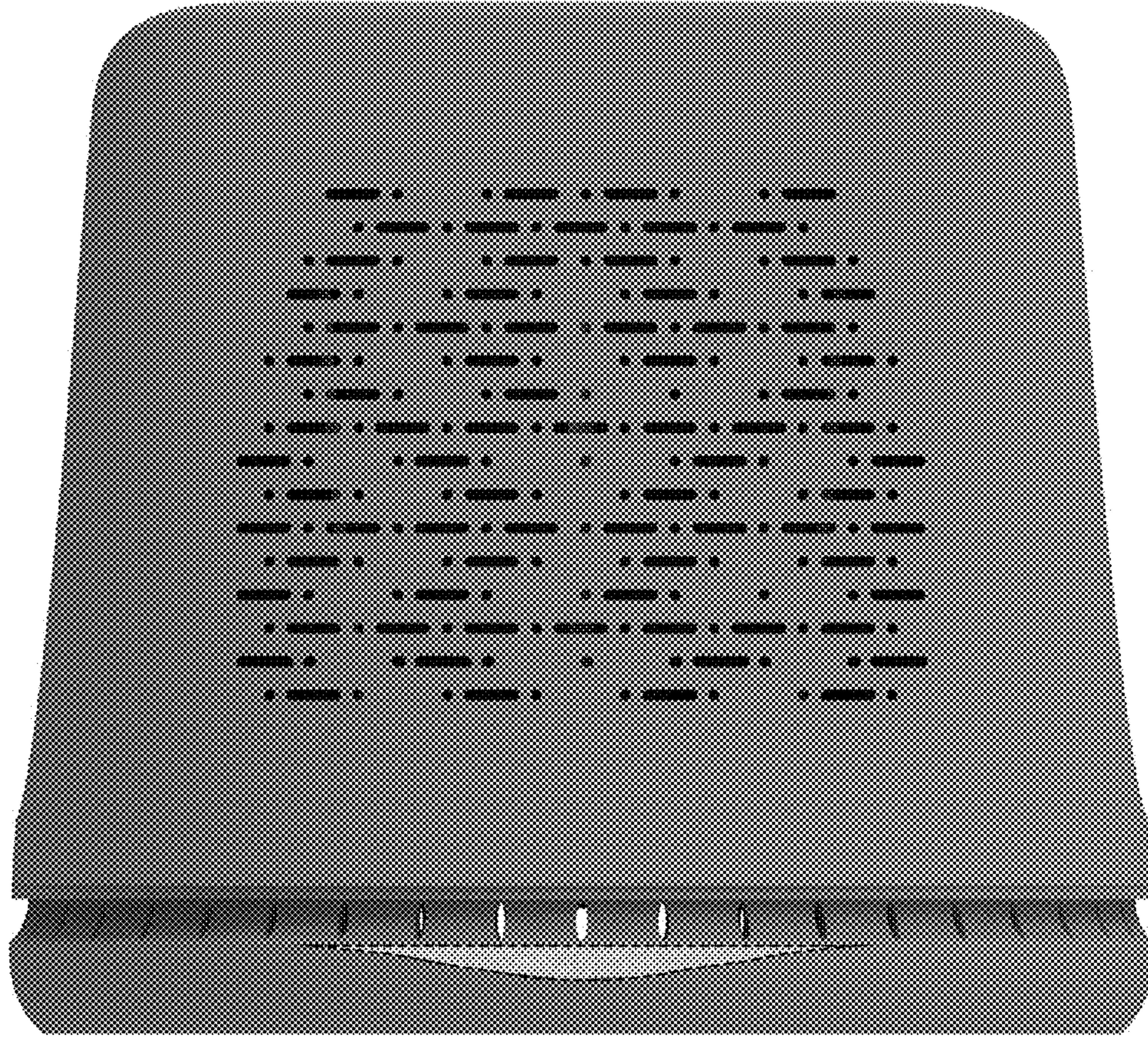

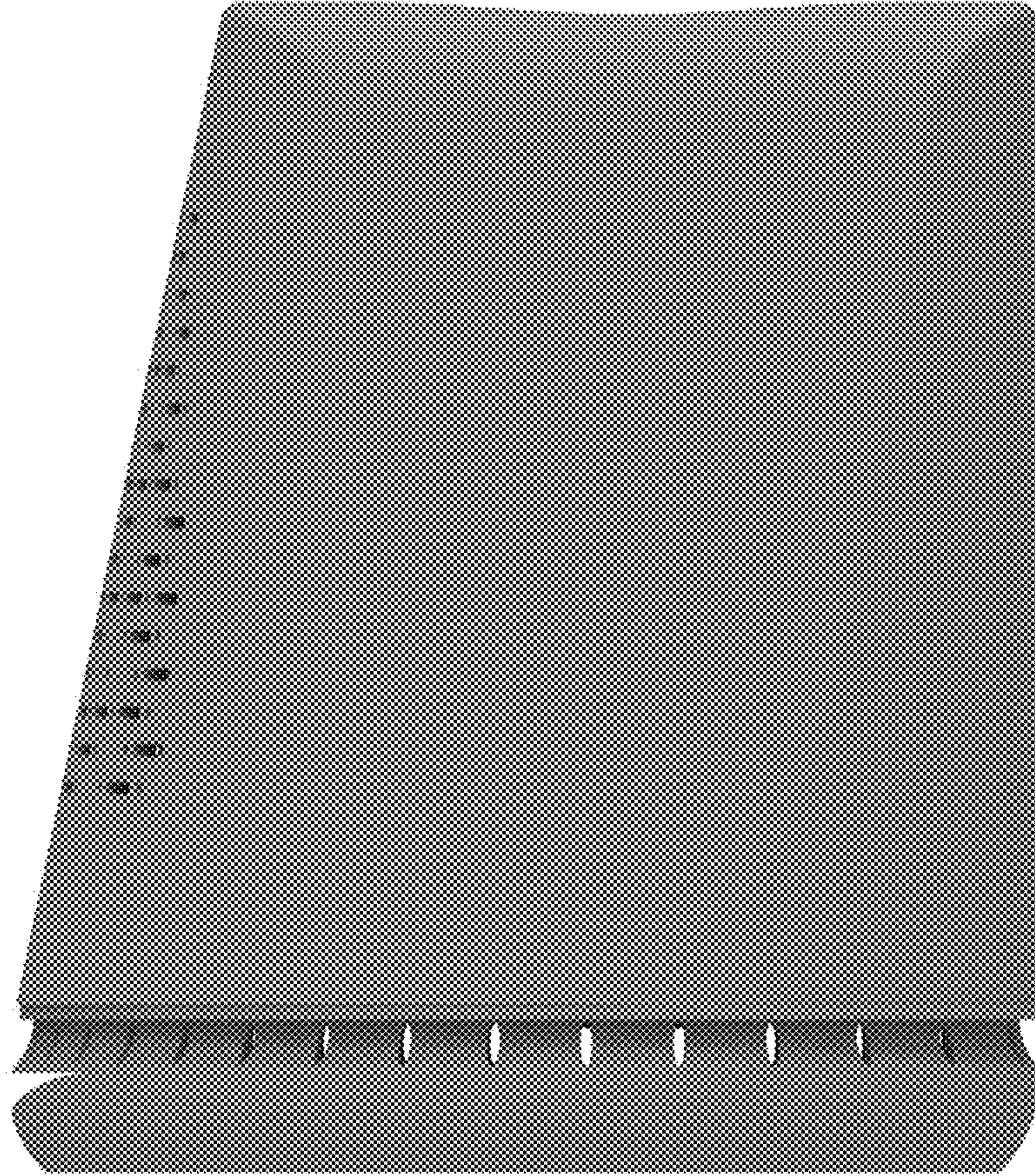

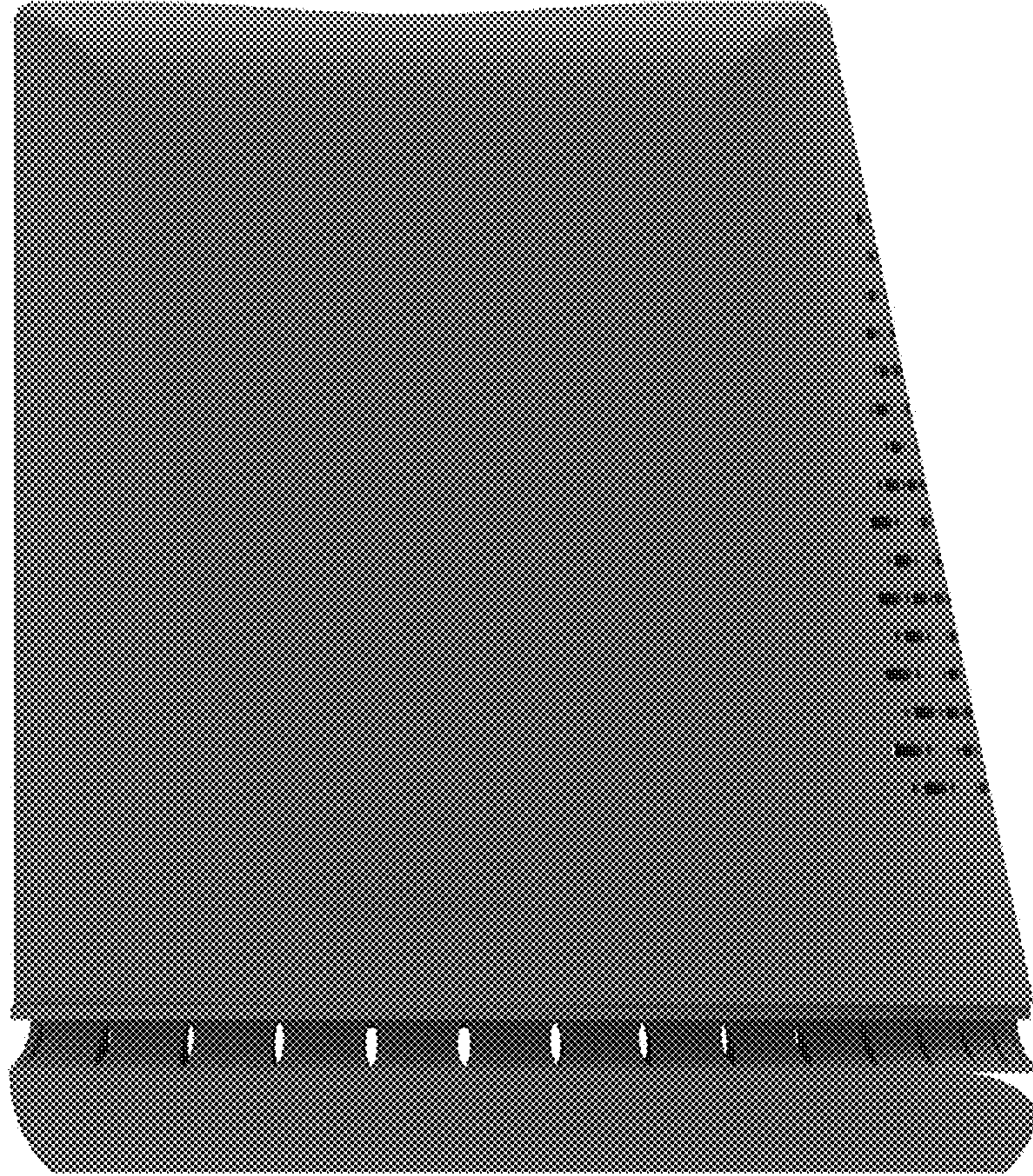

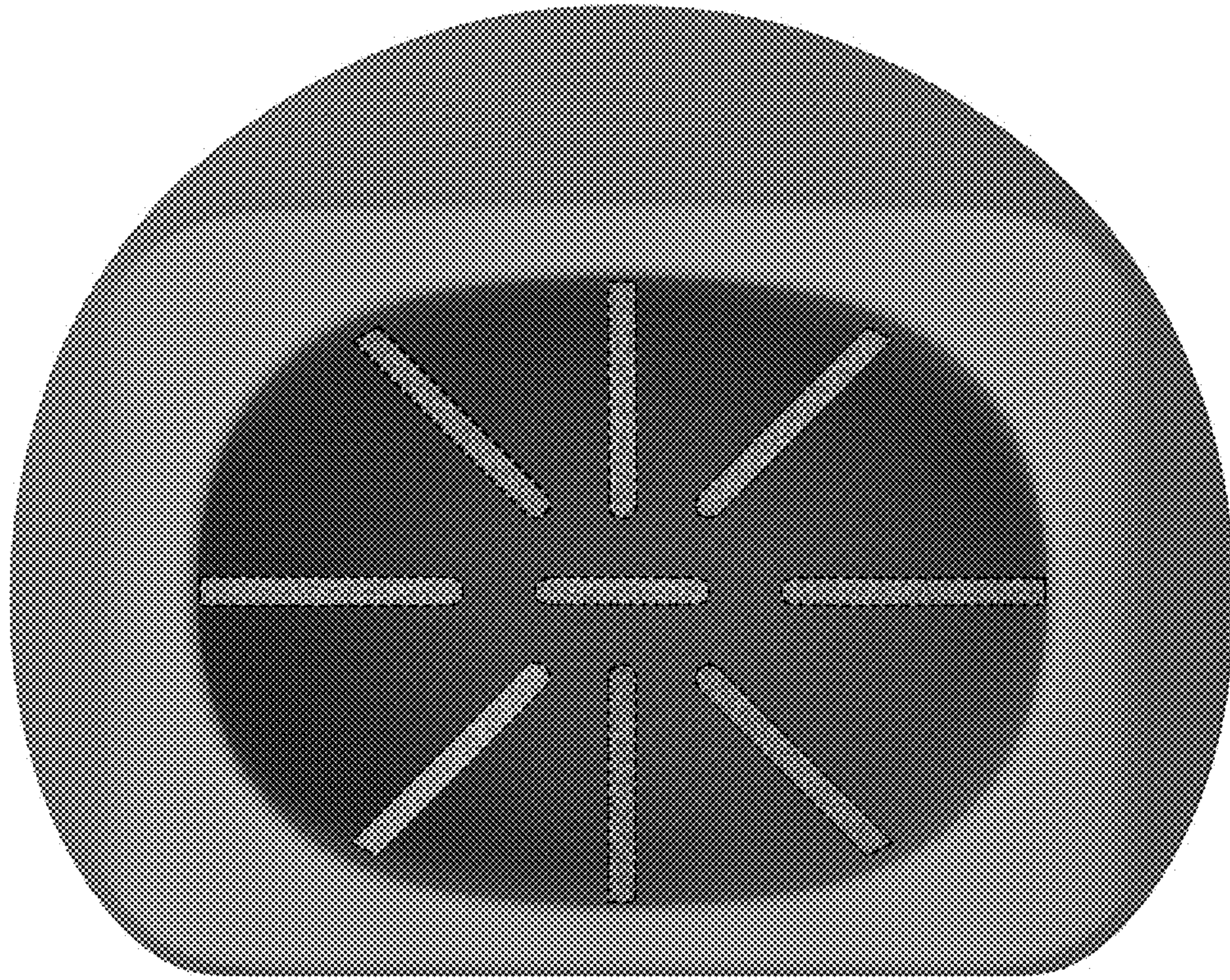

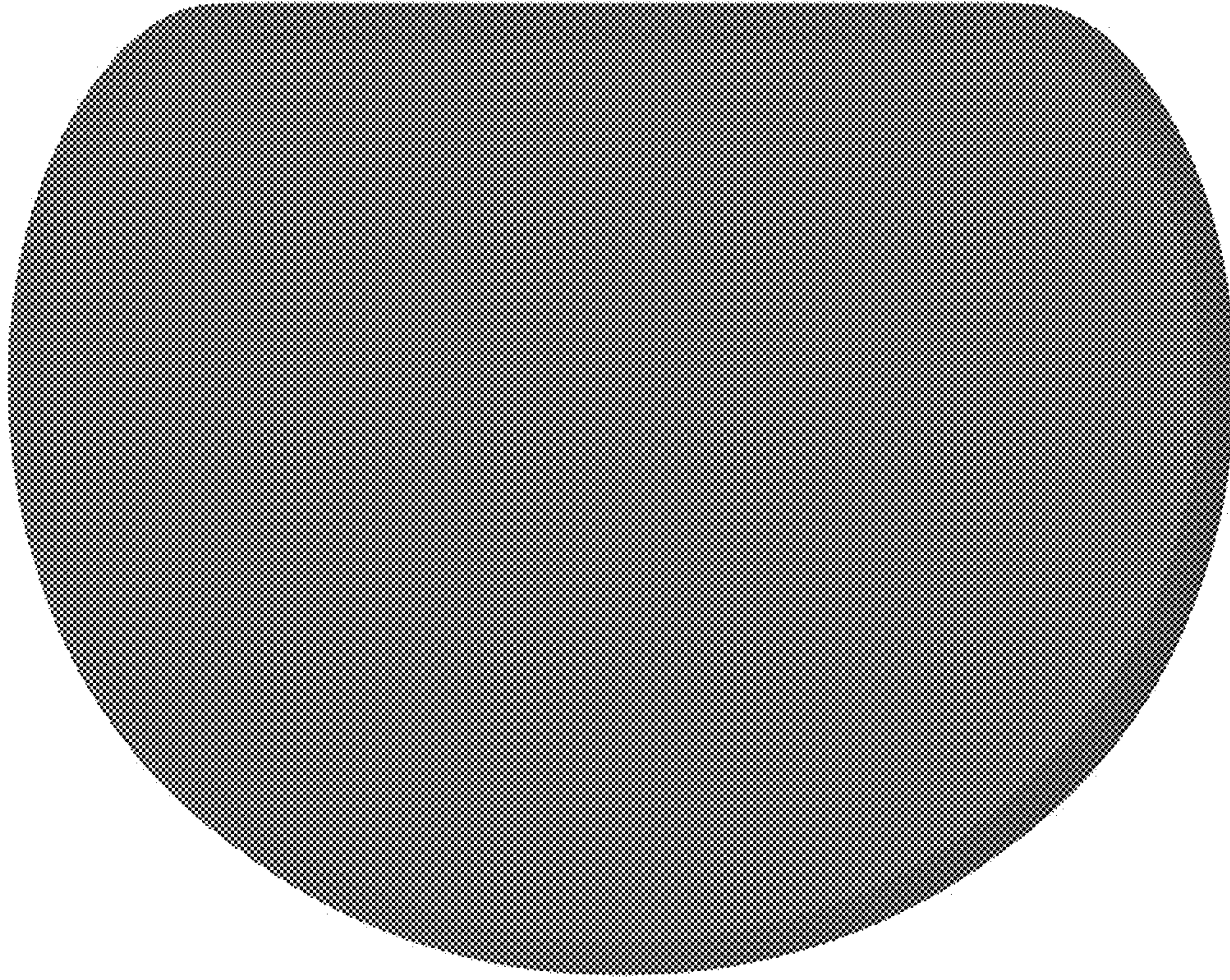
