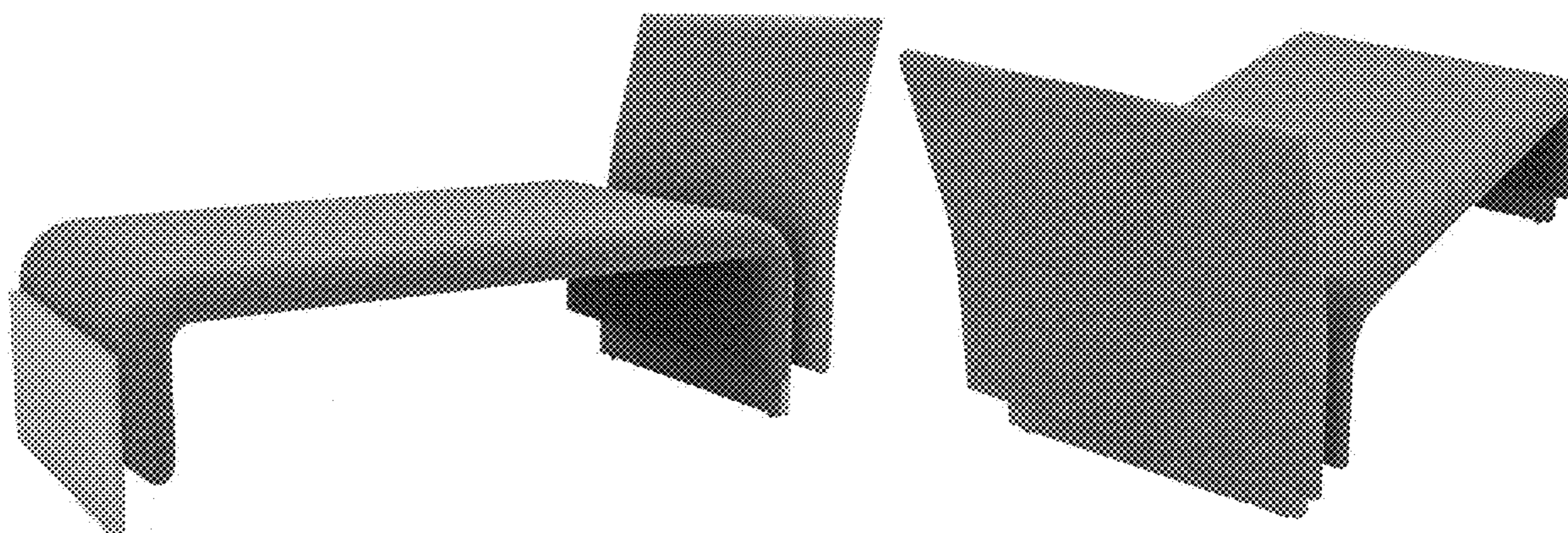
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right-side, front perspective view of a chaise lounge showing my new design;
FIG. 2 is a right-side view thereof, the left-side view being a mirror image thereof;

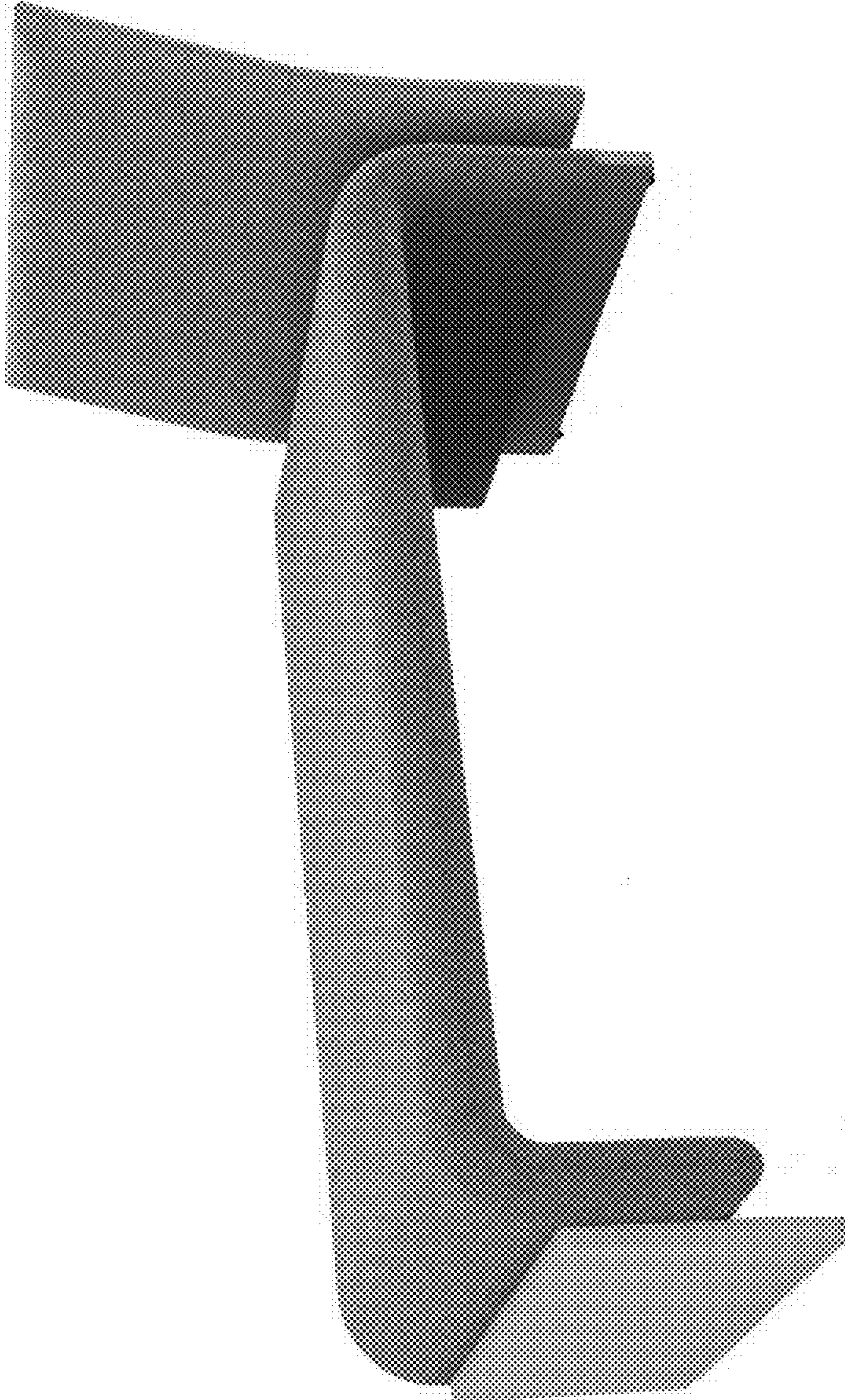

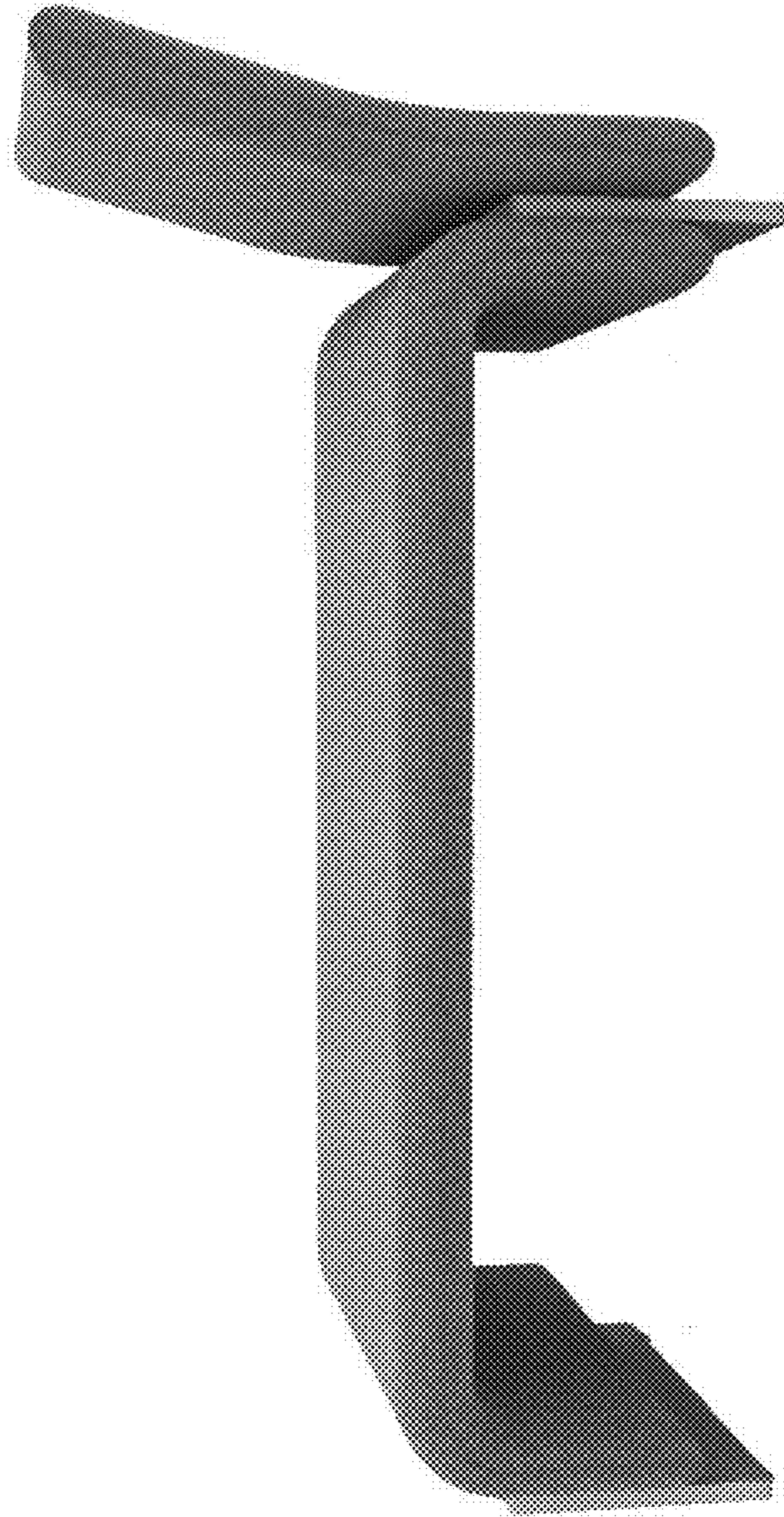

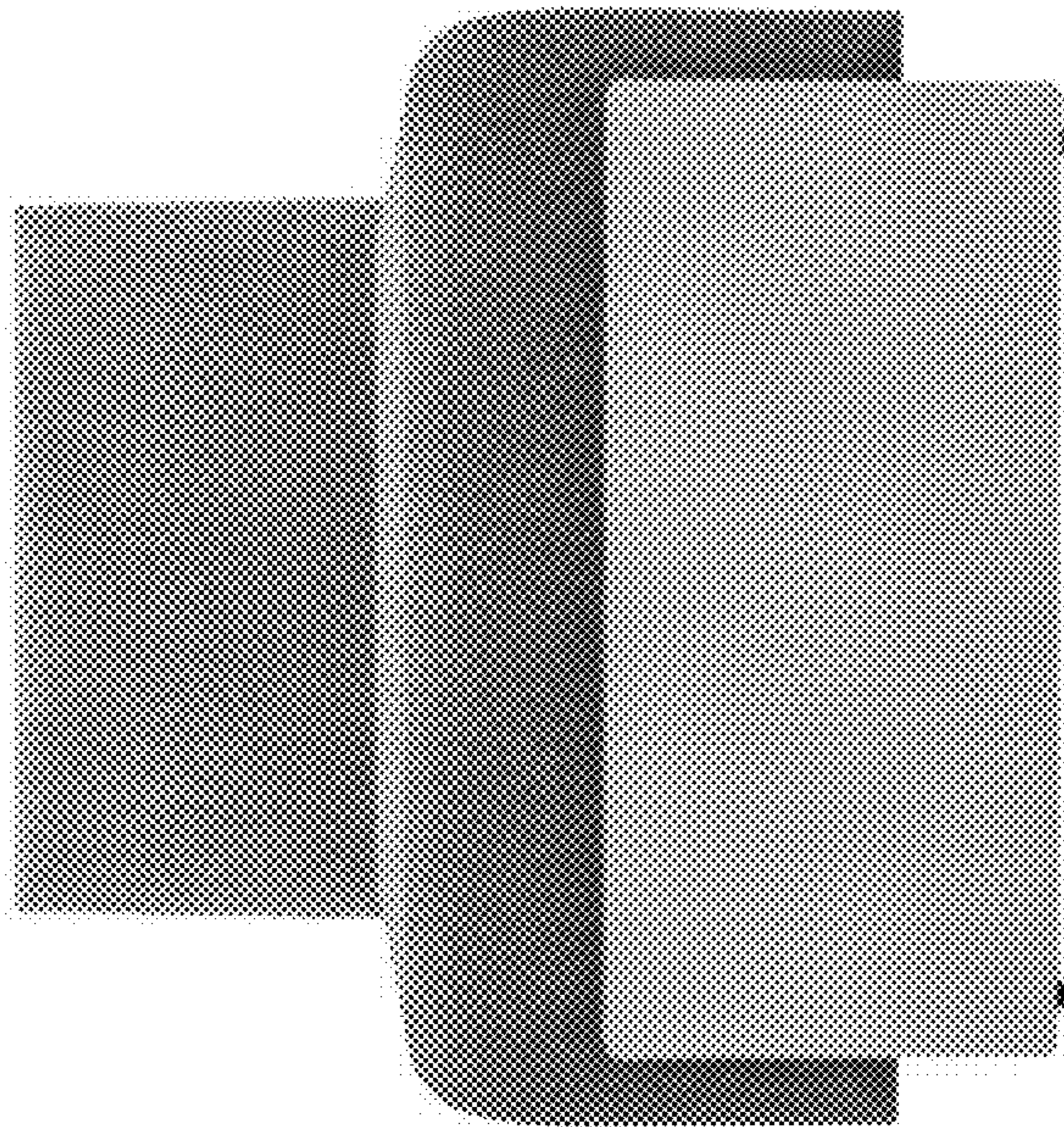

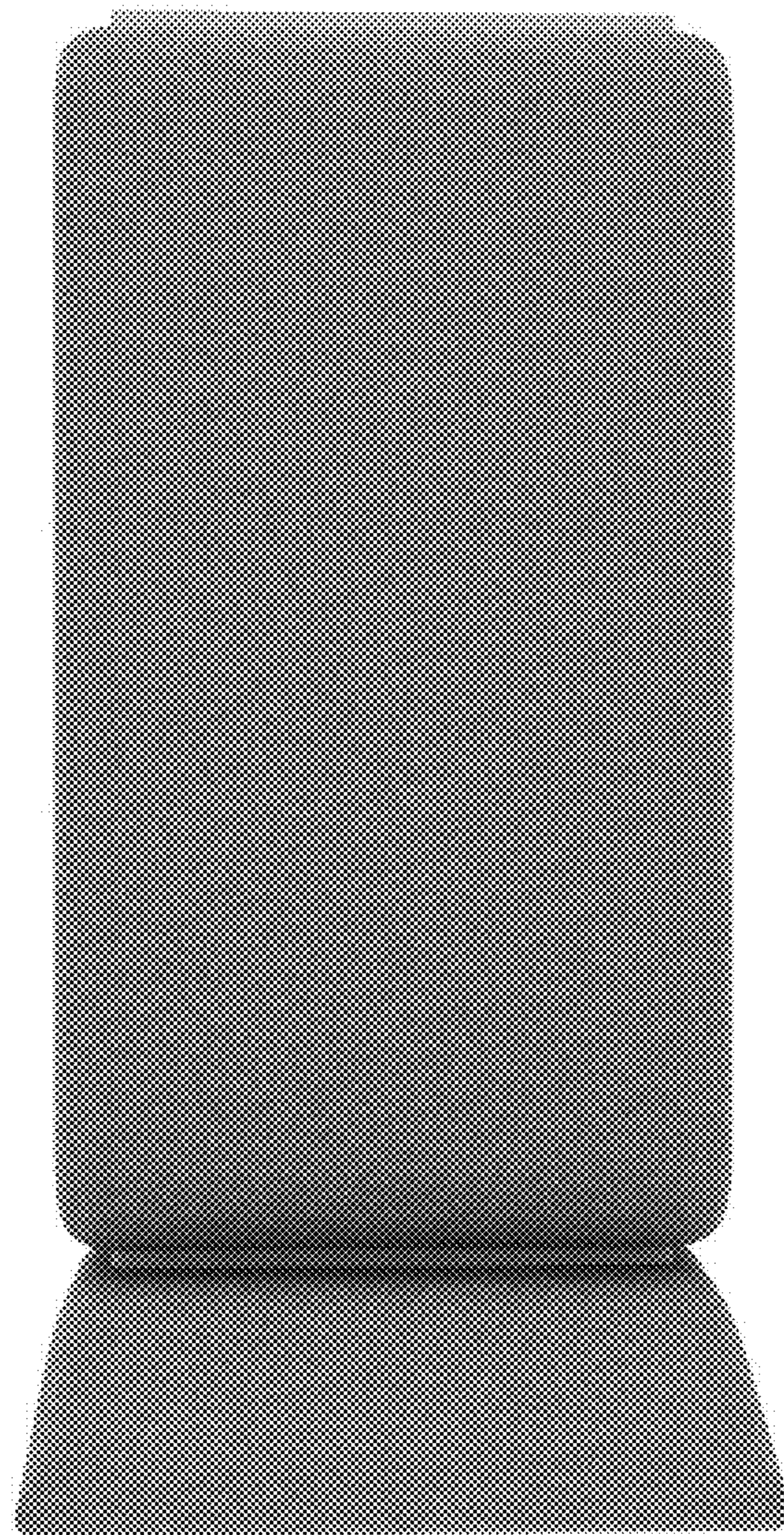

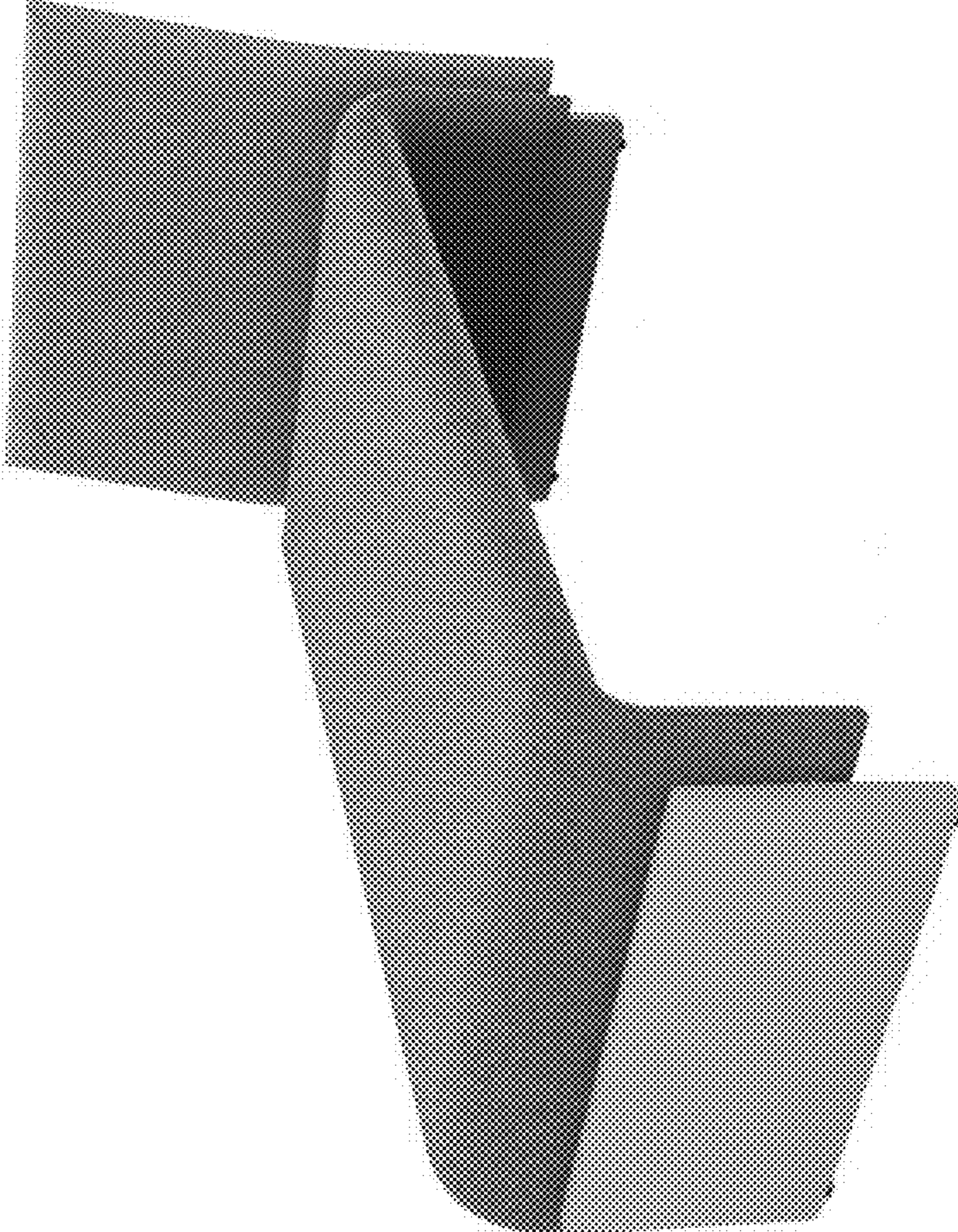

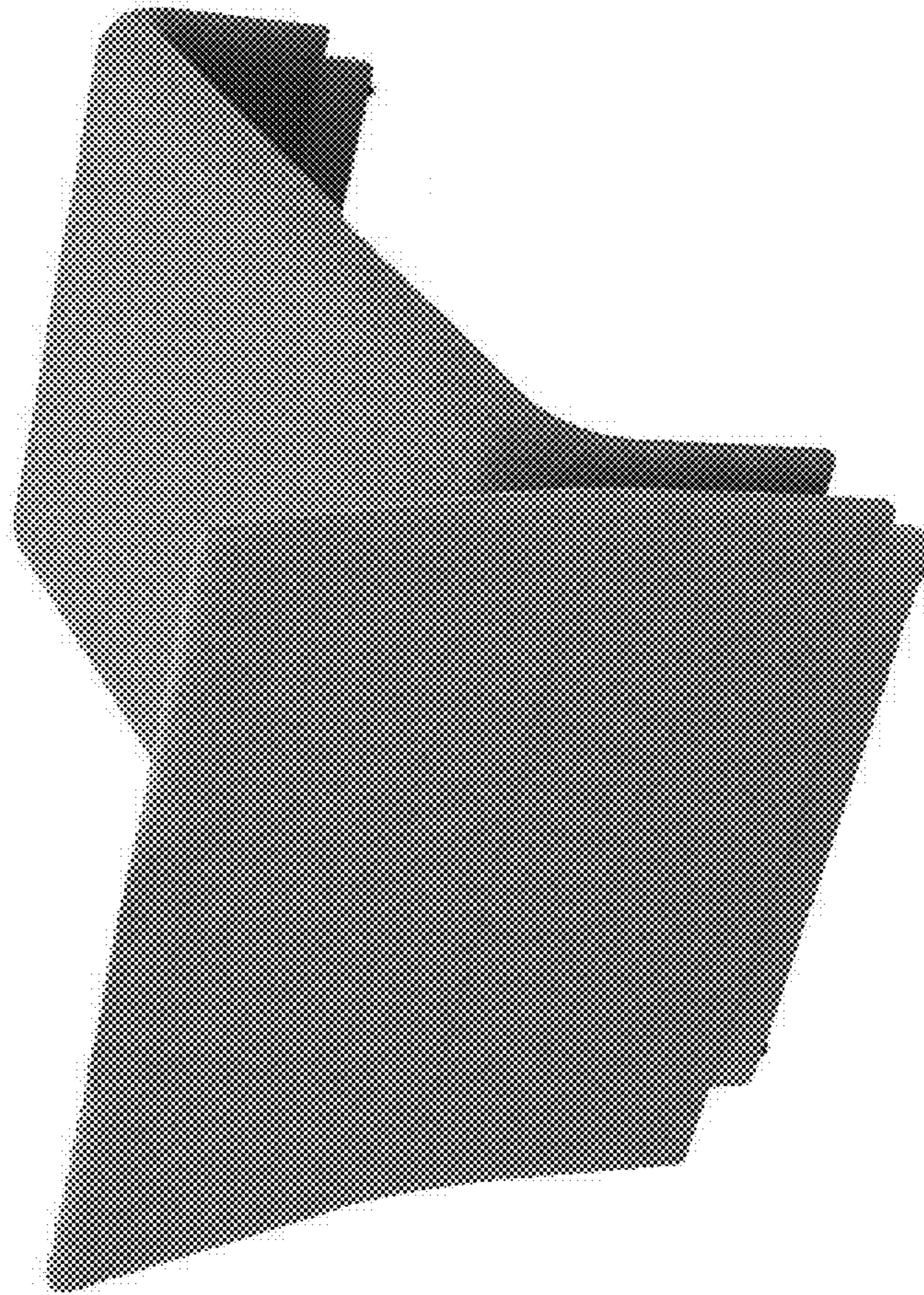

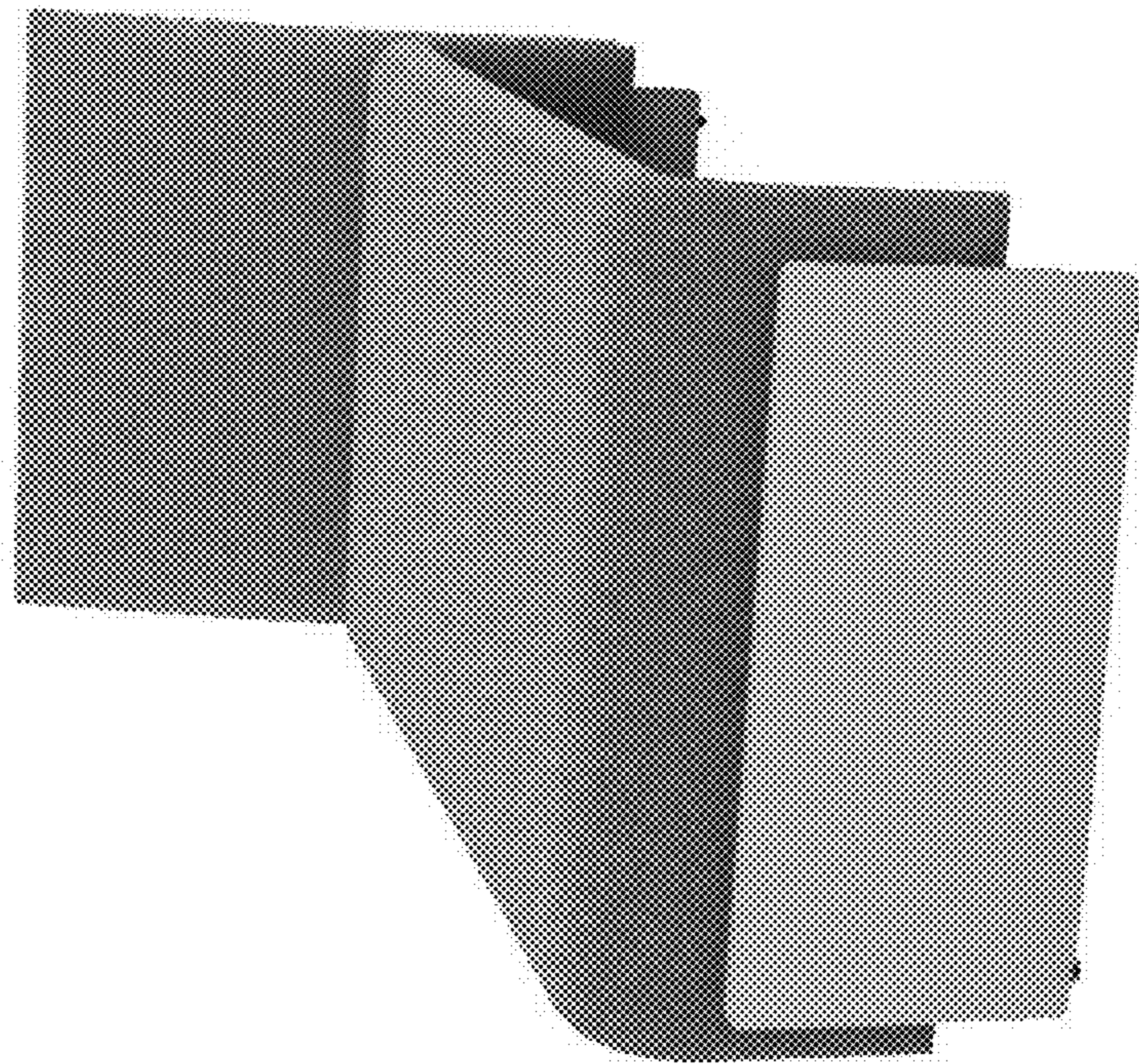
