The ornamental design for a push-in sealing cap for reusing disposable coffee capsules, as shown and described.

DESCRIPTION

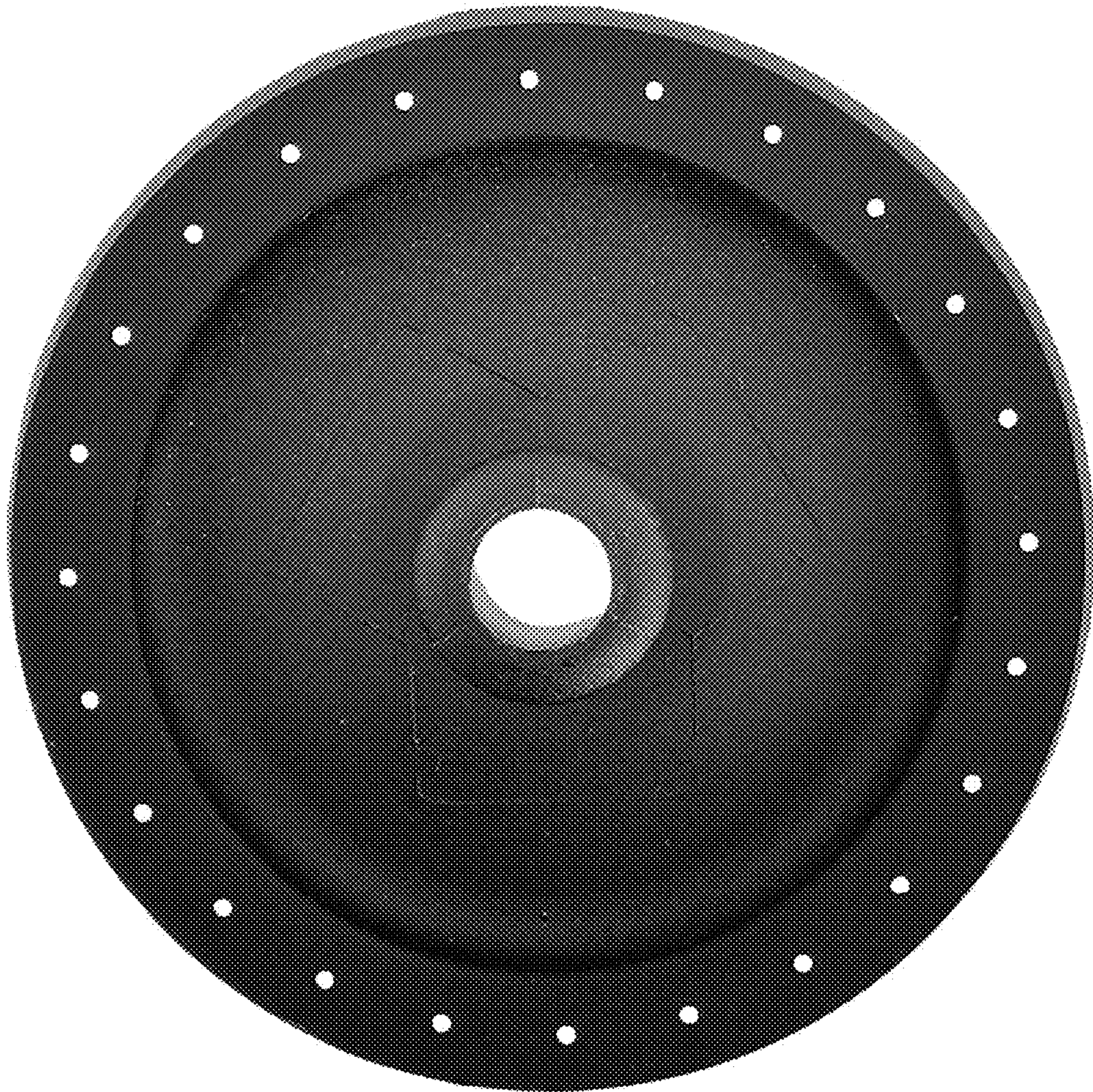
- 1. Push-in sealing cap for reusing disposable coffee capsules
- 1.1—Top perspective view
- 1.2—Bottom perspective view
- 1.3—Second bottom perspective view
- 1.4—Side view
- 1.5—Second top perspective view
- 1.6—Third top perspective view
- 1.7—Top view

The claimed design is for a push-in sealing cap for reusing disposable coffee capsules; the claimed design has pinholes placed on the outer edge and the bigger center hole; a pin with a wider edge at the center bottom is attached below the center hole; the light reflection on the surface of reproductions 1.3, 1.5 to 1.7 forms no part of the claimed design.

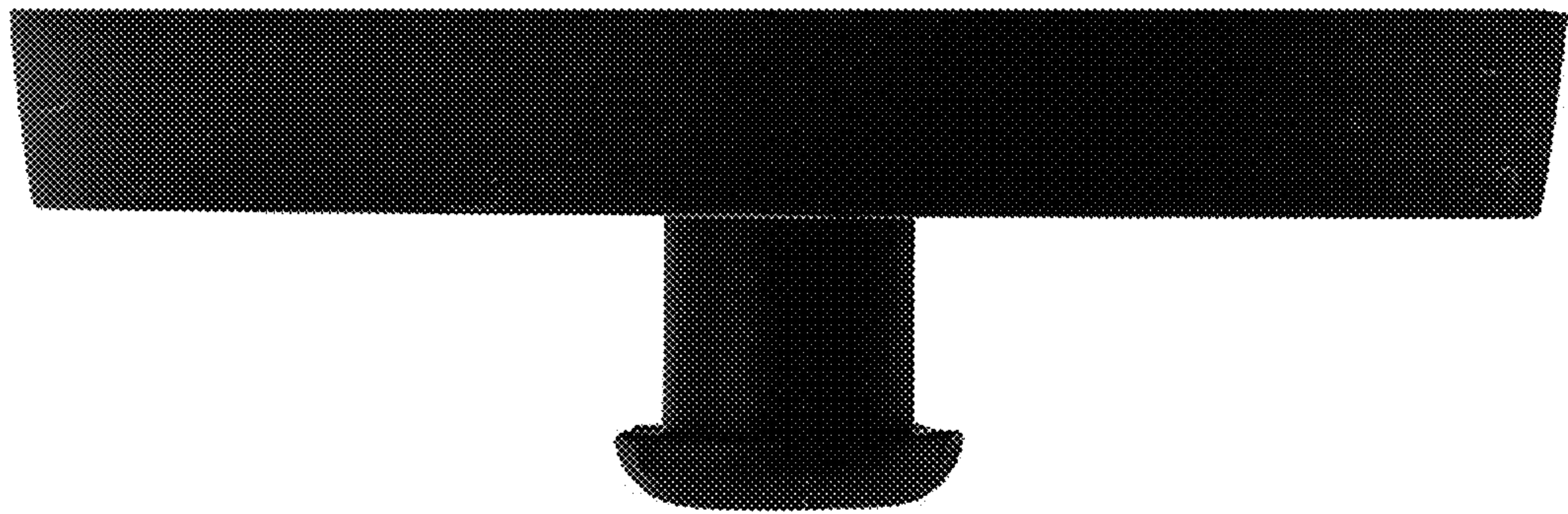
