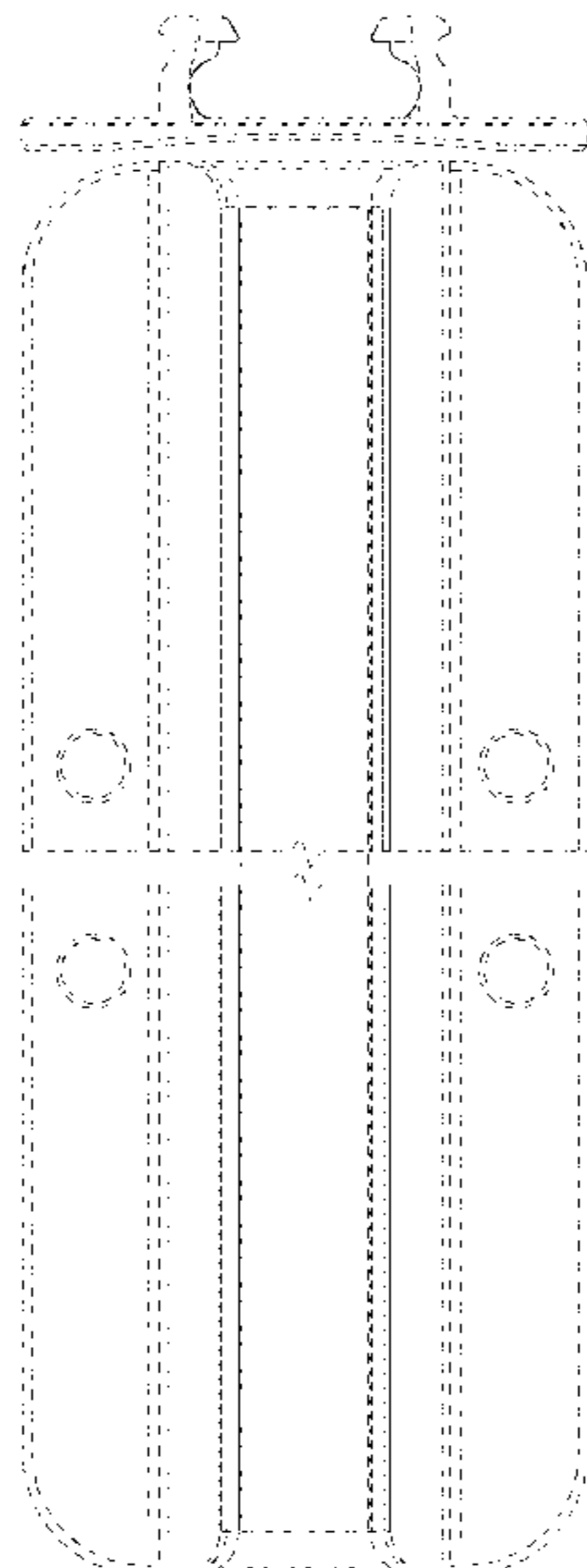
(57) **CLAIM**

The ornamental design for a accessory mounting track, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an accessory mounting track showing my new design; and, FIG. 2 is a top plan view thereof. The features illustrated in broken lines in FIGS. 3 and 4 form no part of the claimed design. The breakaway symbols illustrated in broken lines in the drawings indicate a symbolic length in the length of the accessory mounting track. The appearance of any portion of the accessory mounting track between the breakaway symbols forms no part of the claimed design.

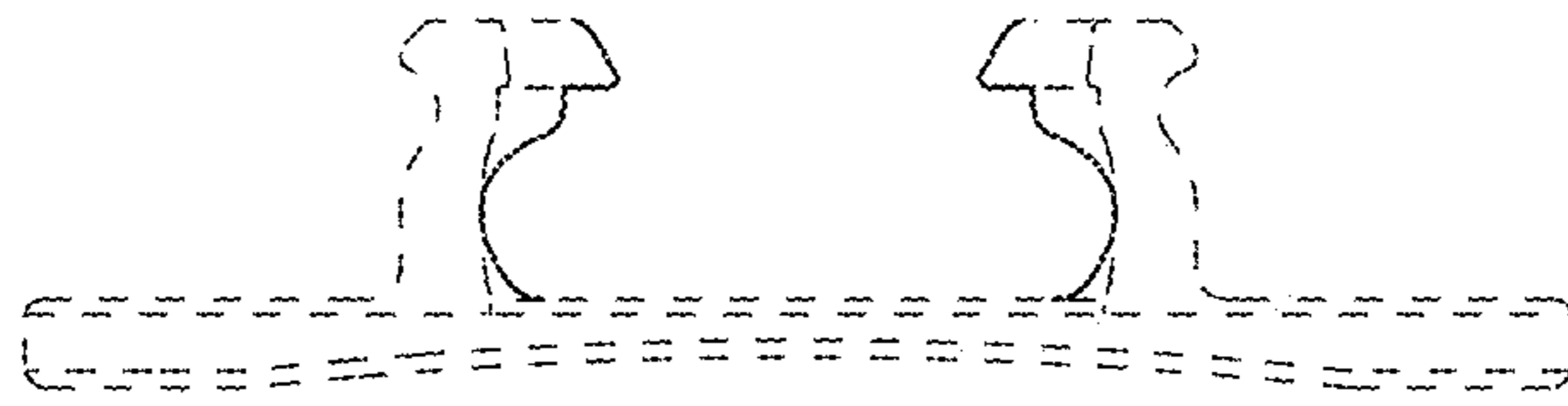

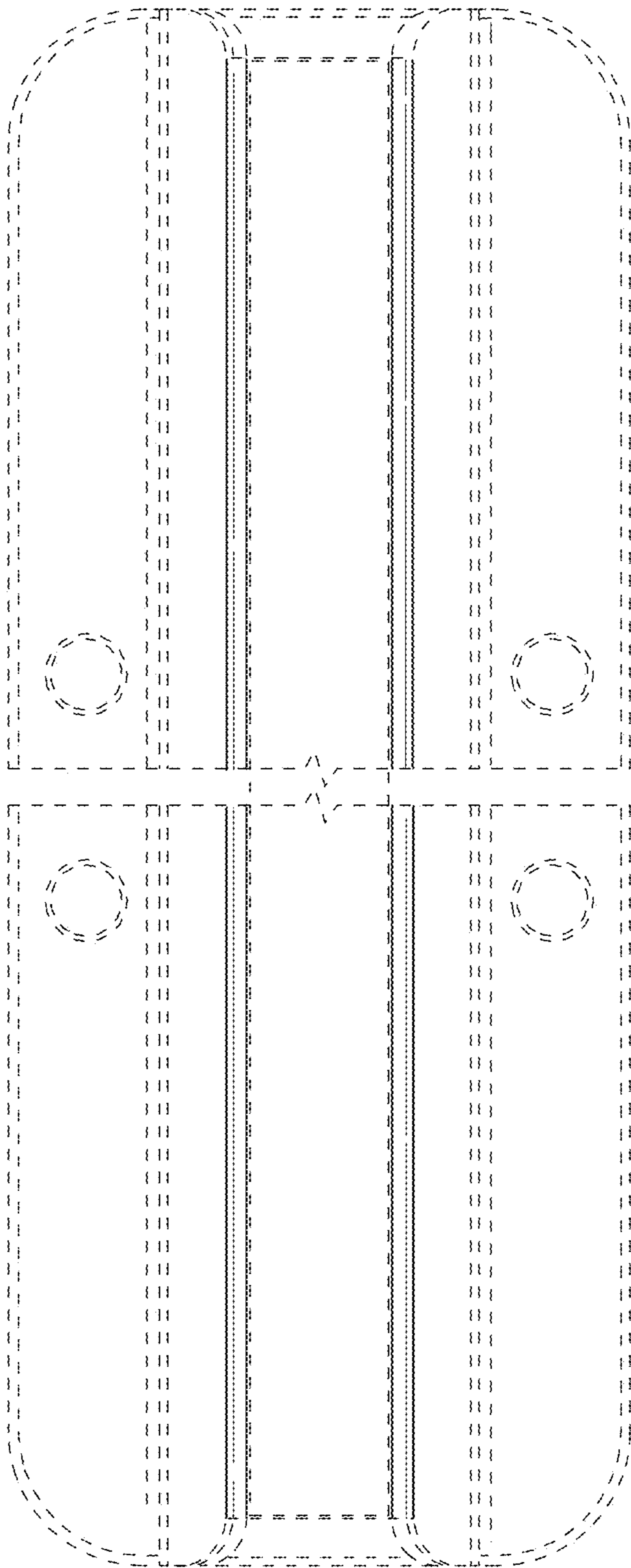
