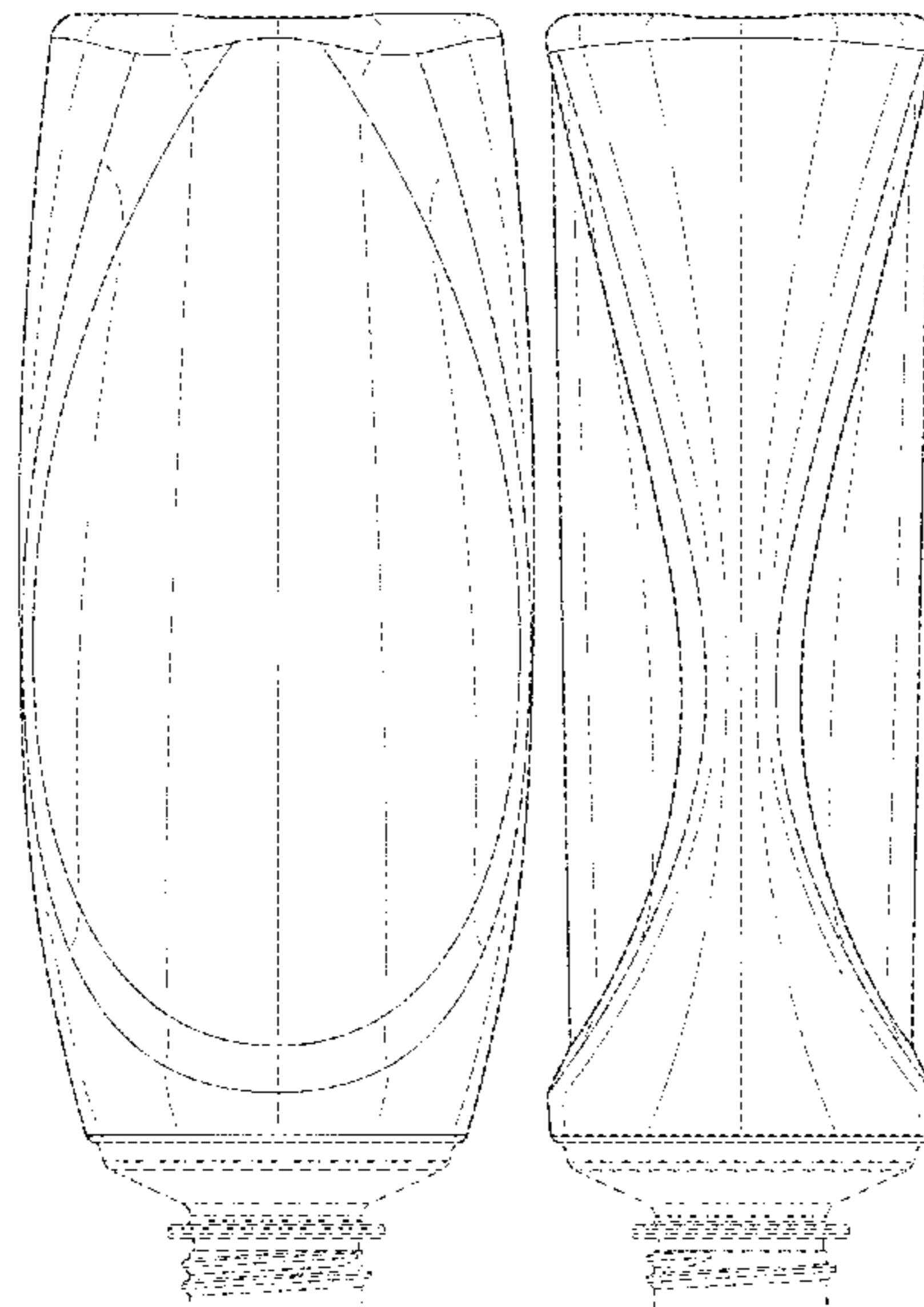
FIG. 1 is a perspective view of a bottom dispensing con-

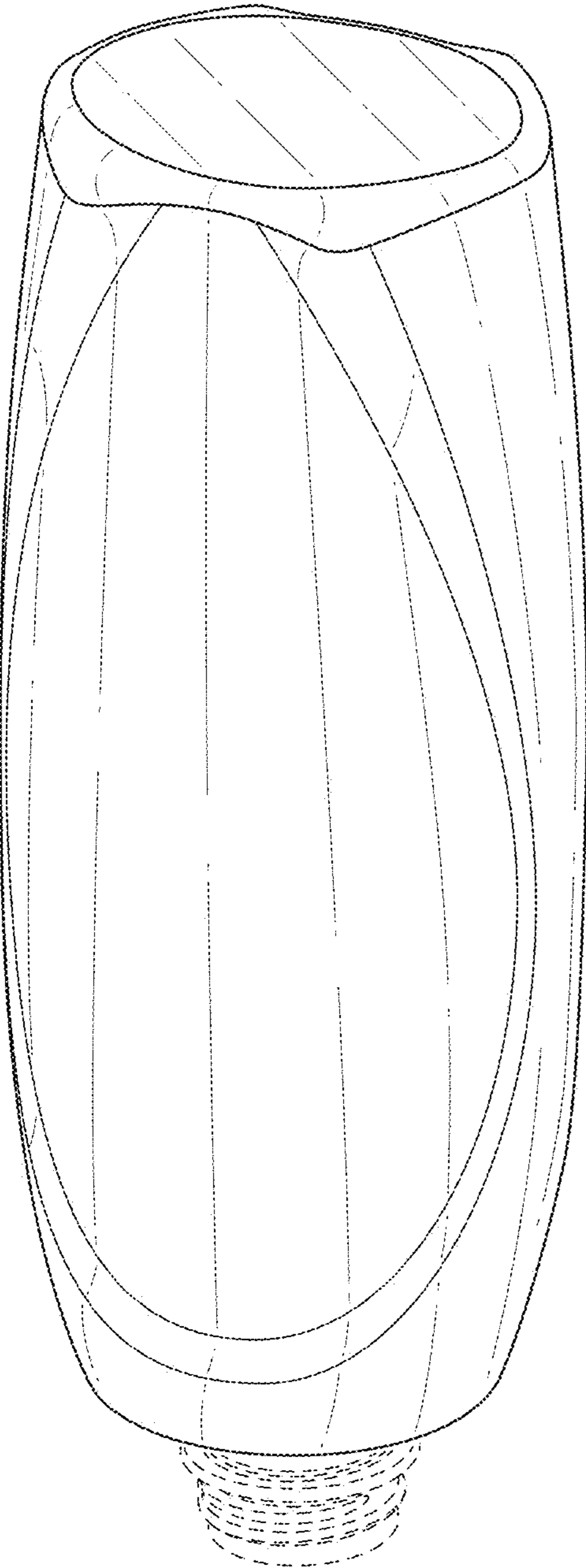

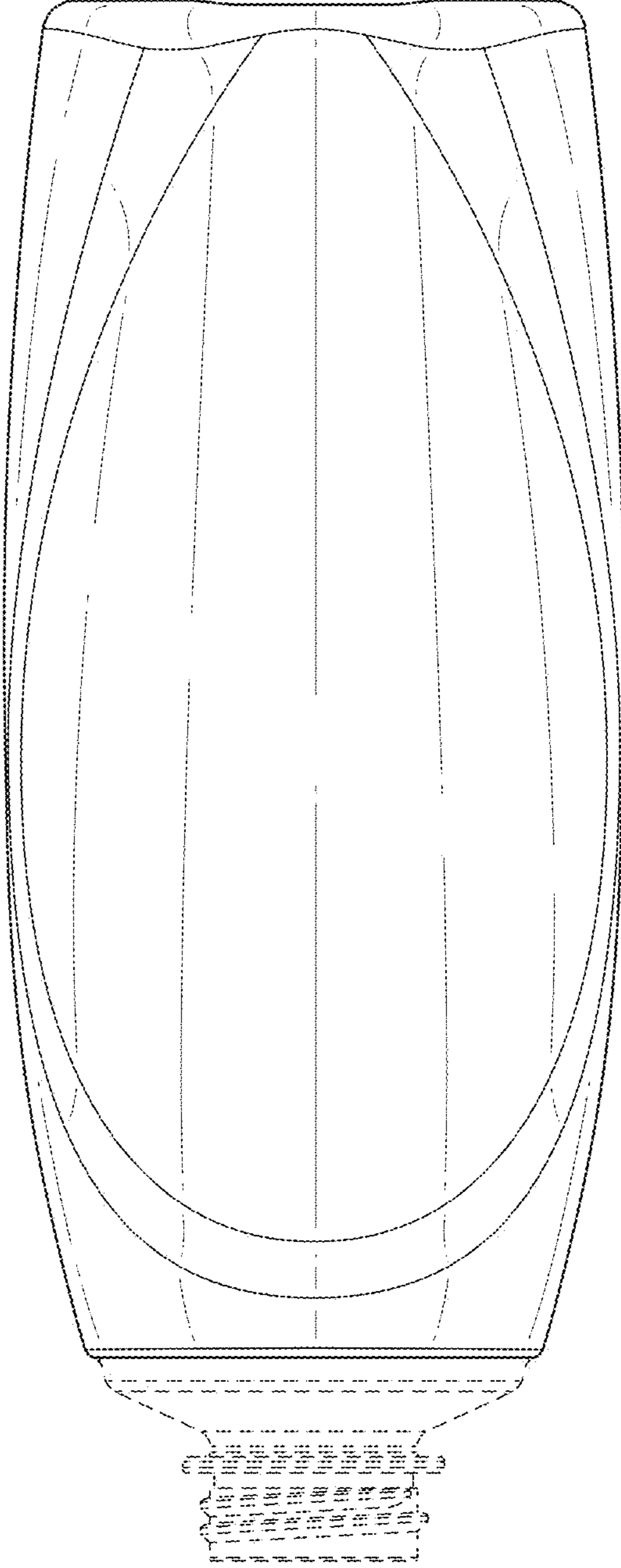

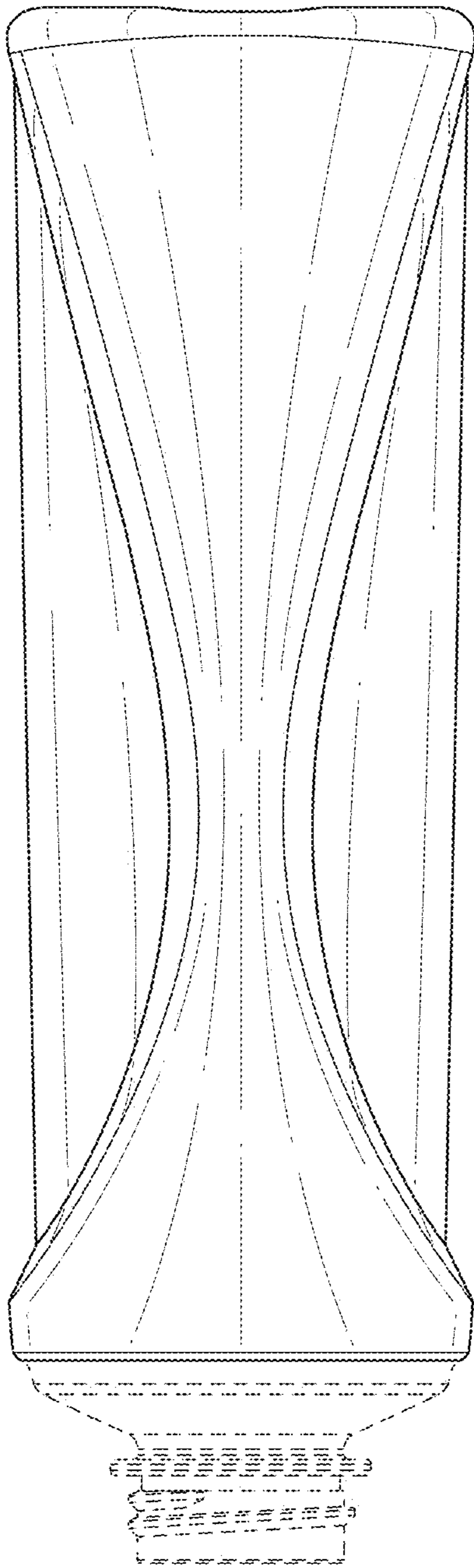

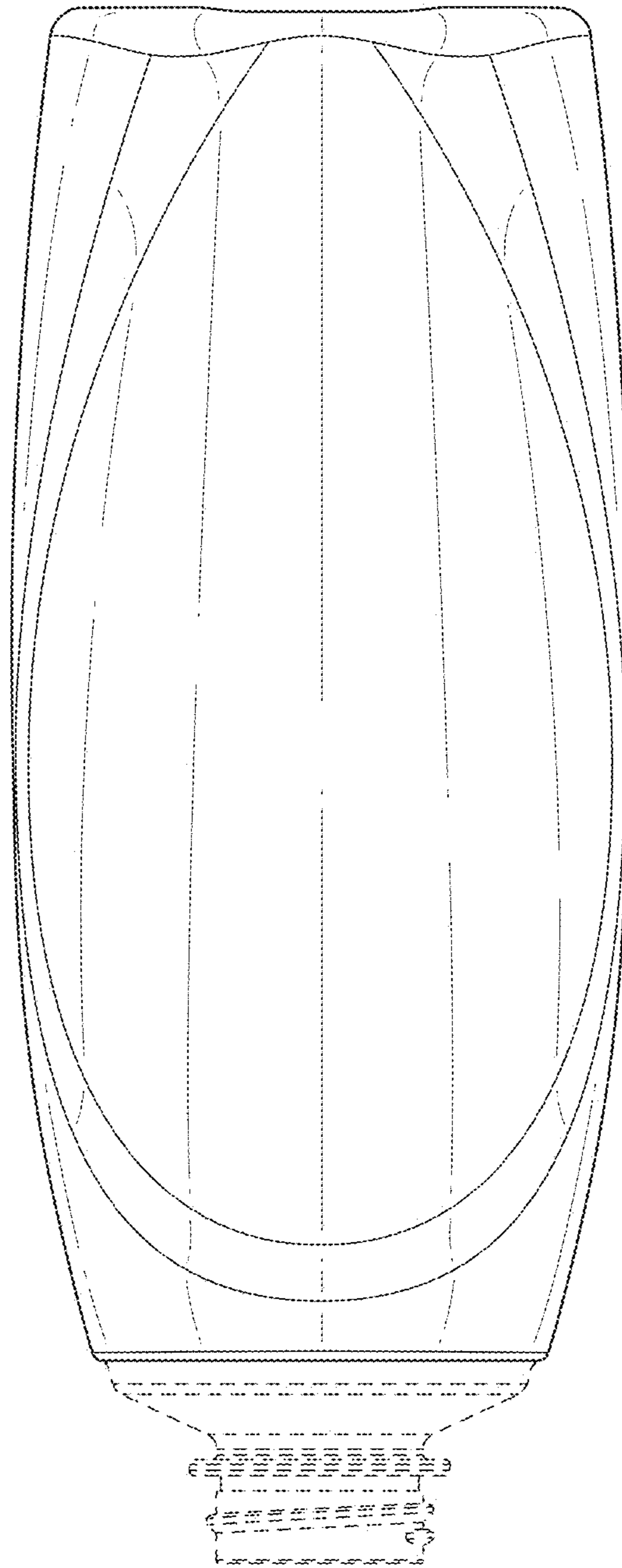

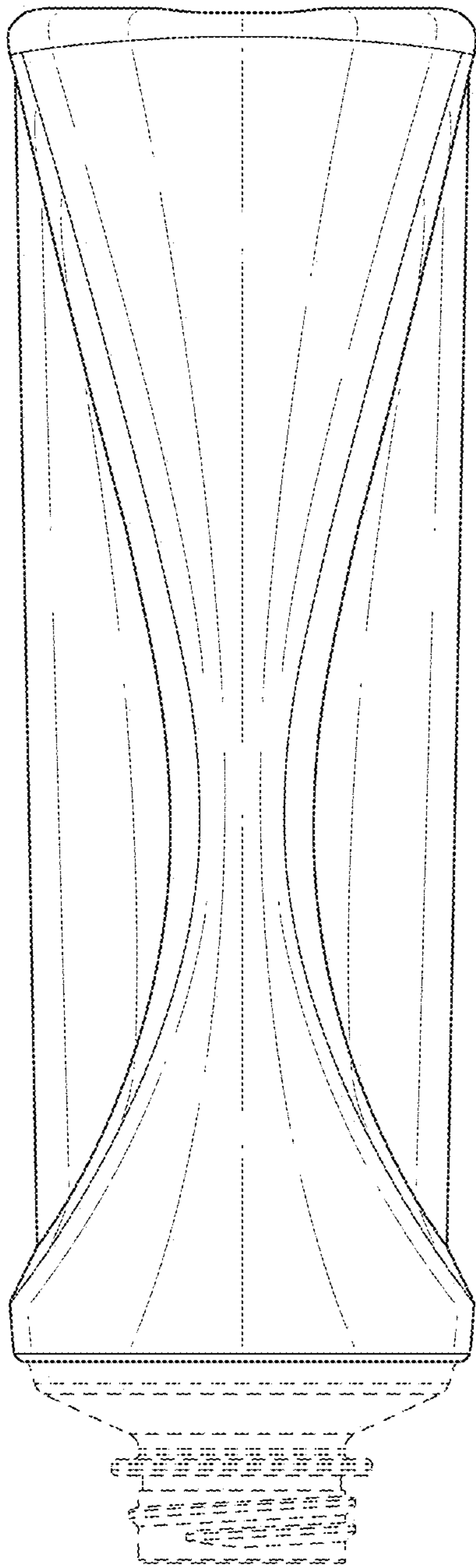

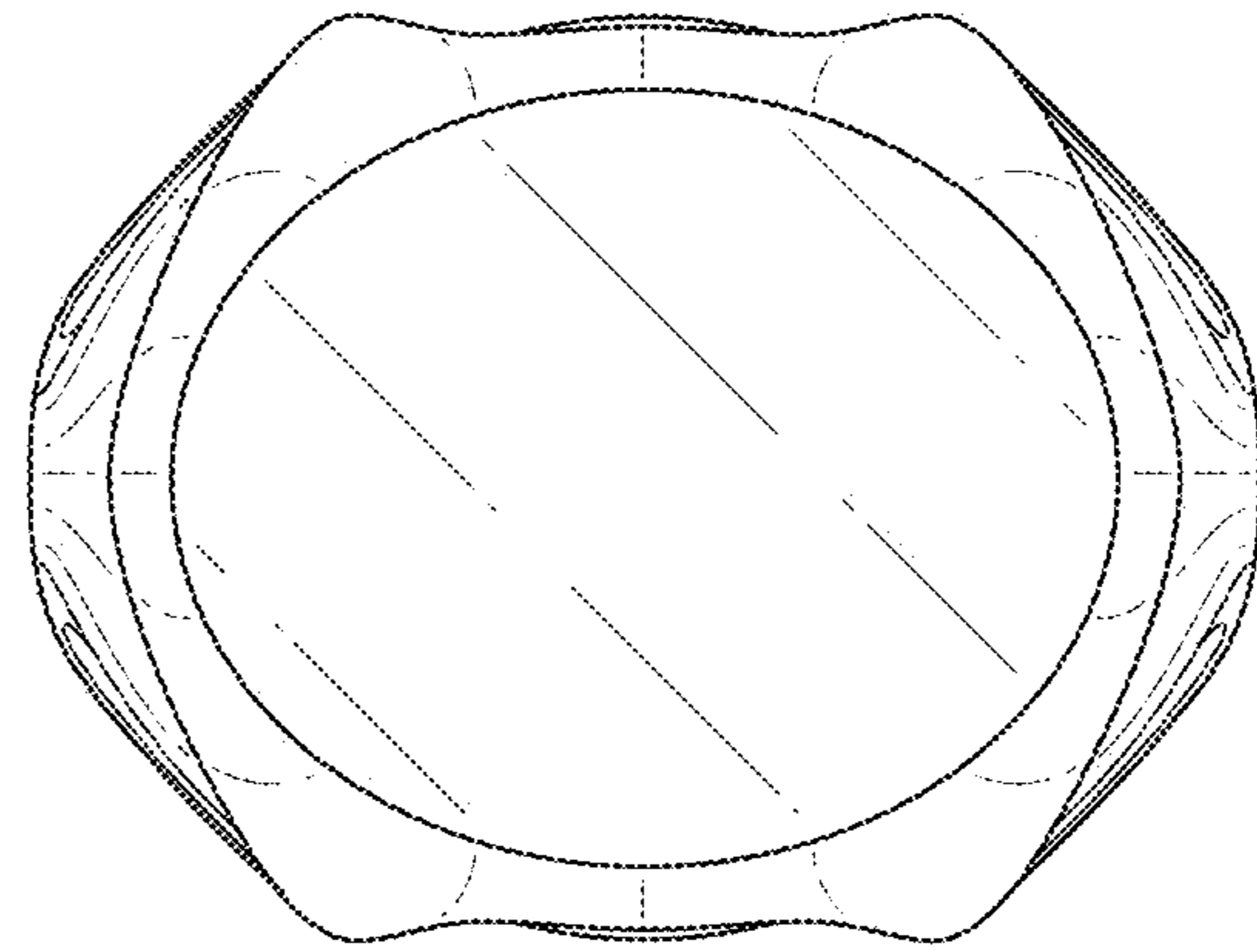

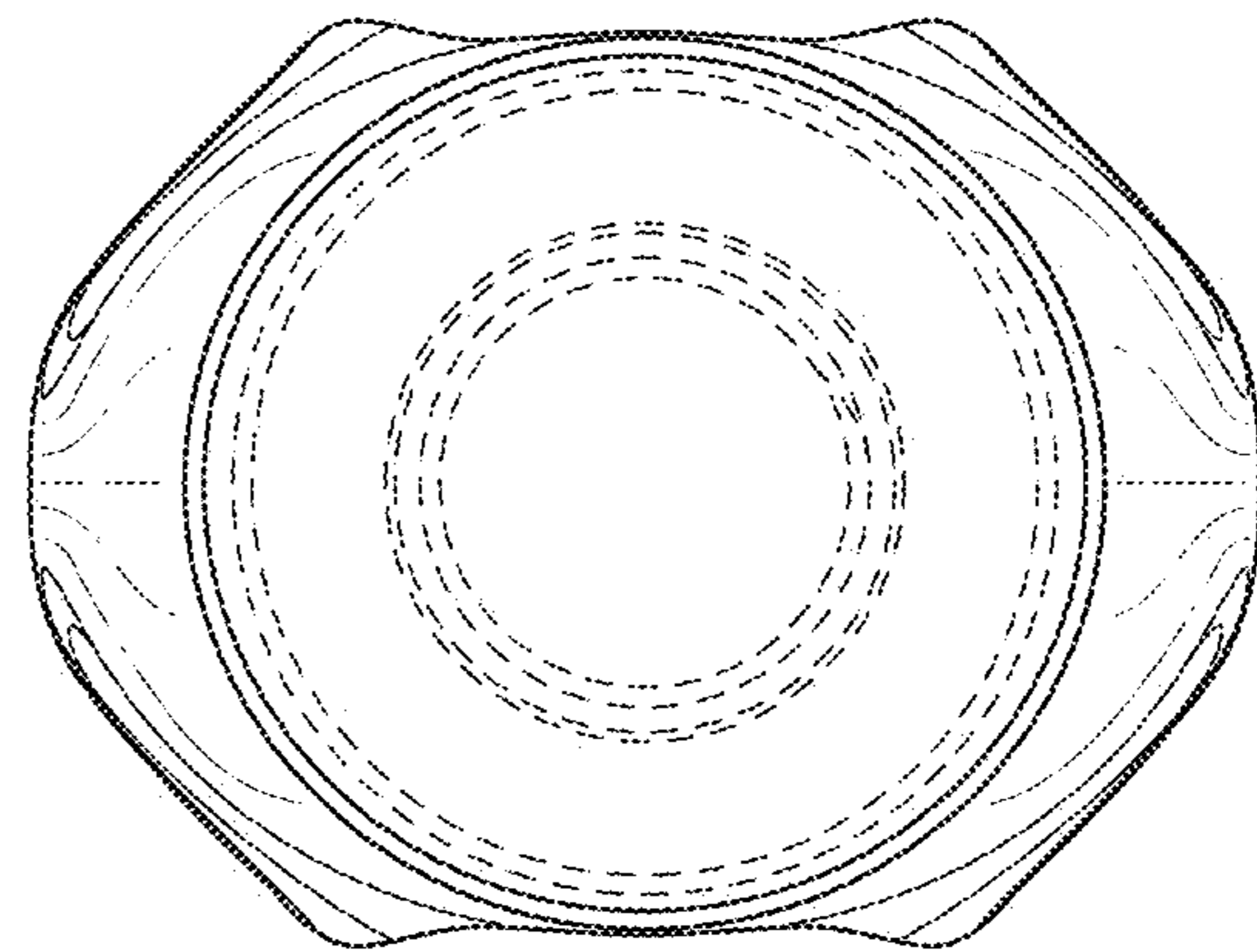
