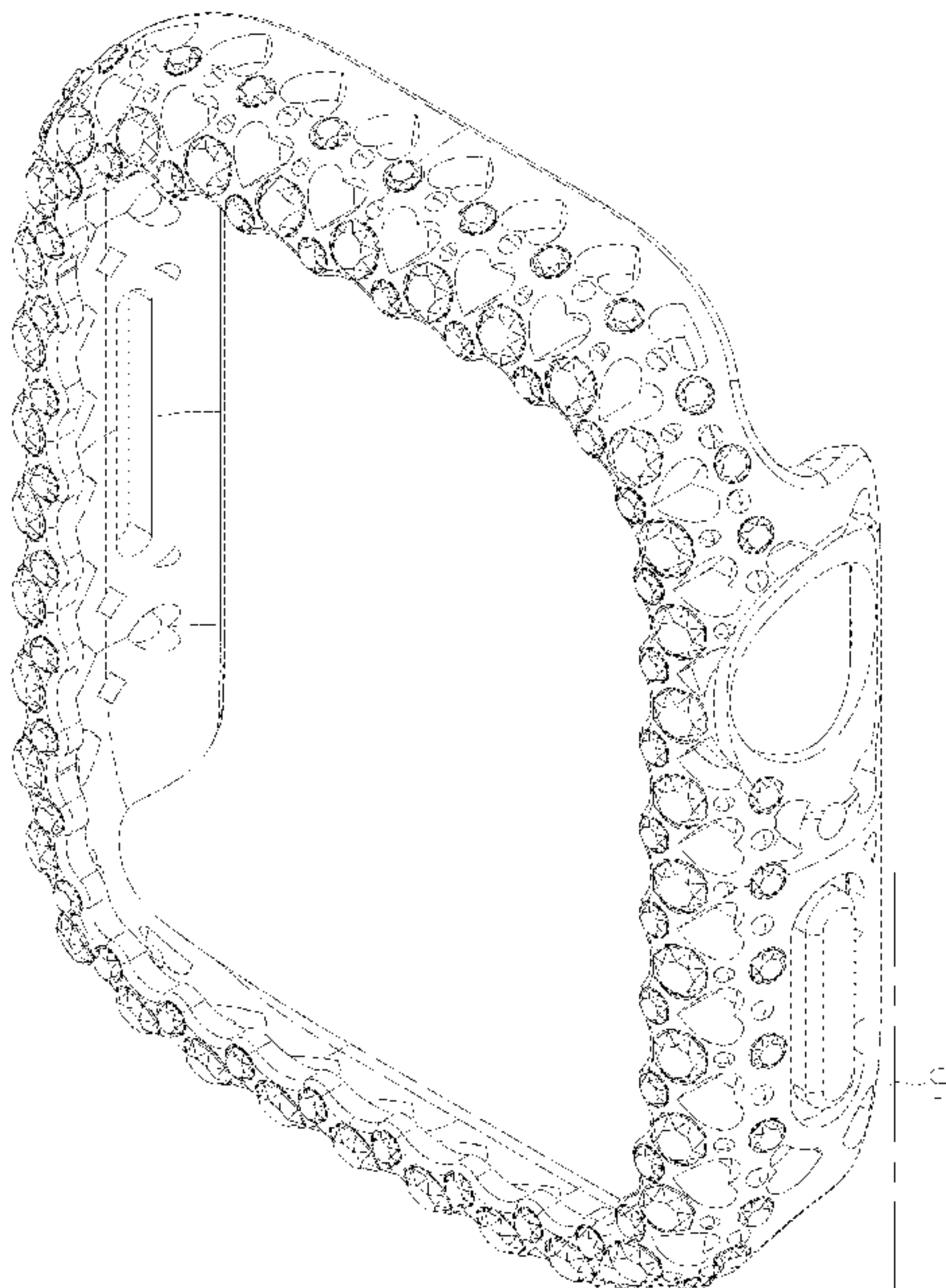
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front, right and top perspective view of a protective case for smartwatch, showing my design.  
FIG. 2 is a rear, left and bottom perspective view thereof.  
FIG. 3 is a front elevation view thereof.  
FIG. 4 is a rear elevation view thereof.  
FIG. 5 is a left side elevation view thereof.

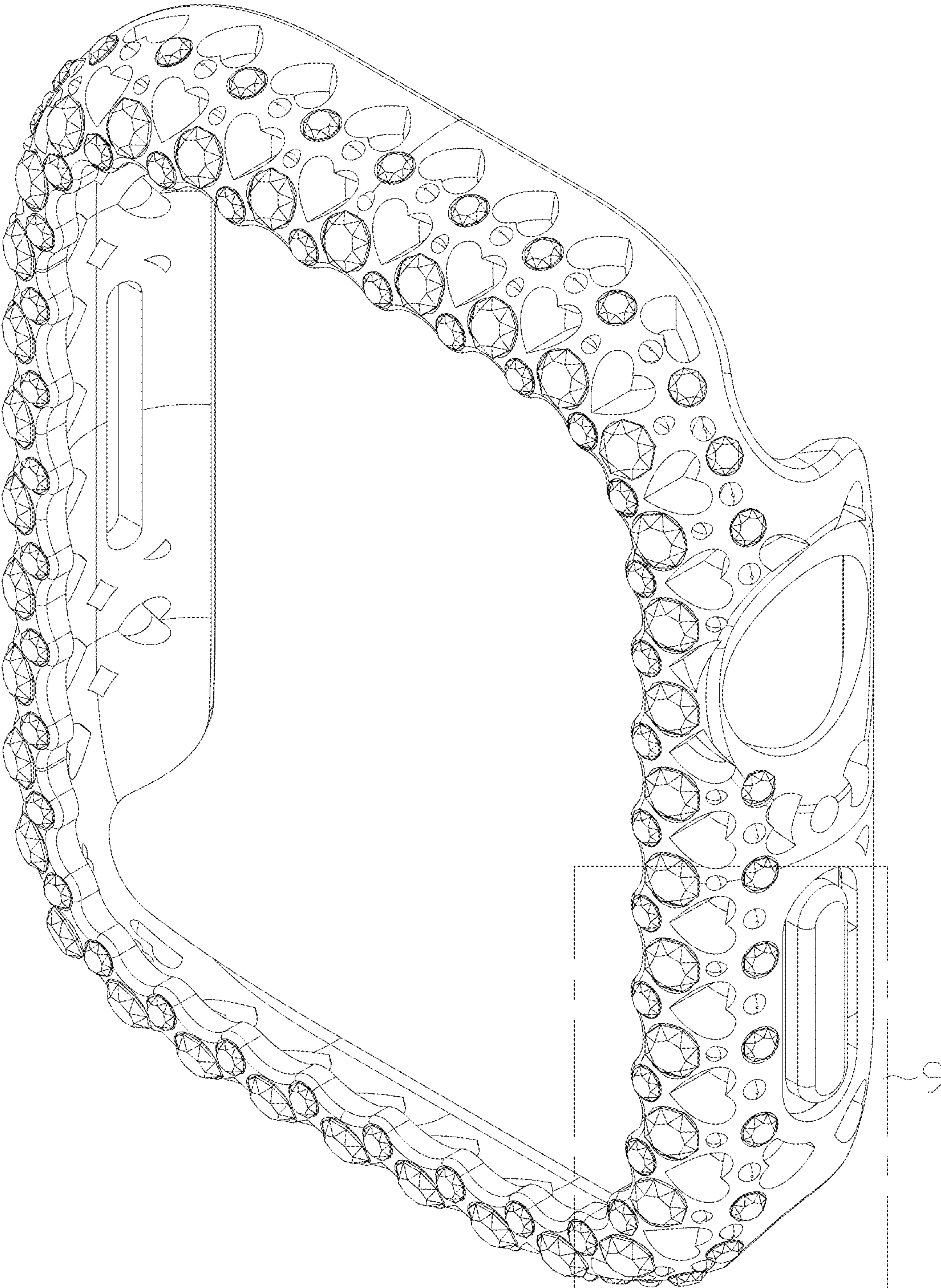

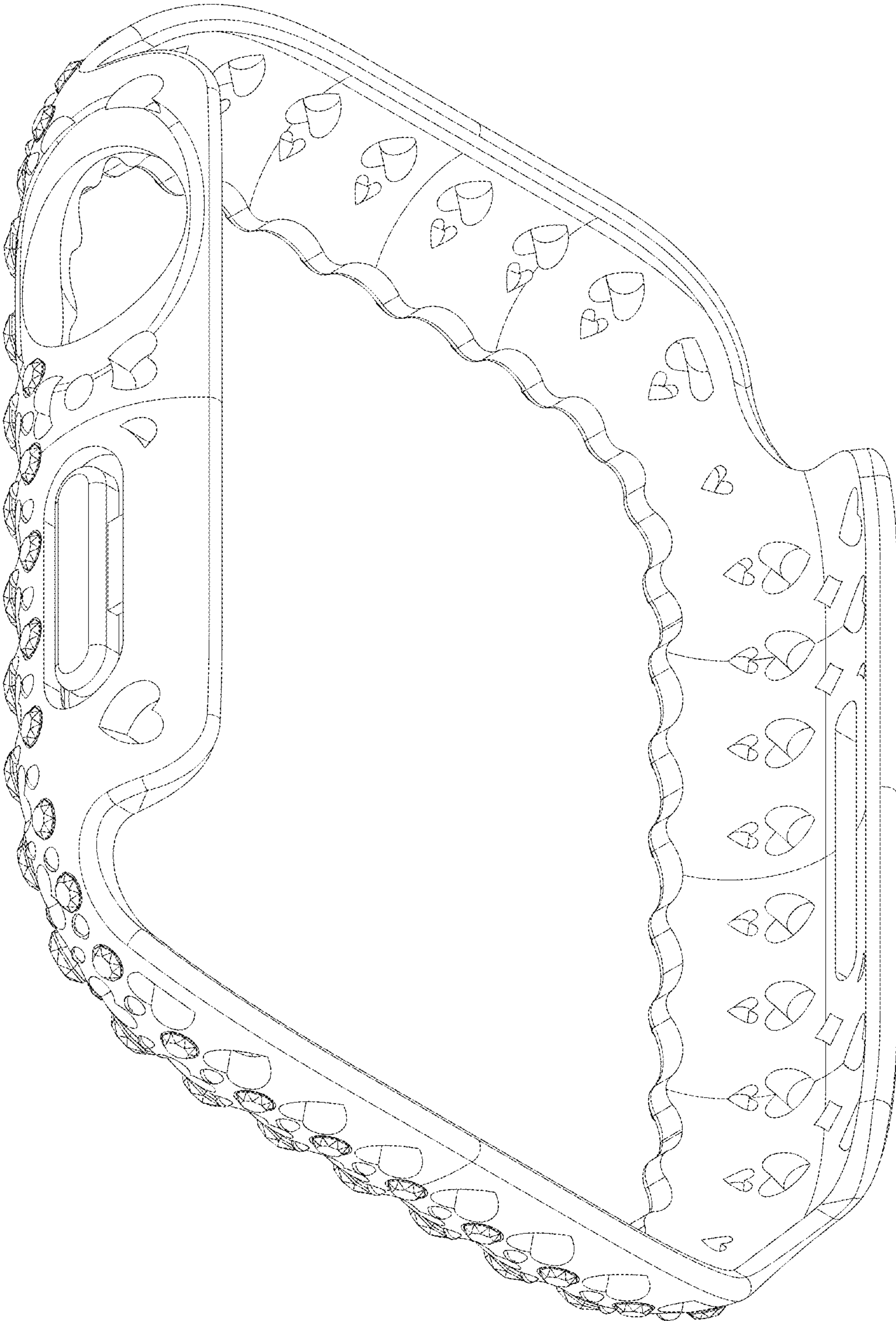

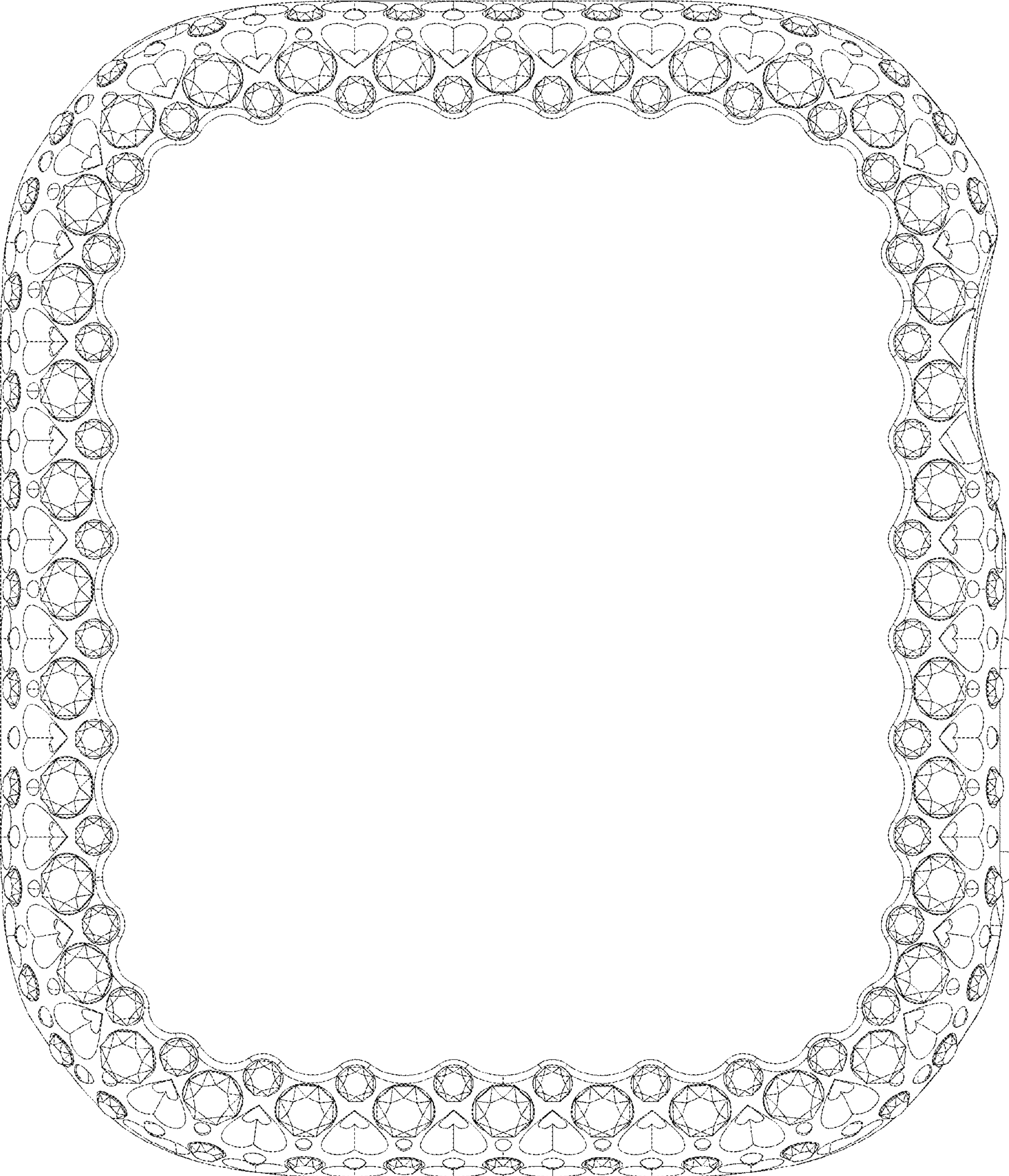

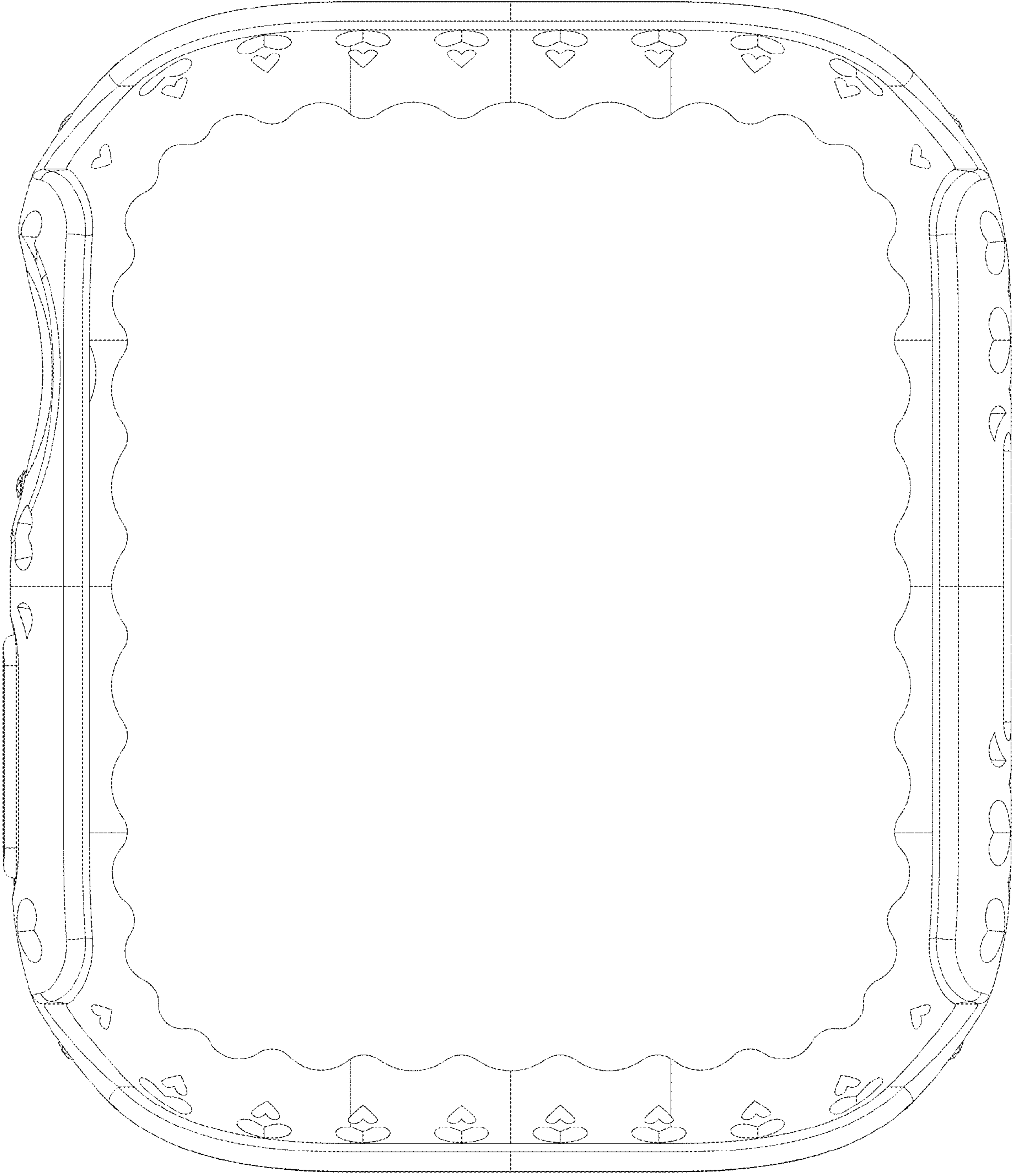

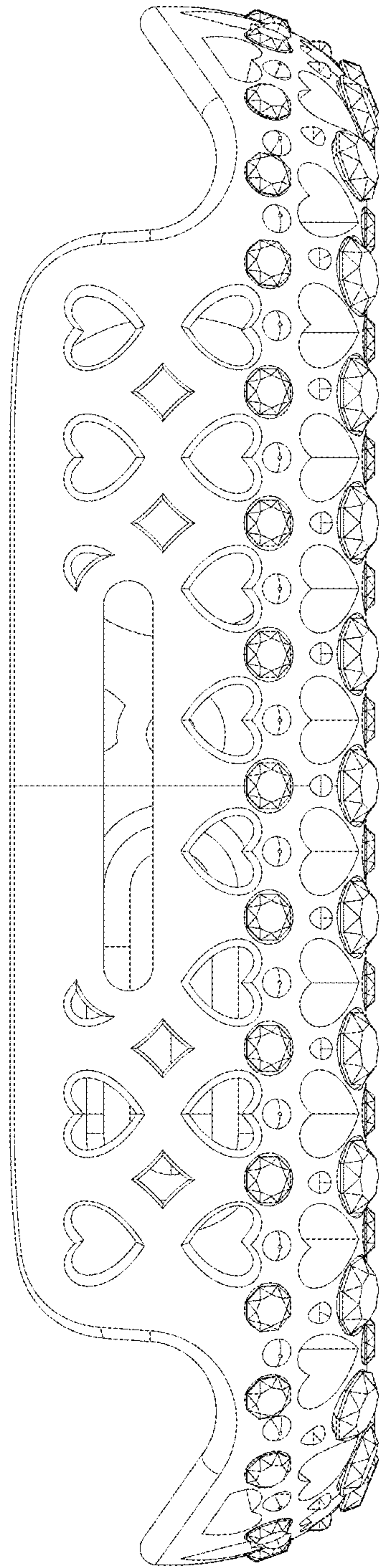

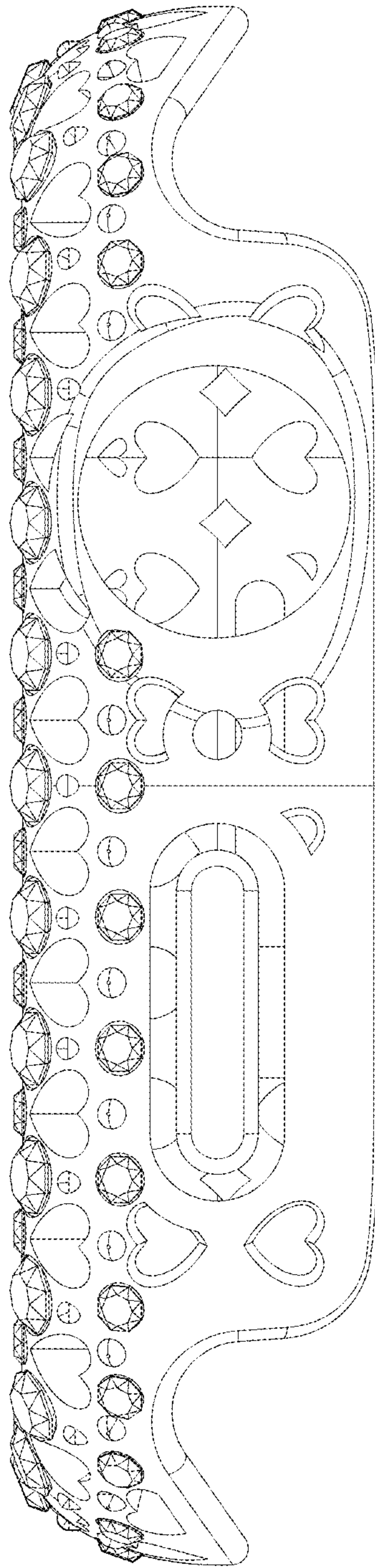

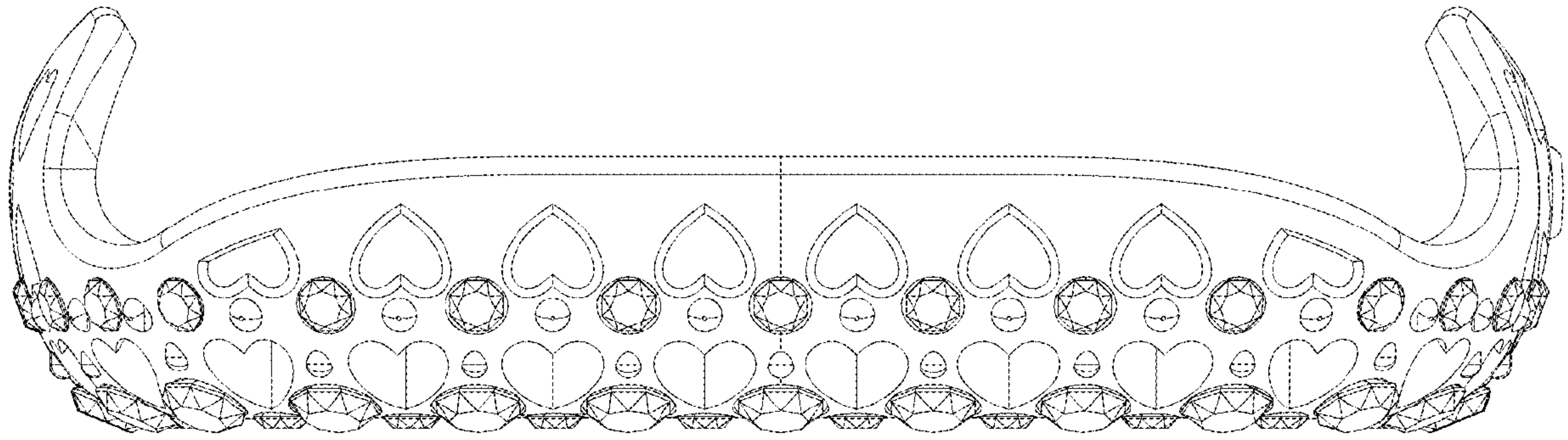

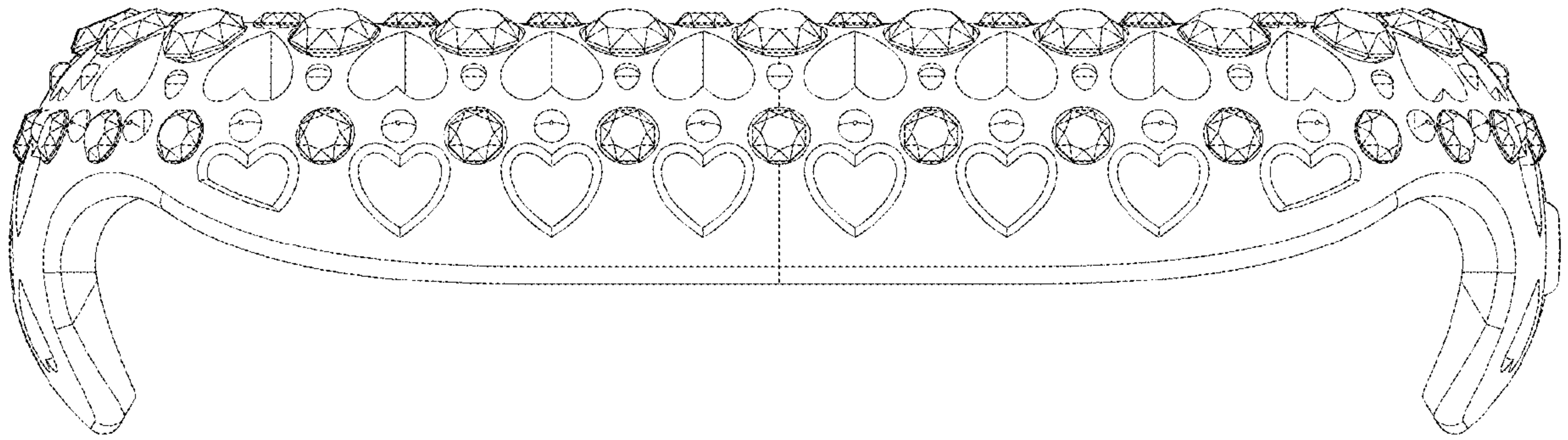

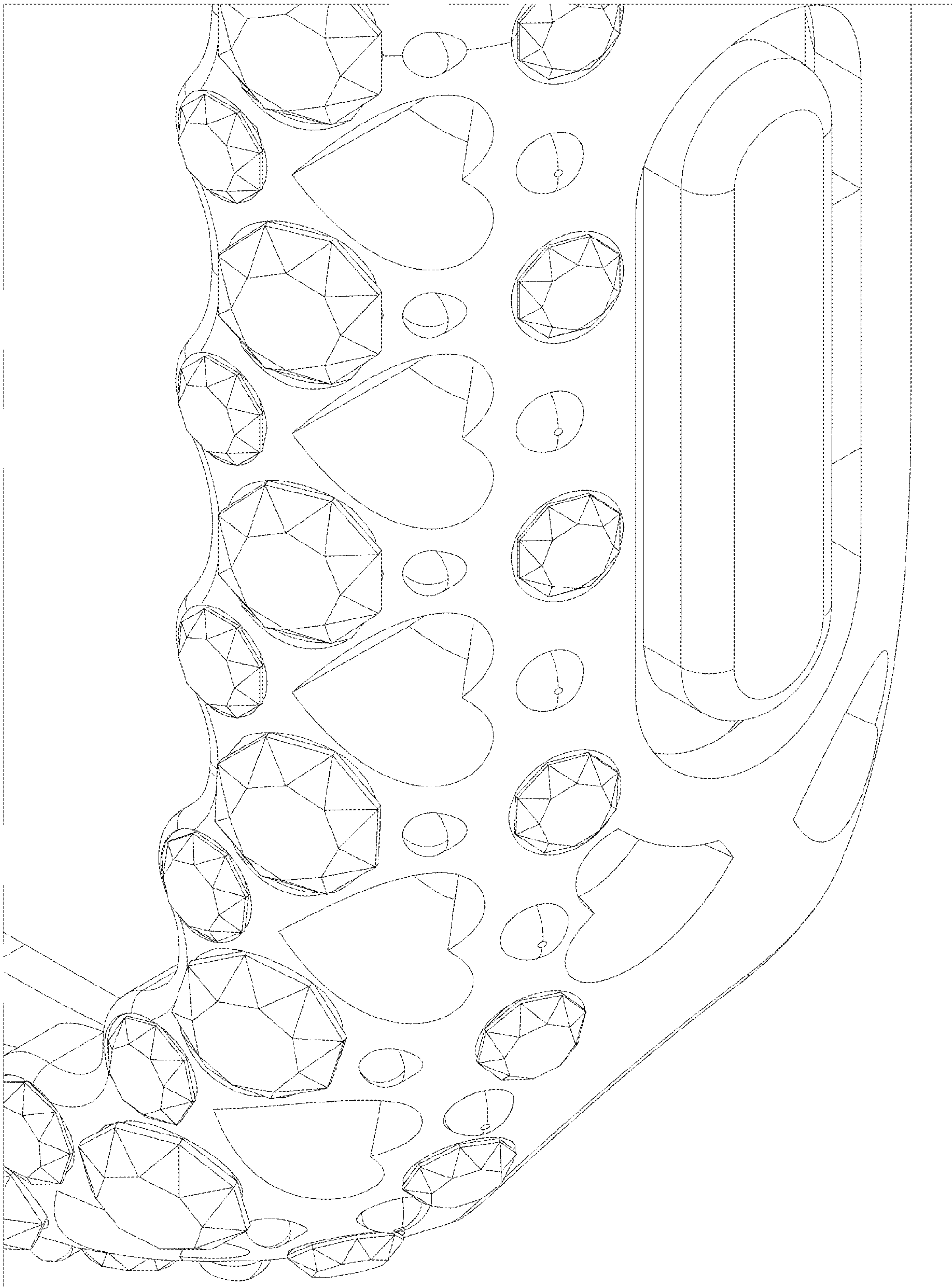
