FIG. 13 is a left side elevation view thereof;

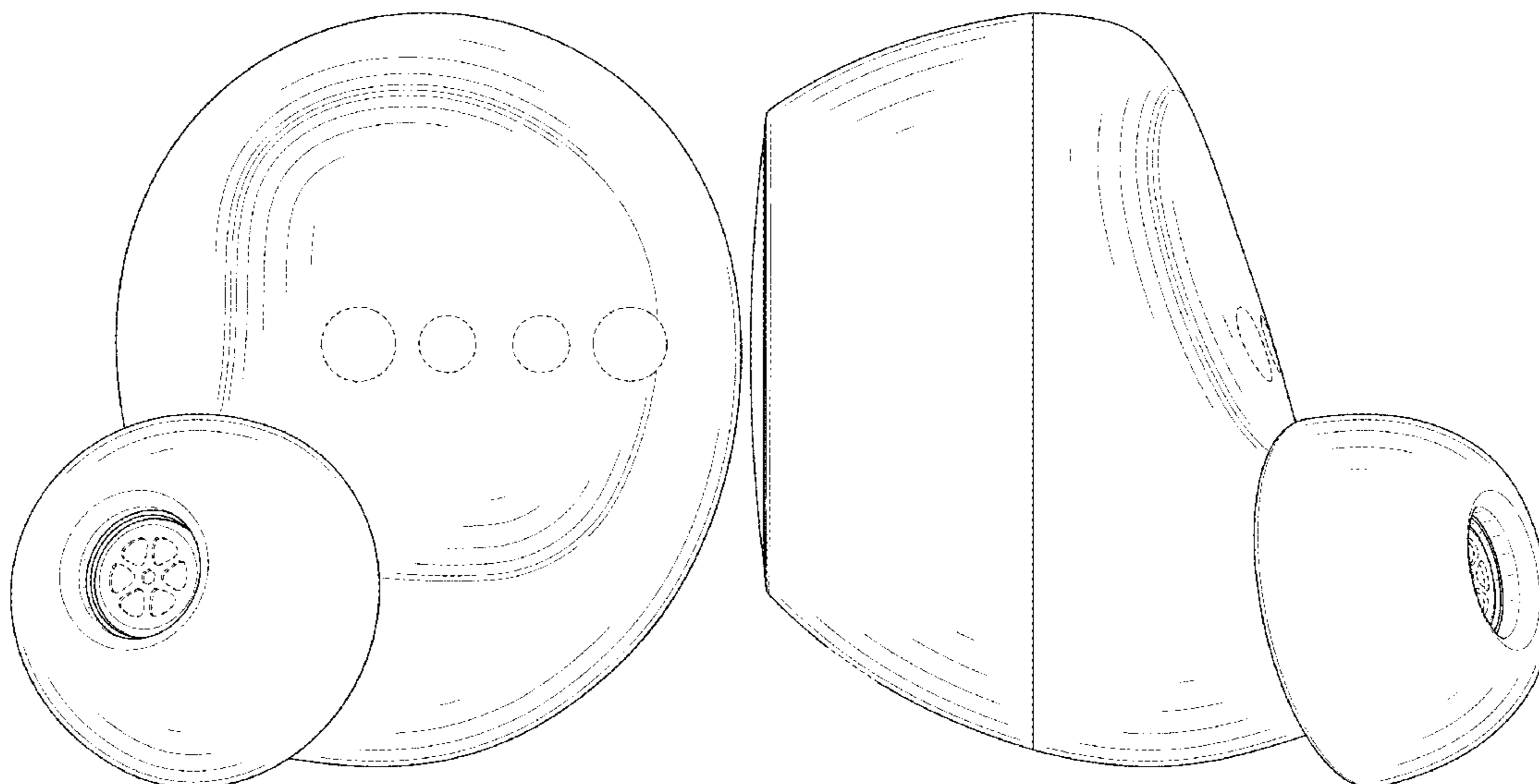
FIG. 14 is a right side elevation view thereof;

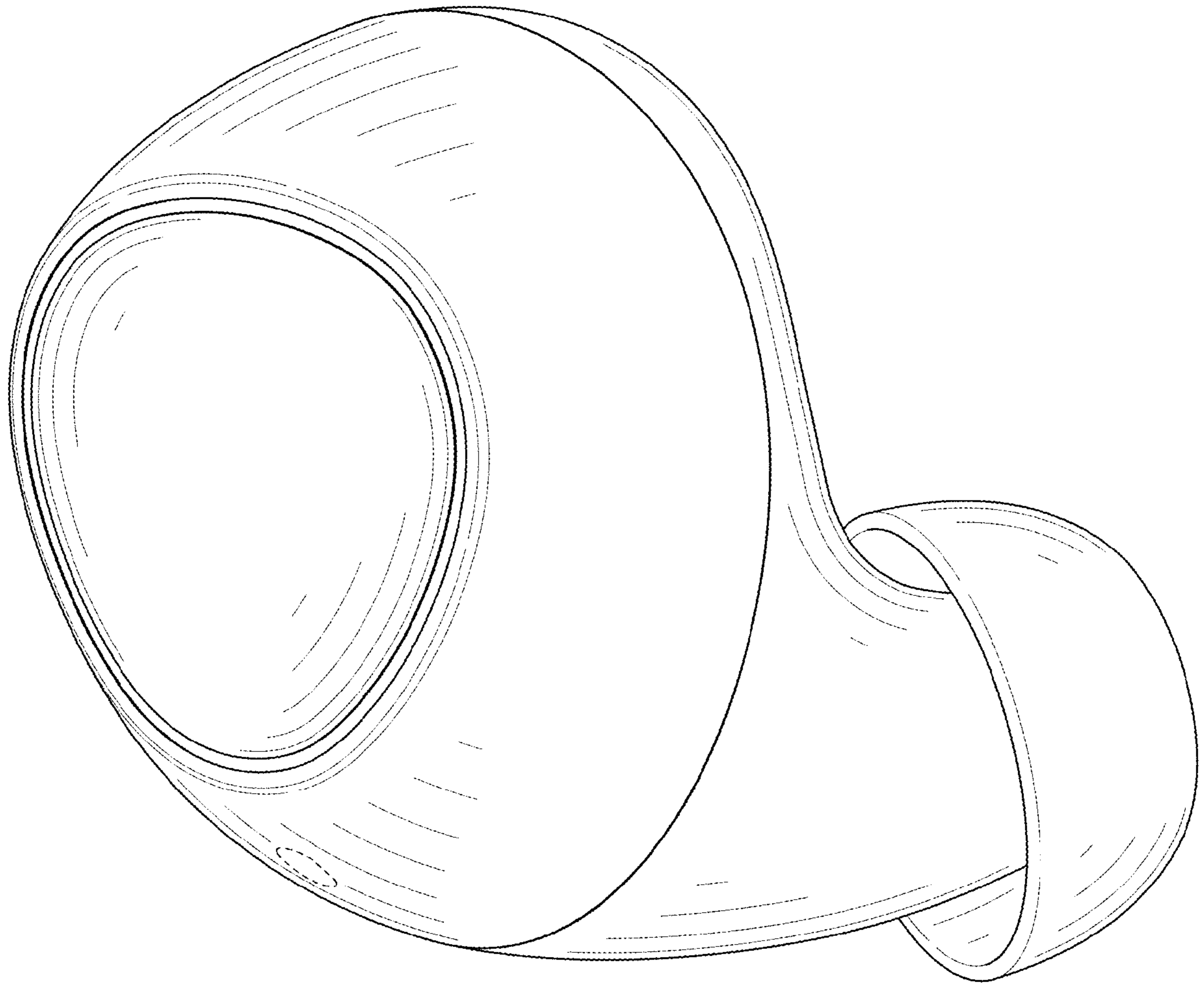

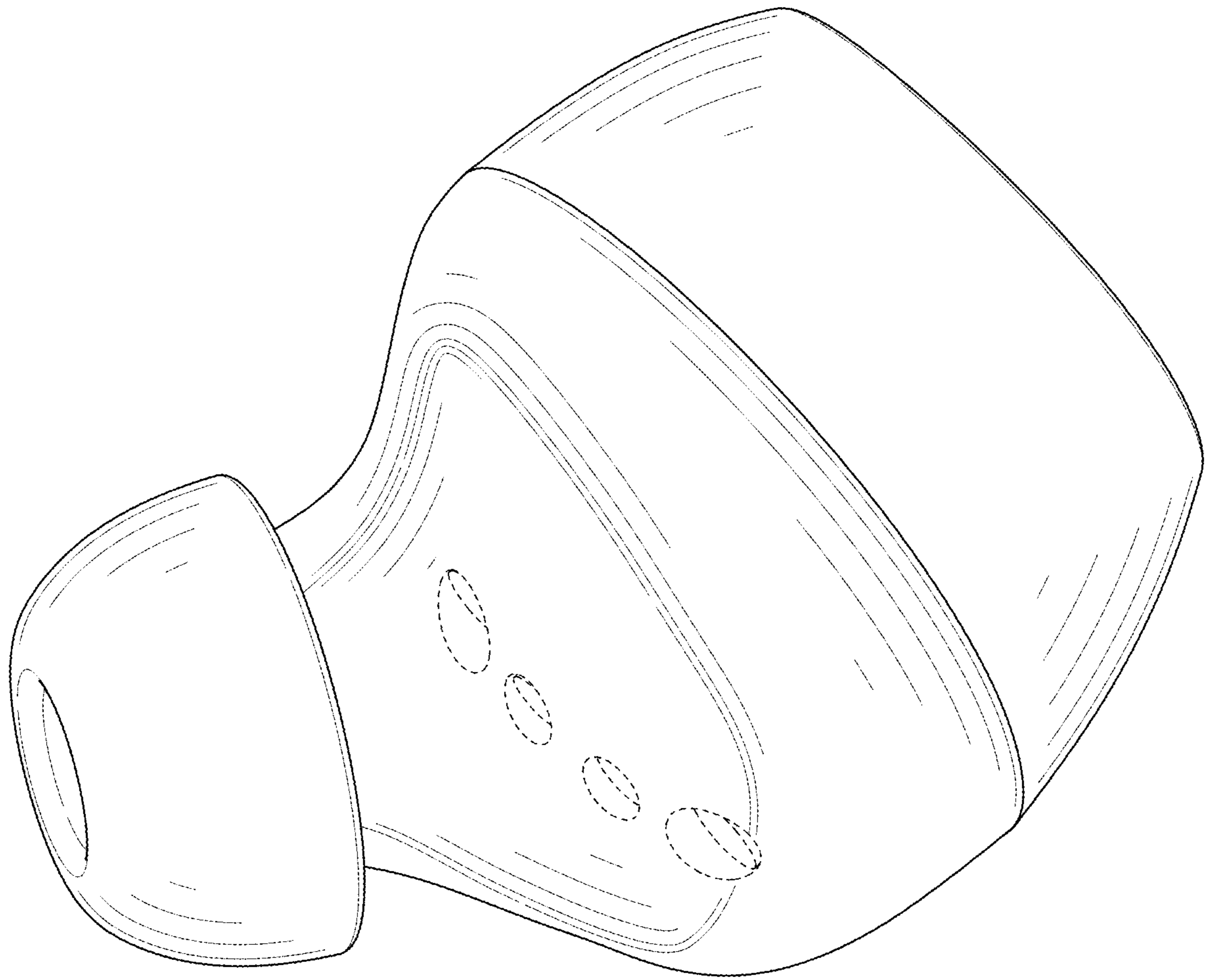

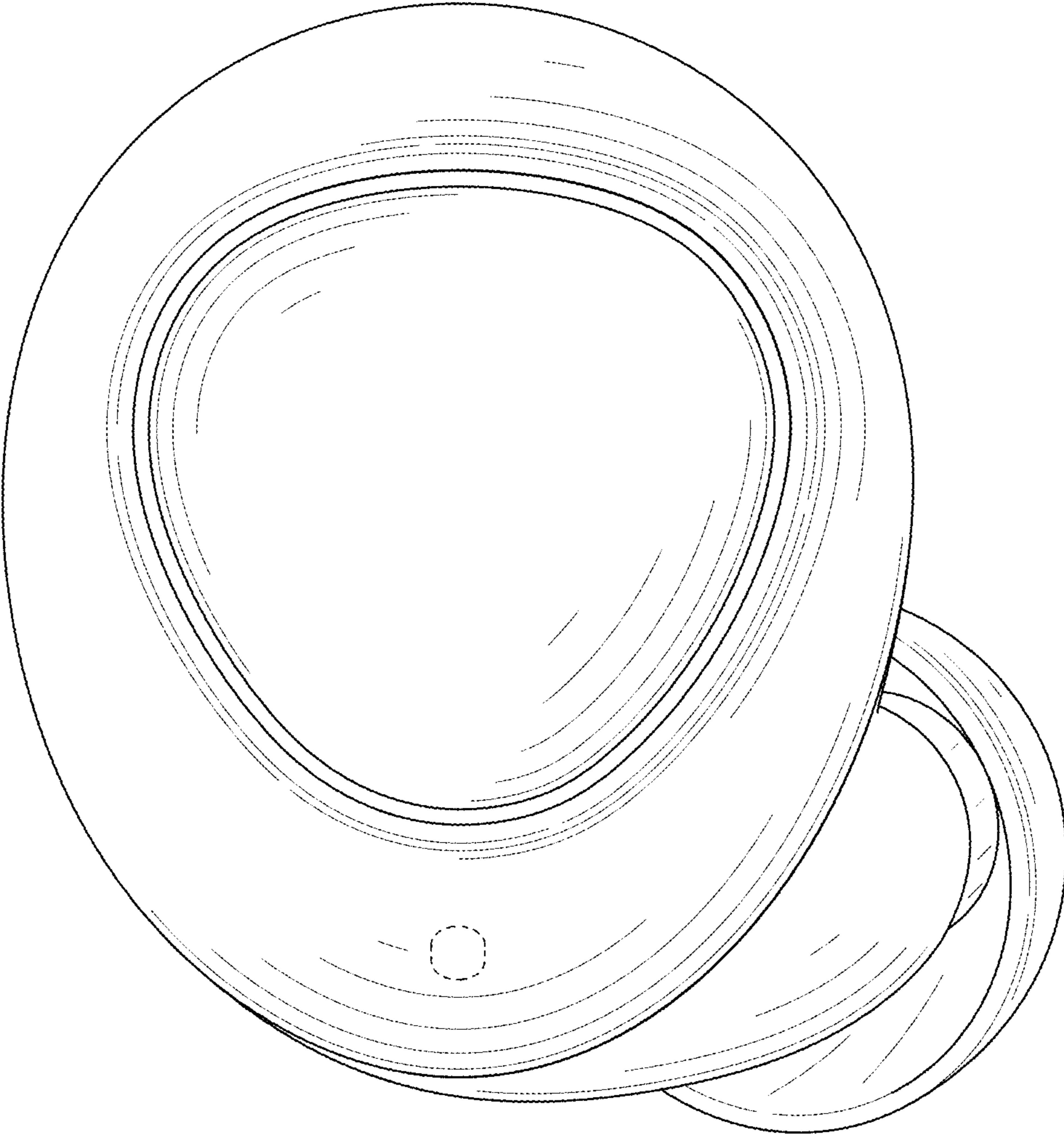

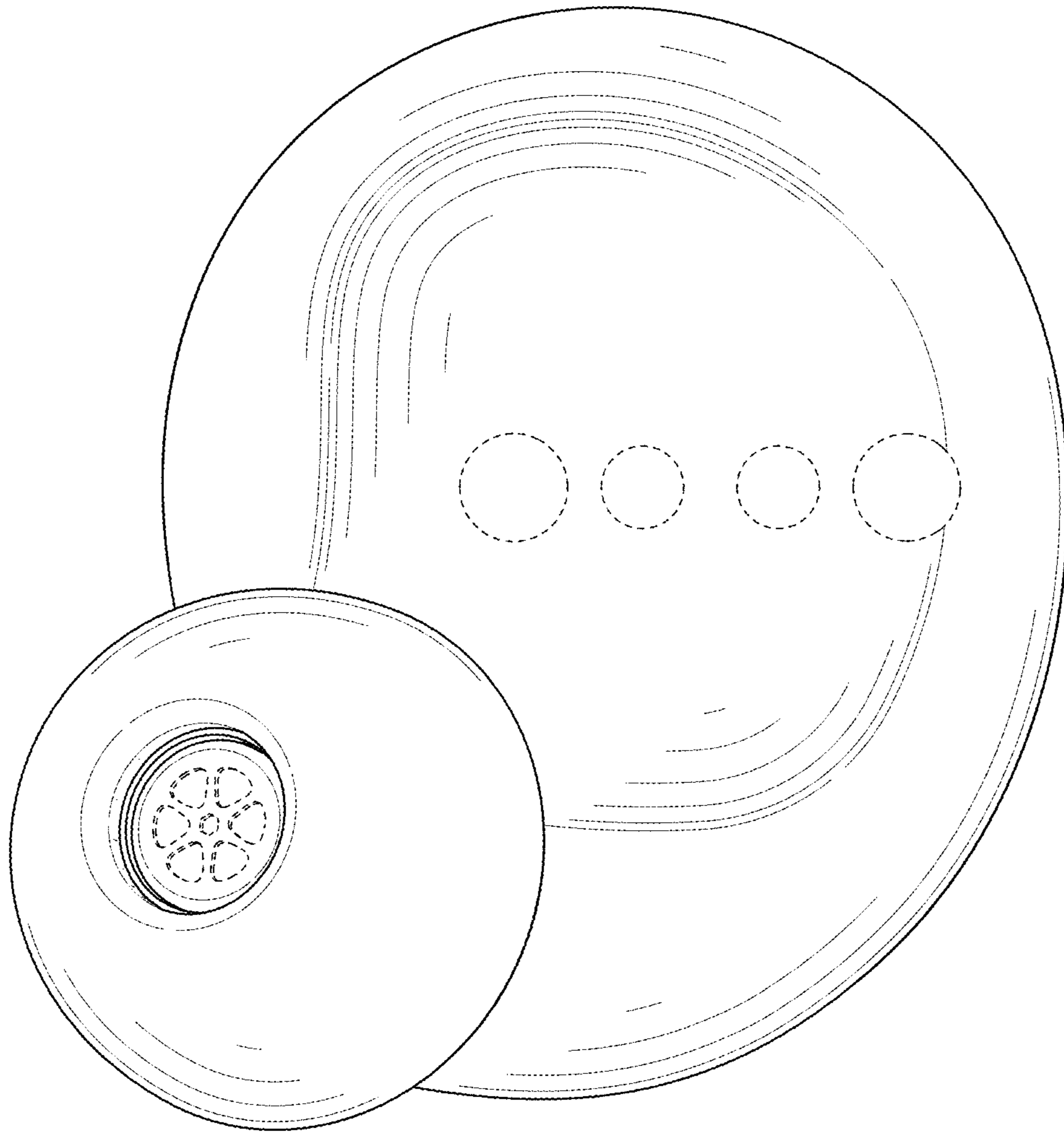

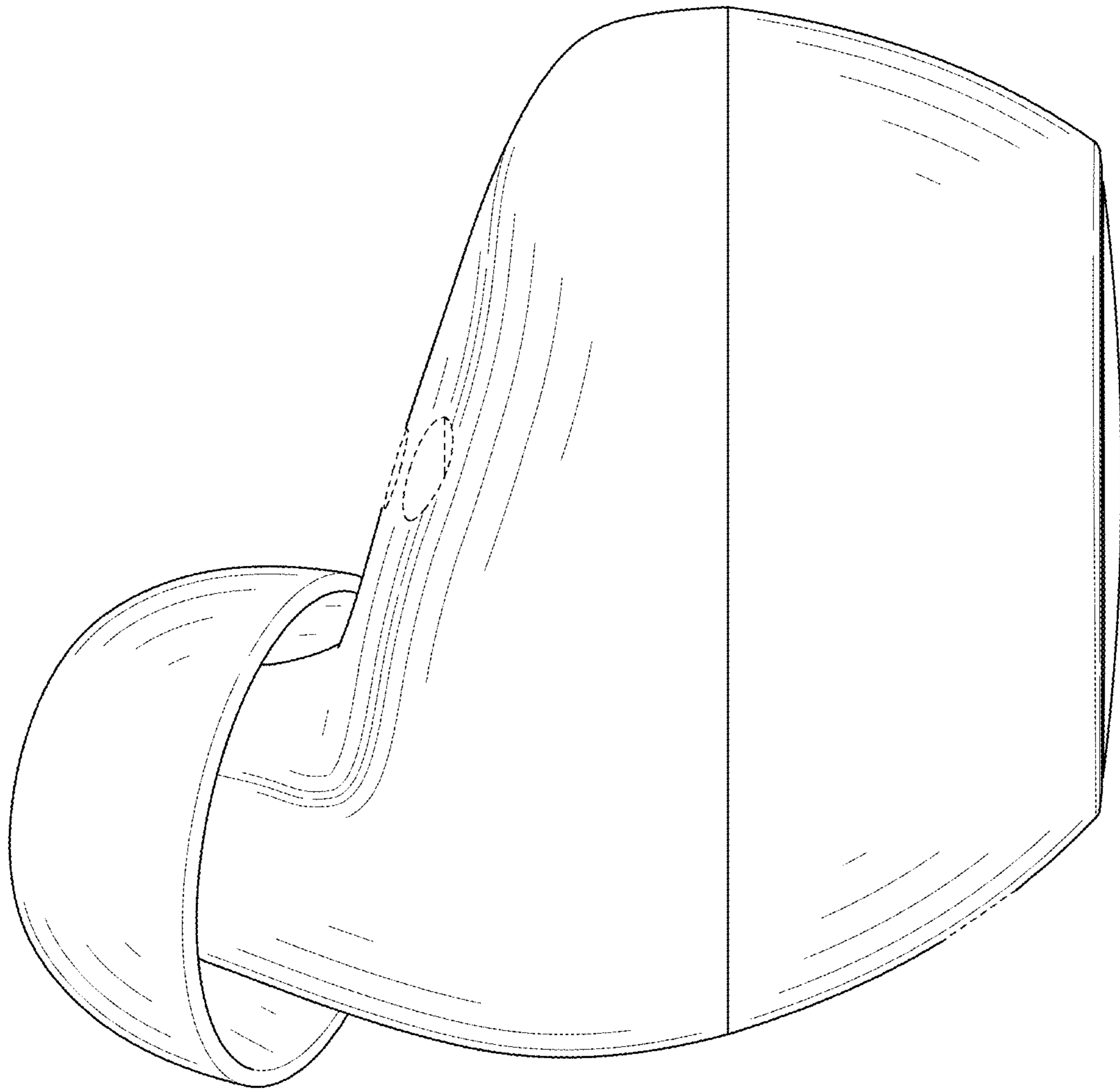

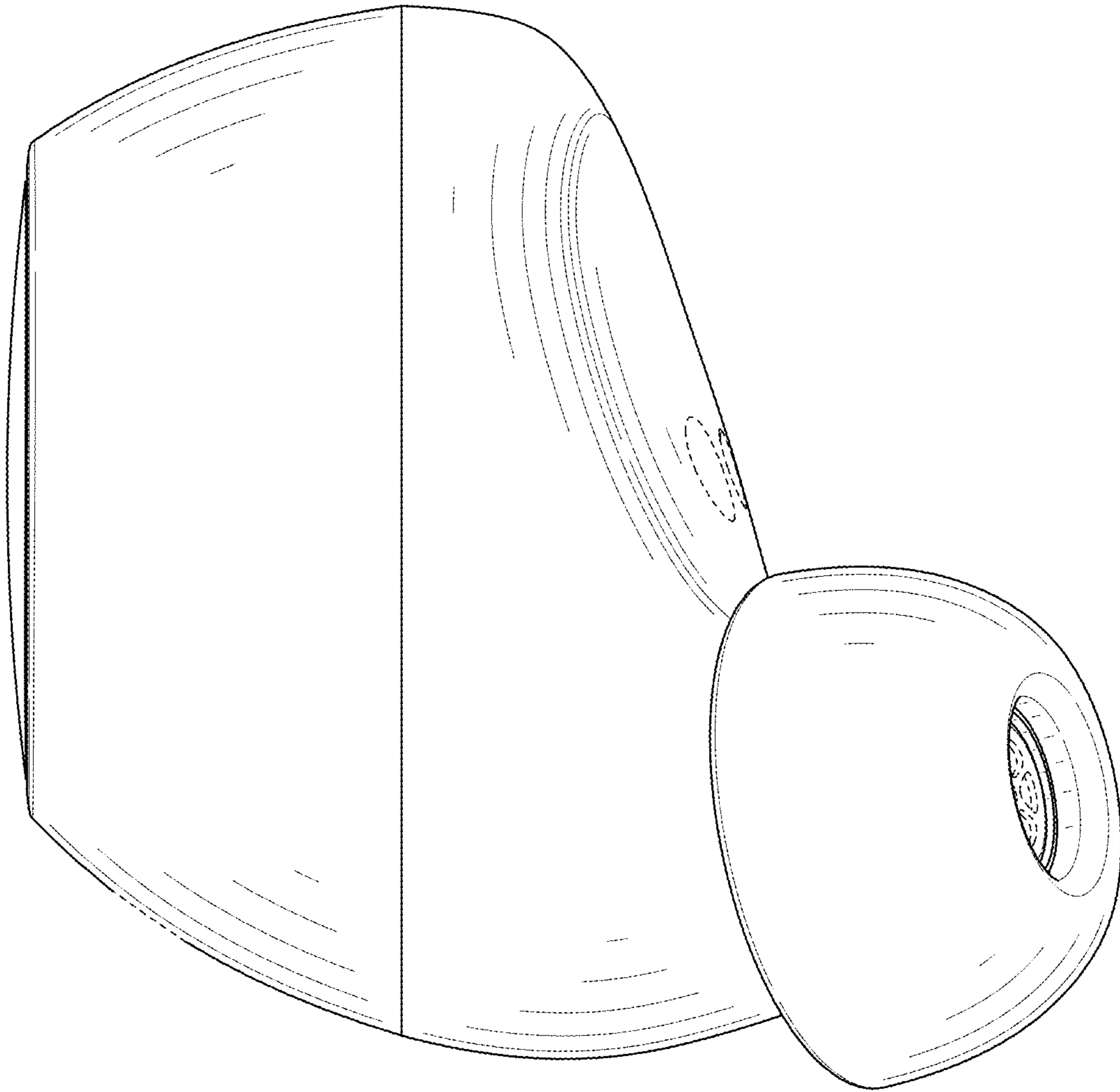

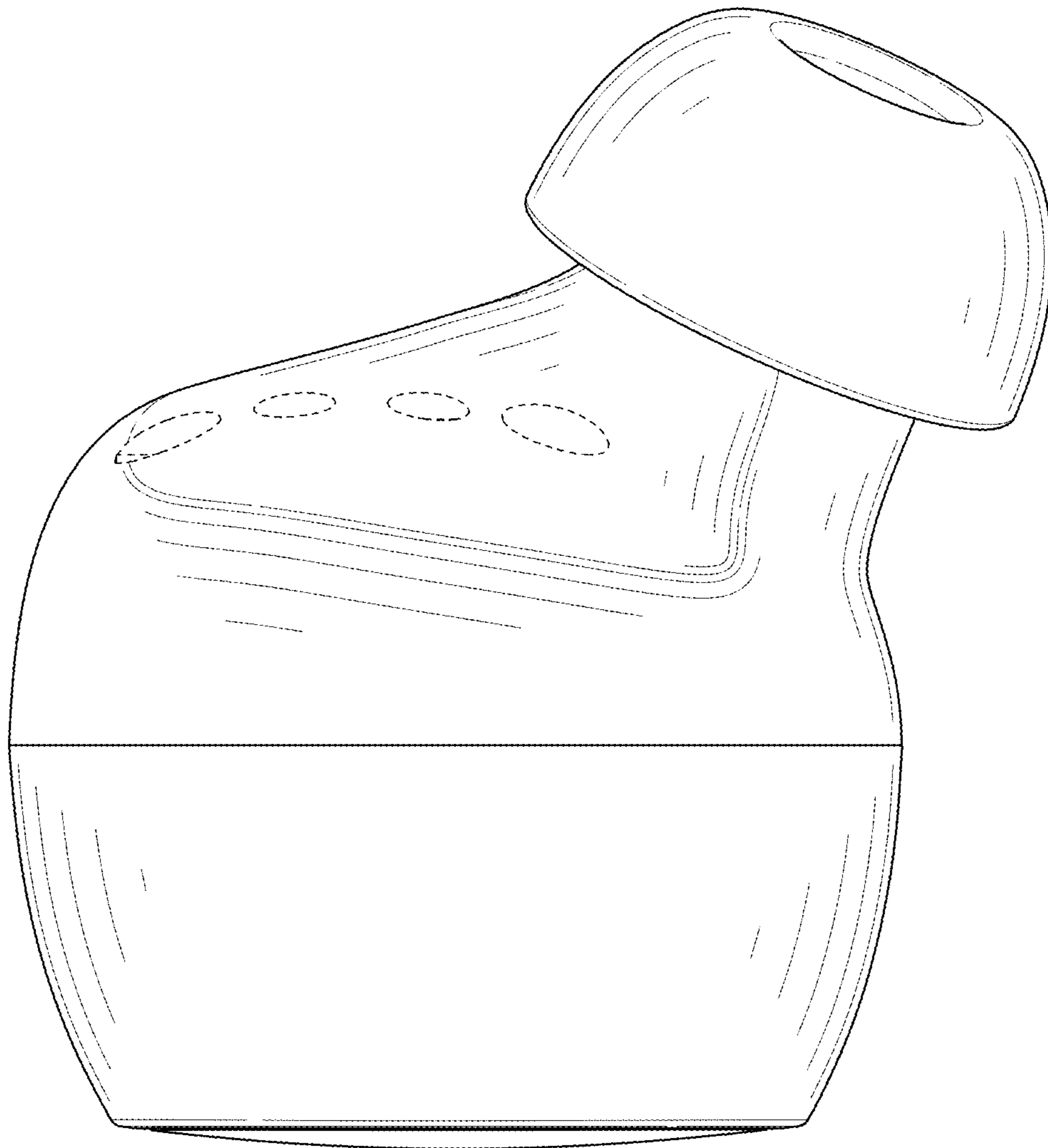

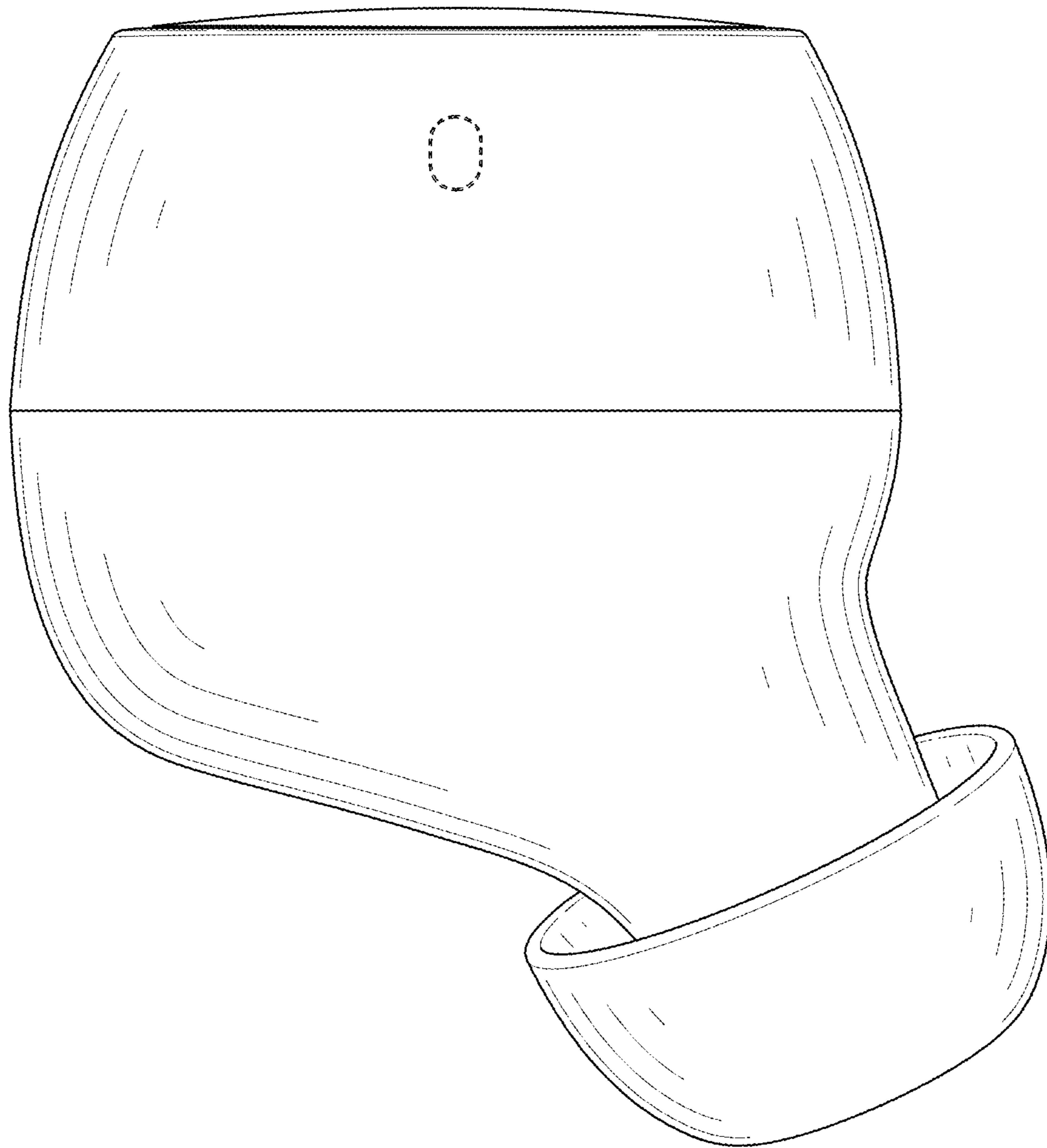

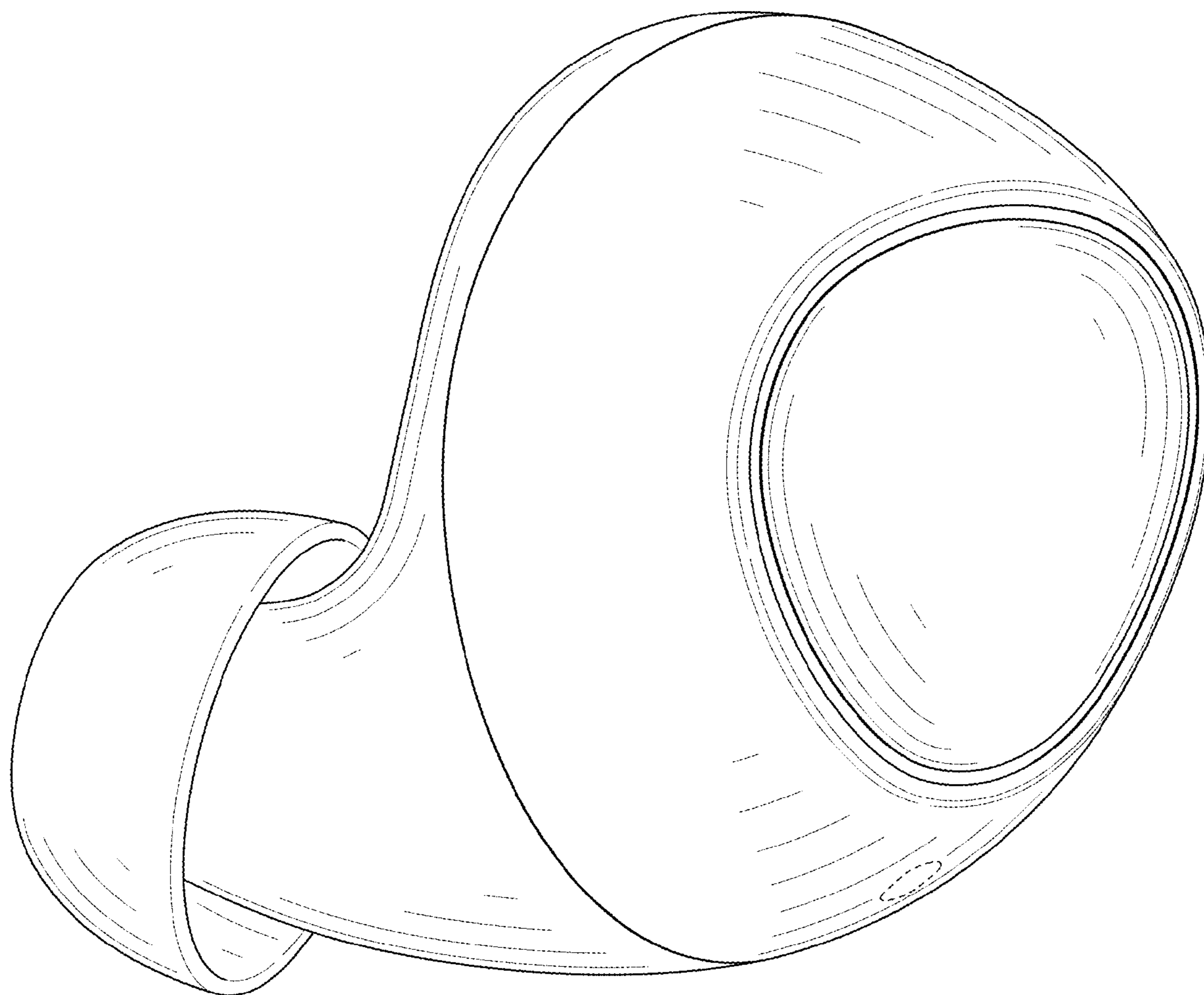

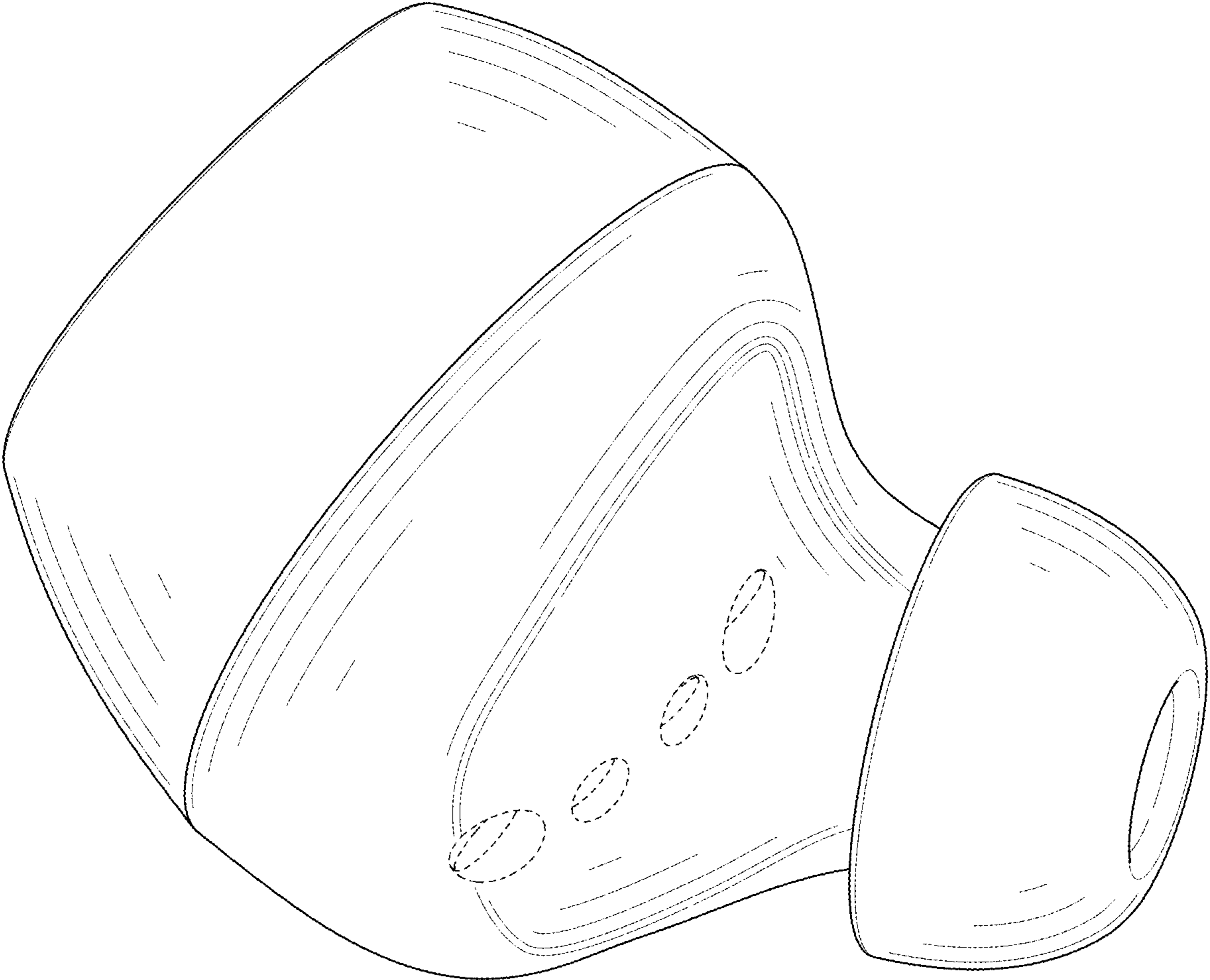

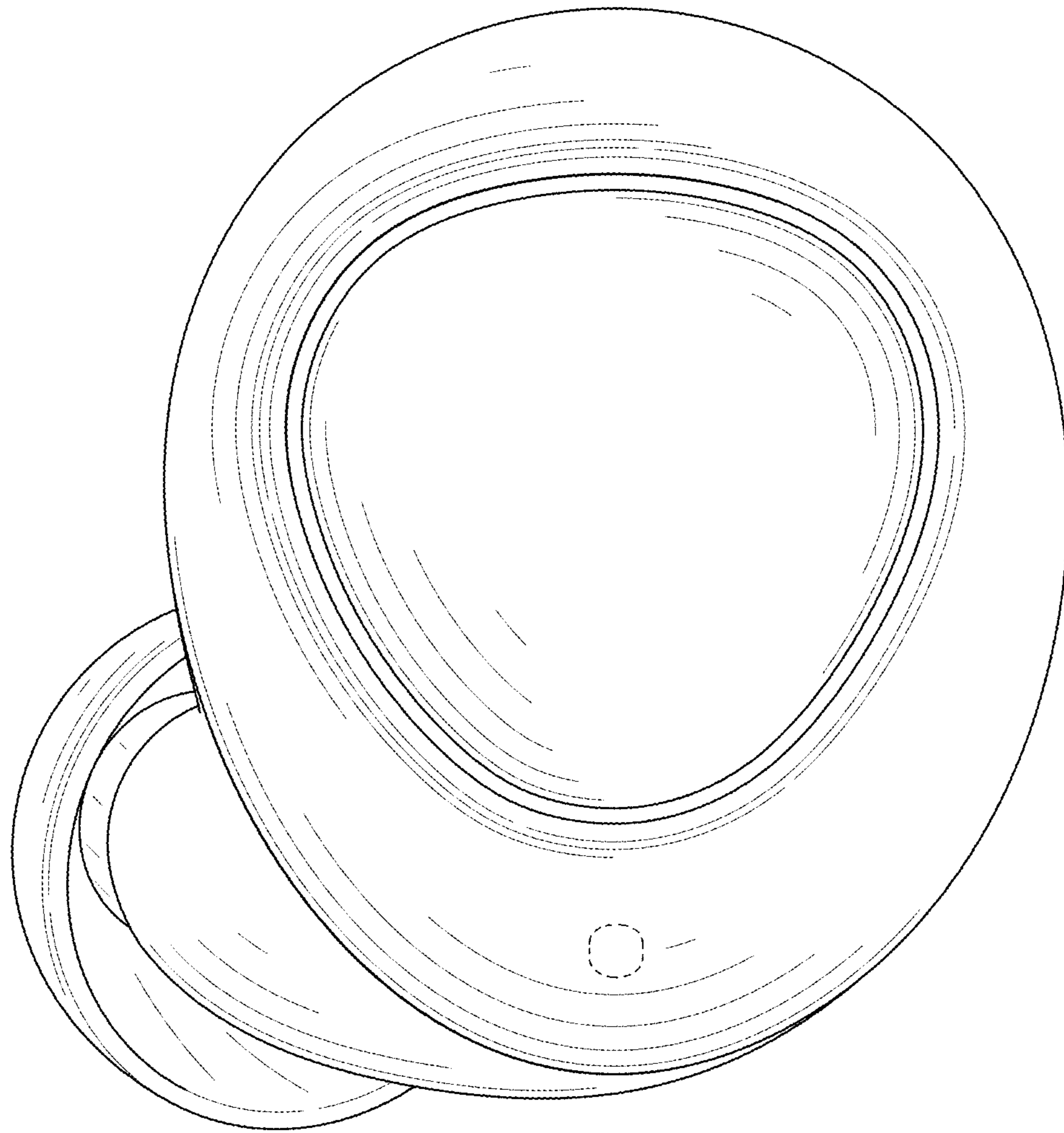

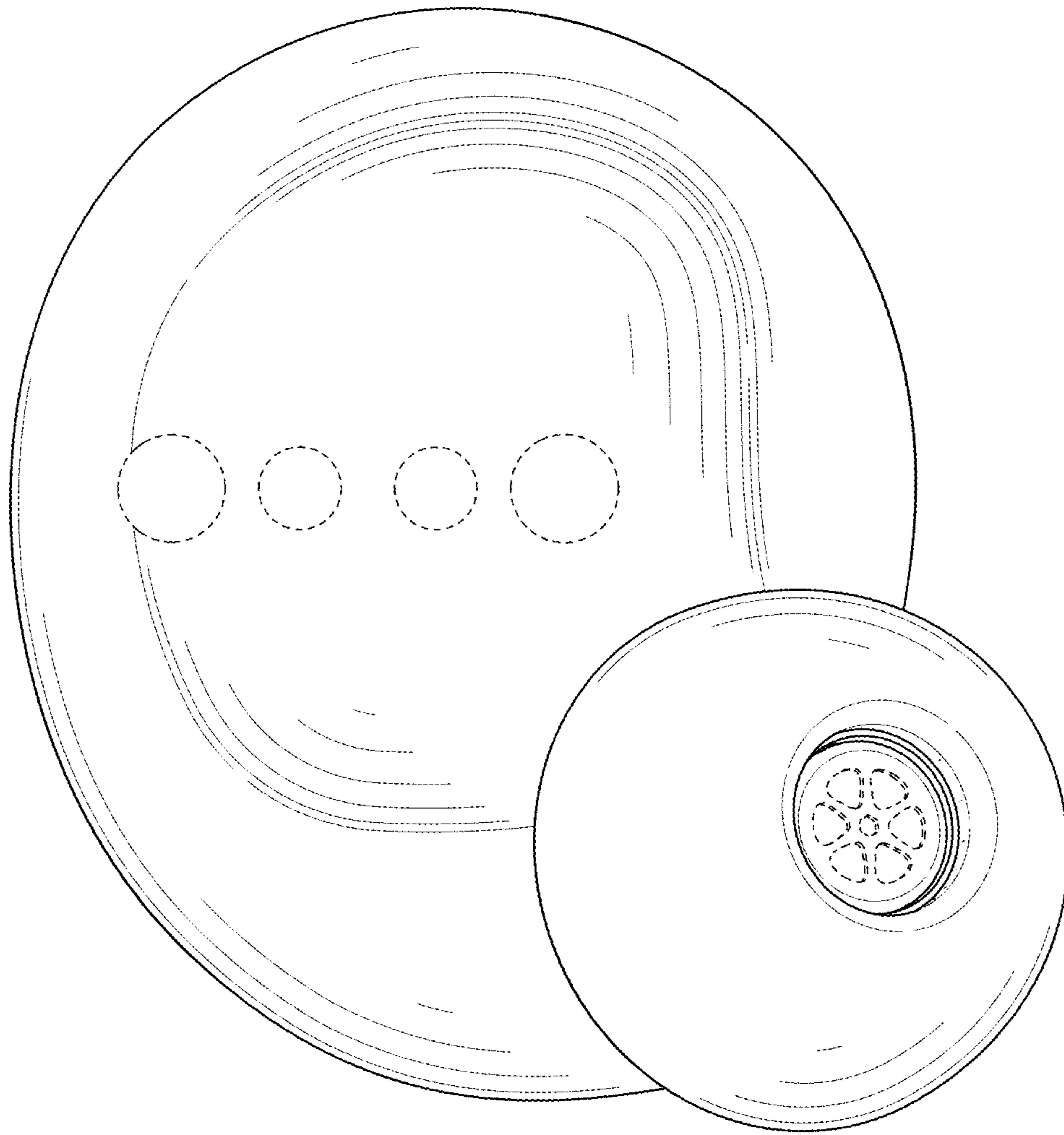

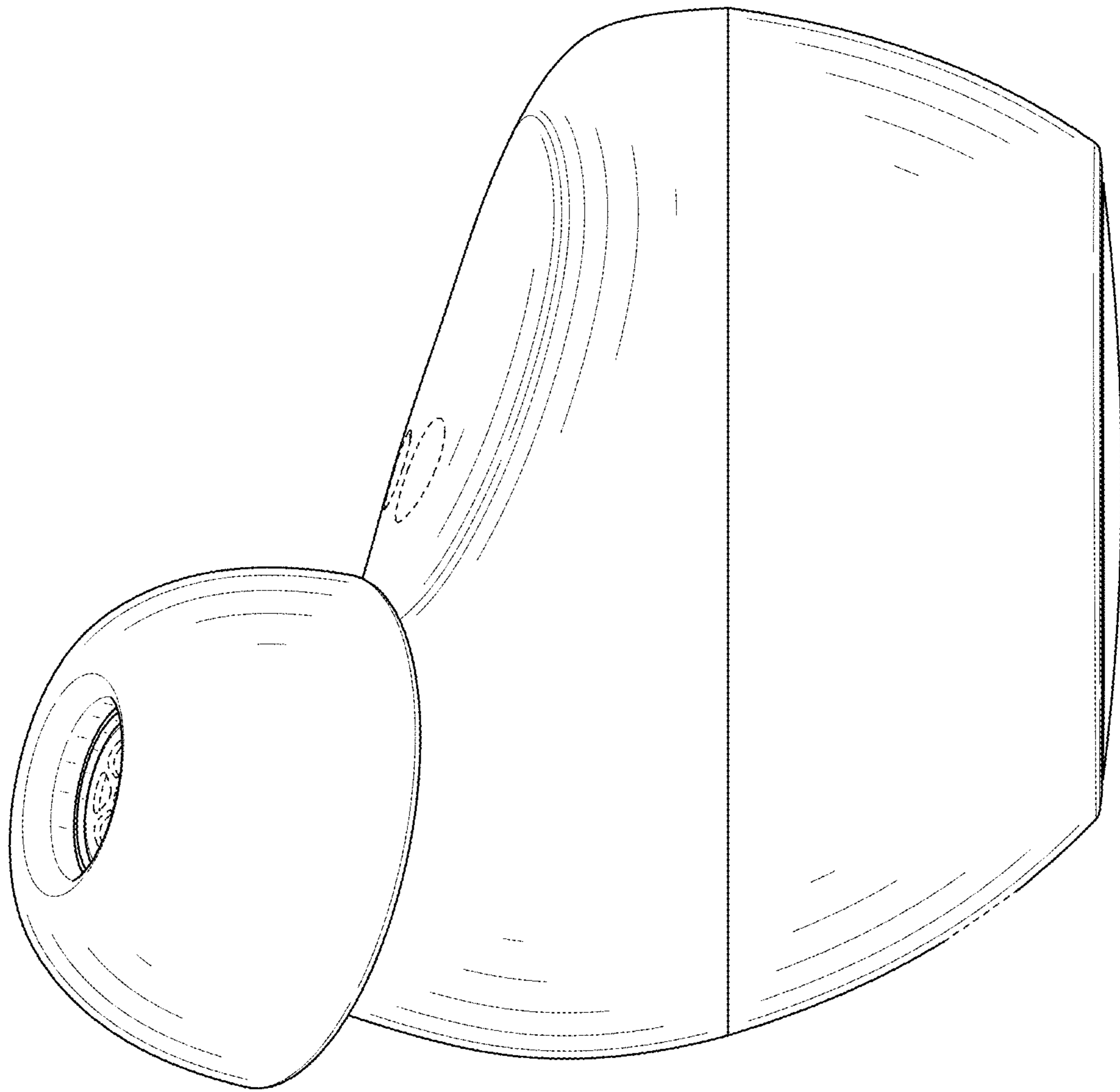

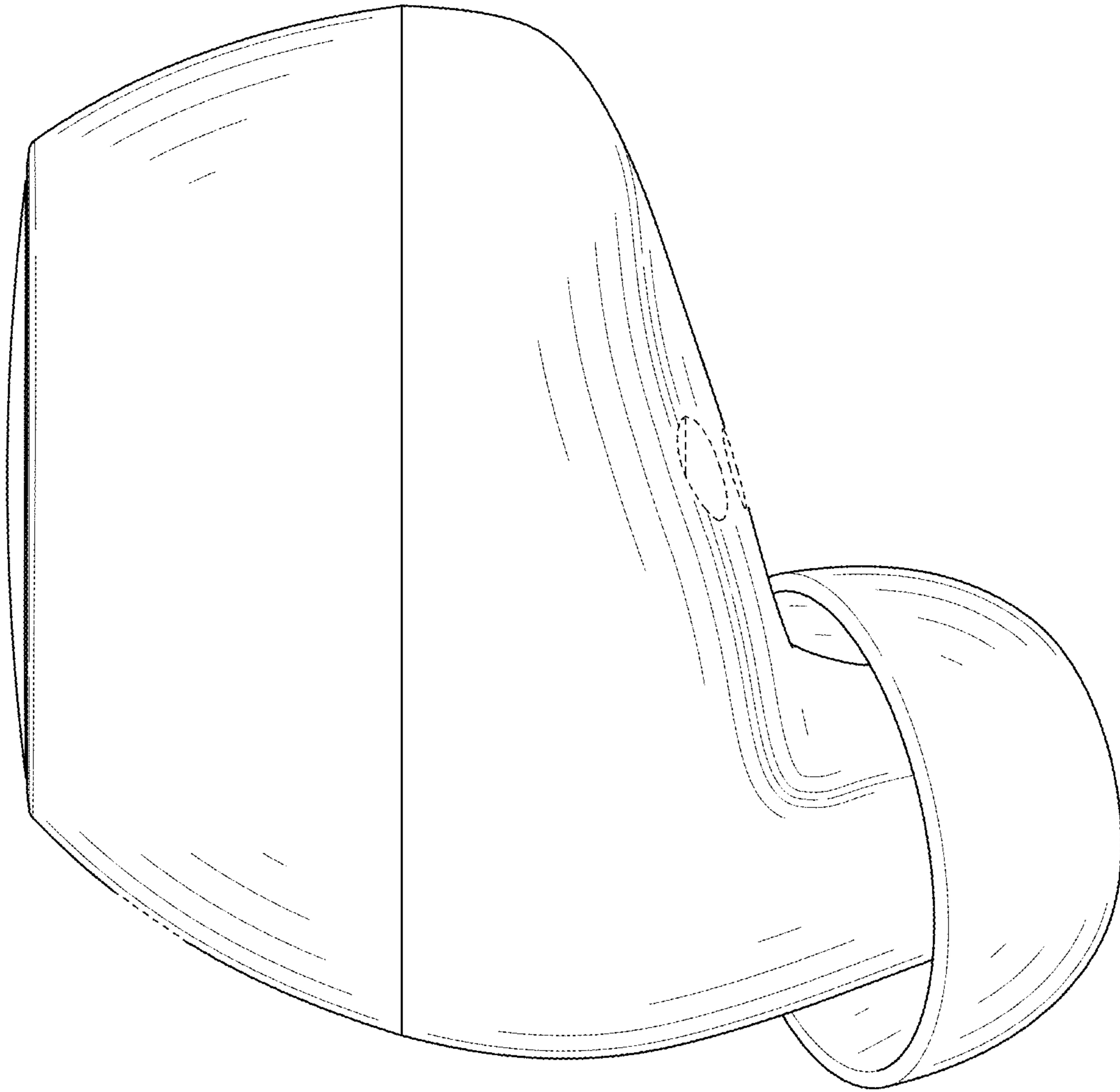

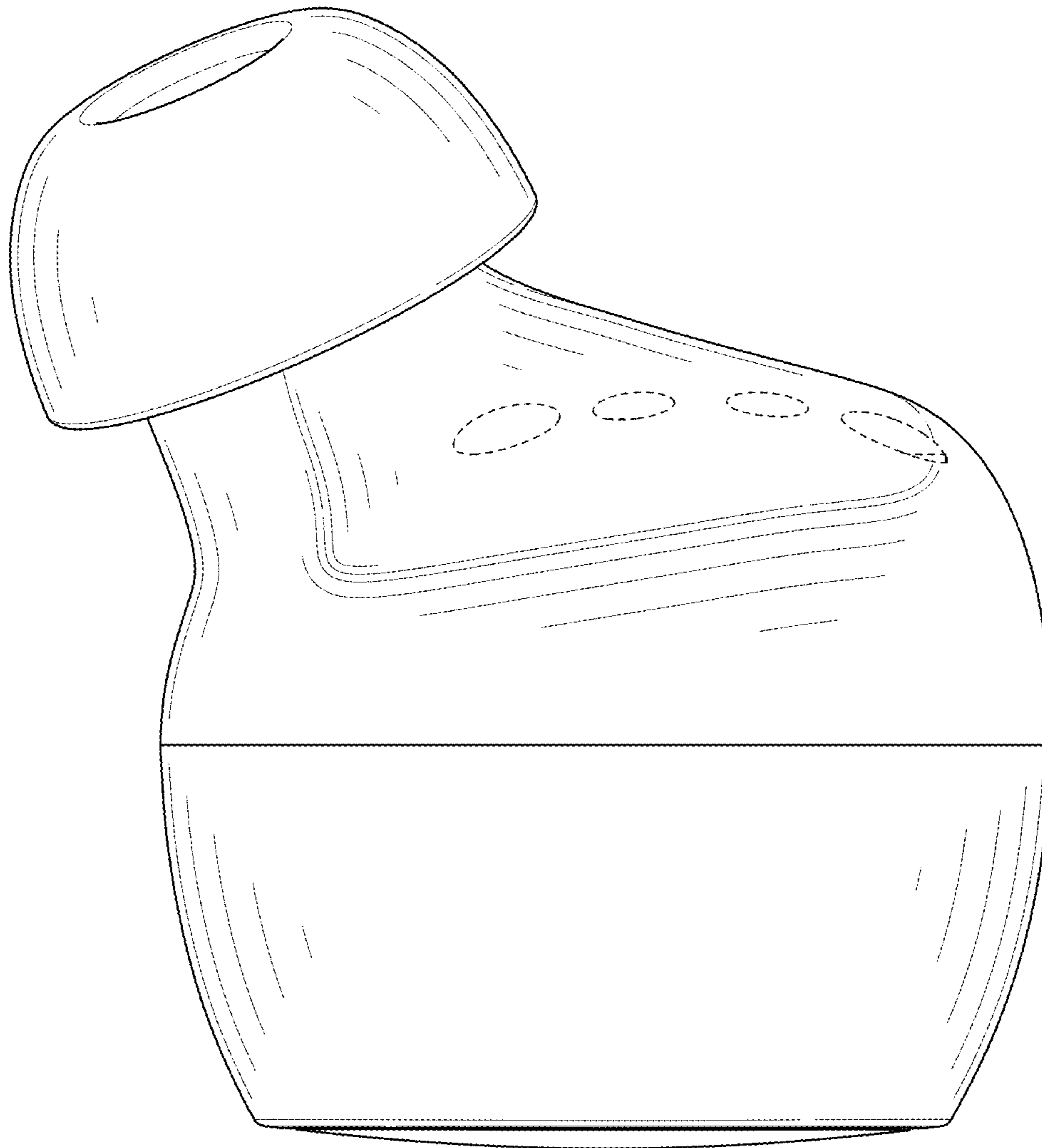

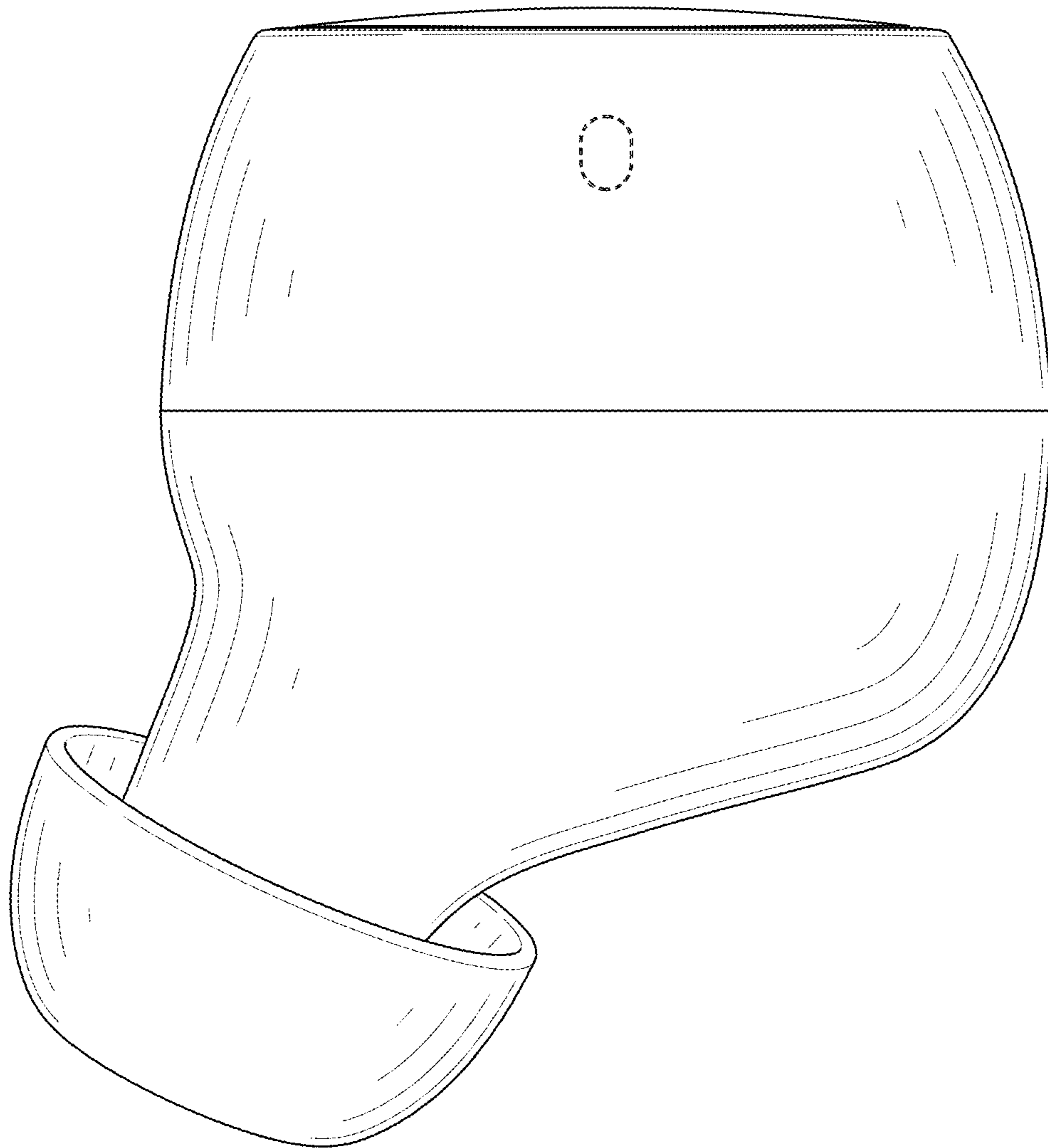
