(57) **CLAIM**

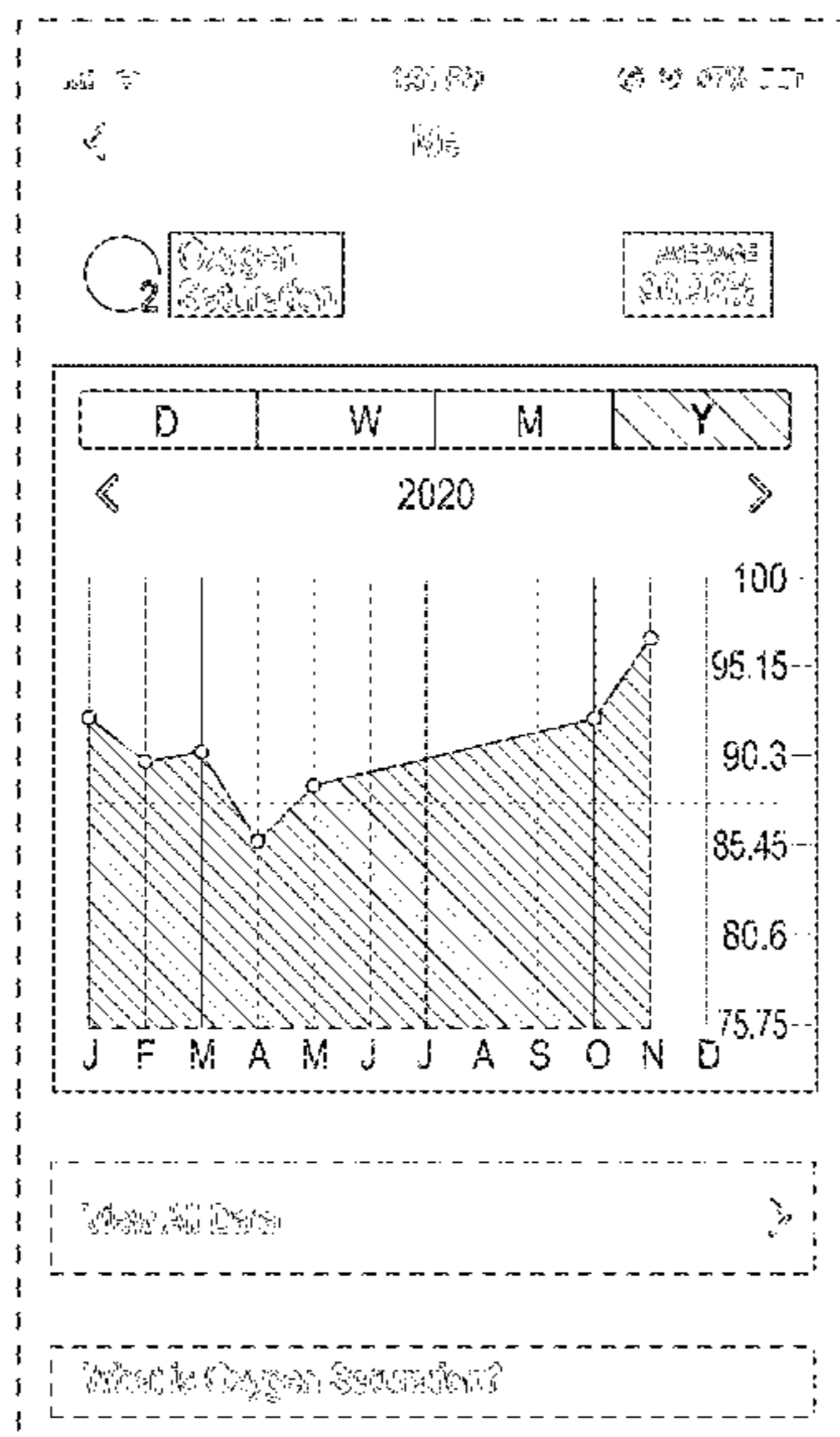
The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design; and, FIG. 2 is a front view of a display screen or portion thereof with graphical user interface in accordance with a second embodiment.

The outermost broken-line rectangle illustrates a display screen or portion thereof and forms no part of the claimed design. The remaining broken lines depict portions of a graphical user interface and form no part of the claimed design. The ornamental design for a display screen or portion thereof with a graphical user interface may be within a graphical user interface of a computer, a smartphone, and/or a tablet.

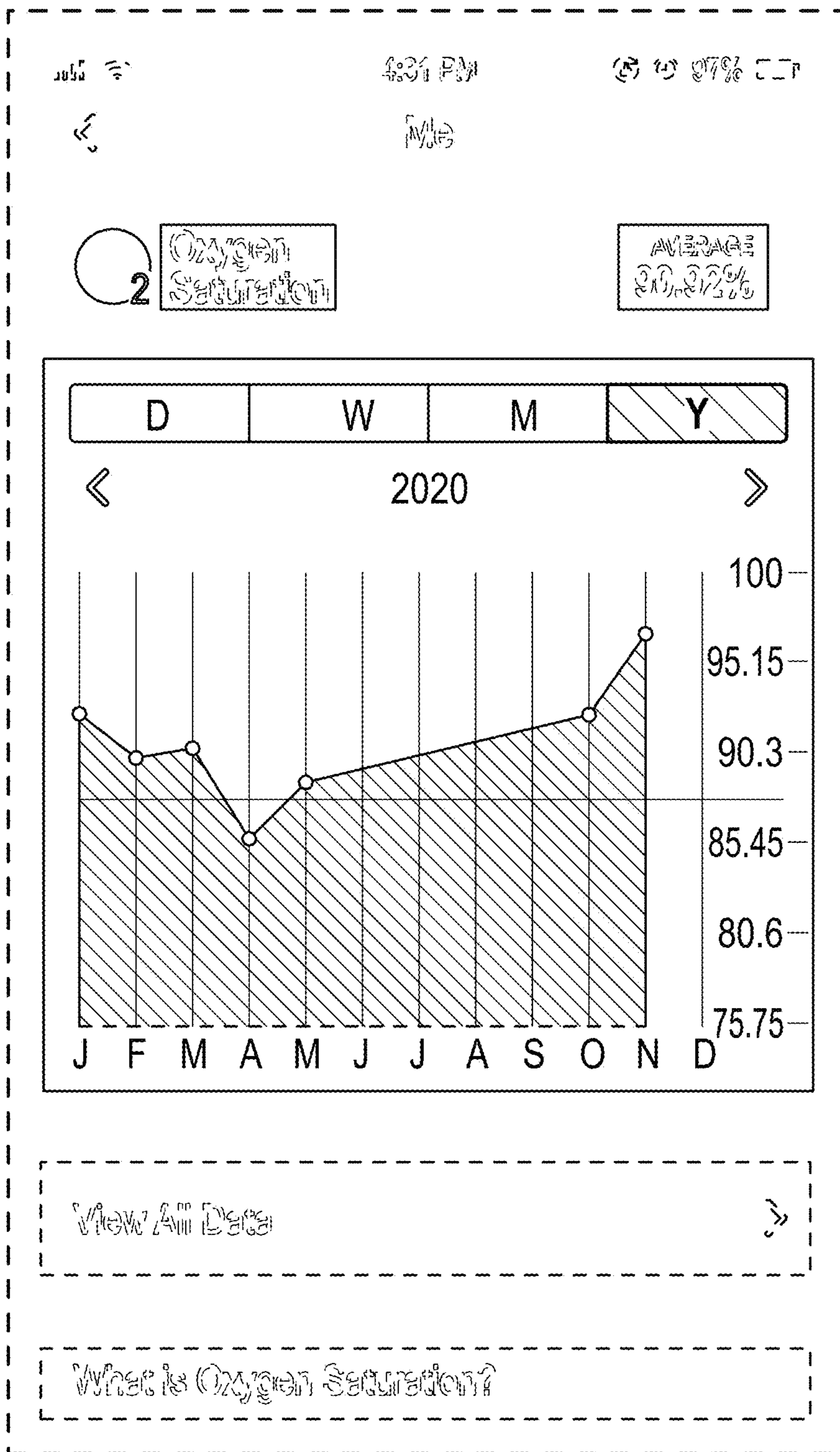

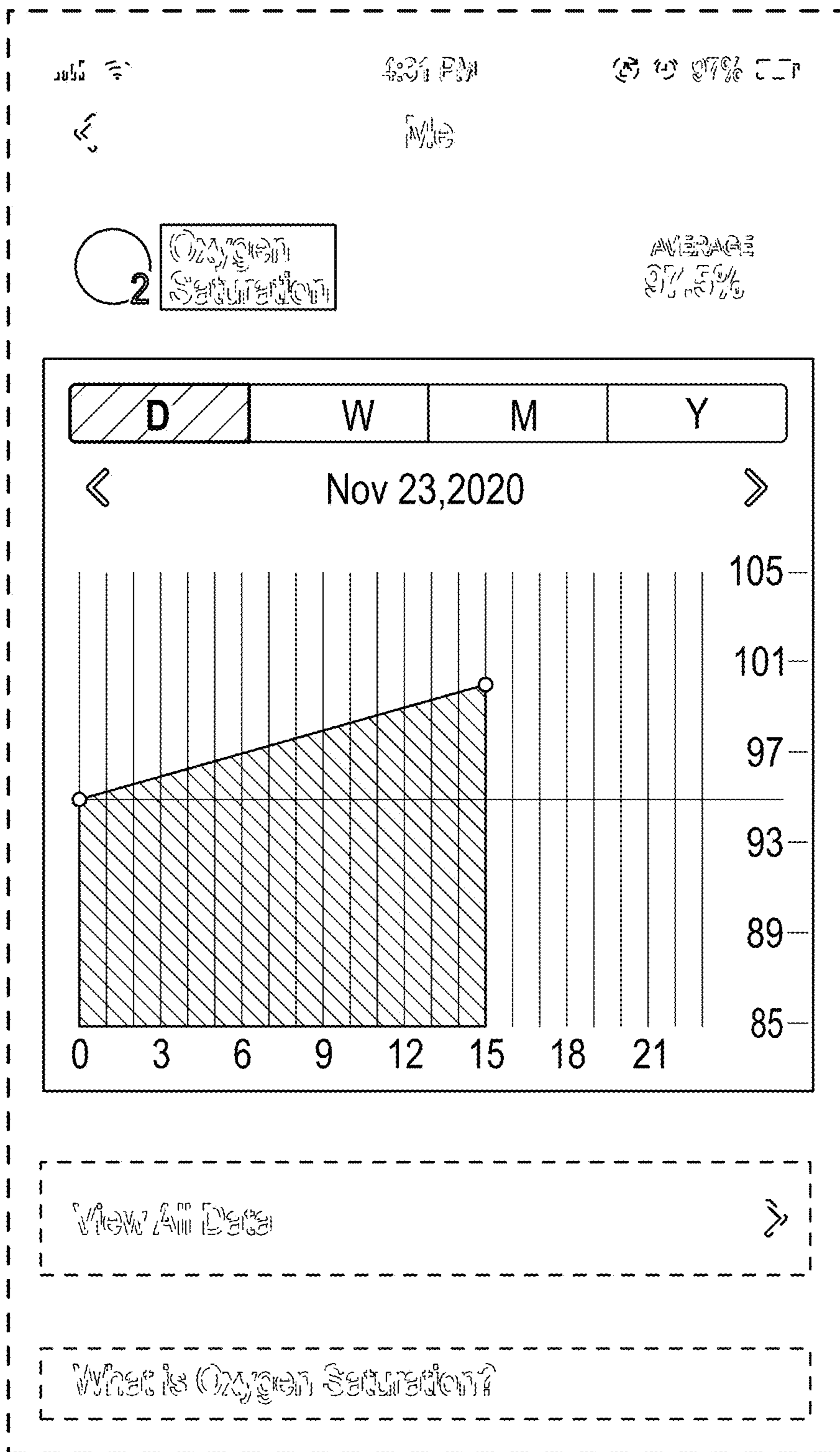
