FIG. 6 is an exploded top view thereof;

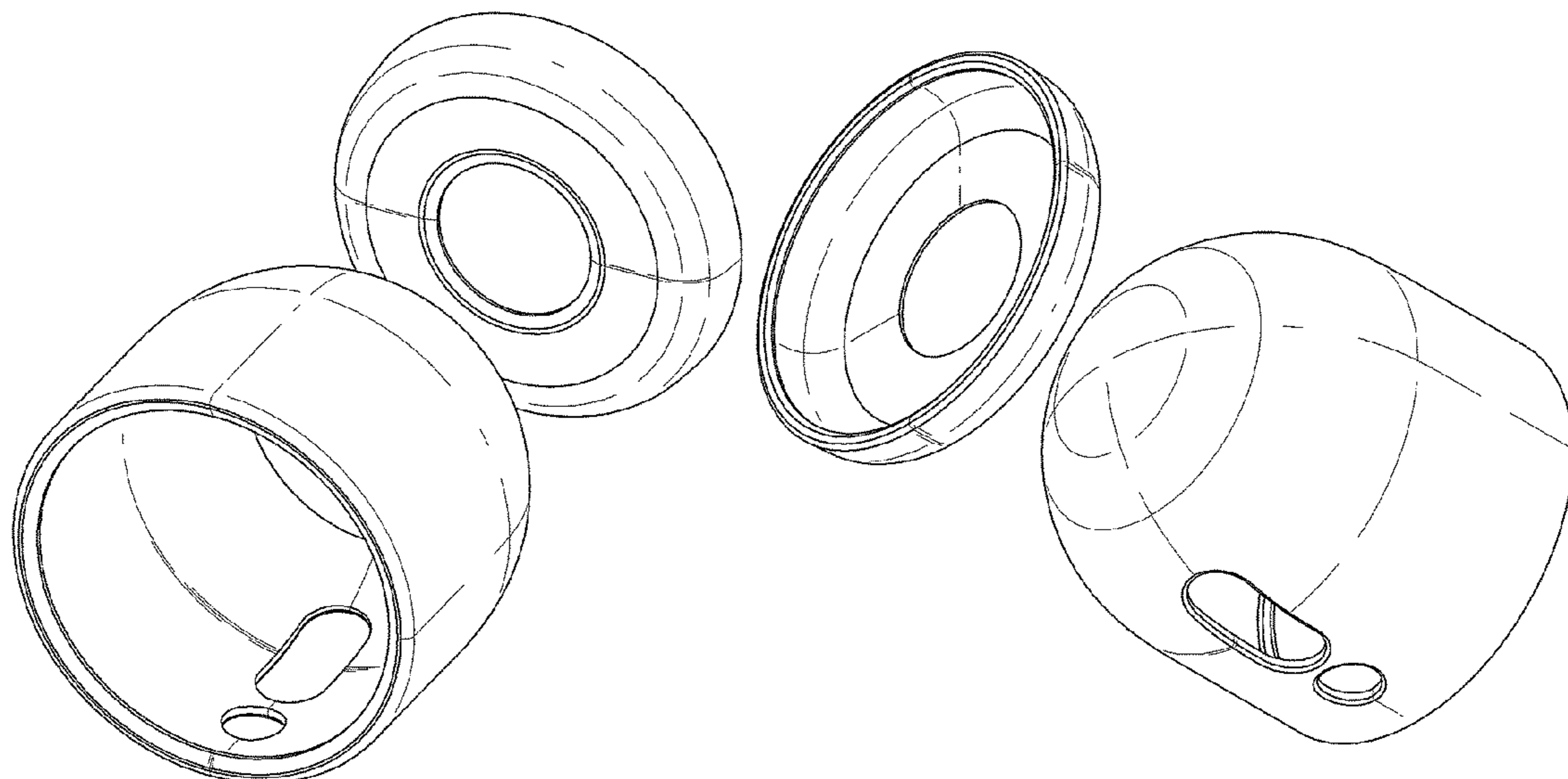
FIG. 7 is an exploded bottom view thereof;

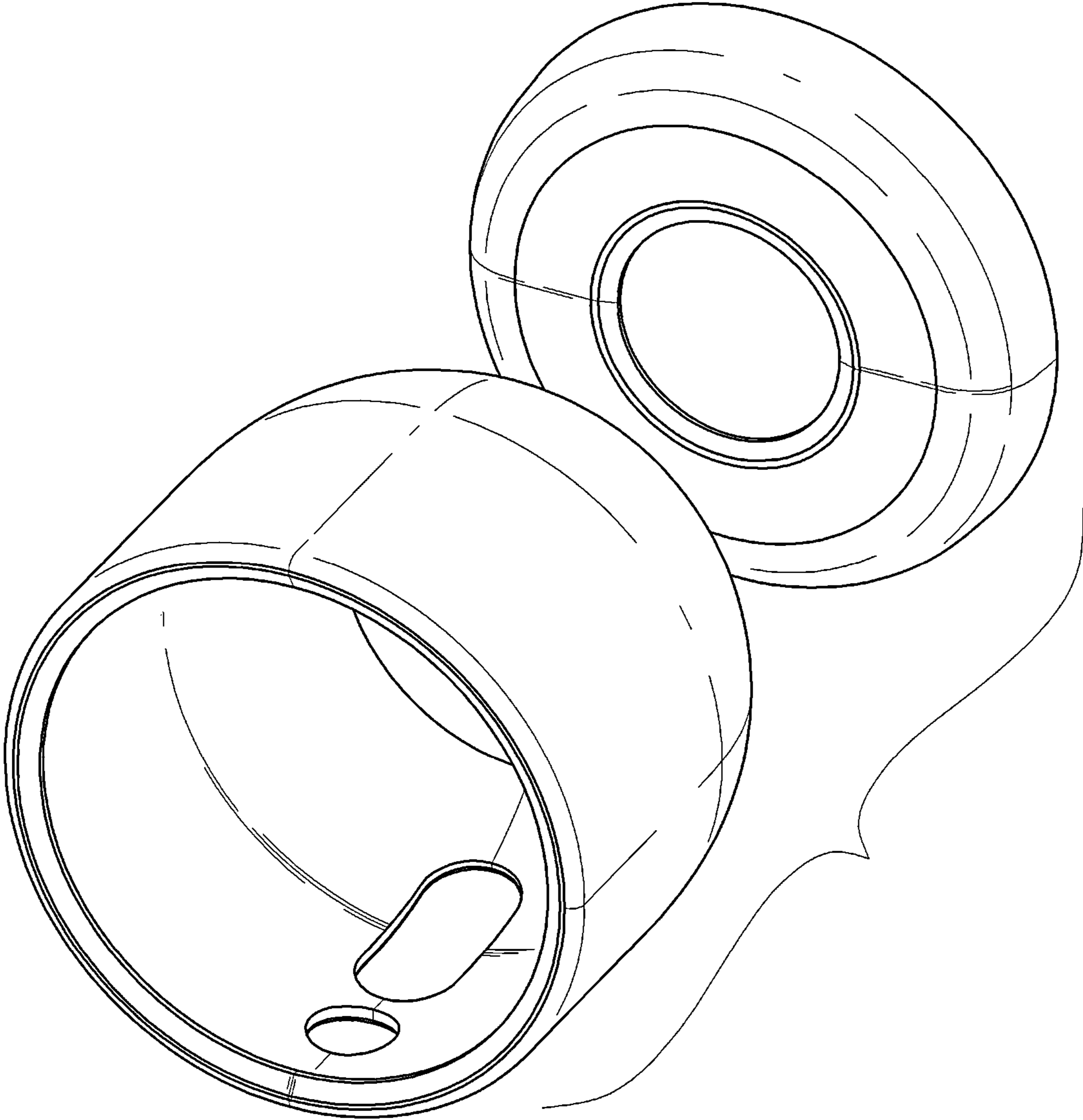

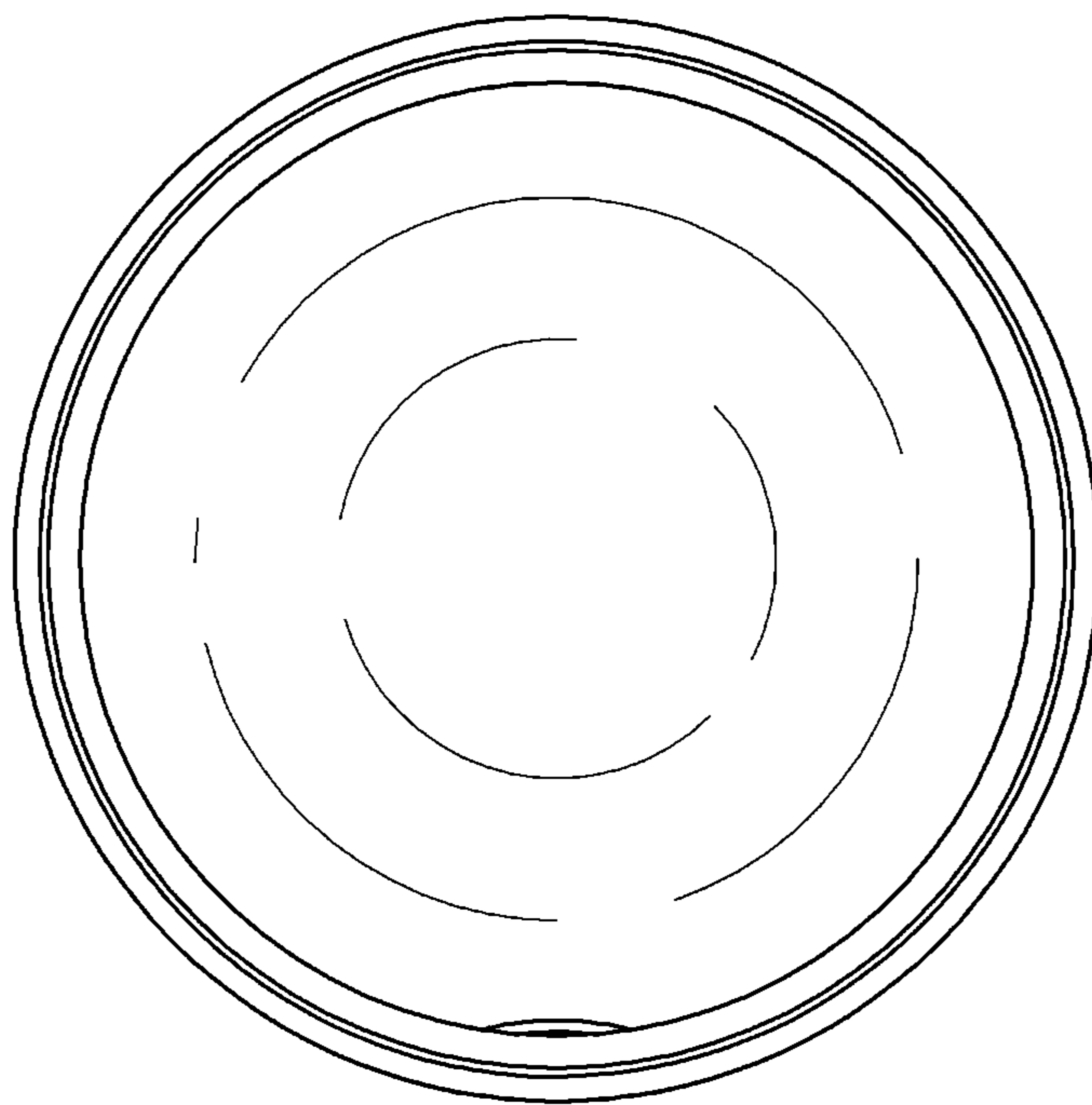

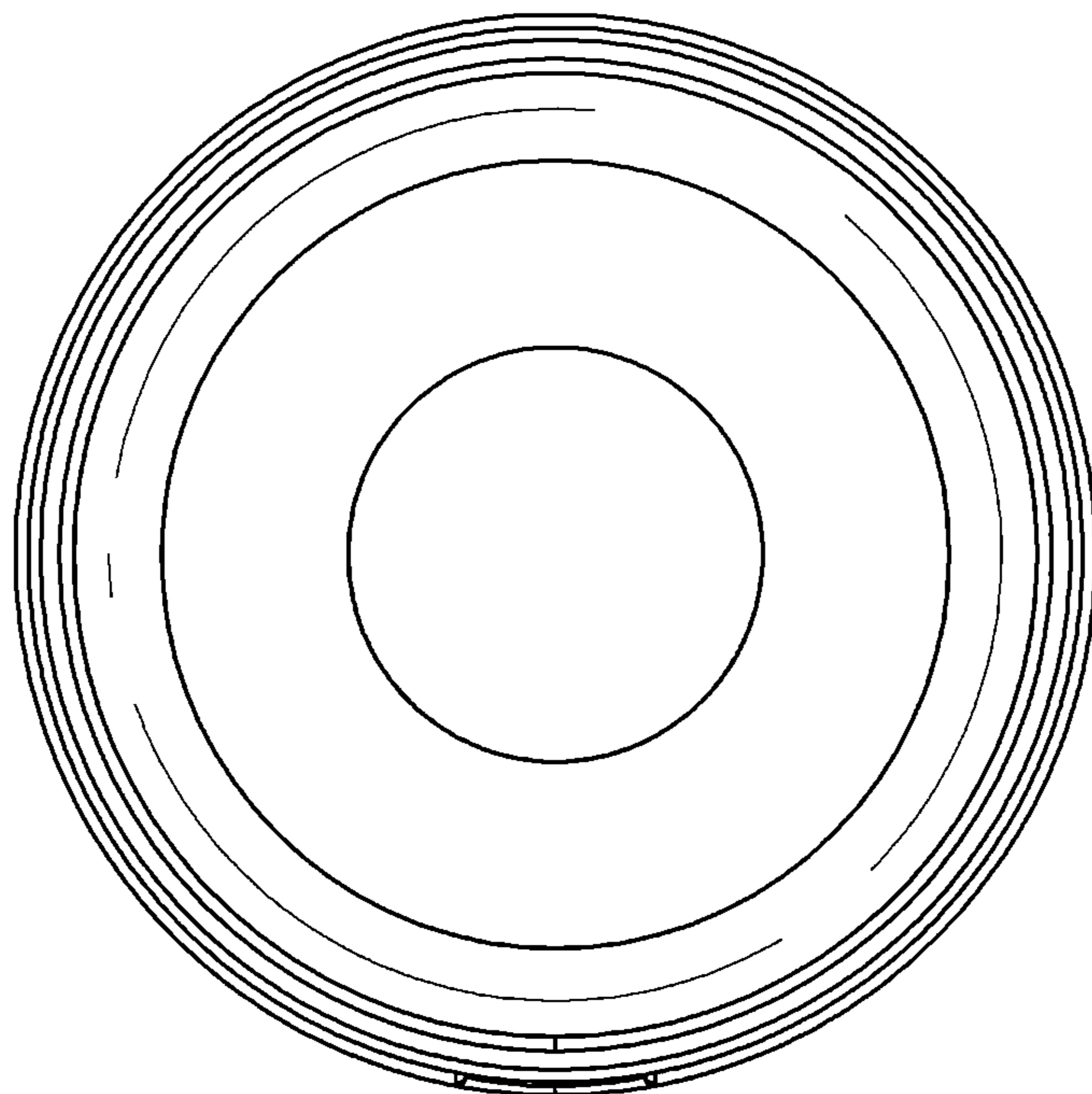

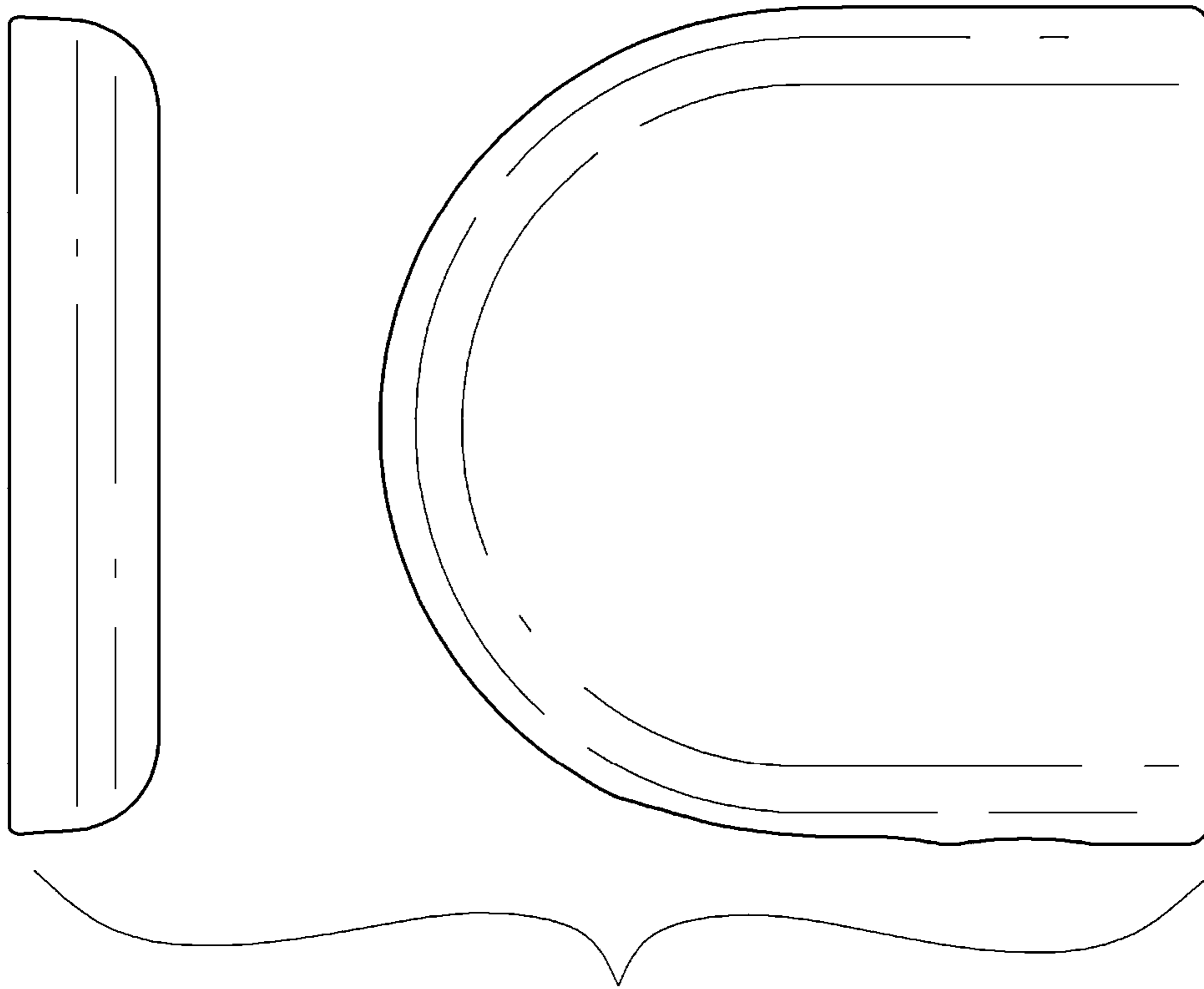

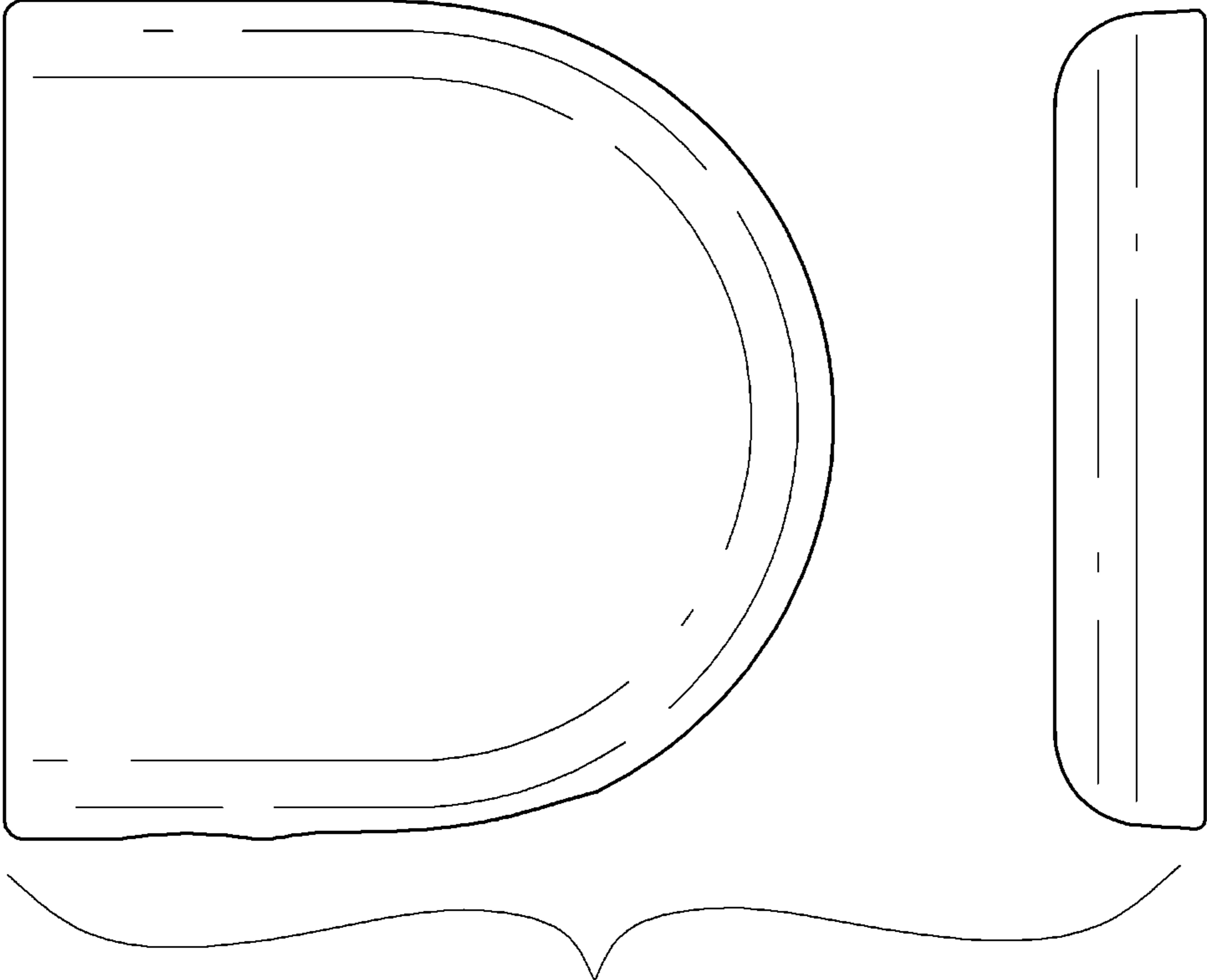

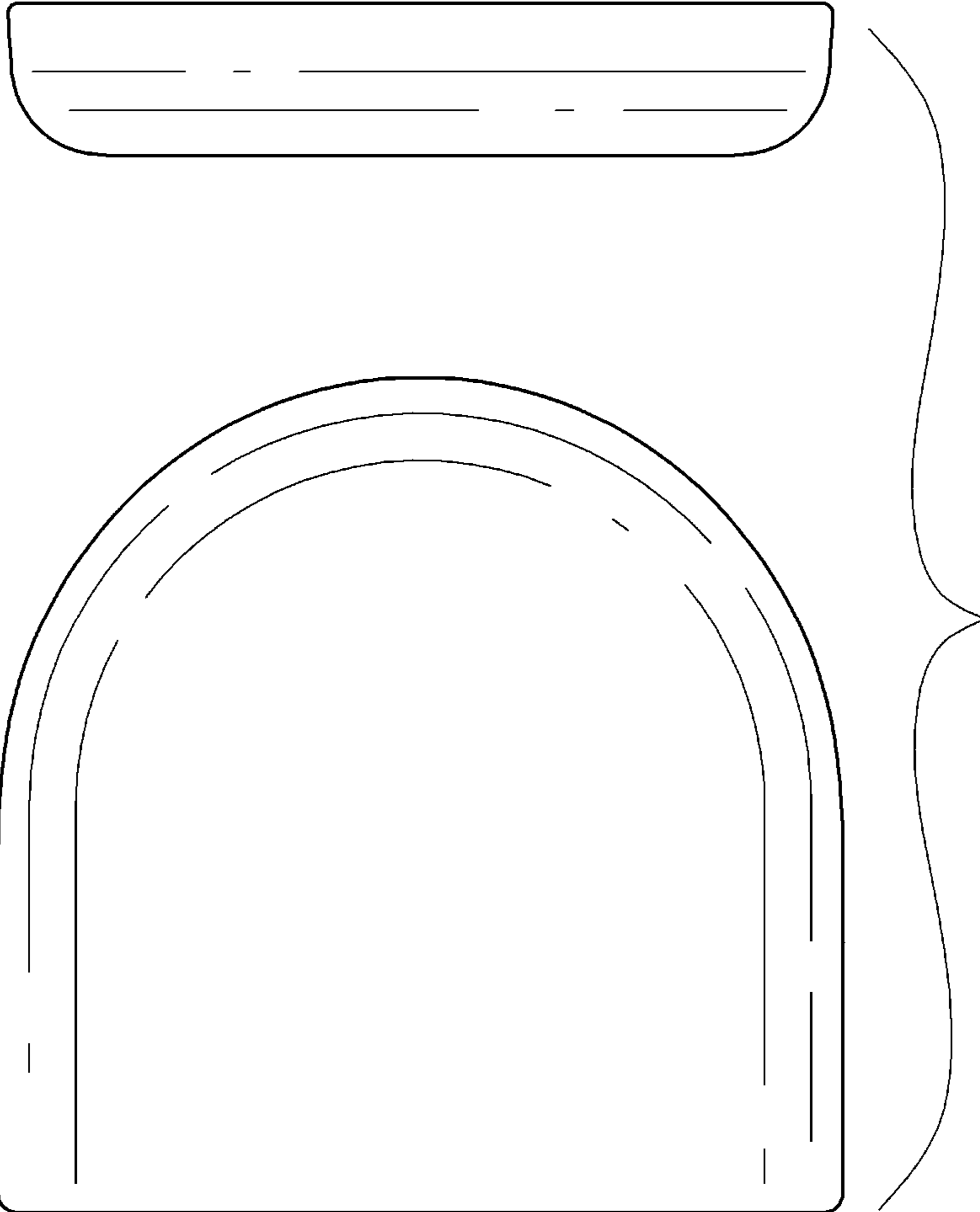

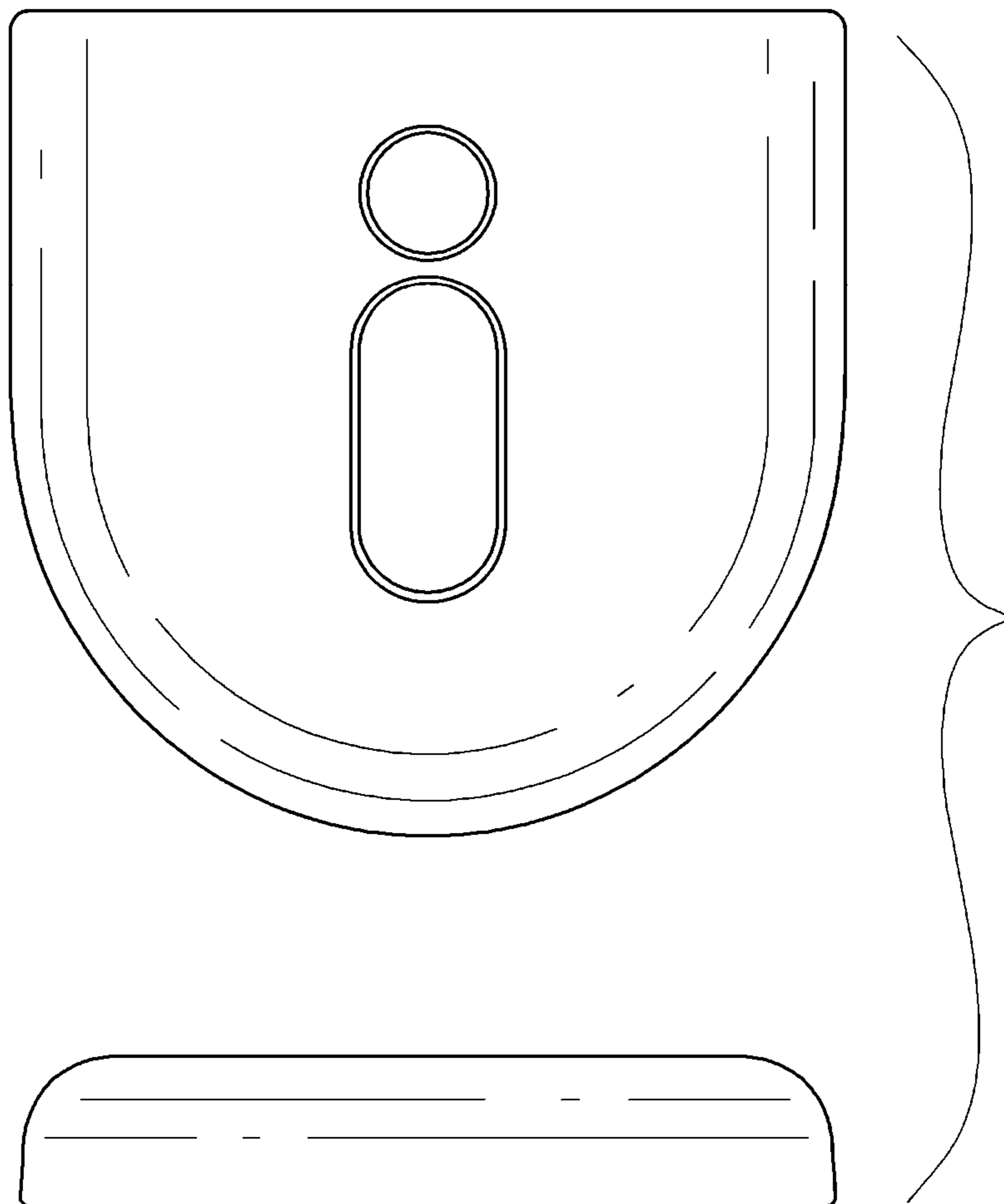

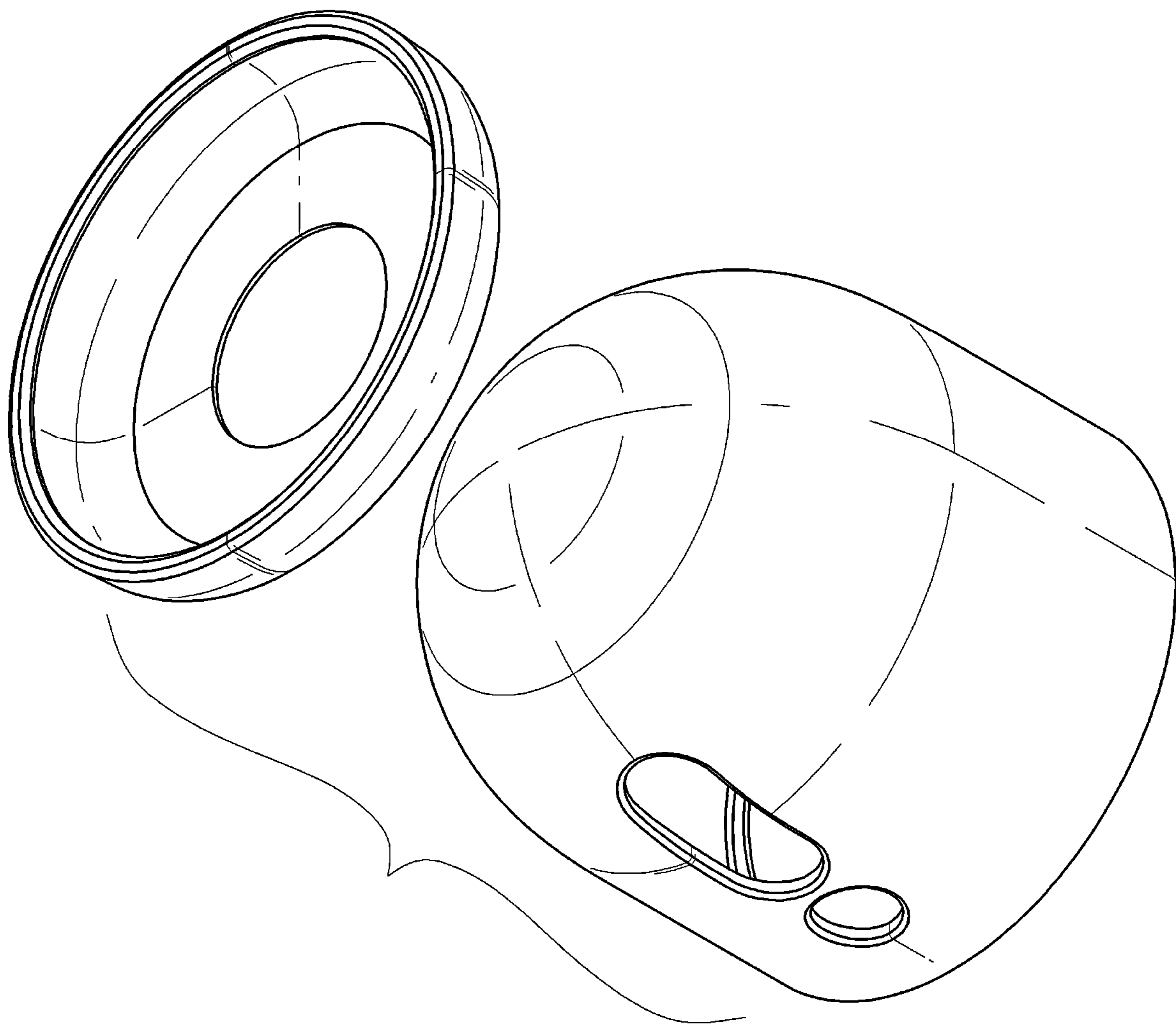
