DESCRIPTION

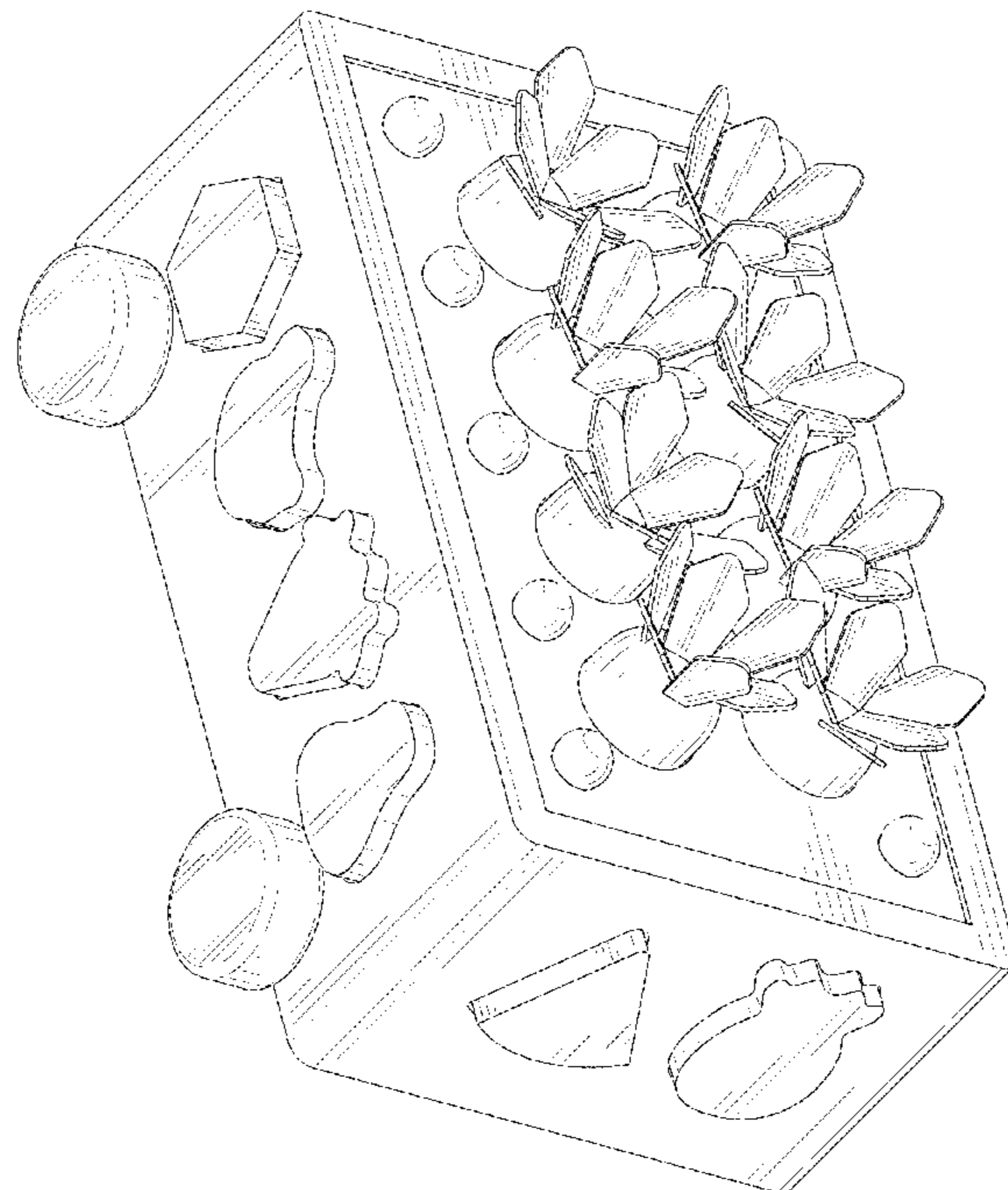
FIG. 1 is a front left bottom perspective view of a radish pulling toy, showing the wagon, removable radishes and fruit components separately for ease of illustration; FIG. 2 is a bottom right top perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a back elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a front left perspective view of the rabbit component of the radish pulling toy, shown separately for ease of illustration; FIG. 10 is a back right perspective view thereof; FIG. 11 is a front elevational view thereof; FIG. 12 is a back elevational view thereof; and, FIG. 13 shows the radish pulling toy, including all components, in an exploded. The broken lines shown in the drawings depict portions of the radish pulling toy that form no part of the claimed design.

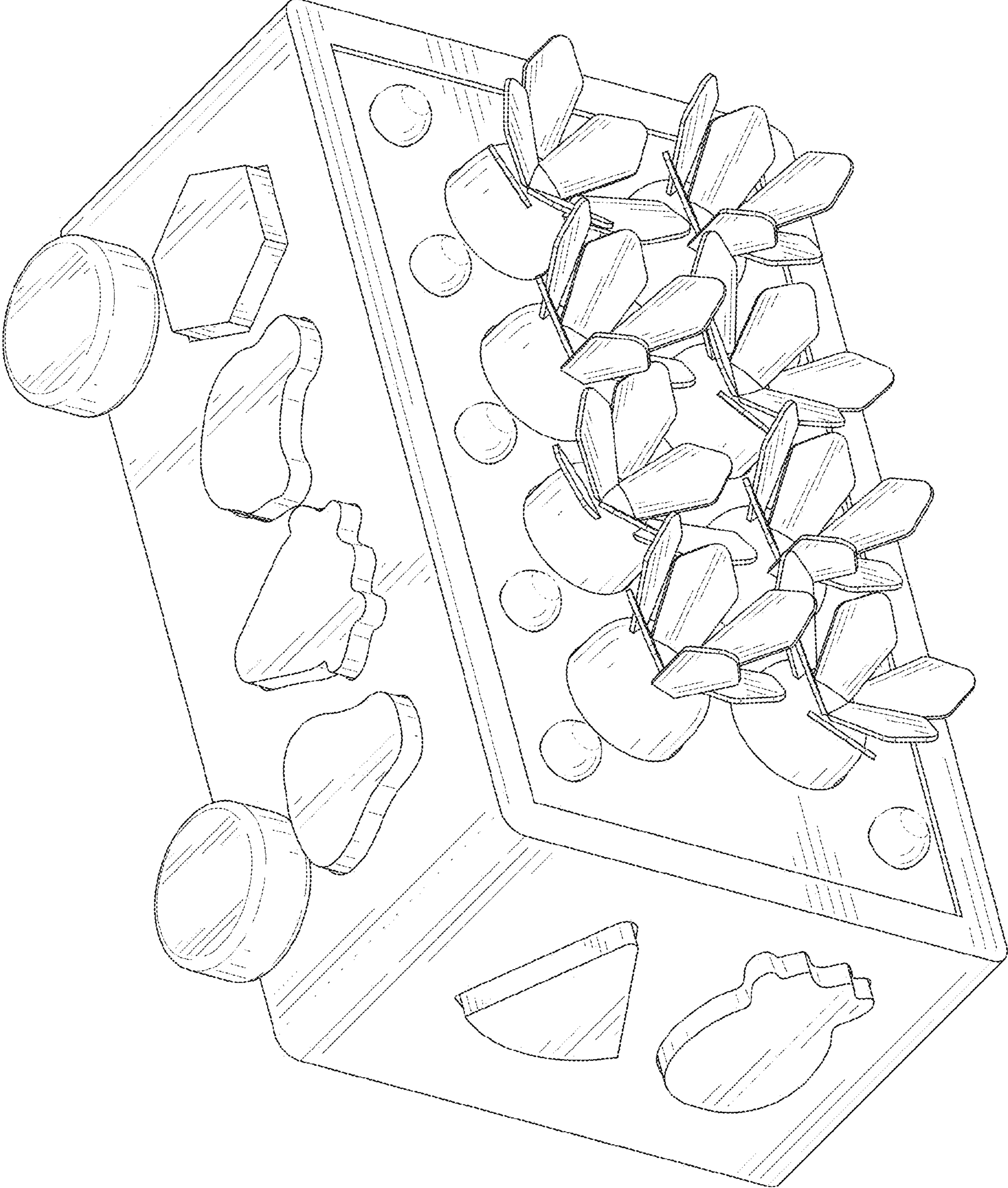

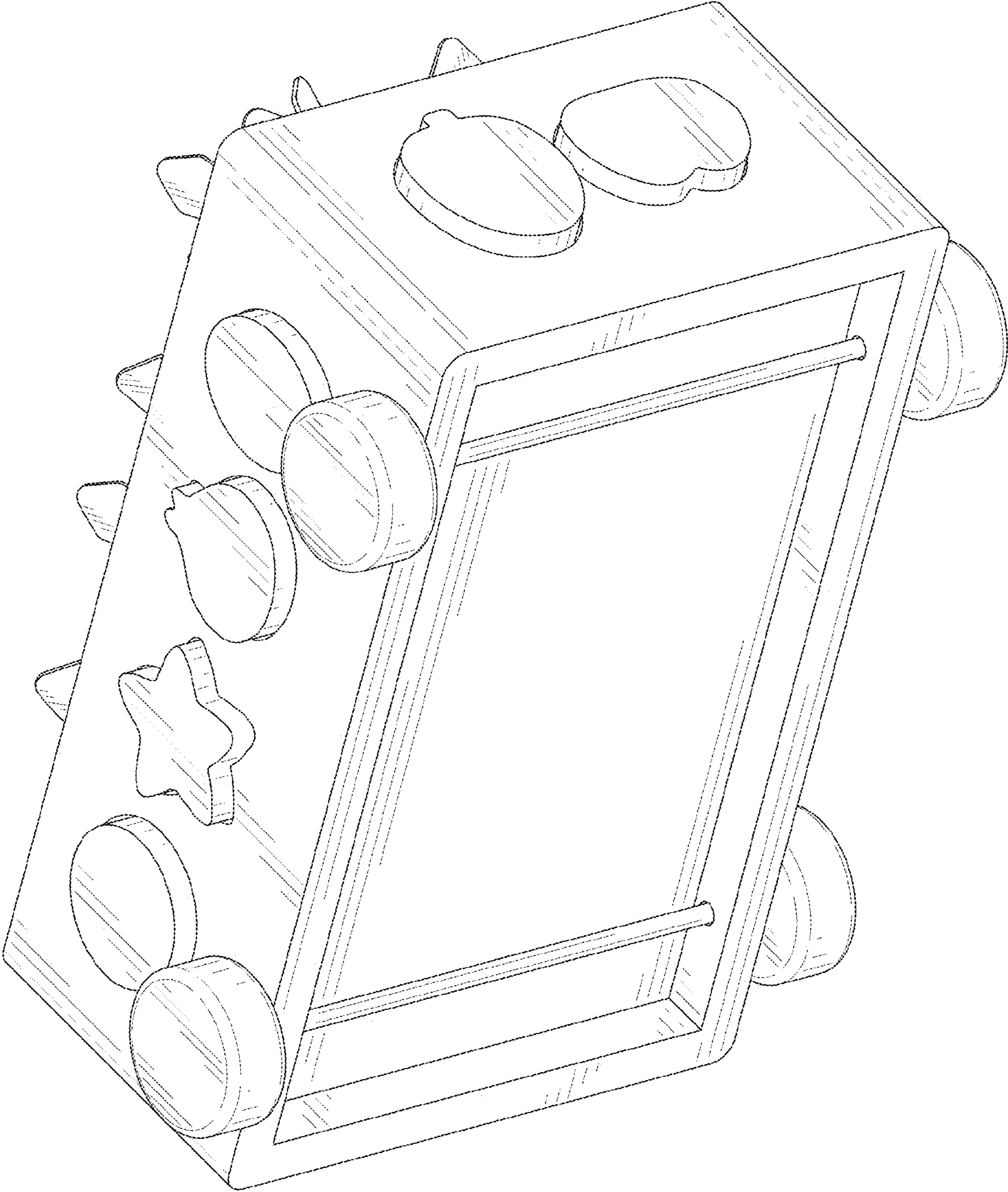

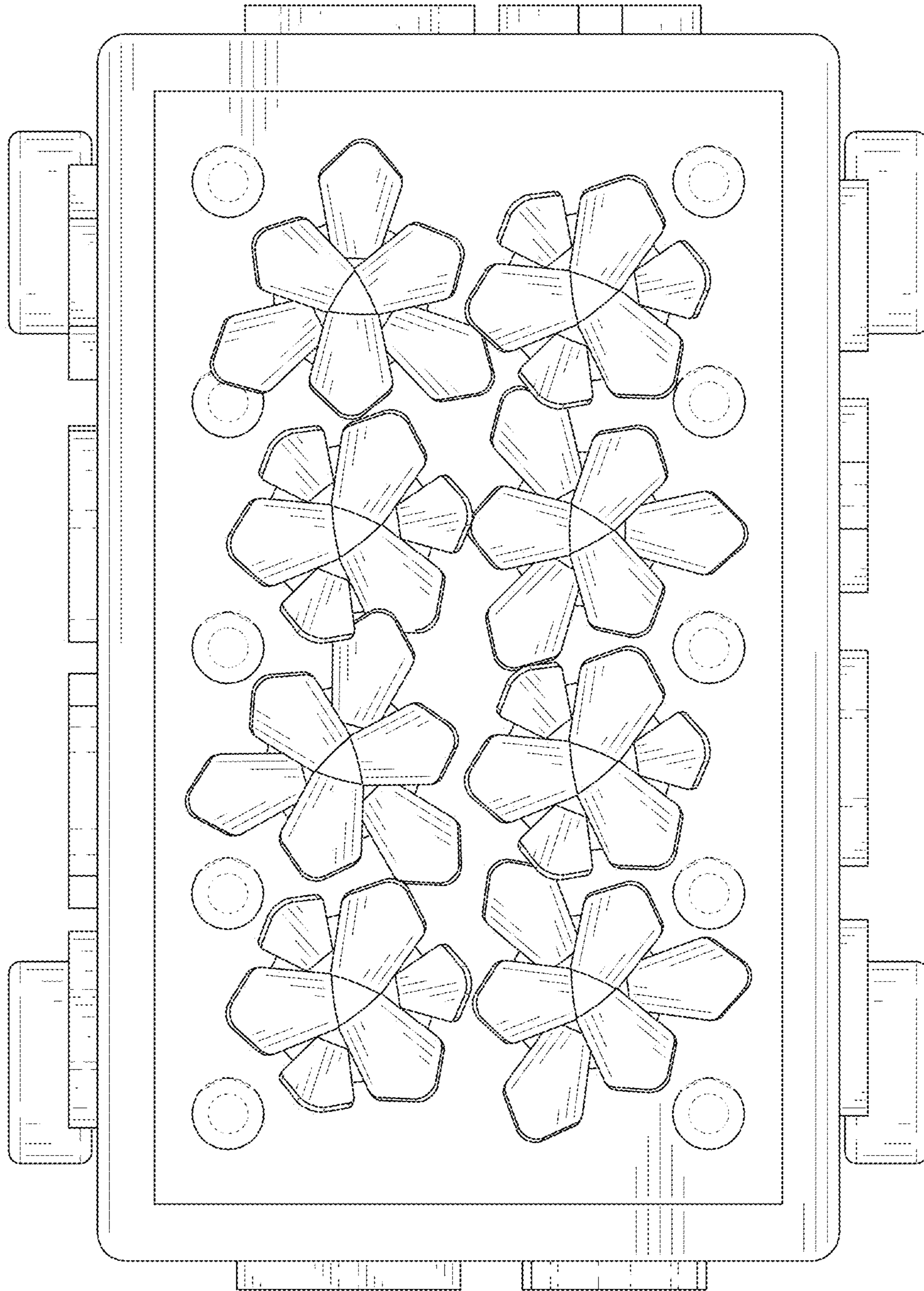

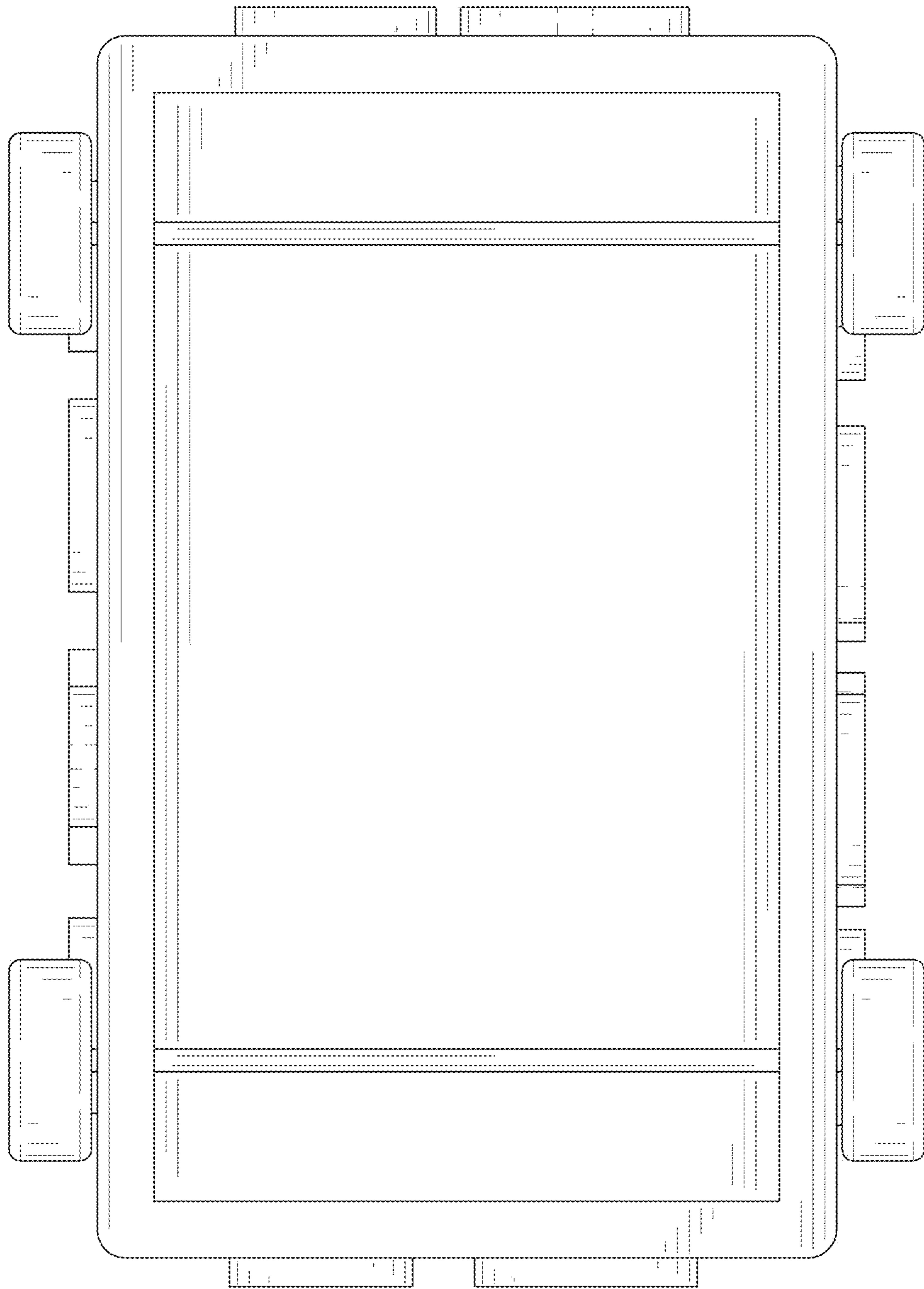

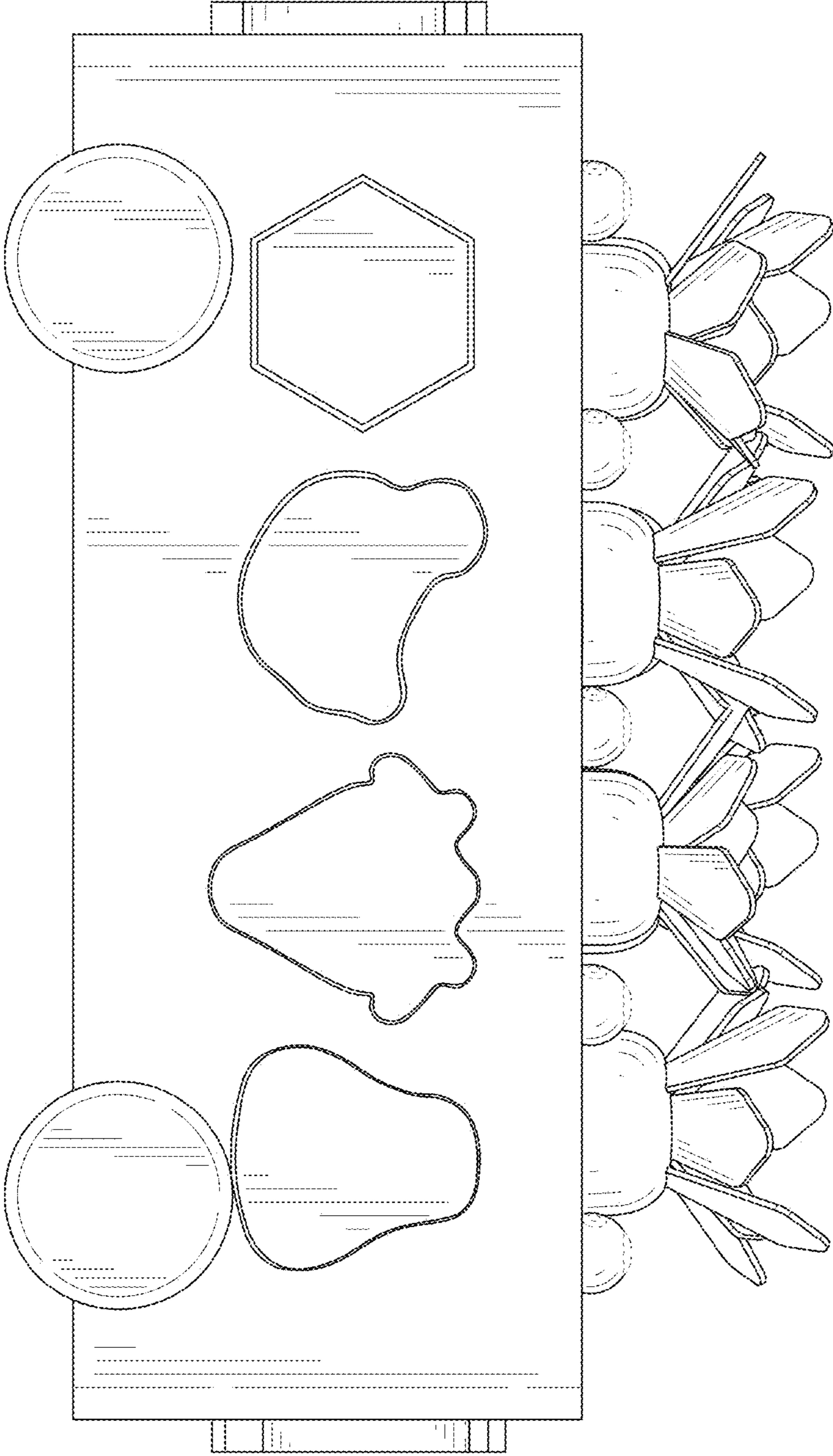

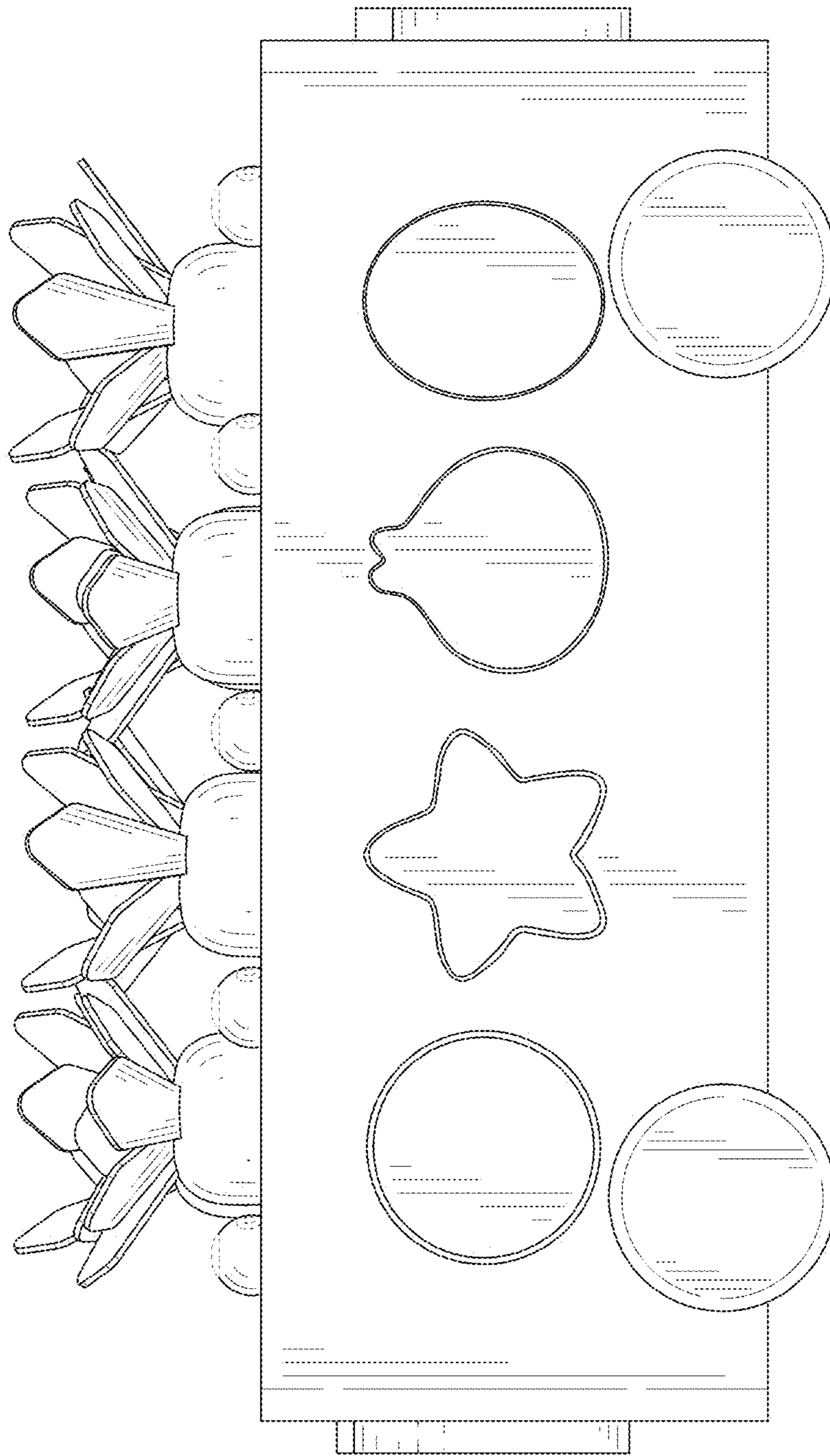

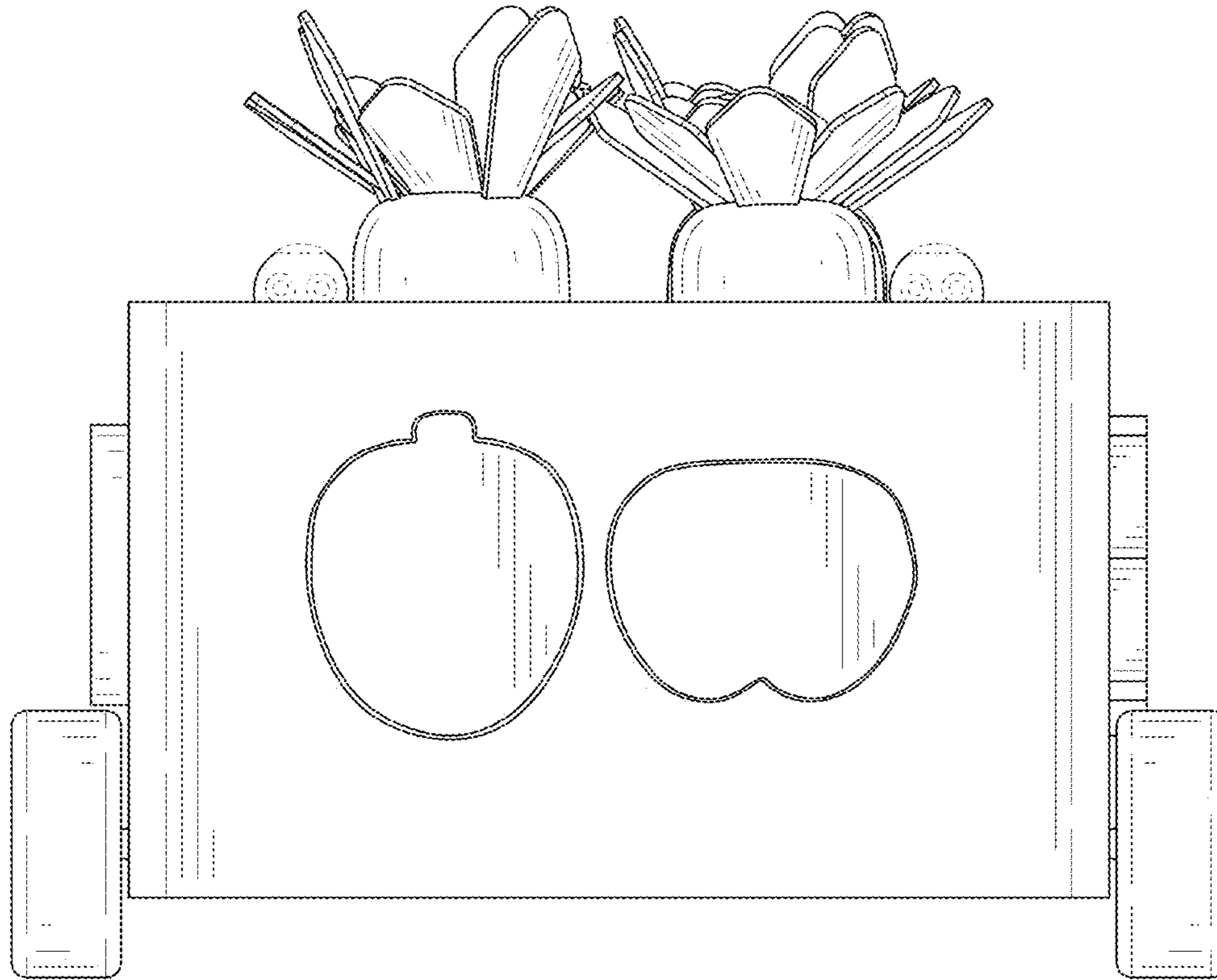

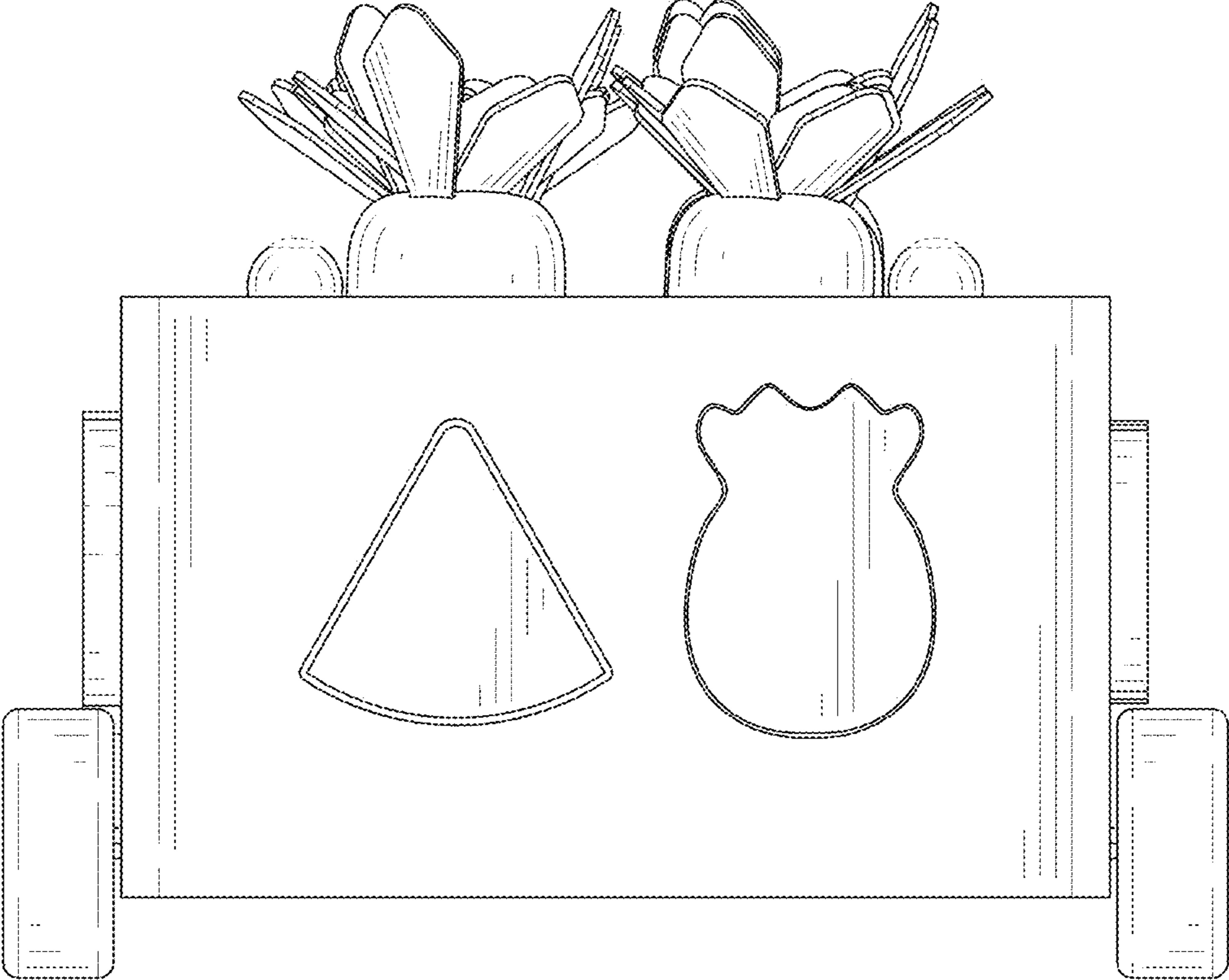

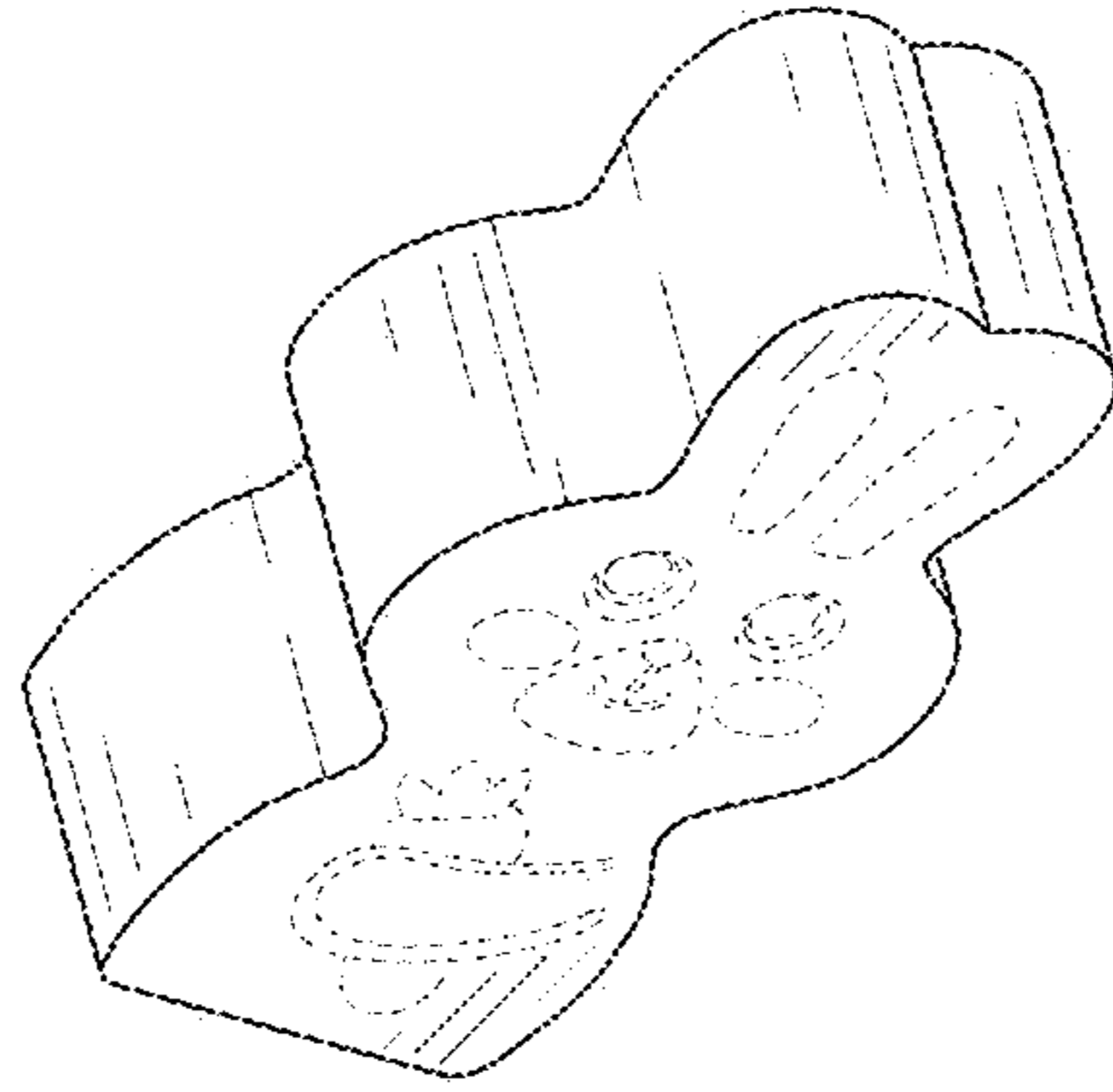

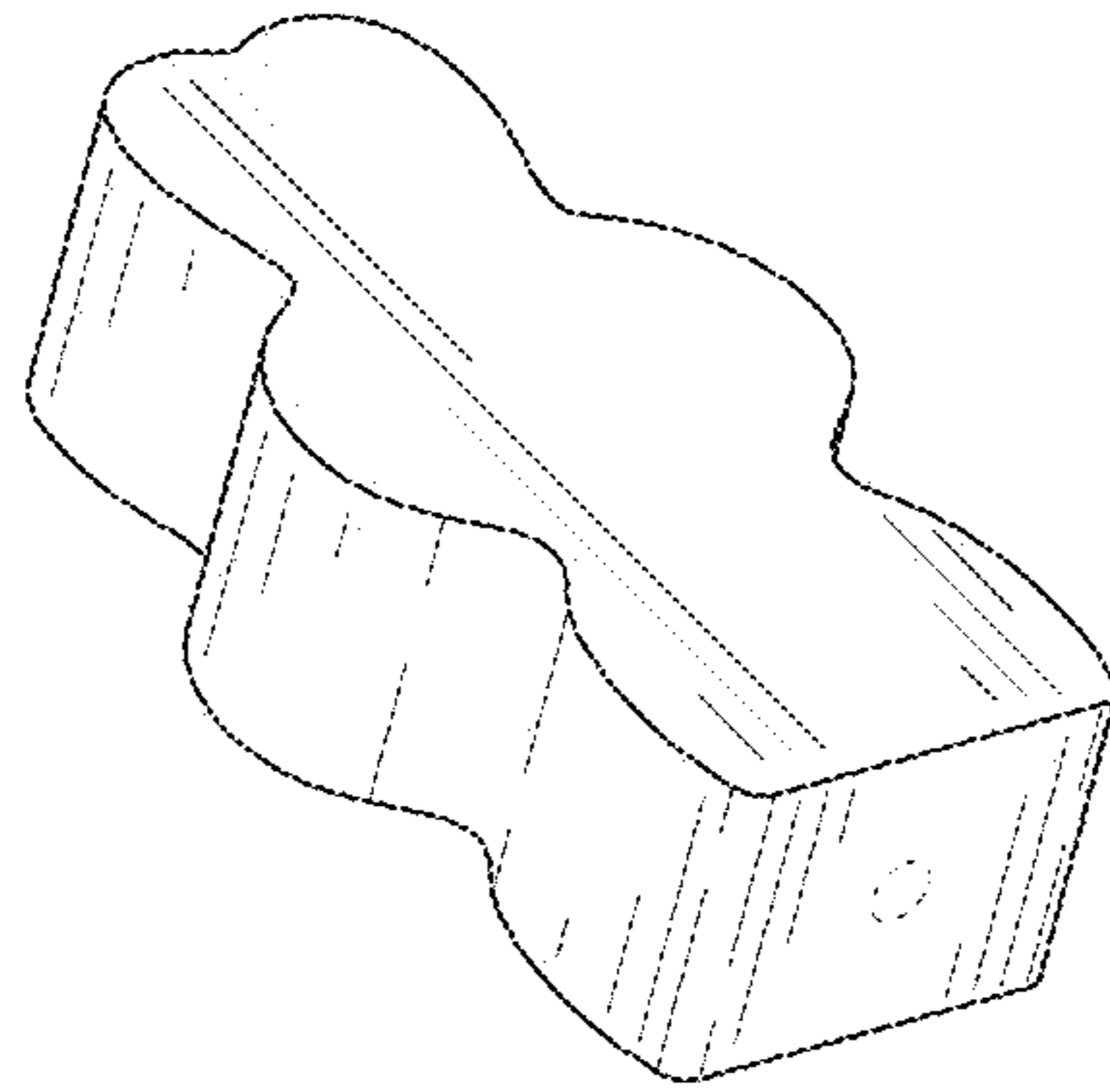

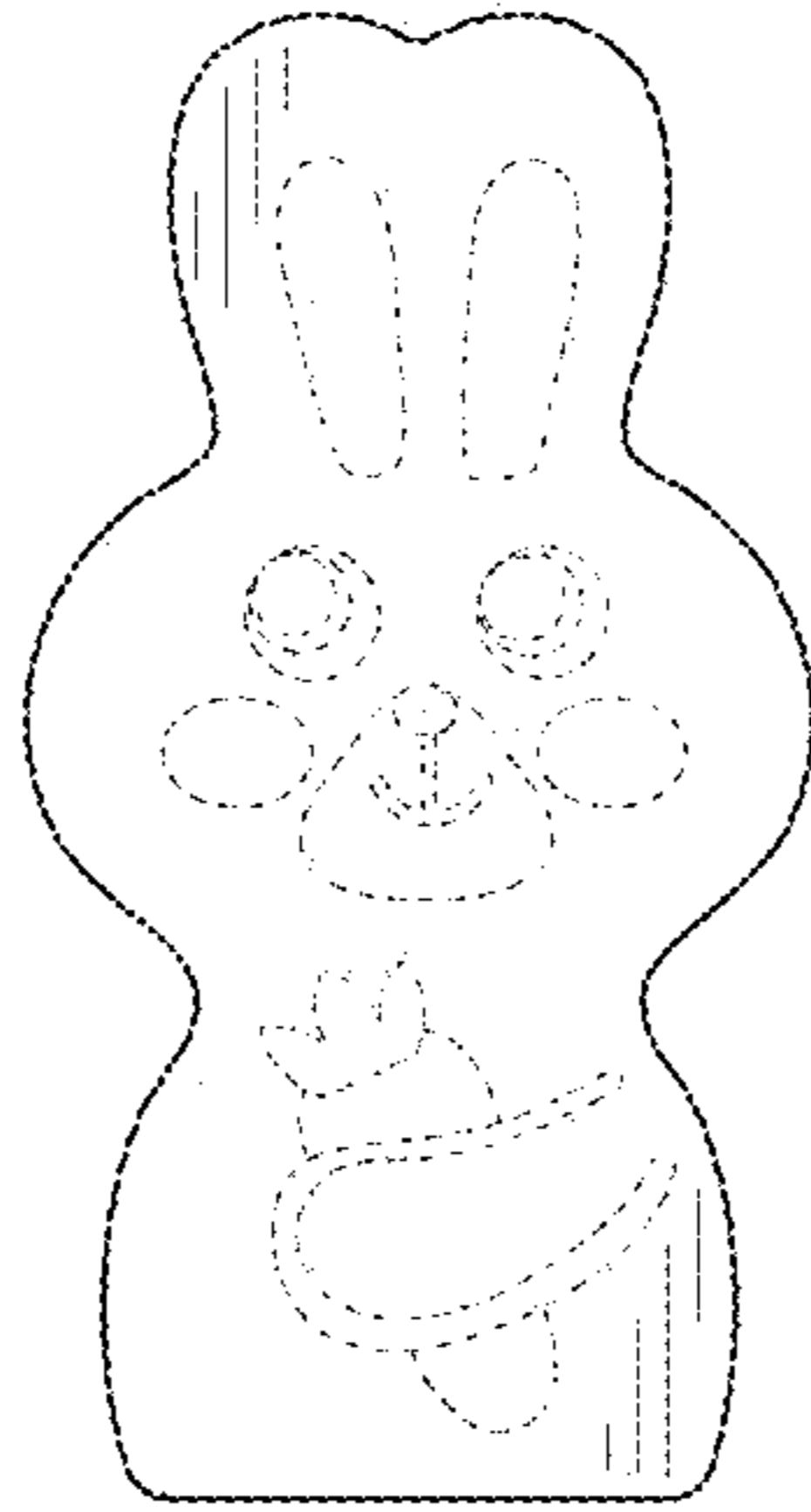

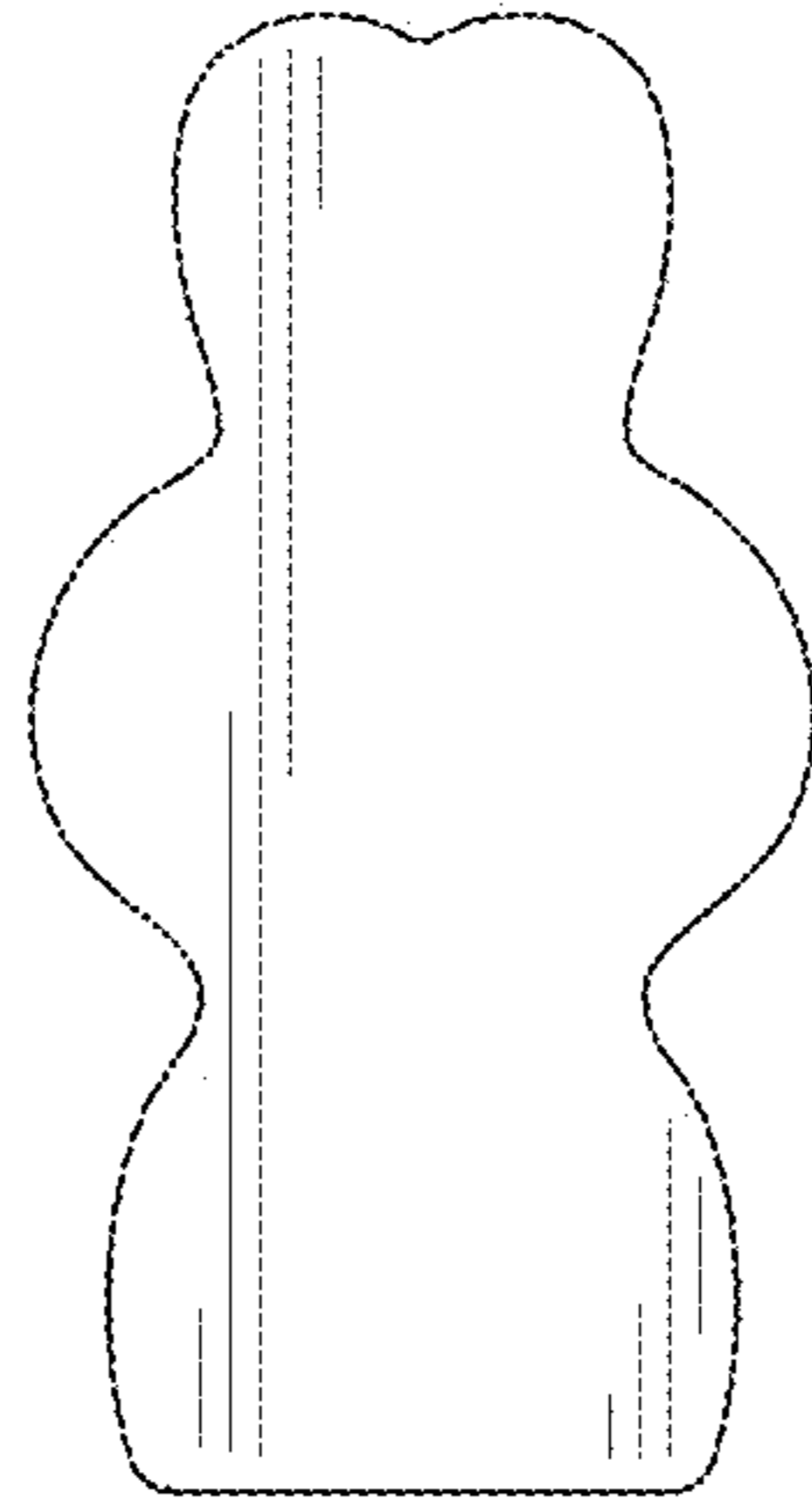

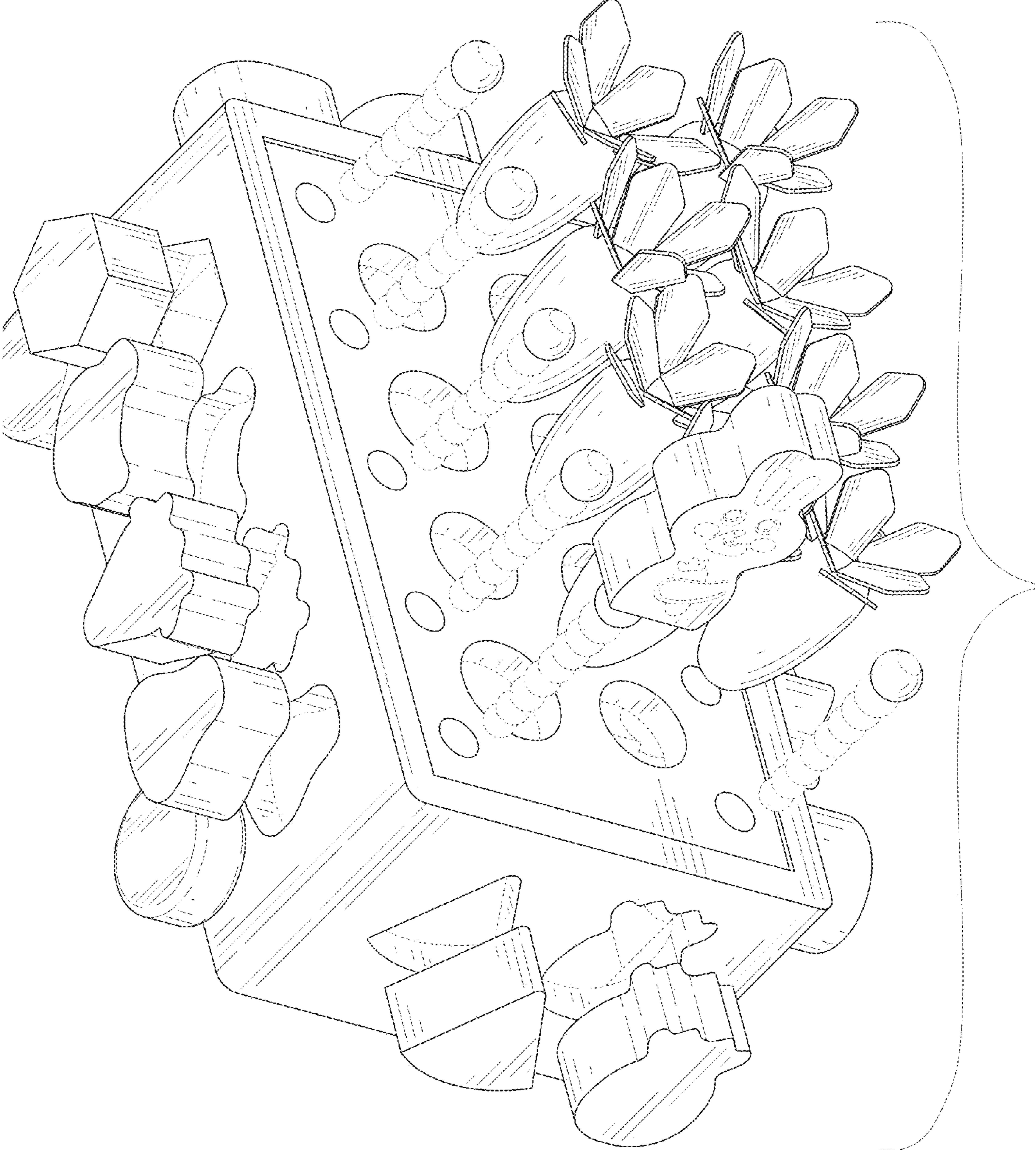
