FIG. 13 is a close-up fourth side view of the distal end of the surgical rasp of FIG. 1.

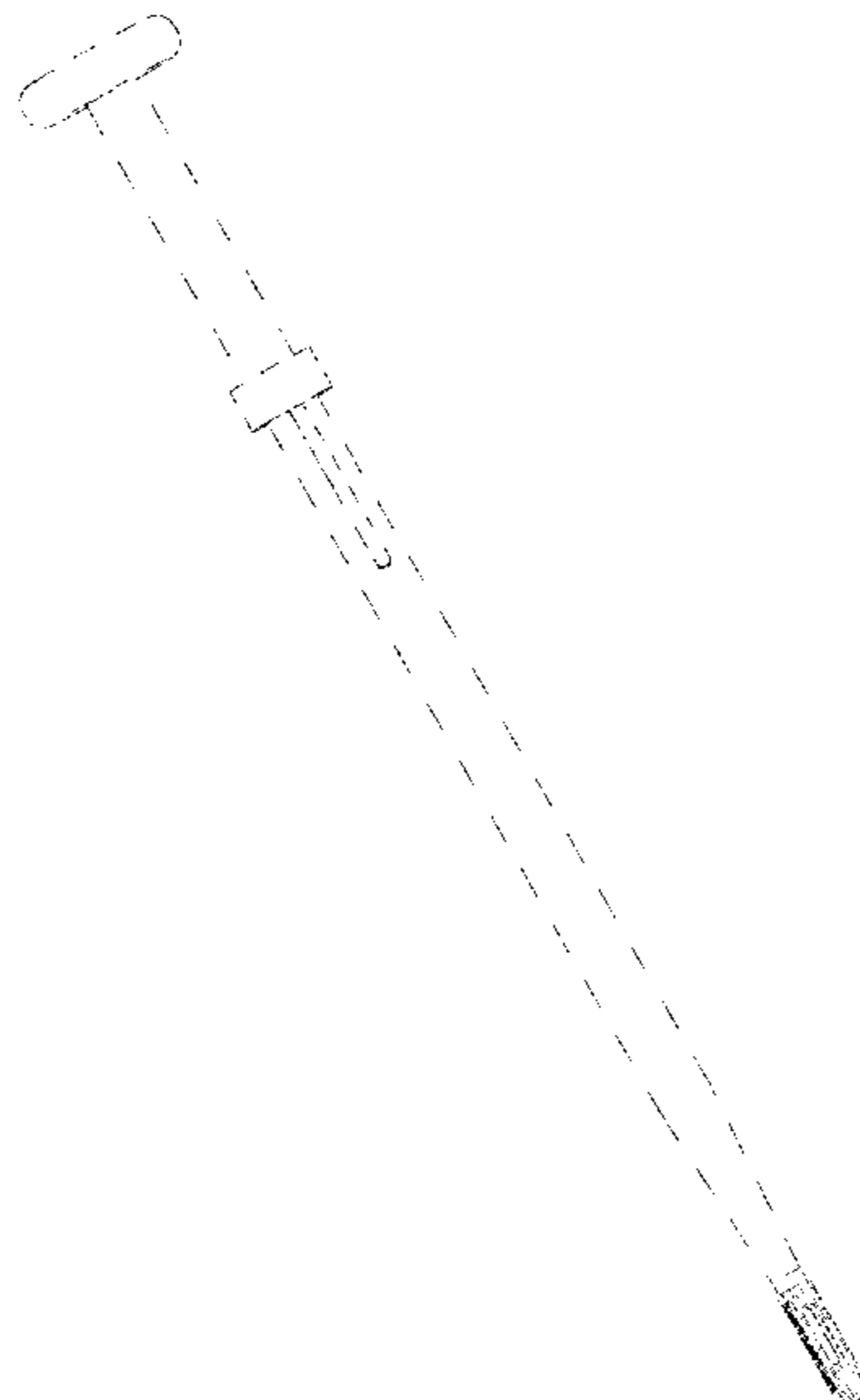

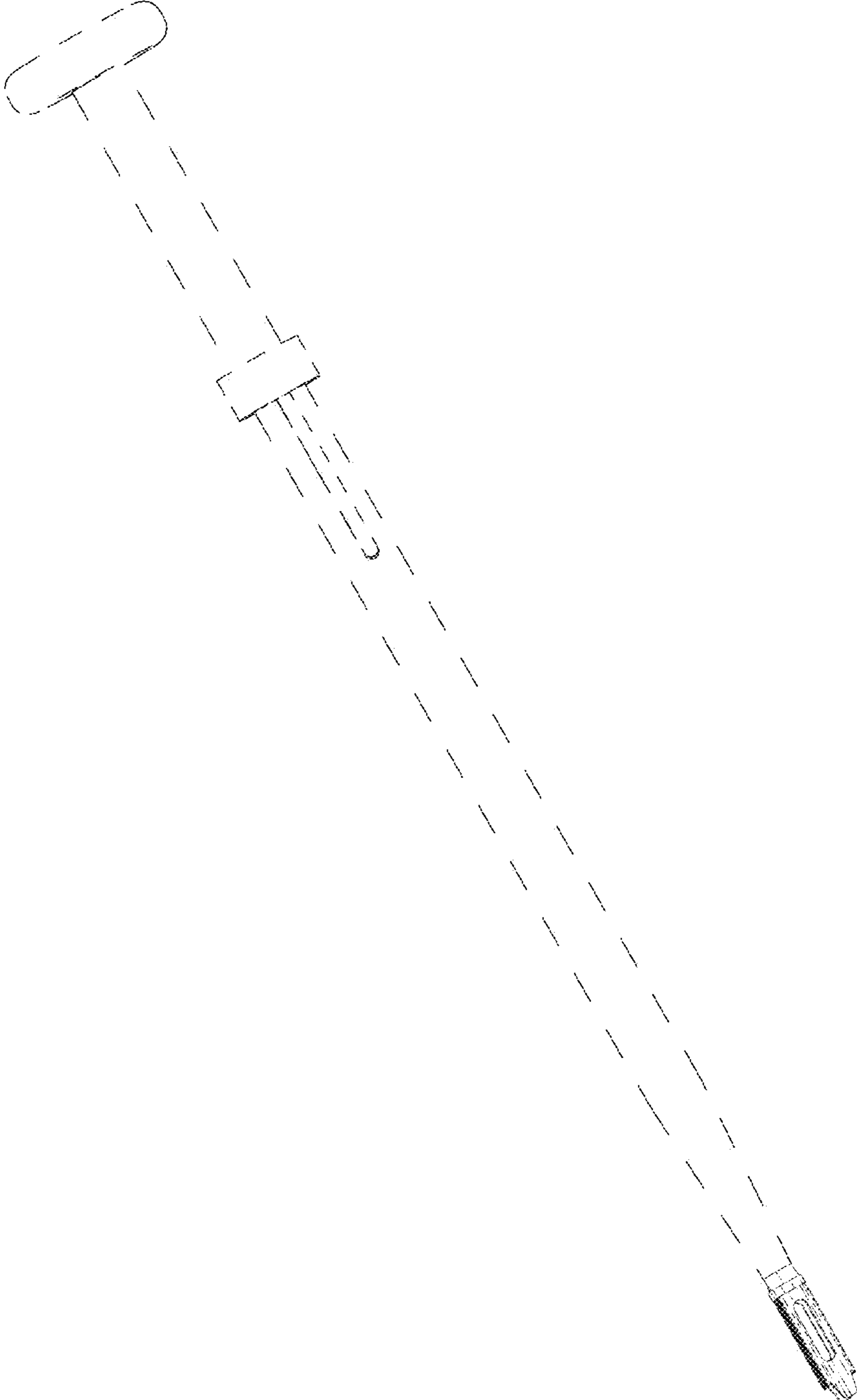

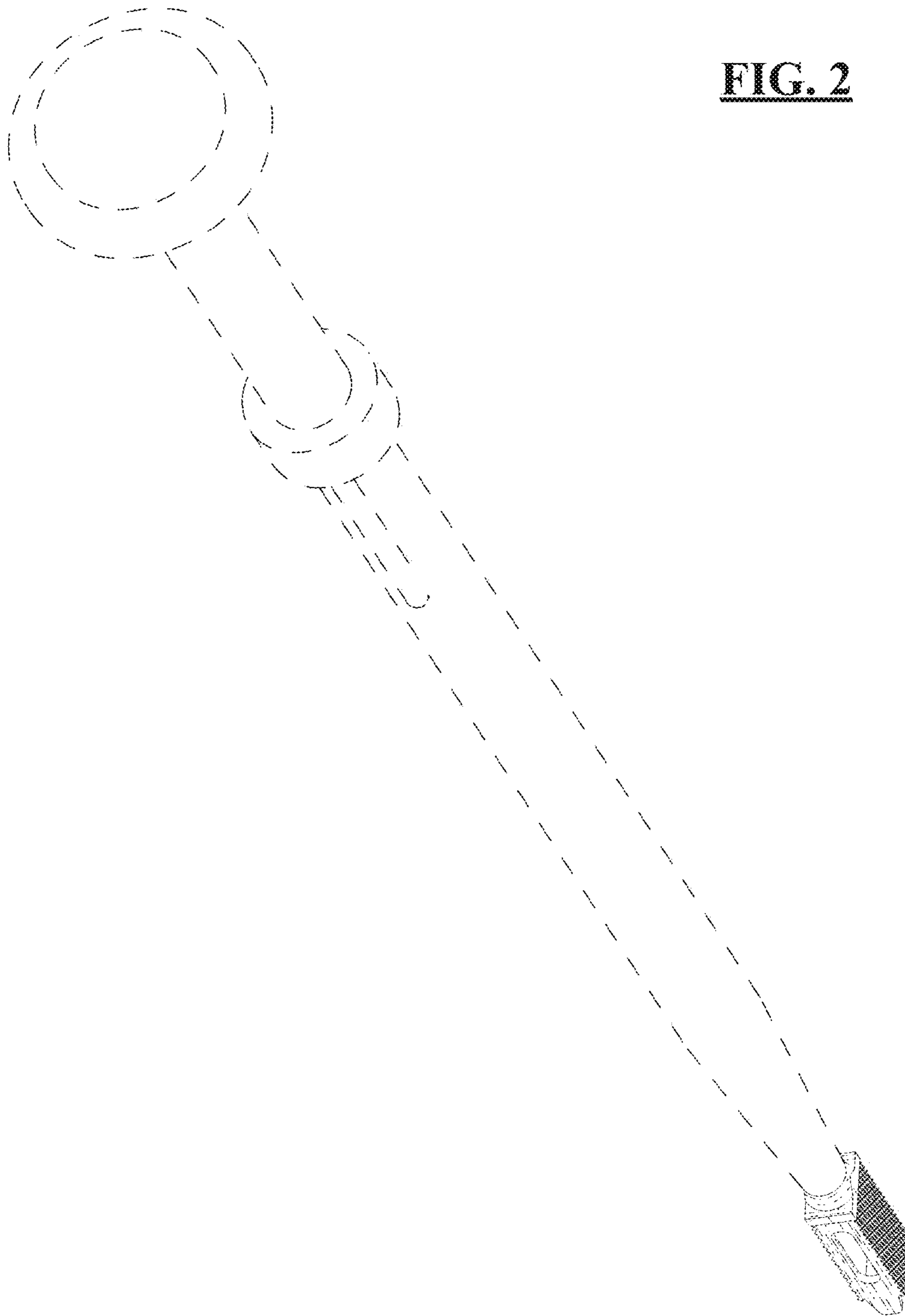

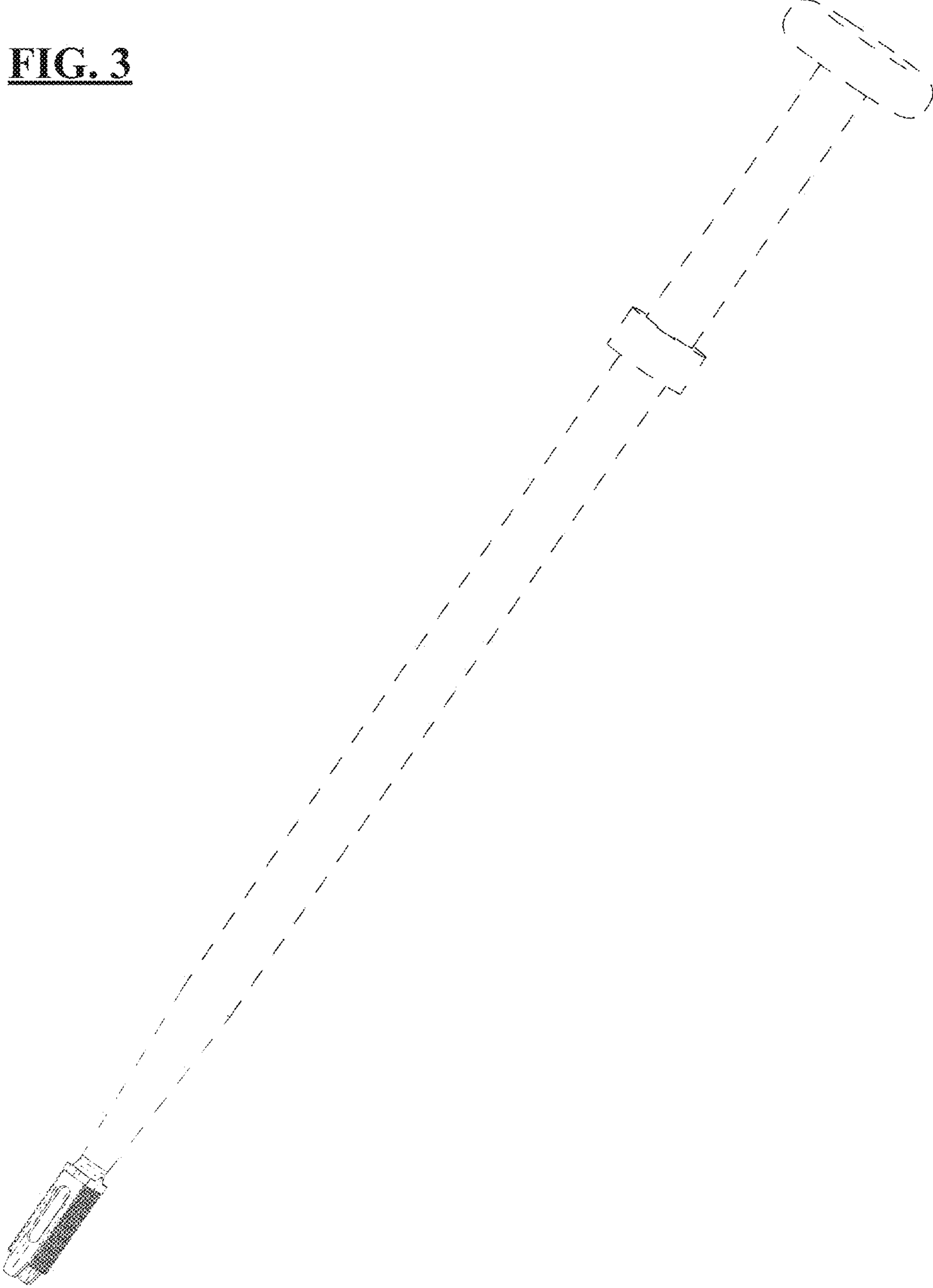

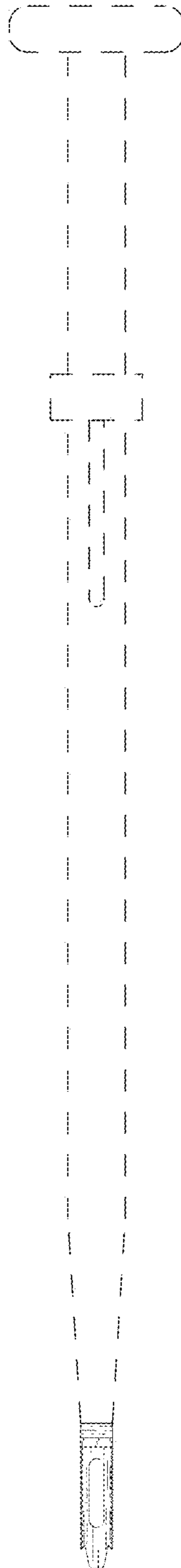

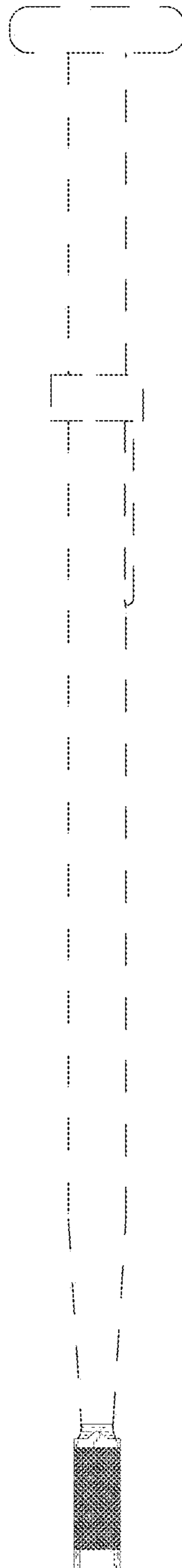

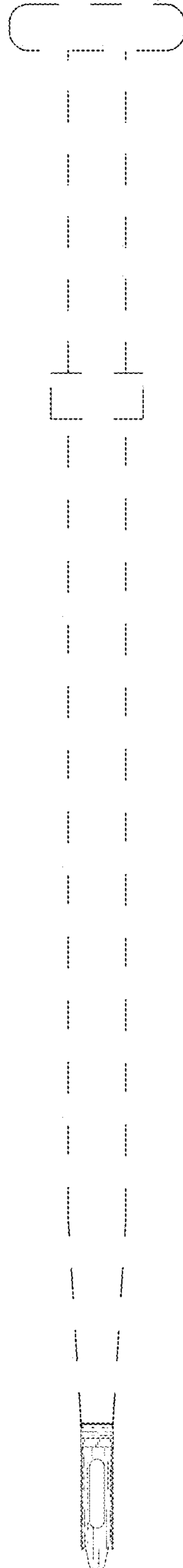

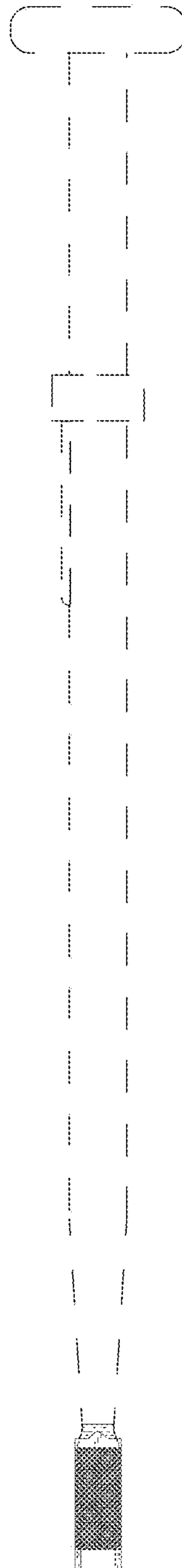

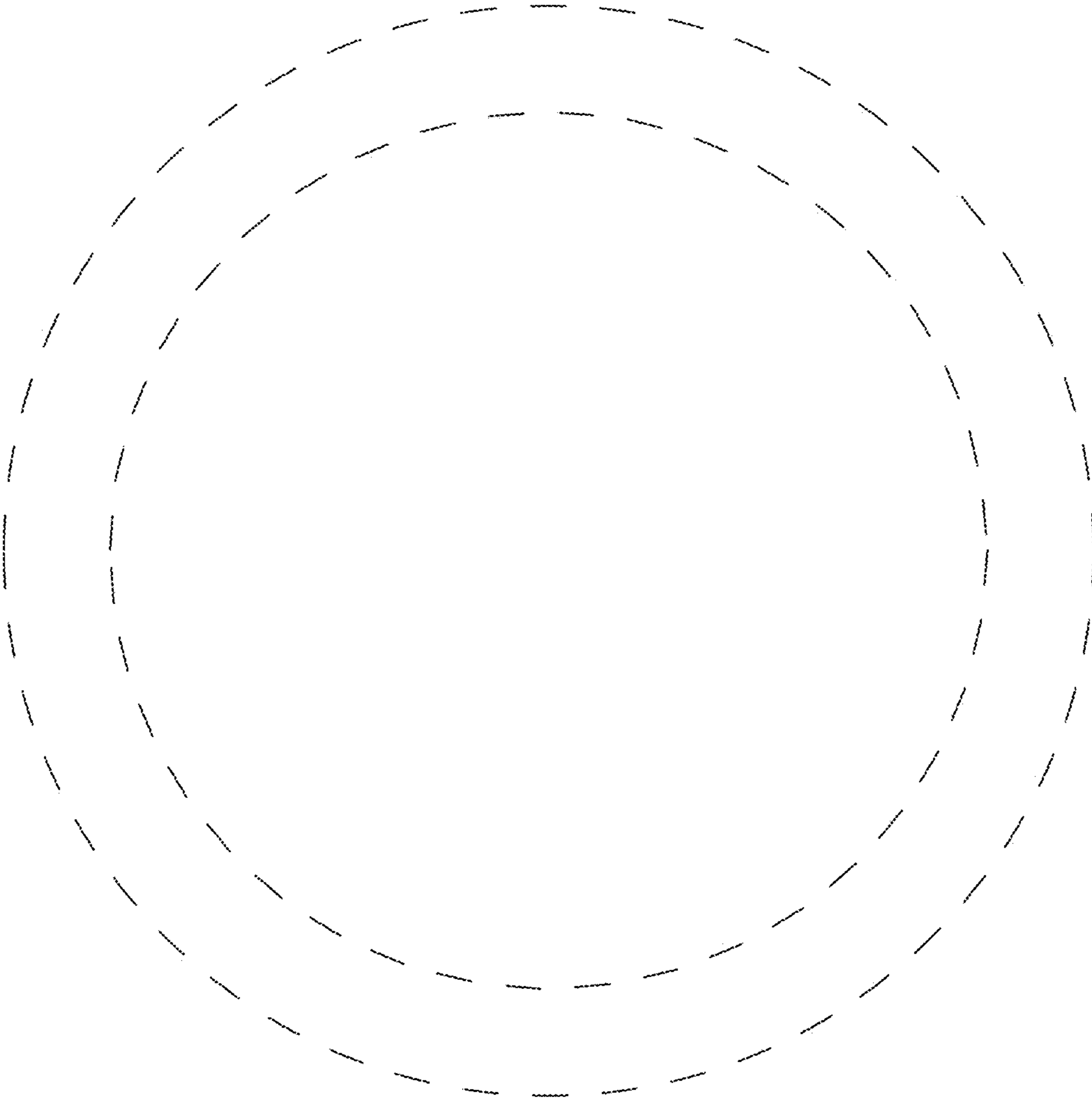

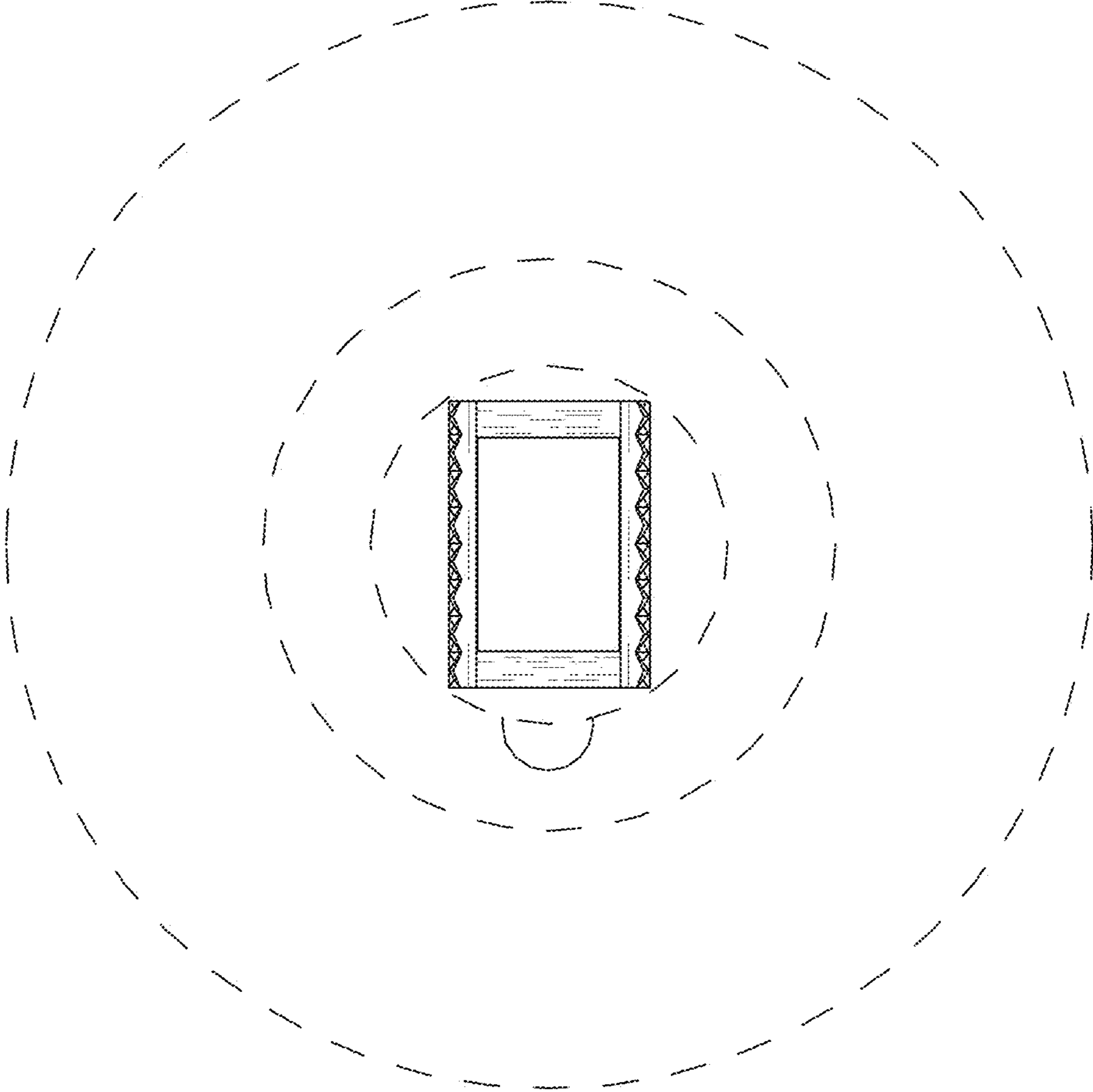

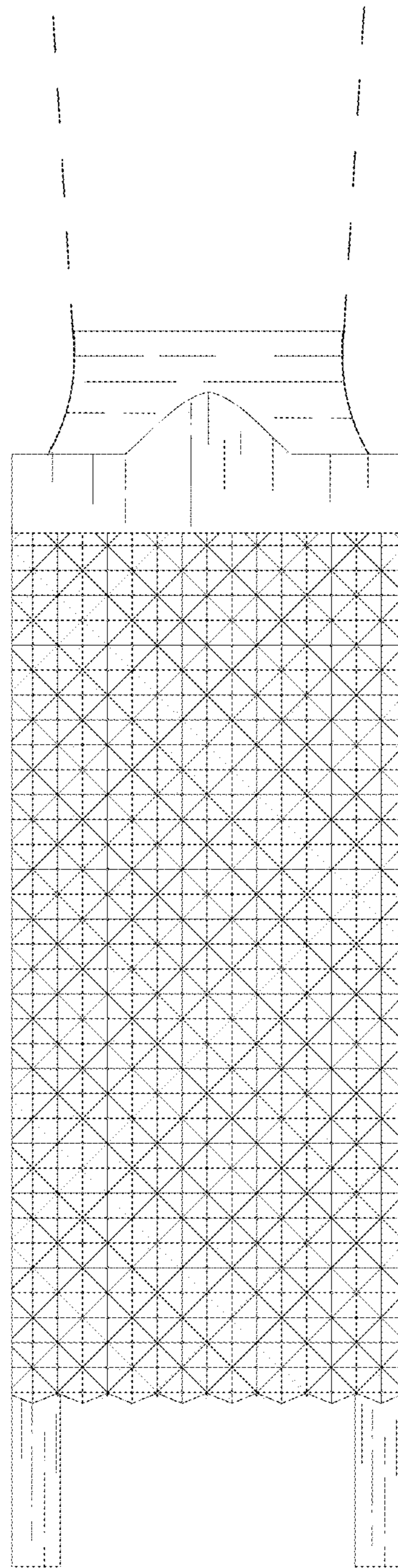

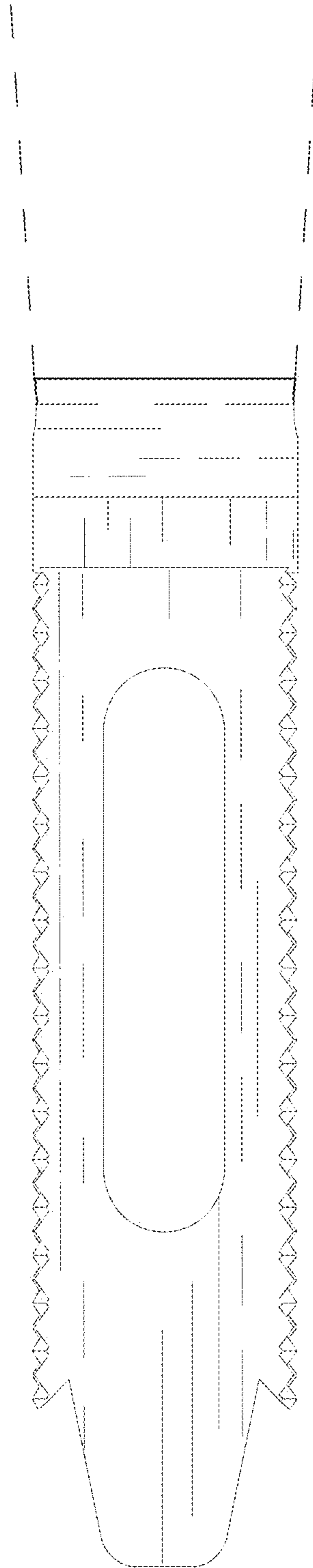

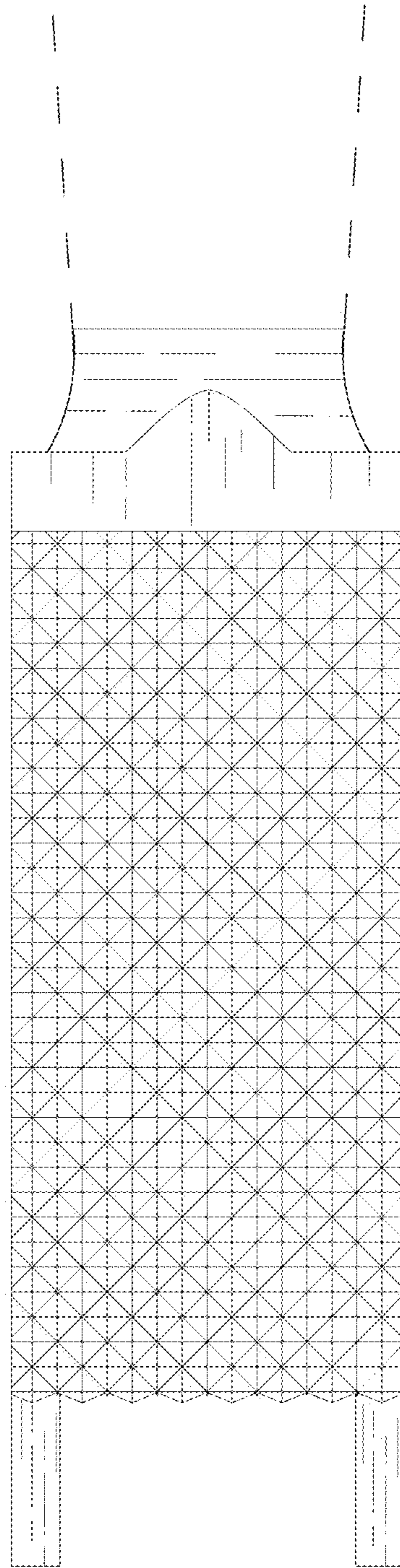
