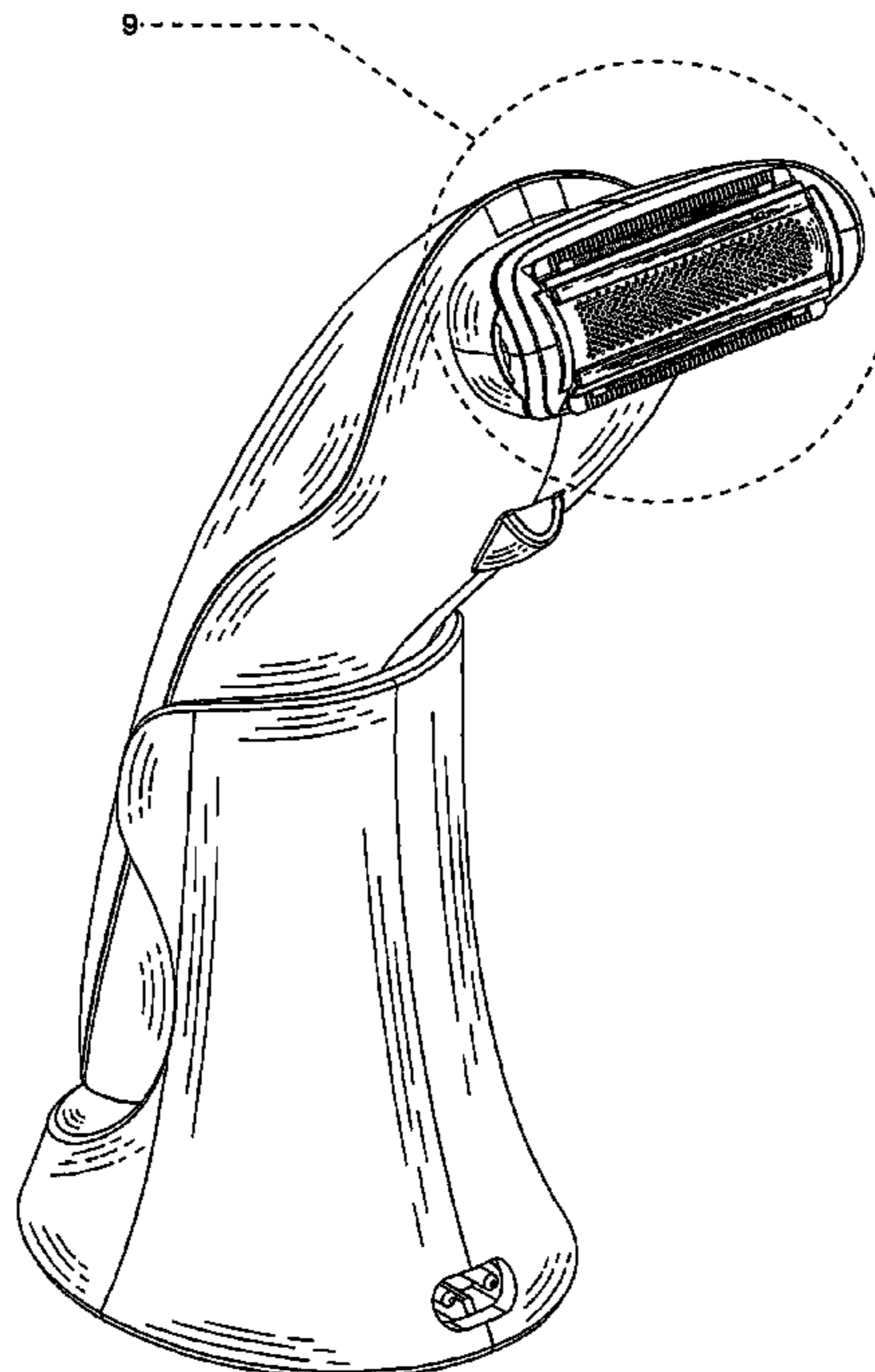
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top and left perspective view of a lady shaver showing my new design;
FIG. 2 is a rear, bottom and right perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a right side elevation view thereof;

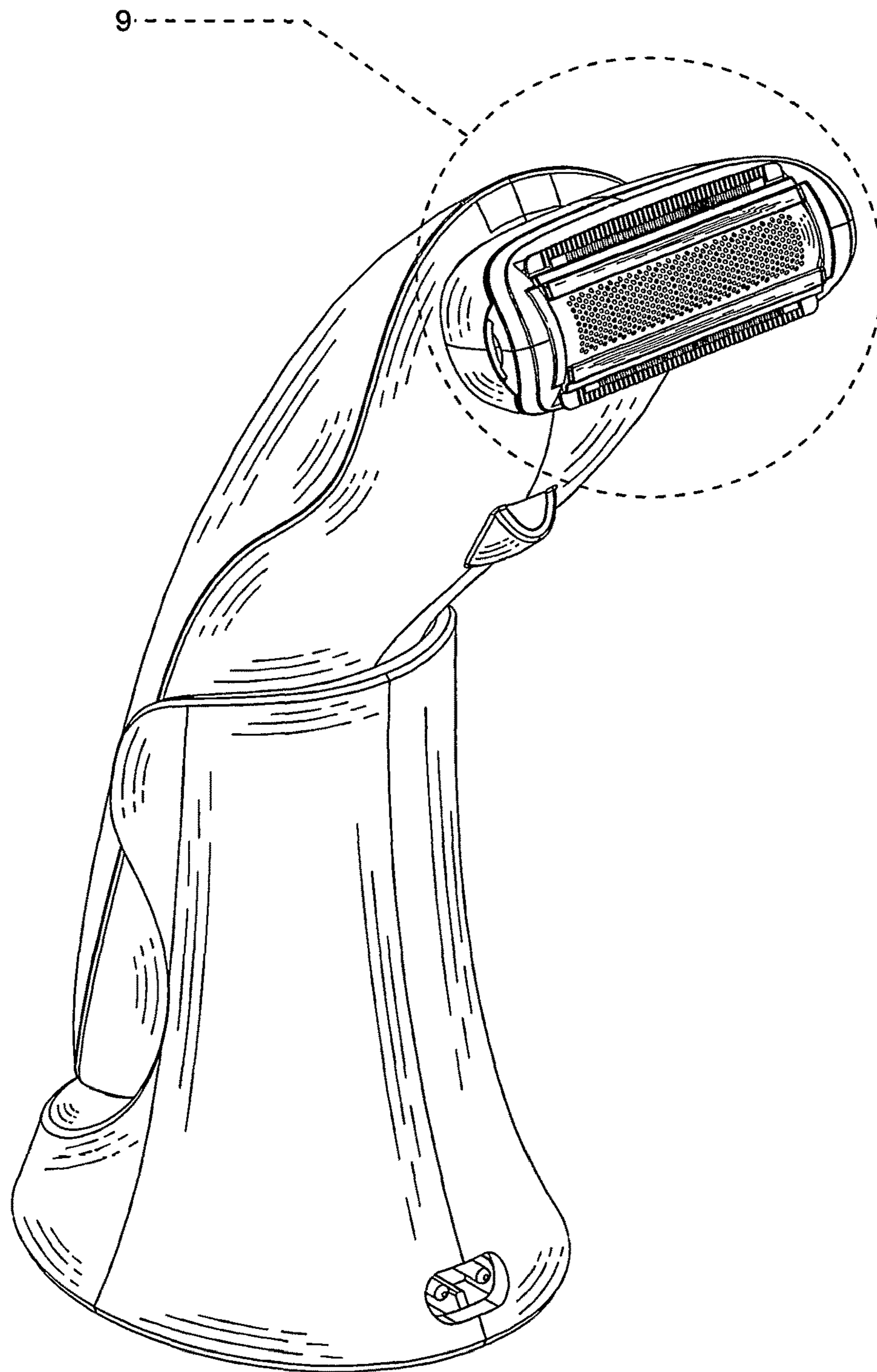

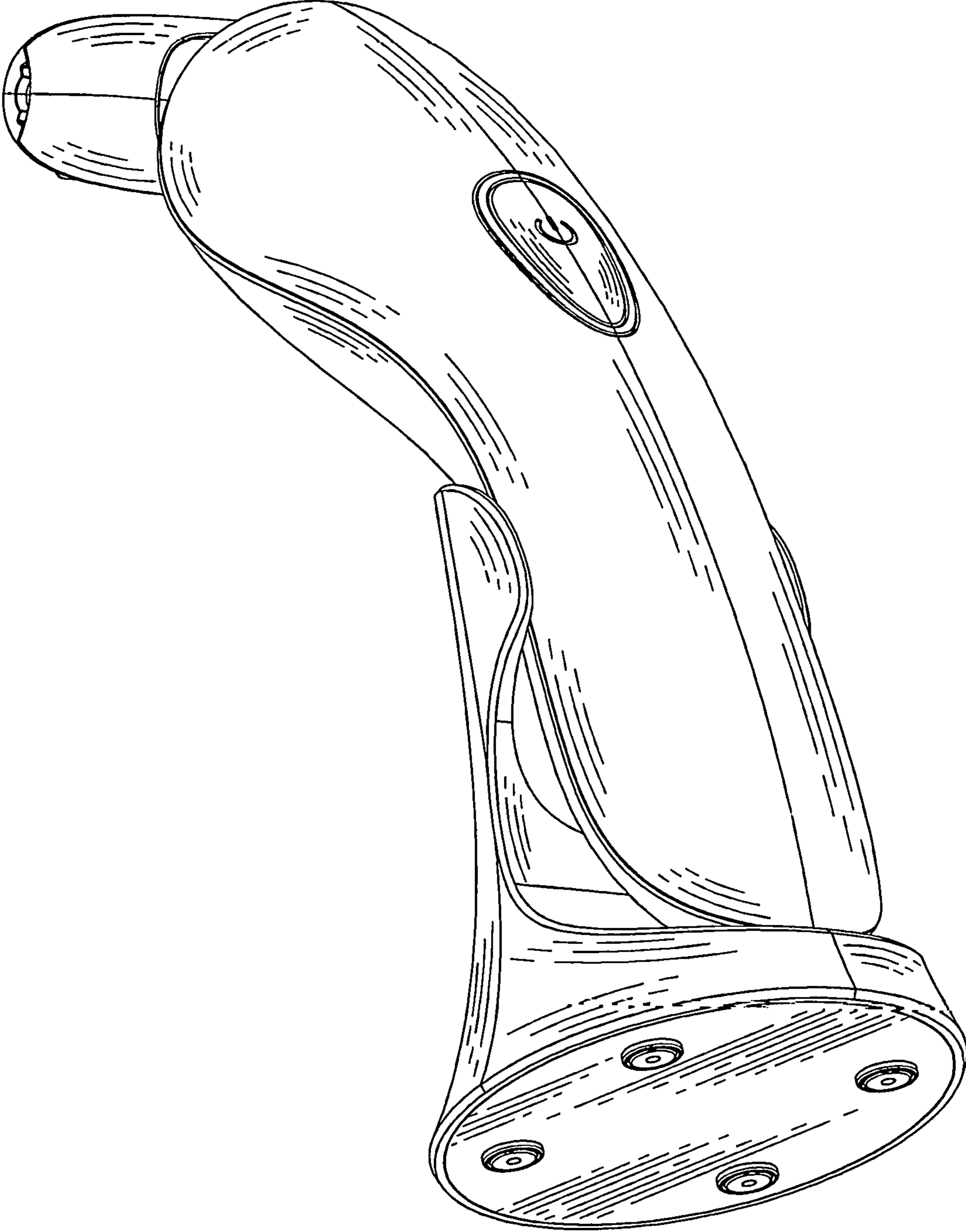

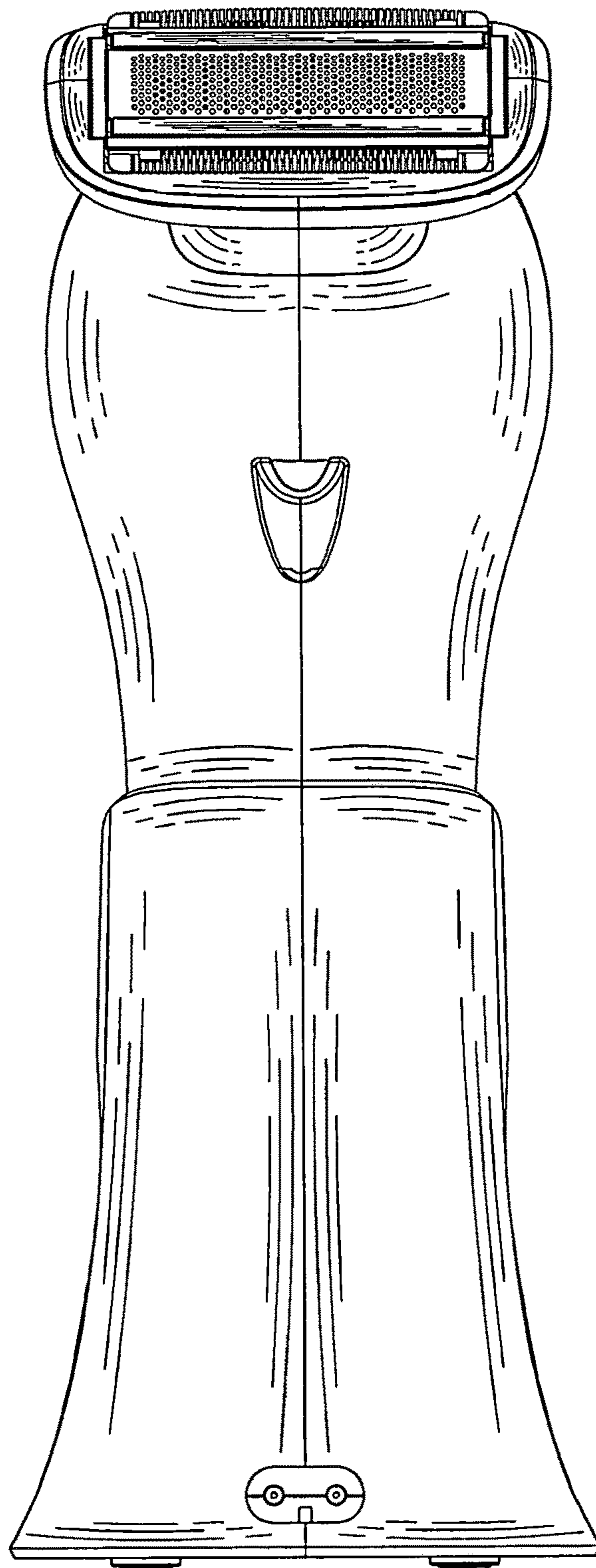

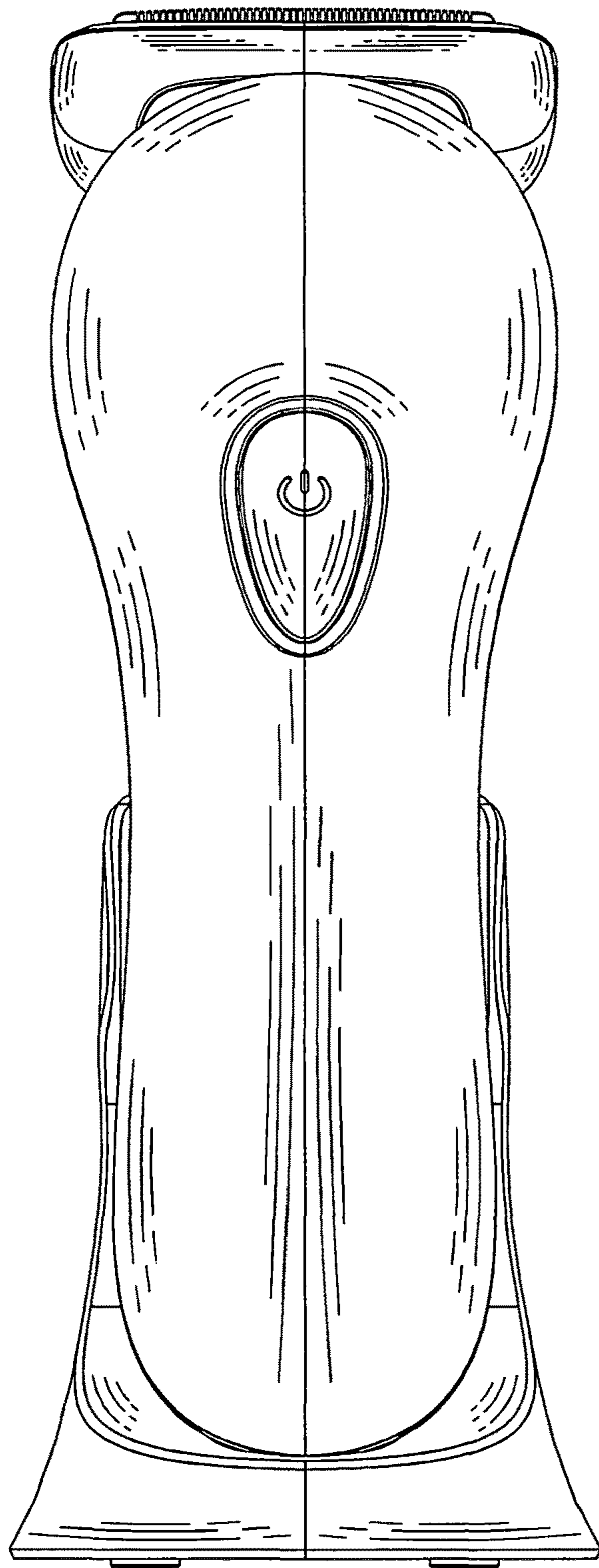

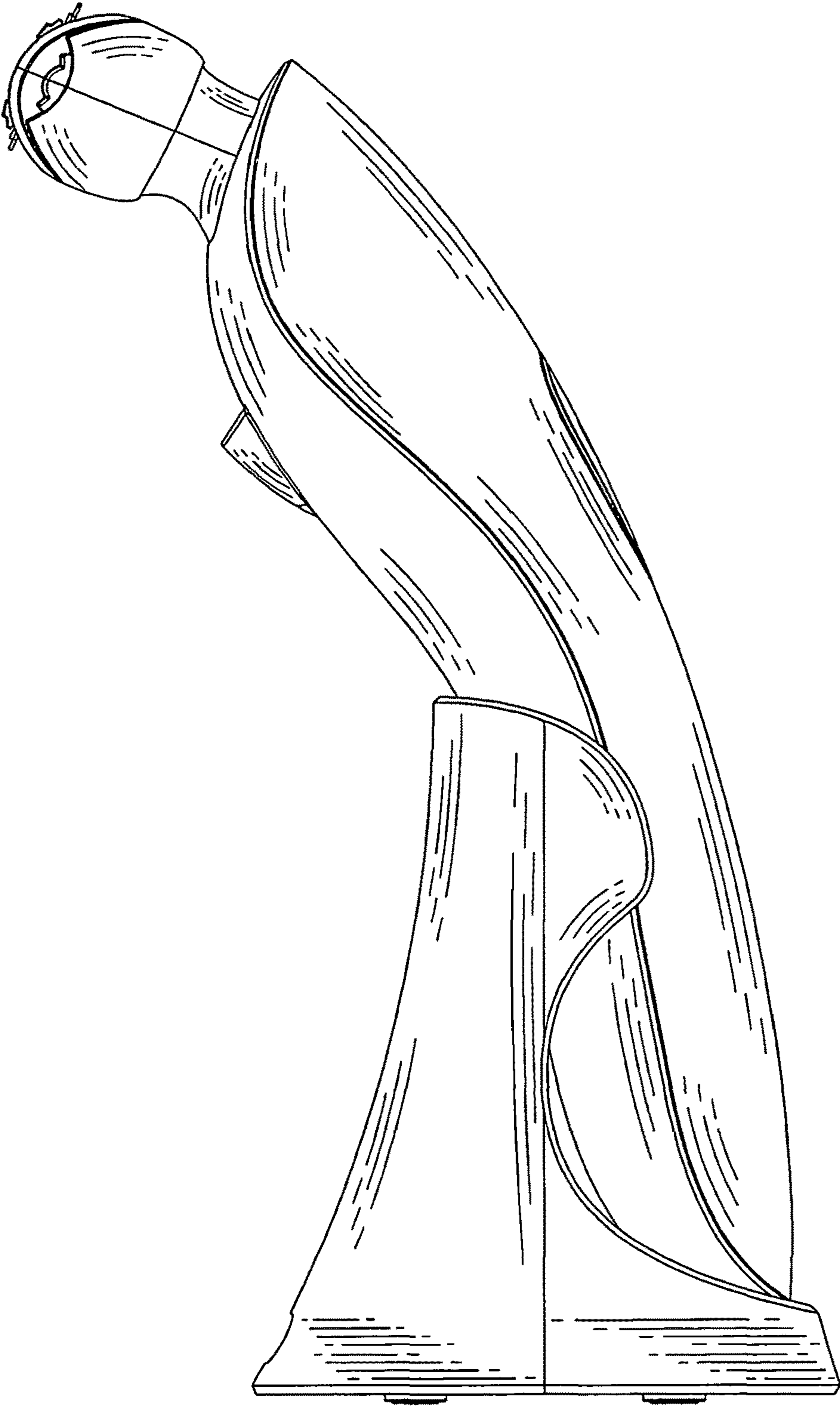

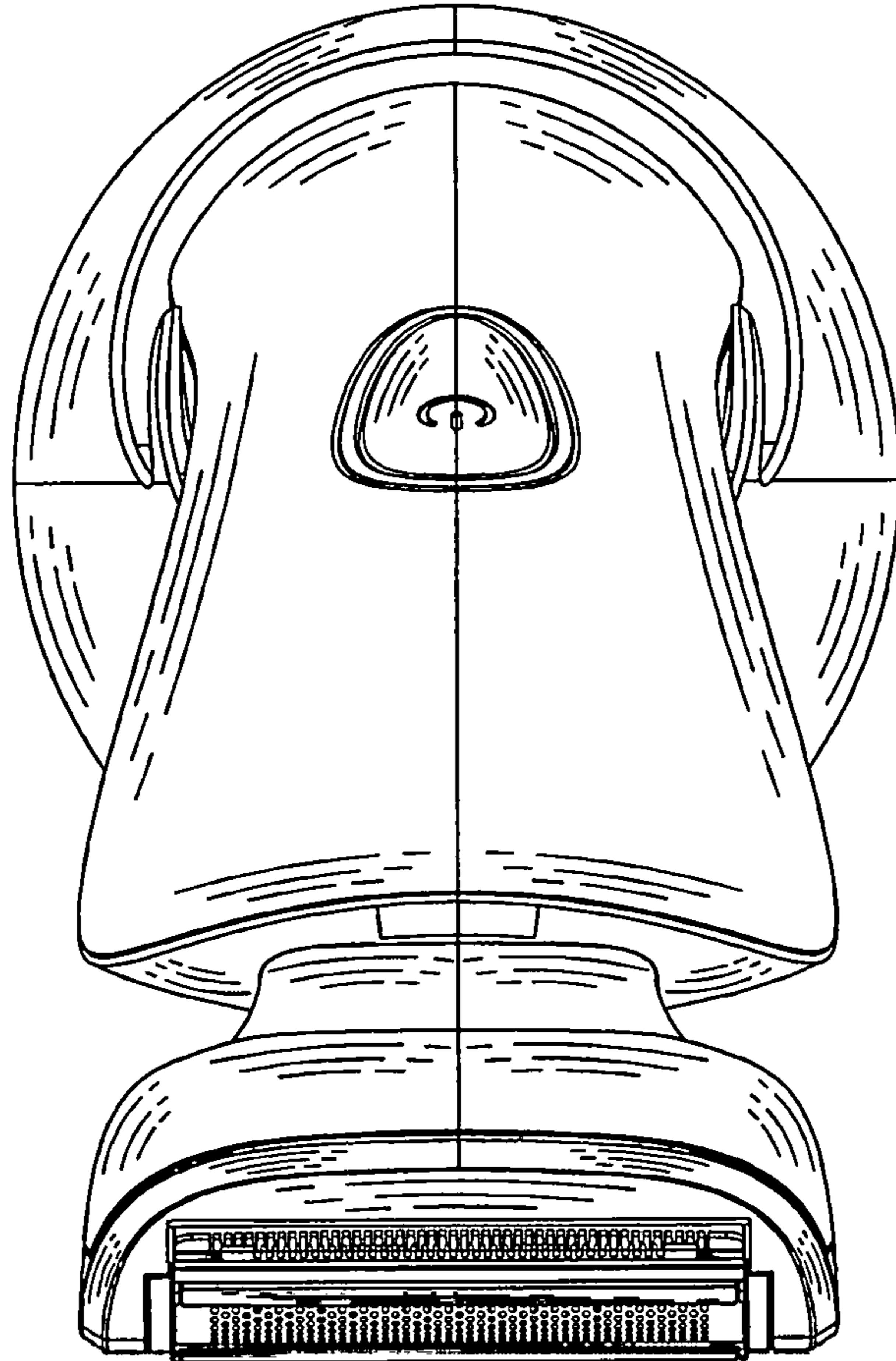

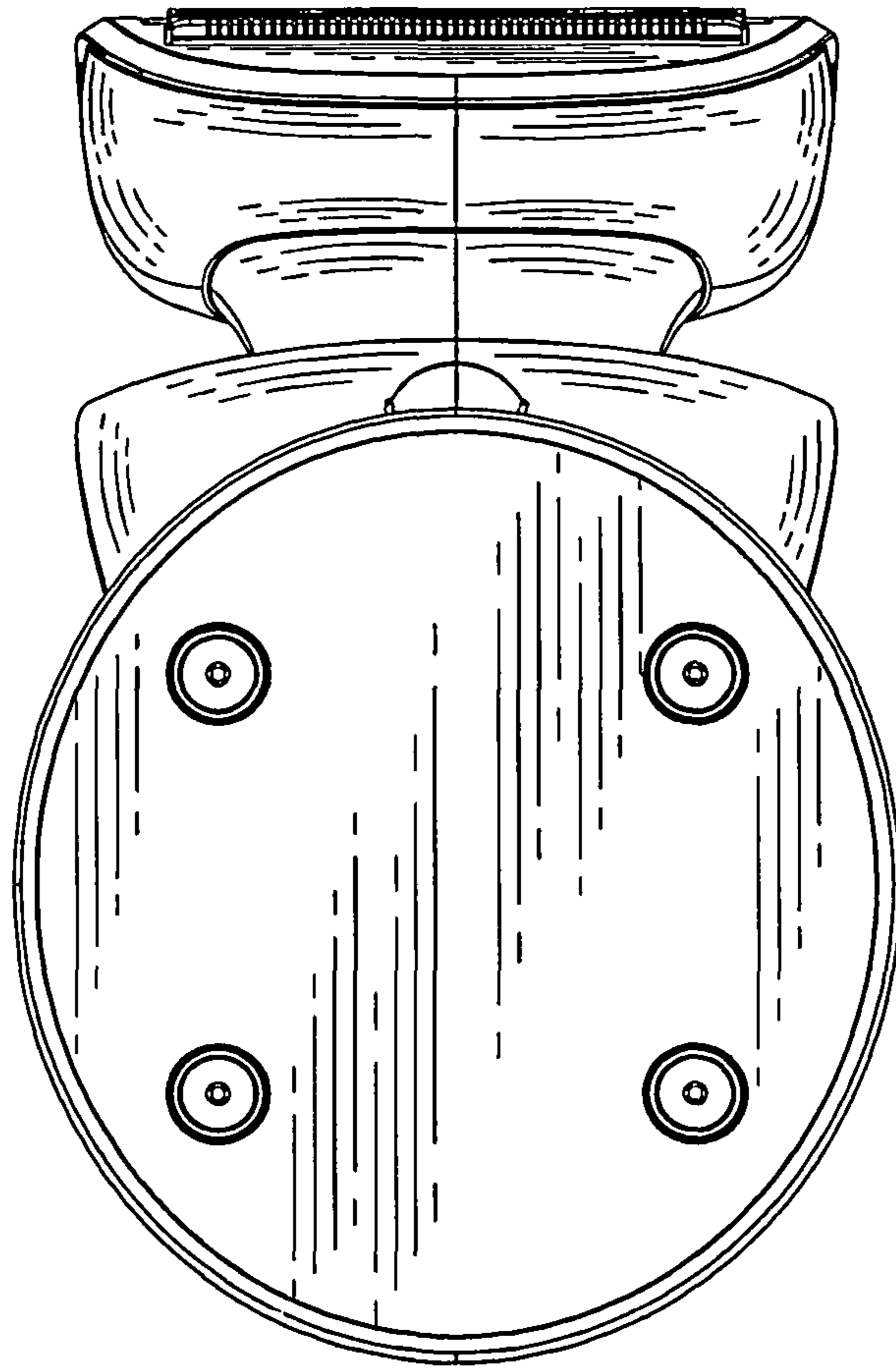

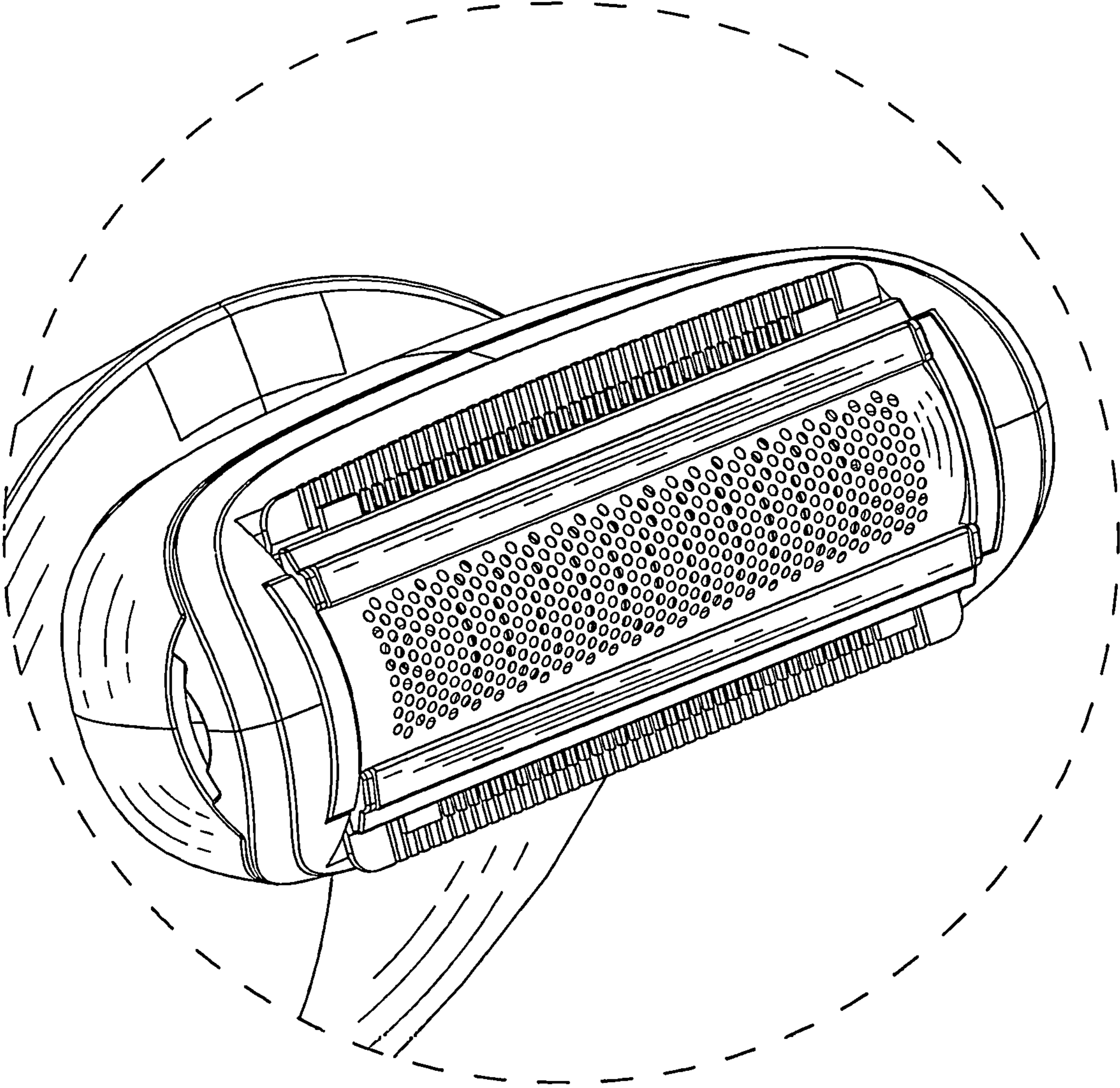
