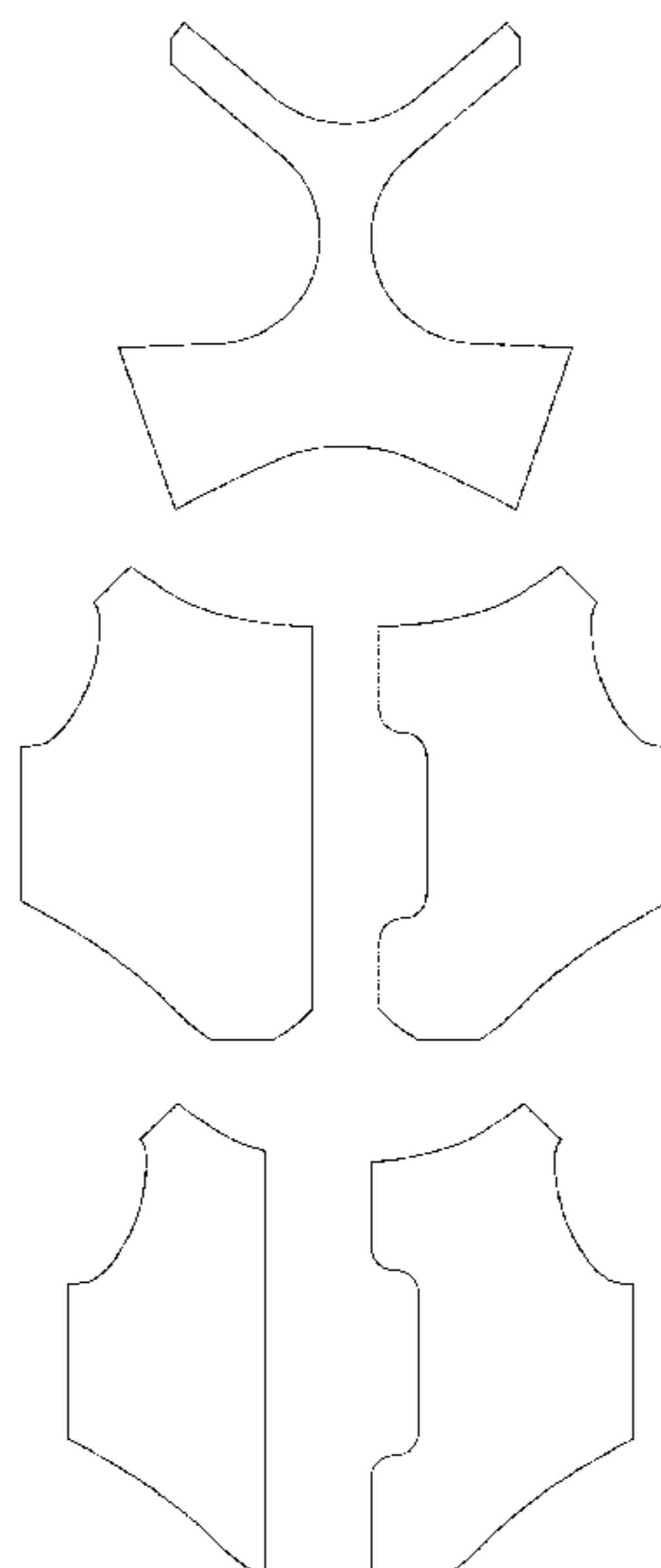
(57) **CLAIM**

The ornamental design for an adjustable dog vest assembly, as shown and described herein.

DESCRIPTION

FIG. 1 is a top plan view of an adjustable dog vest assembly, shown in a flat configuration;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top, front, left side perspective view of the first dog vest panel, shown within an environment of use;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a top, front, right side perspective view of the second dog vest panel, shown within an environment of use;
FIG. 6 is a top, rear, left side perspective view thereof;
FIG. 7 is a top, front, right side perspective view of the third dog vest panel, shown within an environment of use;
FIG. 8 is a top, rear, right side perspective view thereof;
FIG. 9 is a top, front, left side perspective view of the fourth dog vest panel, shown within an environment of use;
FIG. 10 is a top, rear, right side perspective view thereof;

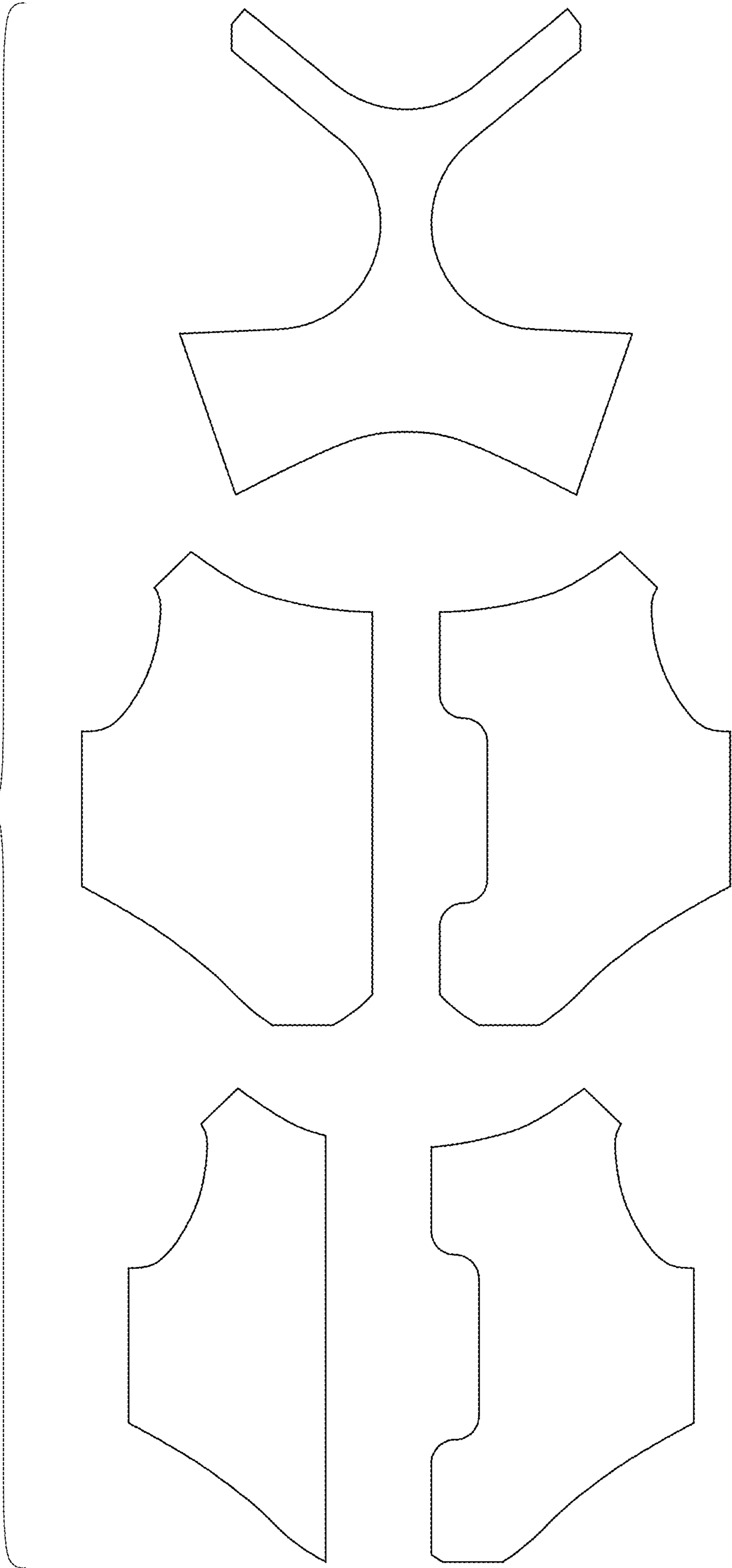
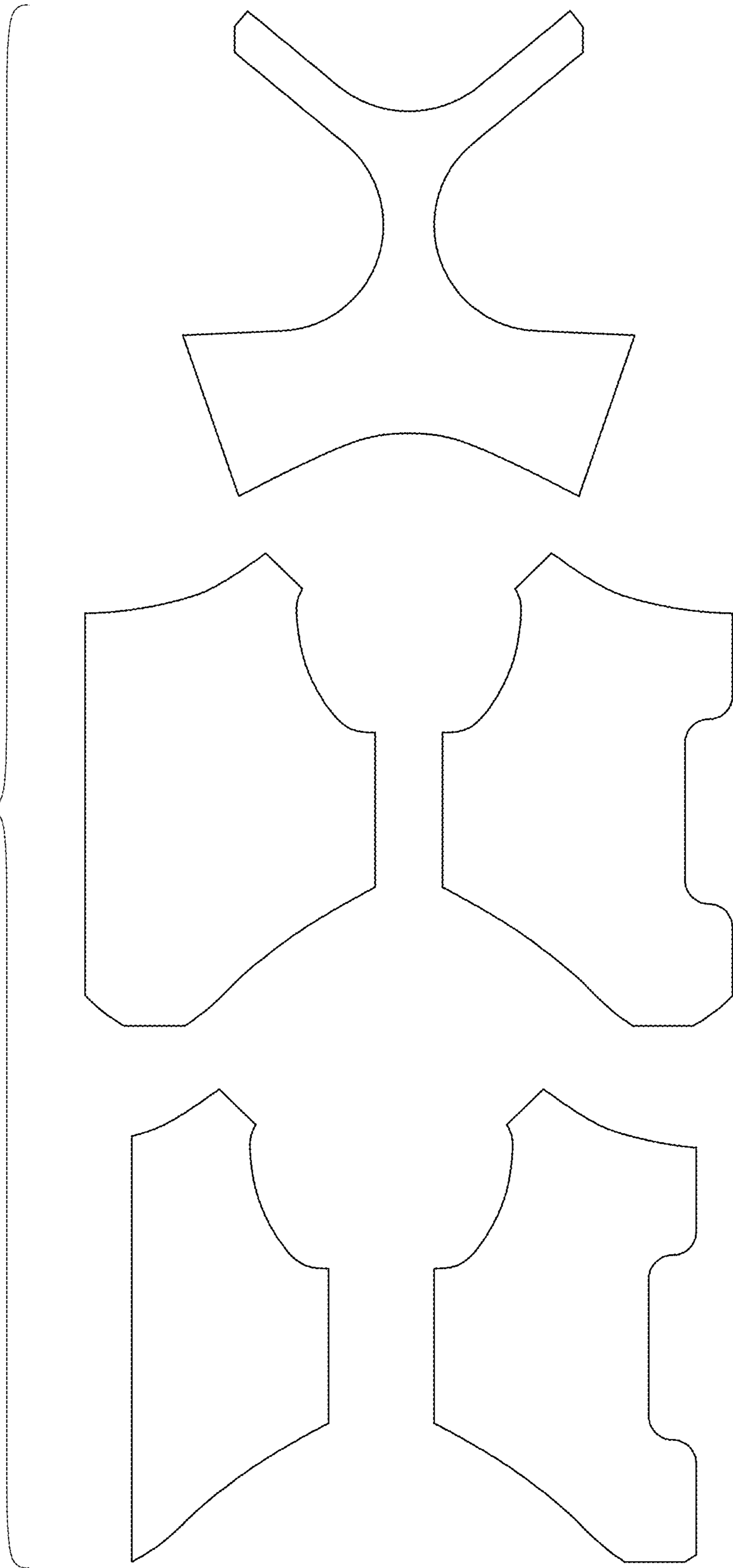

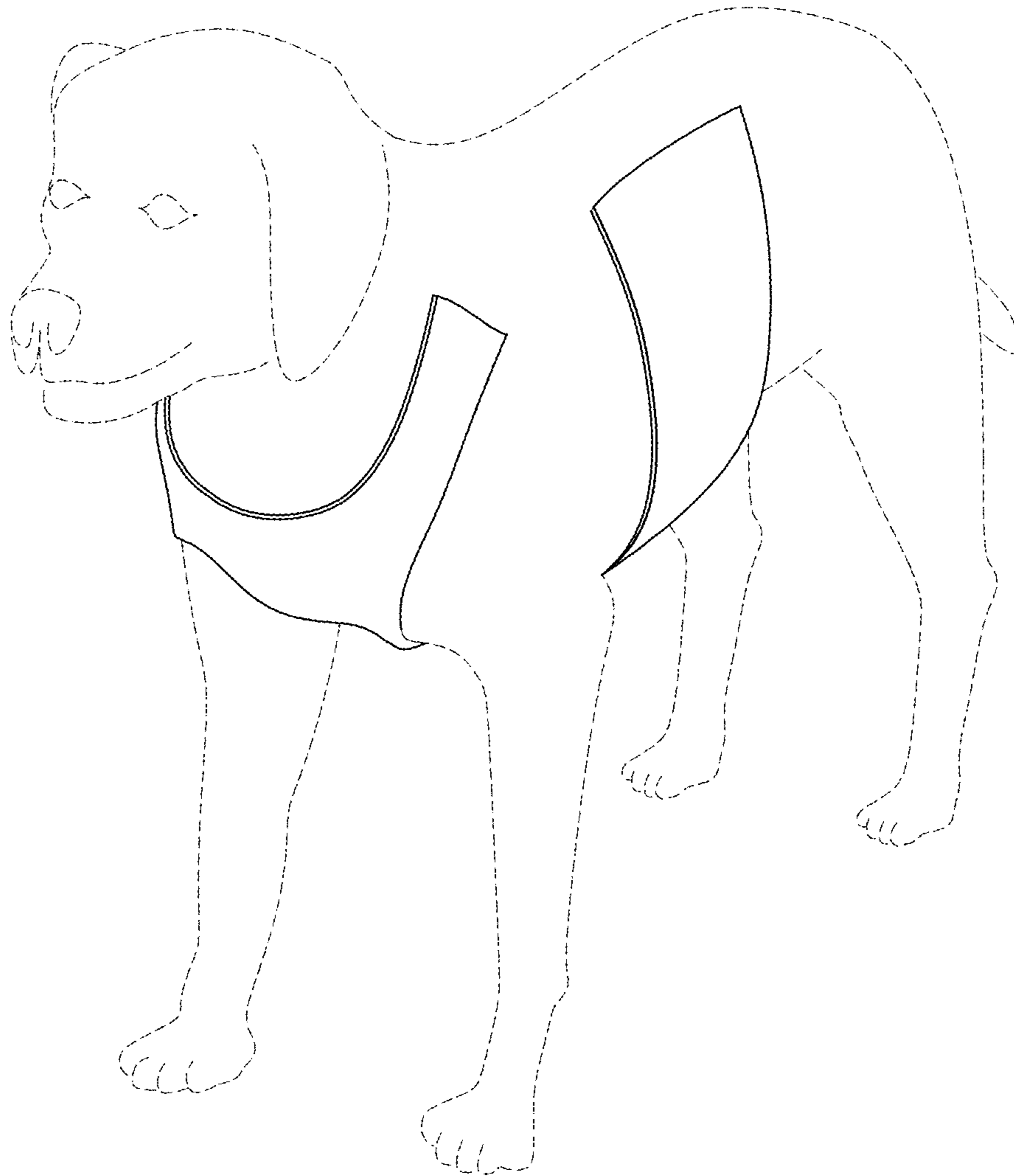

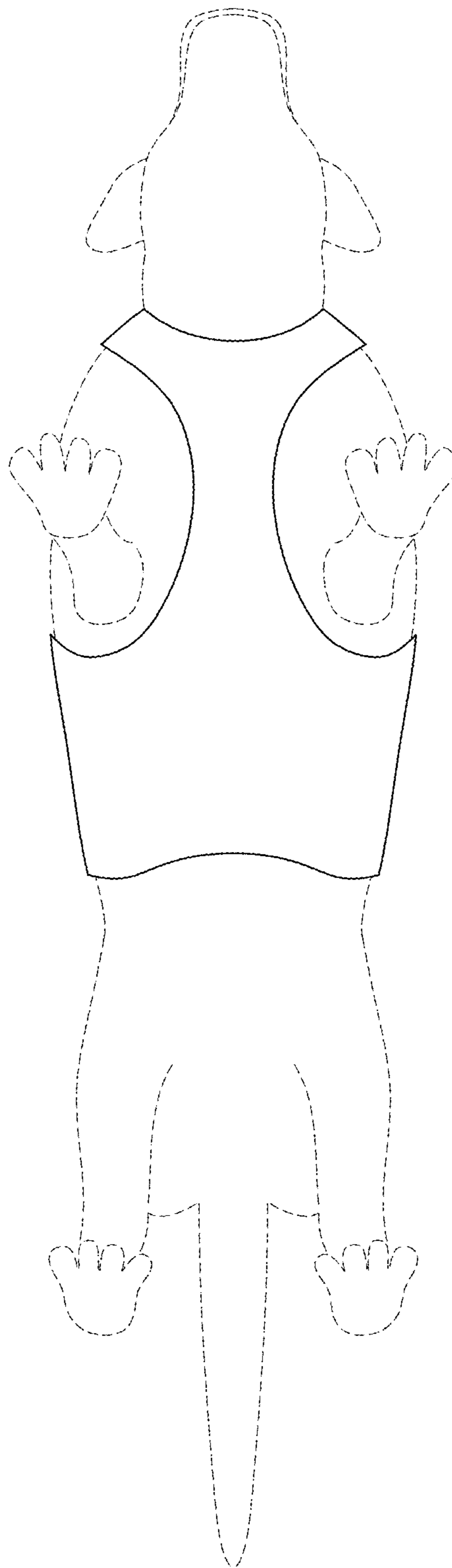

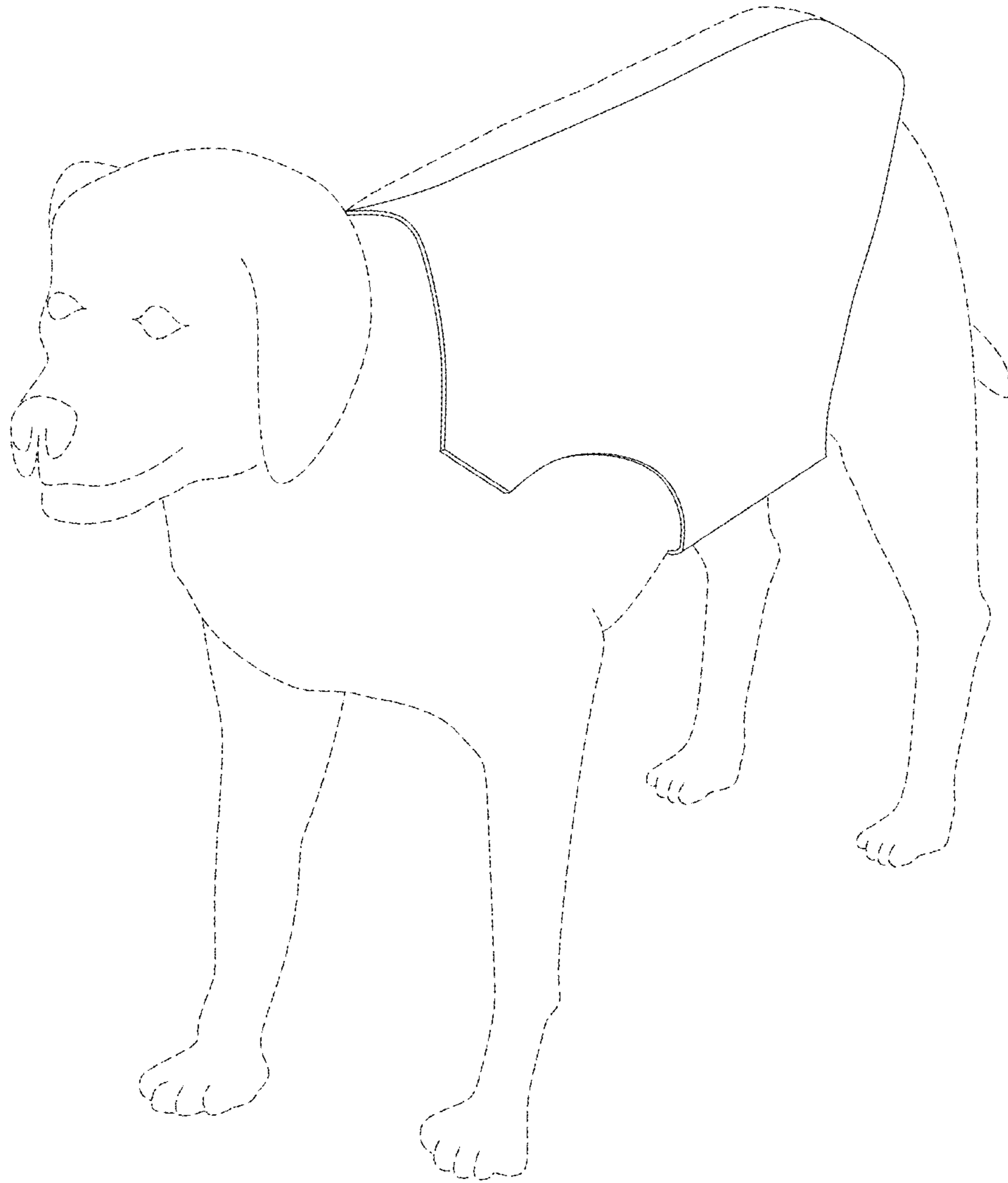

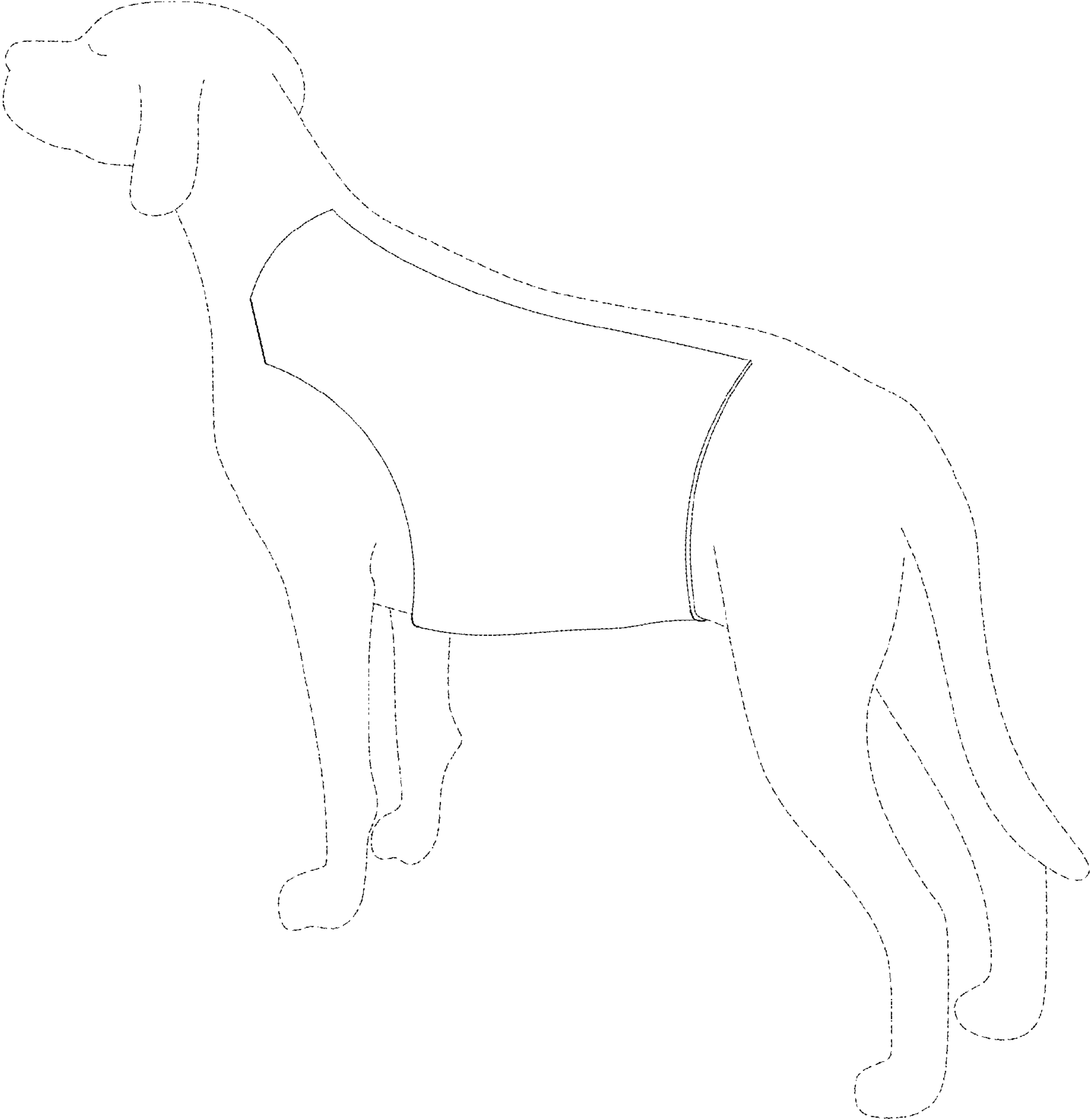

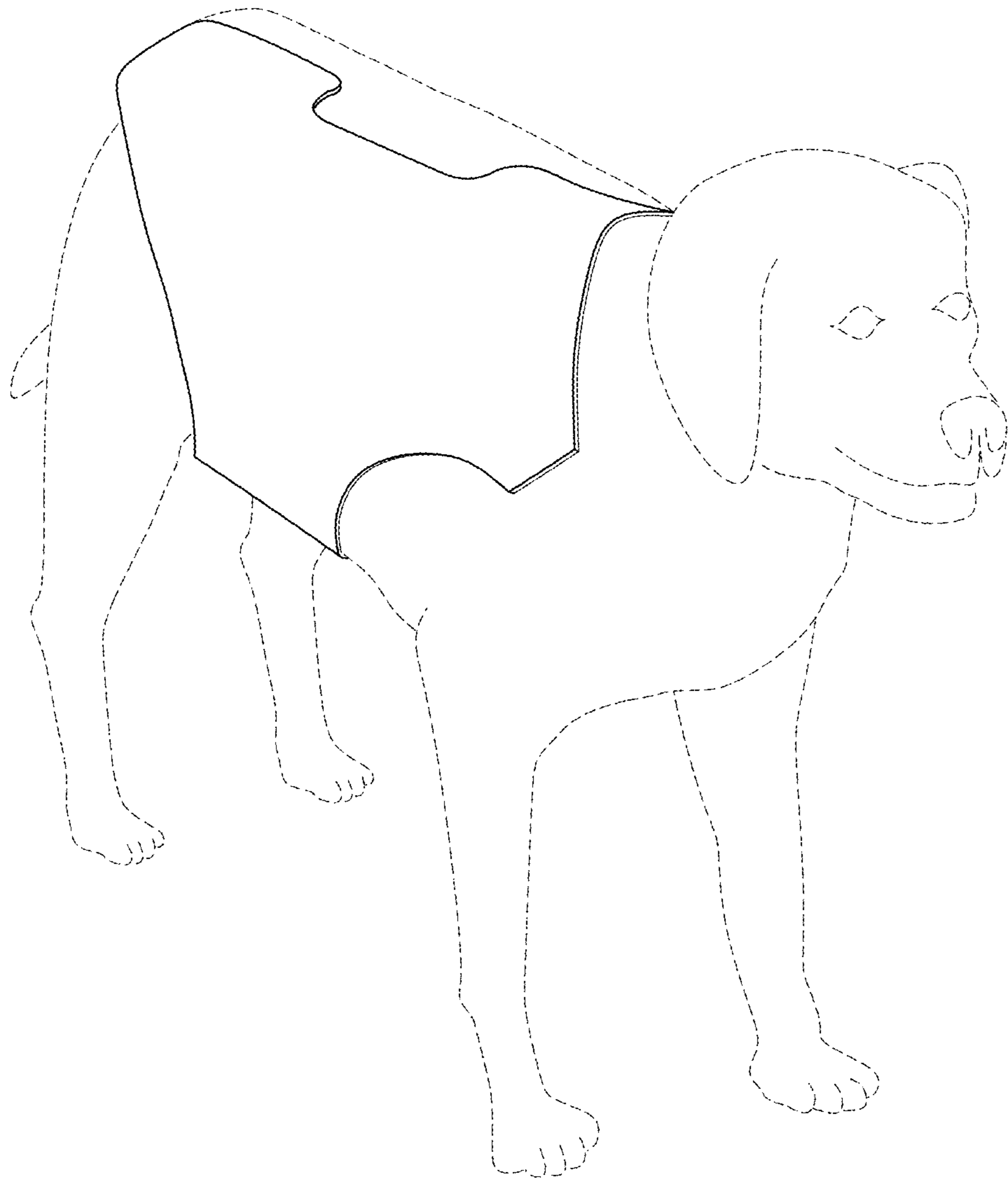

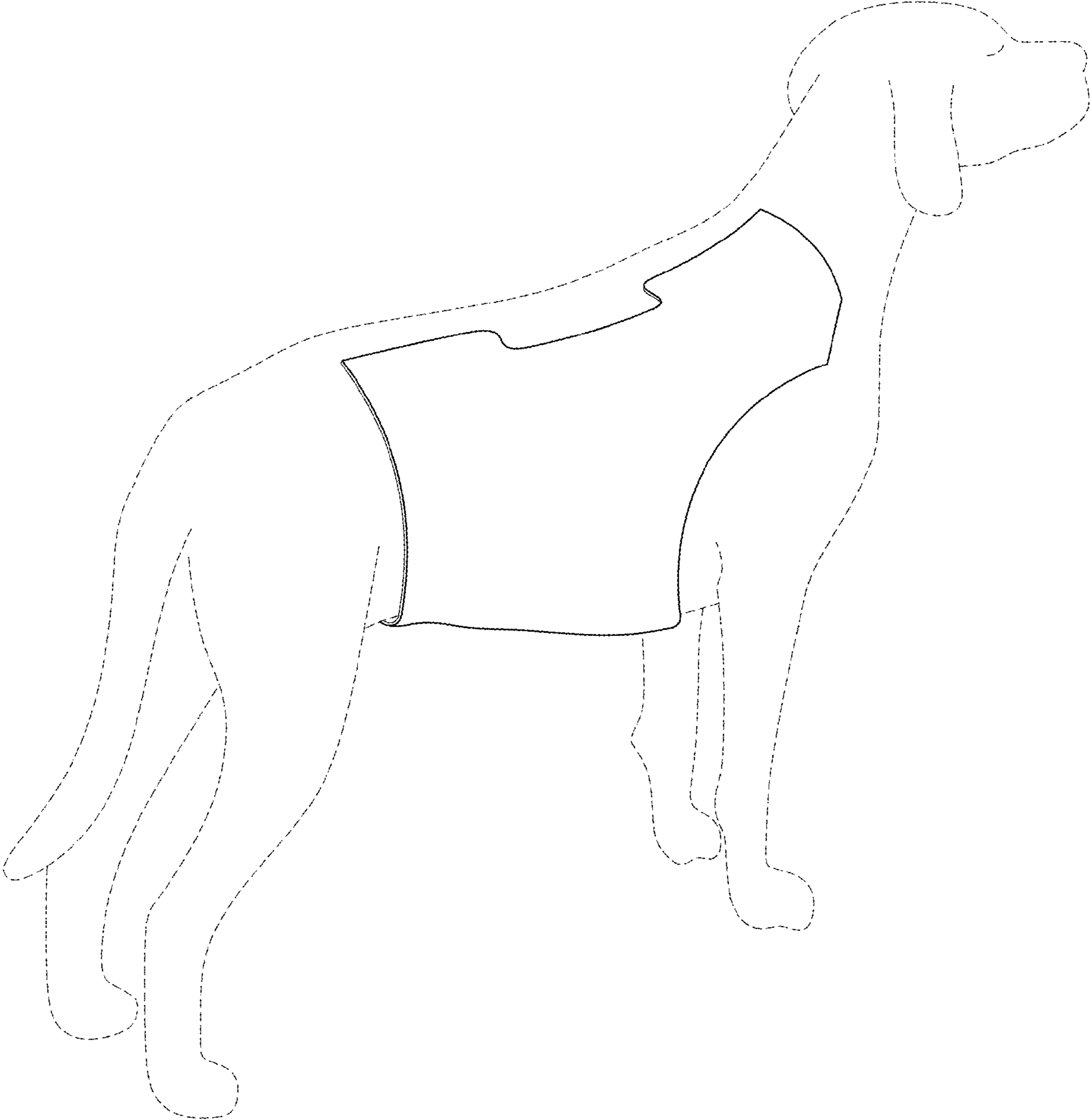

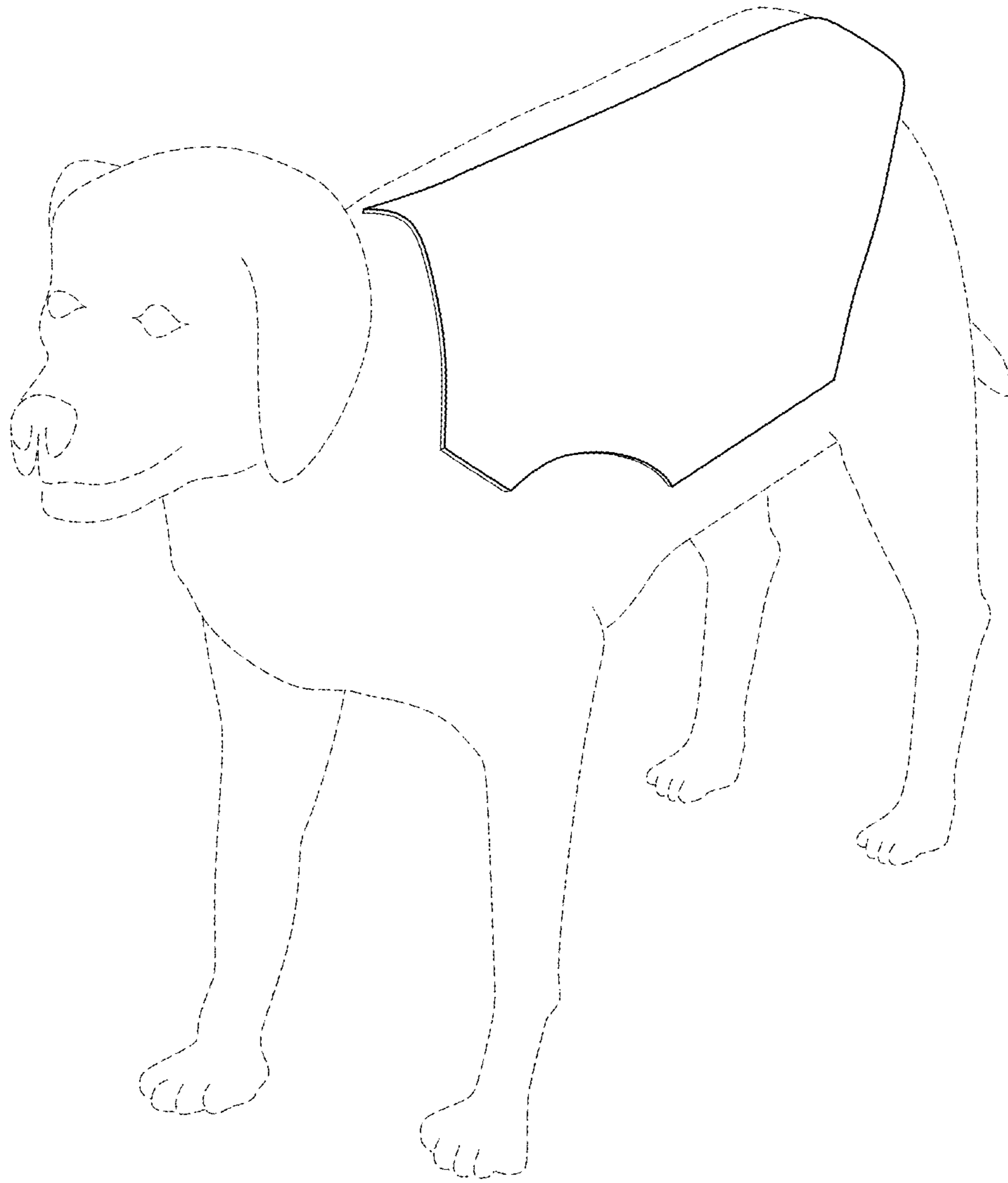

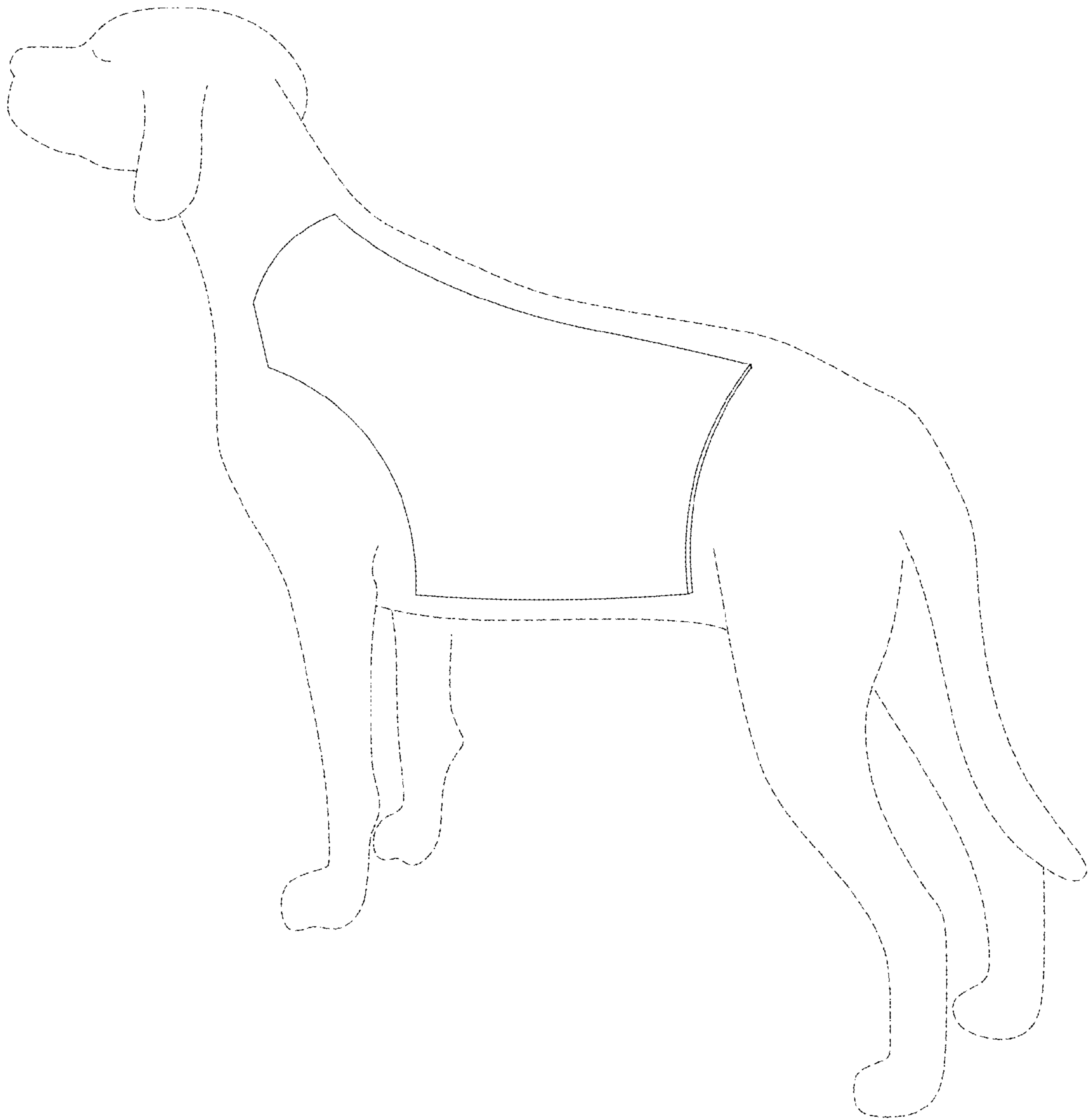

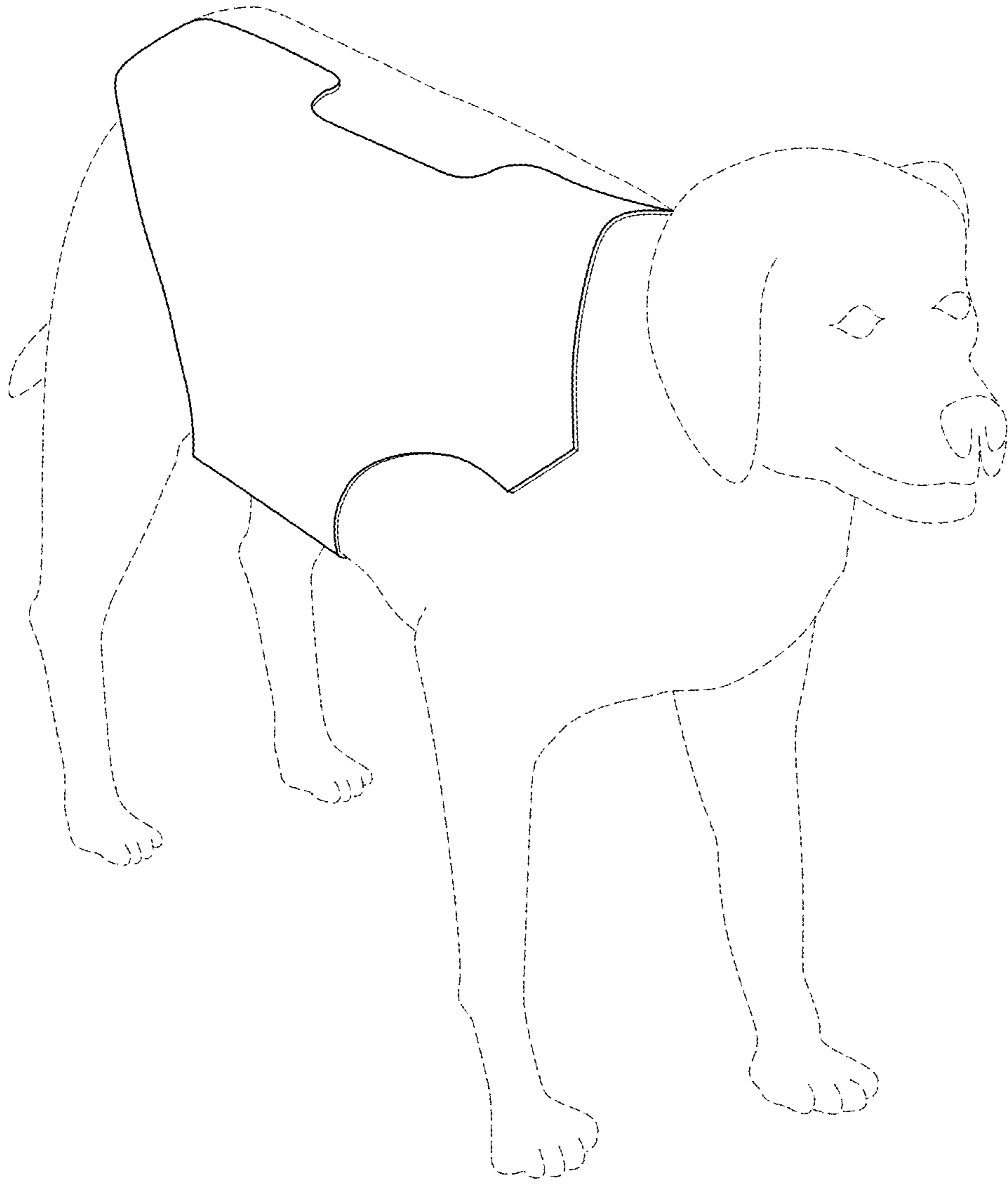

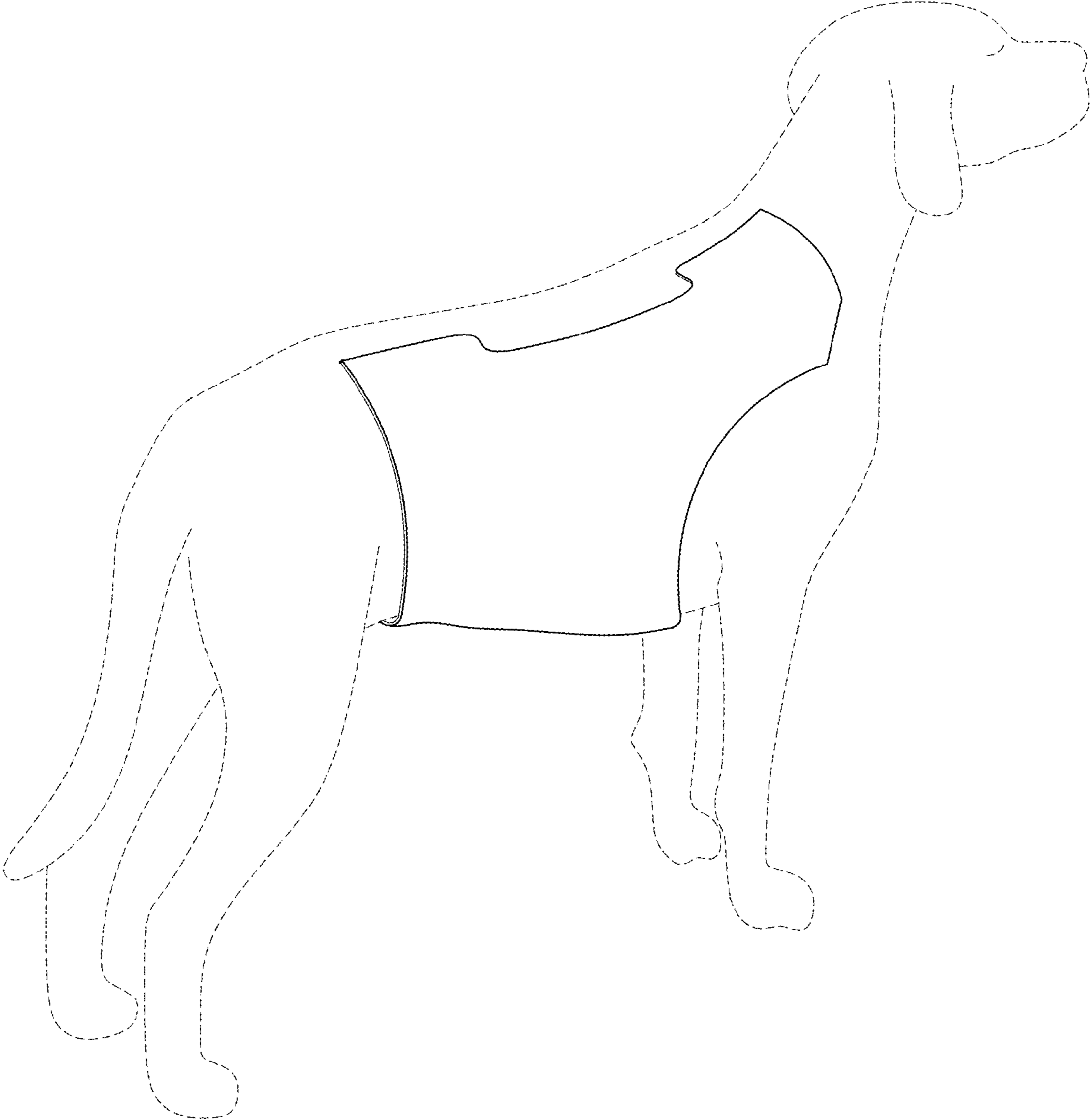
