(57) **CLAIM**

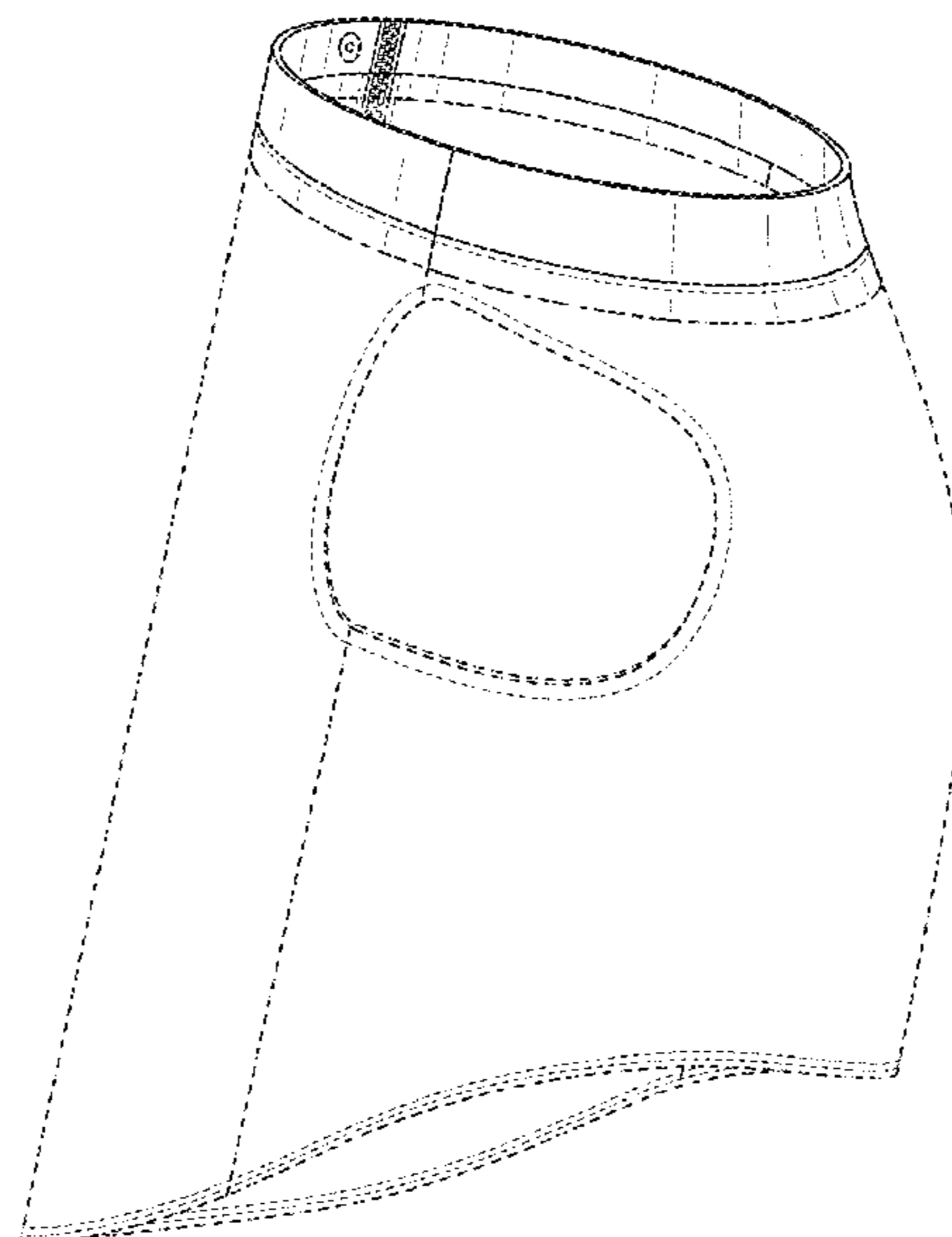
The ornamental design for a pet garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pet garment showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

The shorter, thinner, evenly spaced broken lines on the pet garment depict stitching that forms no part of the claimed design. The longer, thicker, evenly spaced broken lines depict portions of the pet garment that form no part of the claimed design. The dash-dot-dash broken lines illustrate boundaries that form no part of the claimed design.

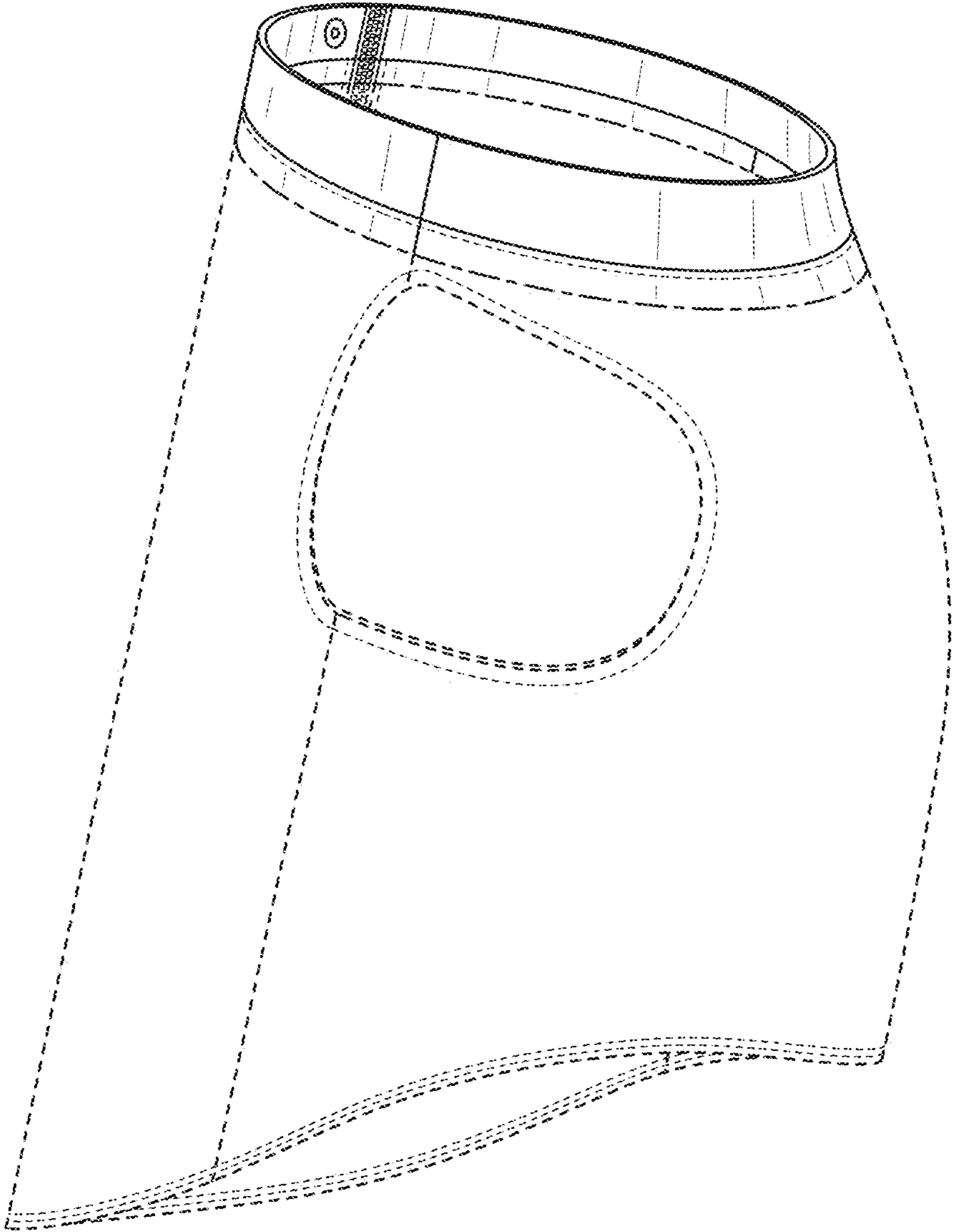

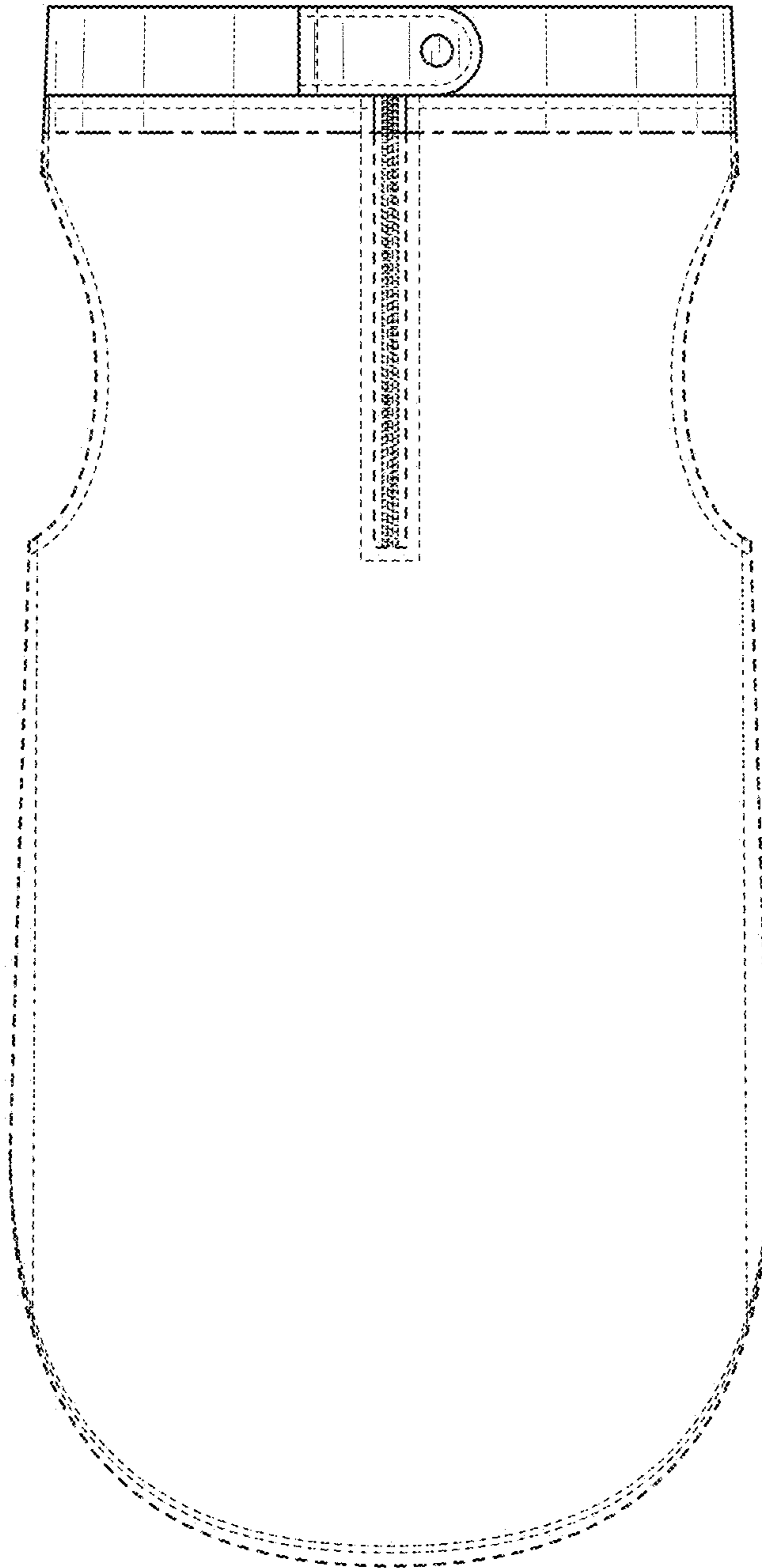

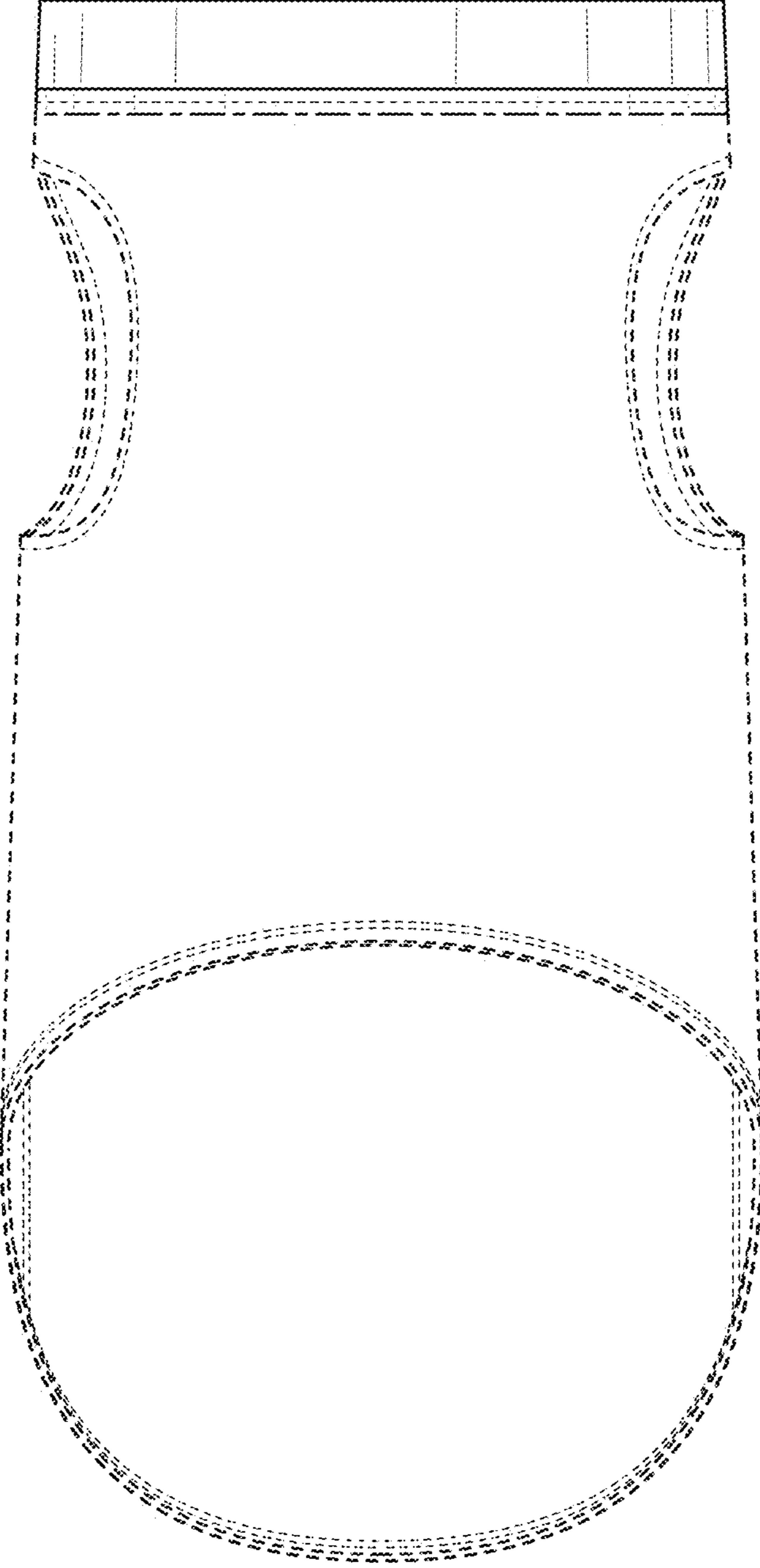

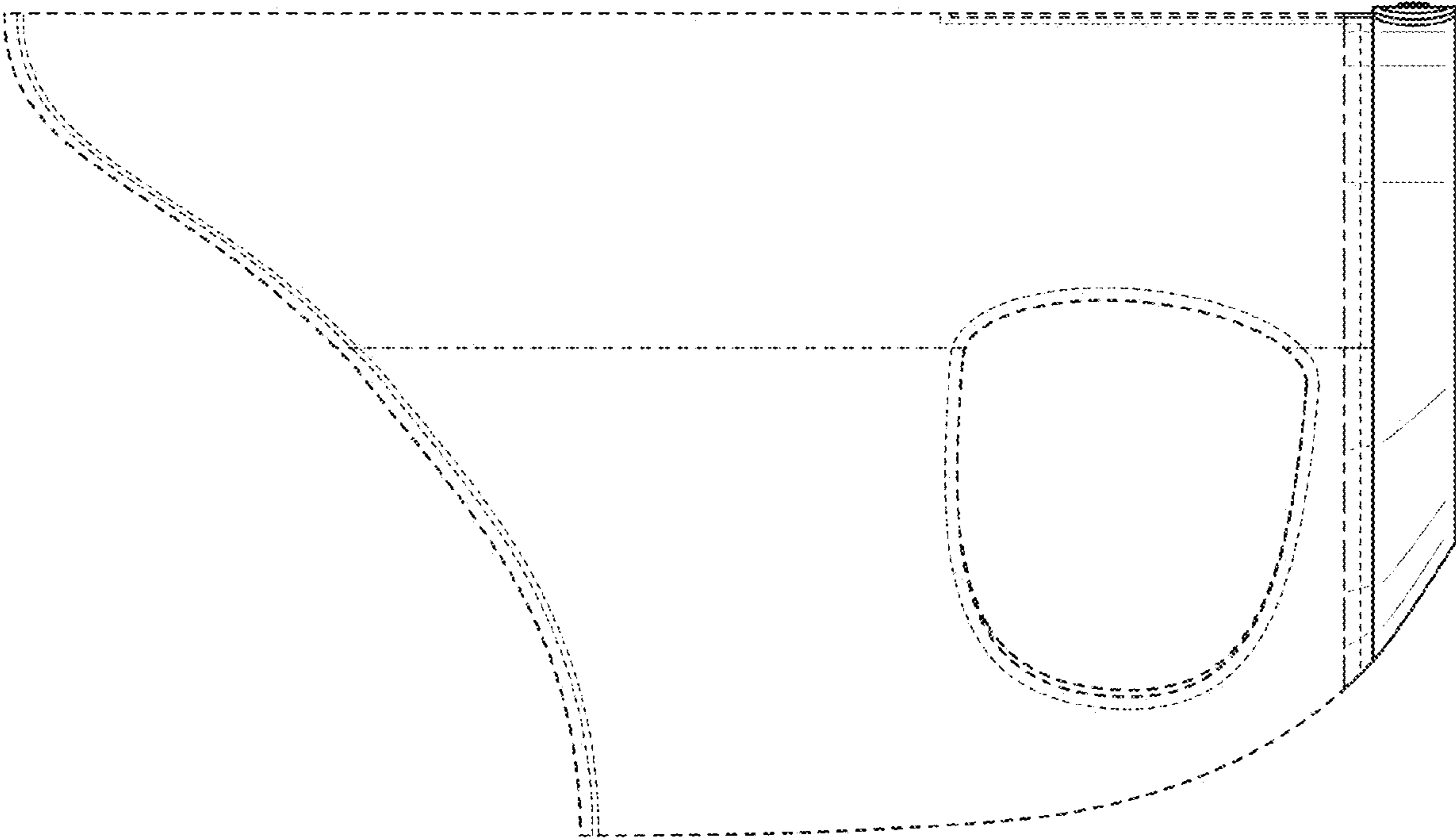

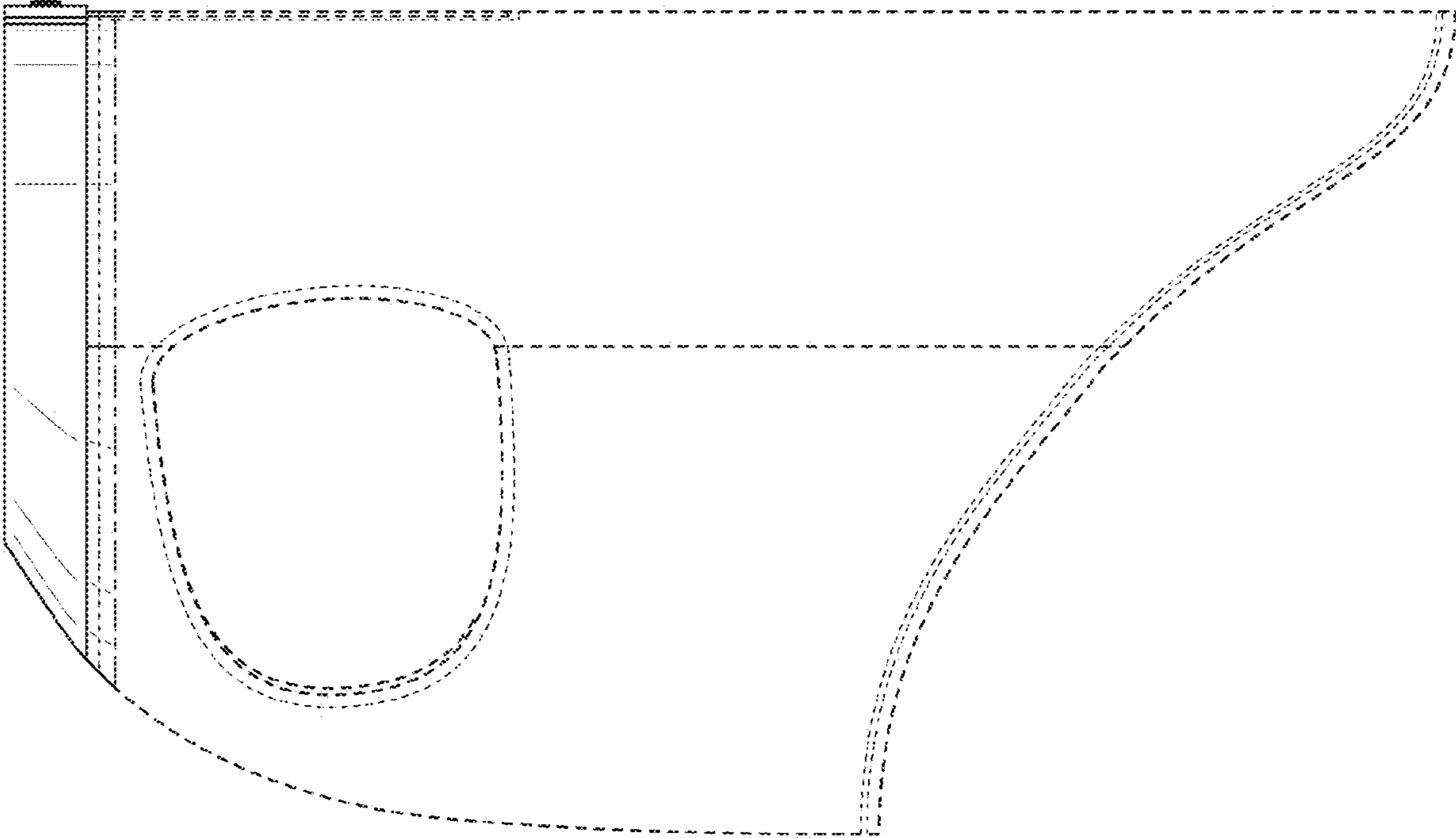

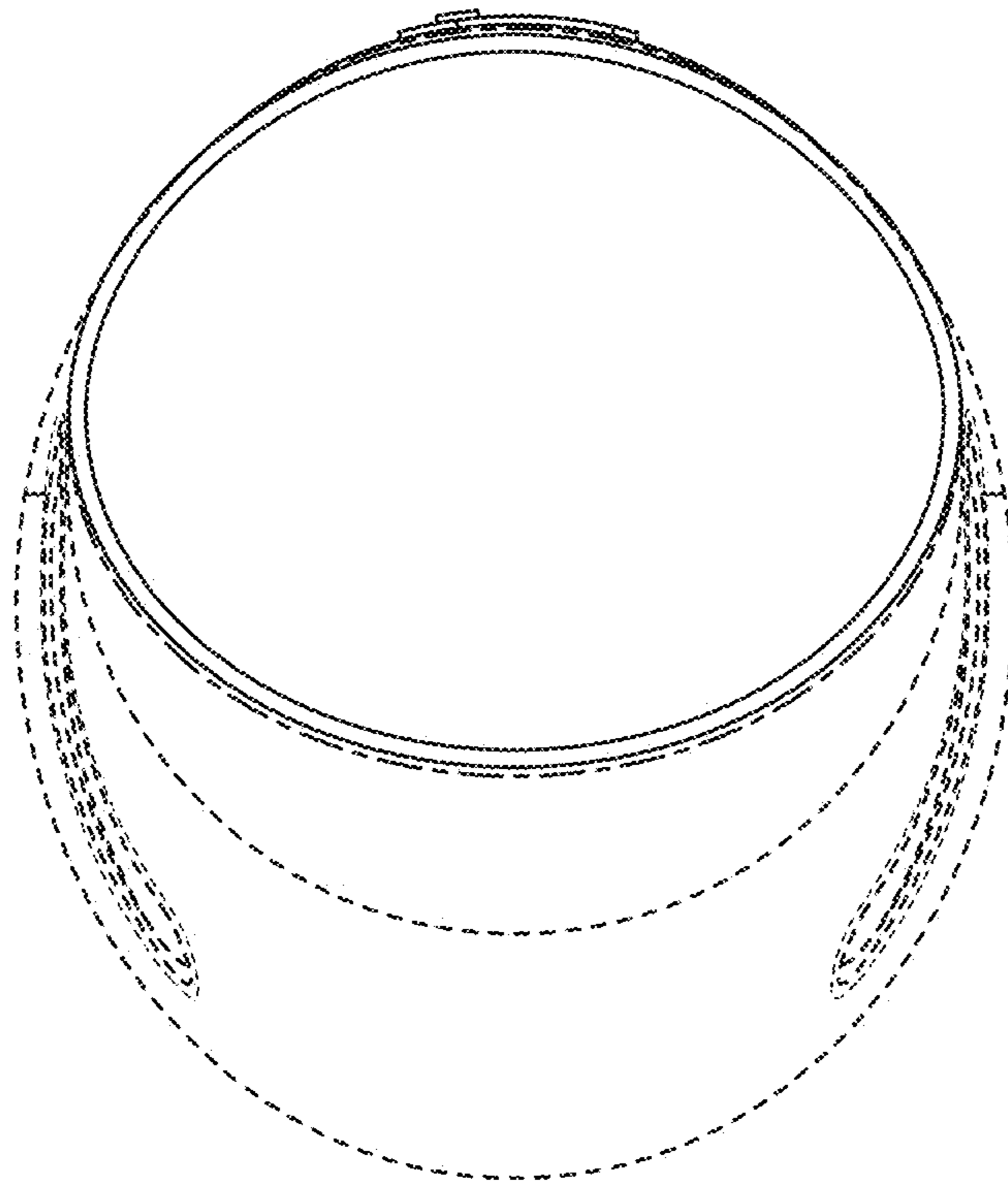

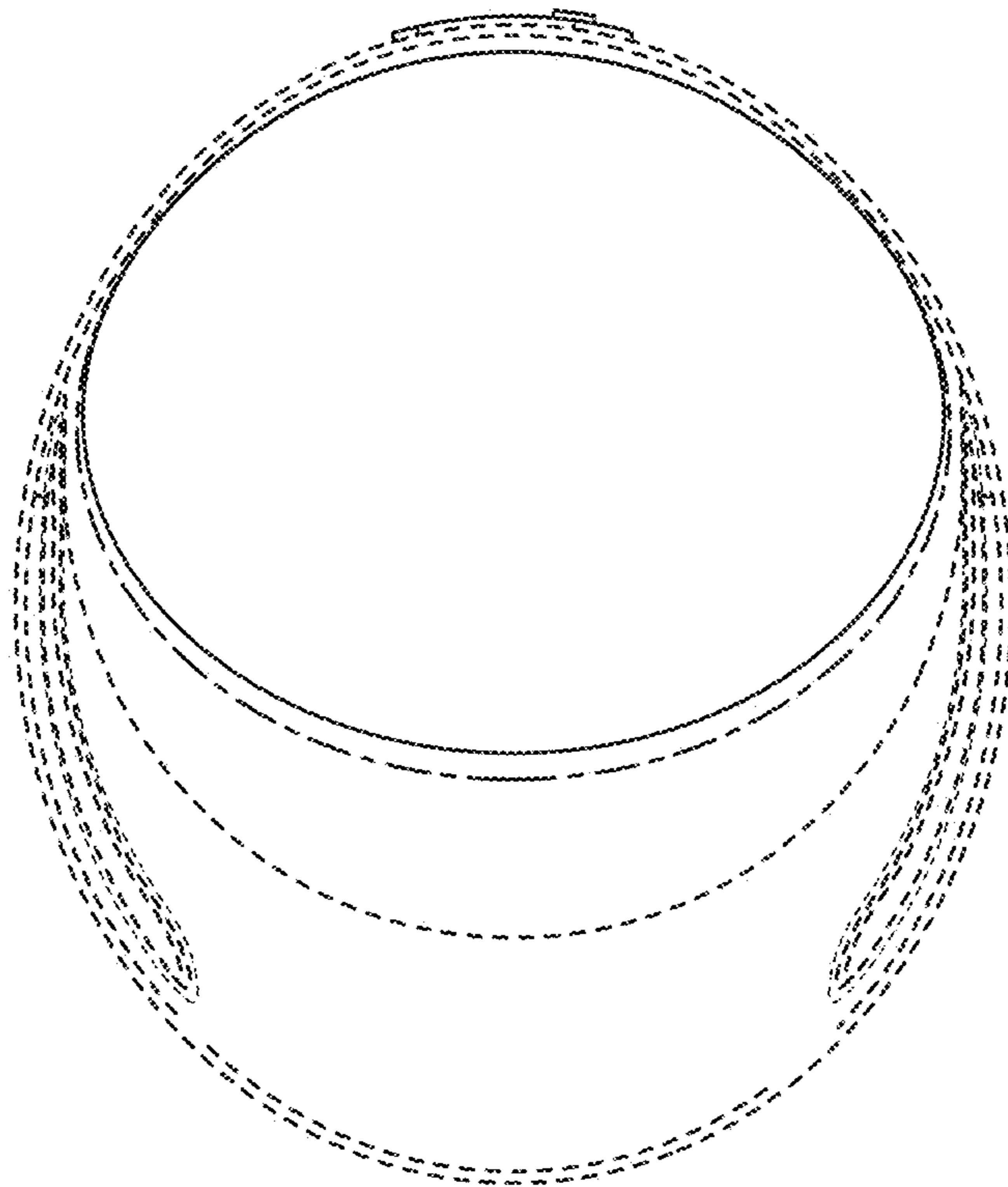
