(57) **CLAIM**

The ornamental Design for an undergarment with integrated liner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an undergarment with integrated liner of the present design;

FIG. 2 is a front view of the undergarment with integrated liner of FIG. 1;

FIG. 3 is a rear view of the undergarment with integrated liner of FIG. 1;

FIG. 4 is a right side view of the undergarment with integrated liner of FIG. 1;

FIG. 5 is a left side view of the undergarment with integrated liner of FIG. 1;

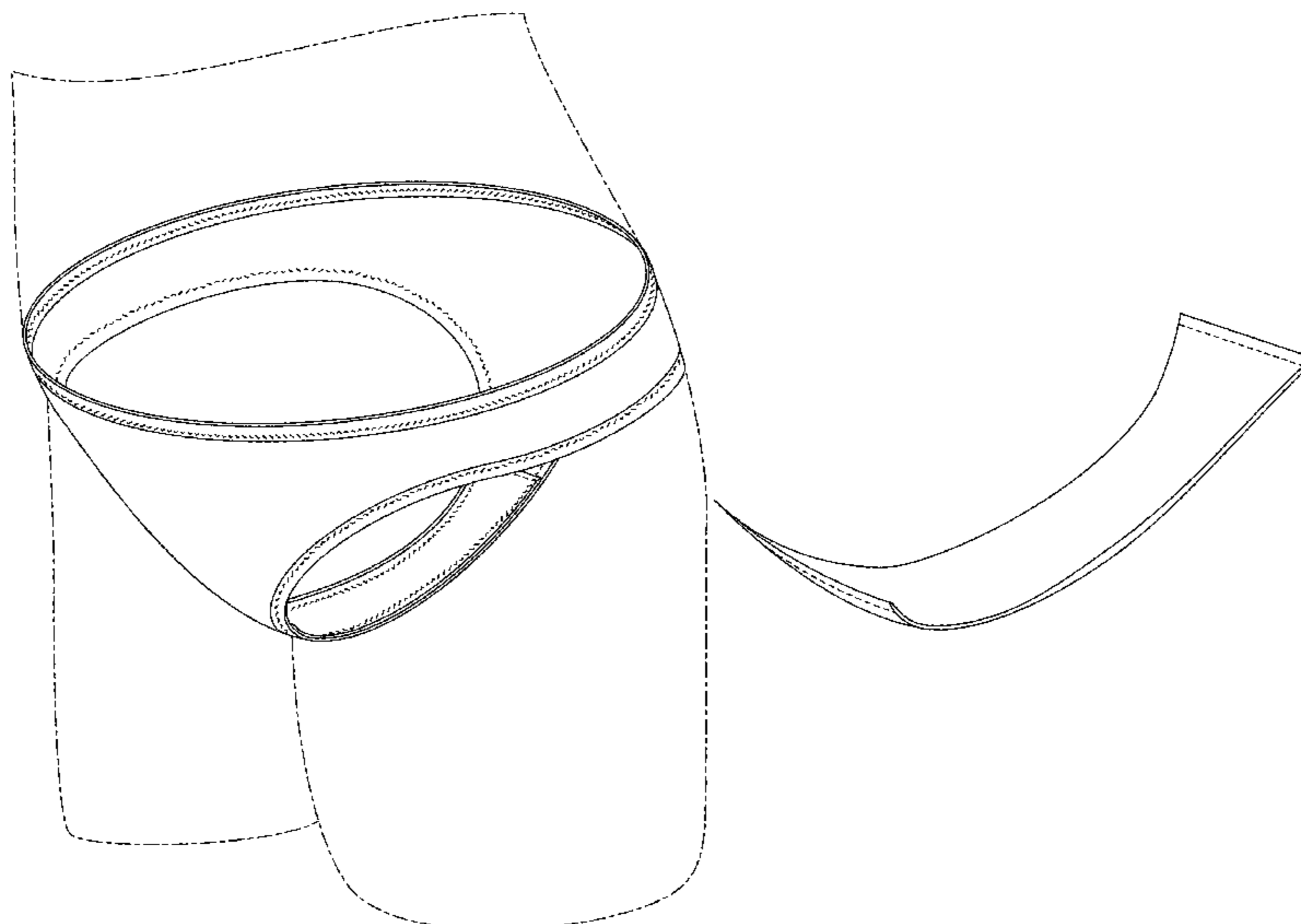
FIG. 6 is a top view of the undergarment with integrated liner of FIG. 1;

FIG. 7 is a bottom view of the undergarment with integrated liner of FIG. 1; and,

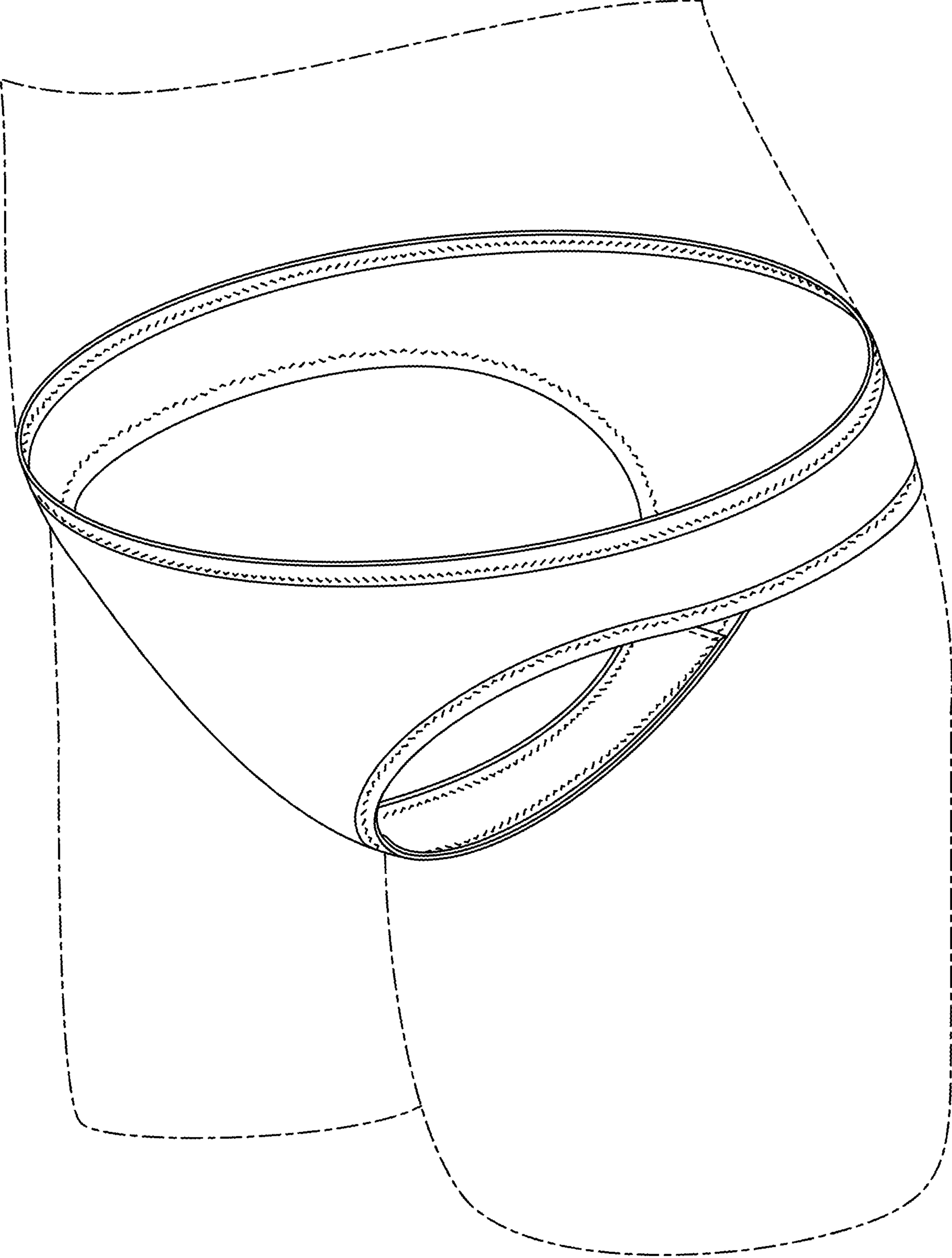

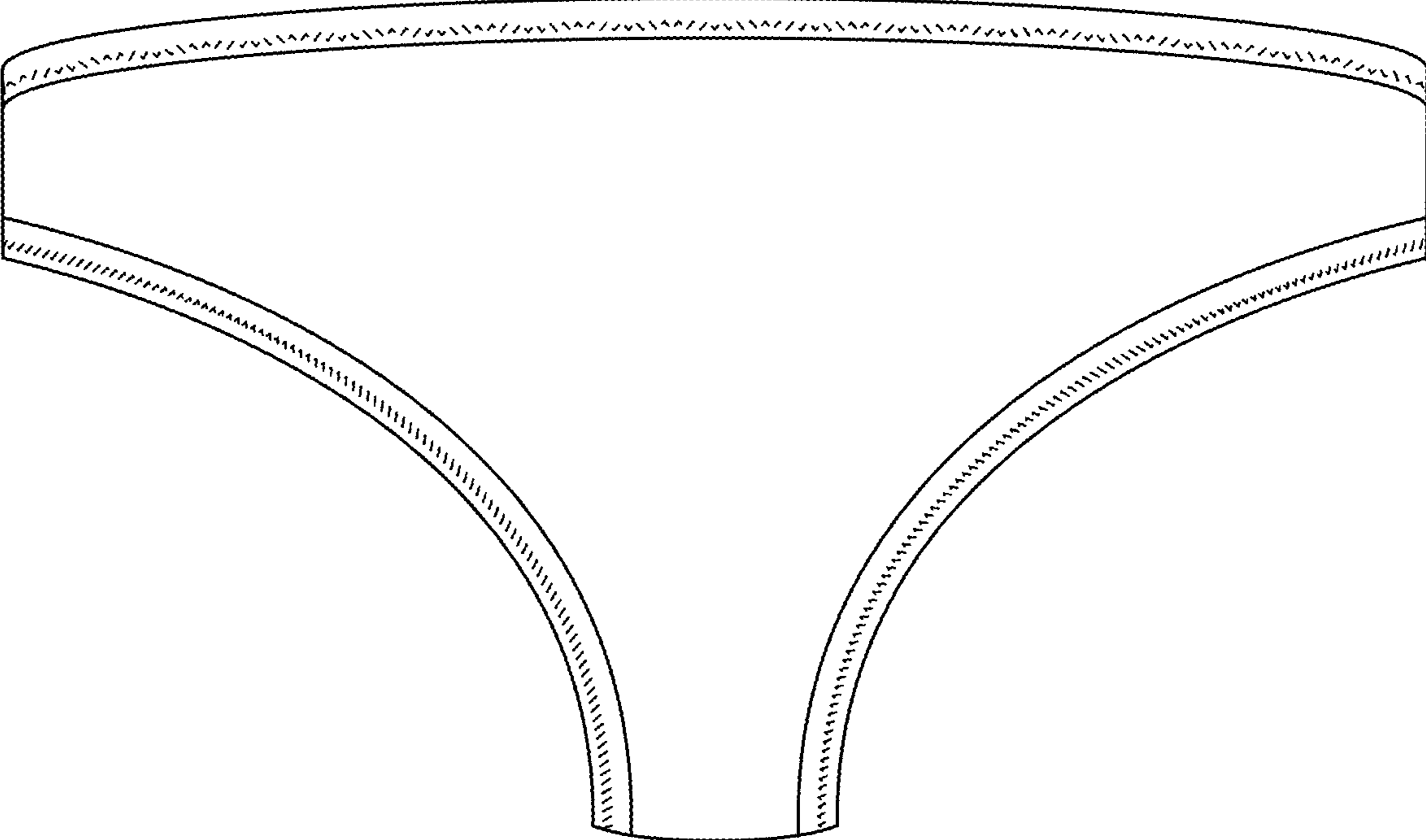

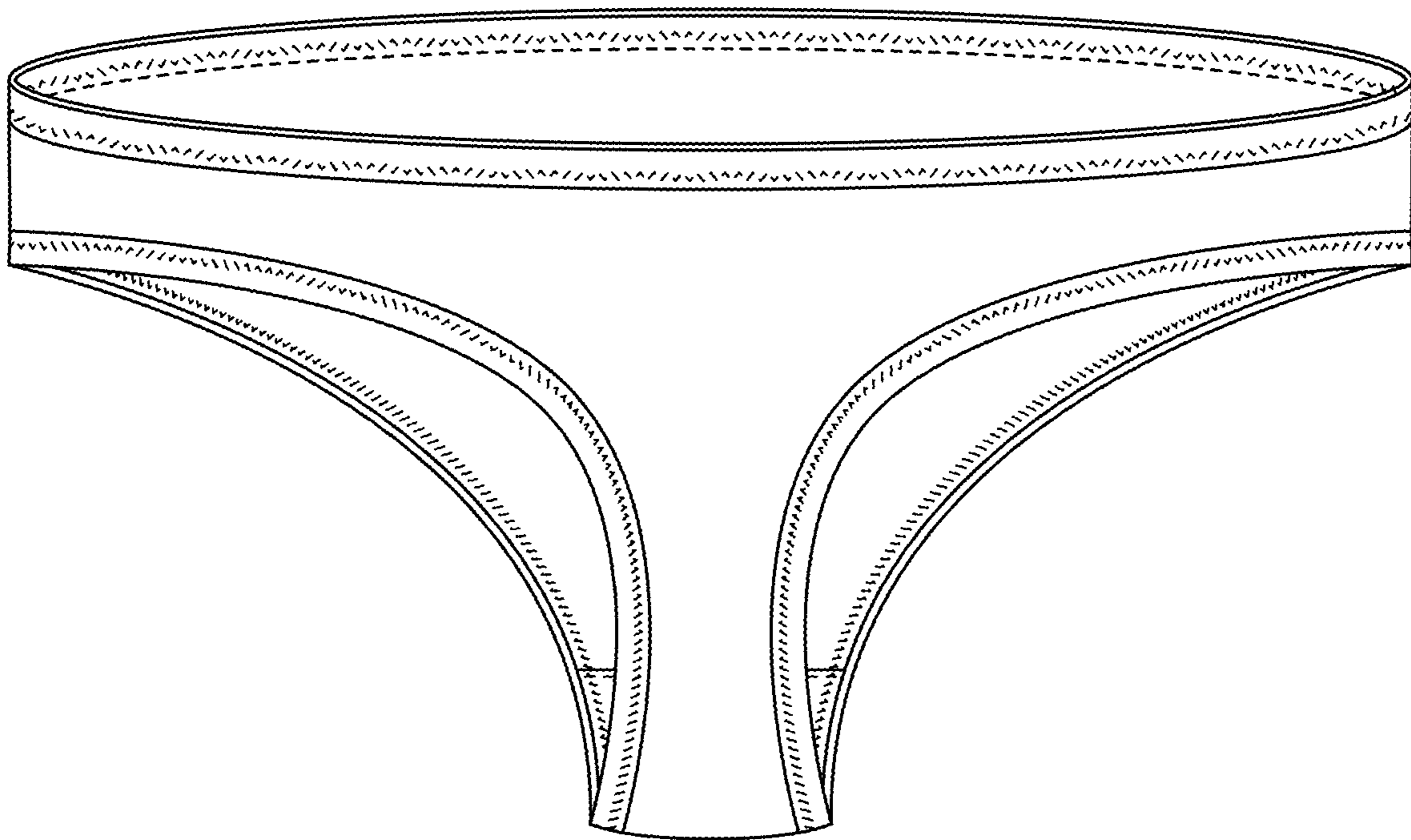

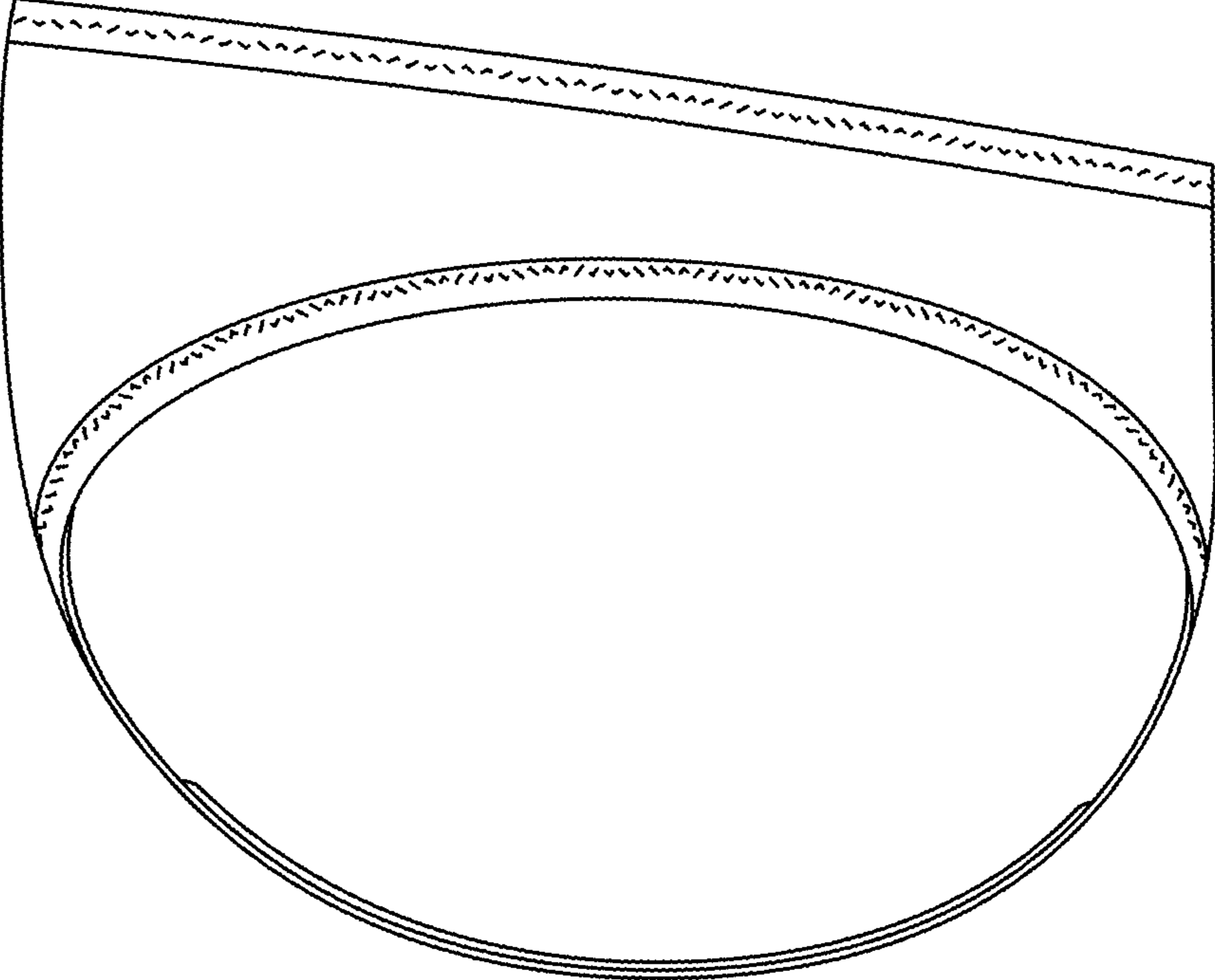

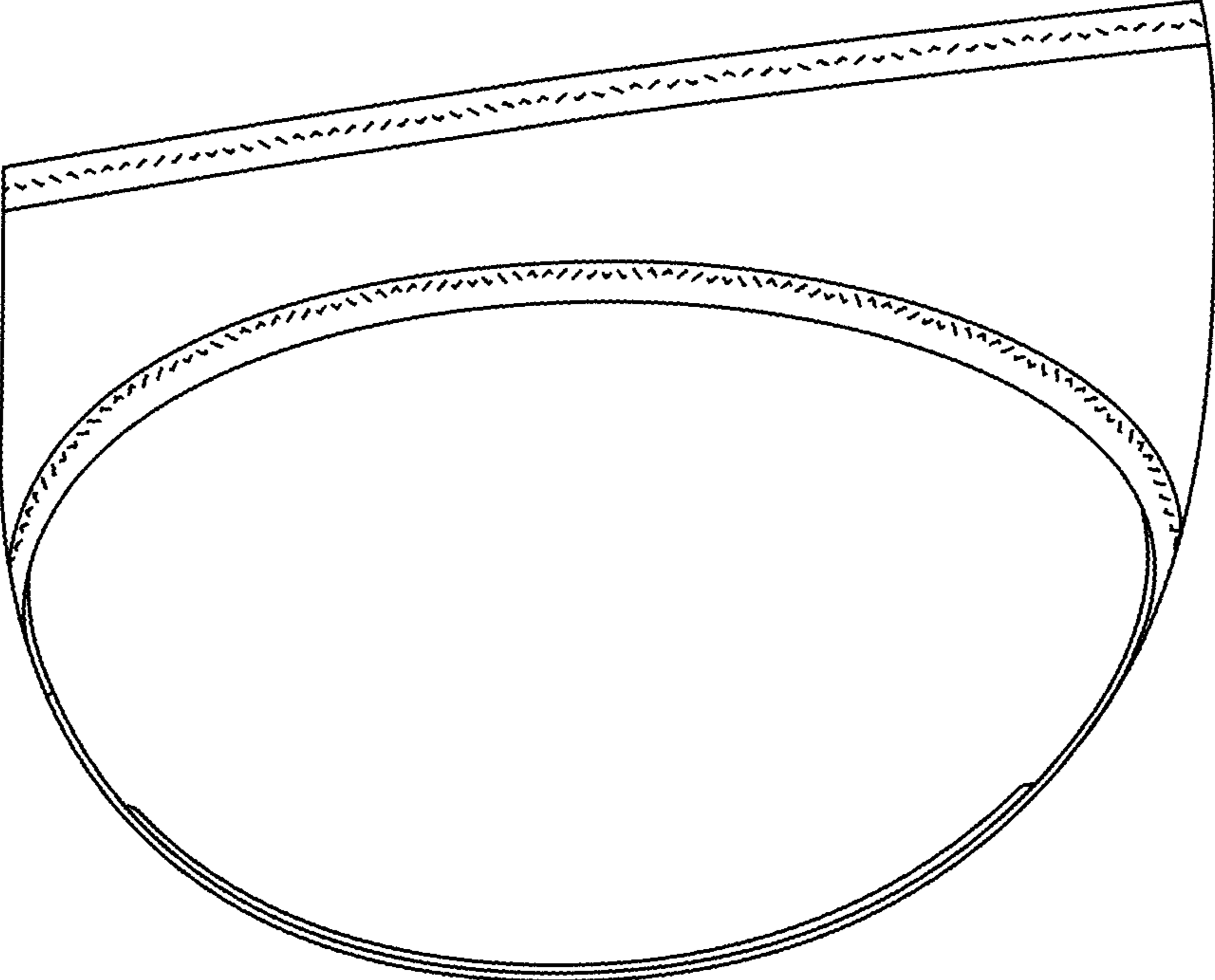

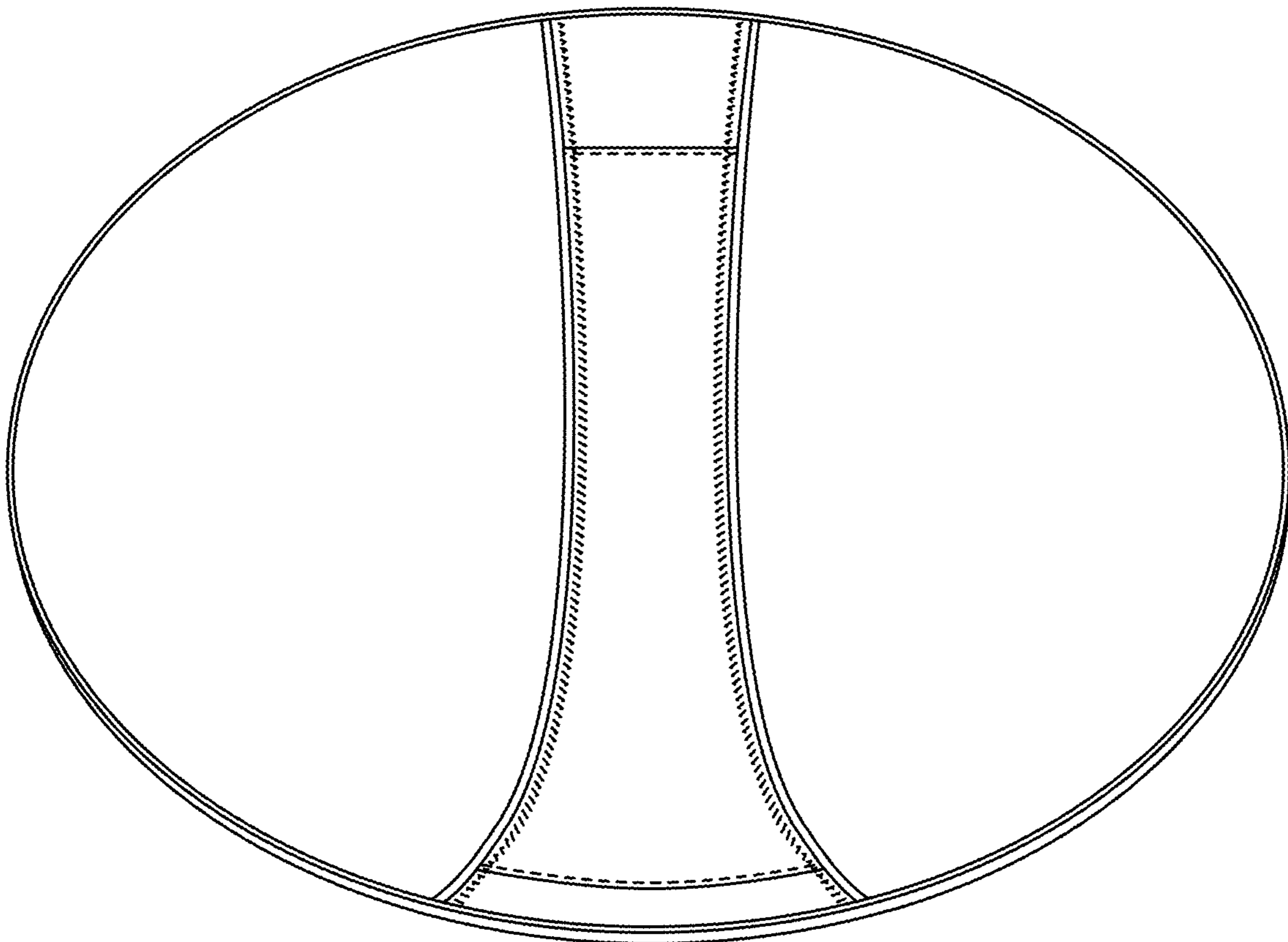

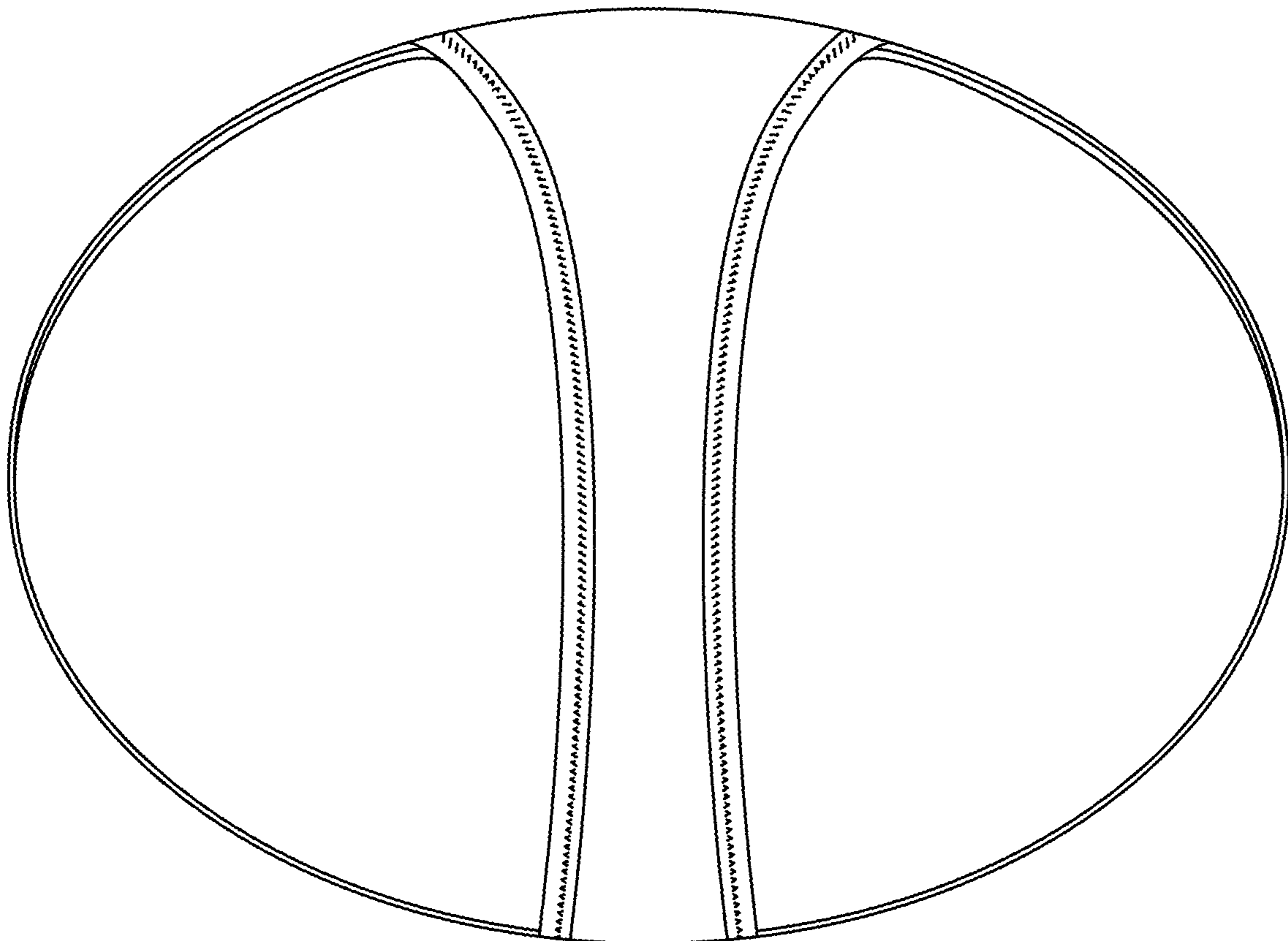

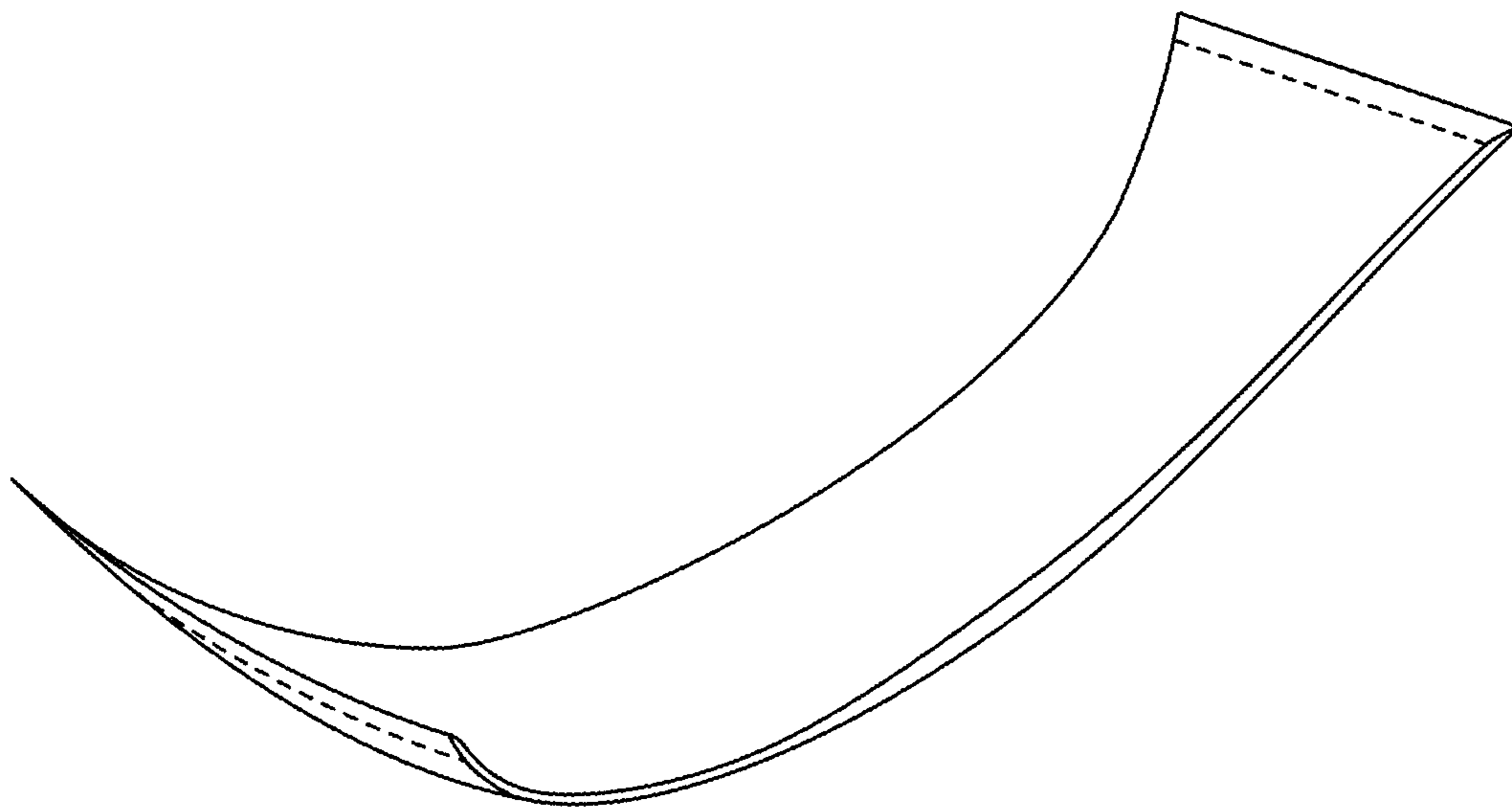
