DESCRIPTION

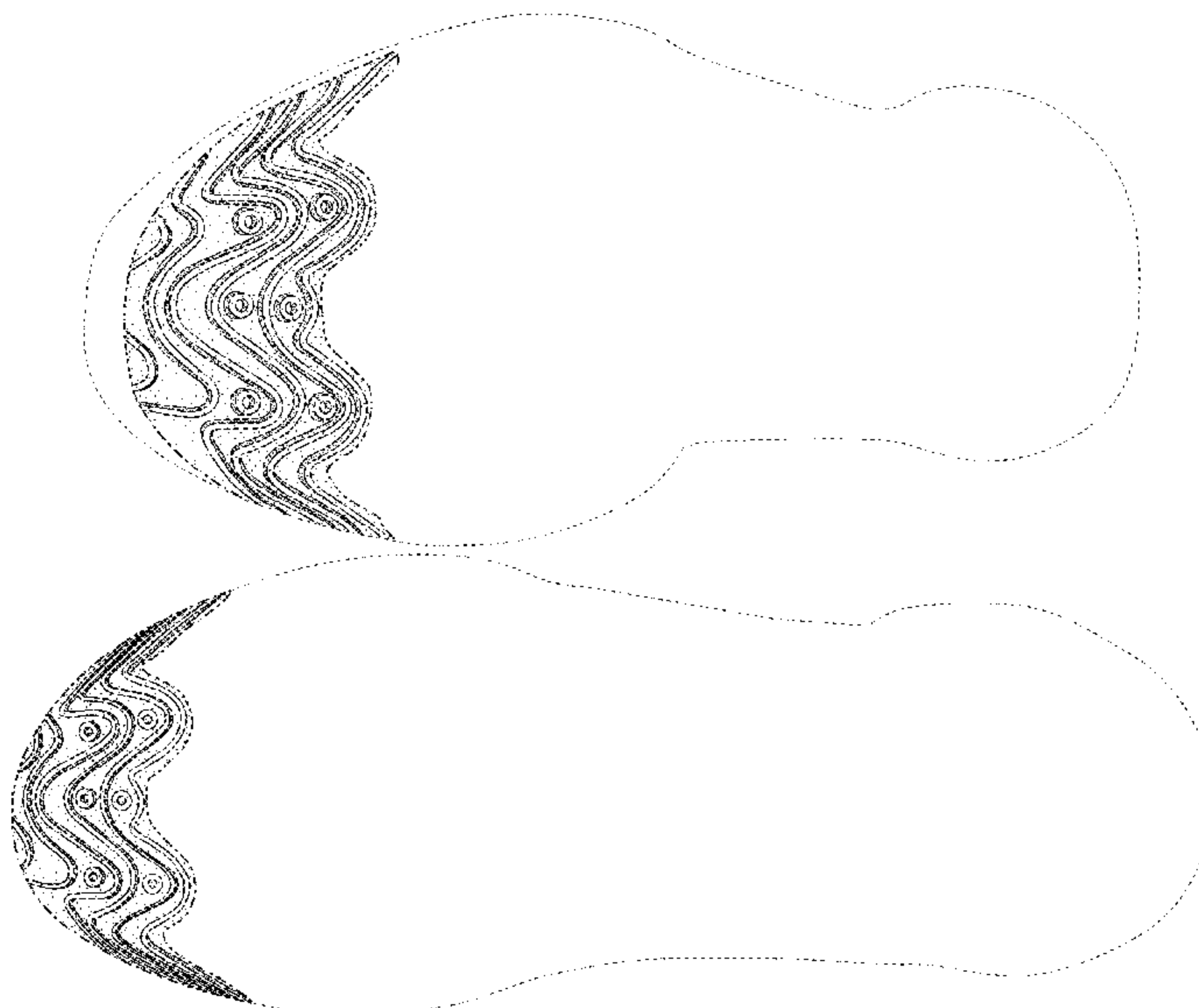
FIG. 1 is a front, bottom perspective view of a shoe, showing our new design;

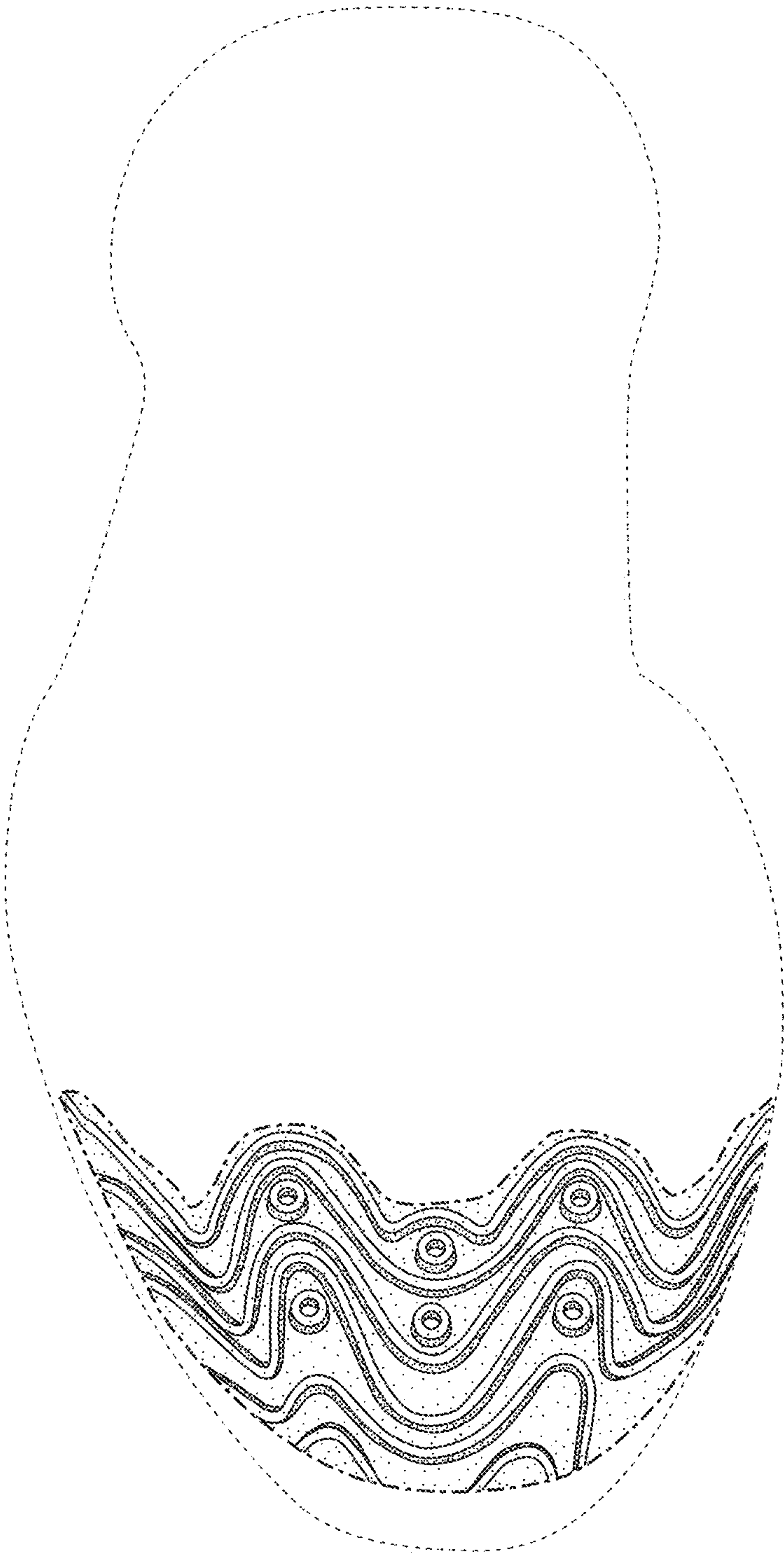

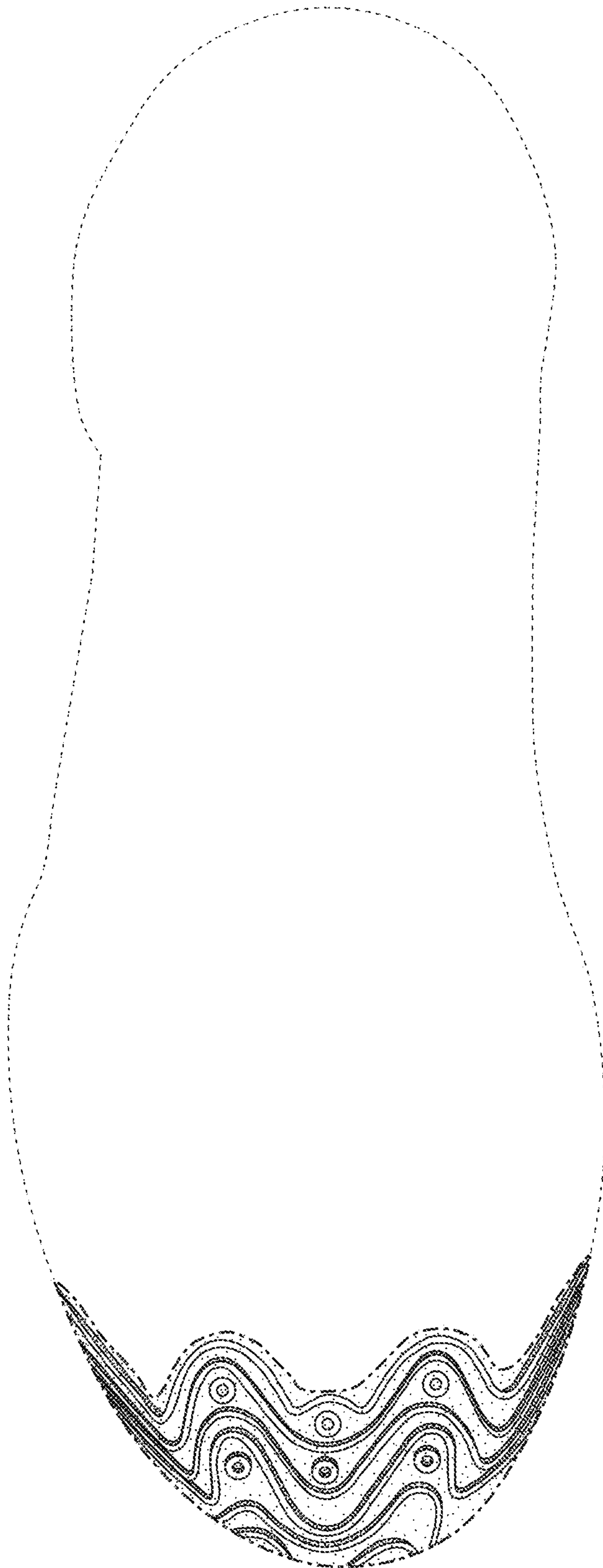

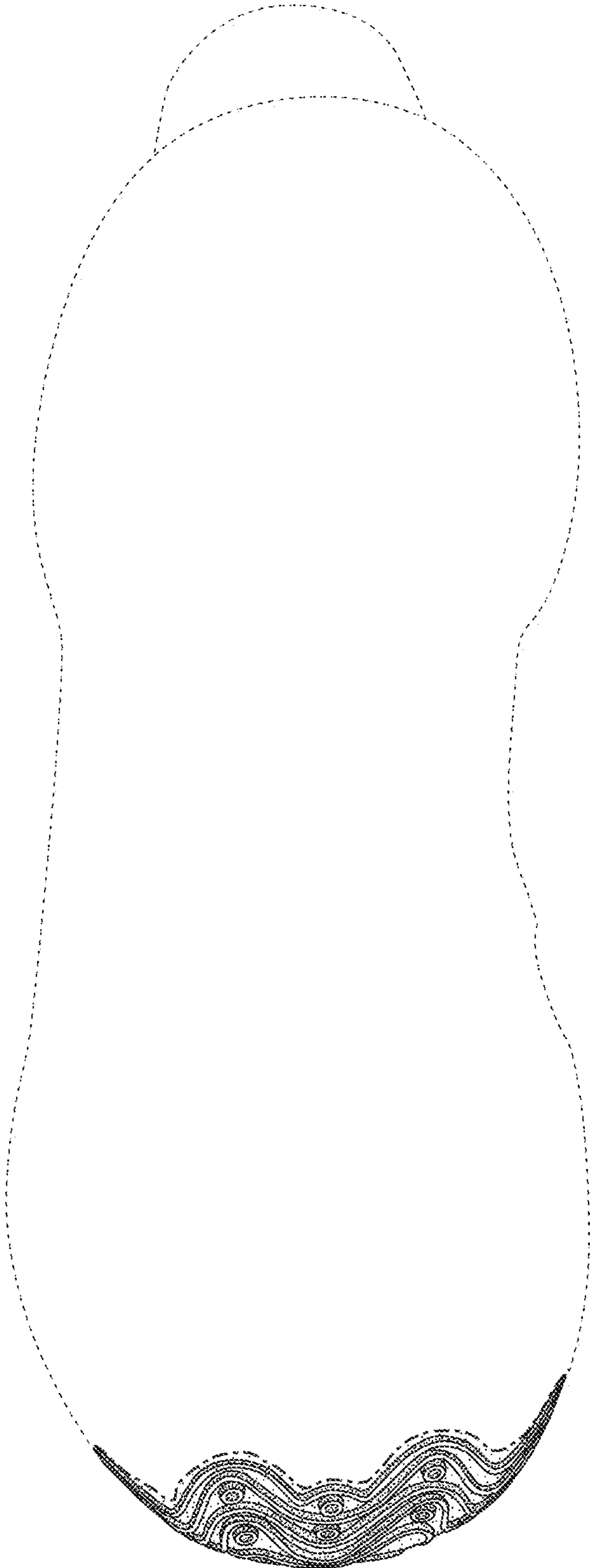

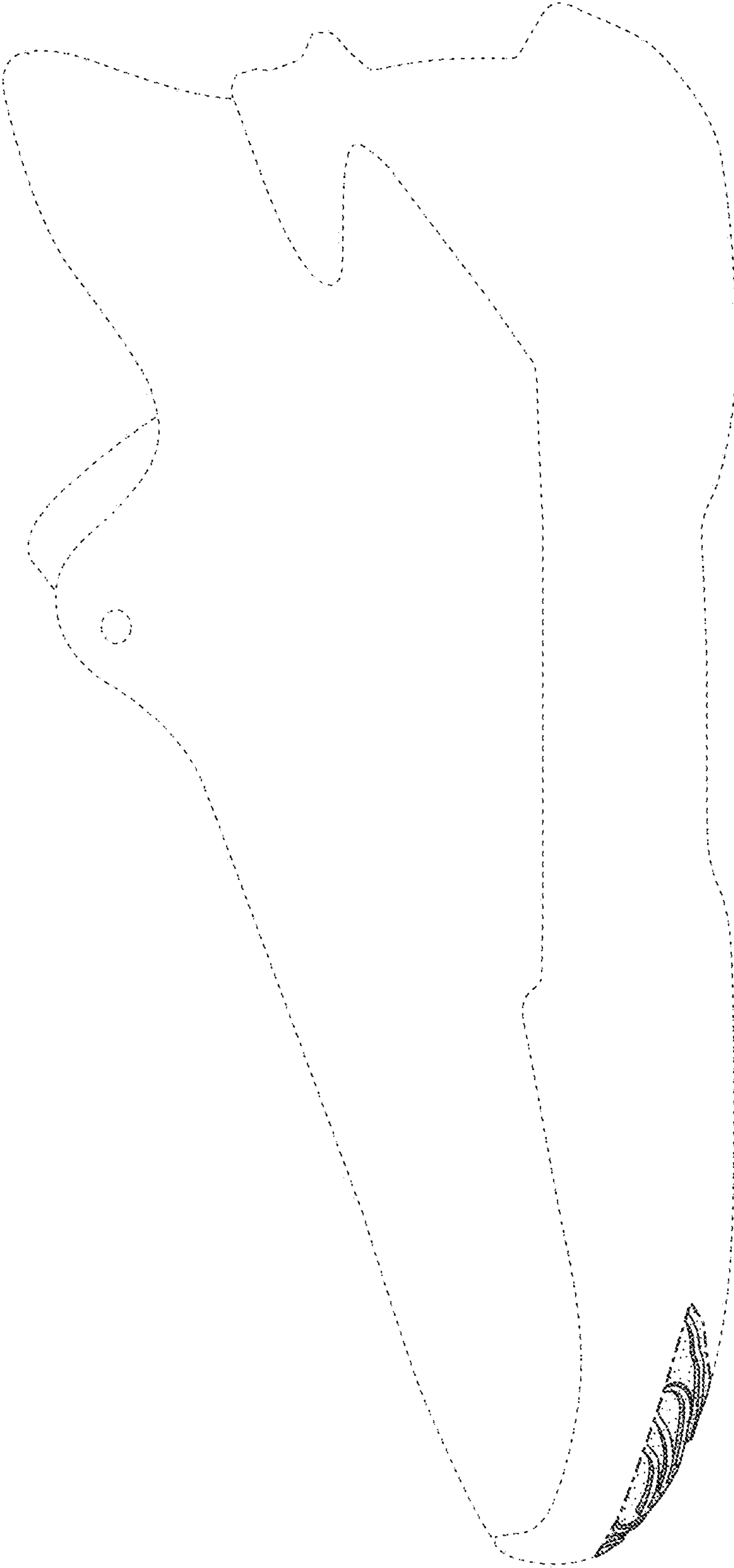

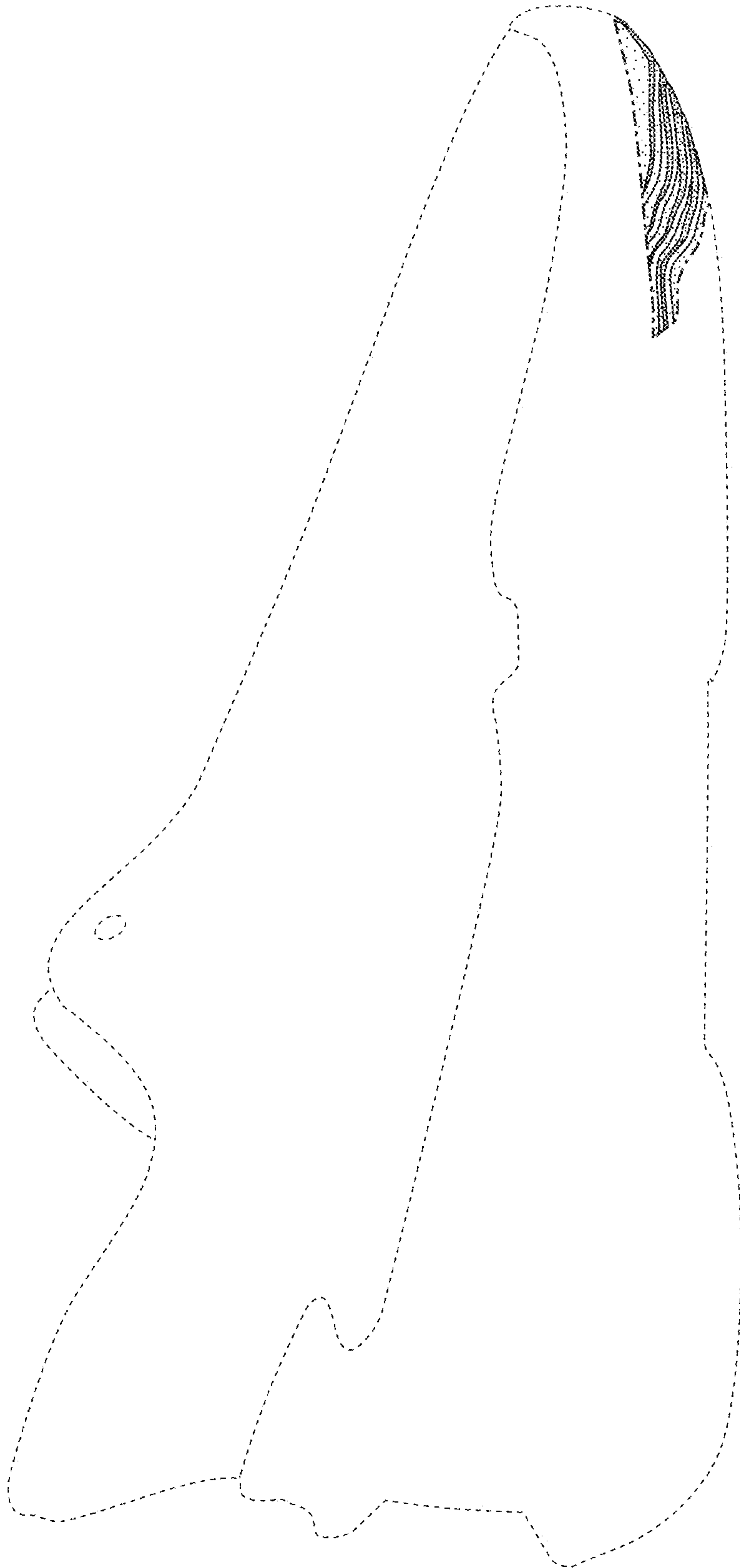

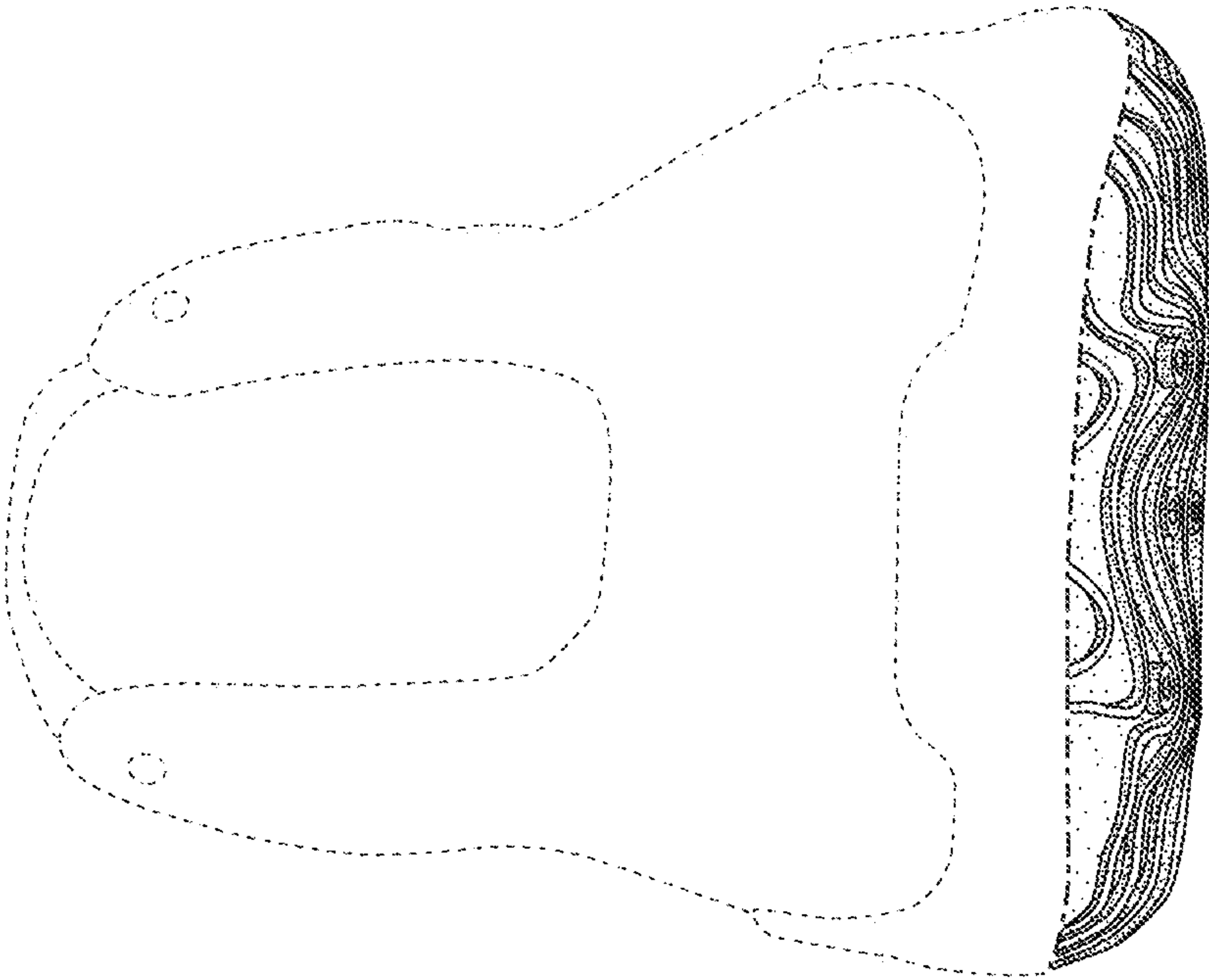
