**DESCRIPTION**

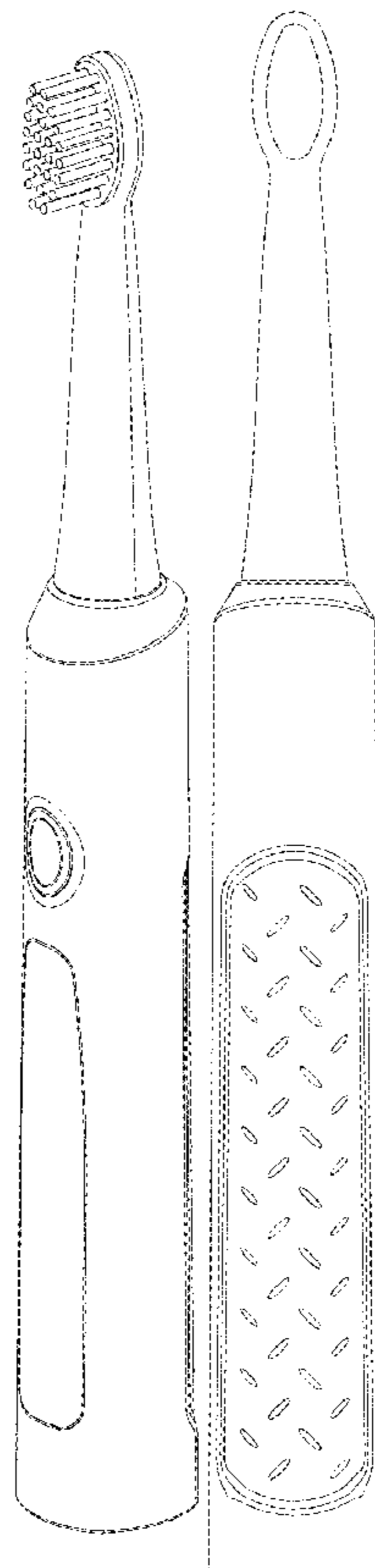
FIG. 1 is a front and right side perspective view of an electric toothbrush showing my new design;

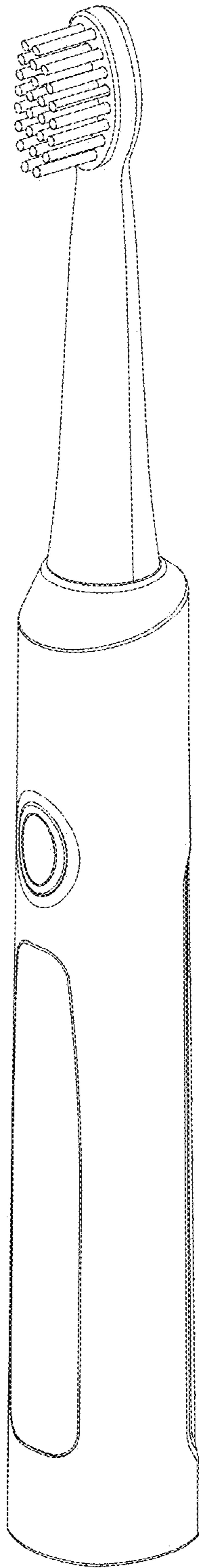

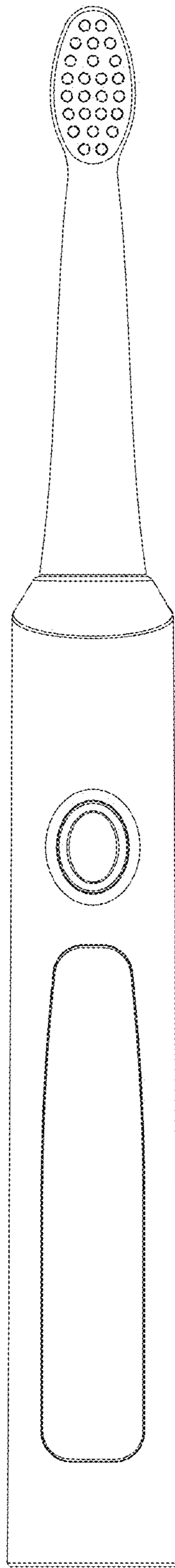

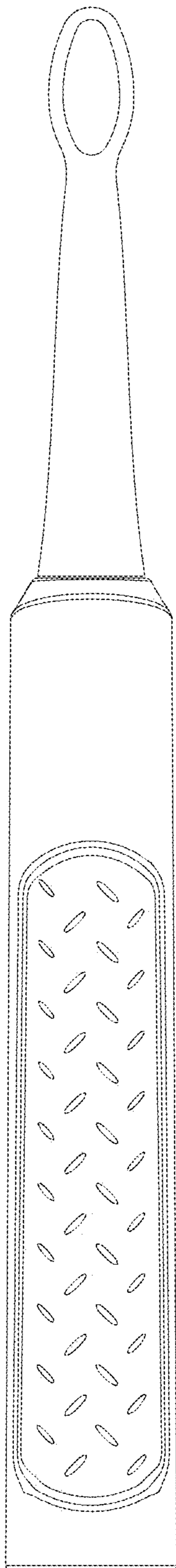

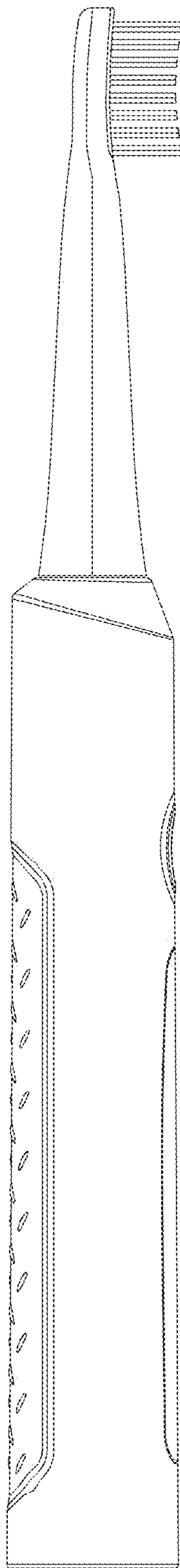

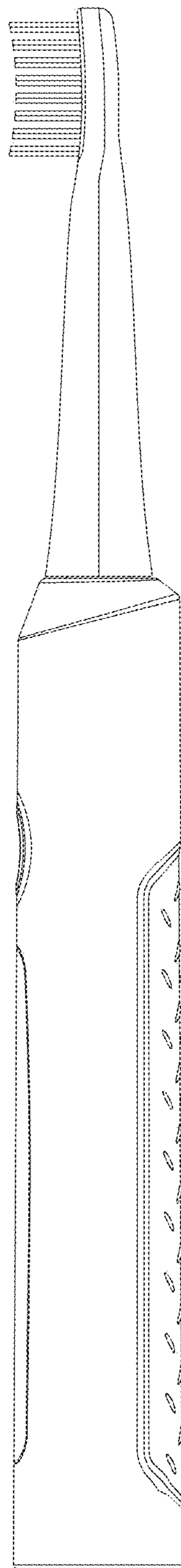

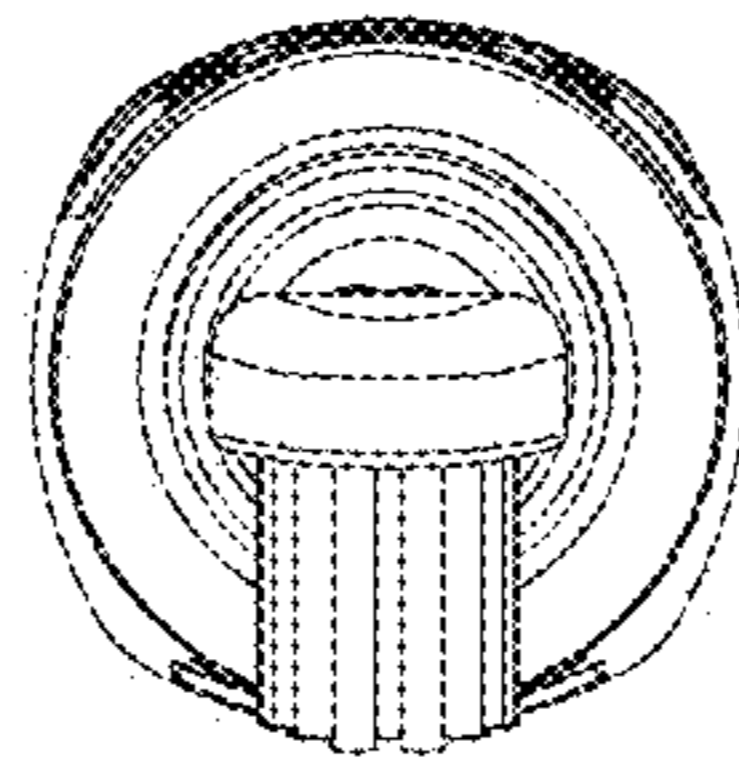

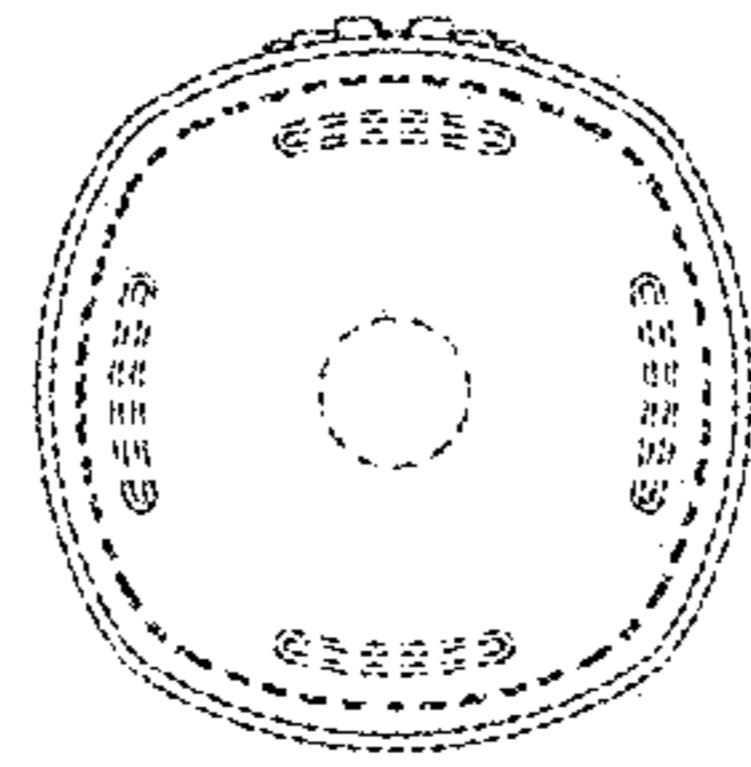
