**DESCRIPTION**

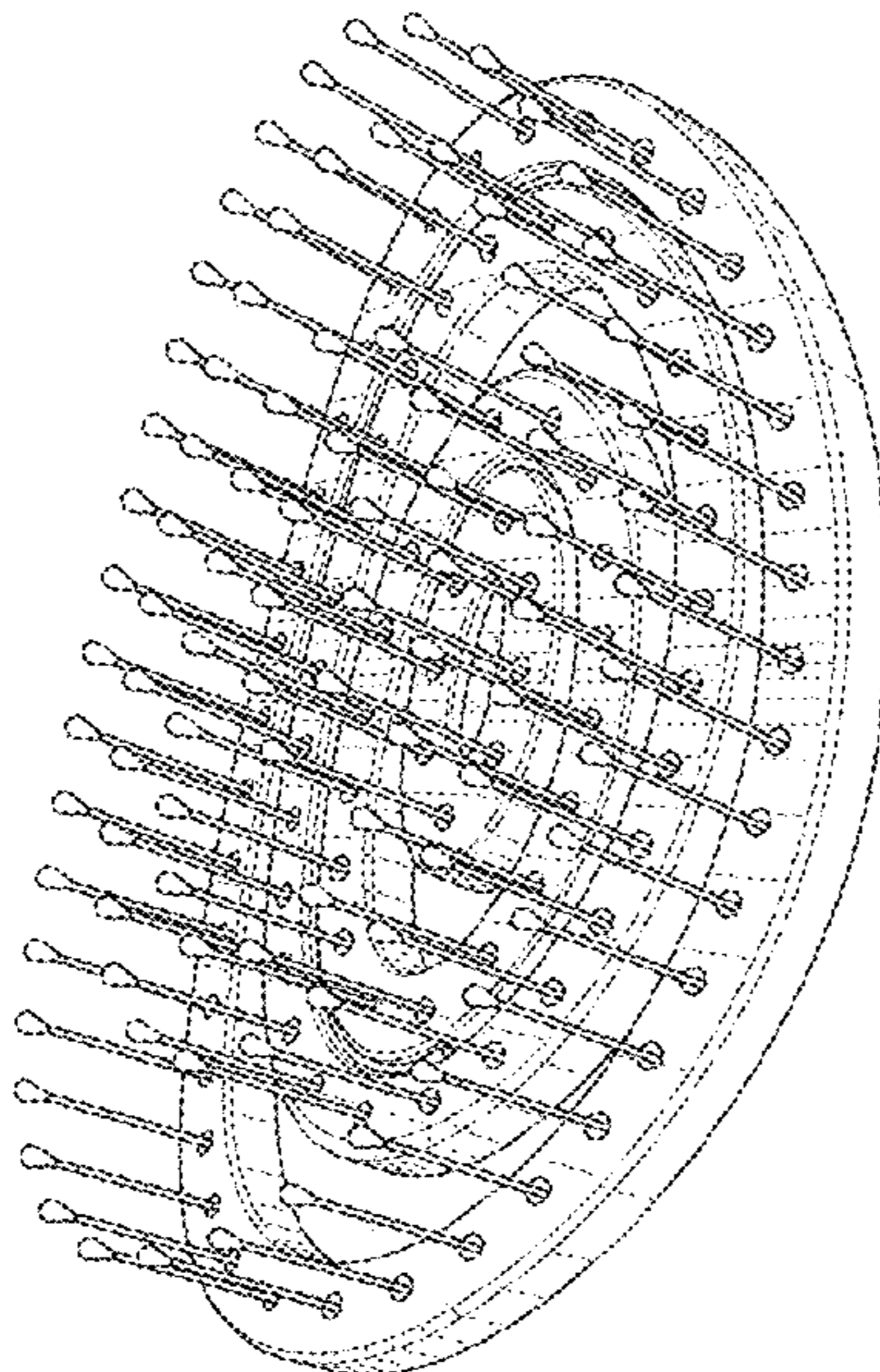
FIG. 1 is a perspective view of a hair brush showing my new design;

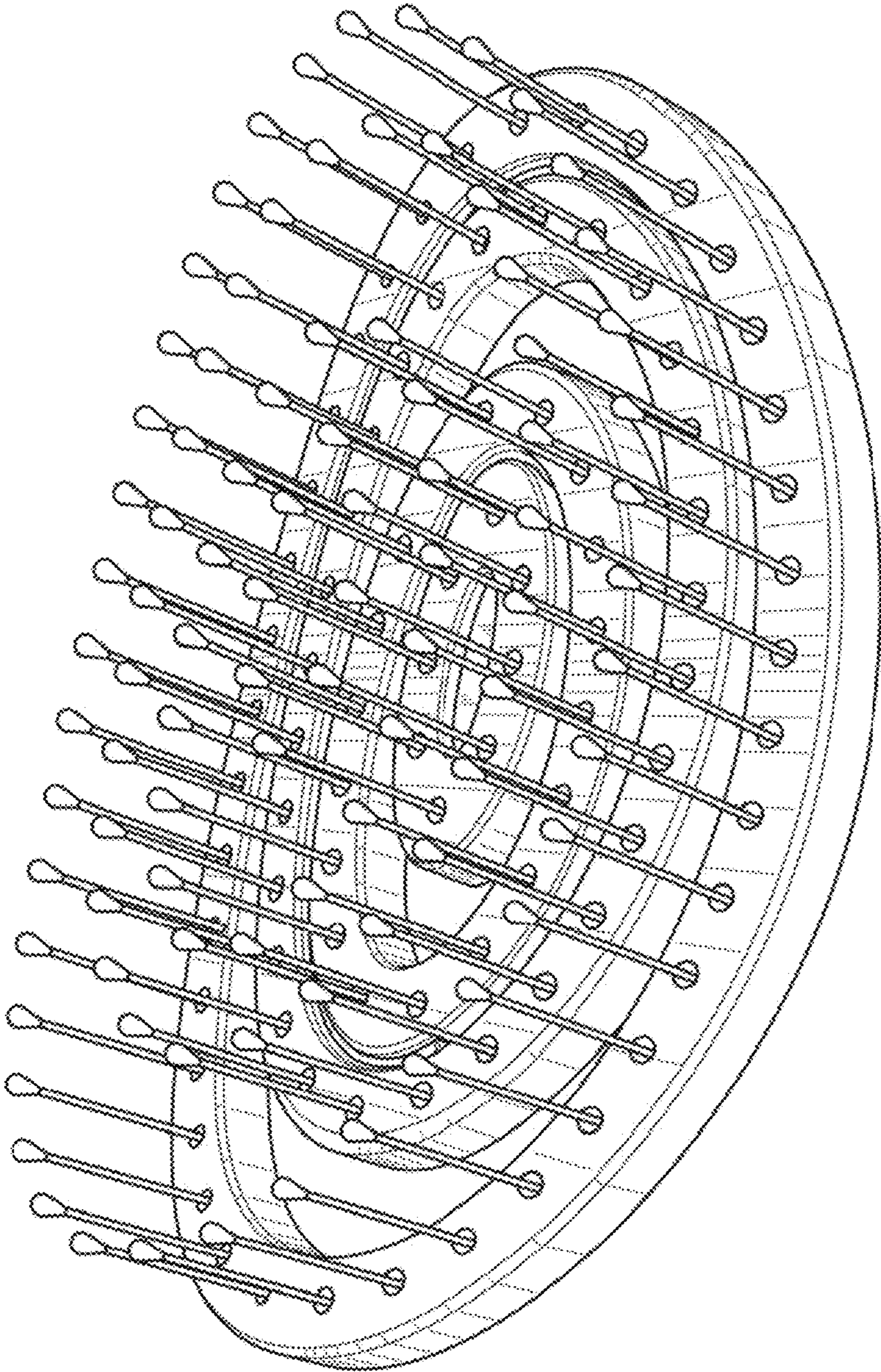

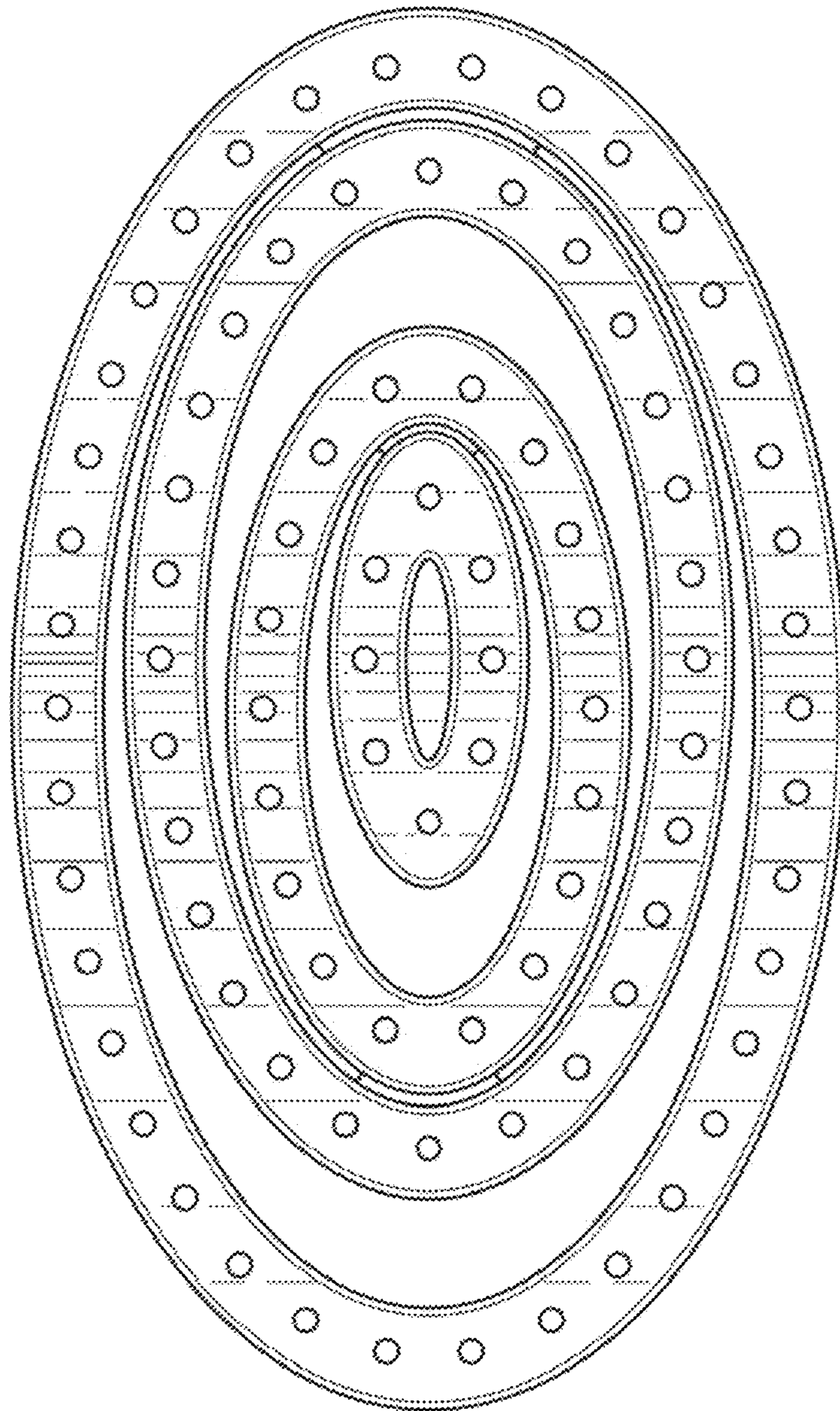

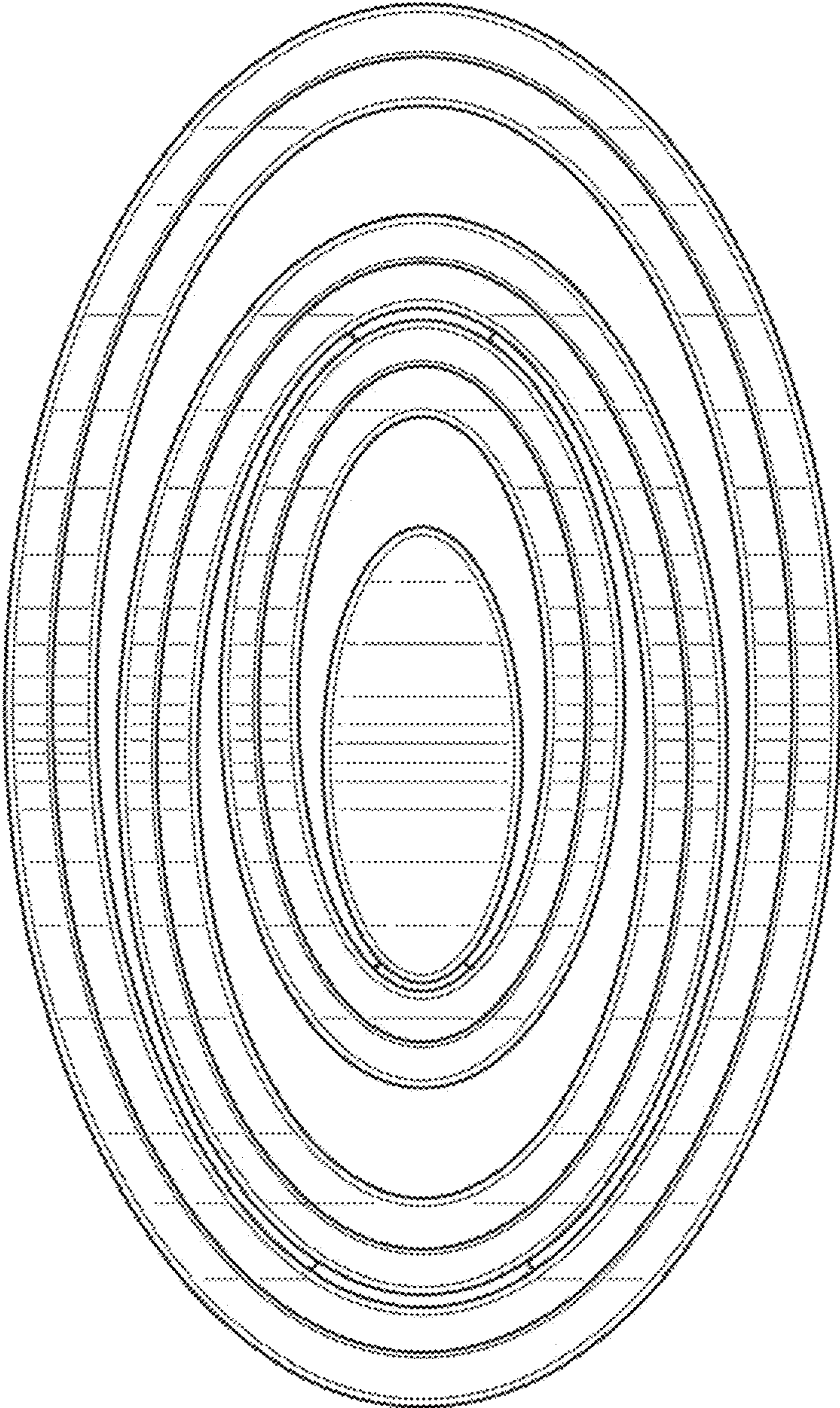

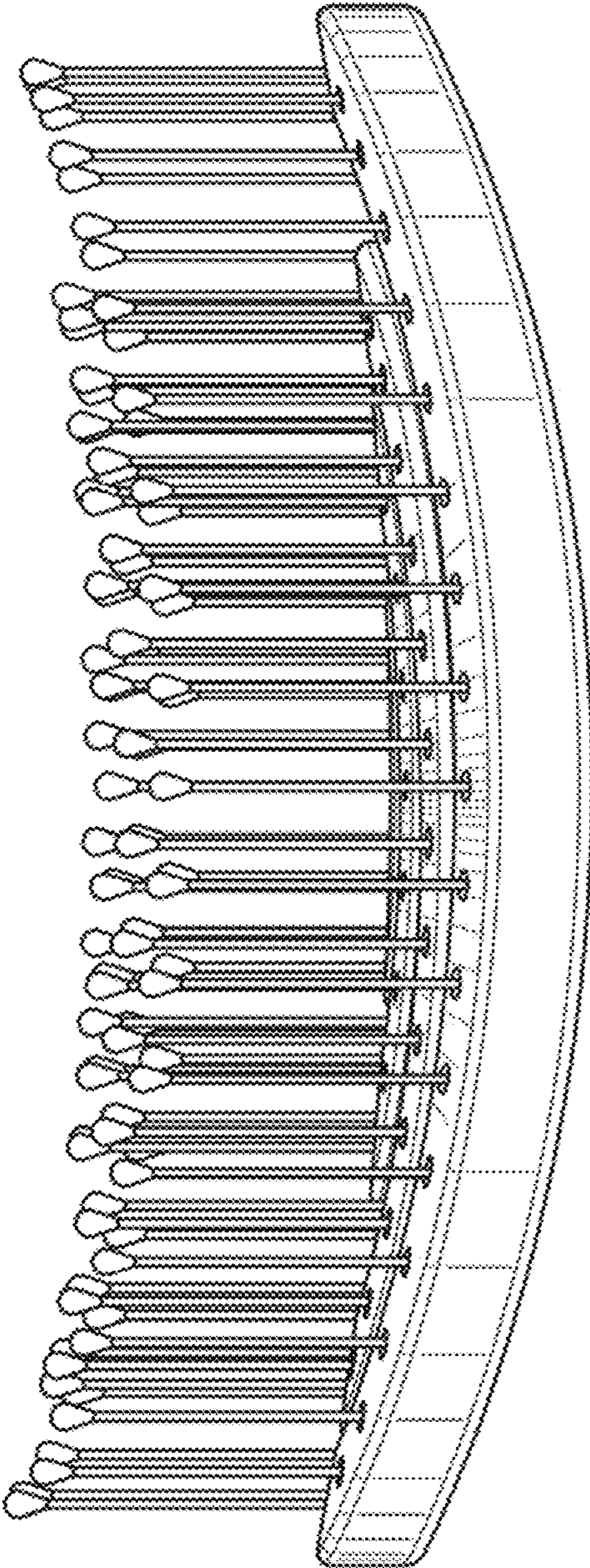

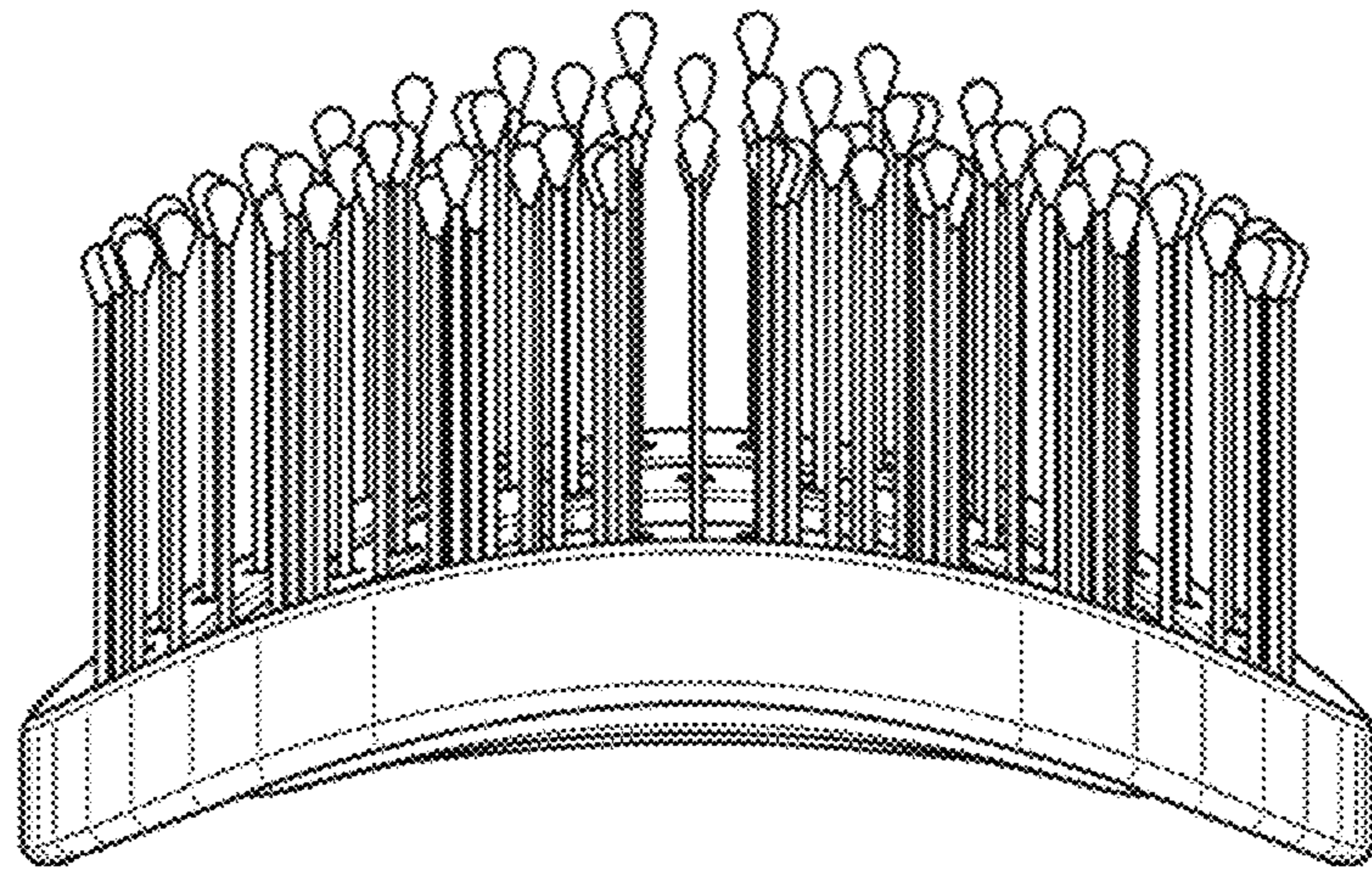

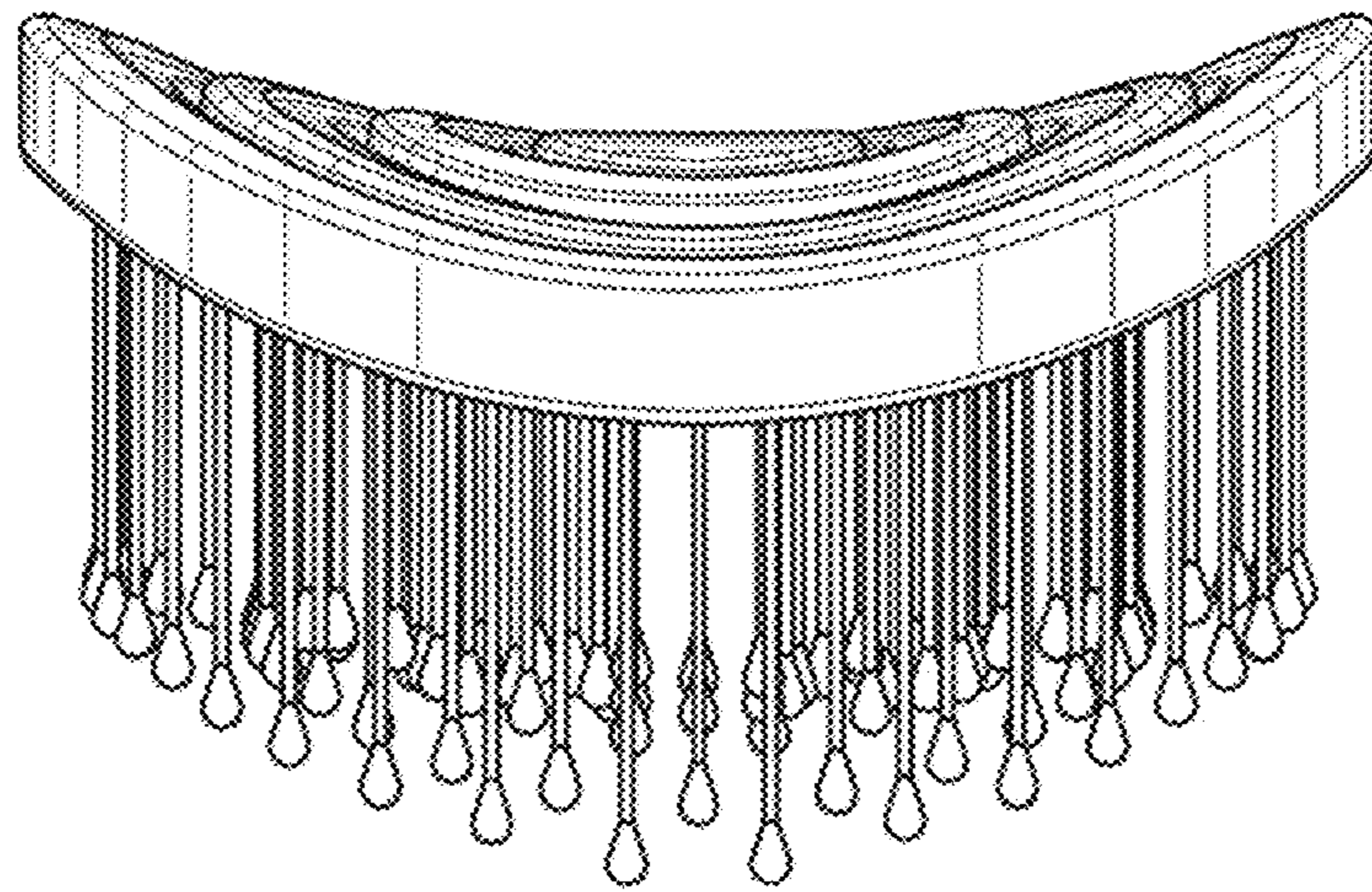
