(57) **CLAIM**

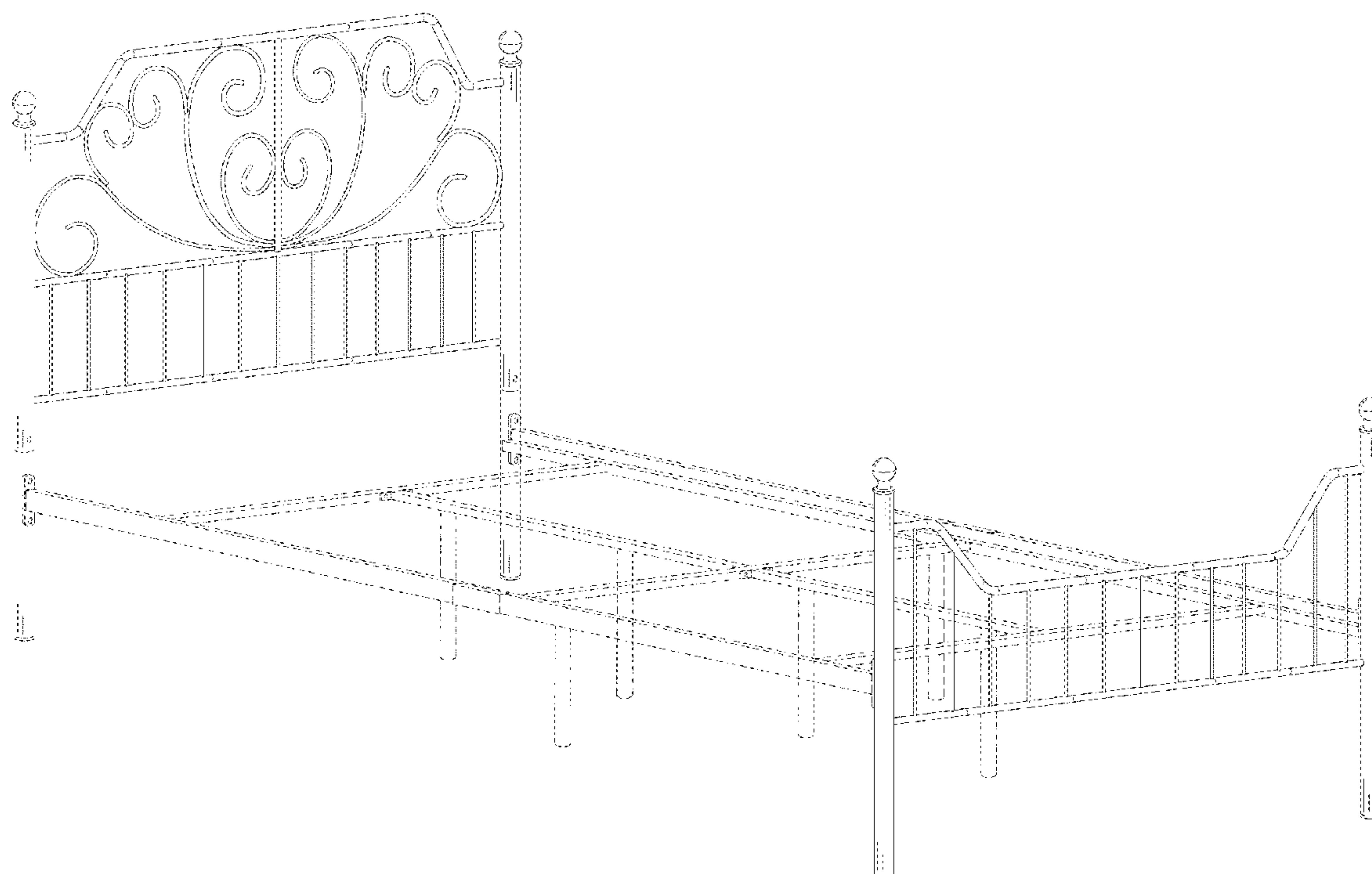
The ornamental design for a bed frame, as shown and as described.

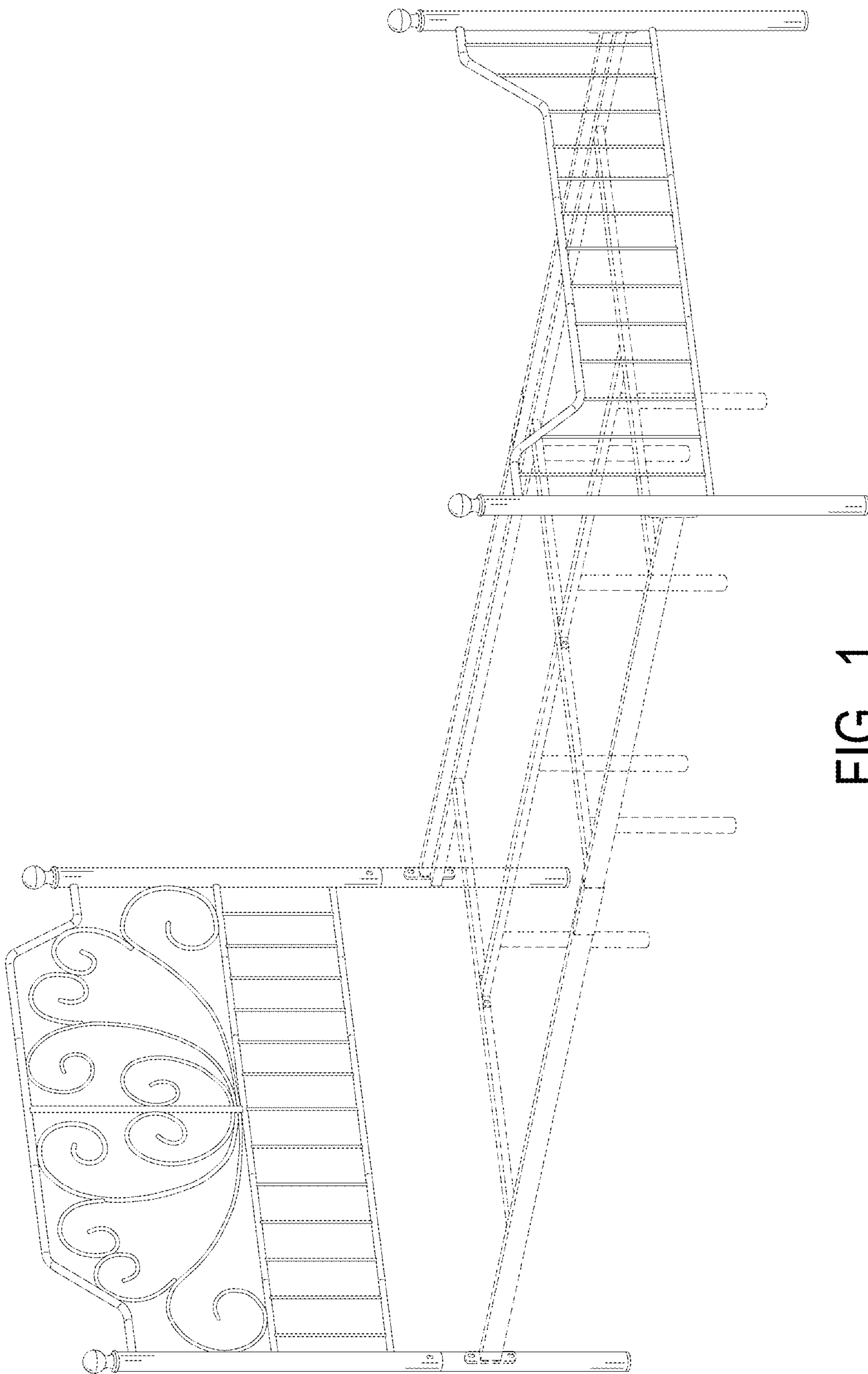

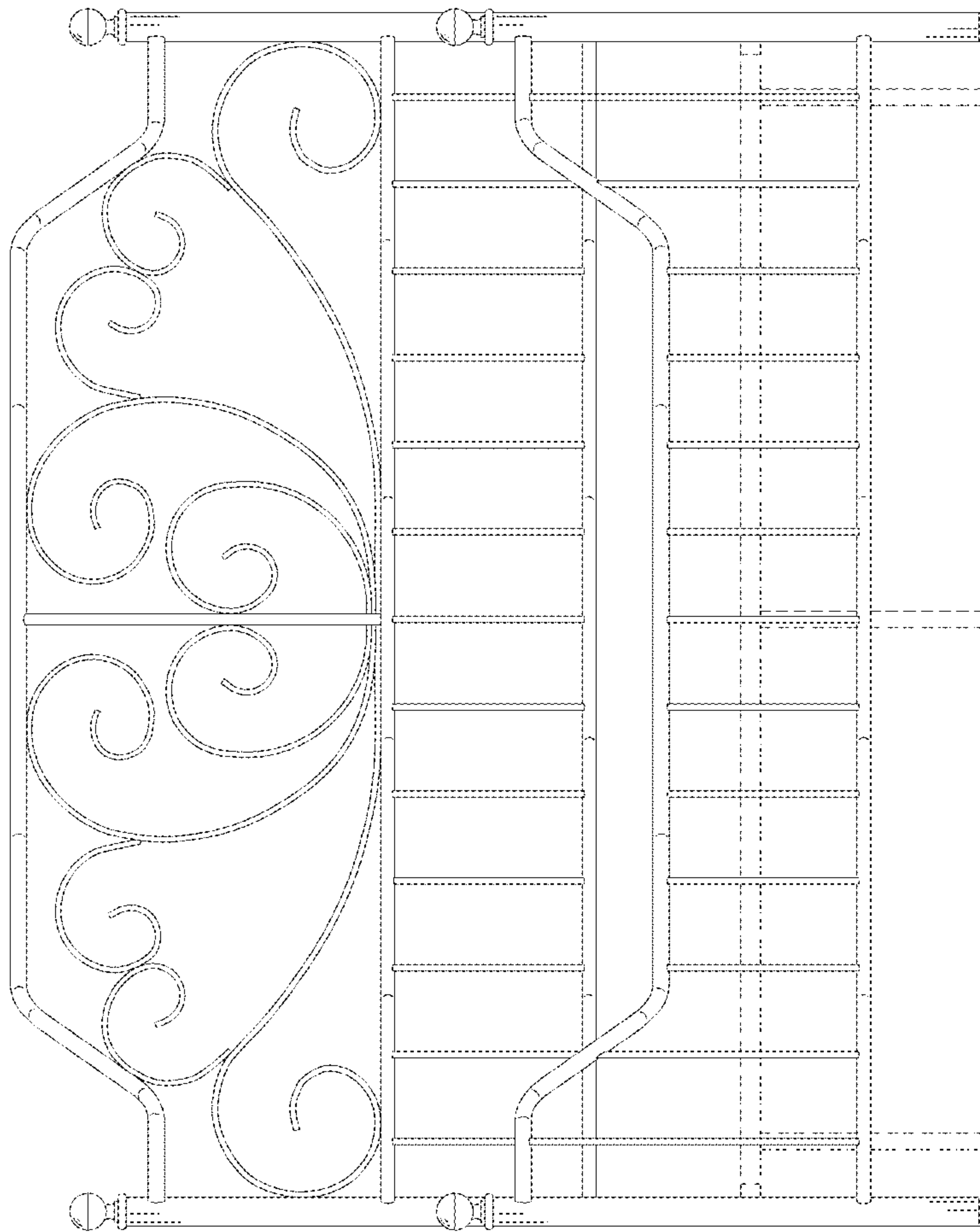

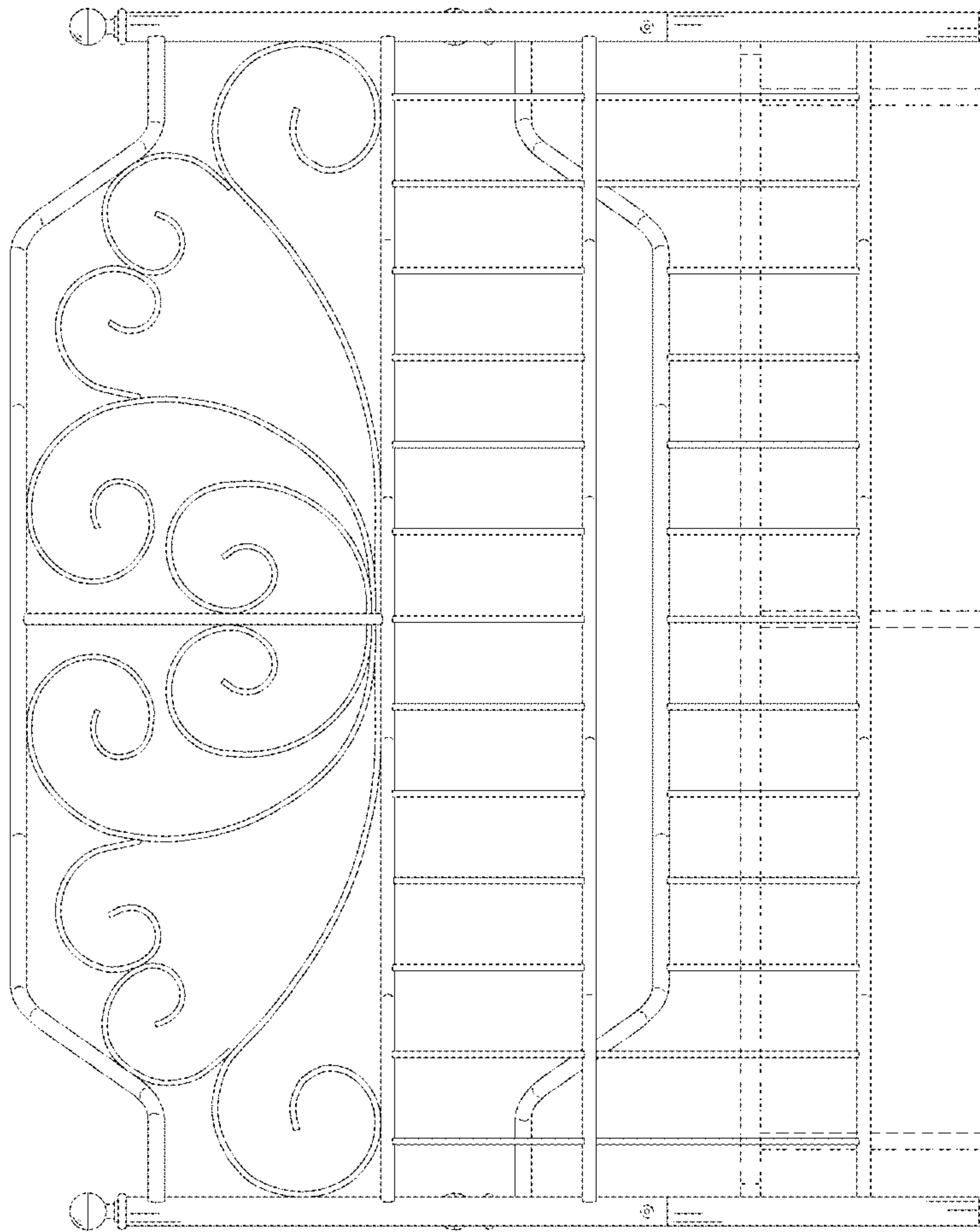

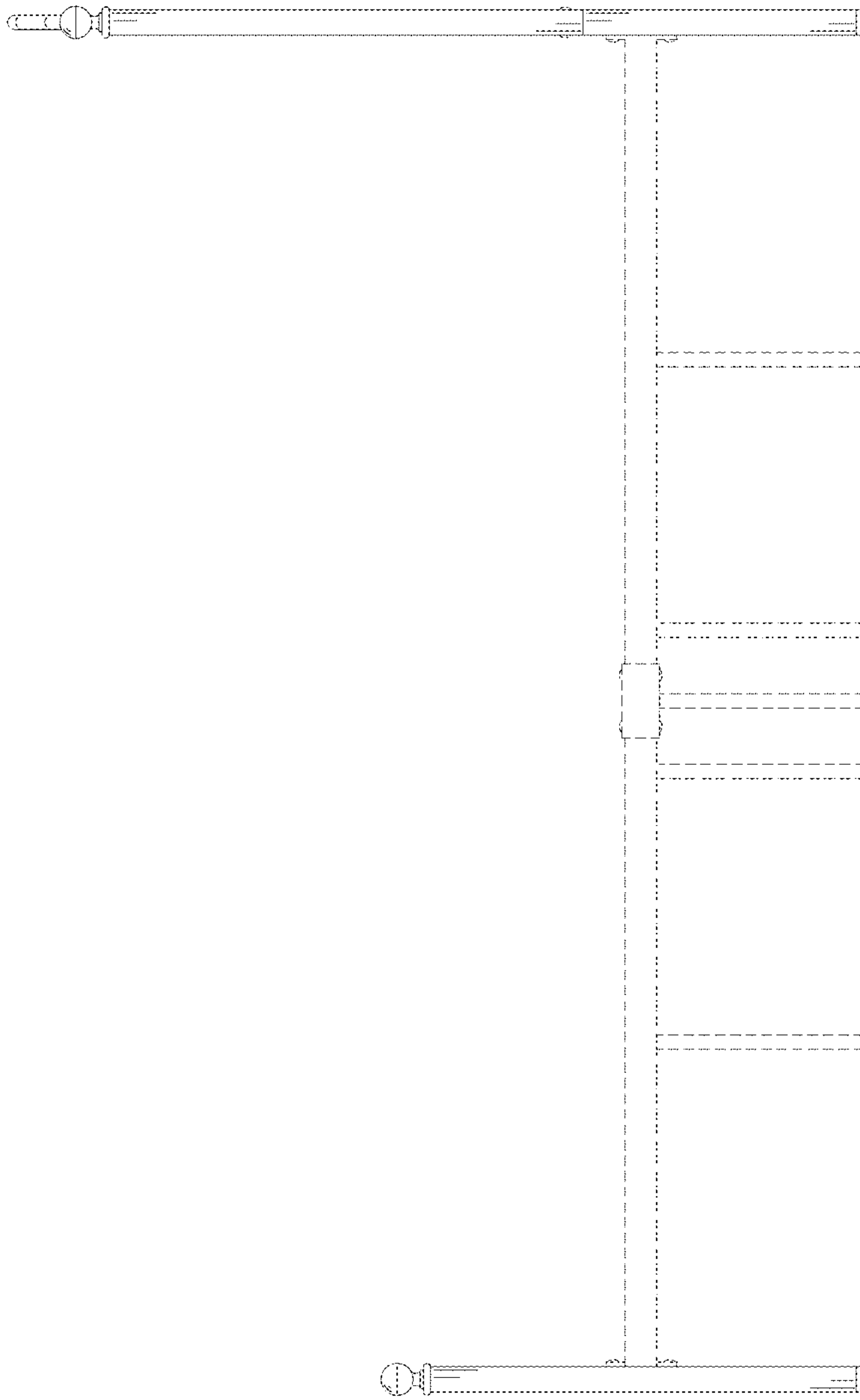

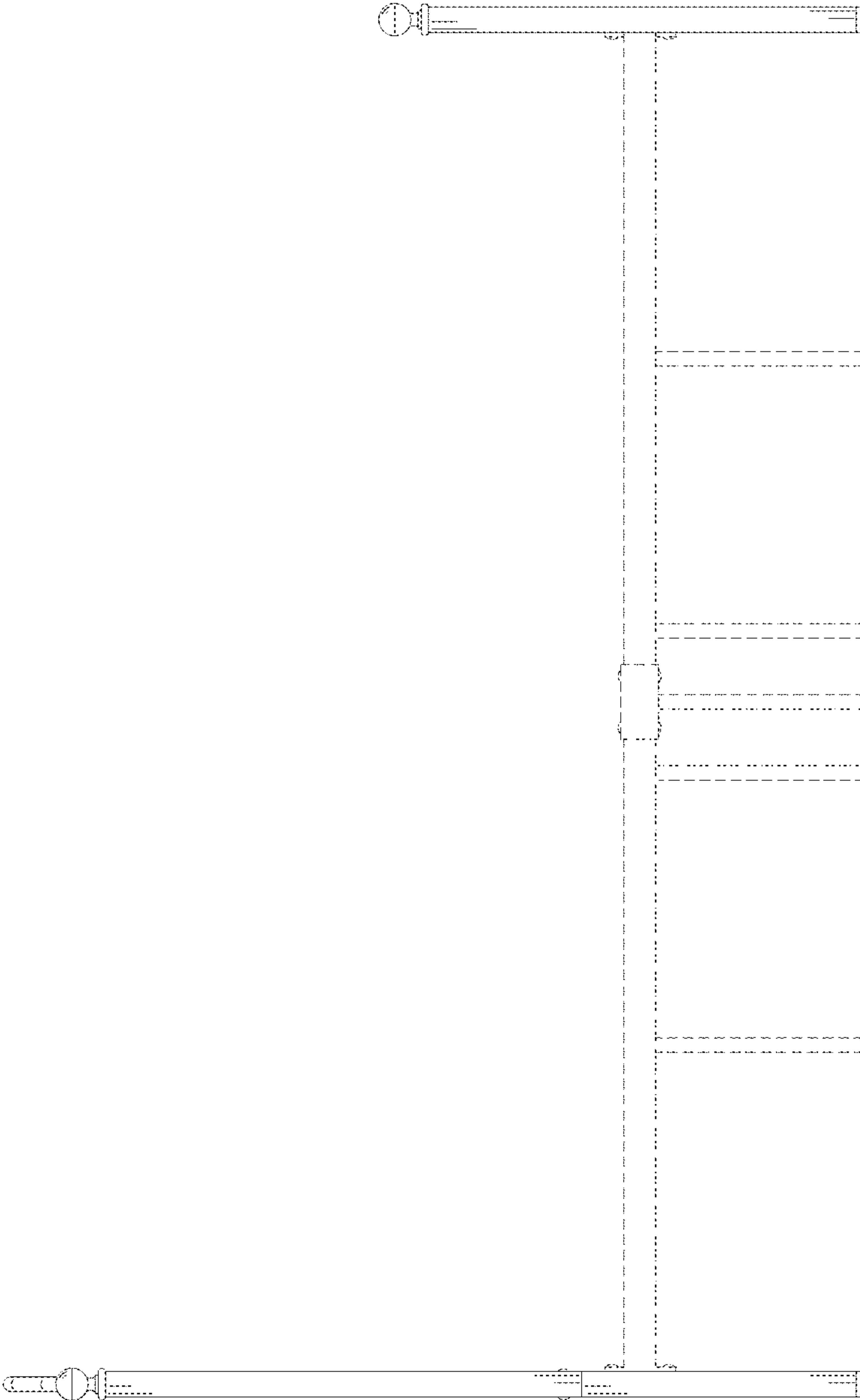

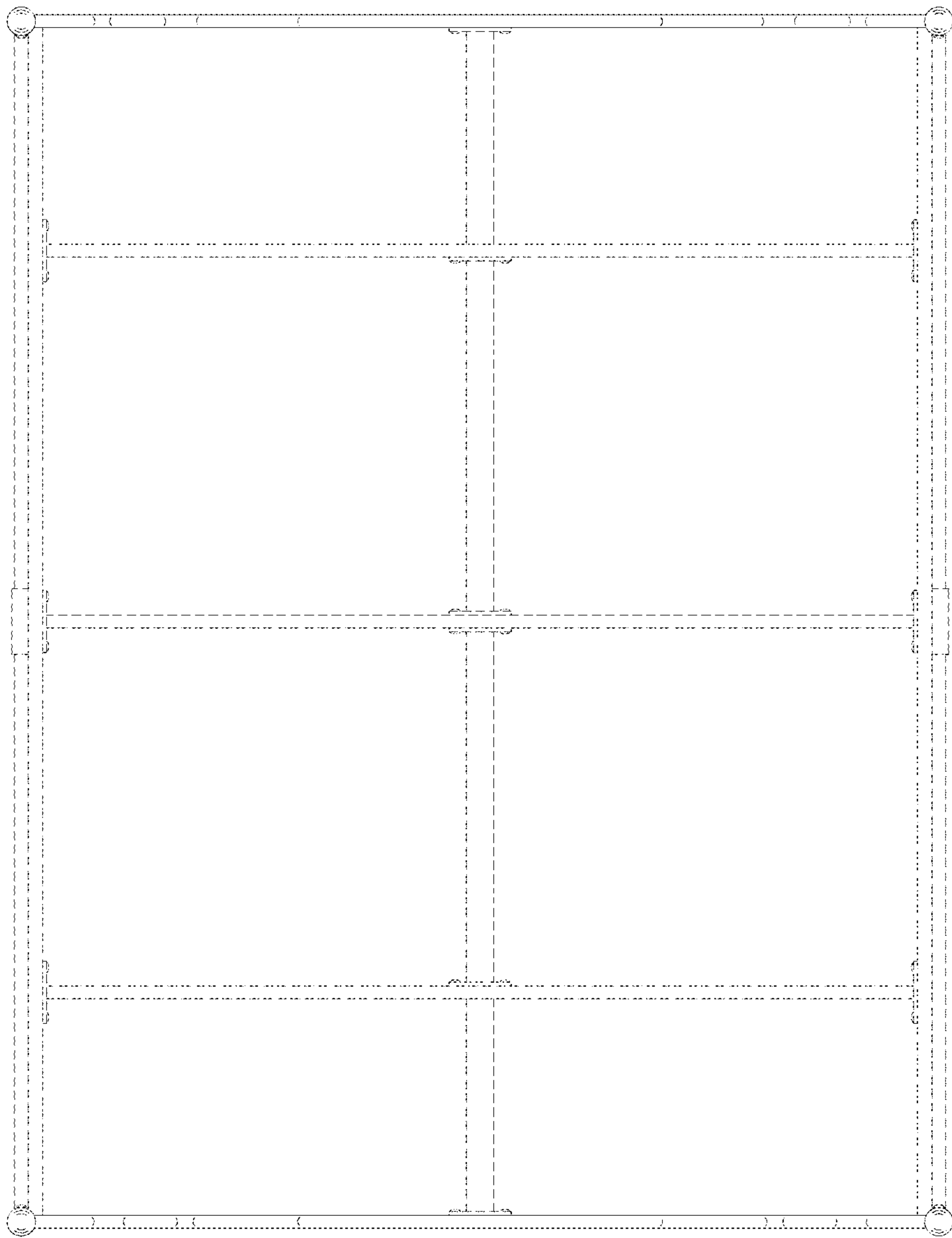

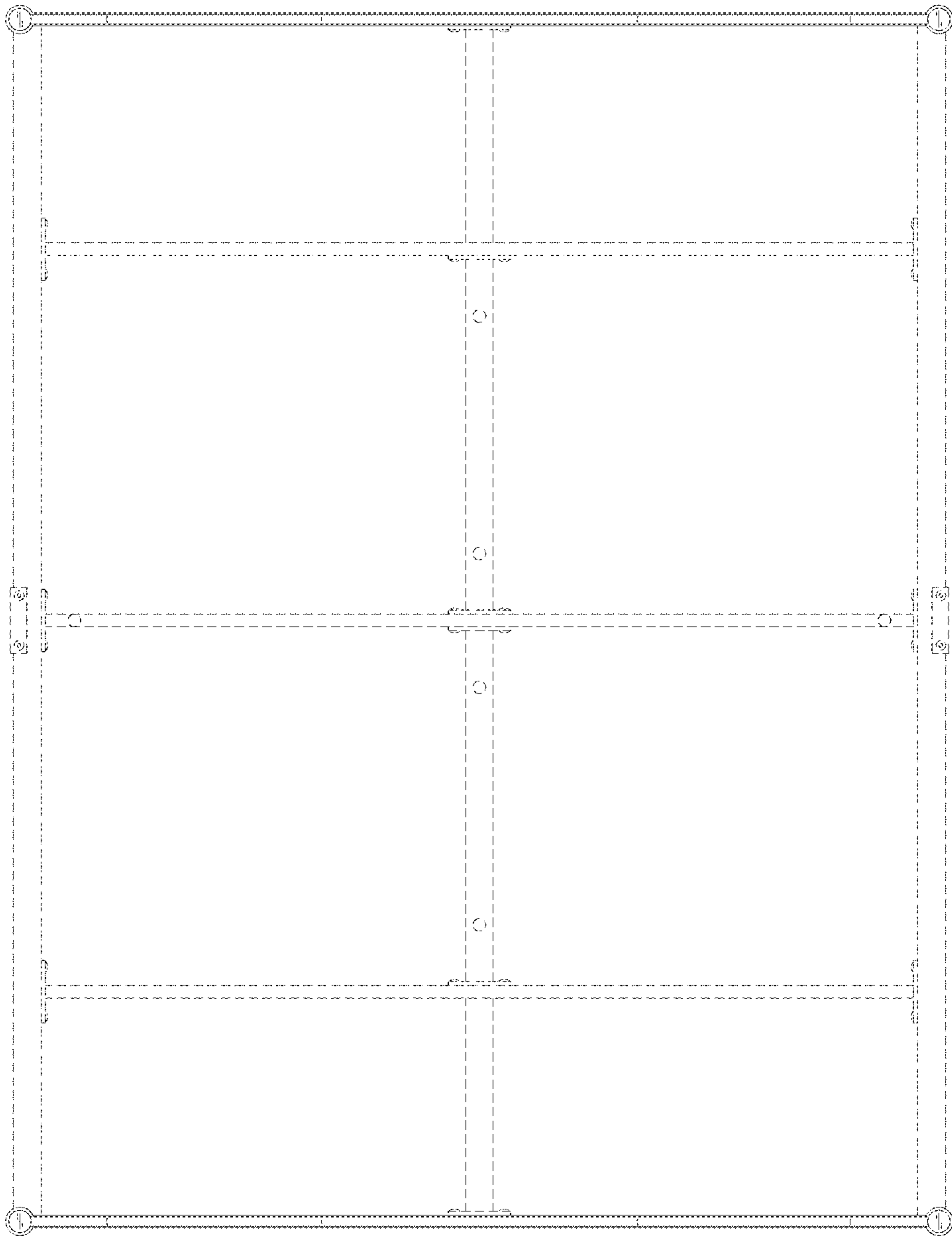
