The ornamental design for a retail fixture, as shown and described.

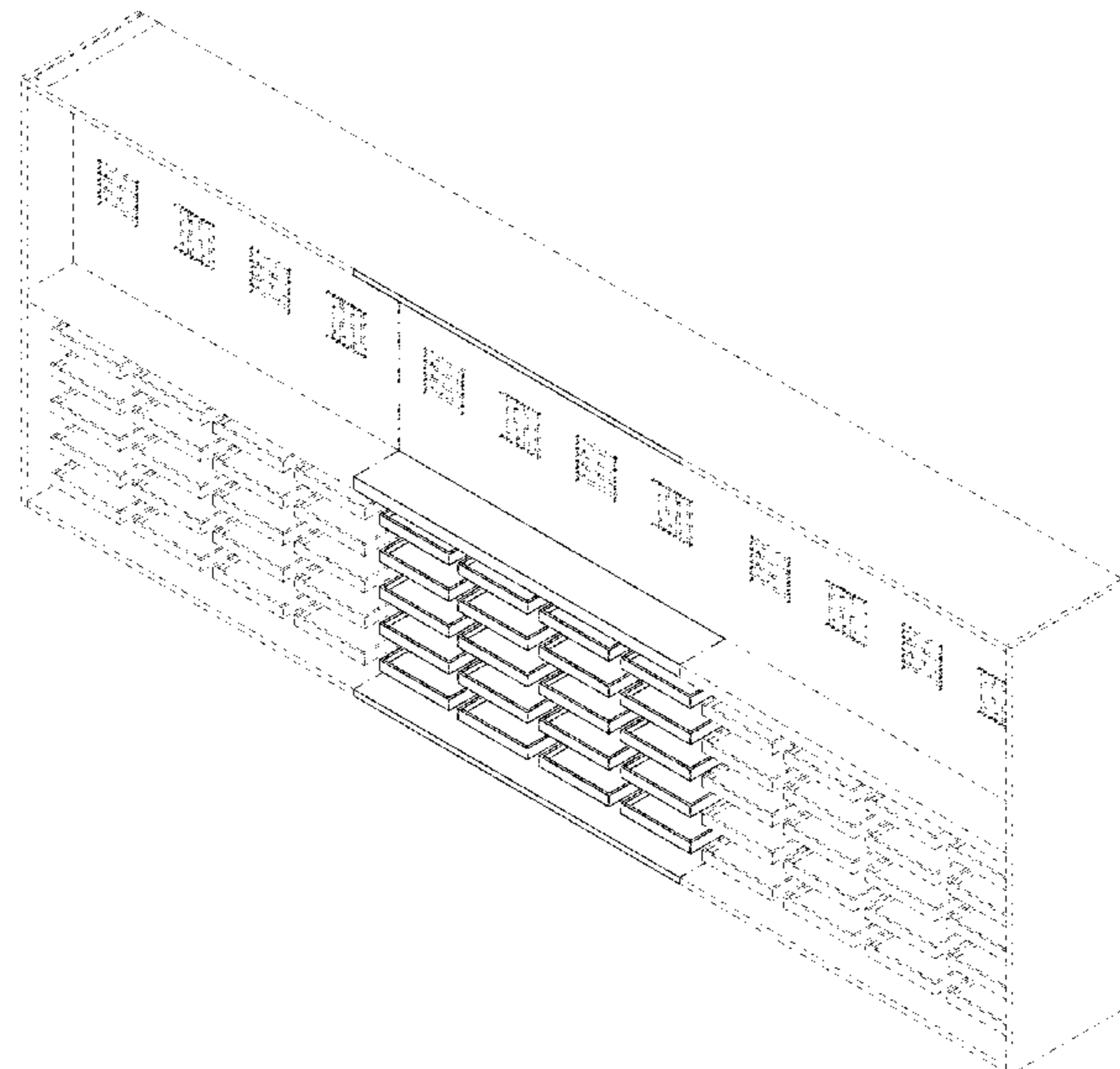
DESCRIPTION

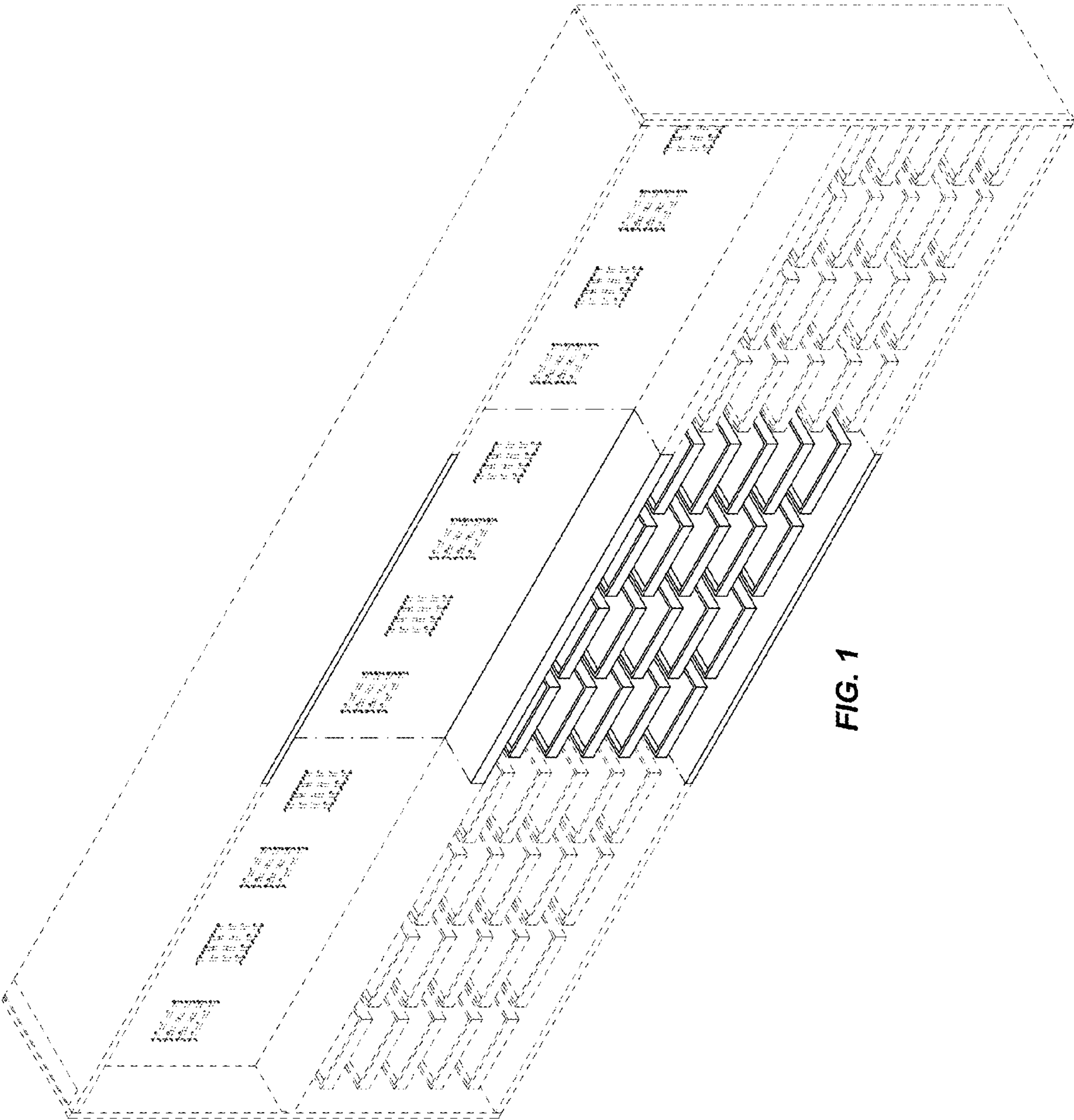

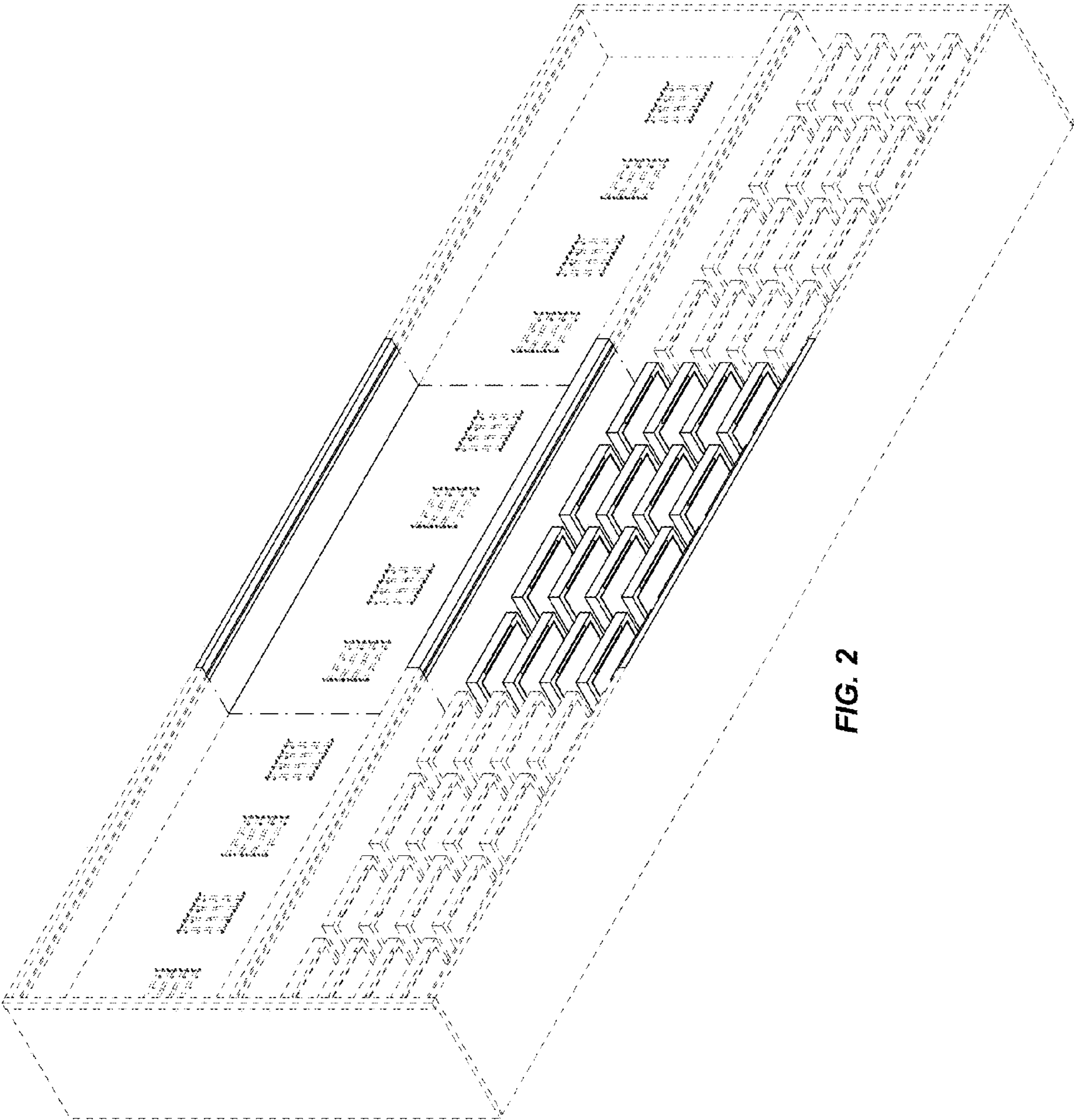

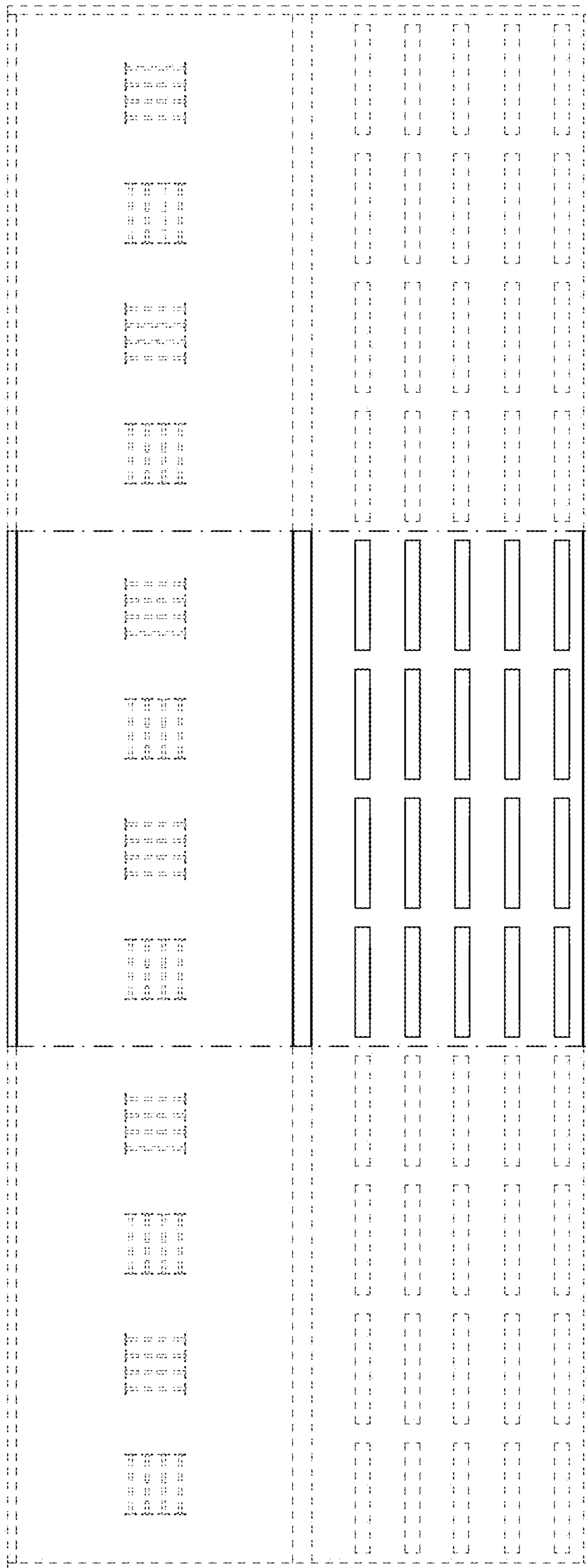
