**DESCRIPTION**

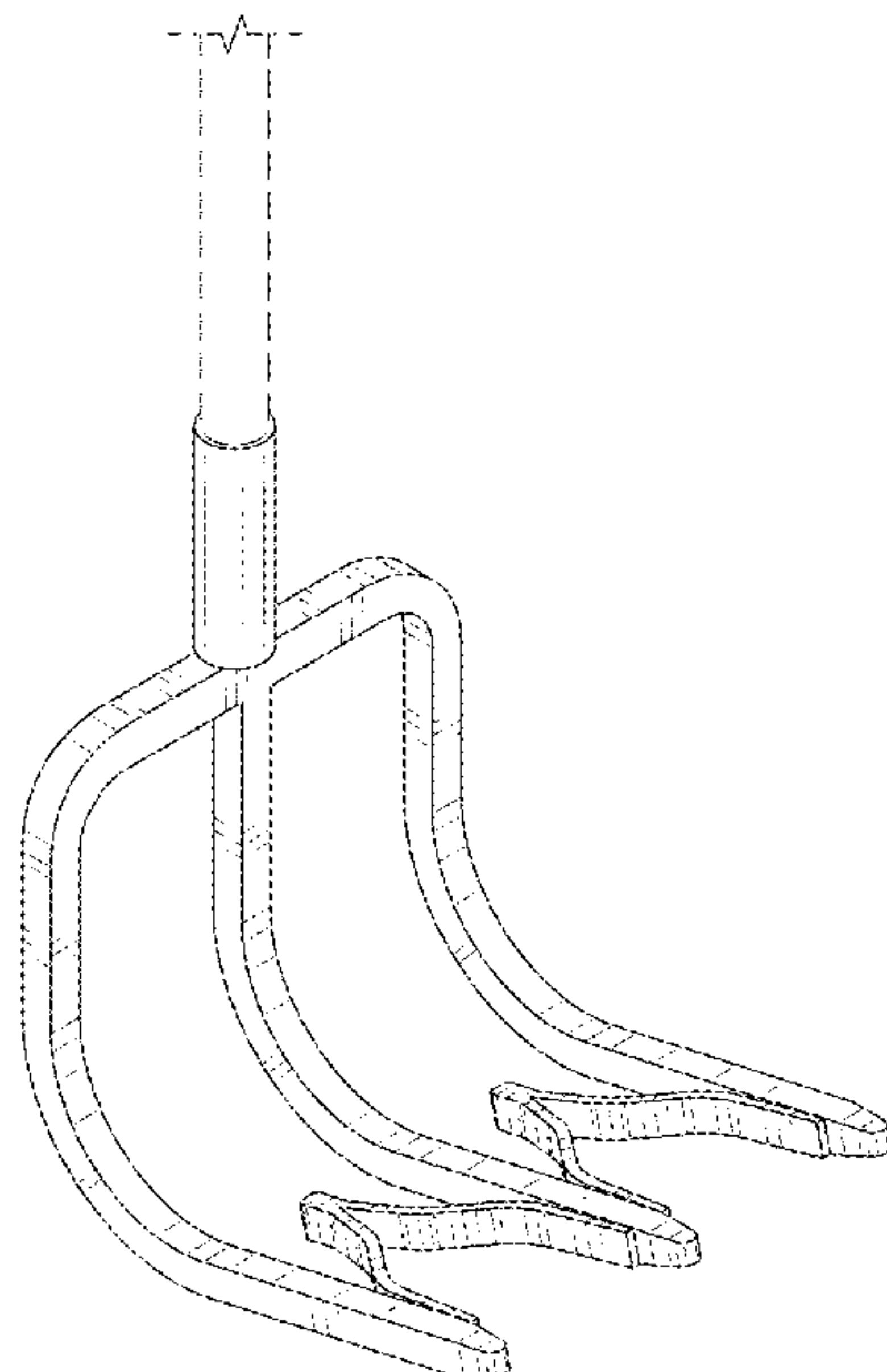
FIG. 1 is a front view of a gardening tool head showing my new design;

FIG. 6 is a bottom view of the gardening tool head; and,  
FIG. 7 is a top front side perspective view of the gardening tool head.

The dot-dash broken lines in FIG. 7 are for the purpose of illustrating a symbolic break. The portion between the break lines forms no part of the claimed design.

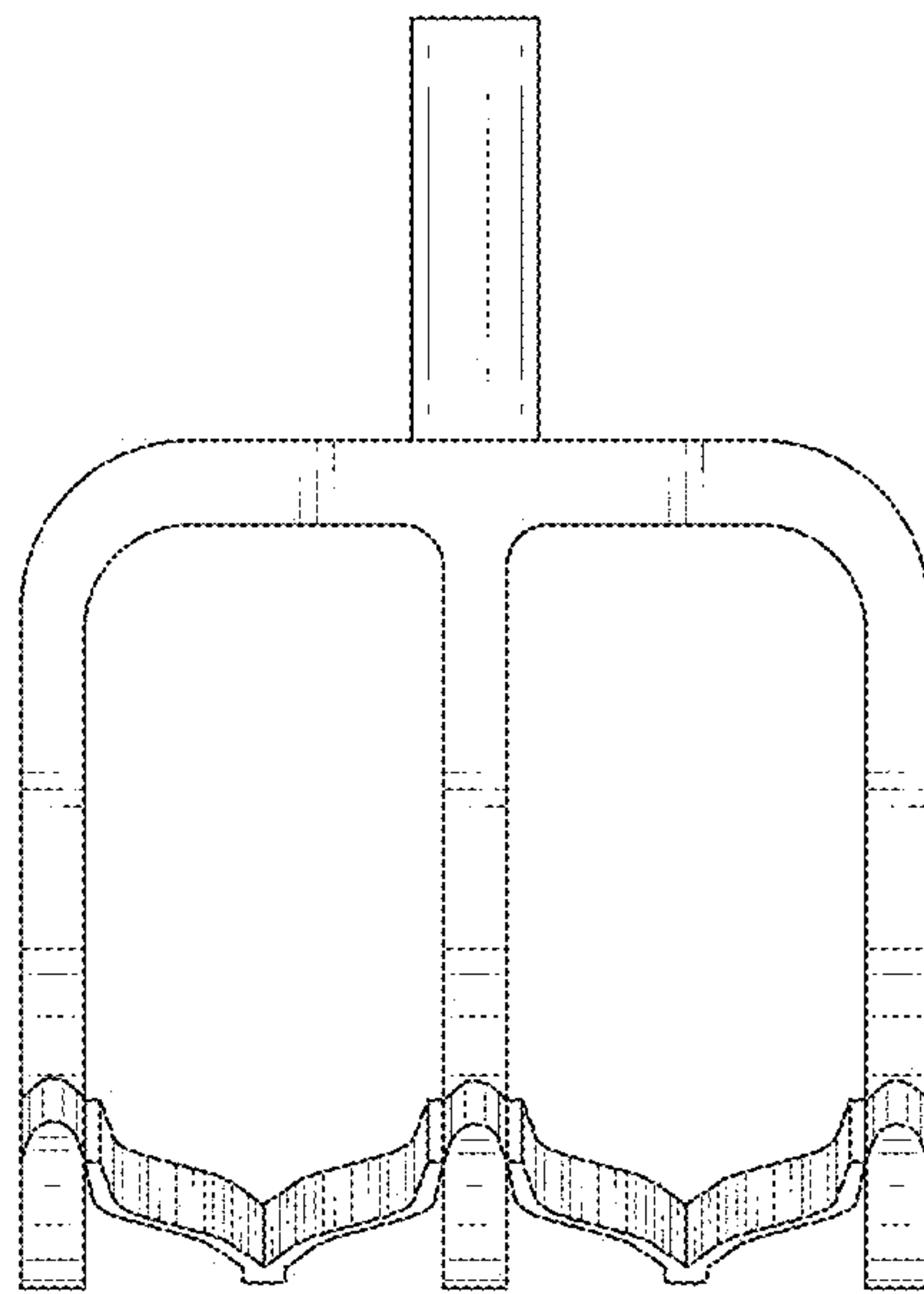

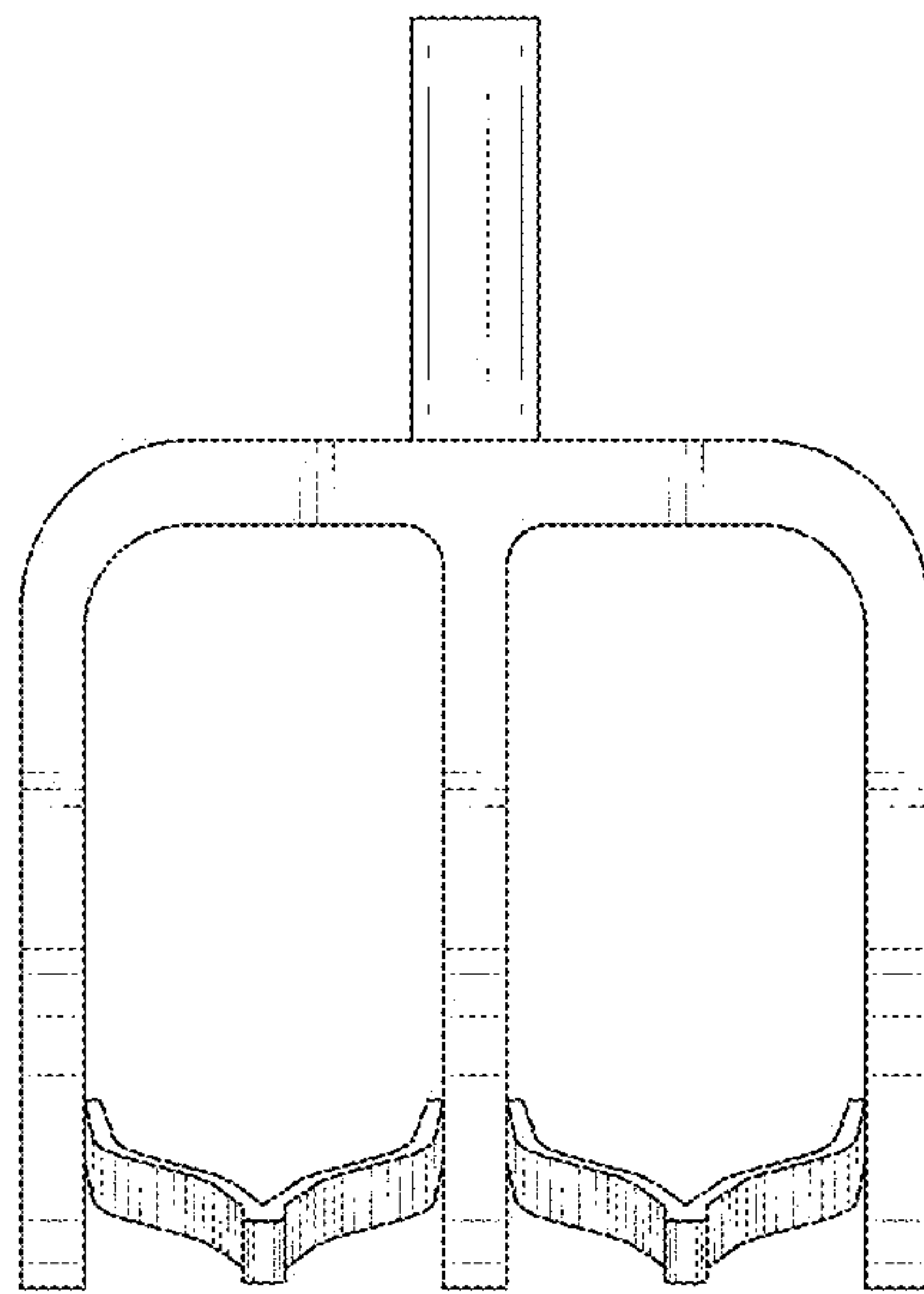

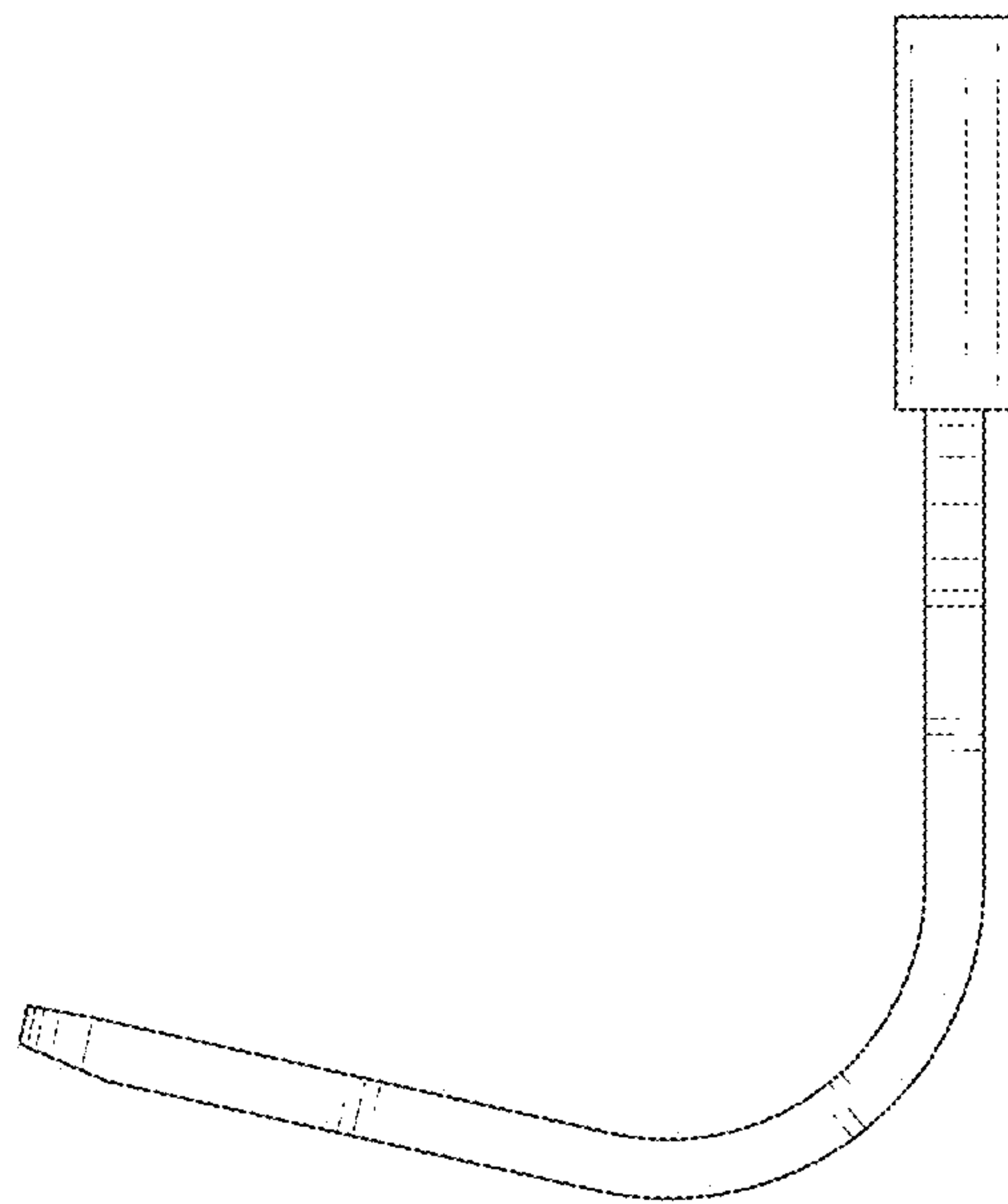

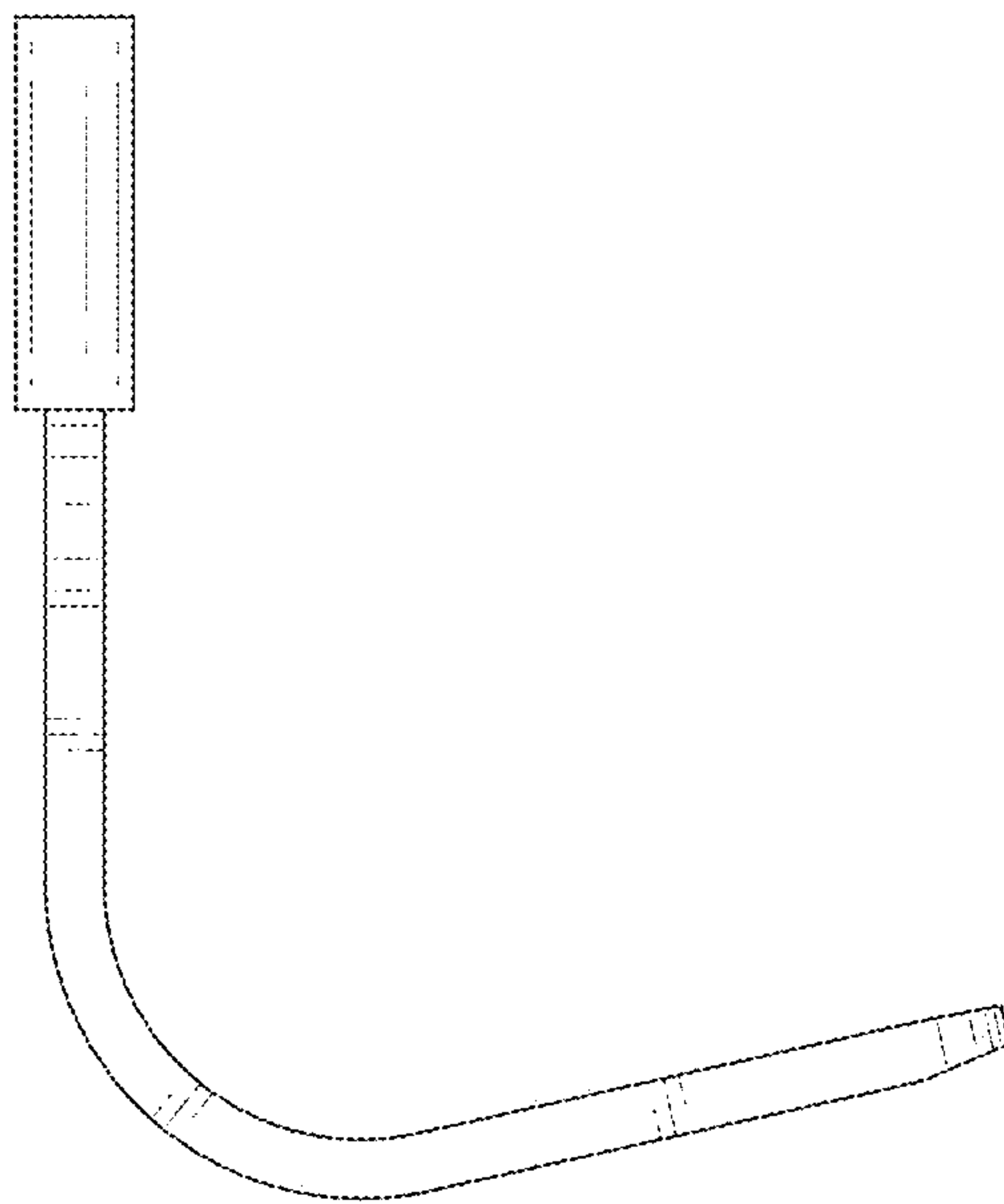

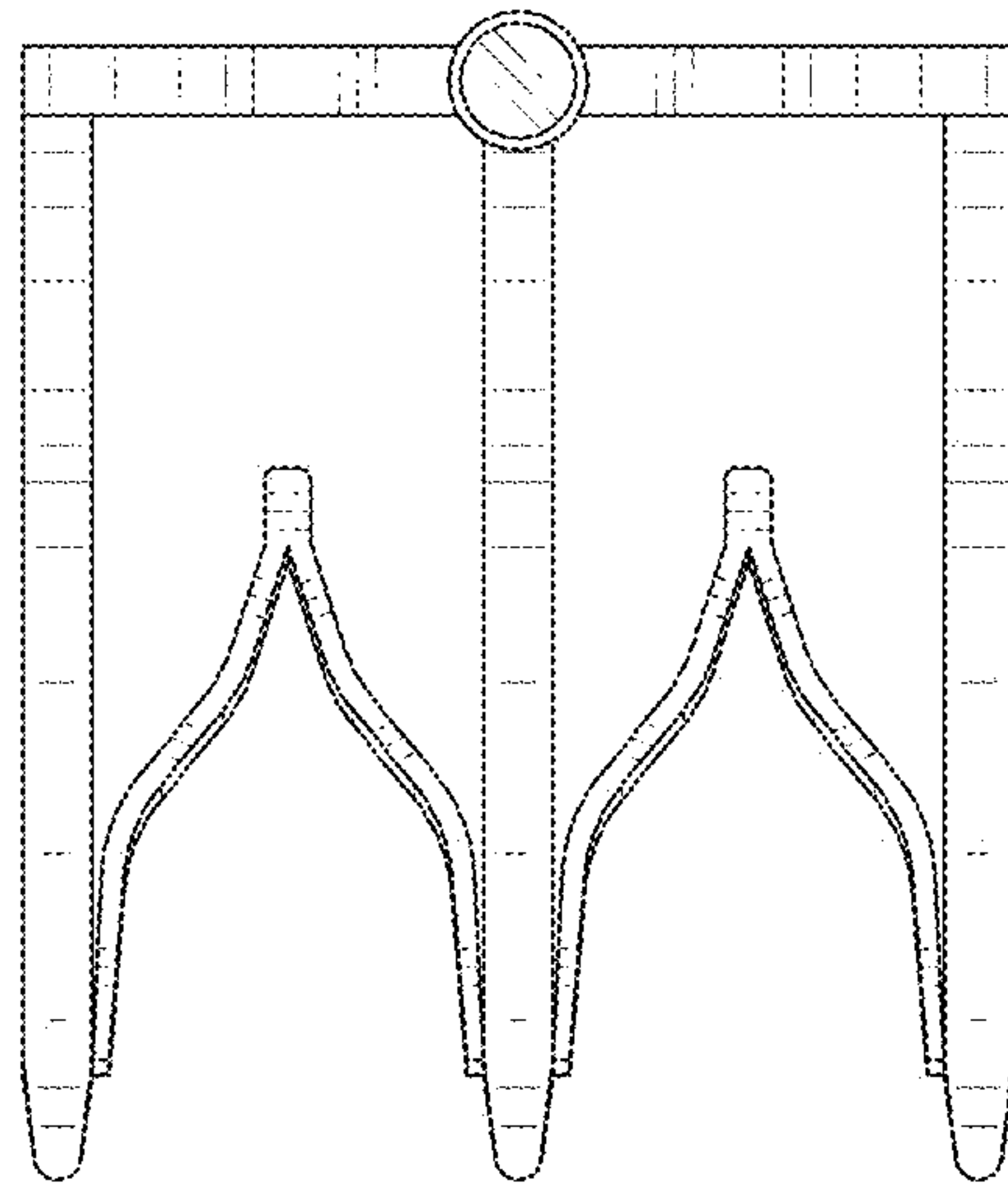

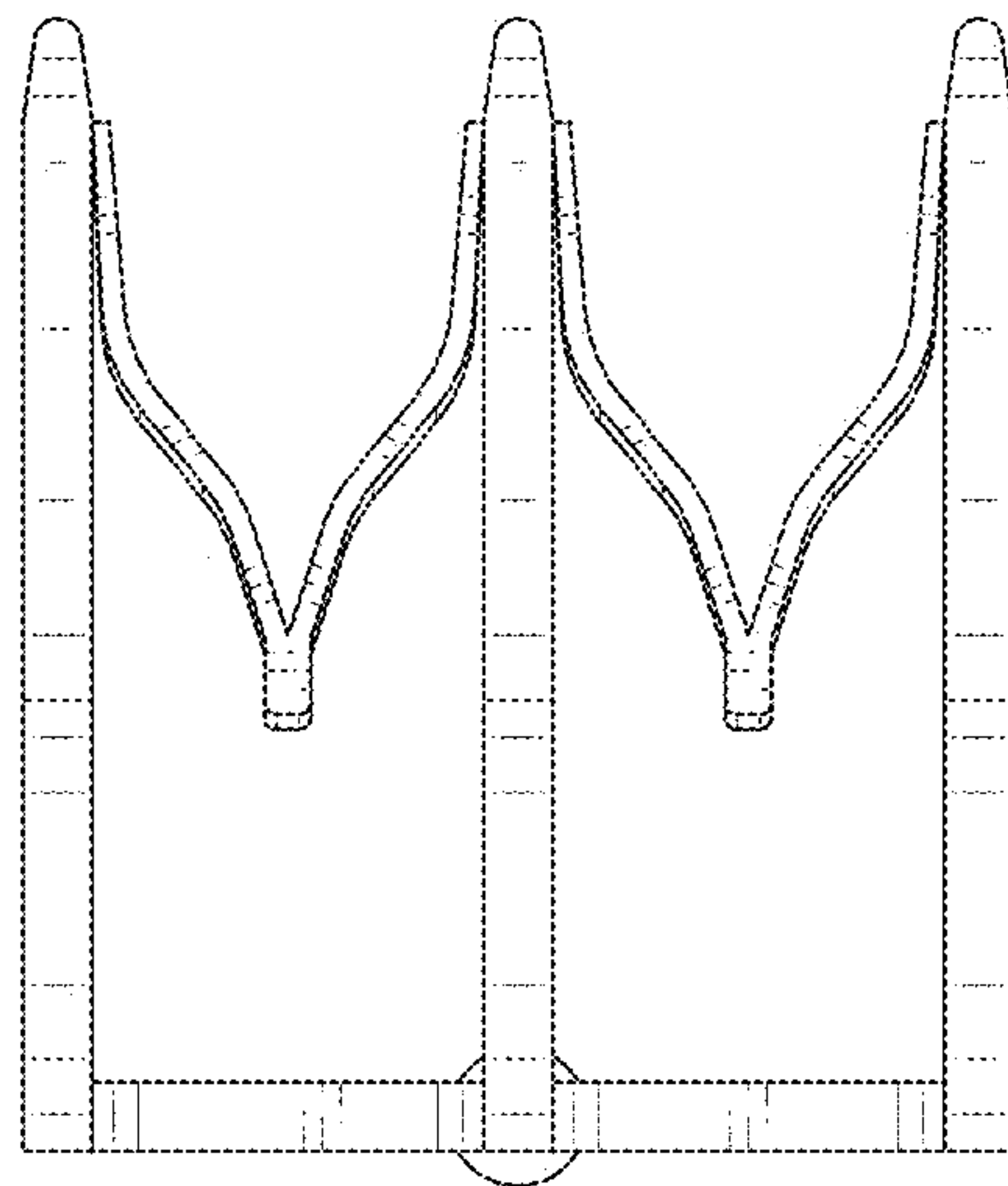

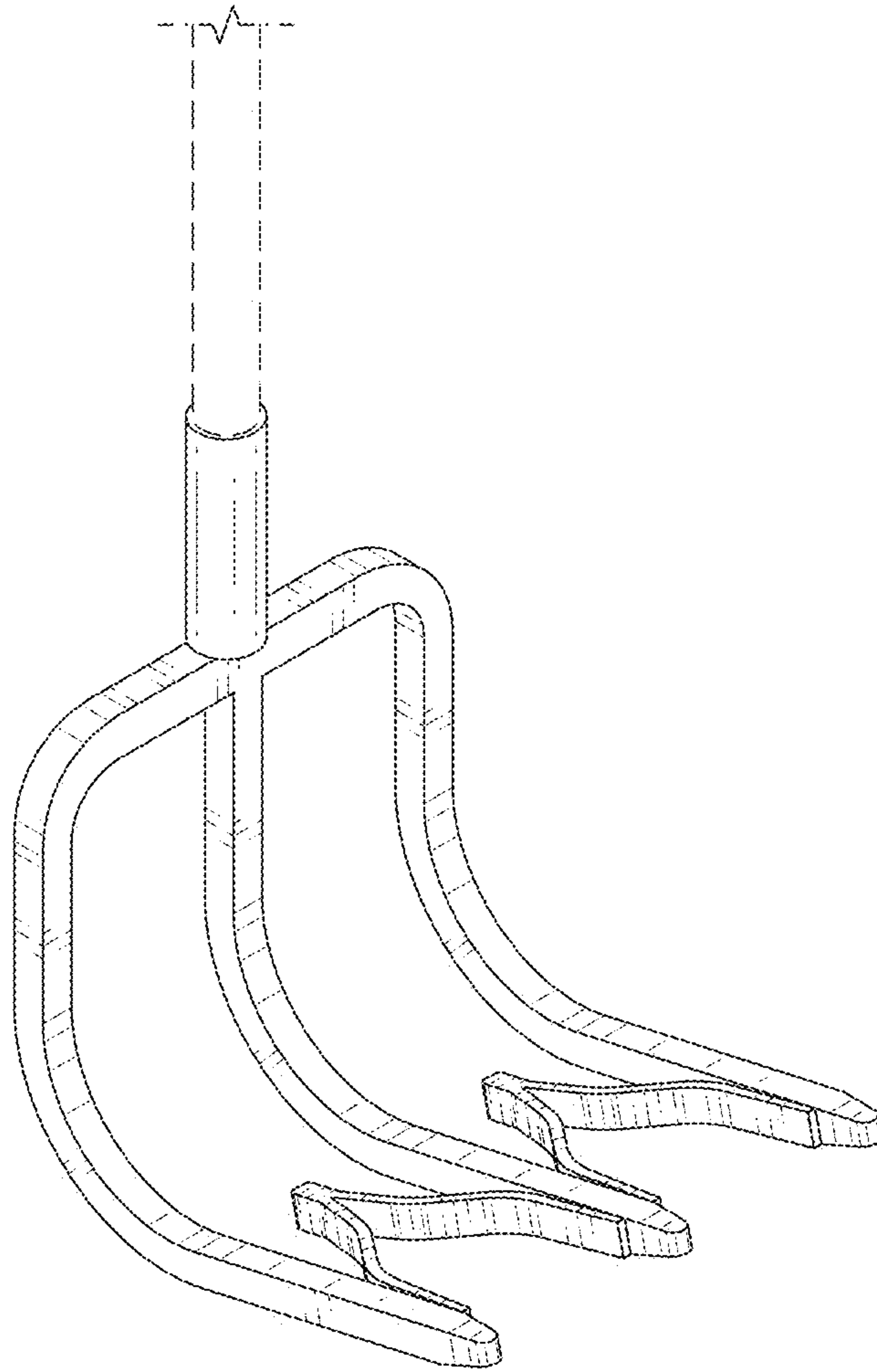
