(57) **CLAIM**

I claim the ornamental design for a sunscreen holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sunscreen holder shown in a closed position;

FIG. 2 is a left-side elevation view thereof;

FIG. 3 is a front elevation view thereof;

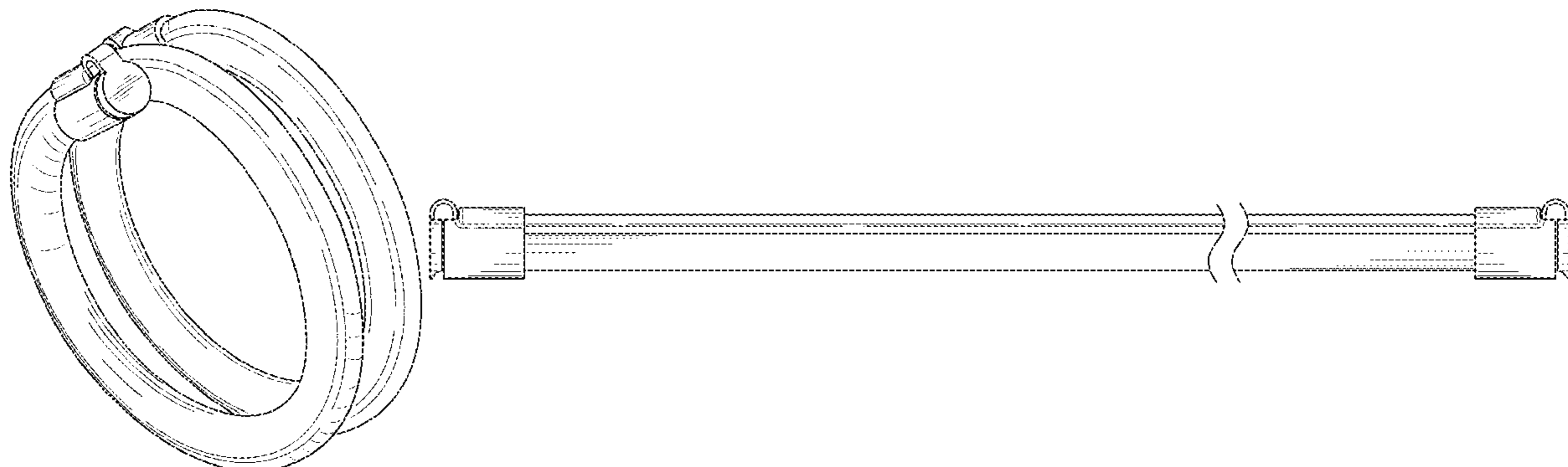
FIG. 4 is a top plan view taken at line 5-5 in FIG. 3; and, FIG. 5 is a cross-sectional view thereof, showing the sunscreen holder.

The length of the claimed design is as seen in FIG. 1, in FIGS. 2-5 the design is shown in a straightened configuration and its length is broken for ease of illustration.

The broken away symbols in the drawings indicate the appearance of any portion of the article between the break lines forms no part of the claimed design.

The broken lines shown illustrate portions of the sunscreen holder that form no part of the claimed design.

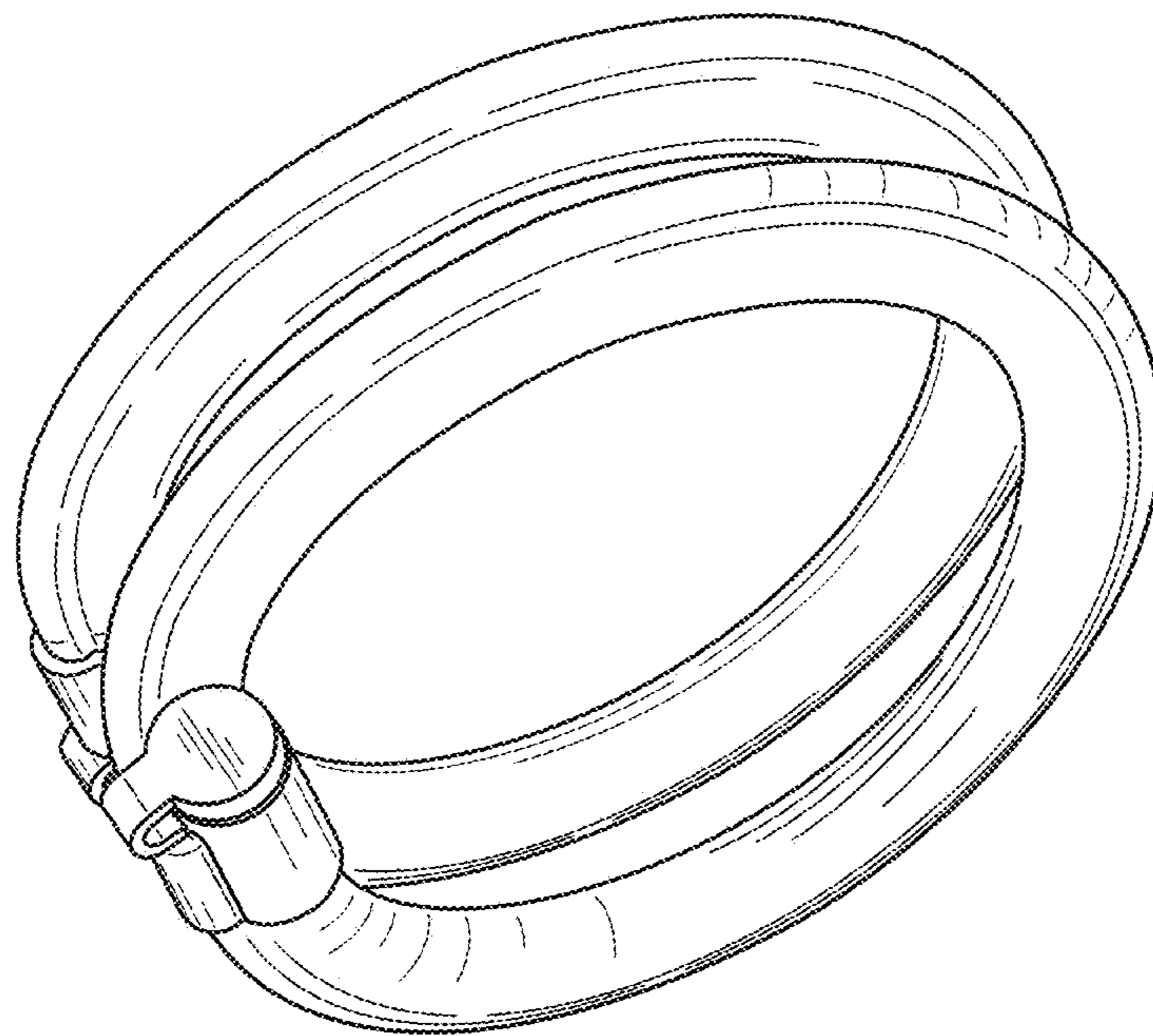

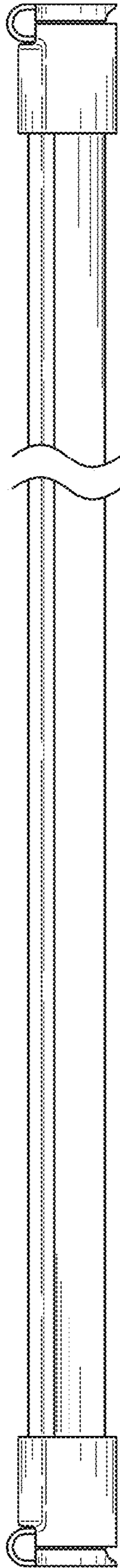

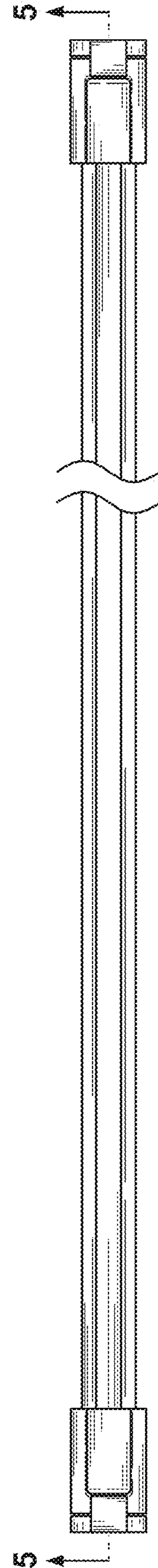

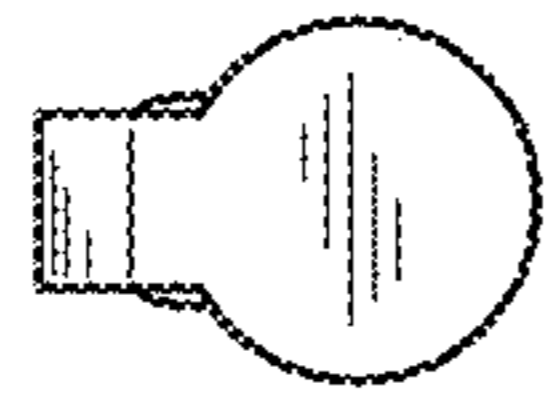

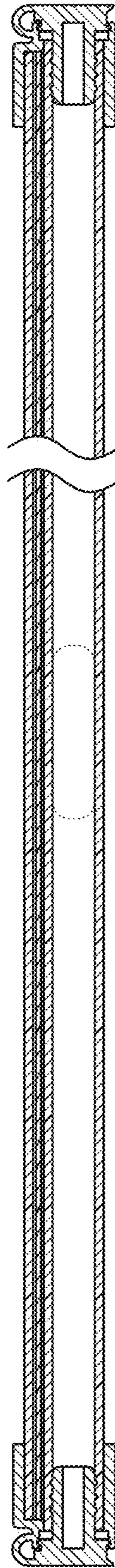
