(57) **CLAIM**

The ornamental design for a band assembly, as shown and described.

FIG. 1 is a front perspective view of a band assembly showing my new design.

FIG. 2 is a rear perspective view thereof.

FIG. 4 is a rear elevation view thereof.

FIG. 5 is a front perspective view of the band portion of the band assembly, shown separately to show aspects of the design that are not visible when combined.

FIG. 6 is a rear perspective view thereof.

FIG. 7 is a front elevation view thereof.

FIG. 8 is a rear elevation view thereof.

FIG. 9 is an end view of the band assembly of FIG. 1.

FIG. 10 is a side elevation view thereof.

FIG. 11 is an opposite side elevation view thereof.

FIG. 12 is an opposite end view thereof.

FIG. 13 is an end view of the band portion of the band assembly of FIG. 5.

FIG. 14 is a side elevation view thereof.

FIG. 15 is an opposite side elevation view thereof.

FIG. 16 is an opposite end view thereof.

FIG. 17 is a detailed view of the lug portion of the band assembly, taken from line 17 in FIG. 4, wherein the lug portion is shown separately to show aspects of the design that are not visible when combined.

FIG. 19 is an end view thereof.

FIG. 20 is a top side view thereof.

FIG. 21 is a side view thereof.

FIG. 22 is an opposite side view thereof.

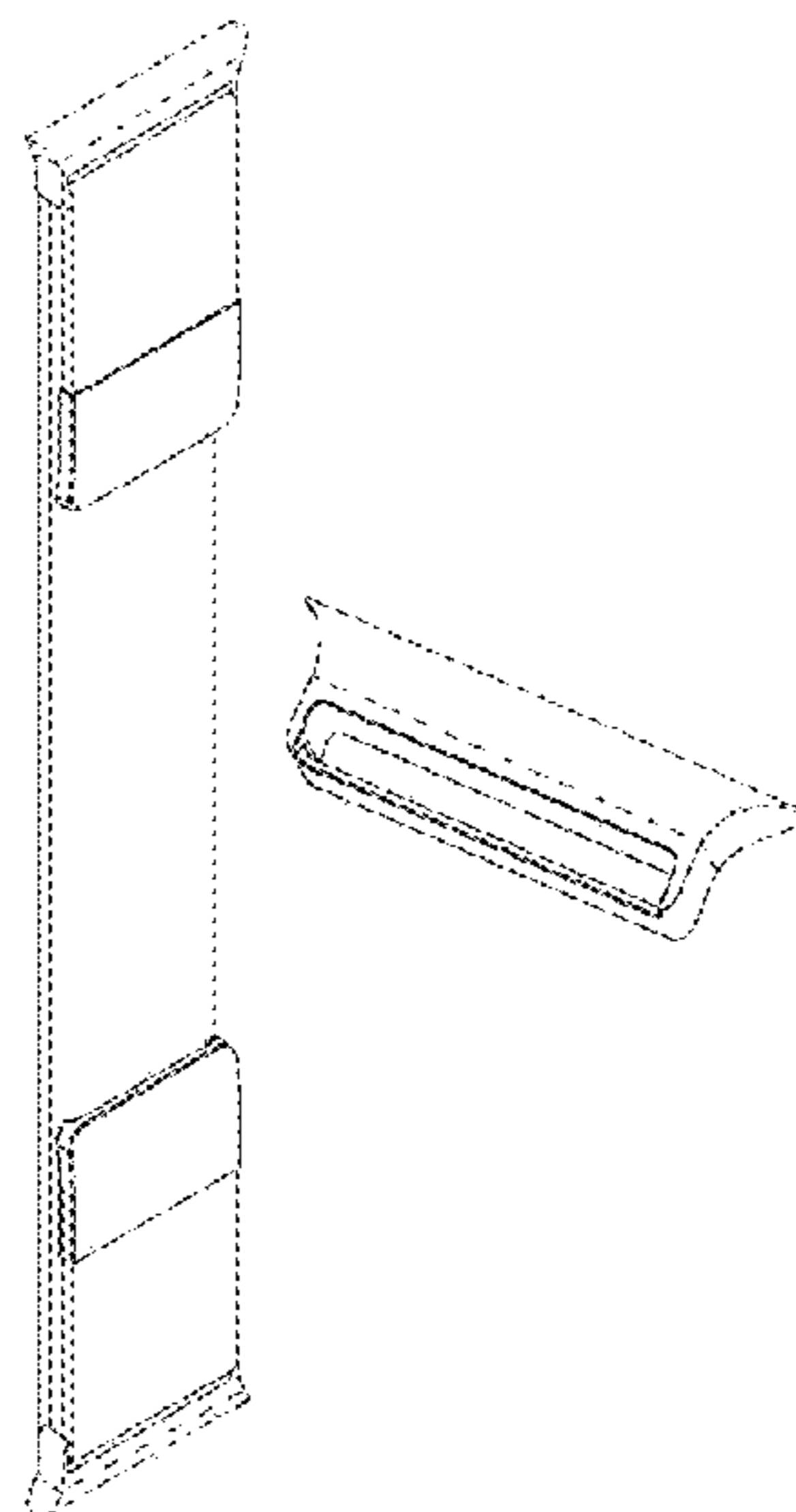
FIG. 23 is a bottom view thereof; and,

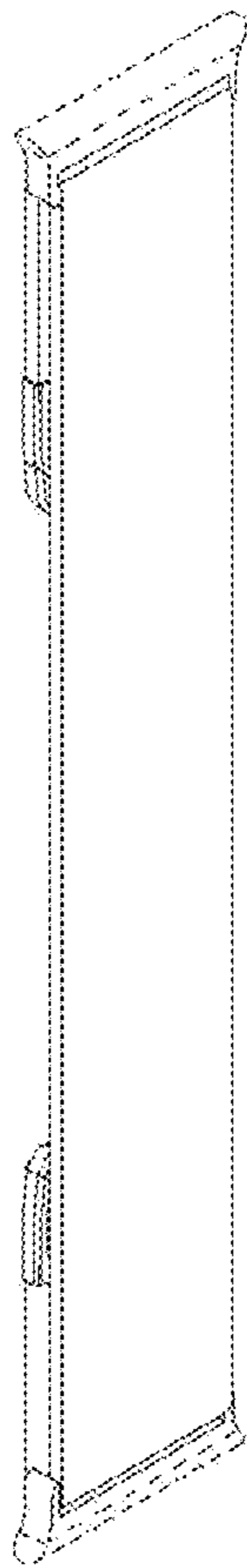

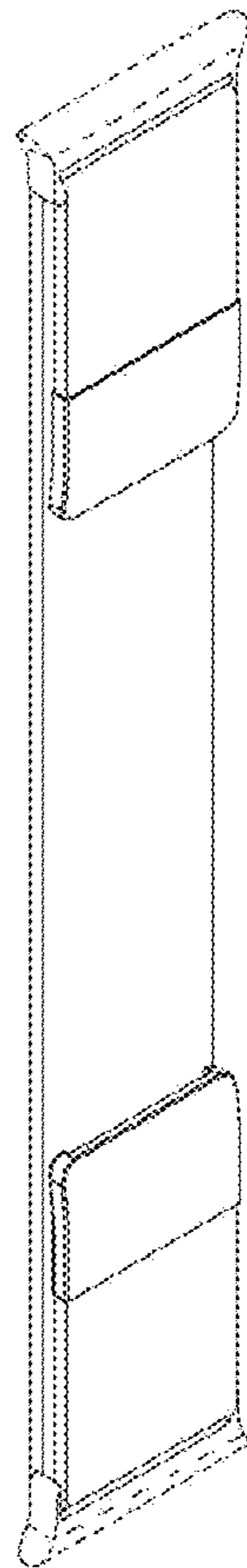

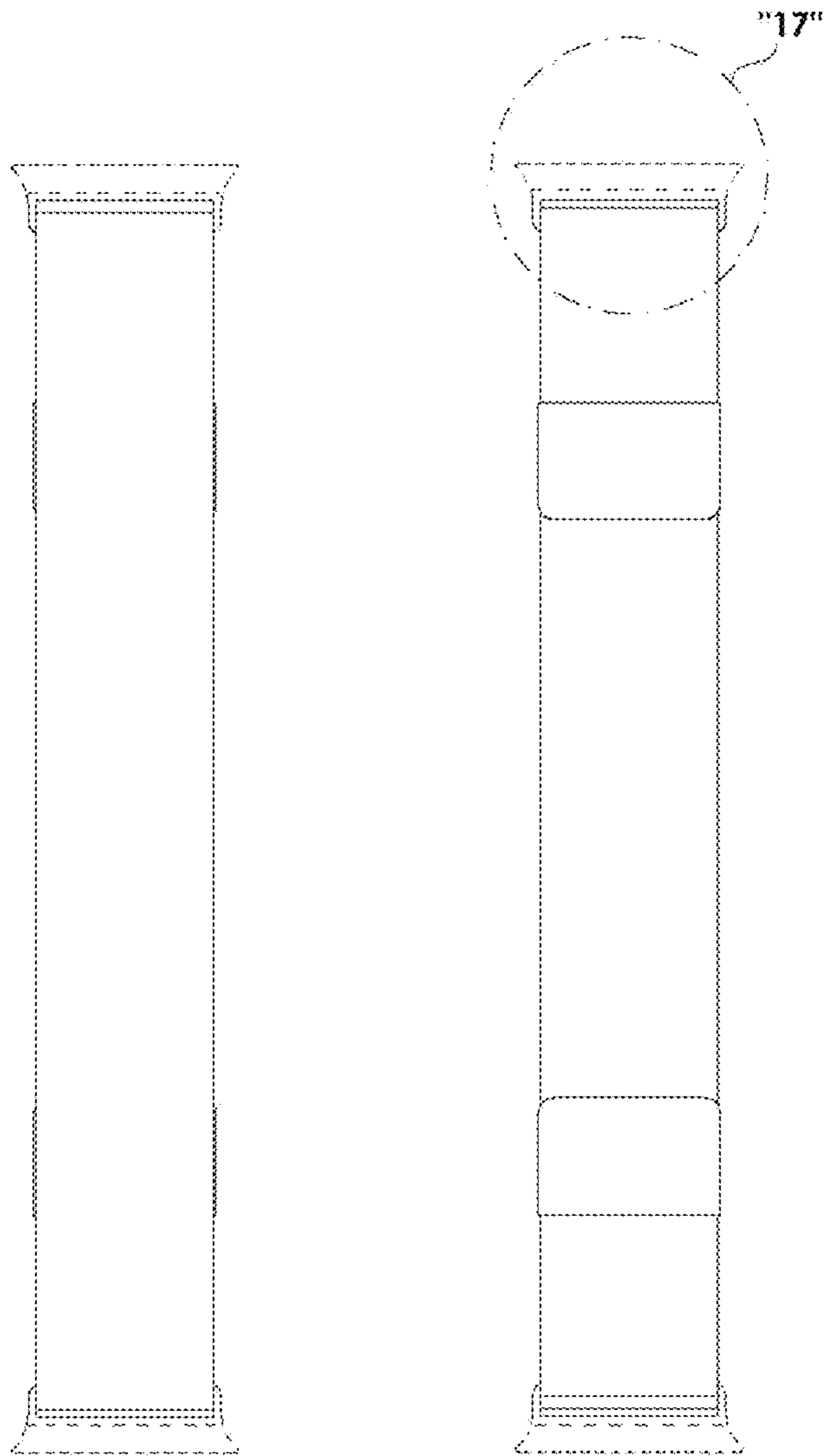

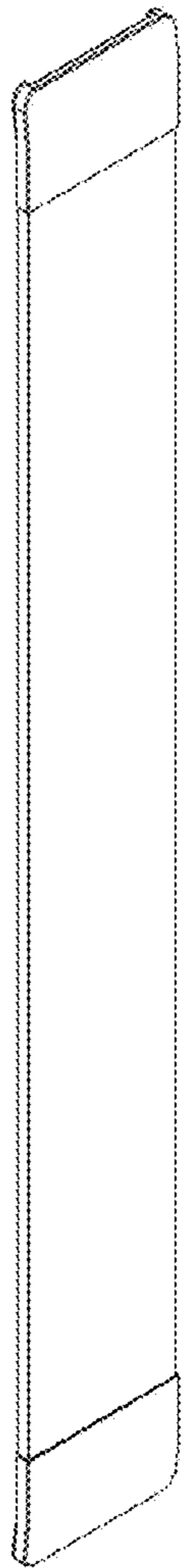

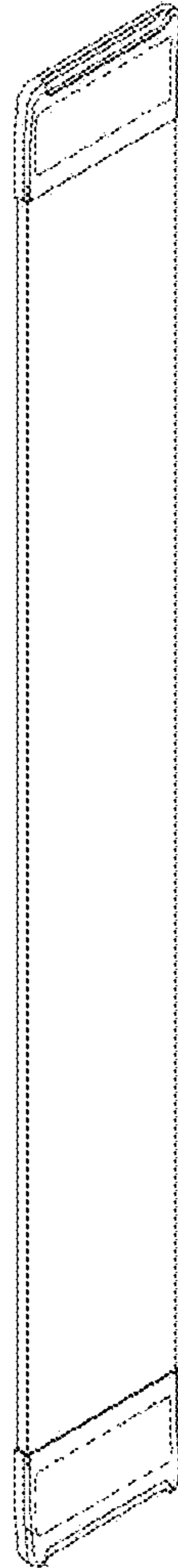

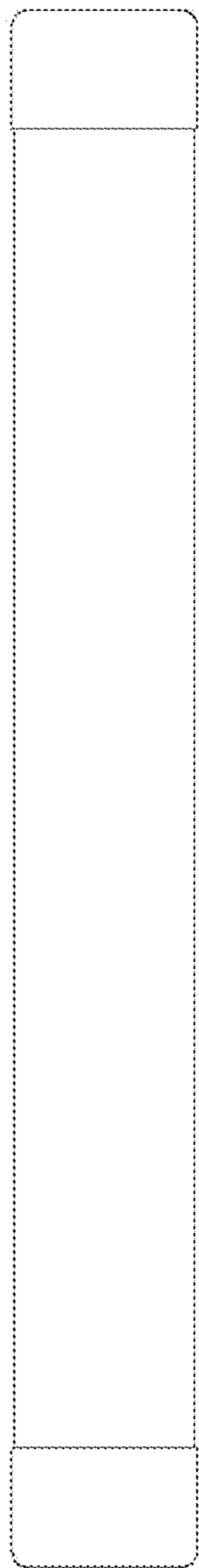

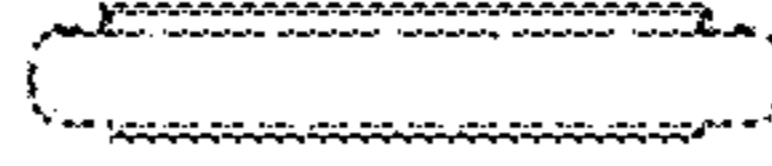

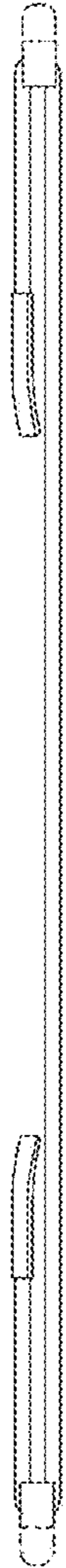

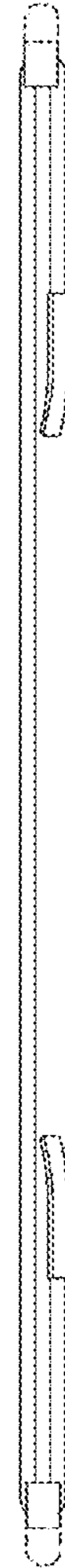

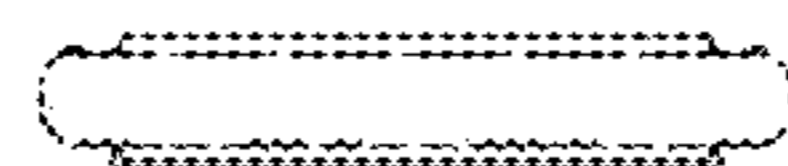

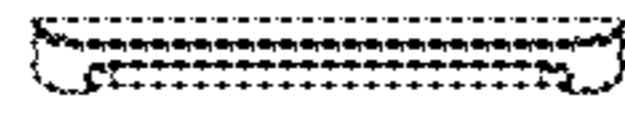

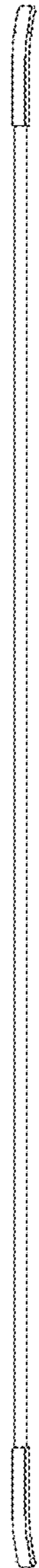

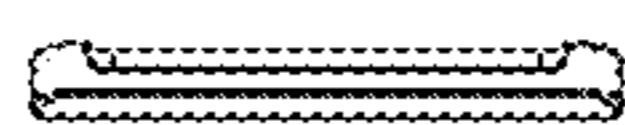

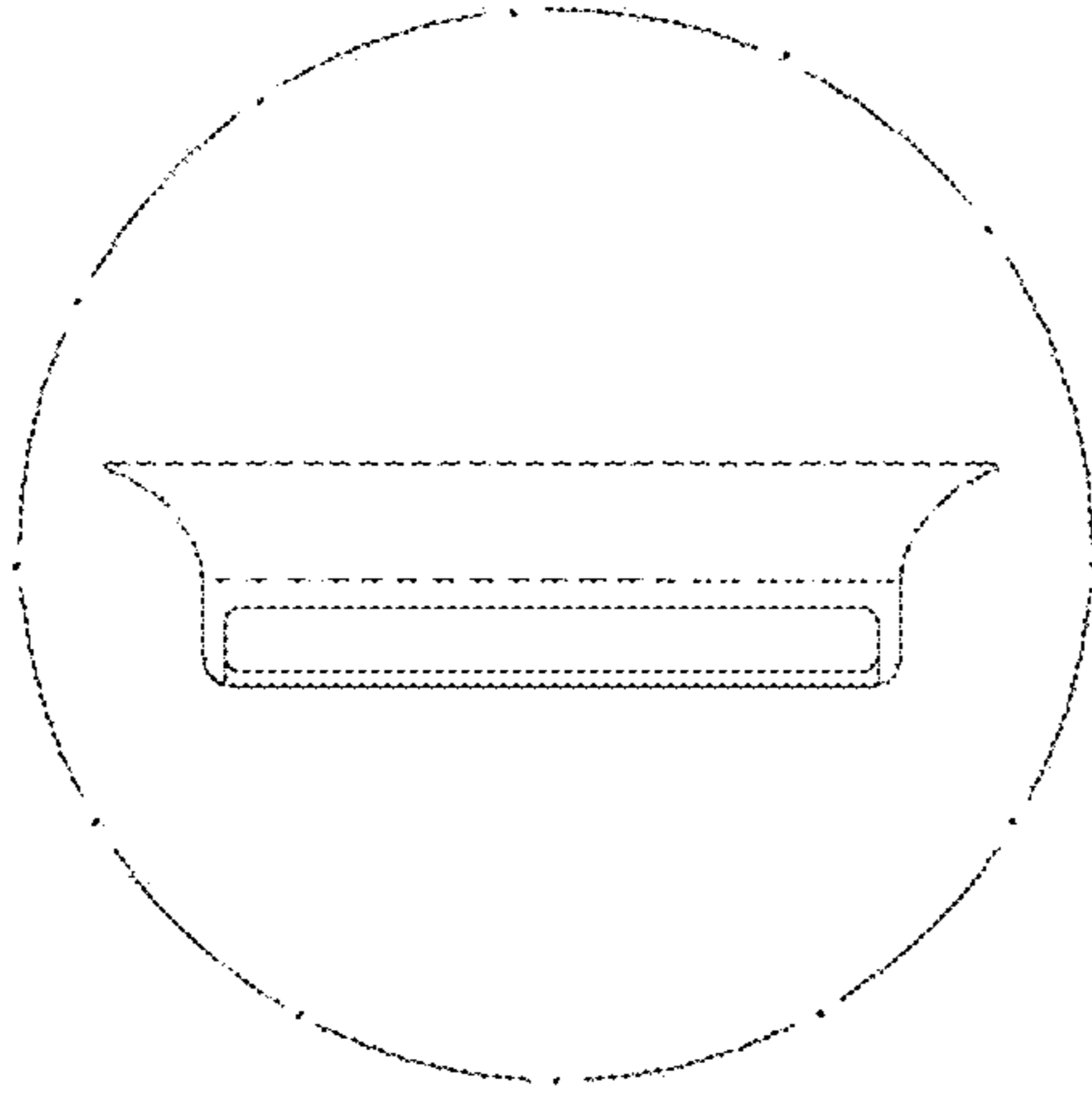

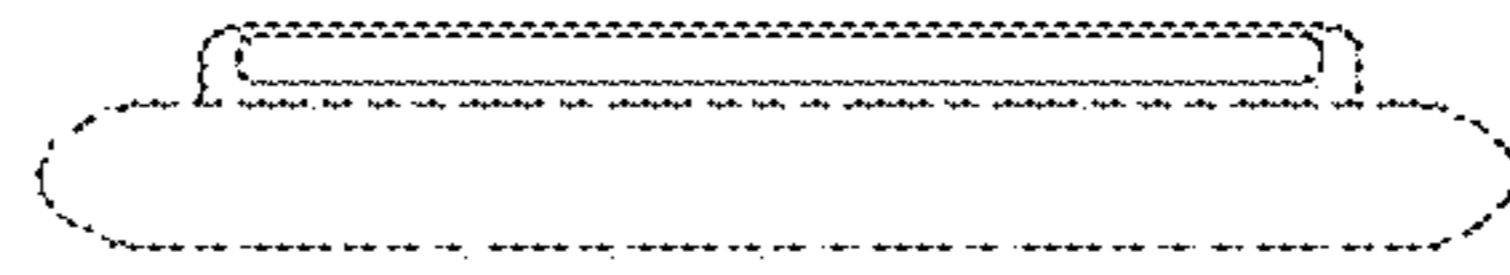

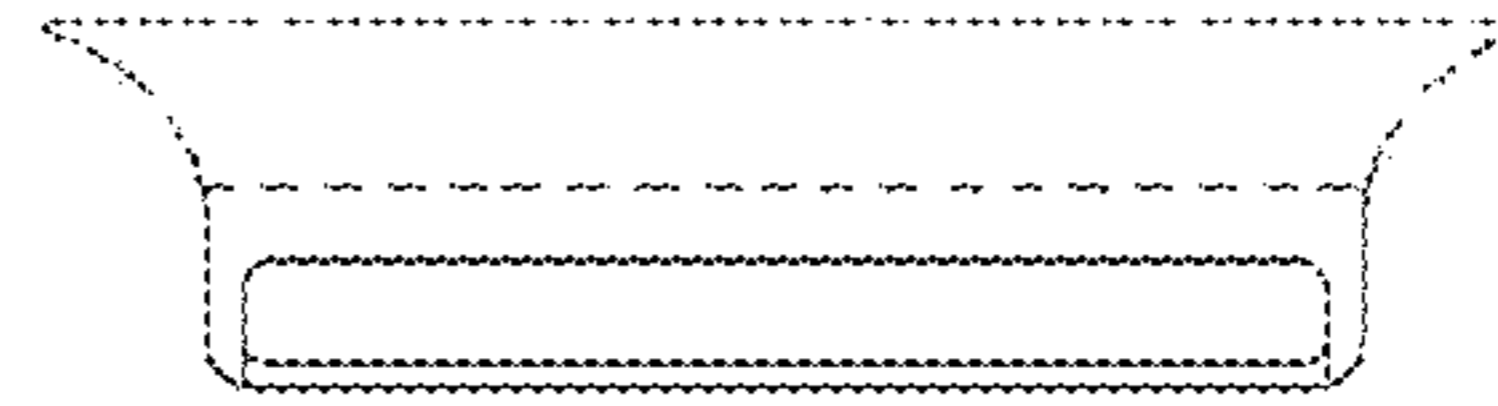

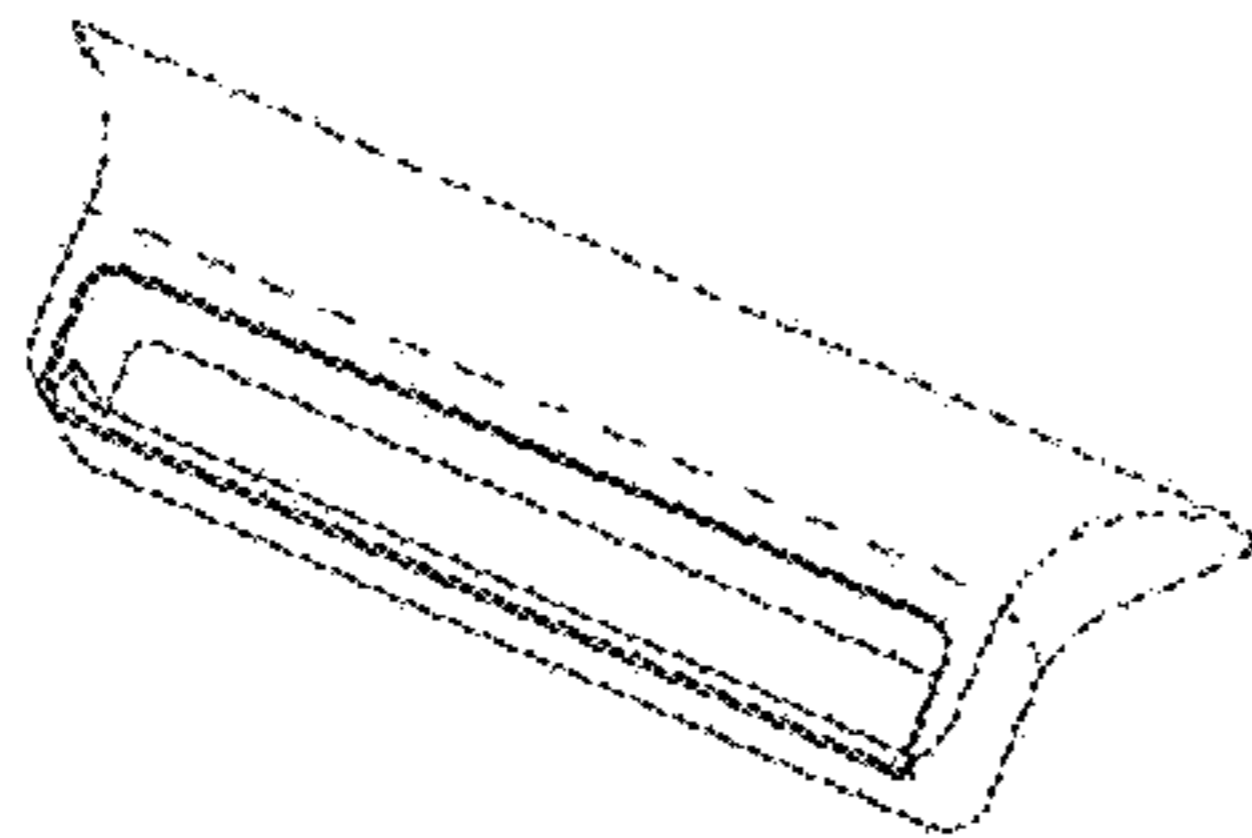

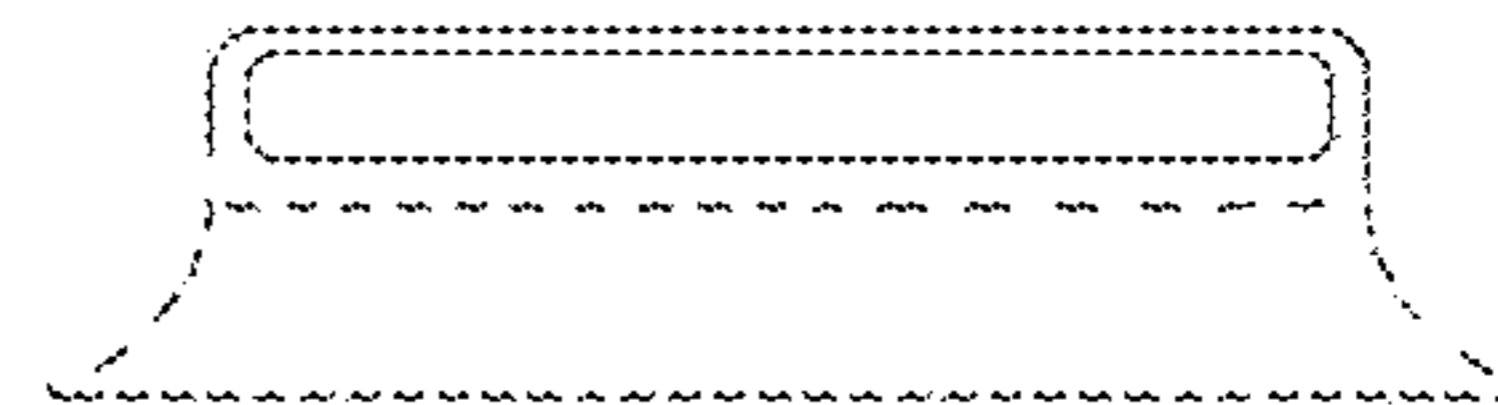

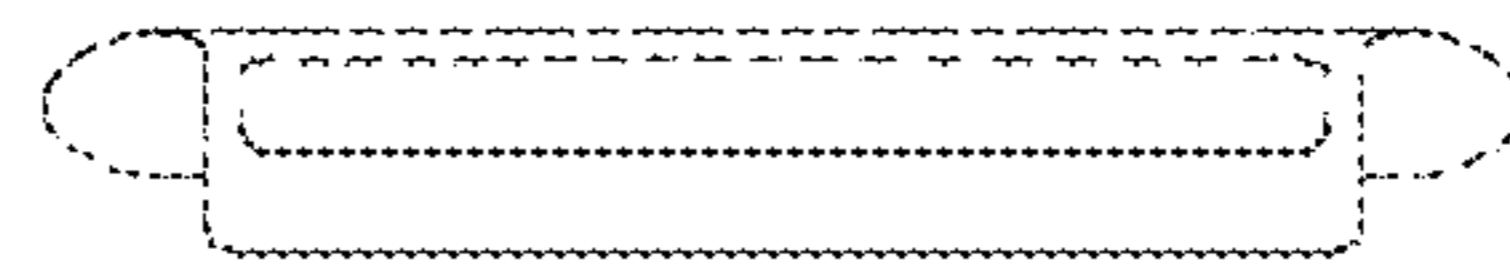

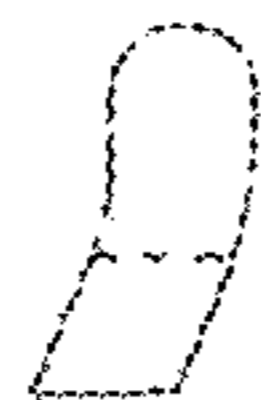

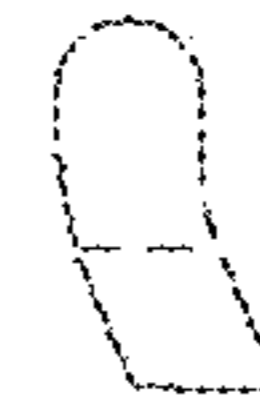
