(57) **CLAIM**

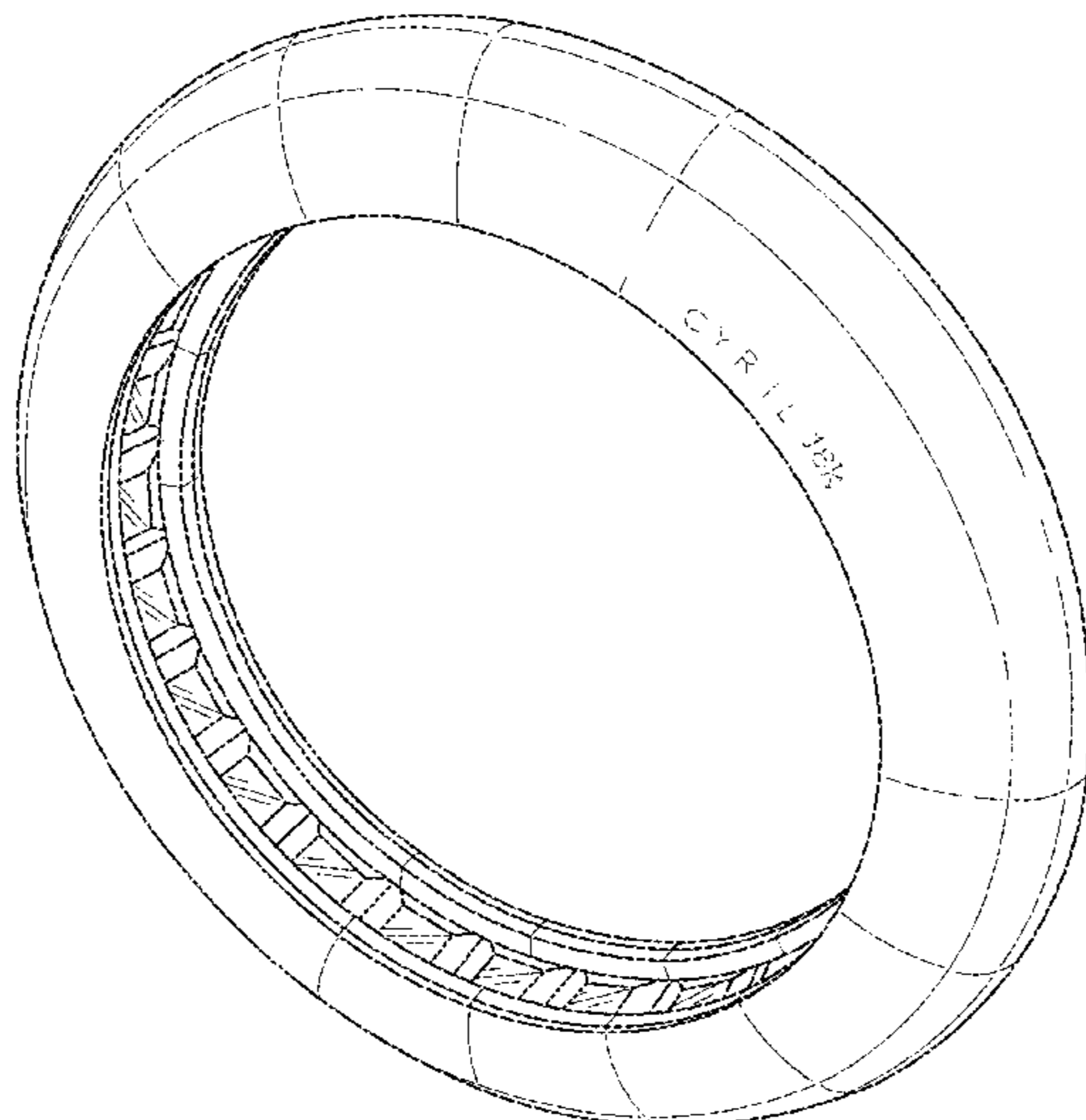
The ornamental design for a jewelry band, as shown and described.

DESCRIPTION

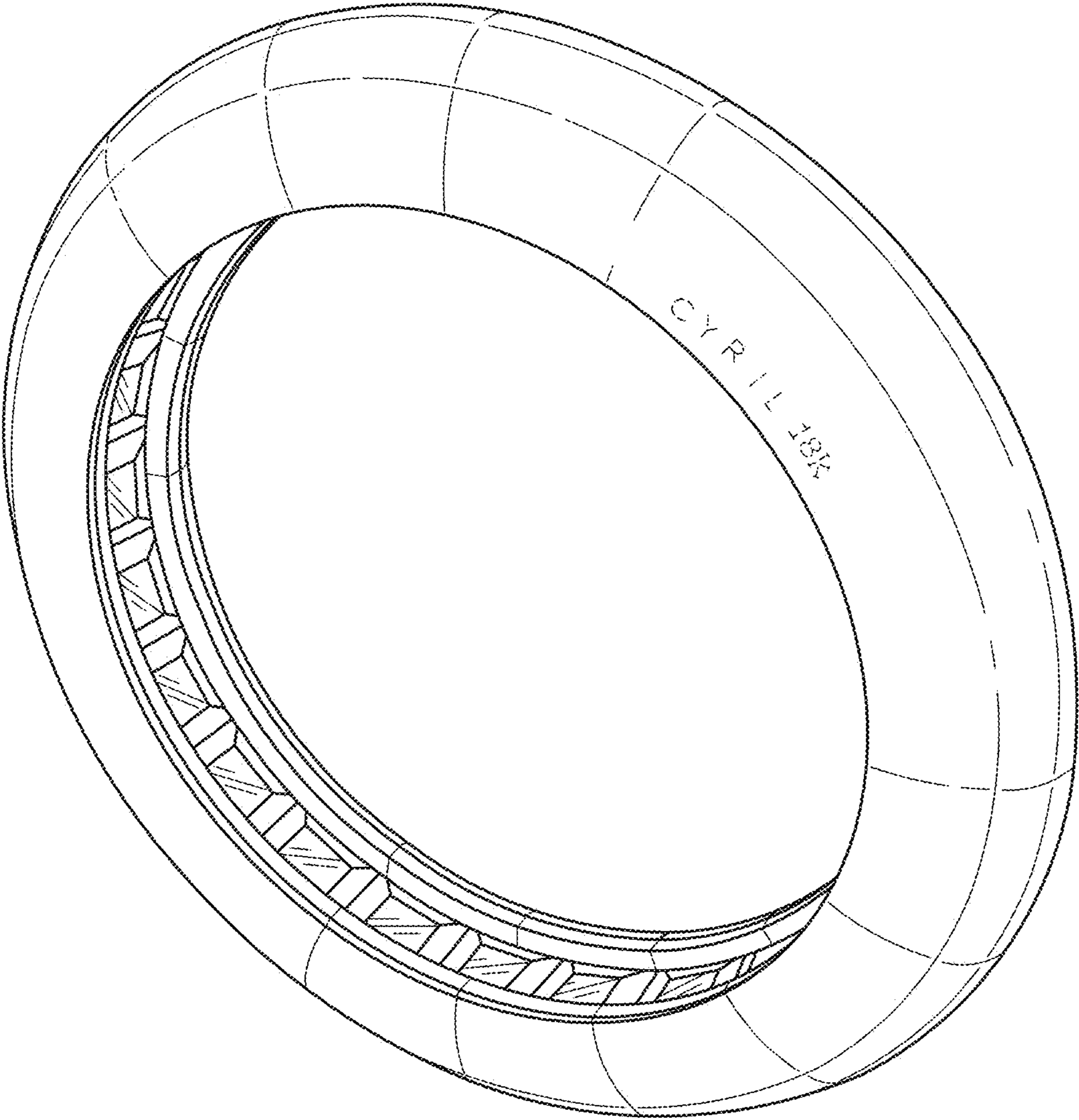

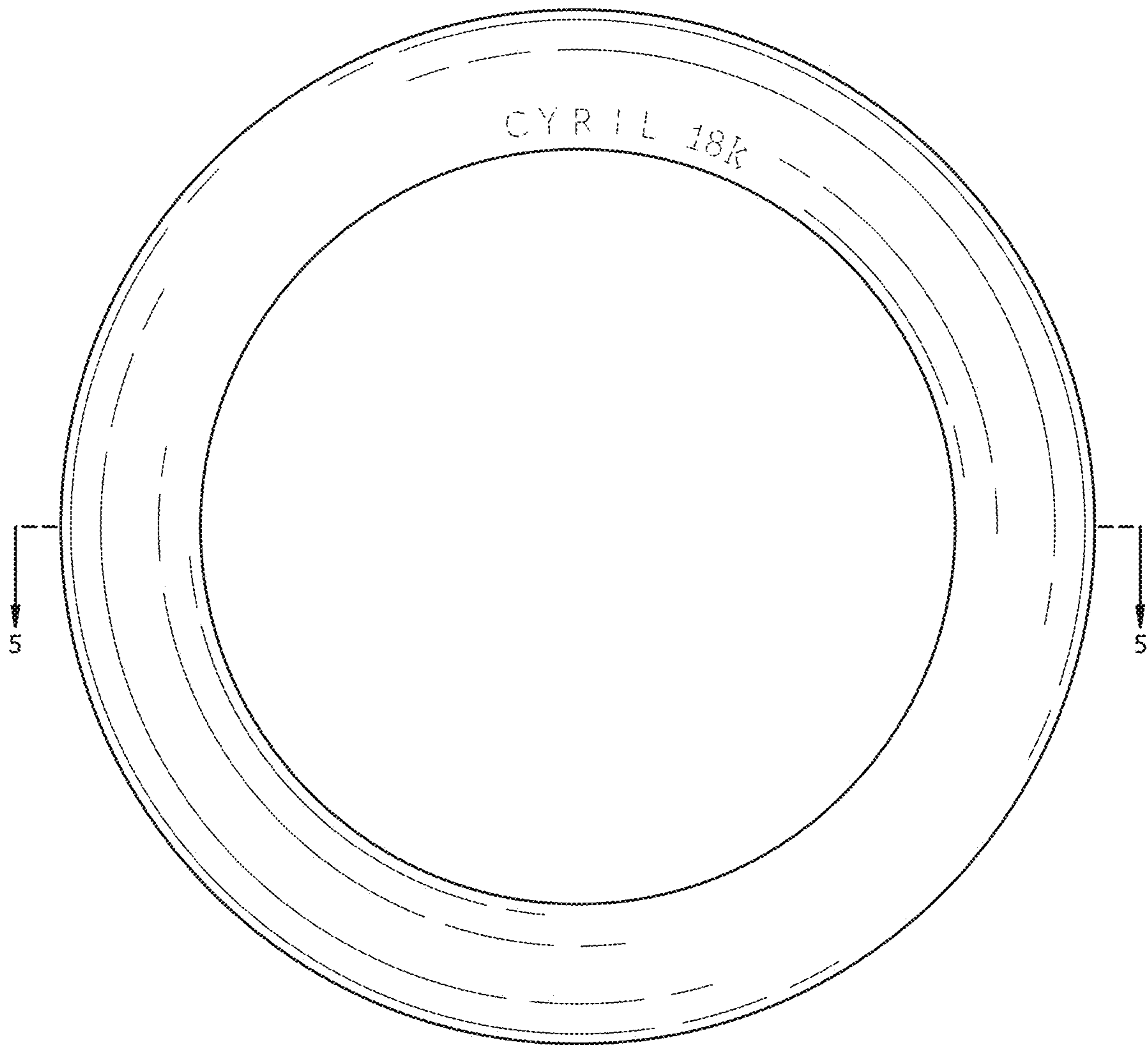

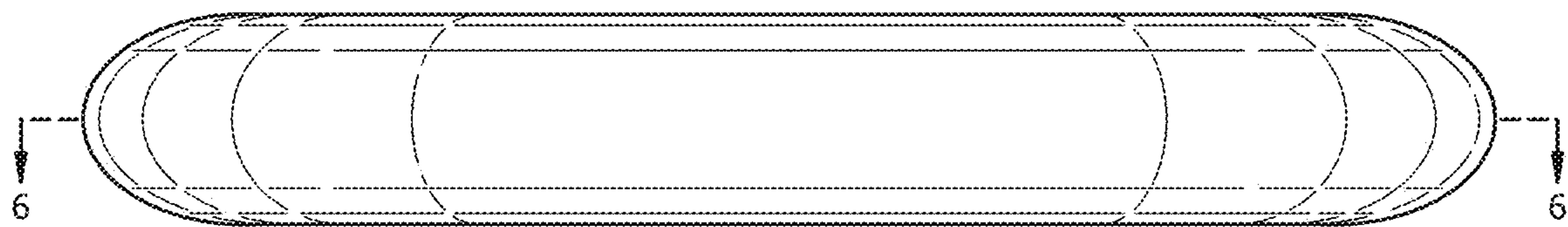

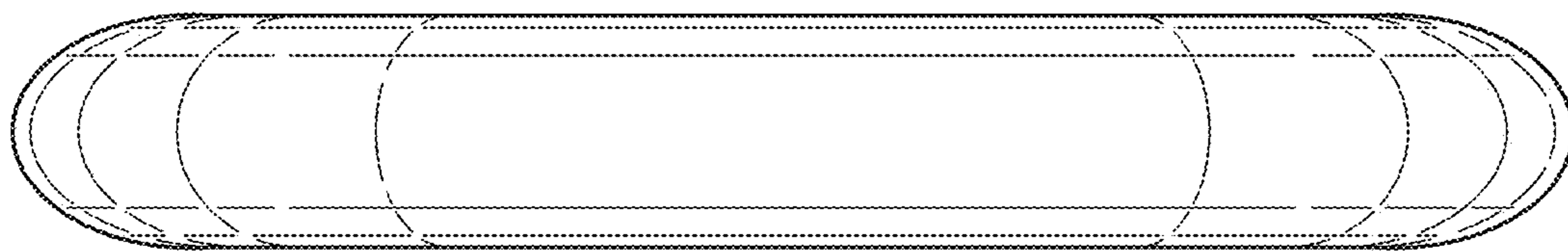

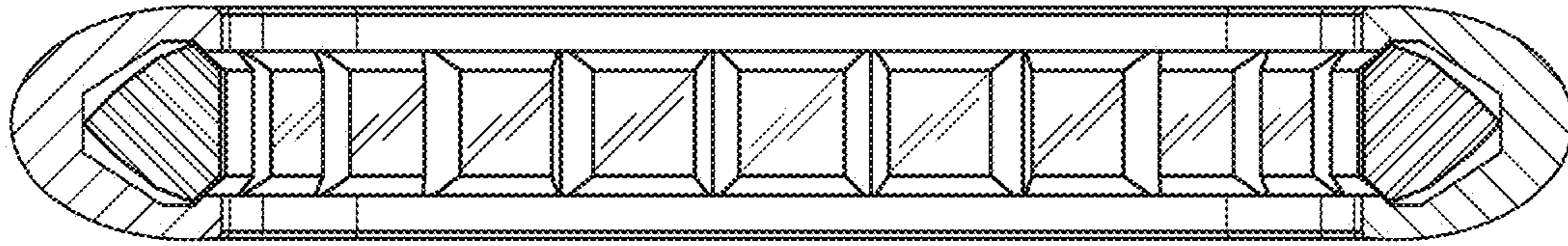

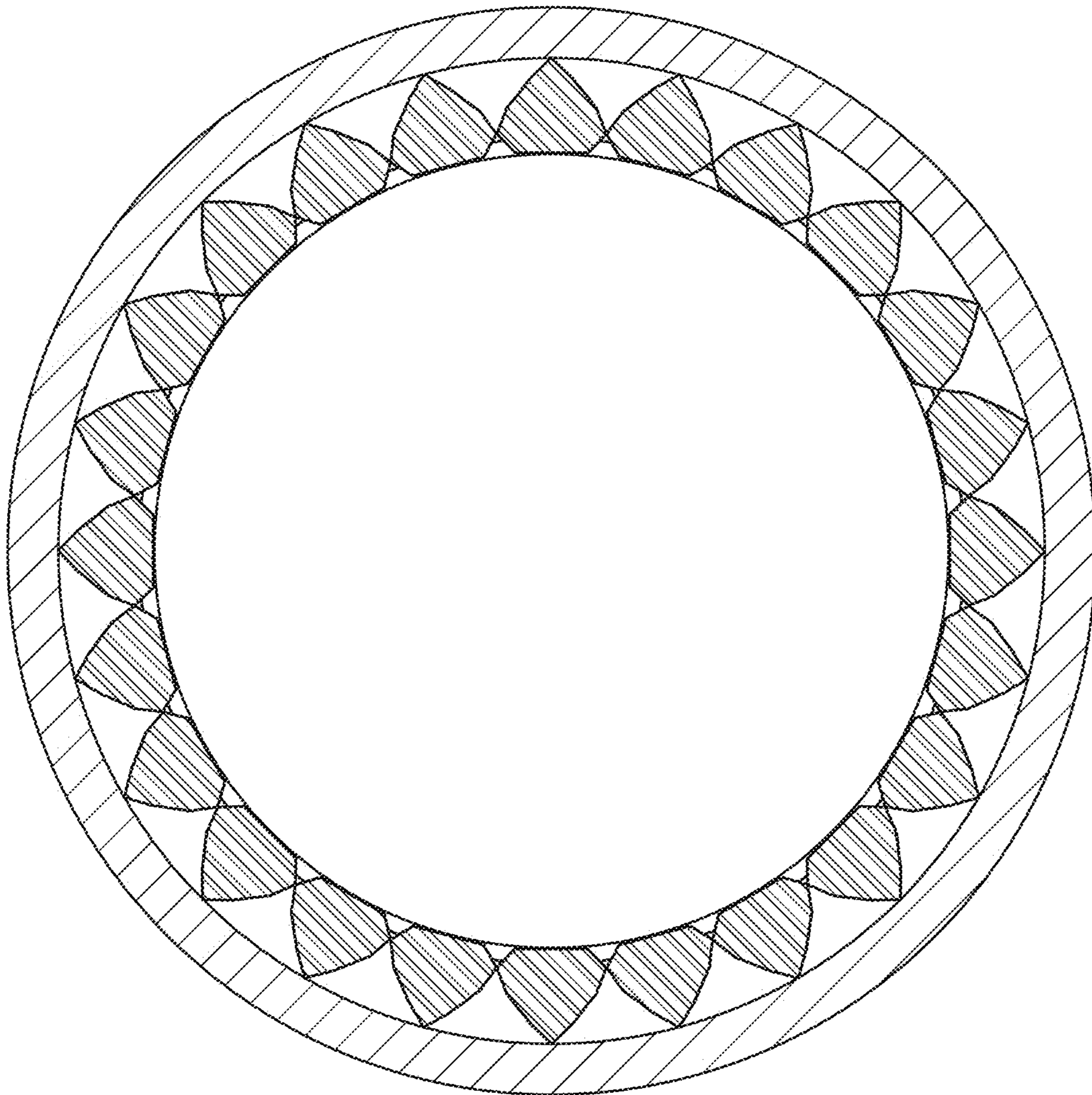

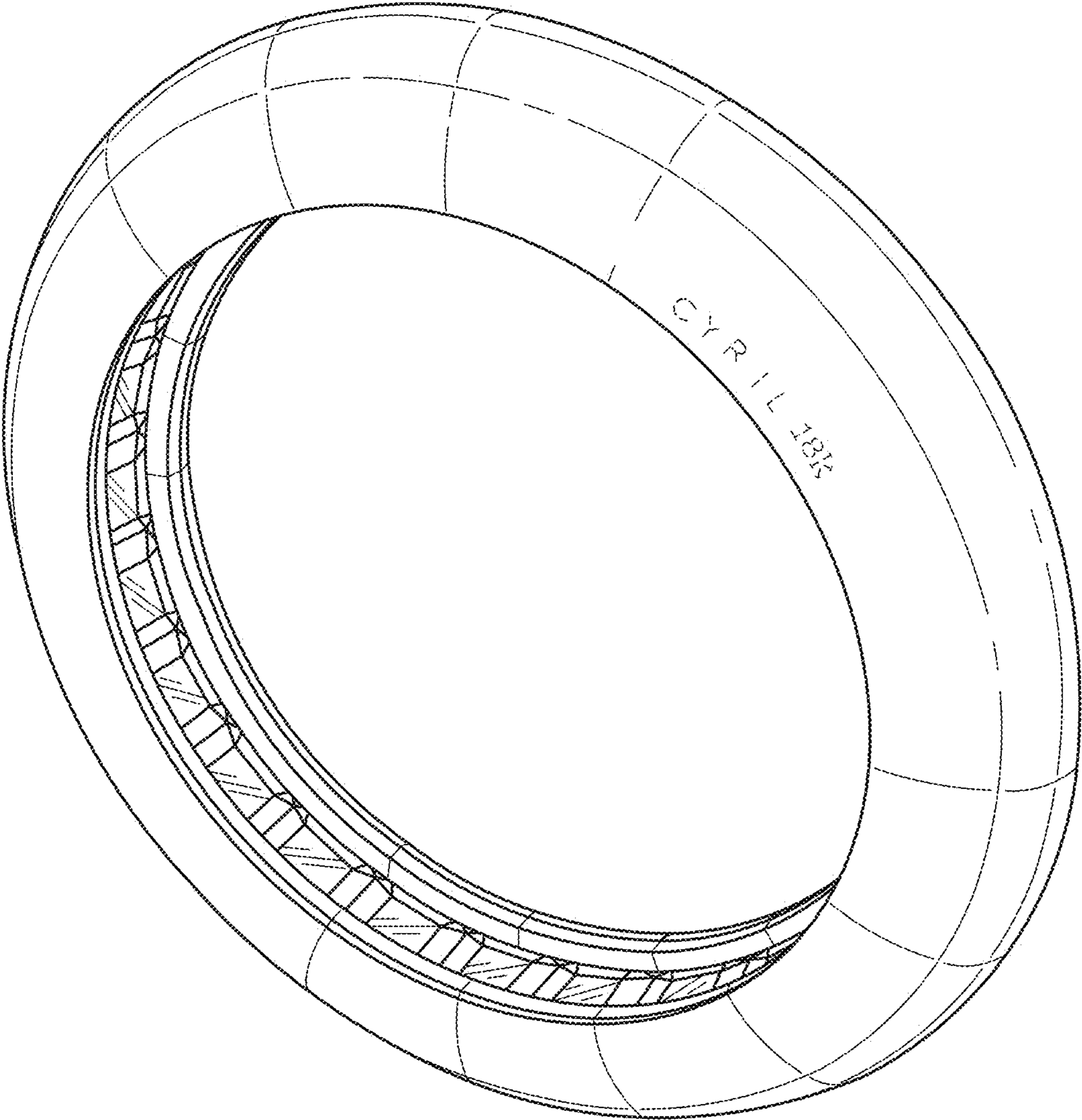

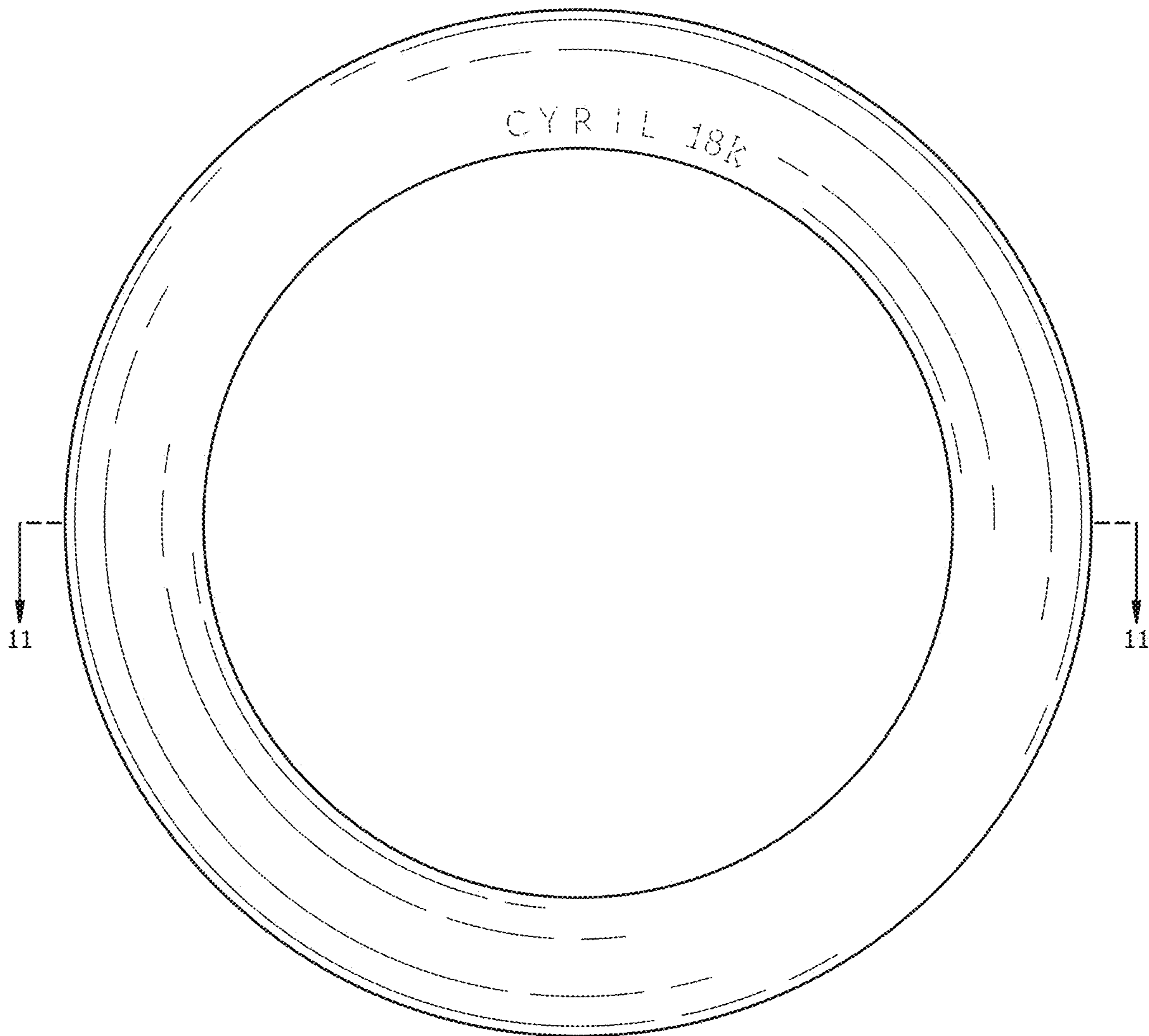

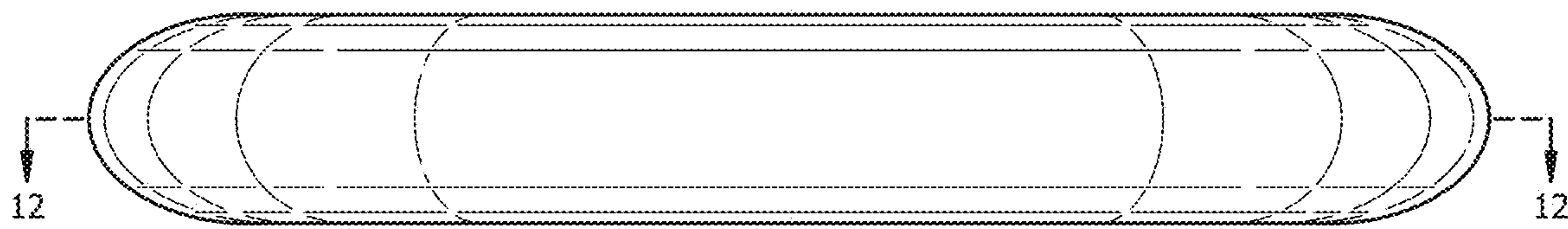

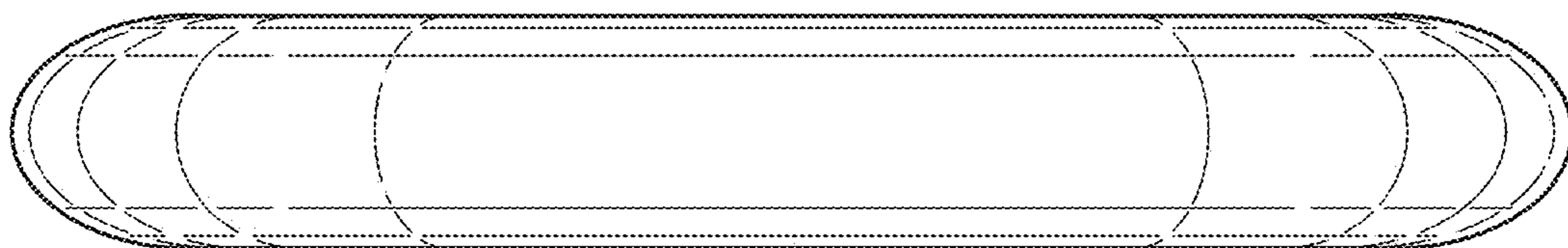

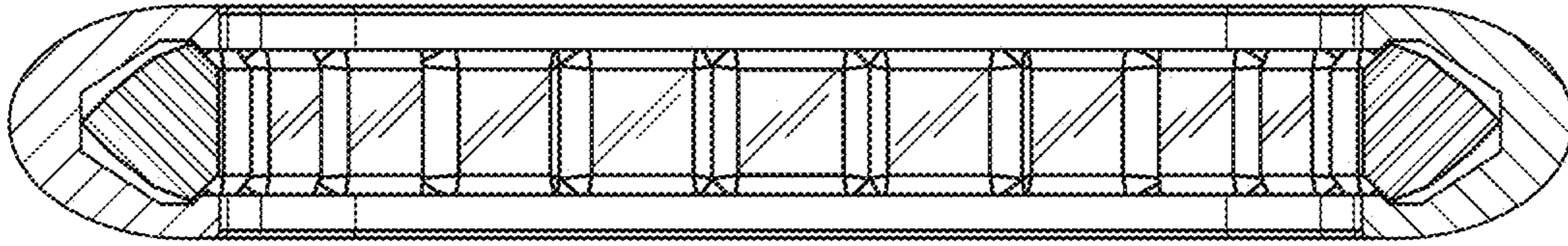

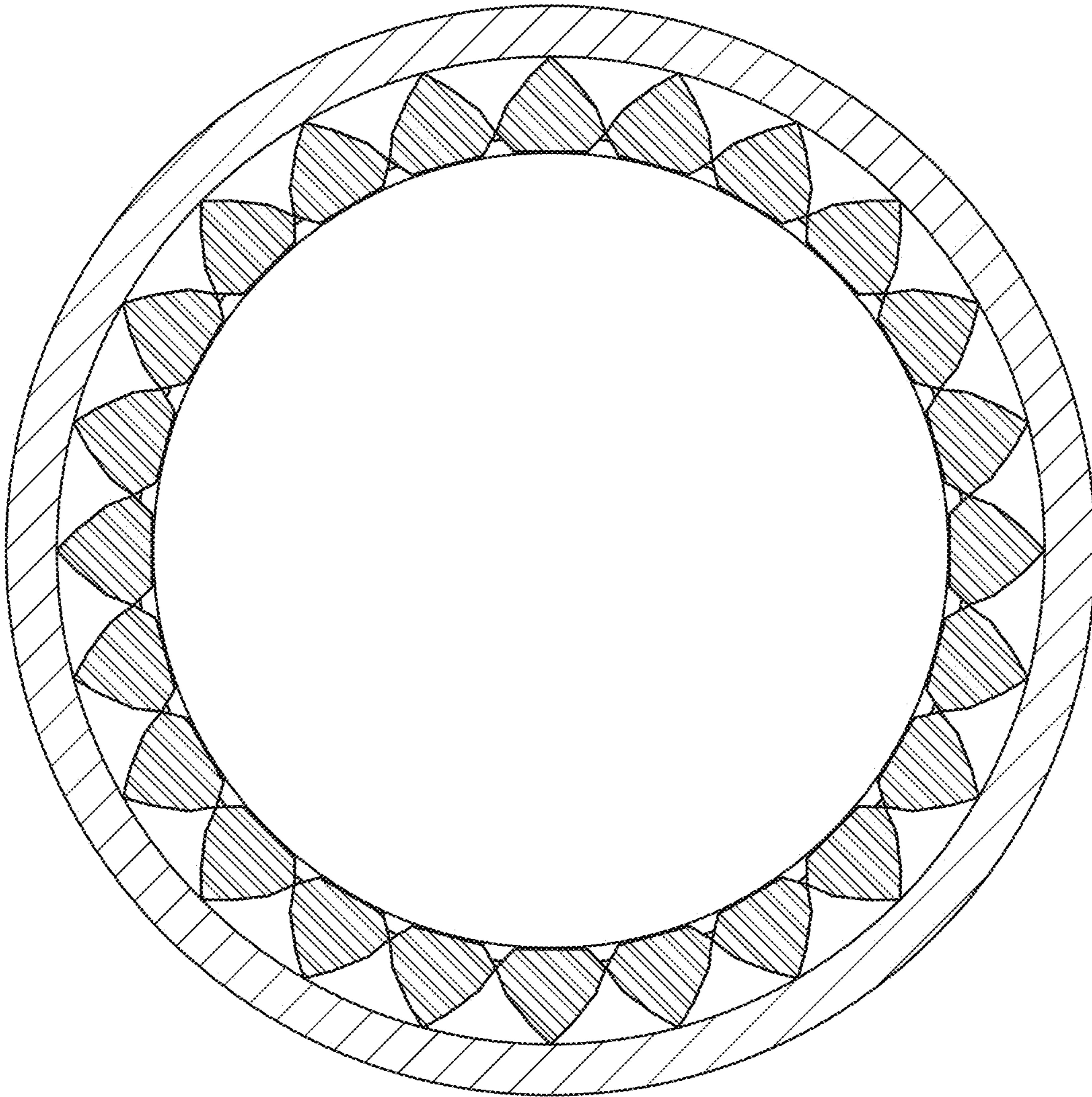

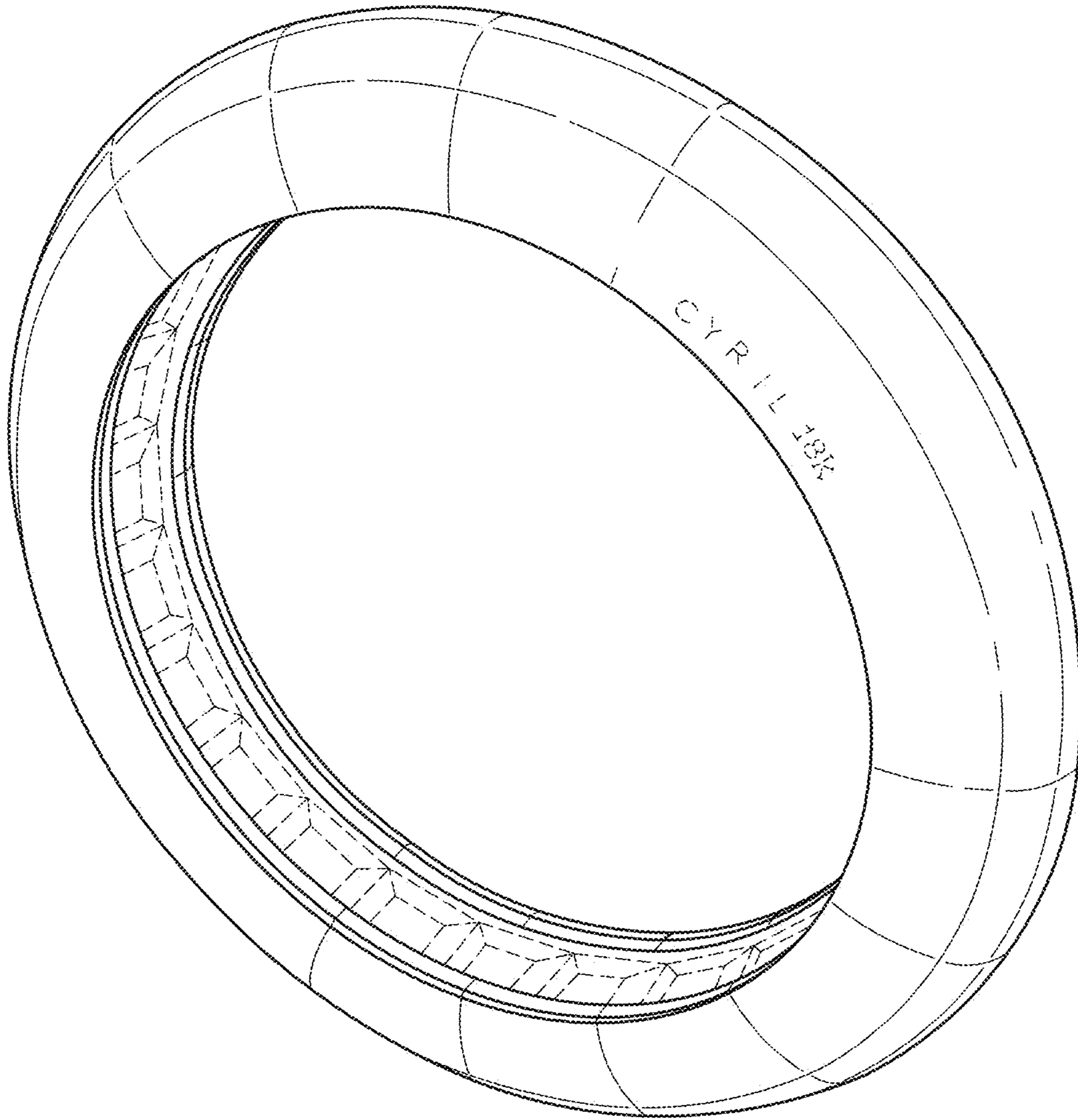

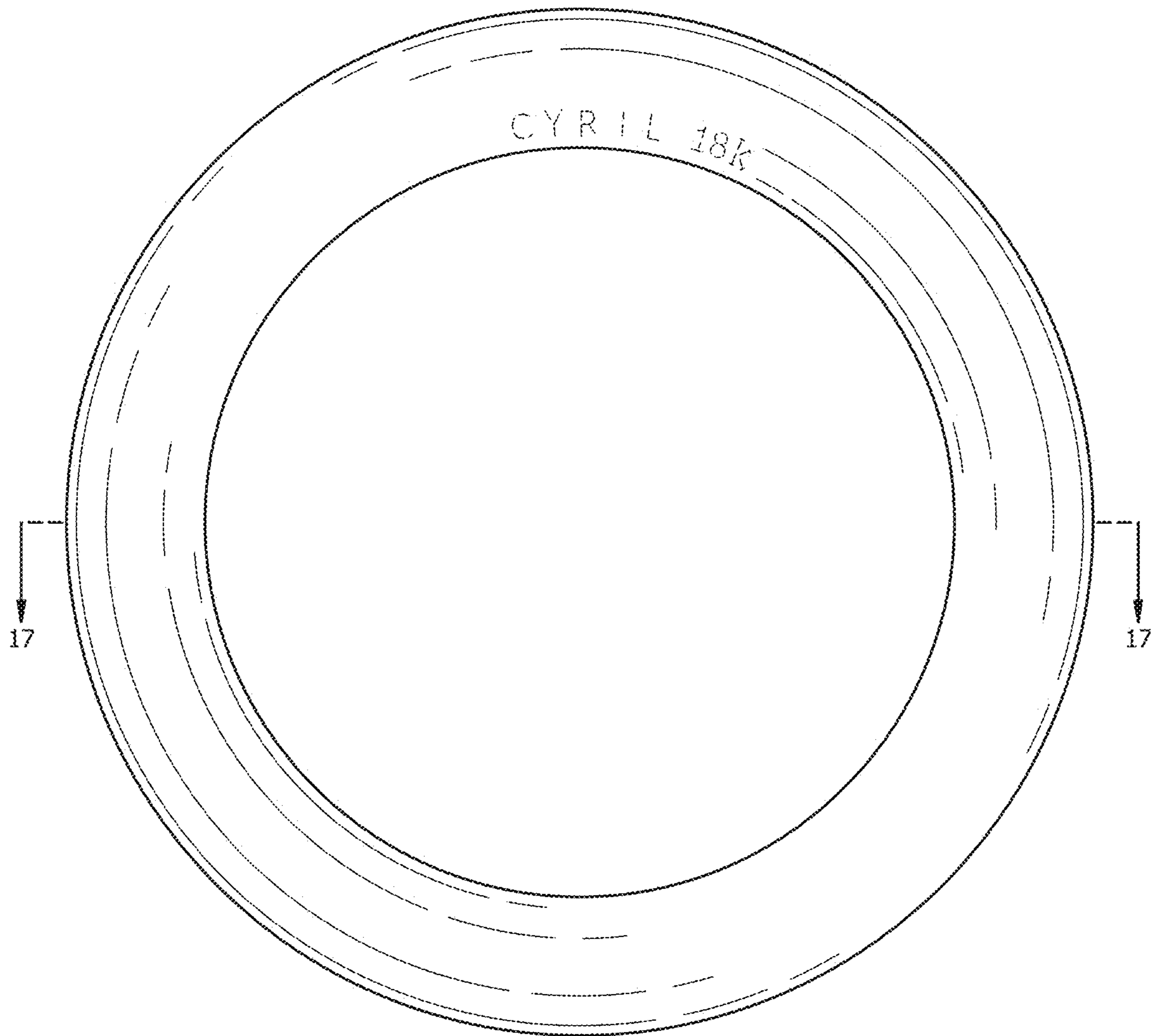

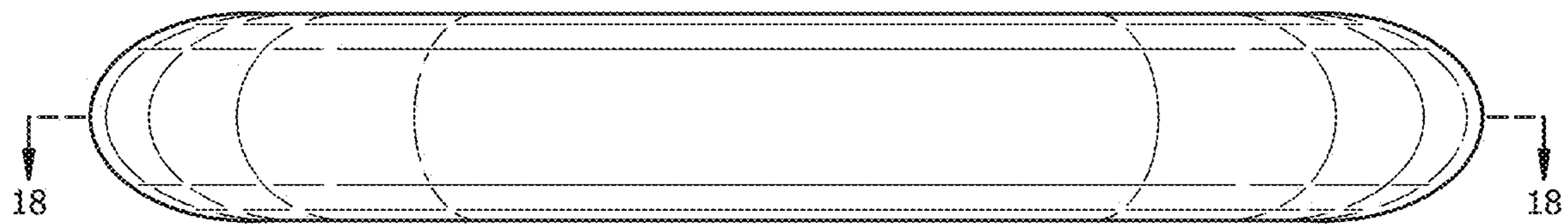

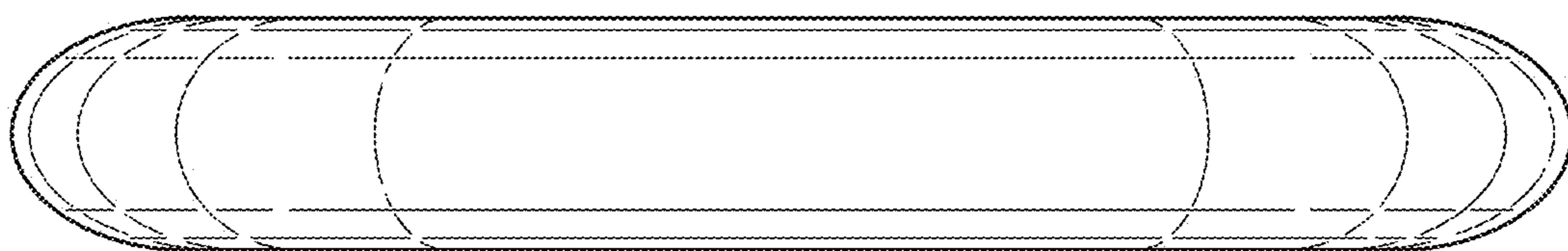

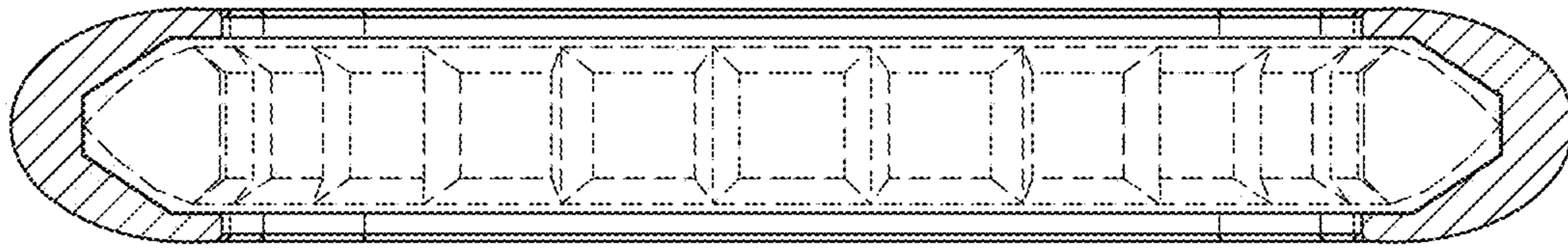

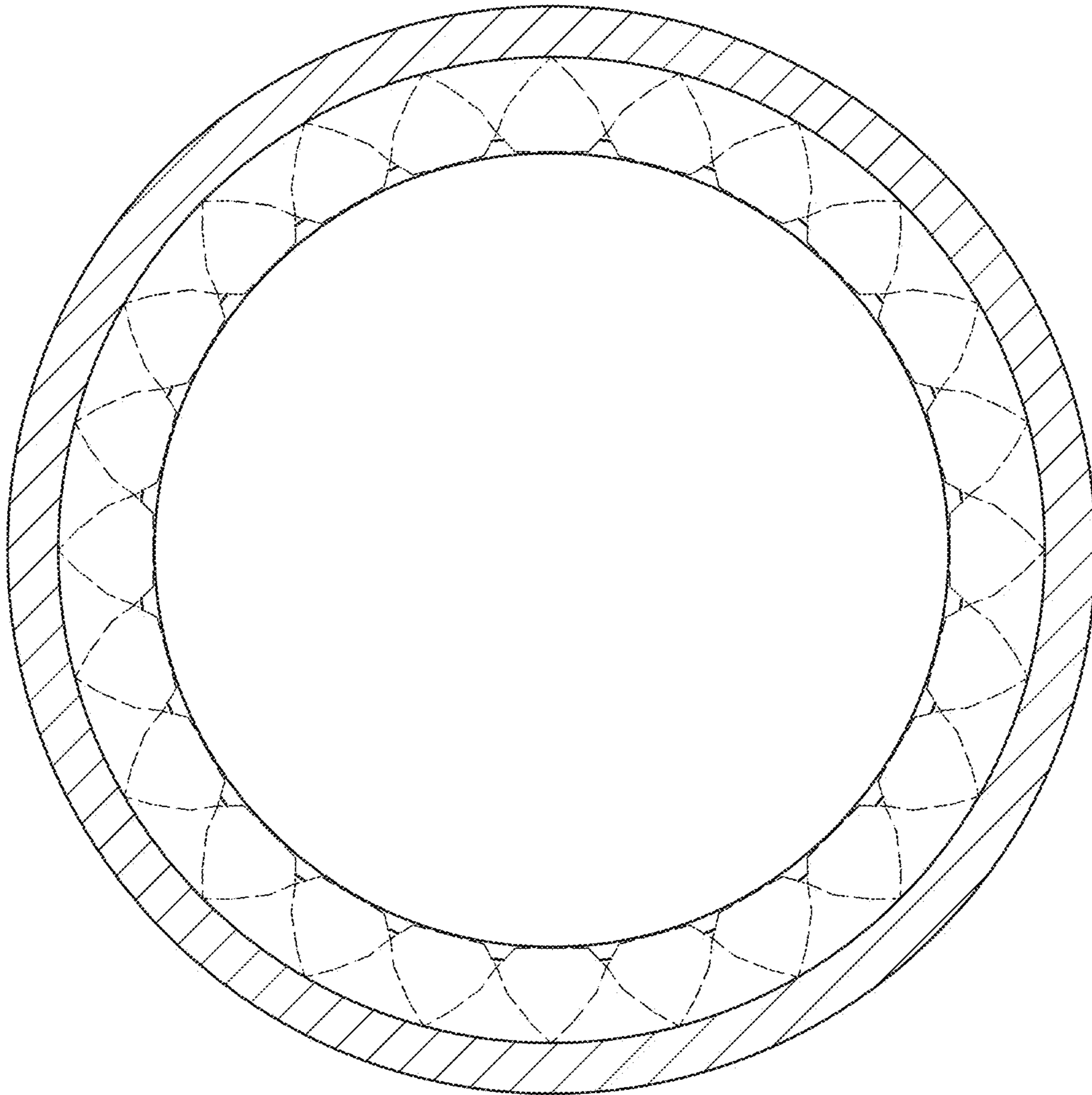
