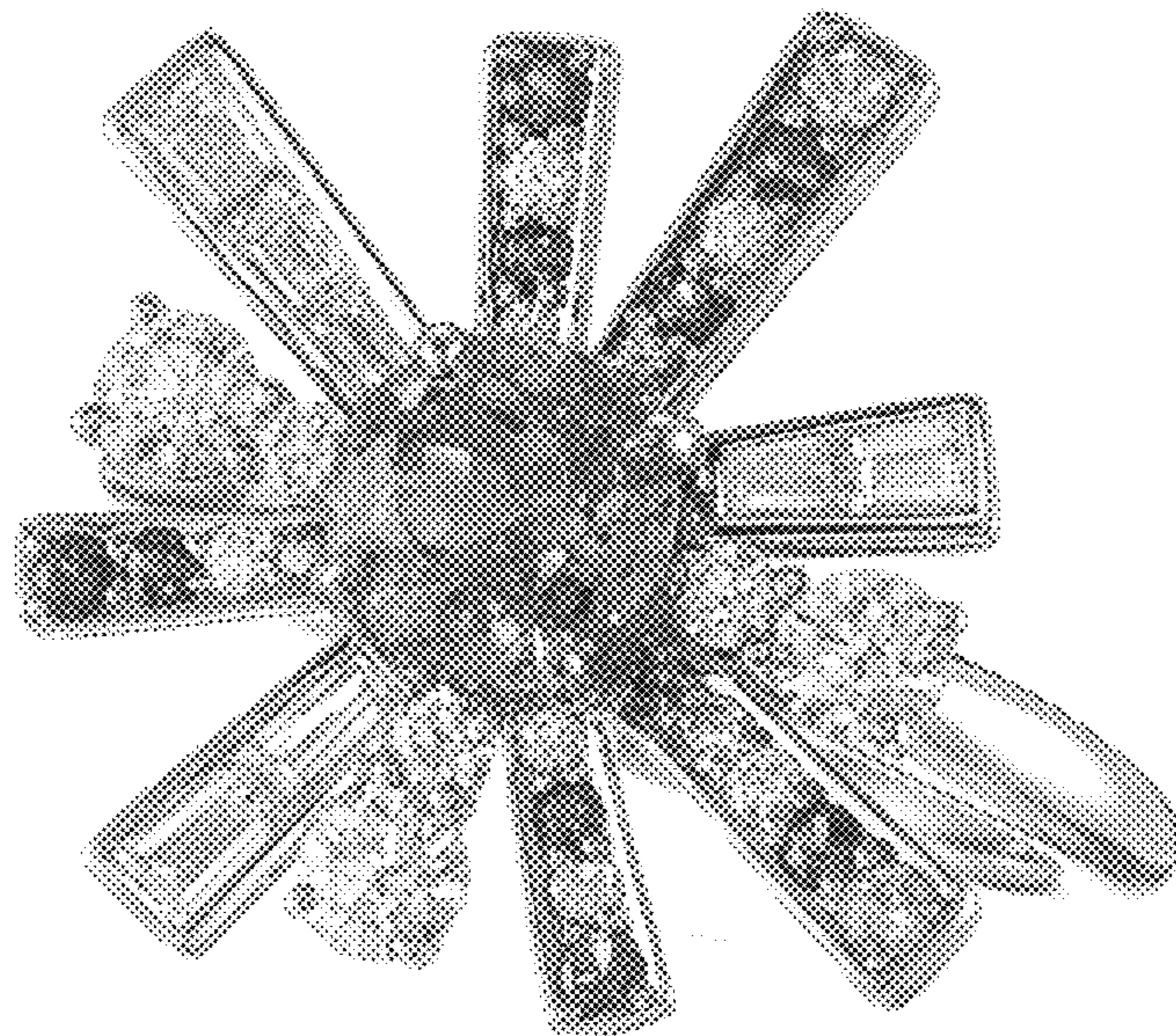

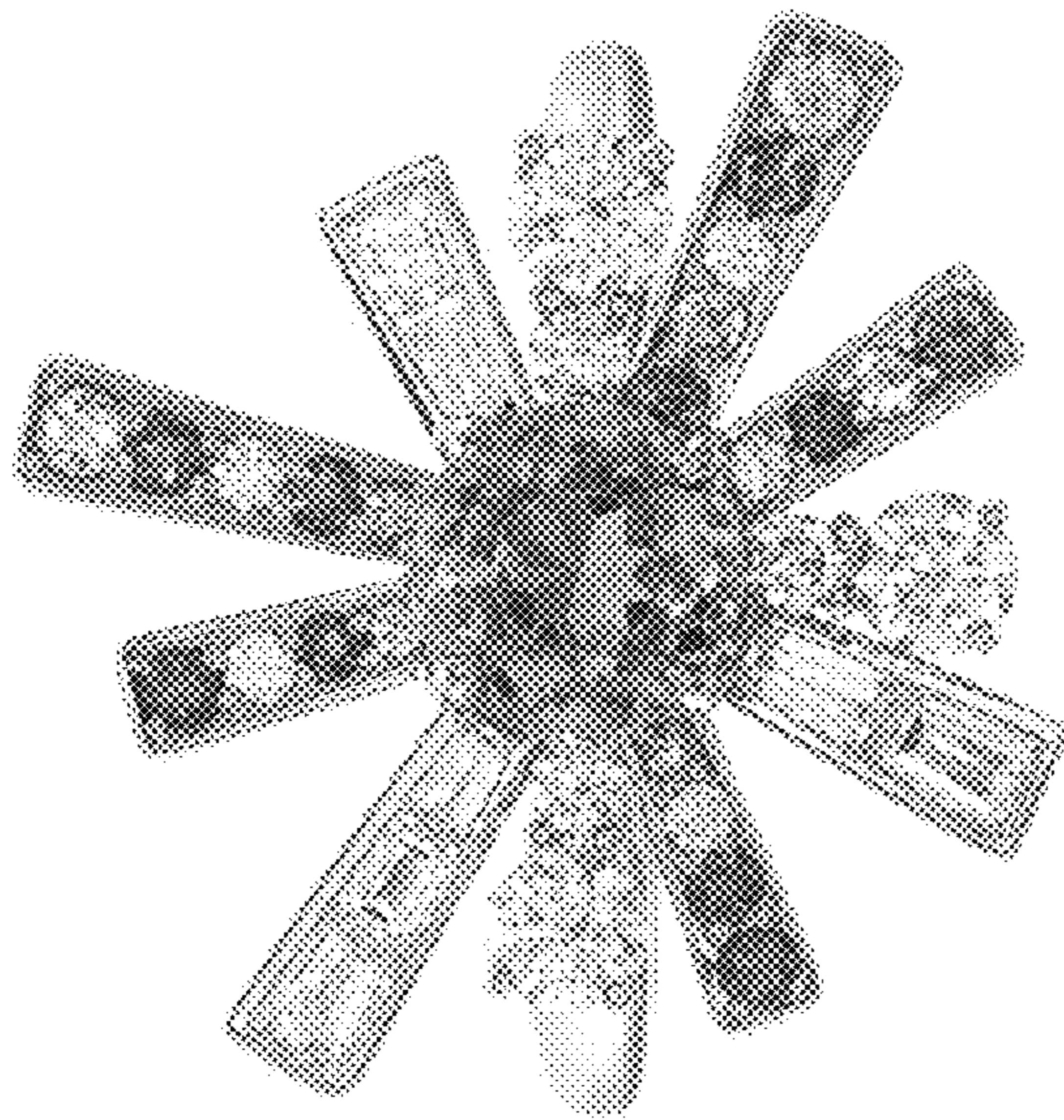
The ornamental design for a ring, as shown and described.

**DESCRIPTION**

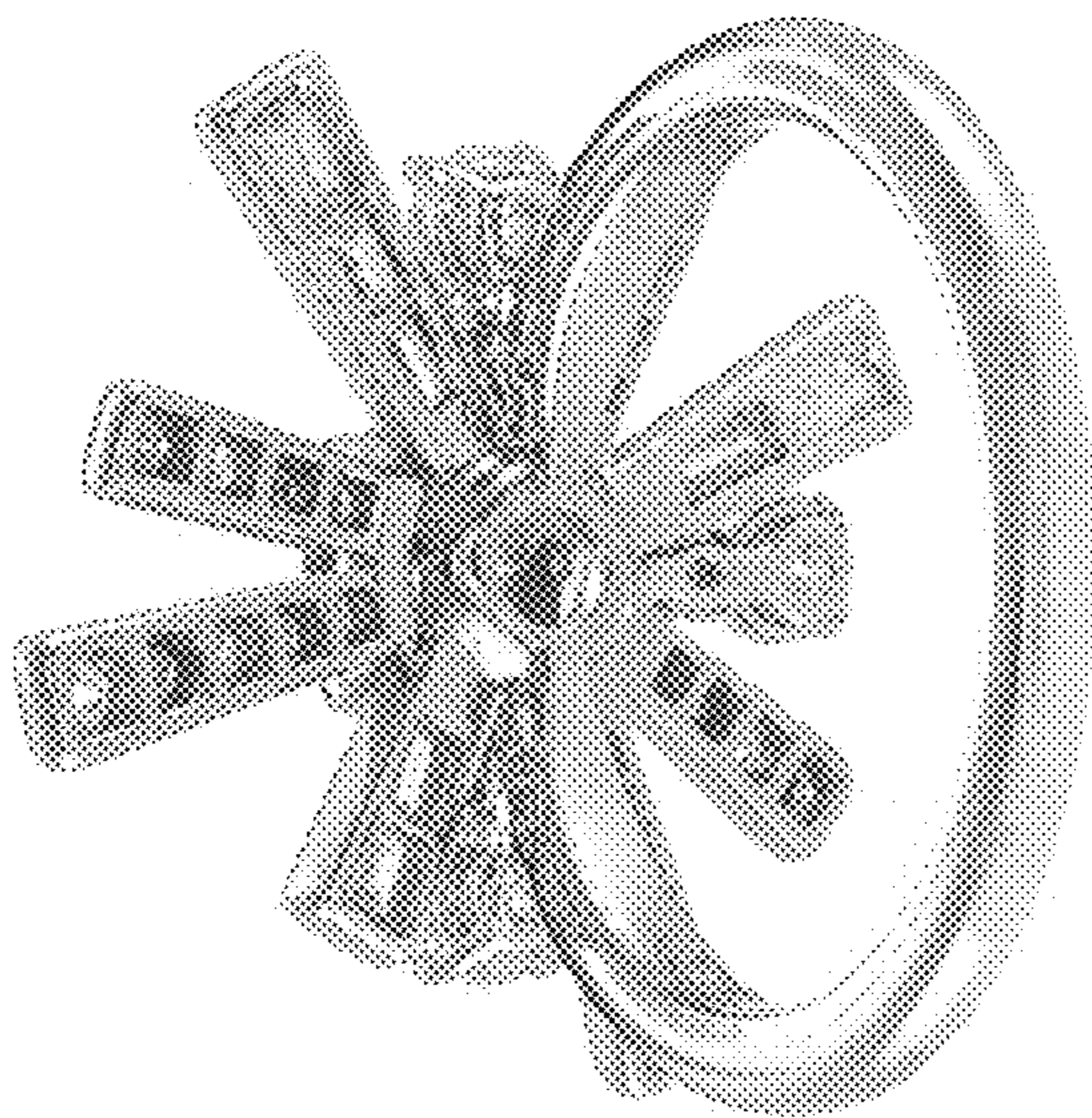
FIG. 1 is a top view of a ring of my new design;

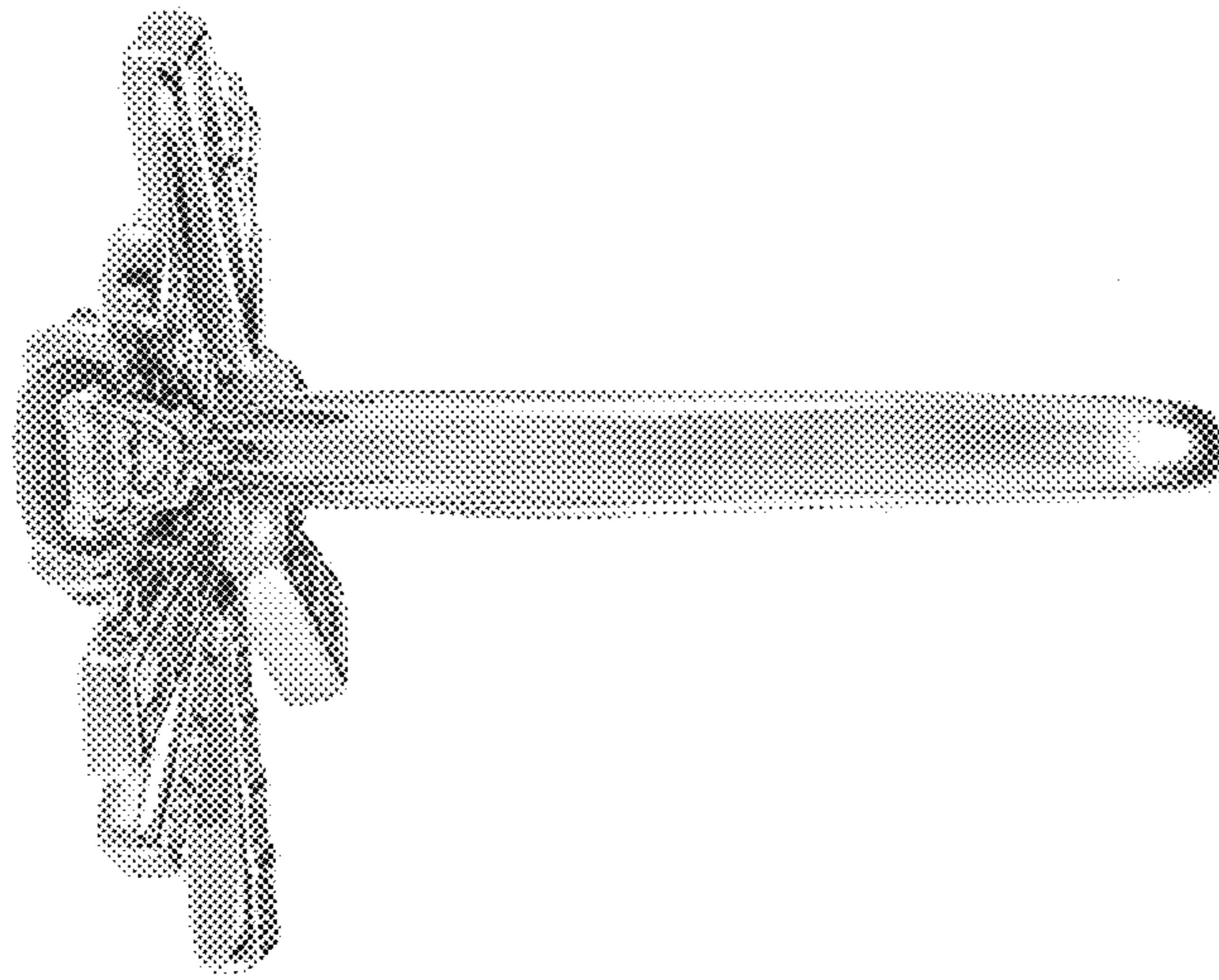




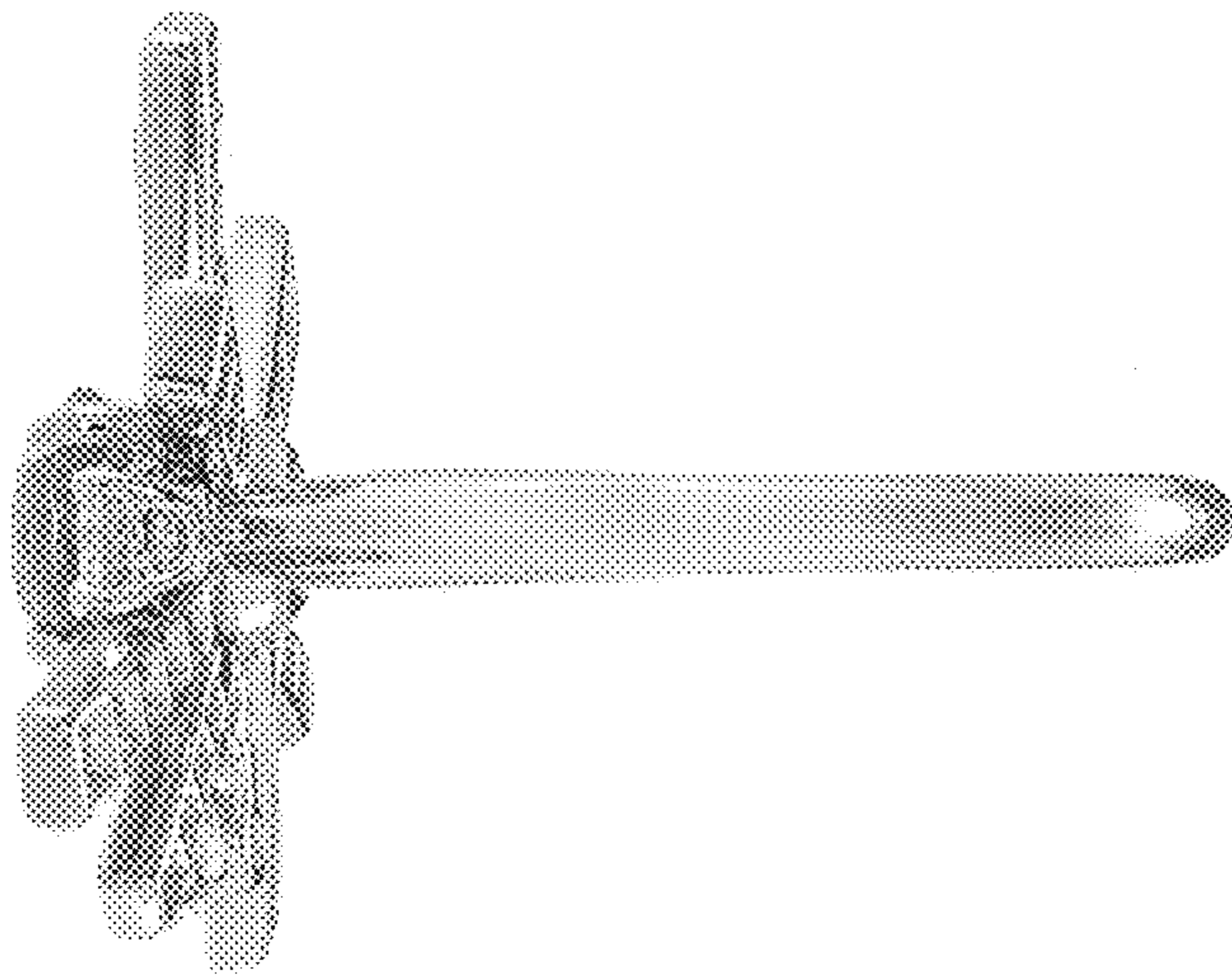

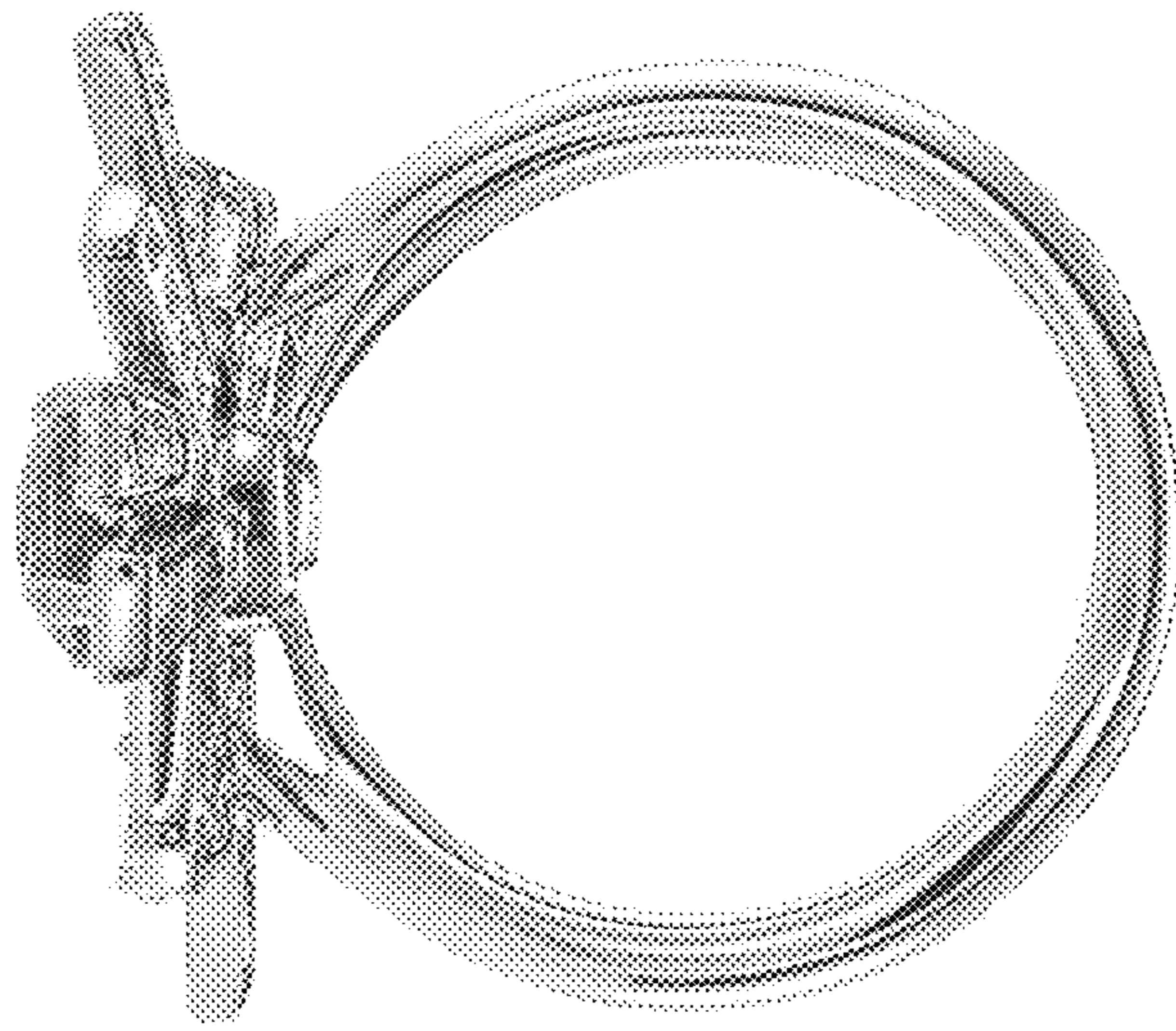

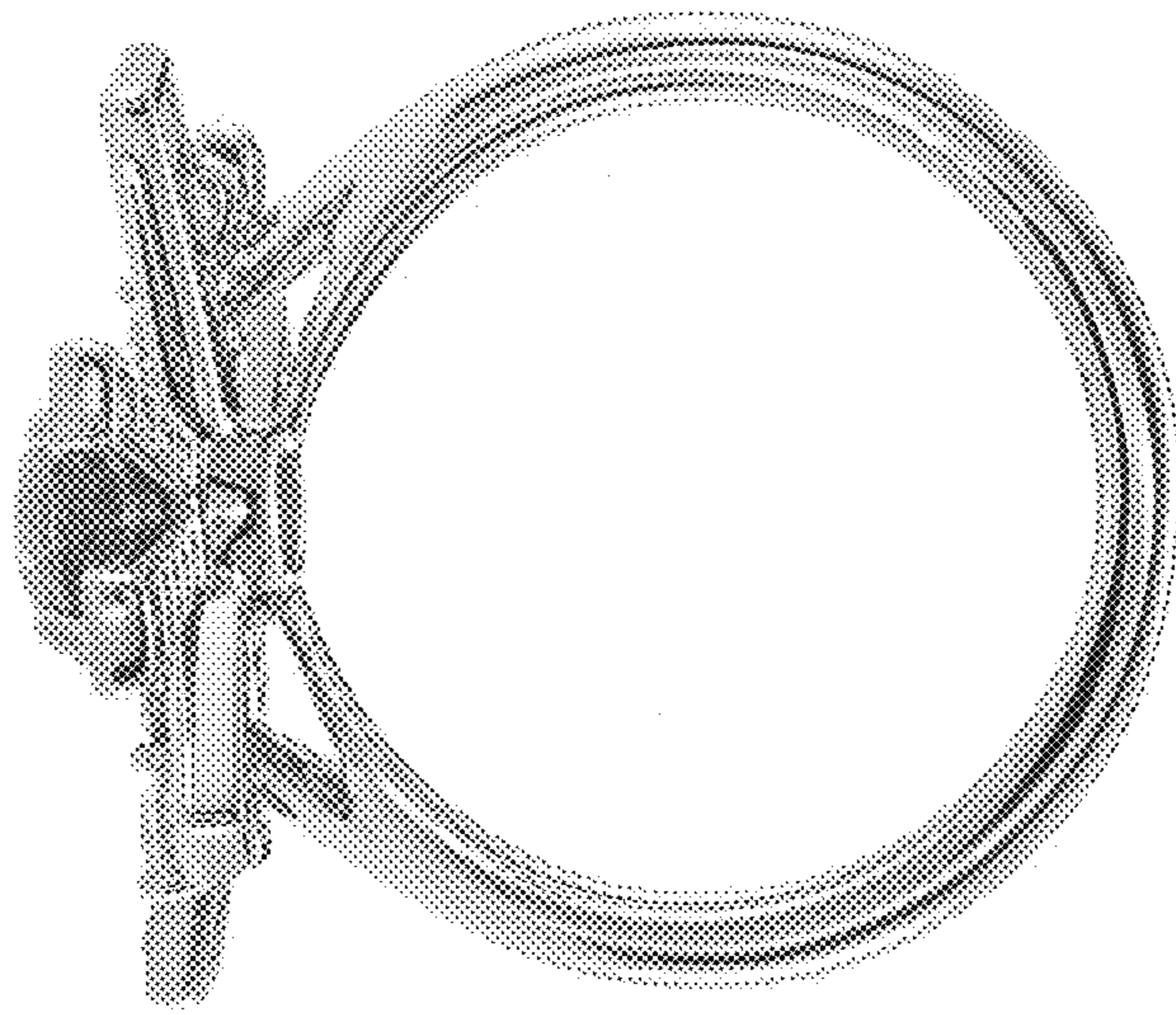

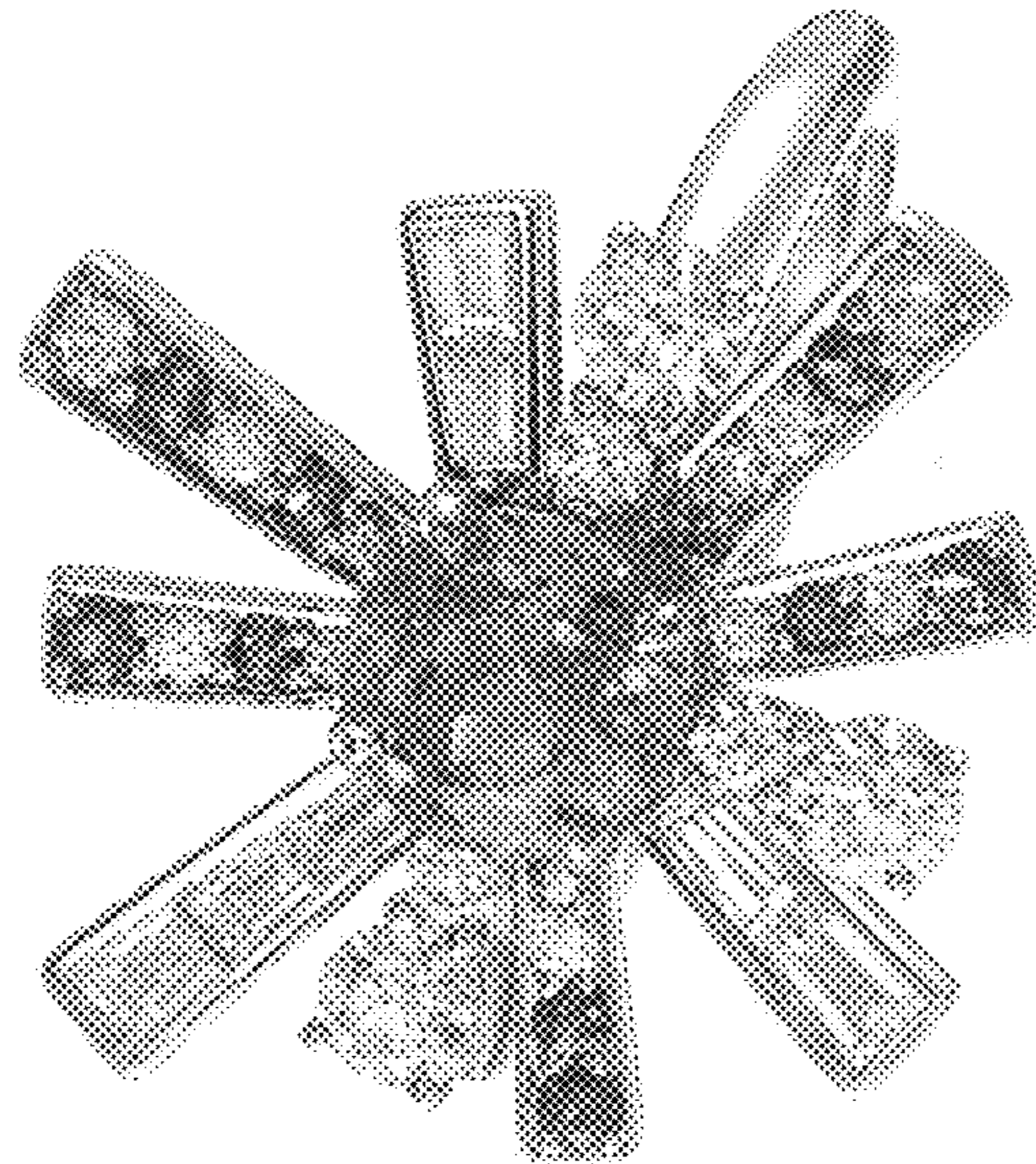

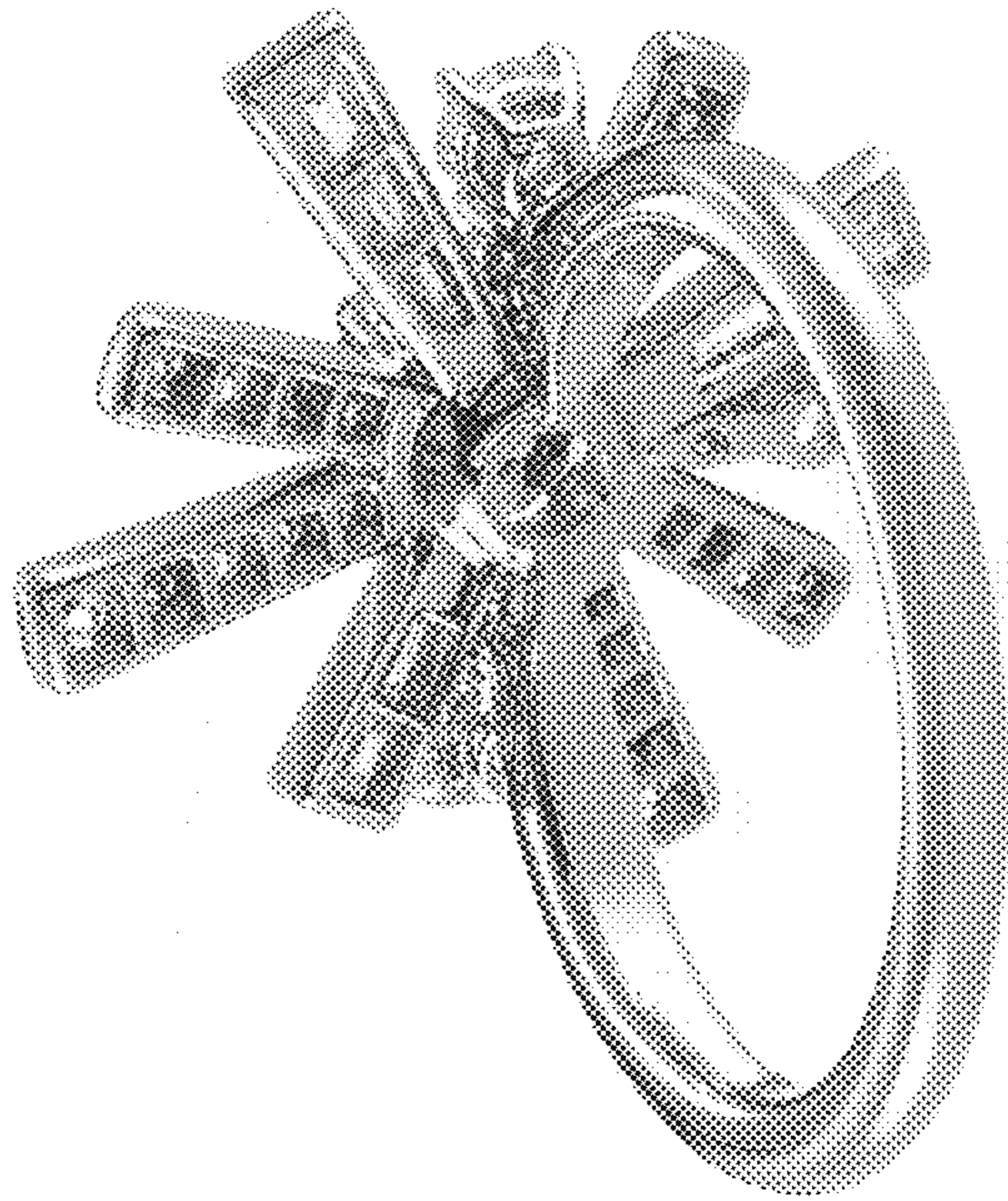
