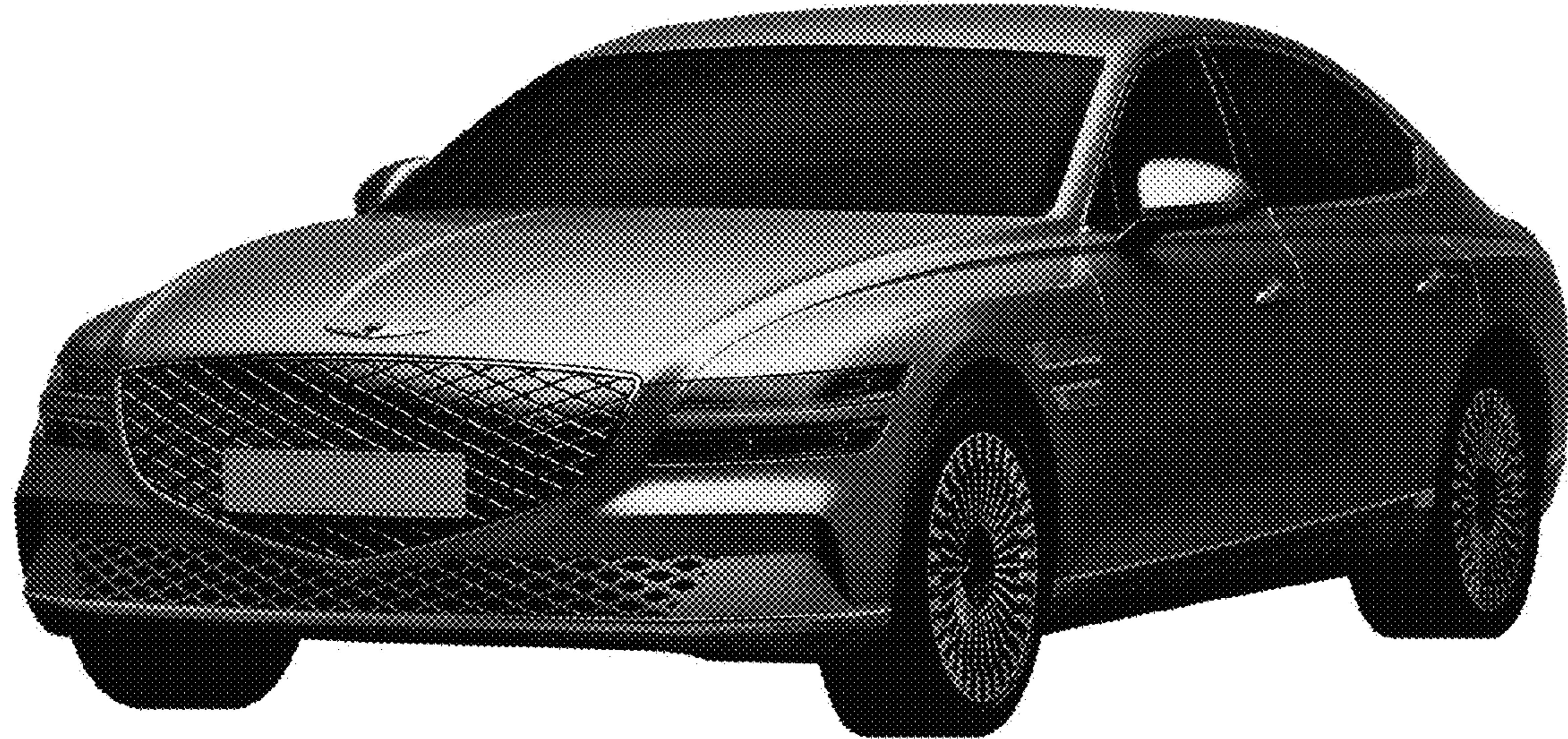
(57) **CLAIM**

The ornamental design for a motor car, as shown and described.

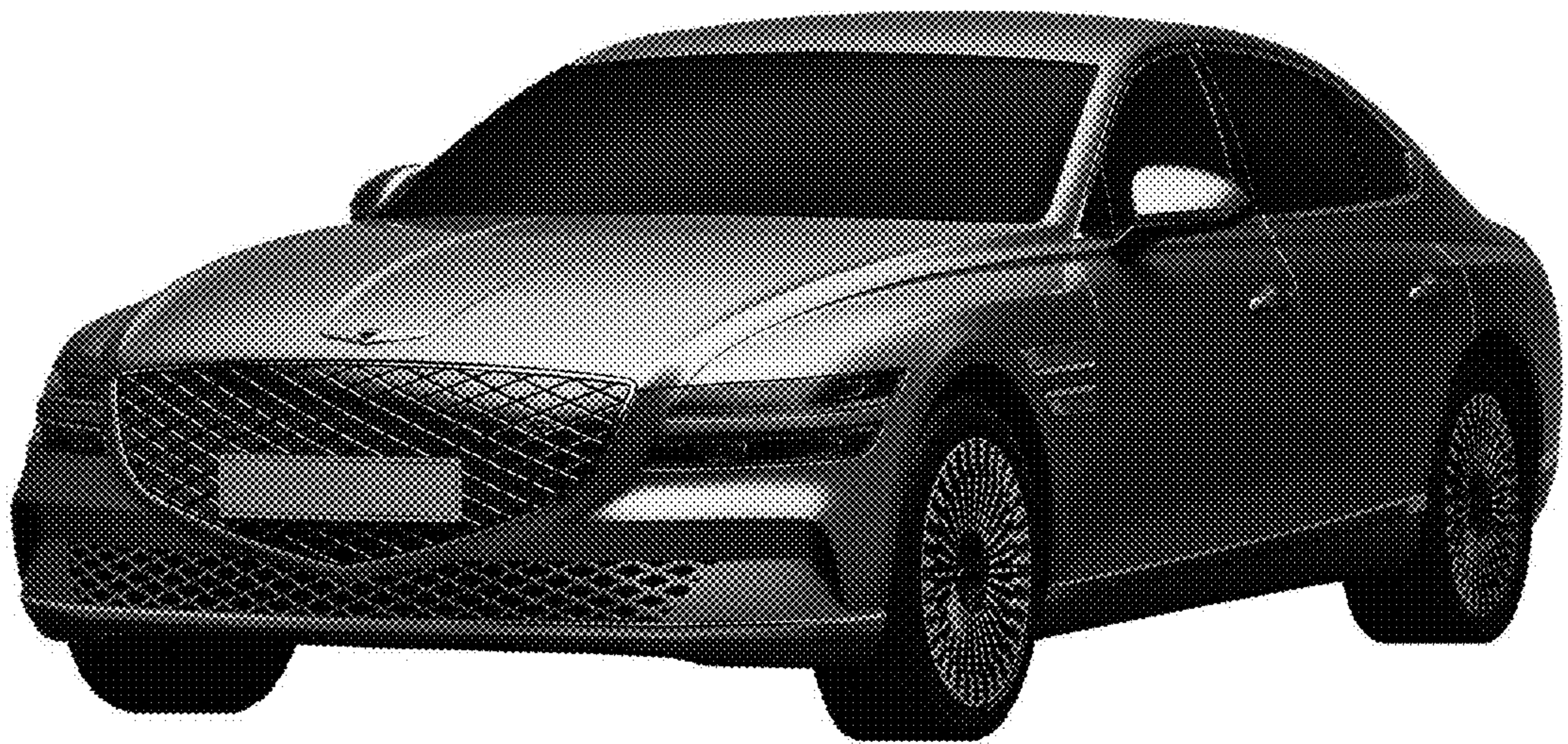
**DESCRIPTION**

1.5 : Left  
1.6 : Top  
Reproduction 1.1 is a top, front, and left side perspective view of a motor car embodying our new design; reproduction 1.2 is a front elevation view thereof; reproduction 1.3 is a rear elevation view thereof; reproduction 1.4 is a right side elevation view thereof; reproduction 1.5 is a left side elevation view thereof; and reproduction 1.6 is a top plan view thereof; this design is for a heavyweight article and therefore the bottom part of the article is omitted.

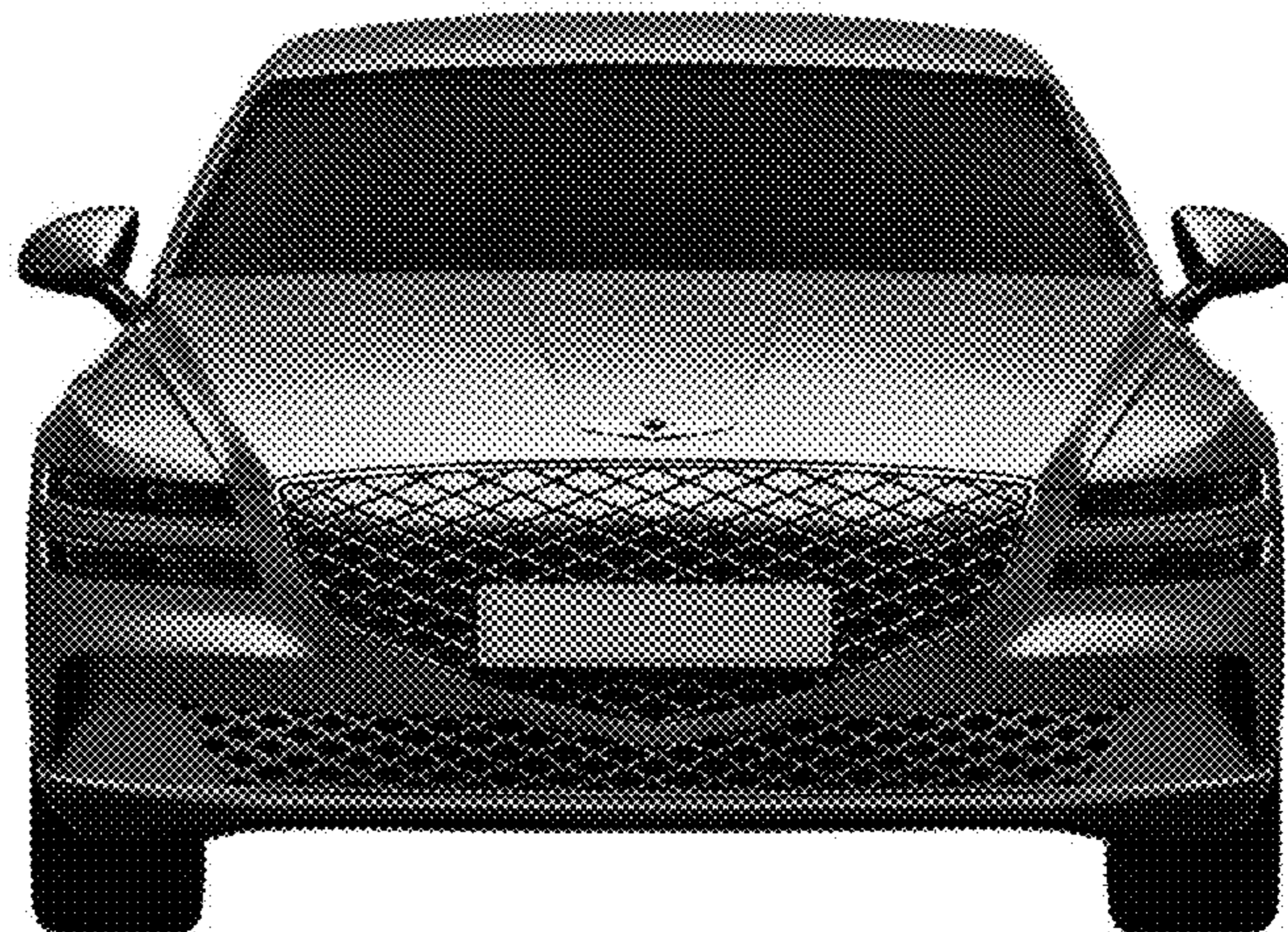

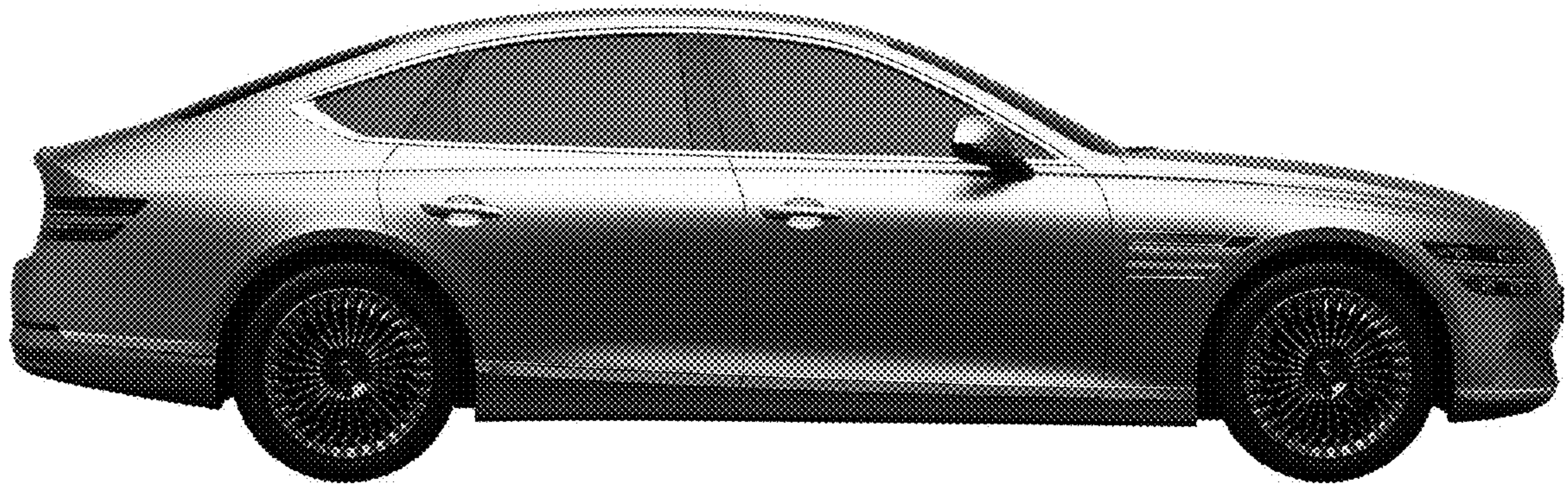

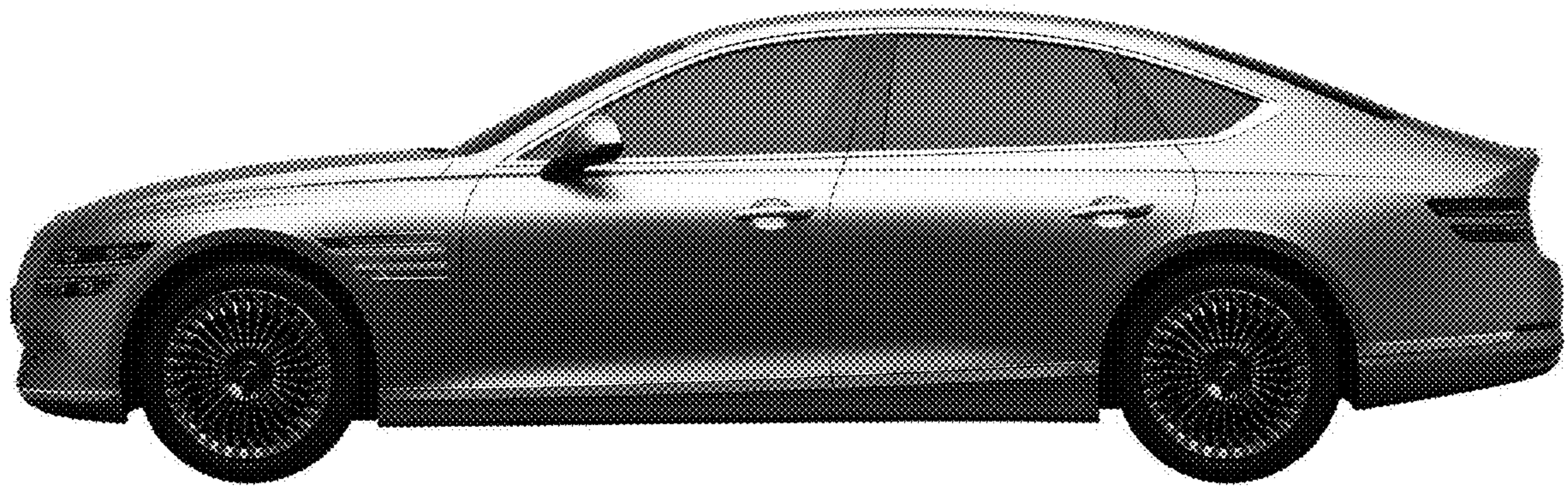
