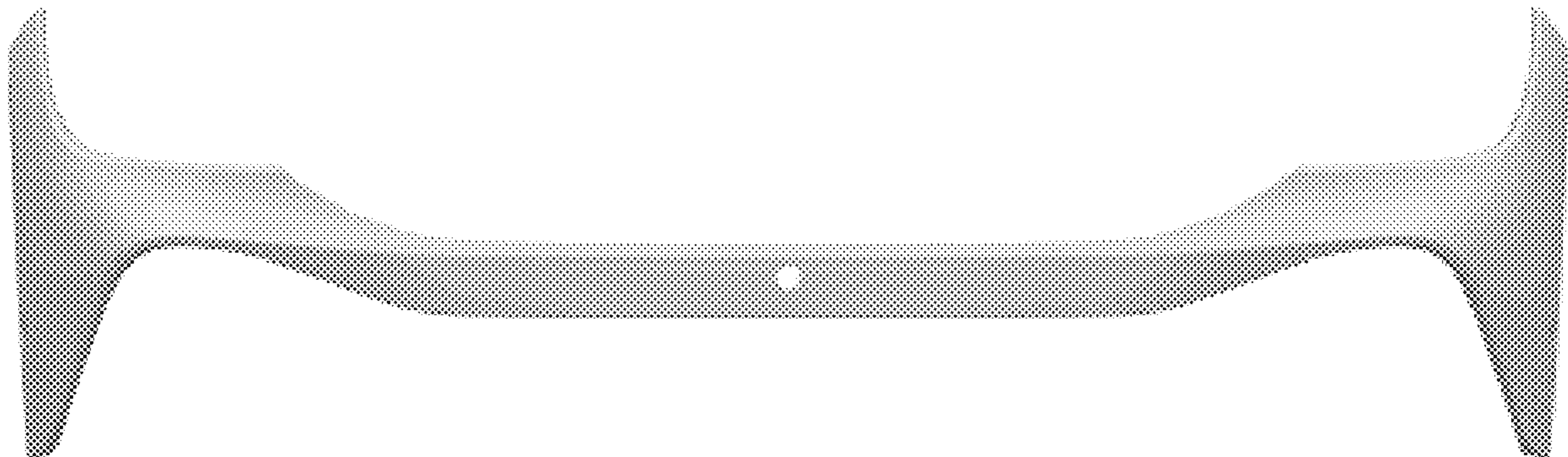

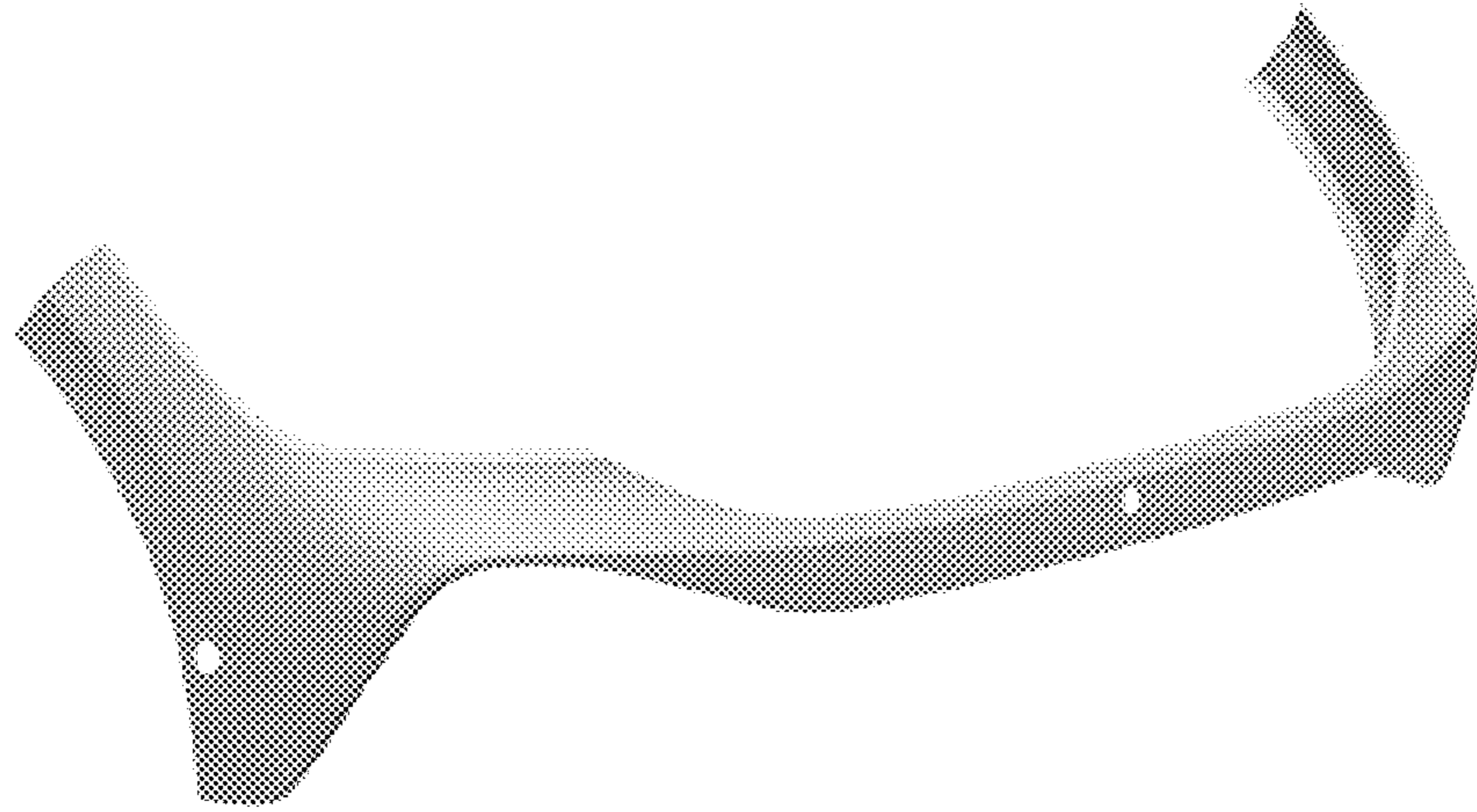
The ornamental design for a vehicle bumper, as shown and described.

**DESCRIPTION**

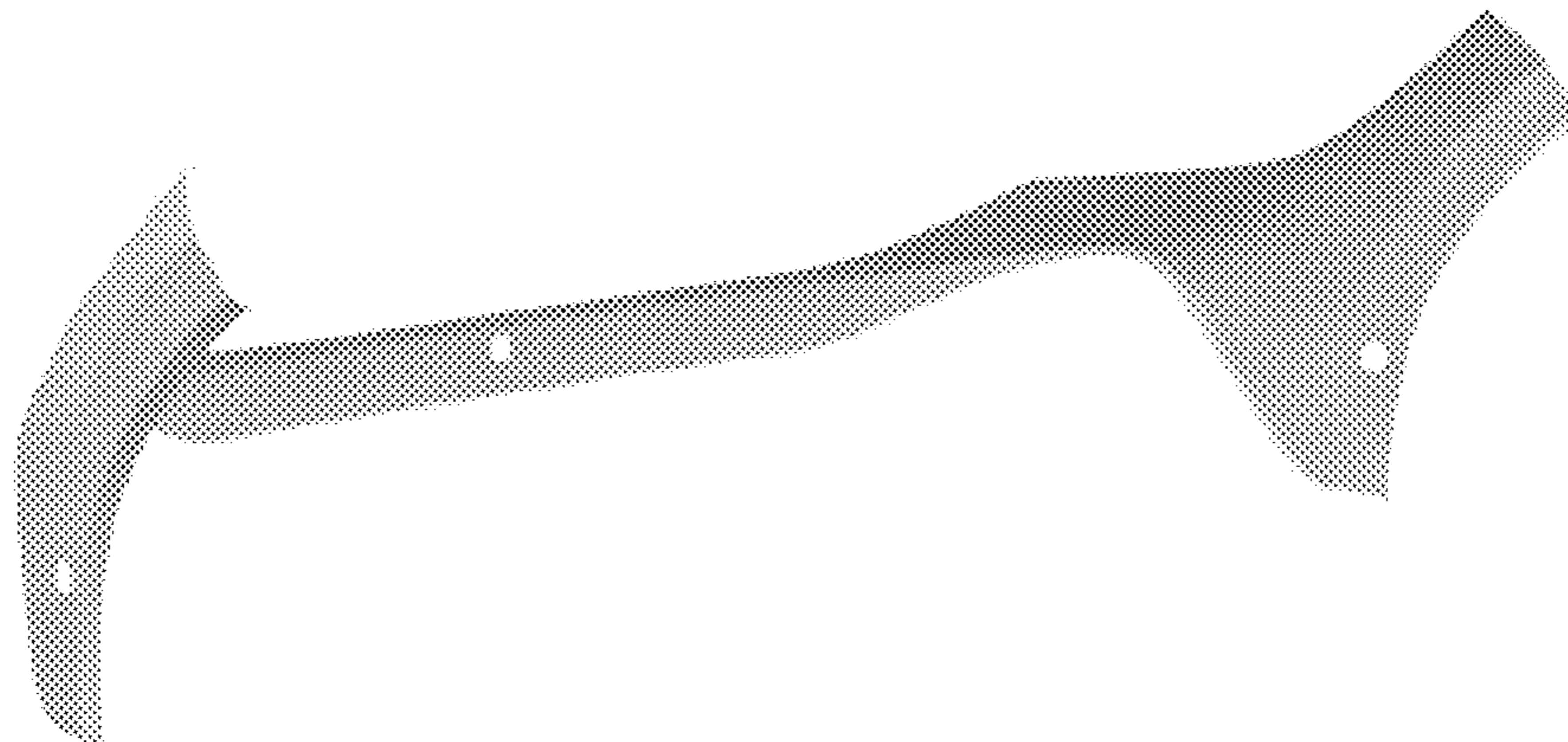
FIG. 1 is a front and left side perspective view of a vehicle bumper showing my new design;

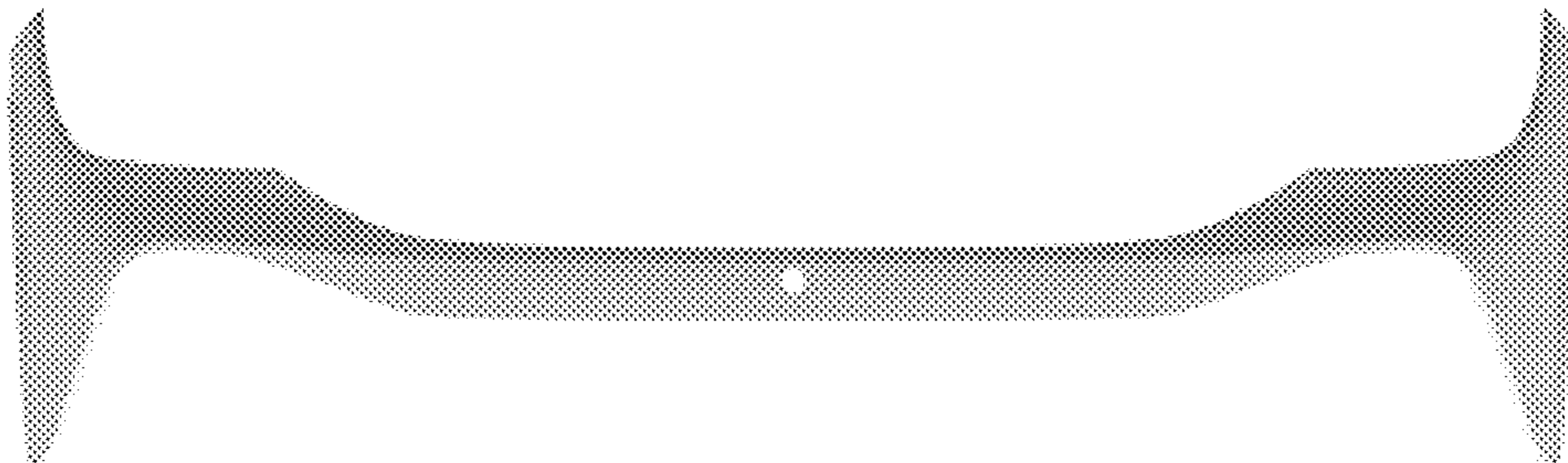

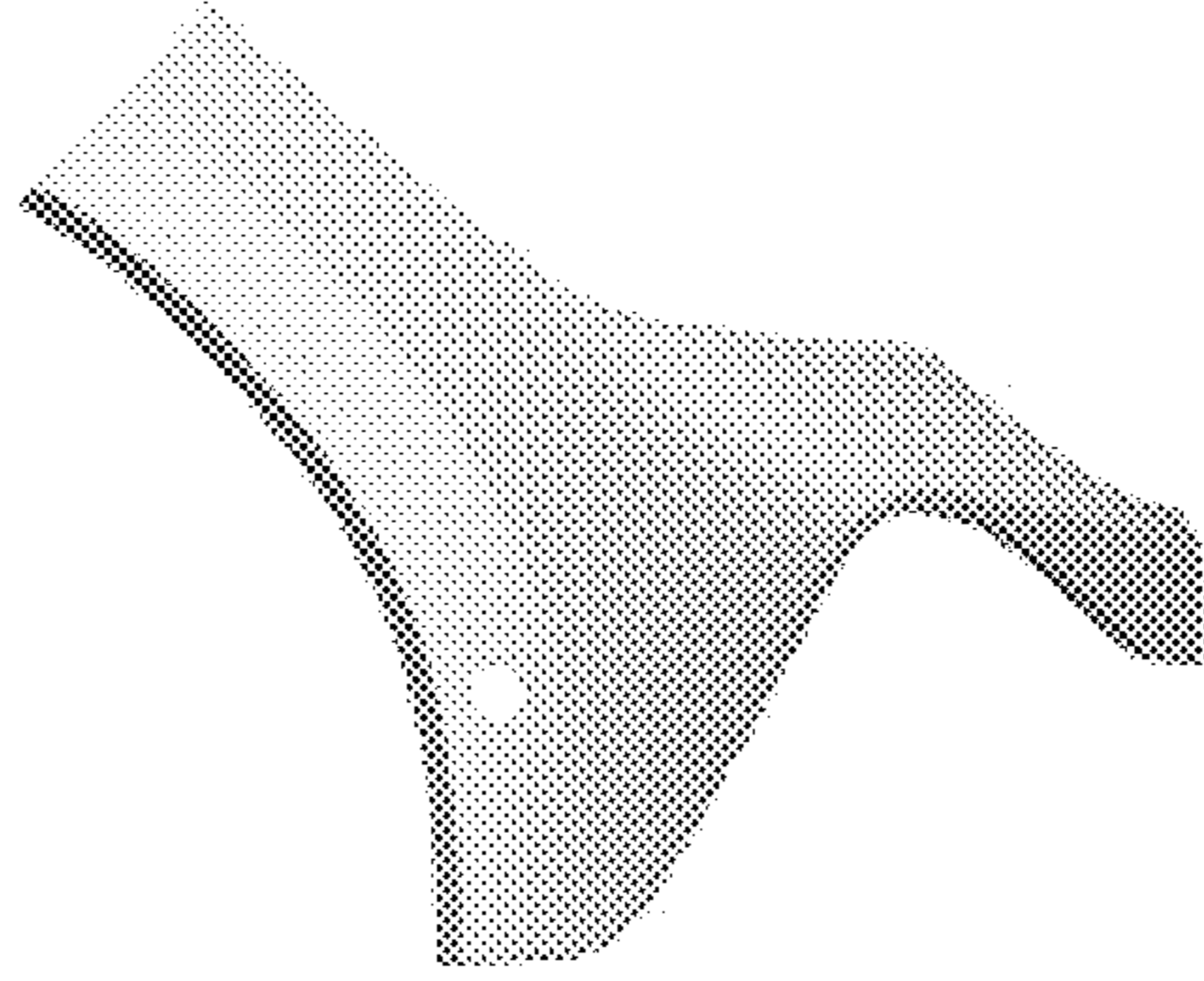

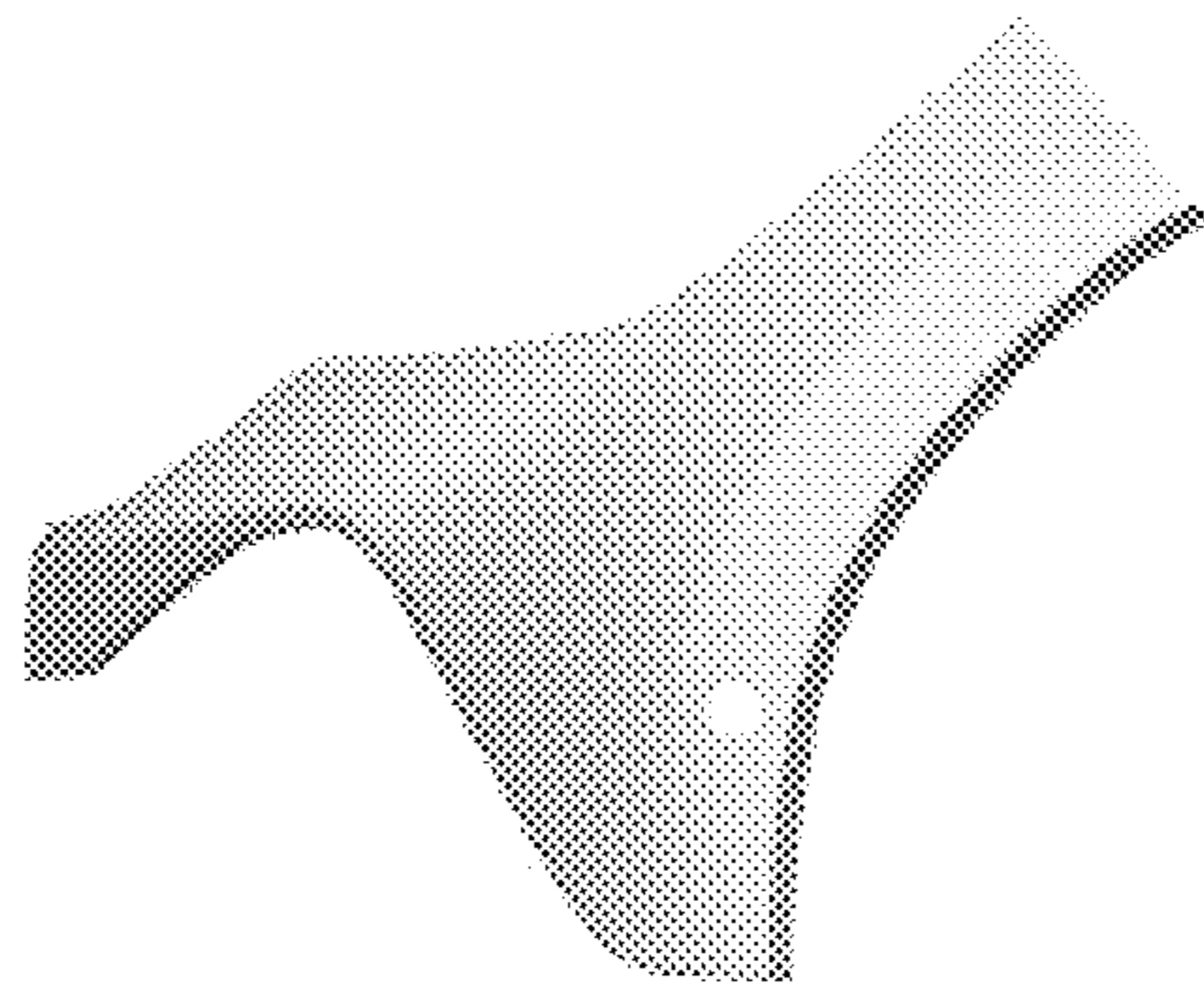

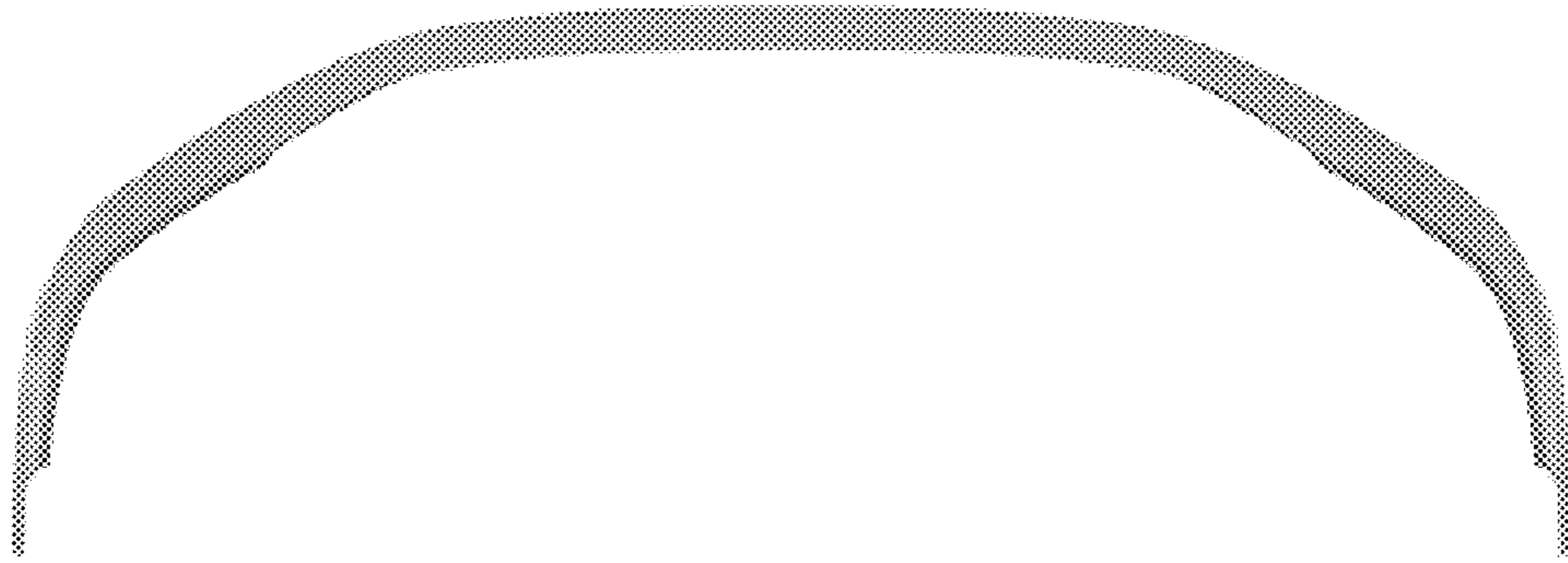

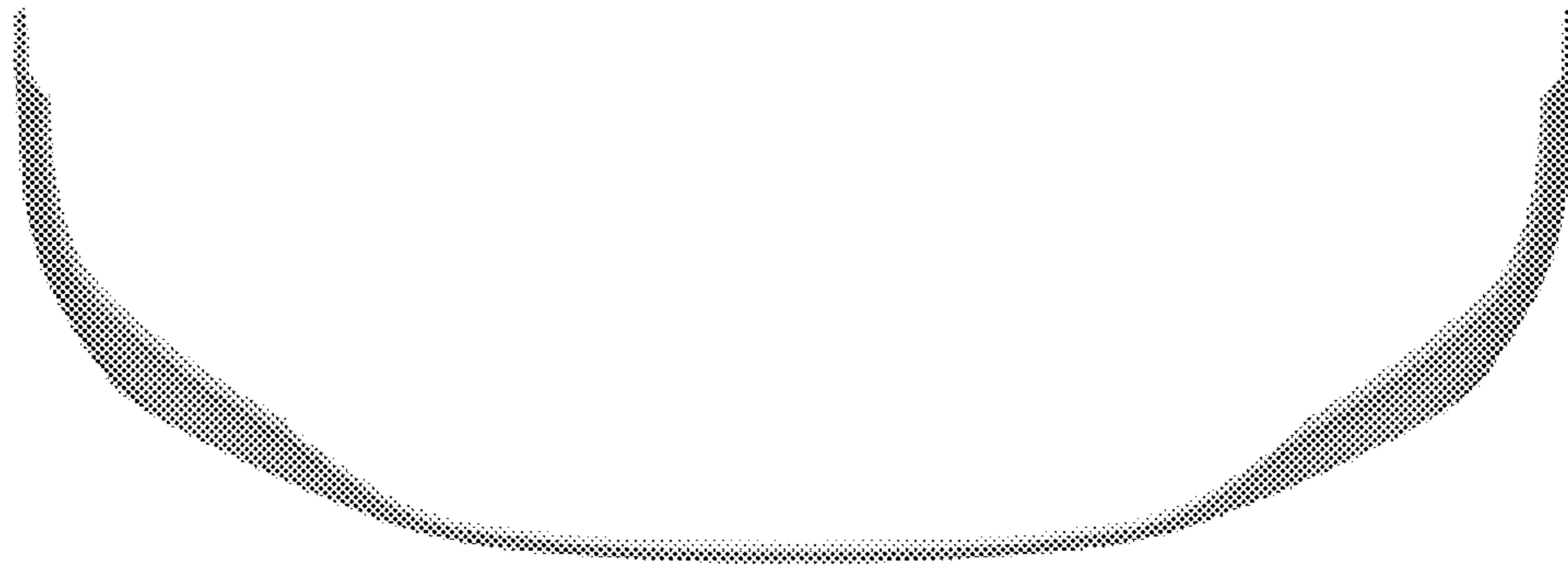
