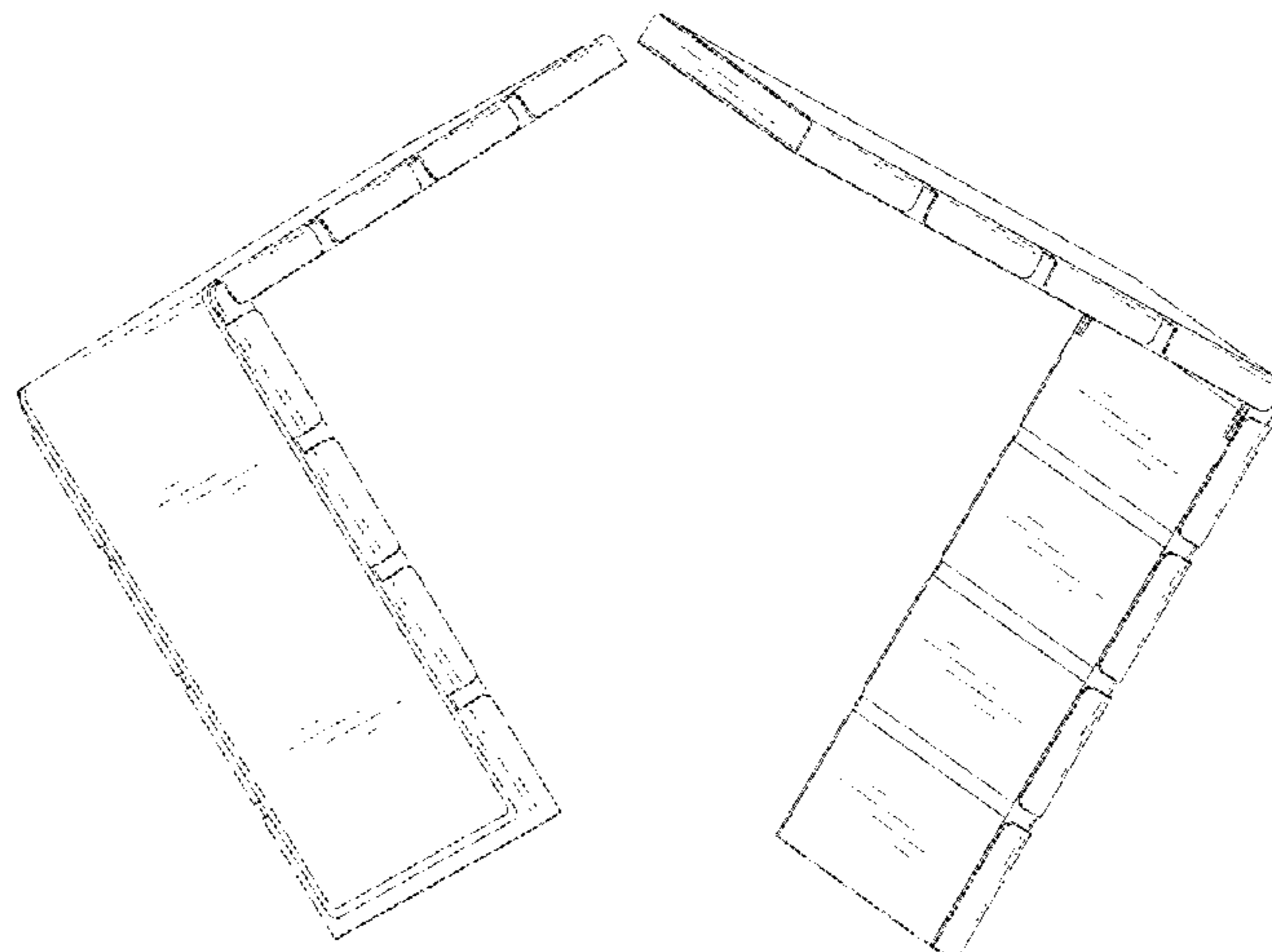
(57) **CLAIM**

The ornamental design for a foldable mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right perspective view of a foldable mobile phone in a first folded state showing our new design; FIG. 2 is a rear, left perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top view thereof; FIG. 8 is a bottom view thereof; FIG. 9 is a front, right perspective view thereof, shown in a second folded state; FIG. 10 is a rear, left perspective view thereof, shown in the second folded state; FIG. 11 is a front, right perspective view thereof, shown in a first unfolded state; FIG. 12 is a rear, left perspective view thereof, shown in the first unfolded state; FIG. 13 is a front, right perspective view thereof, shown in a second unfolded state; FIG. 14 is a rear, left perspective view thereof, shown in the second unfolded state; FIG. 15 is a front, right perspective view thereof, shown in a third unfolded state; and, FIG. 16 is a rear, left perspective view thereof, shown in the third unfolded state.

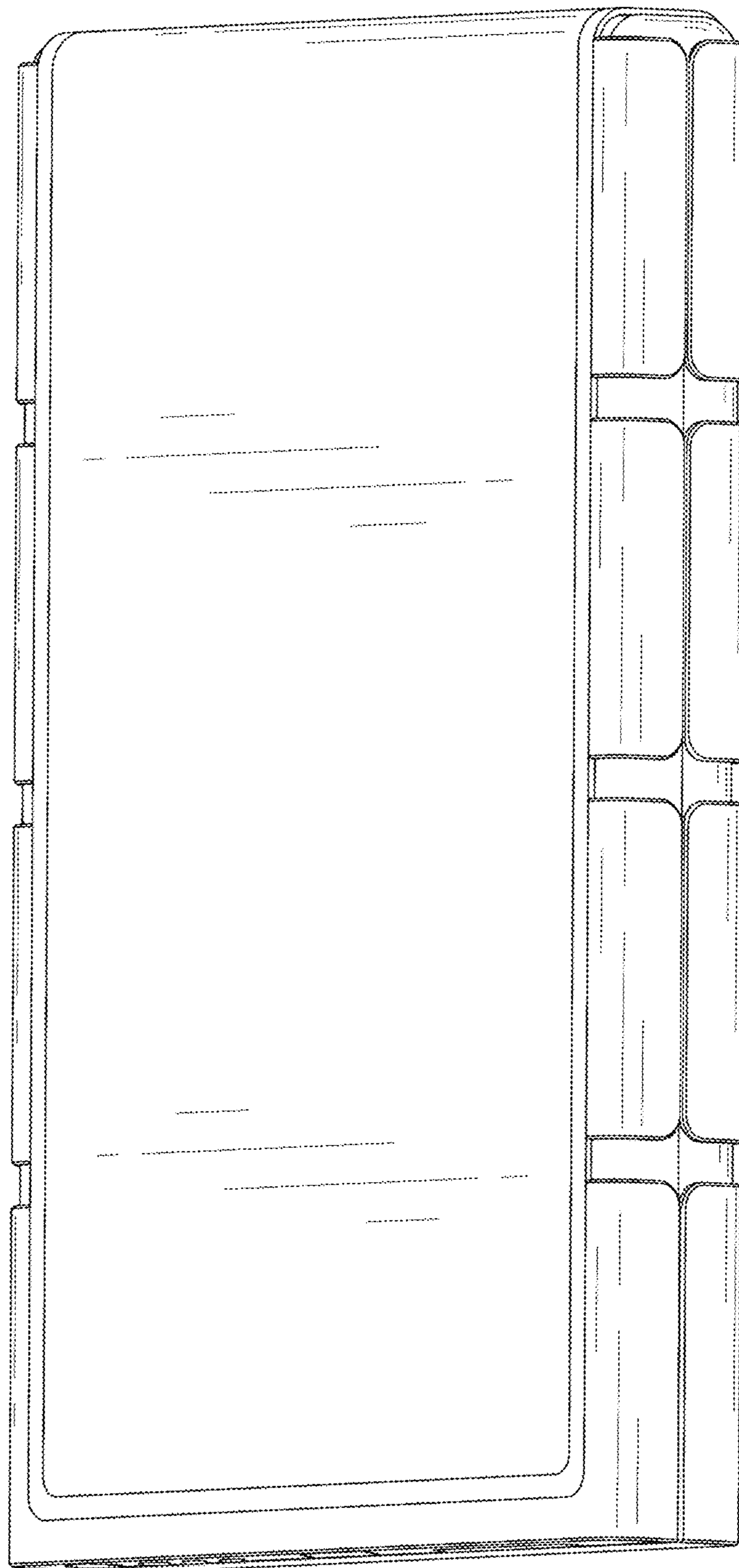

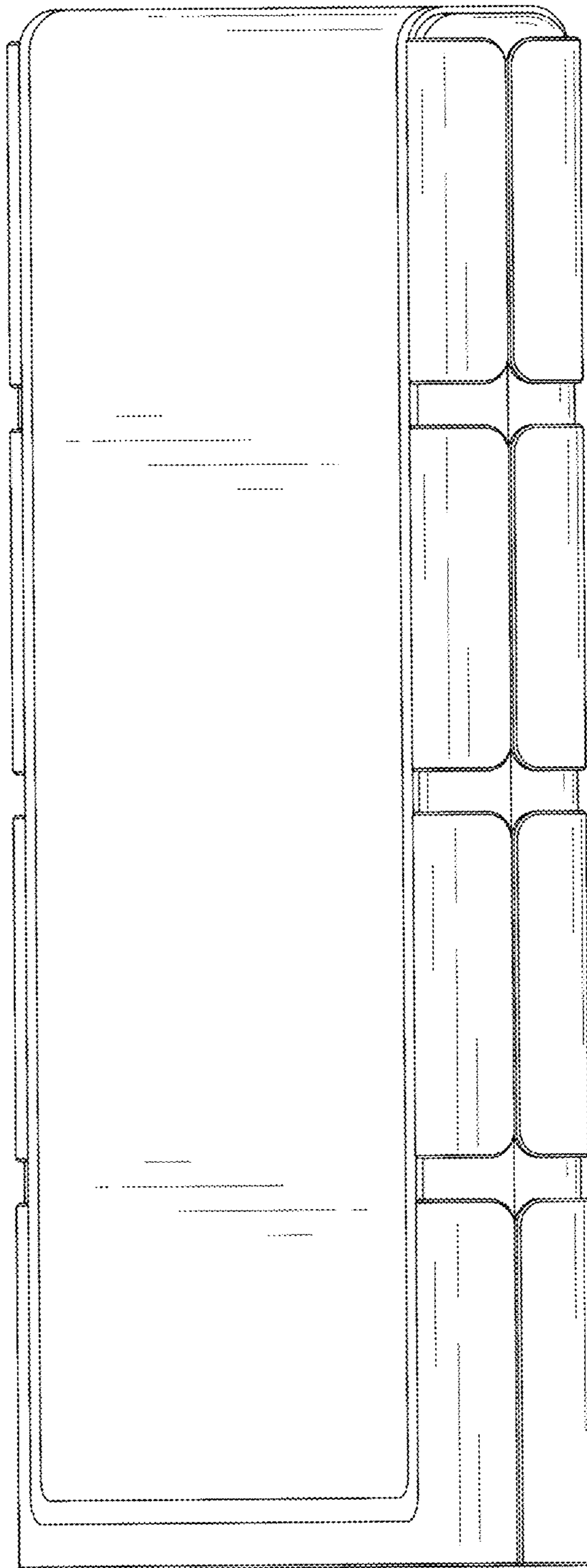

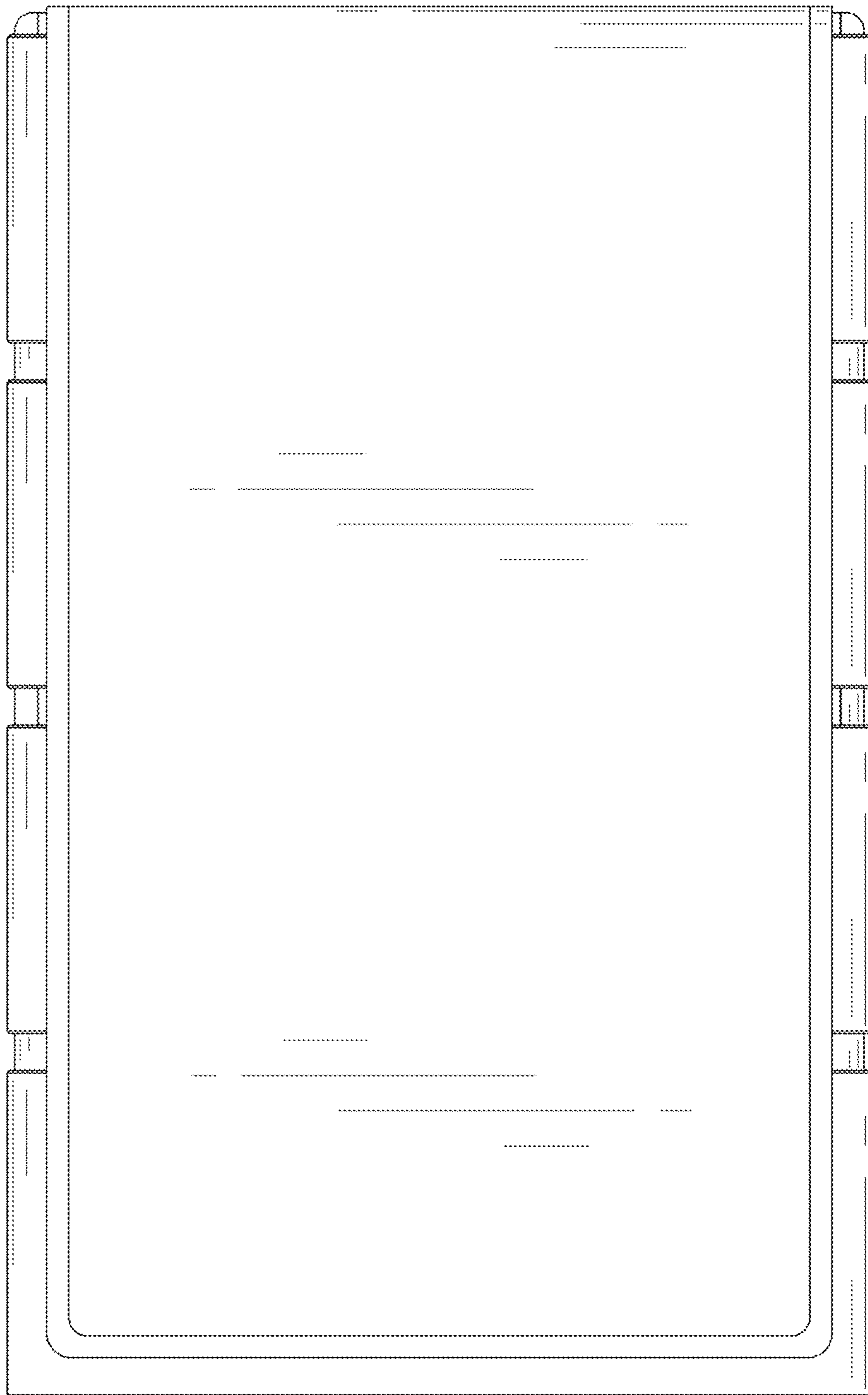

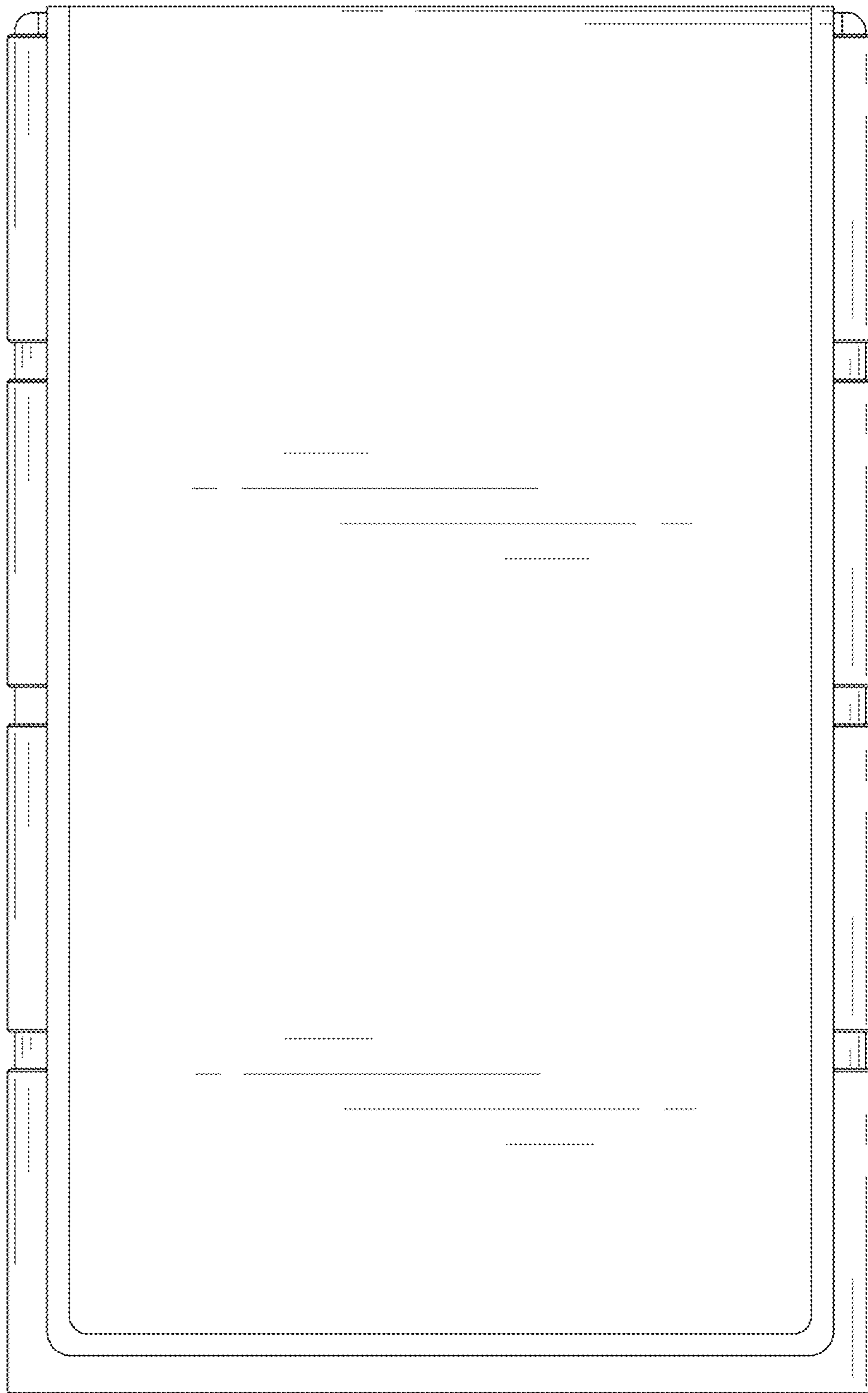

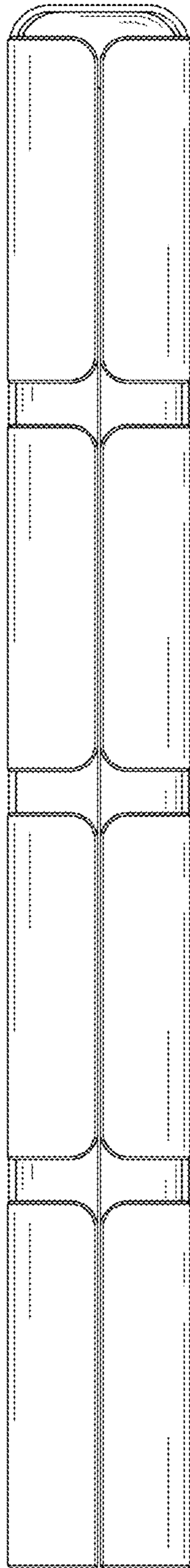

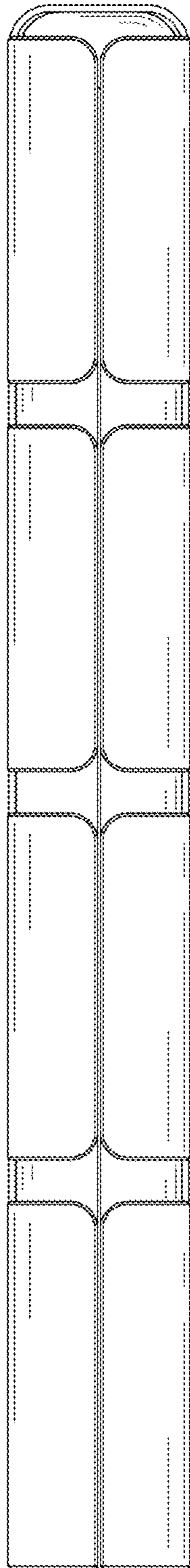

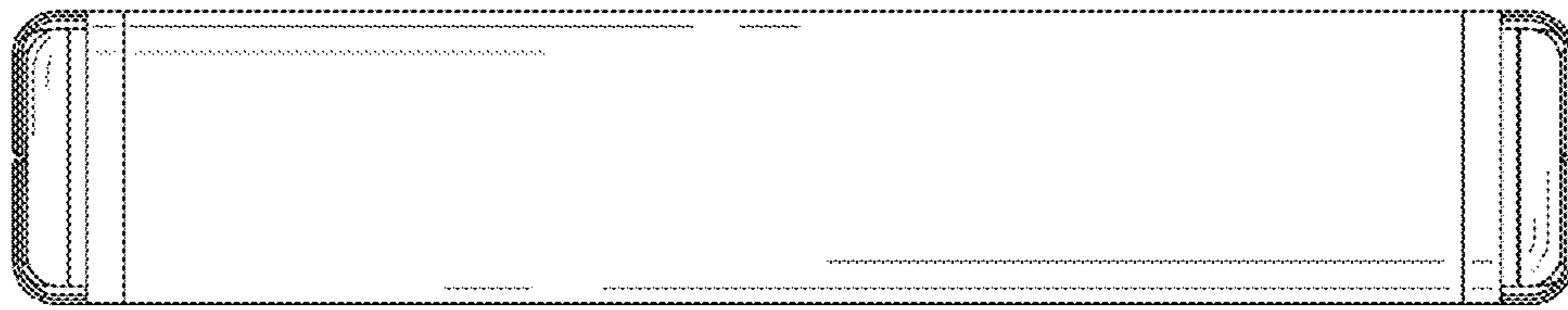

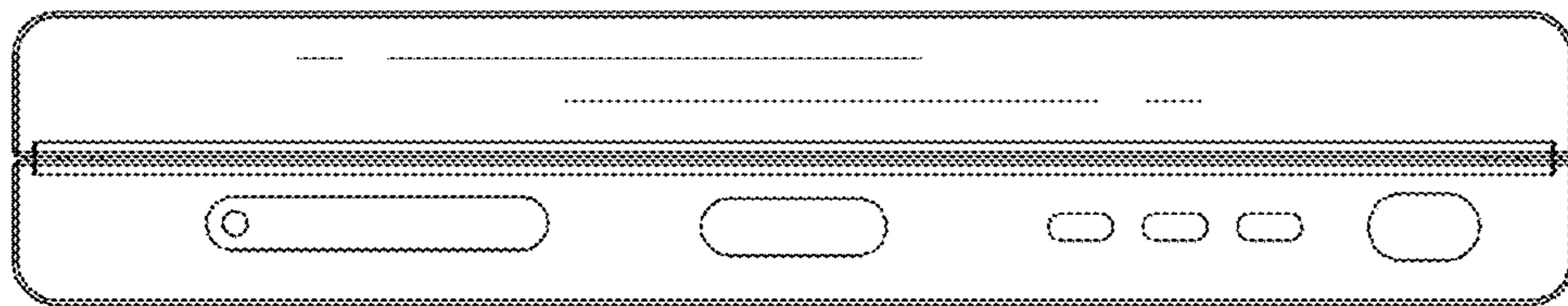

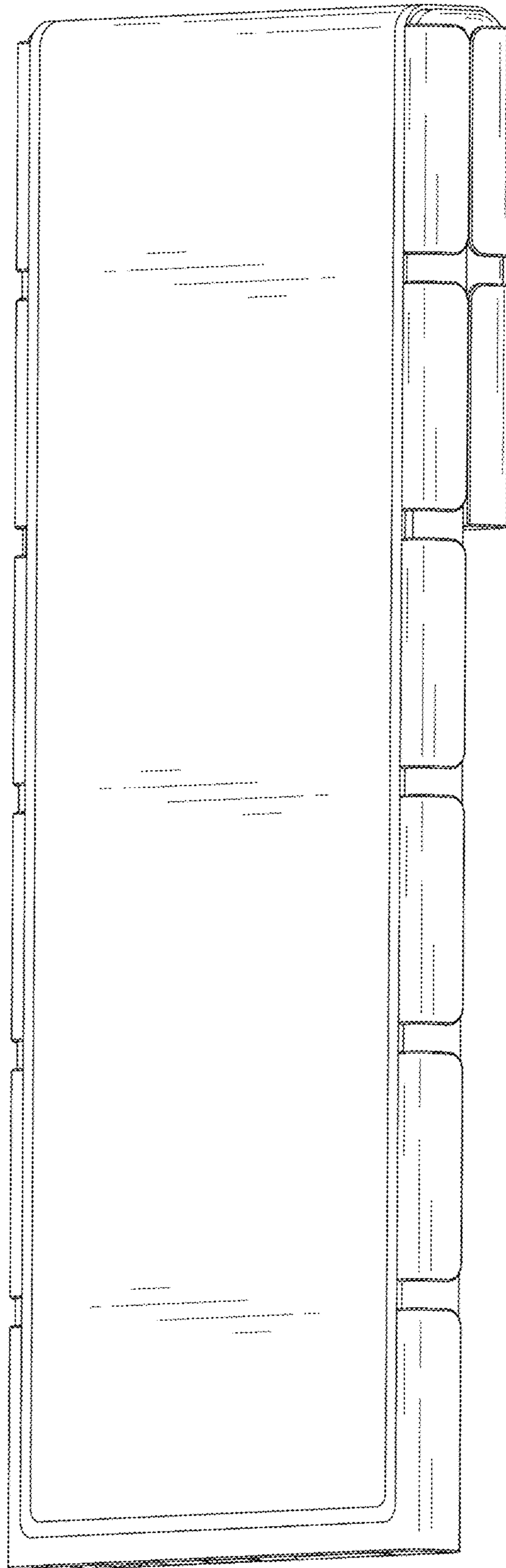




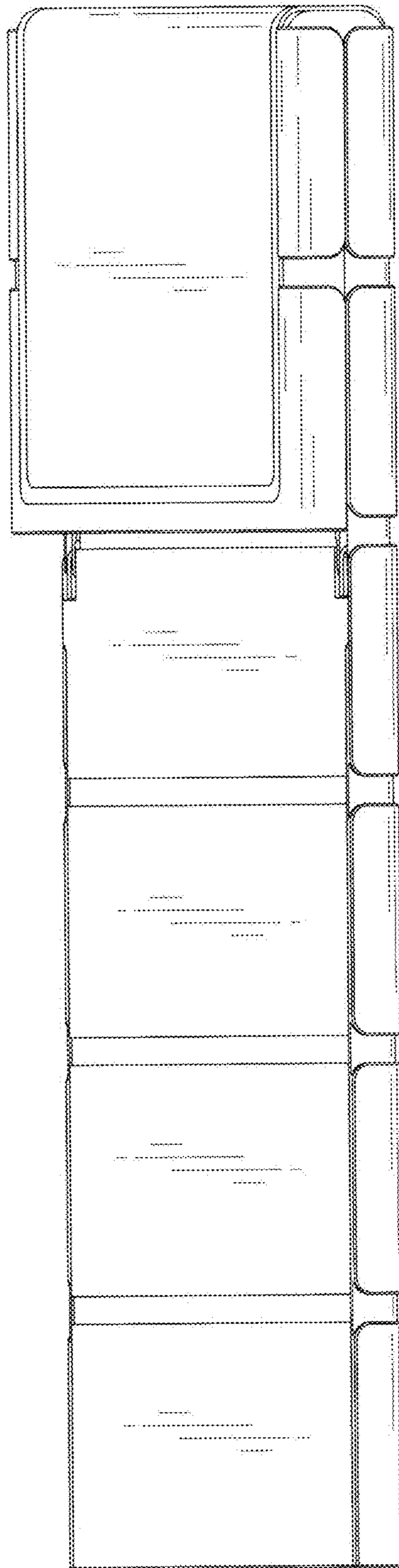

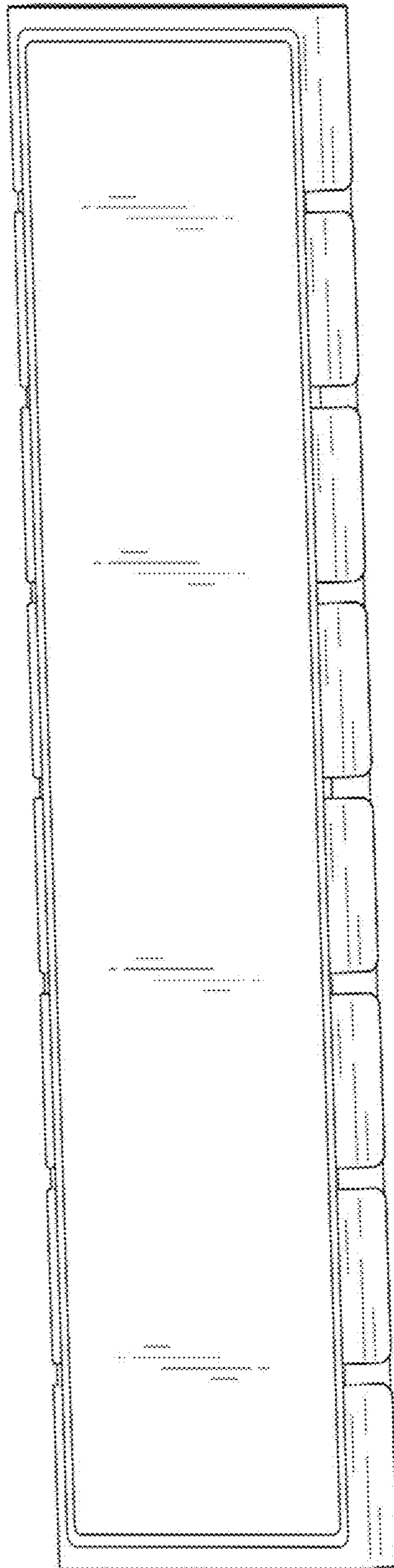

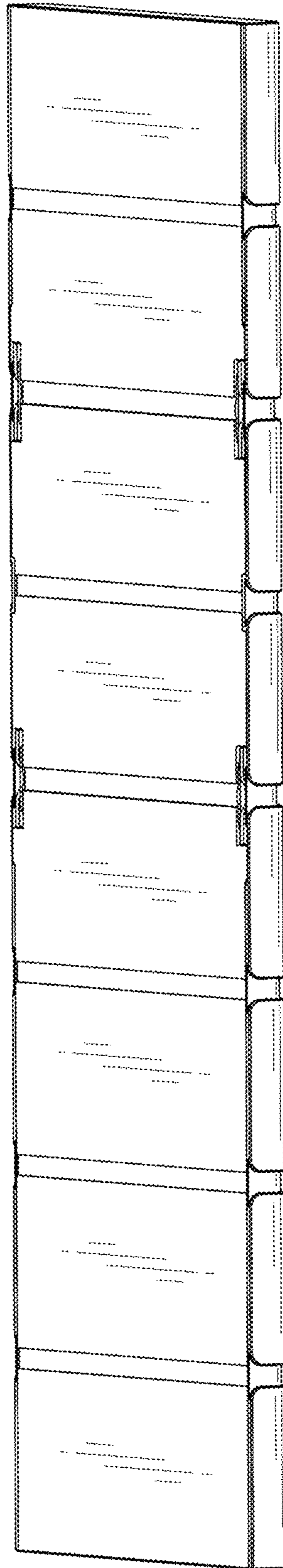

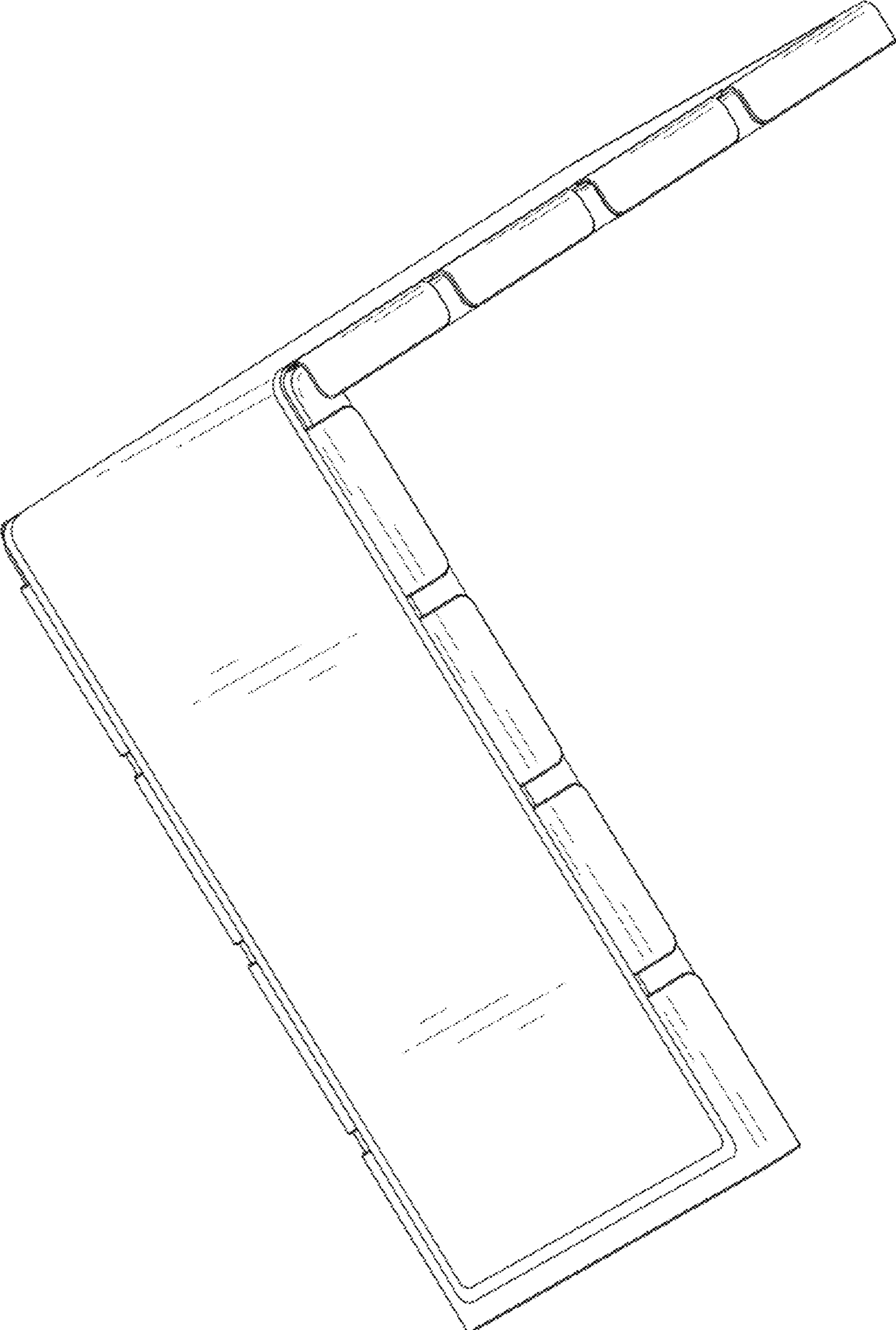

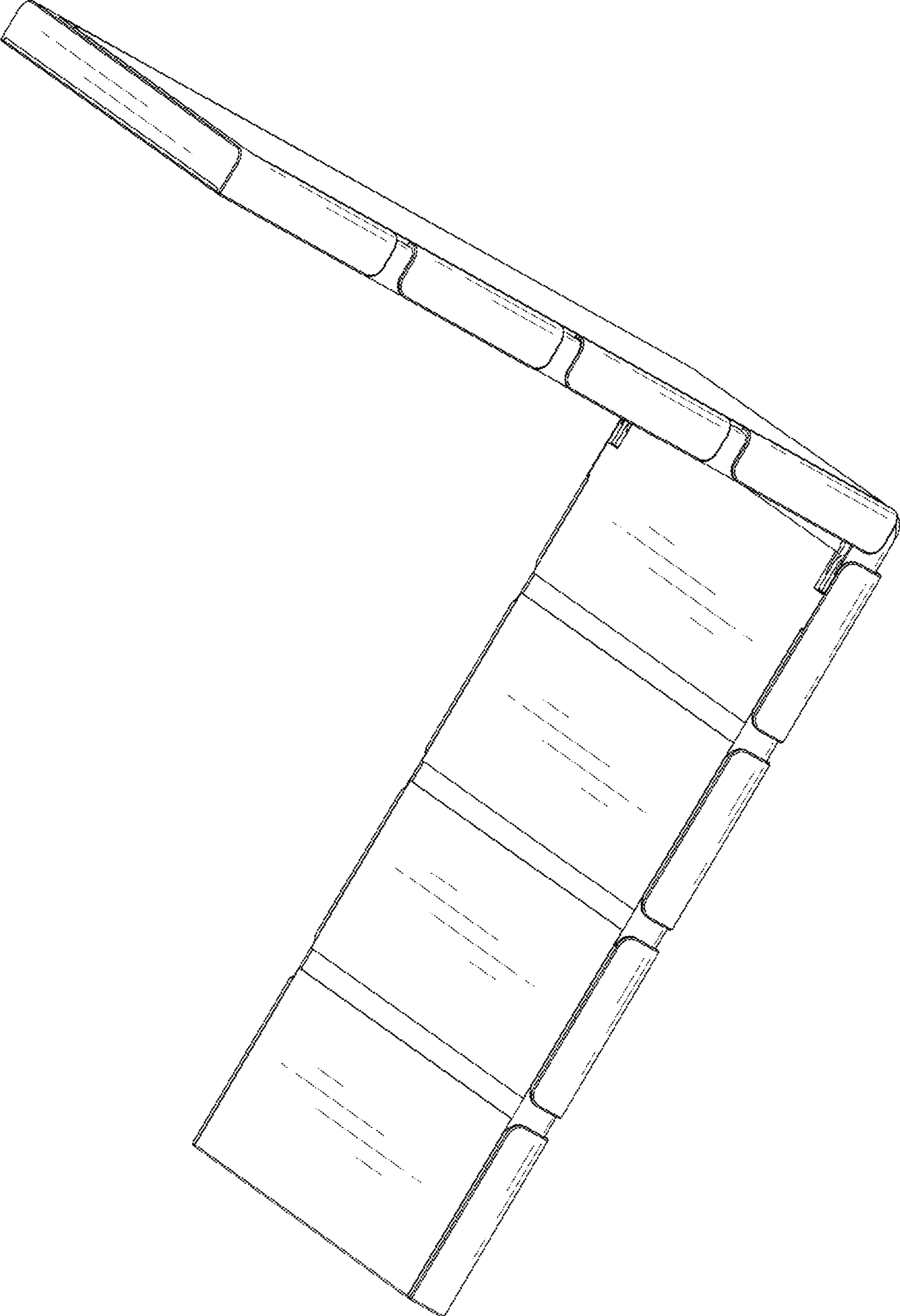

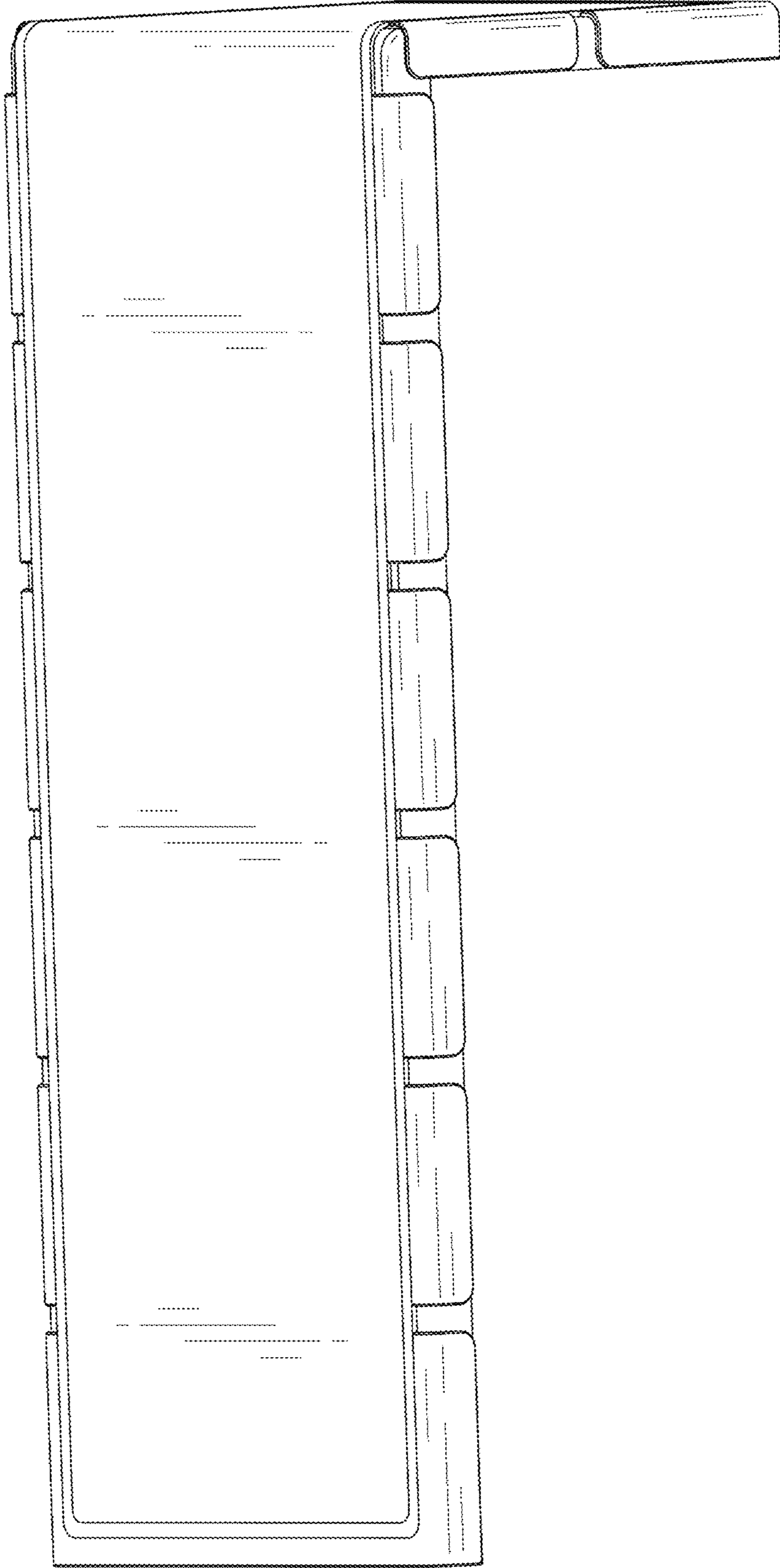
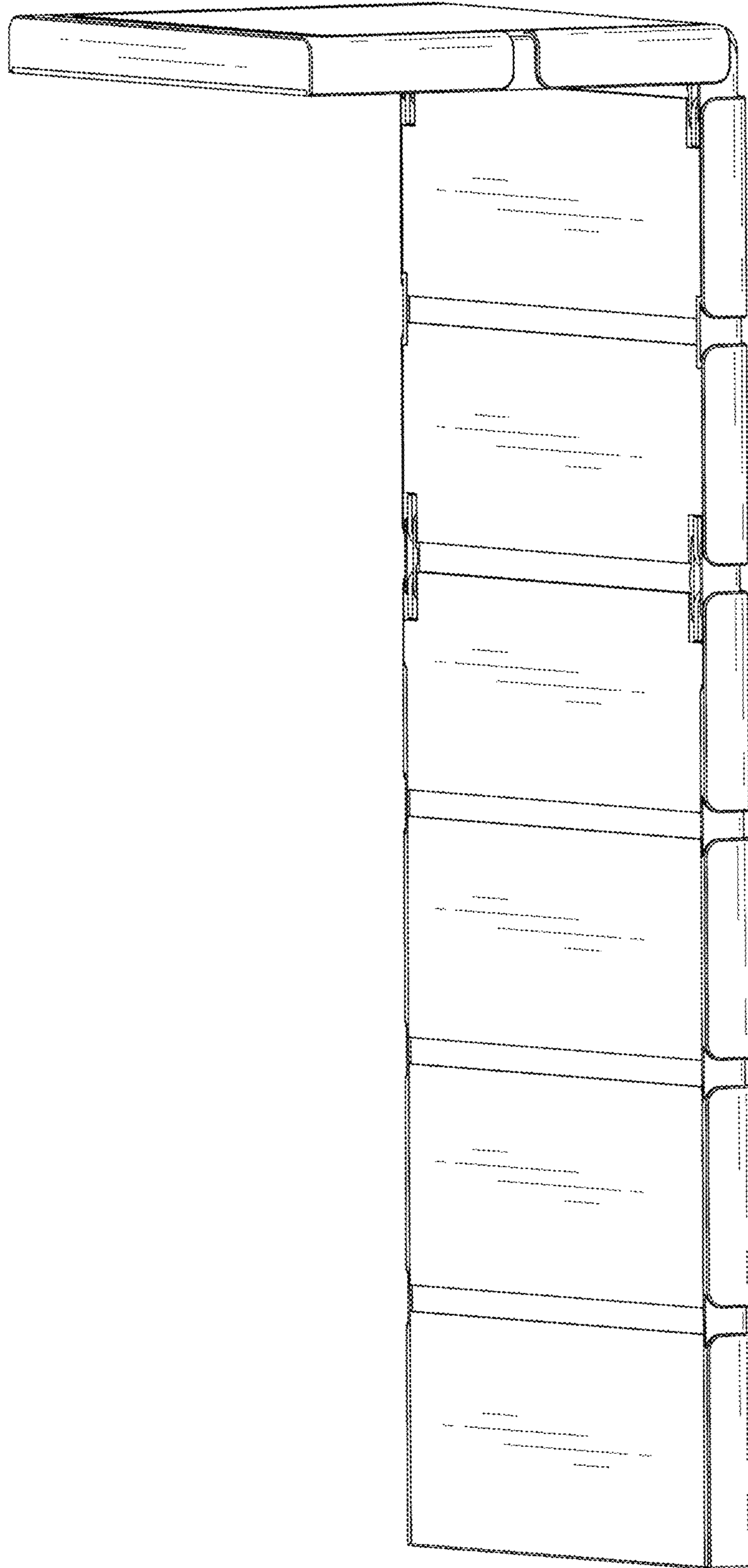
