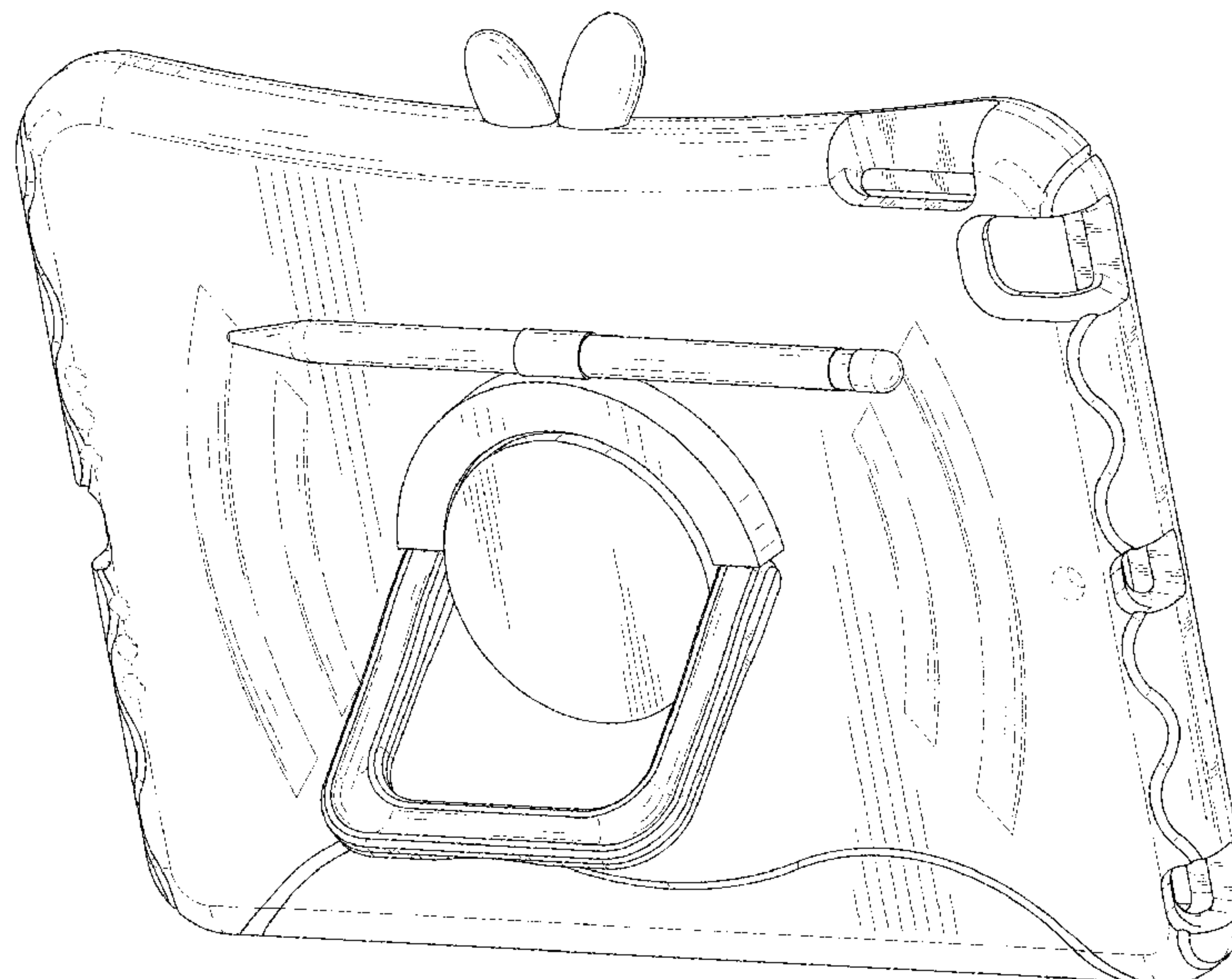
(57) **CLAIM**

The ornamental design for a protective case for tablet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a protective case for tablet showing my new design;  
 FIG. 2 is another perspective view thereof;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a right side elevational view thereof;

 FIG. 8 is a bottom plan view thereof;  
 FIG. 9 is a perspective view of the protective case for tablet where a tablet is received in the protective case for tablet; and,  
 FIG. 10 is a perspective view of the protective case for tablet where a kickstand is in an open state.  
 The broken lines in the drawings depict portions of the protective case for tablet that form no part of the claimed design.

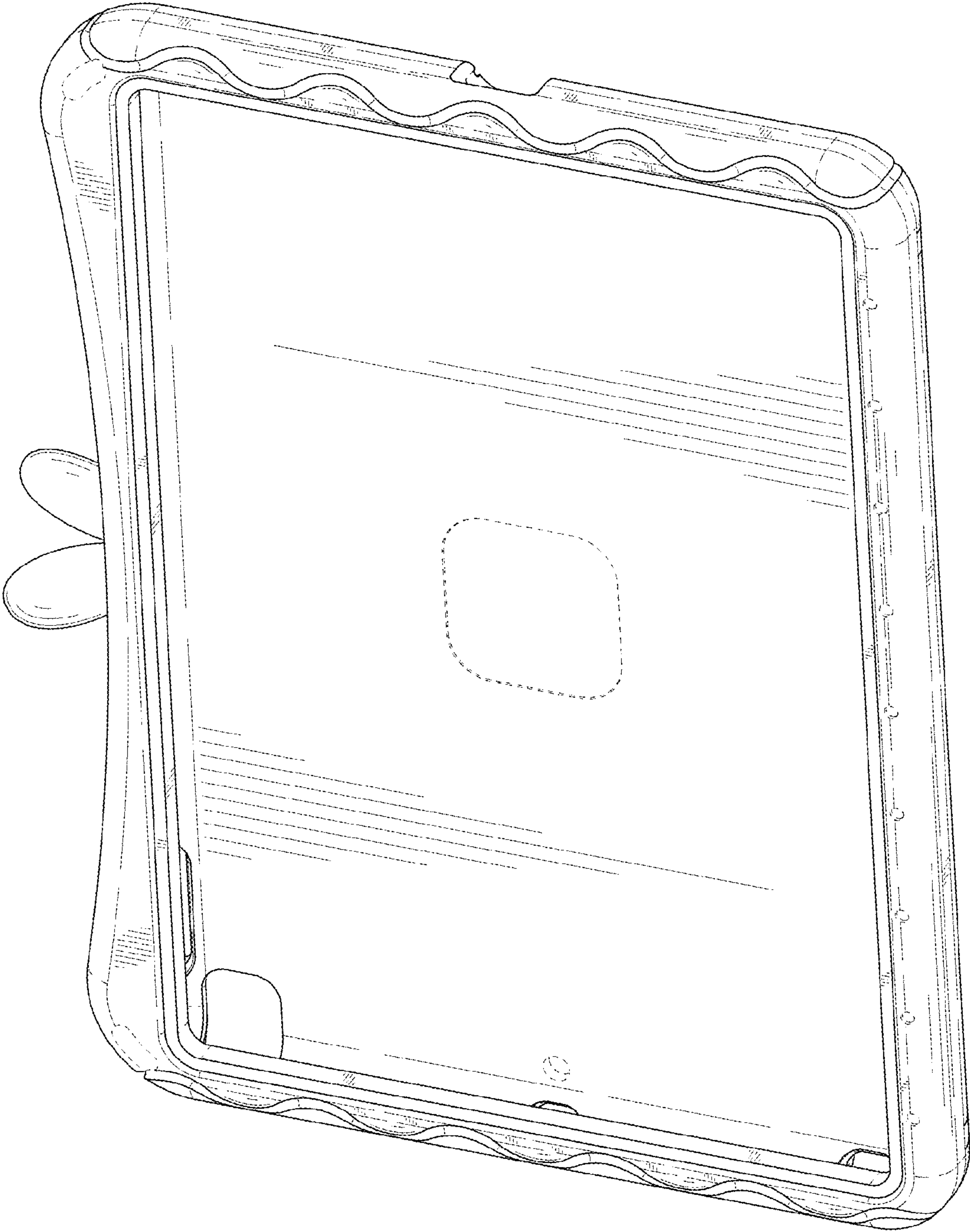

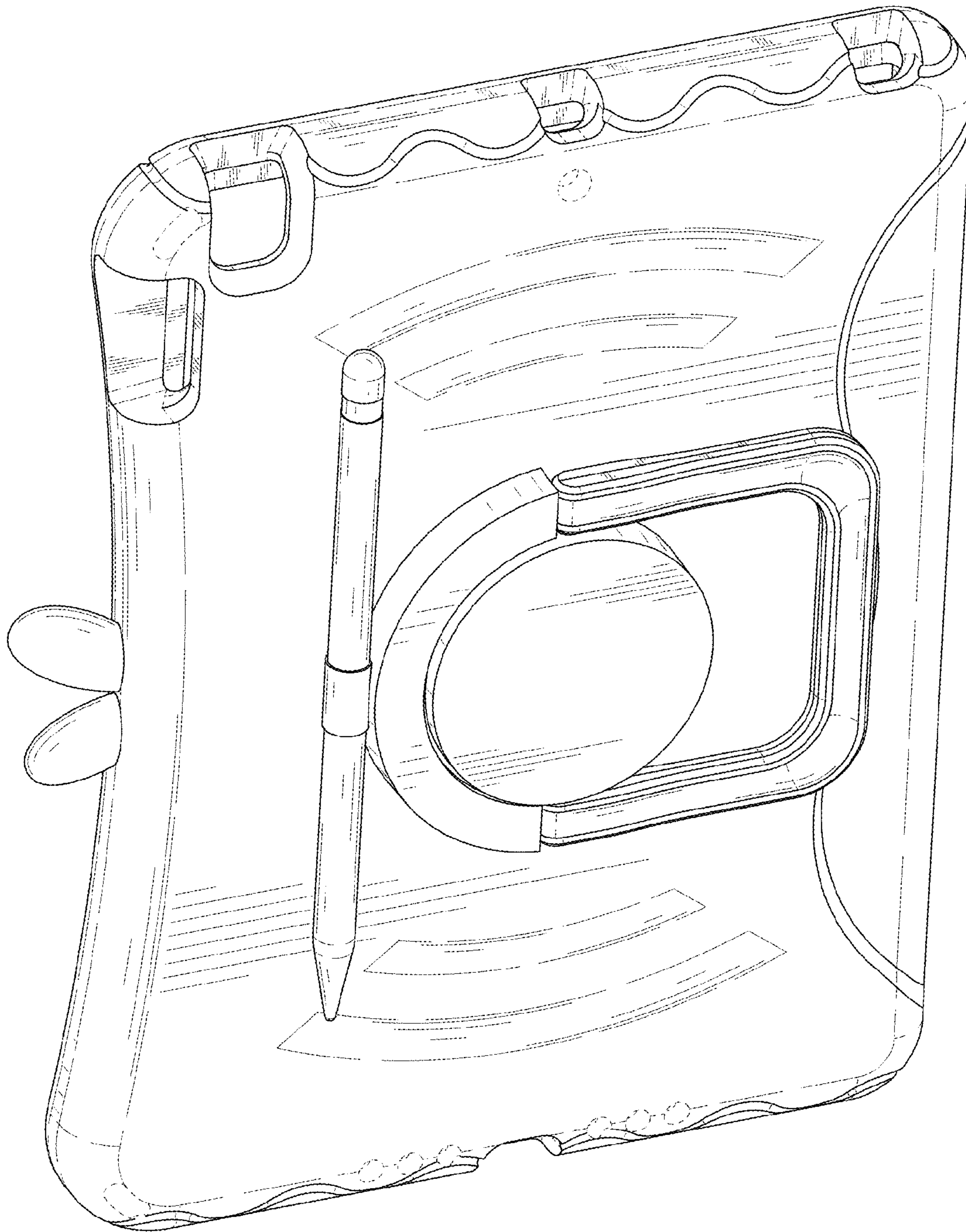

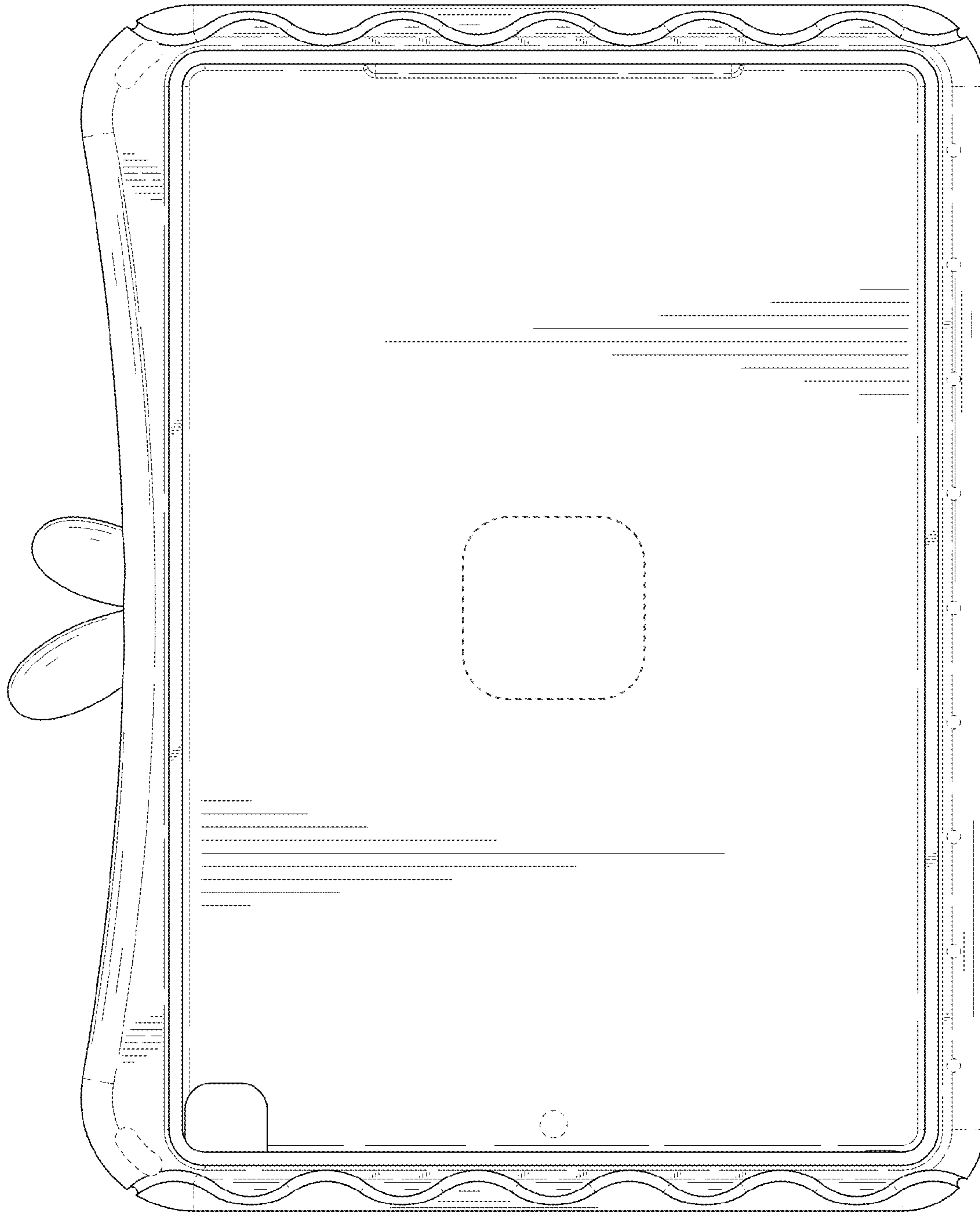

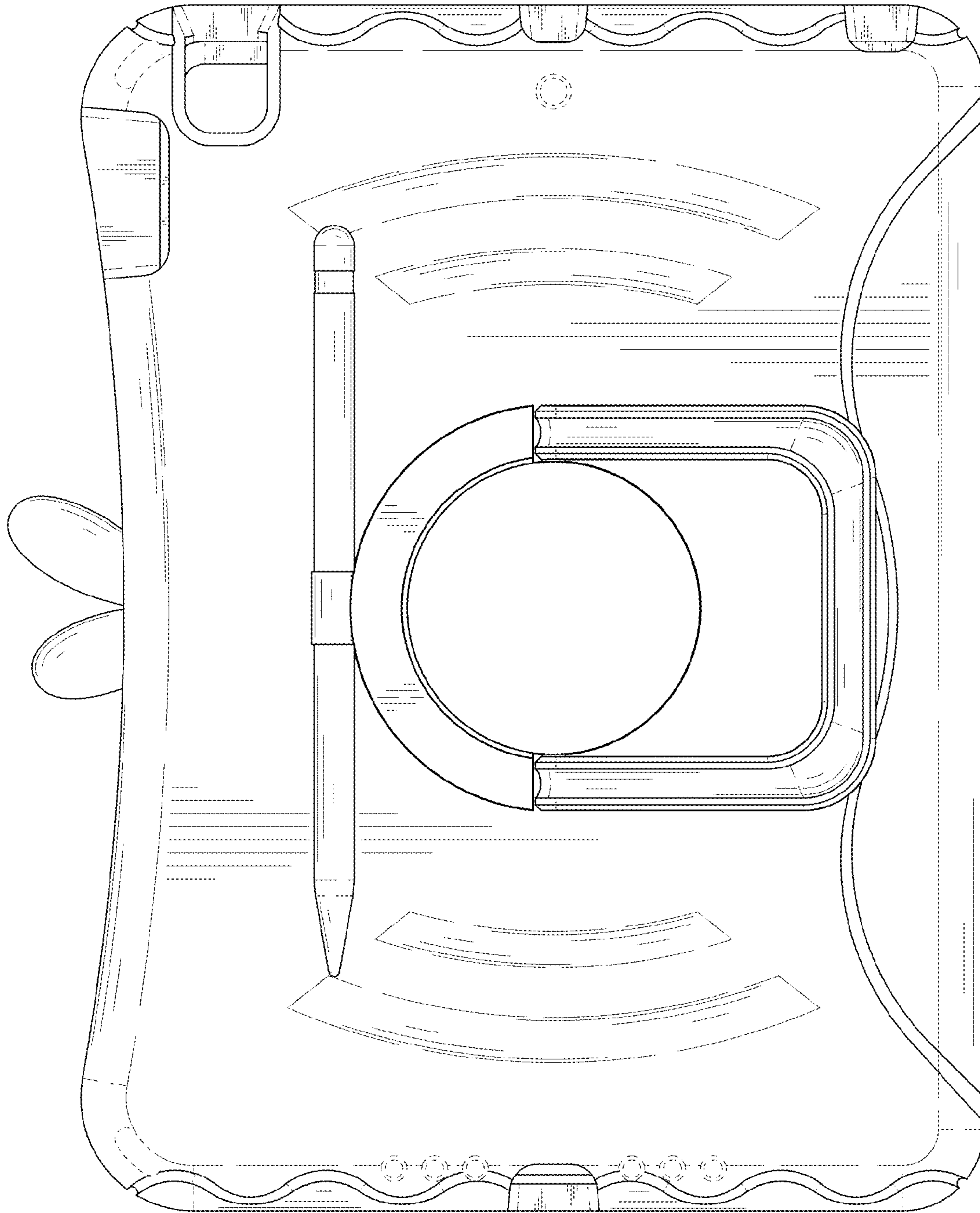

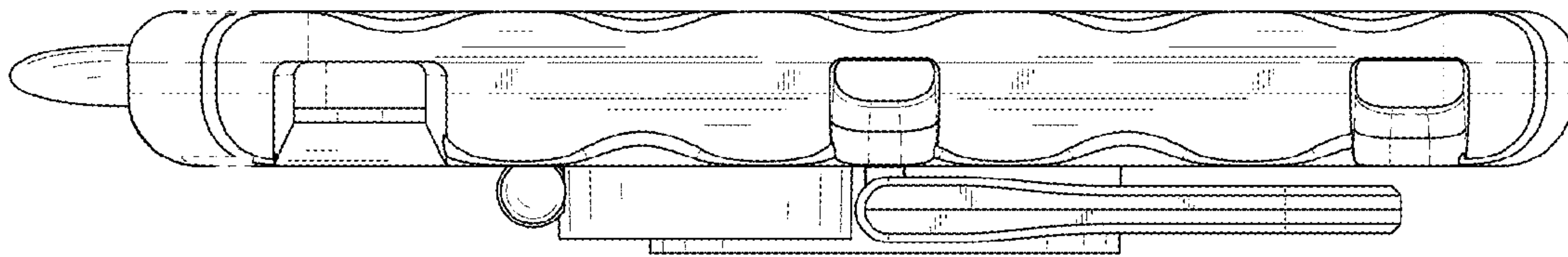

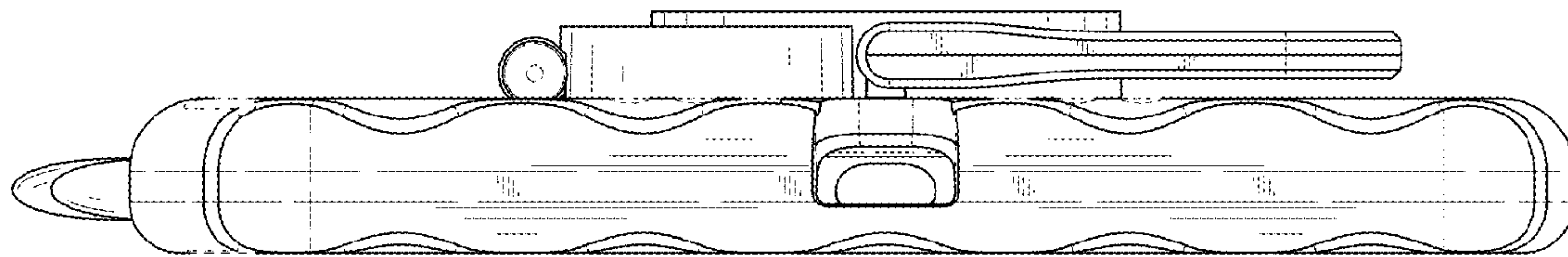

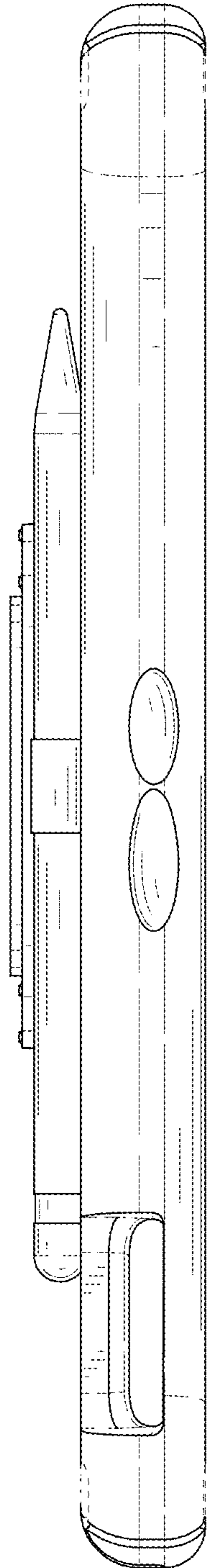

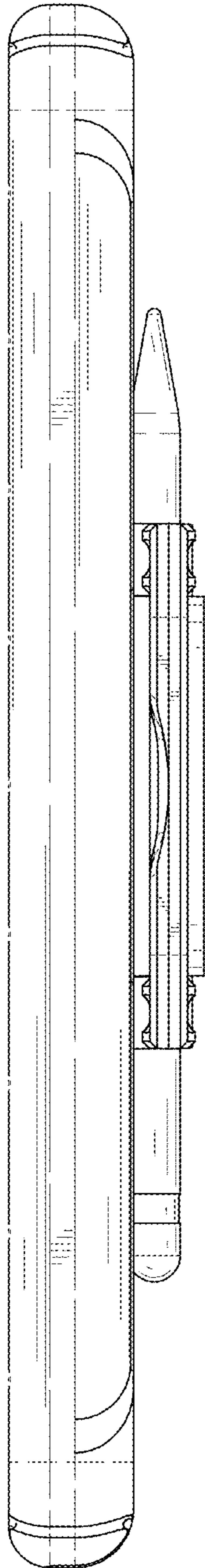

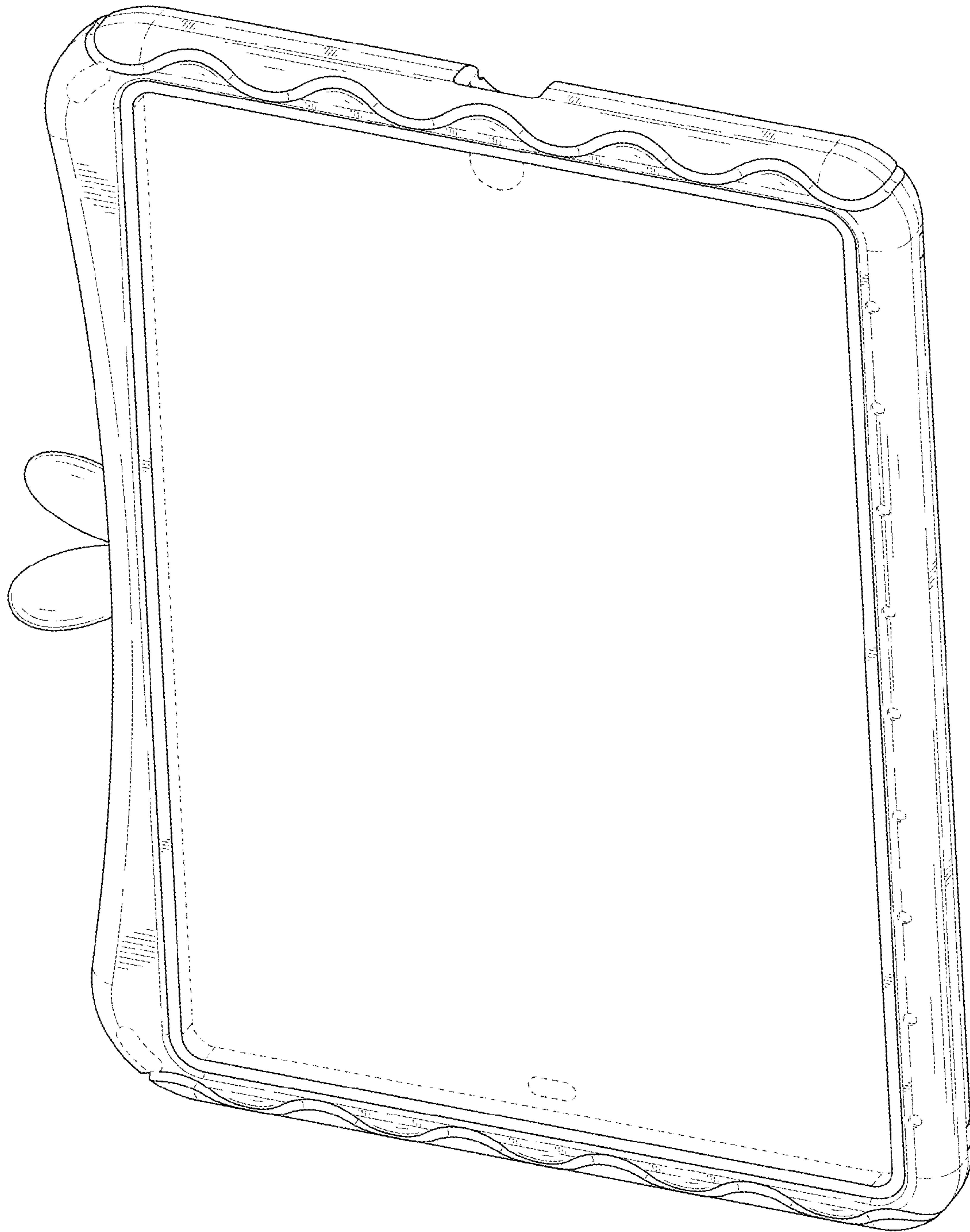

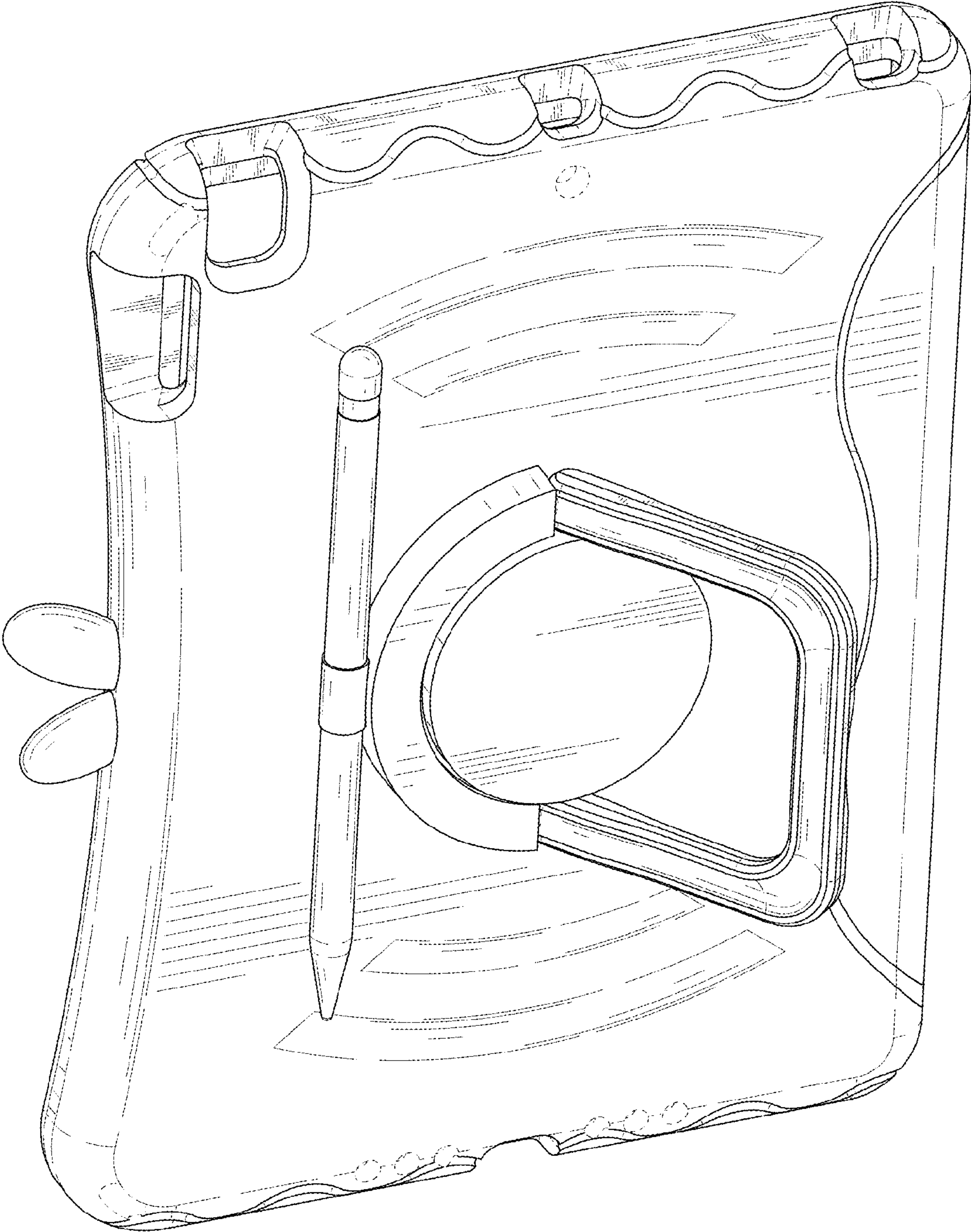
