FIG. 2 is a front view of the invention illustrated in FIG. 1, depicting the door thereof in an open position;

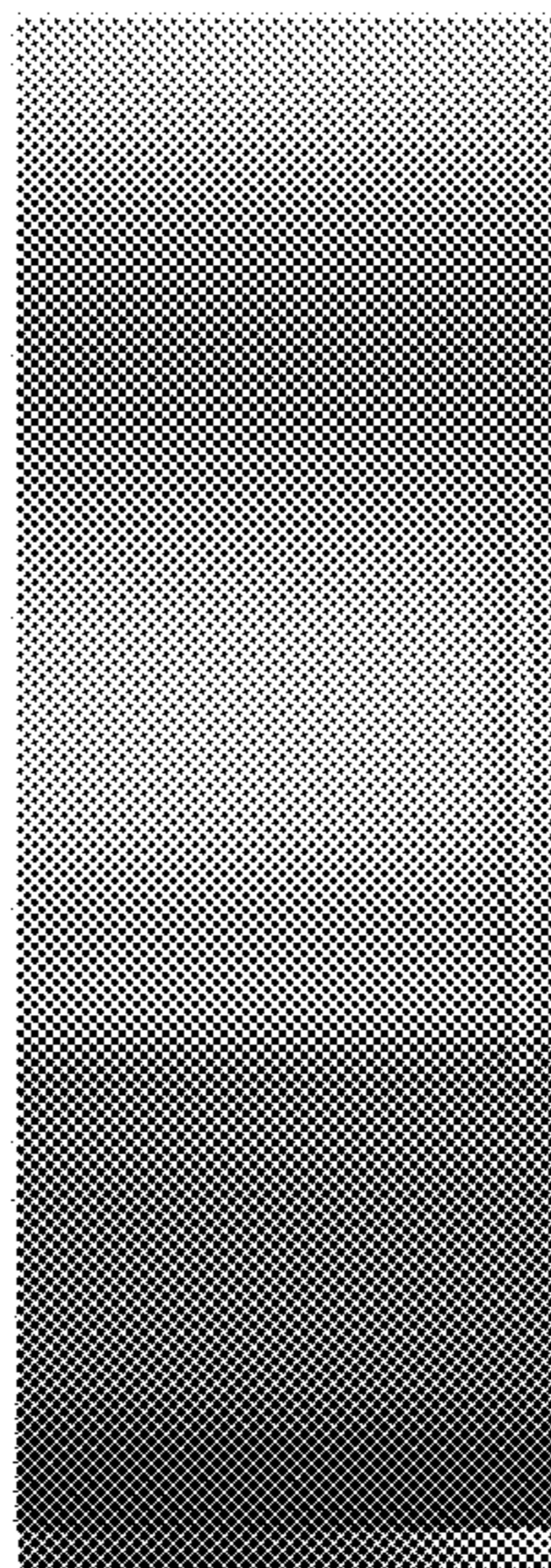
FIG. 3 is a front perspective view of the invention illustrated in FIG. 1, depicting the door thereof in a closed position;

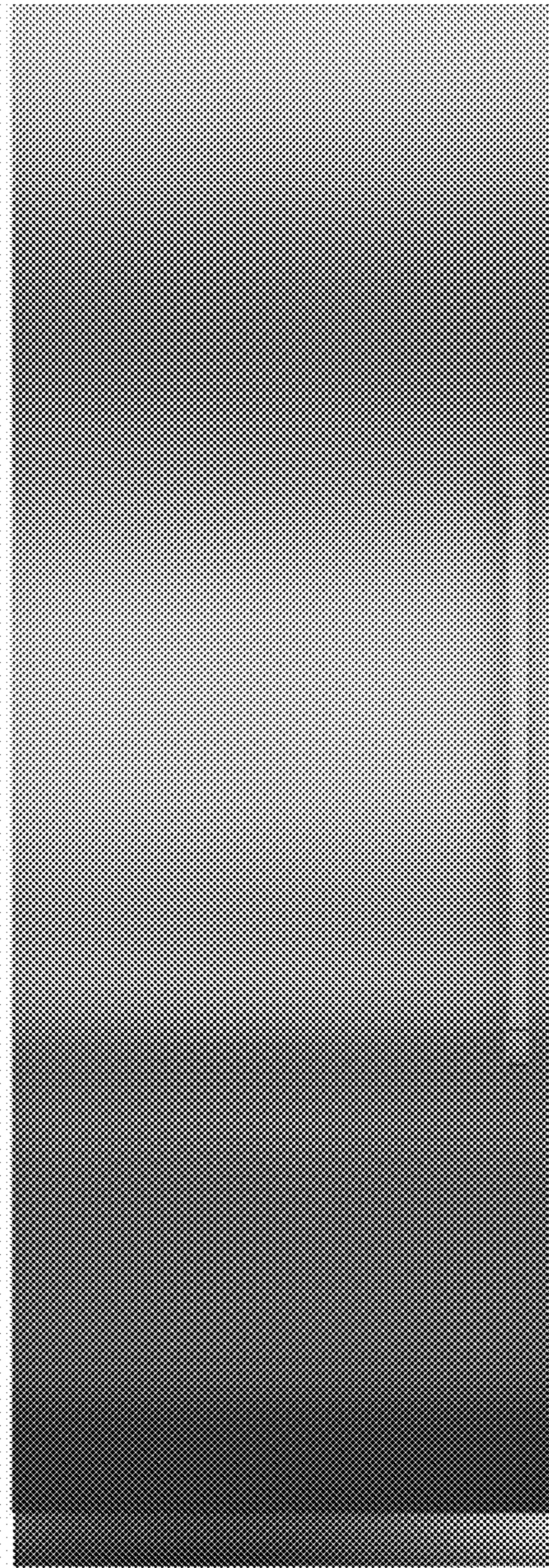

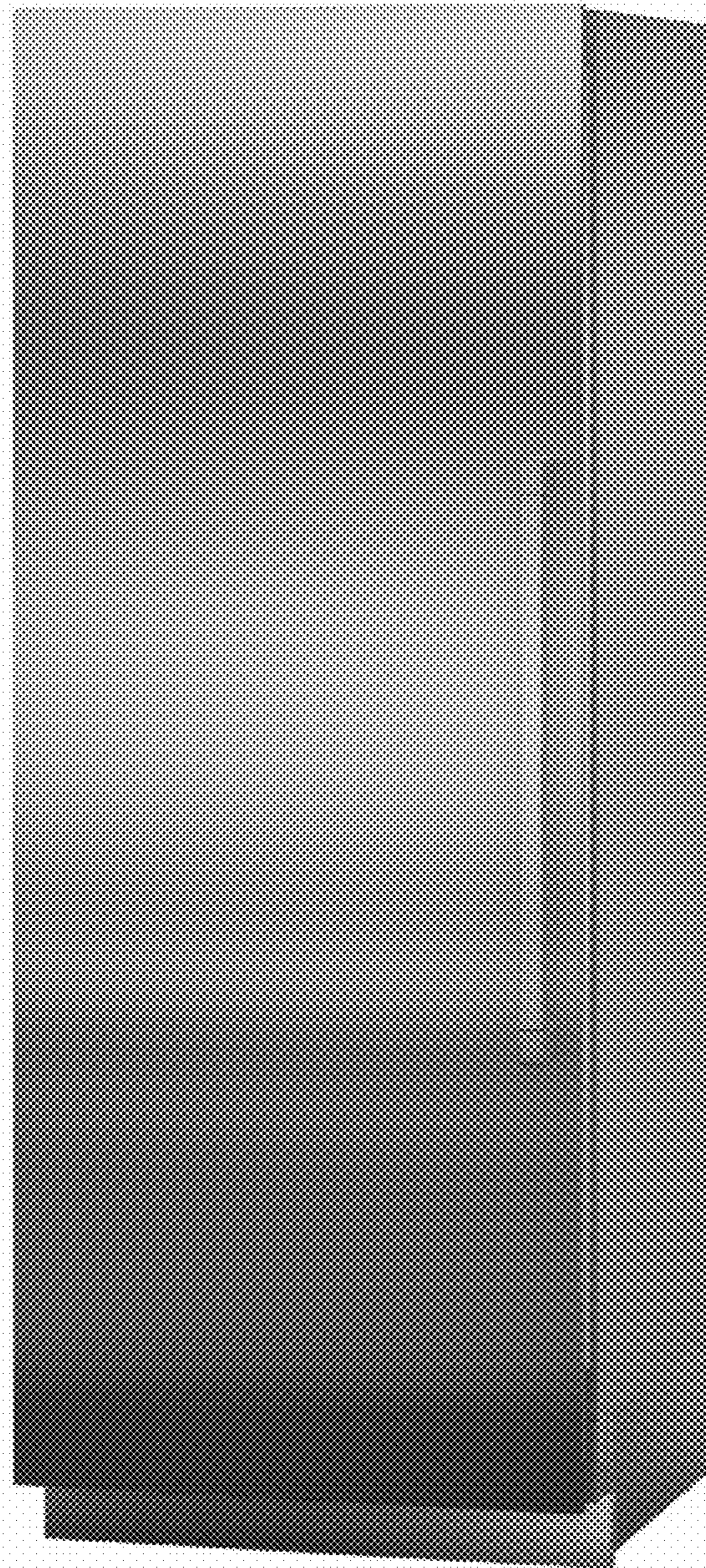

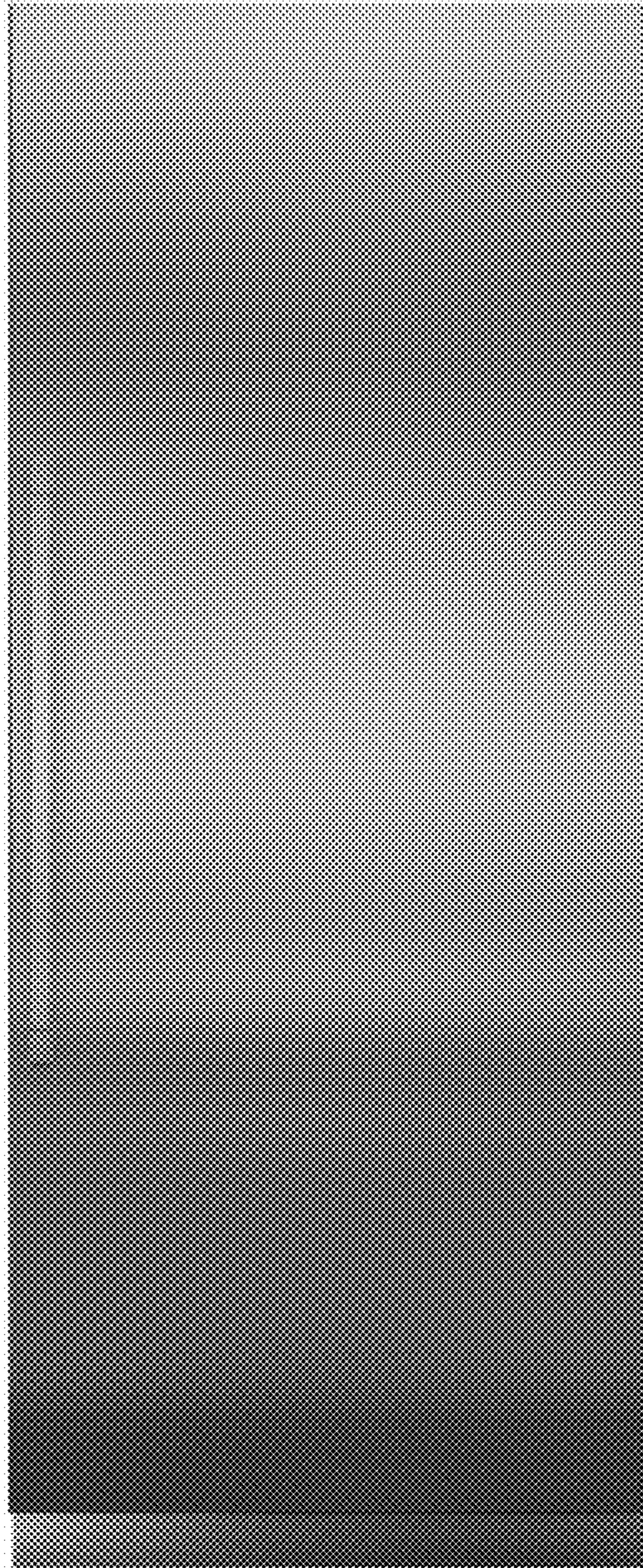

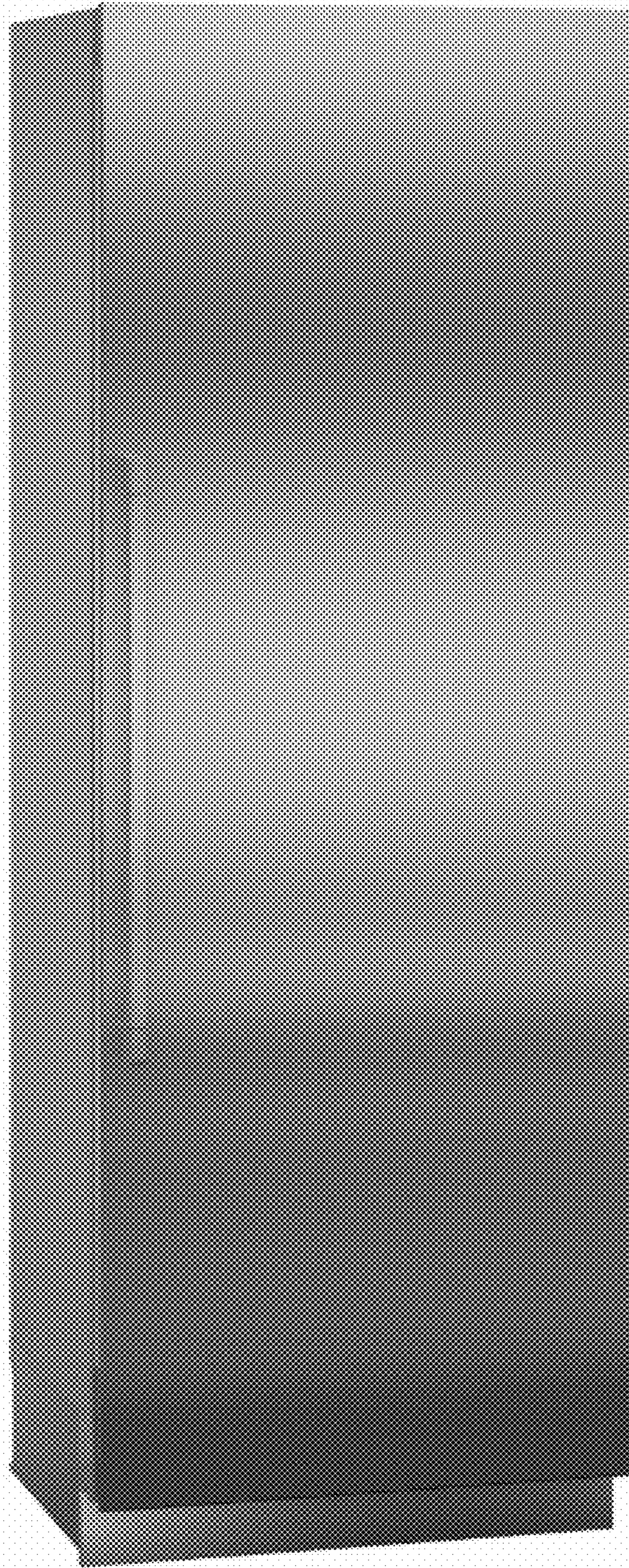
