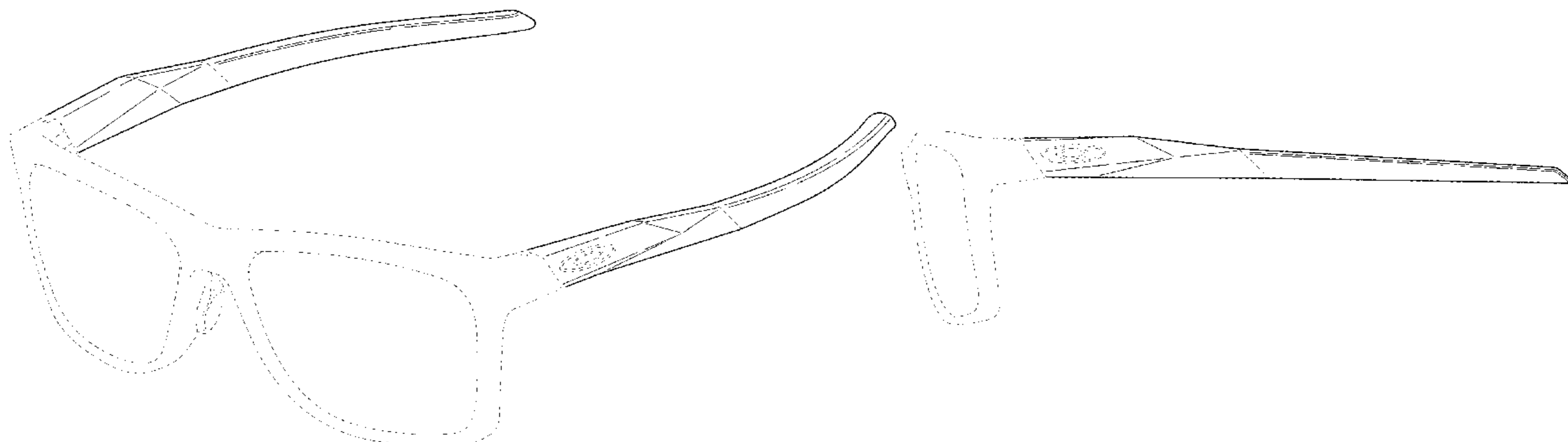

**DESCRIPTION**  
FIG. 1 is a top front perspective view of eyeglasses showing the claimed design;

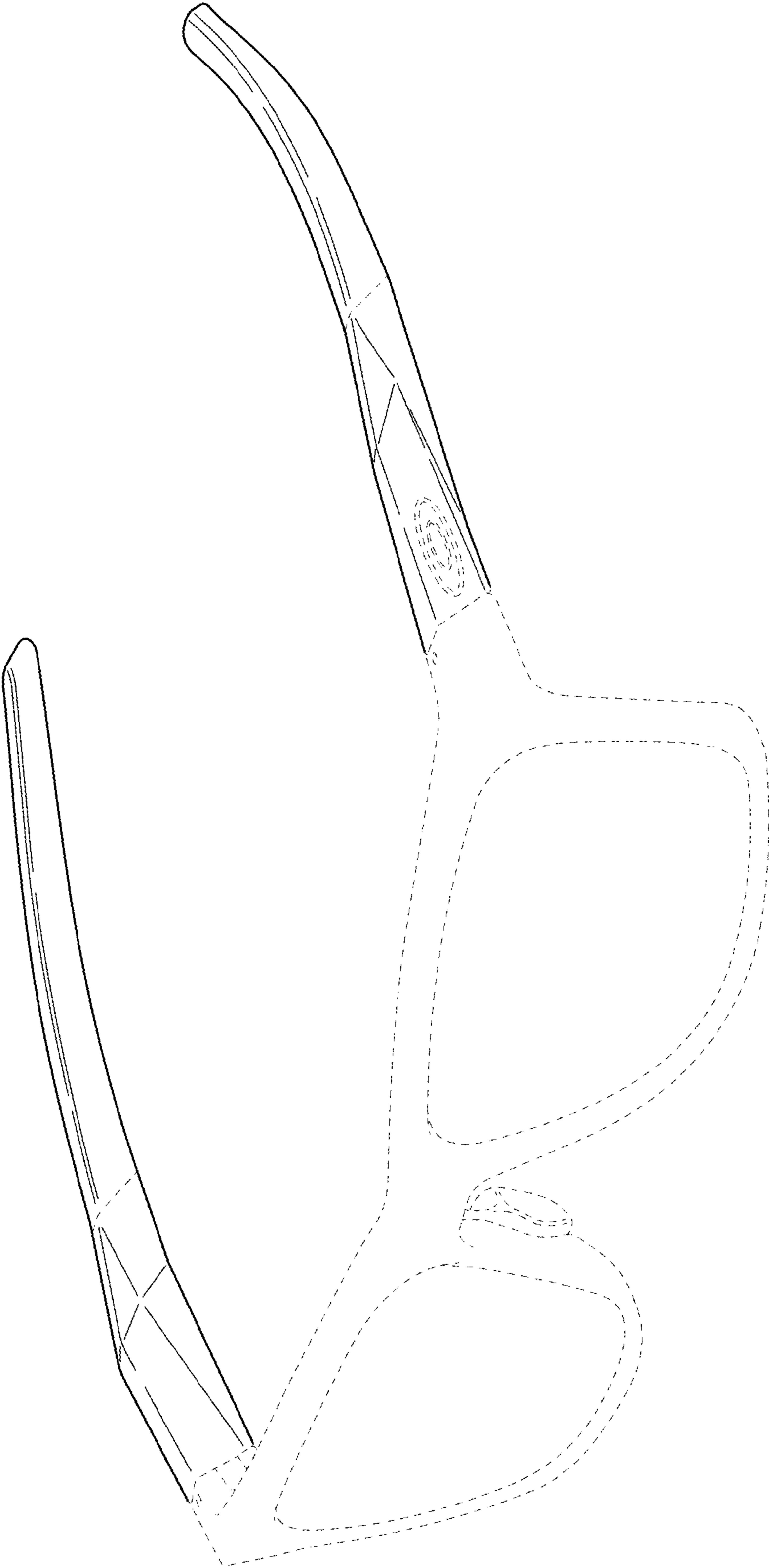
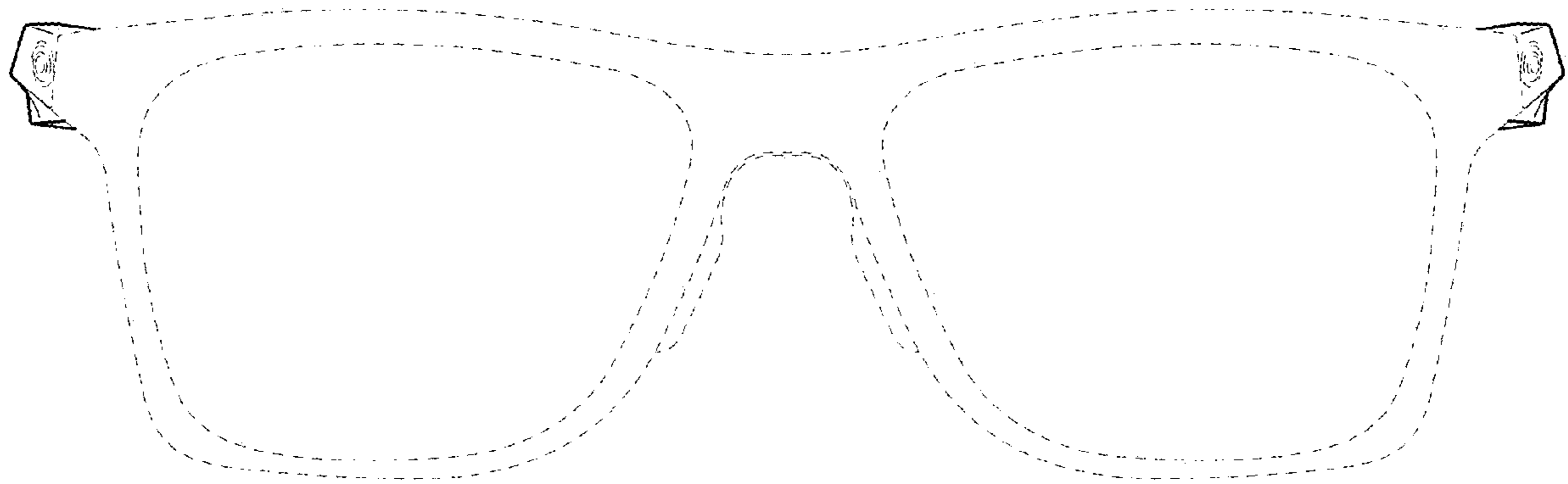
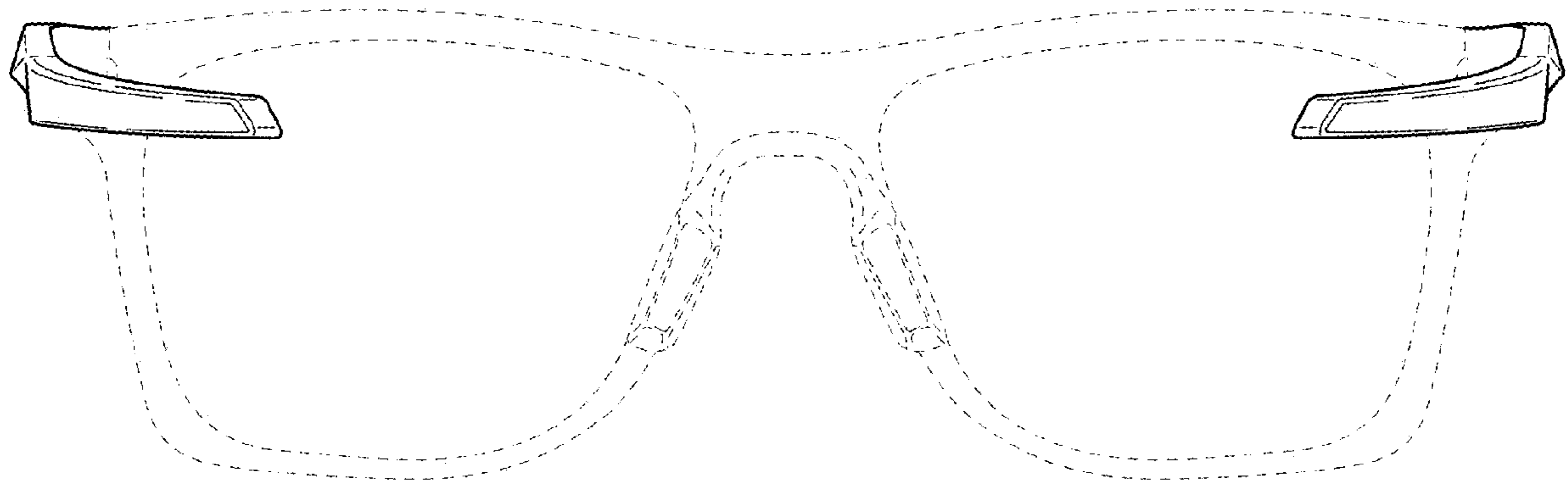

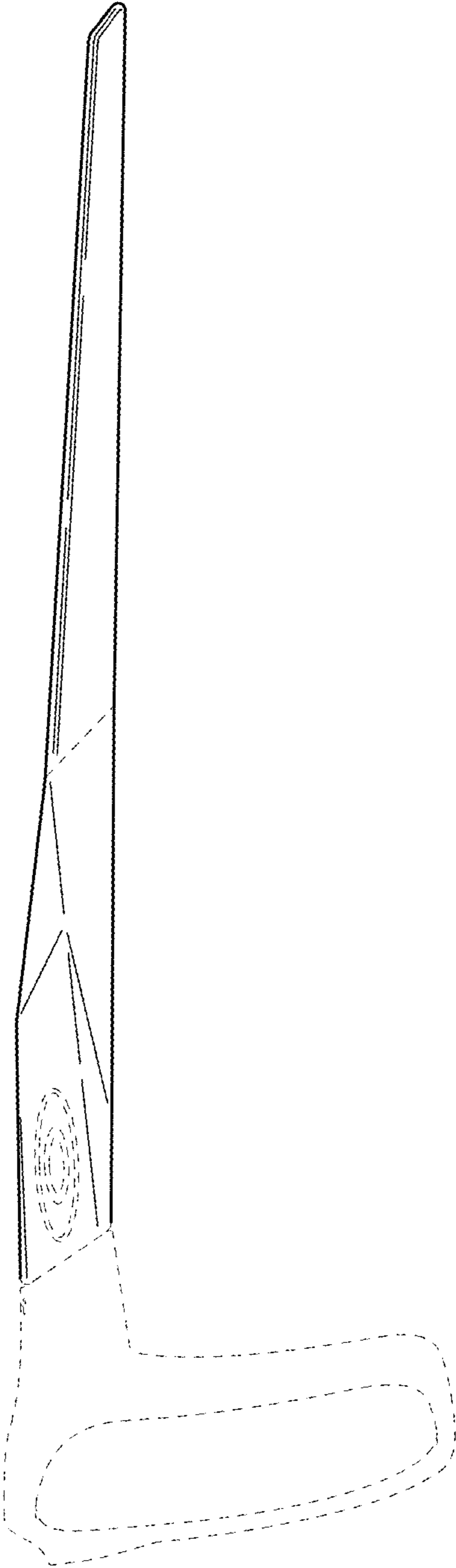

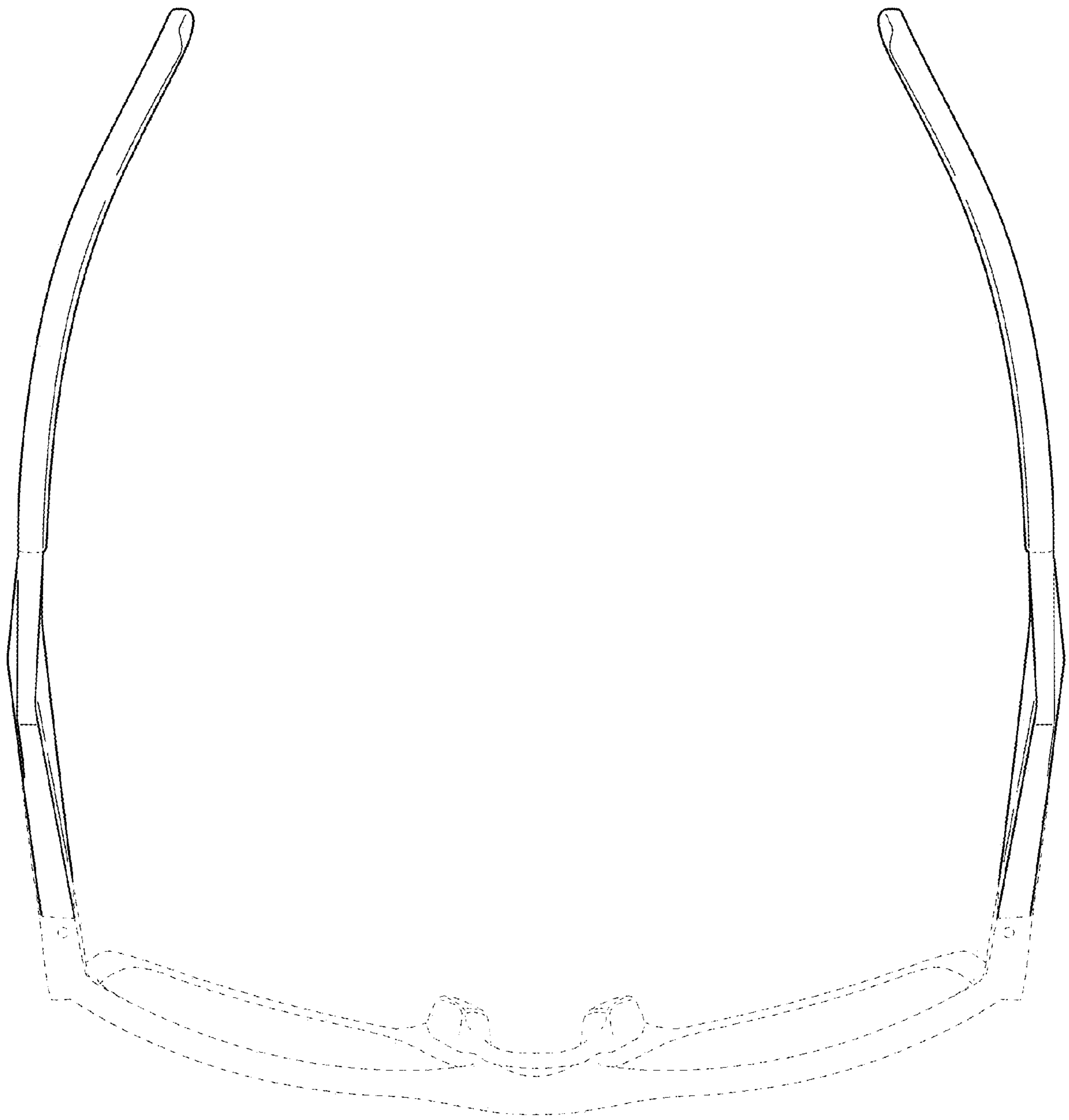

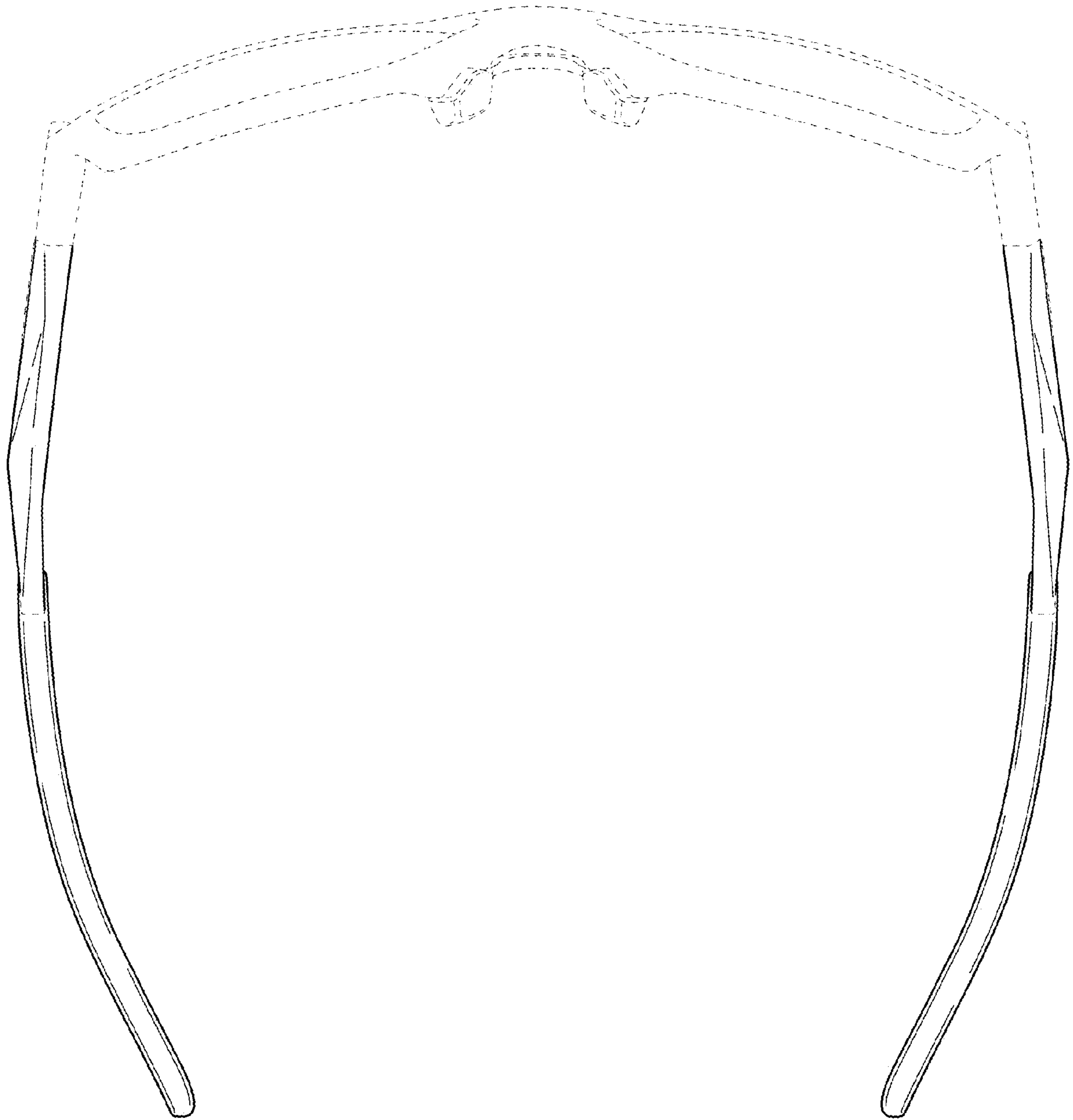
