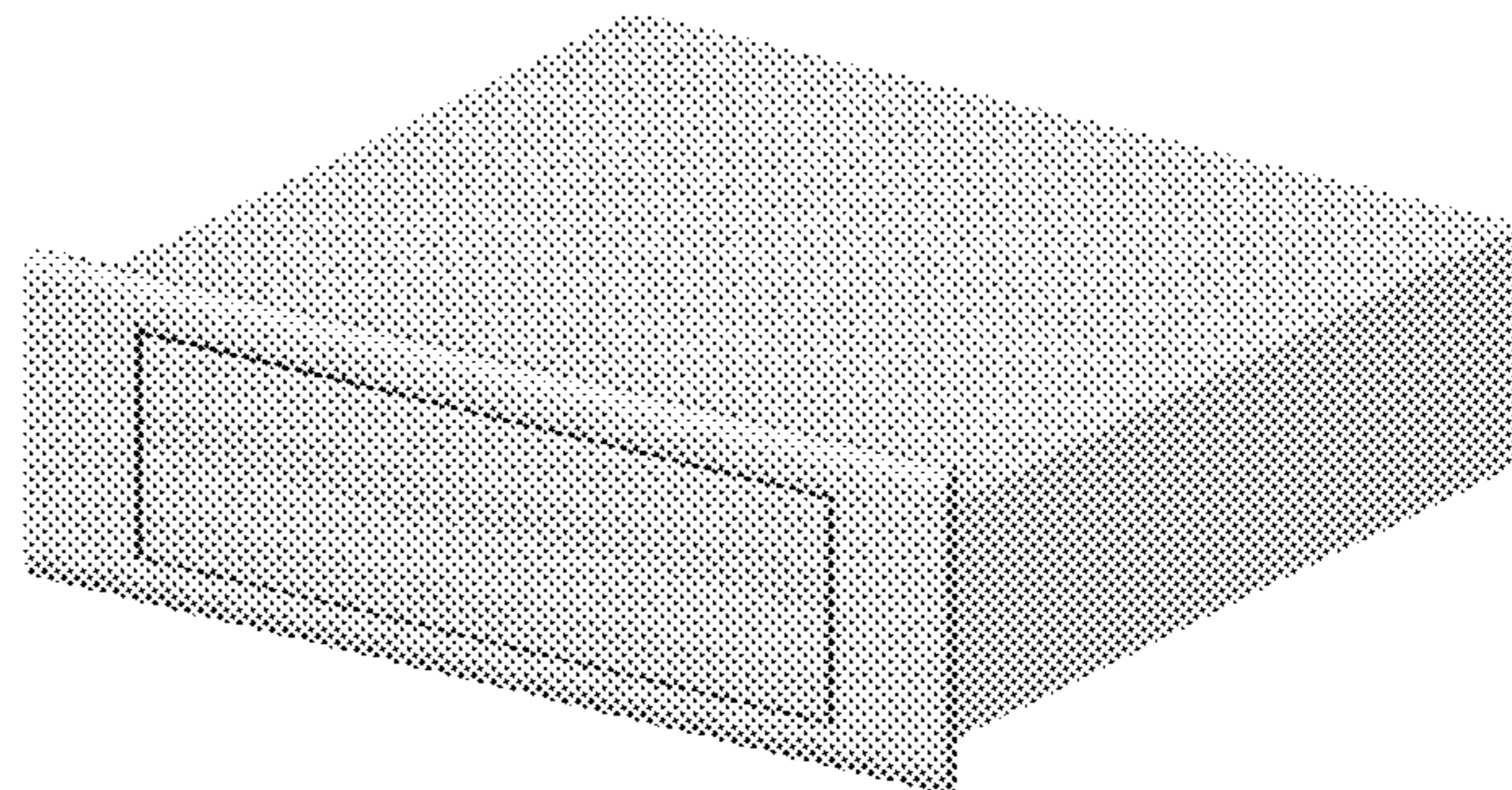
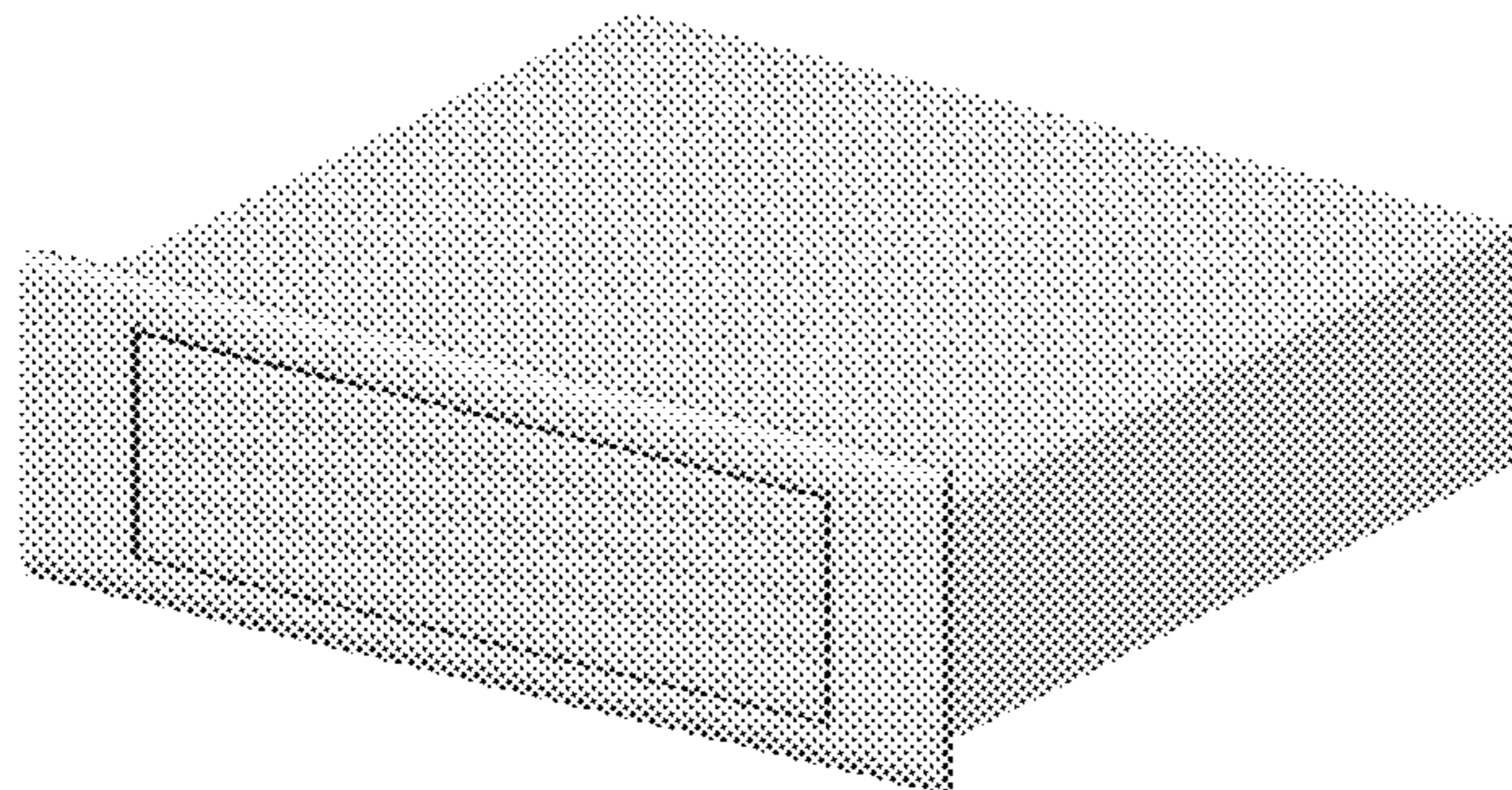


FIG. 18. is a top plan view thereof;

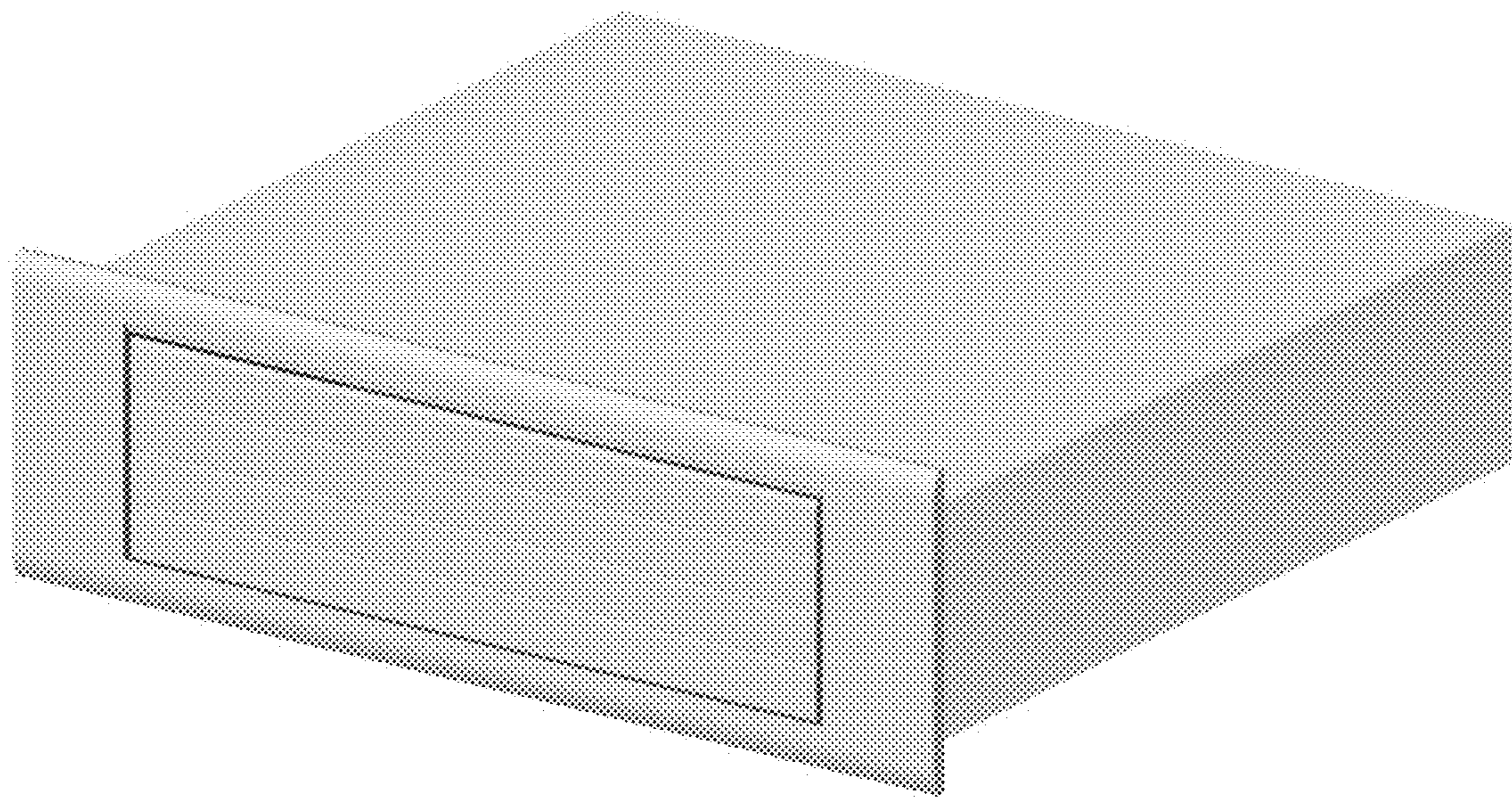

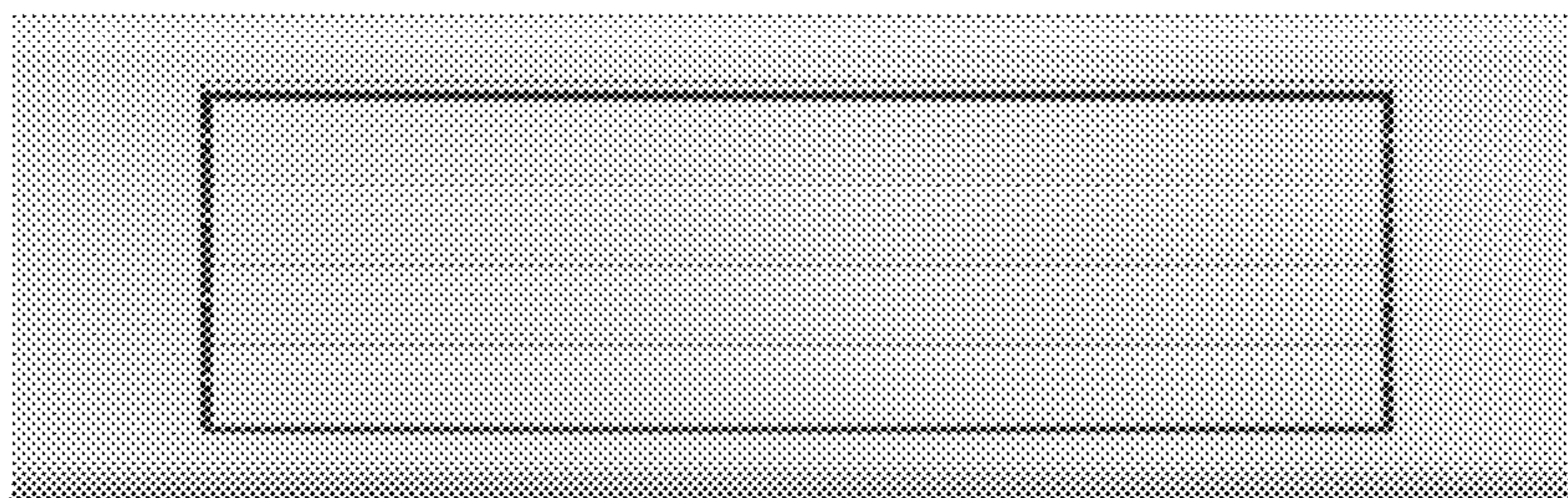

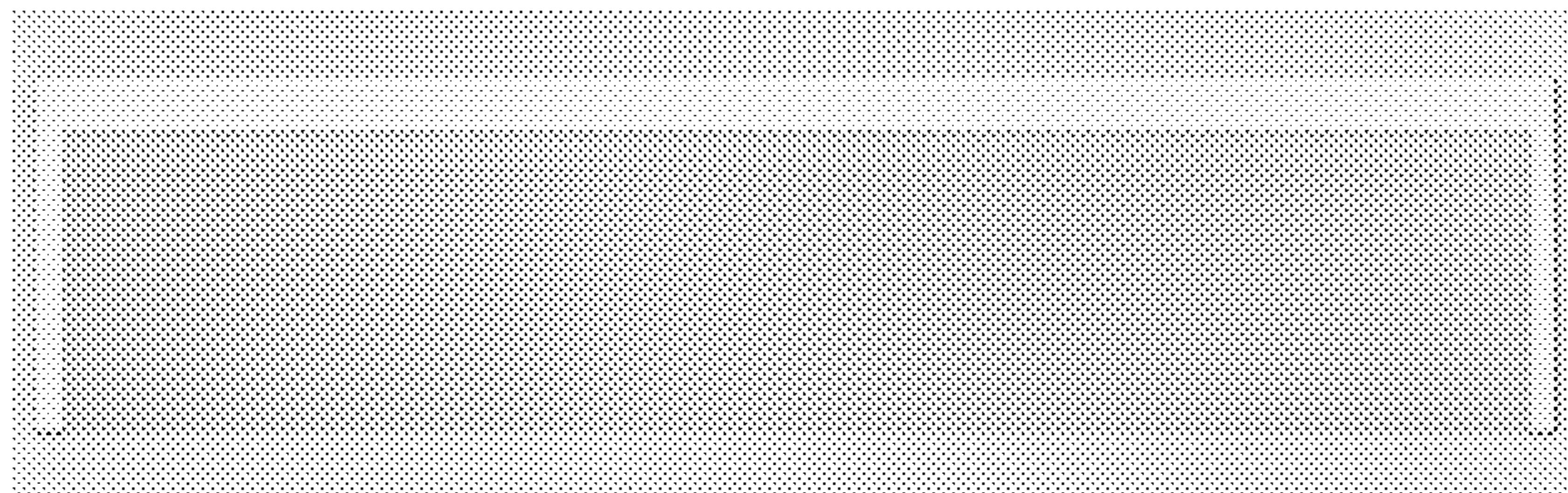

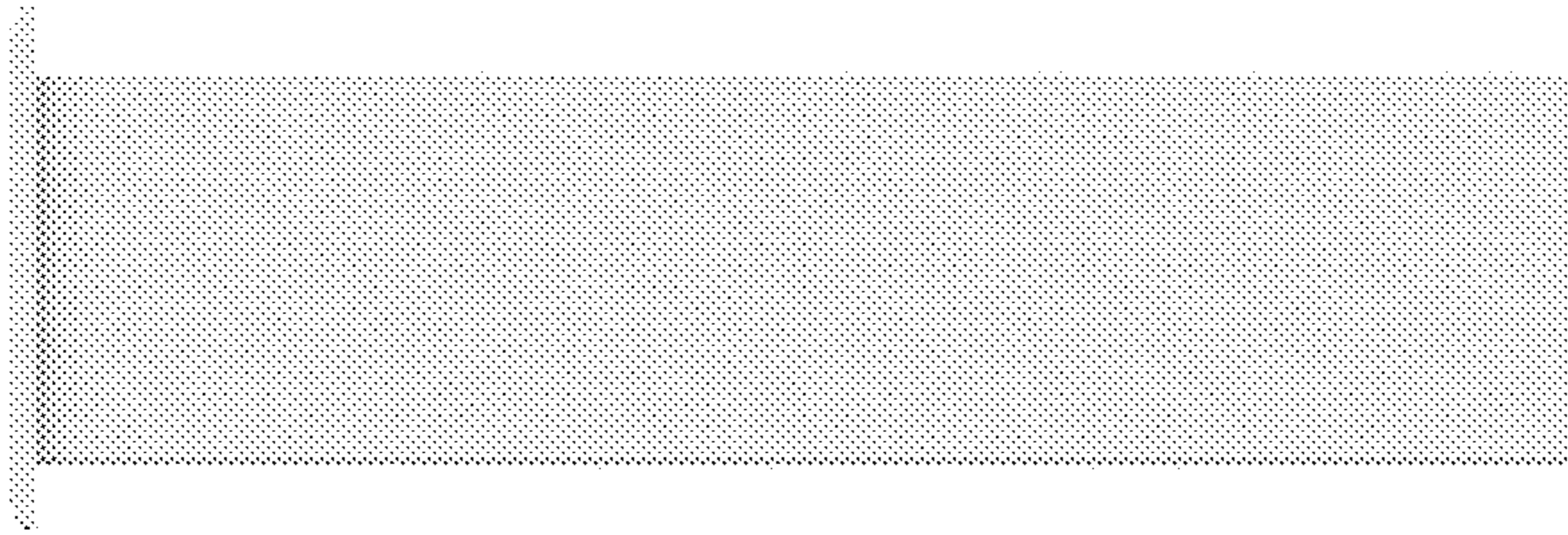

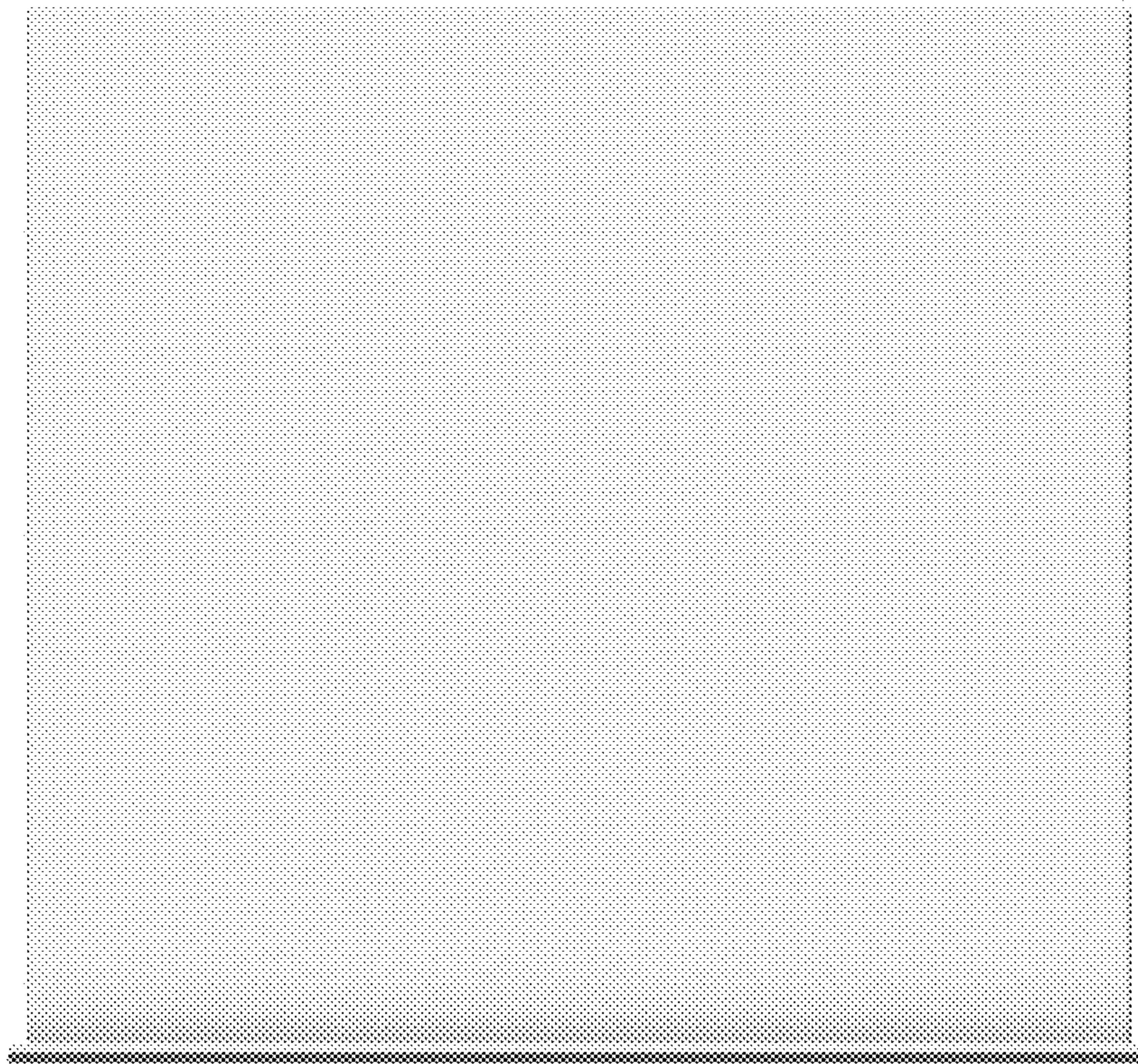

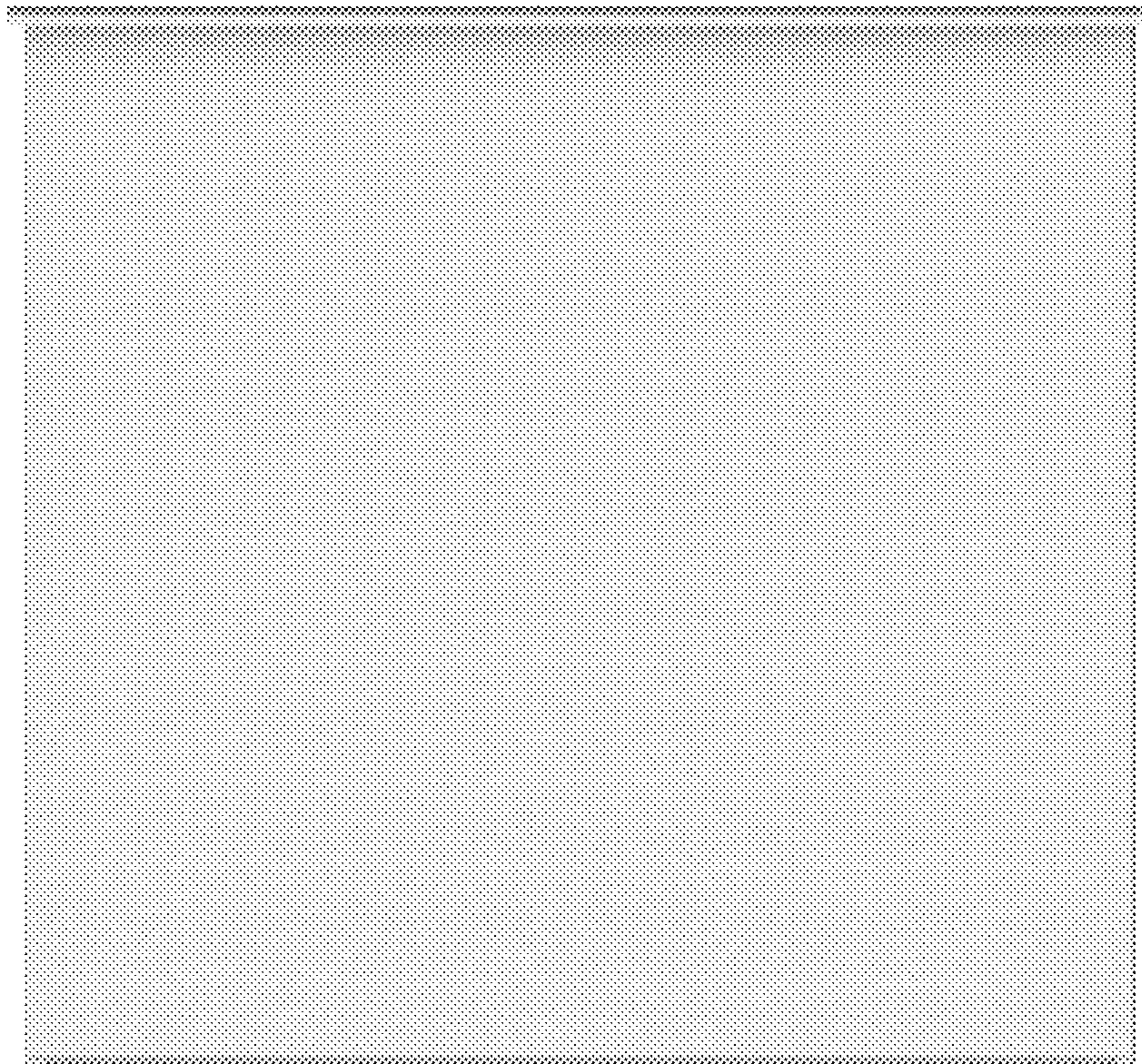

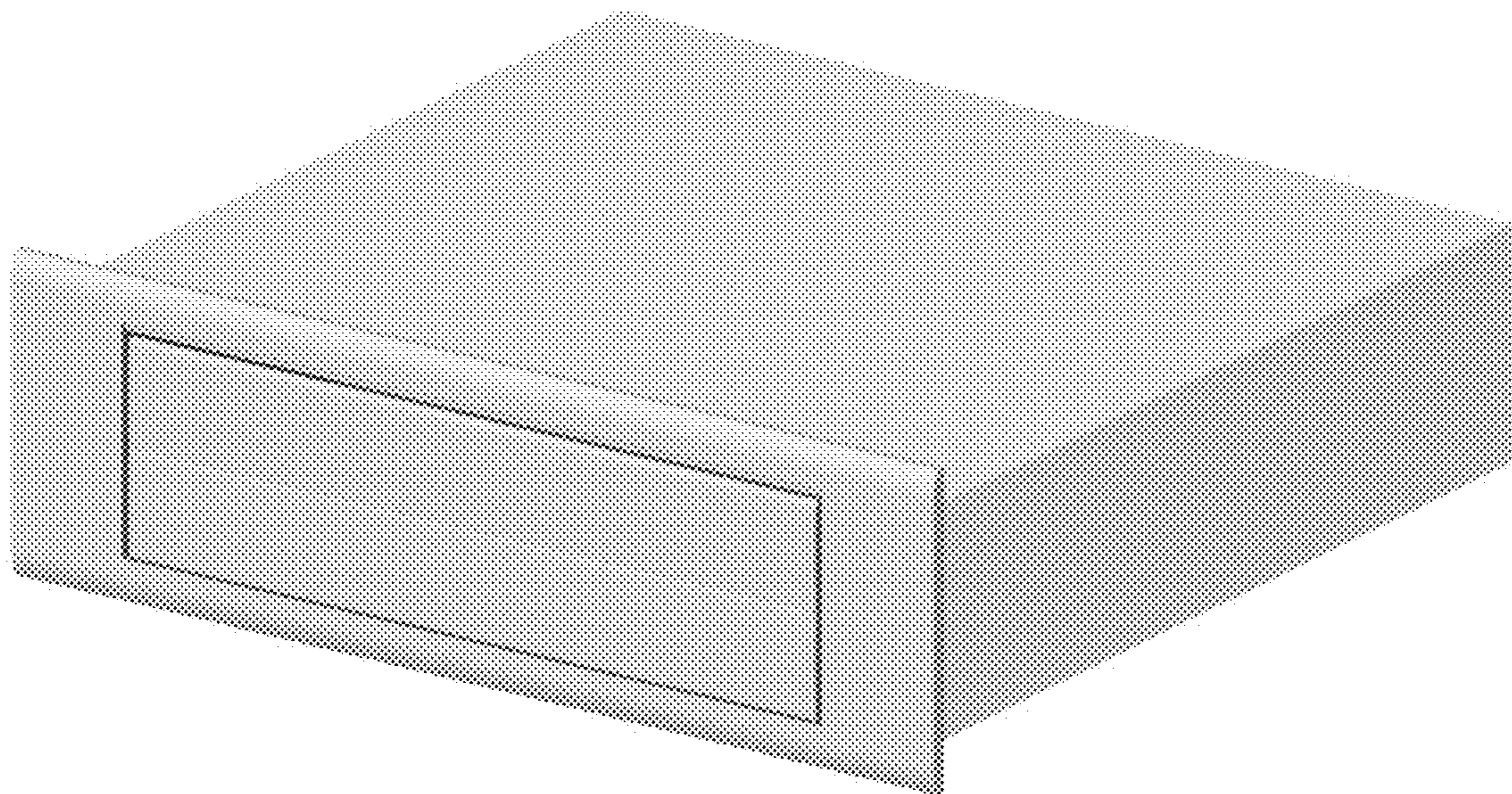

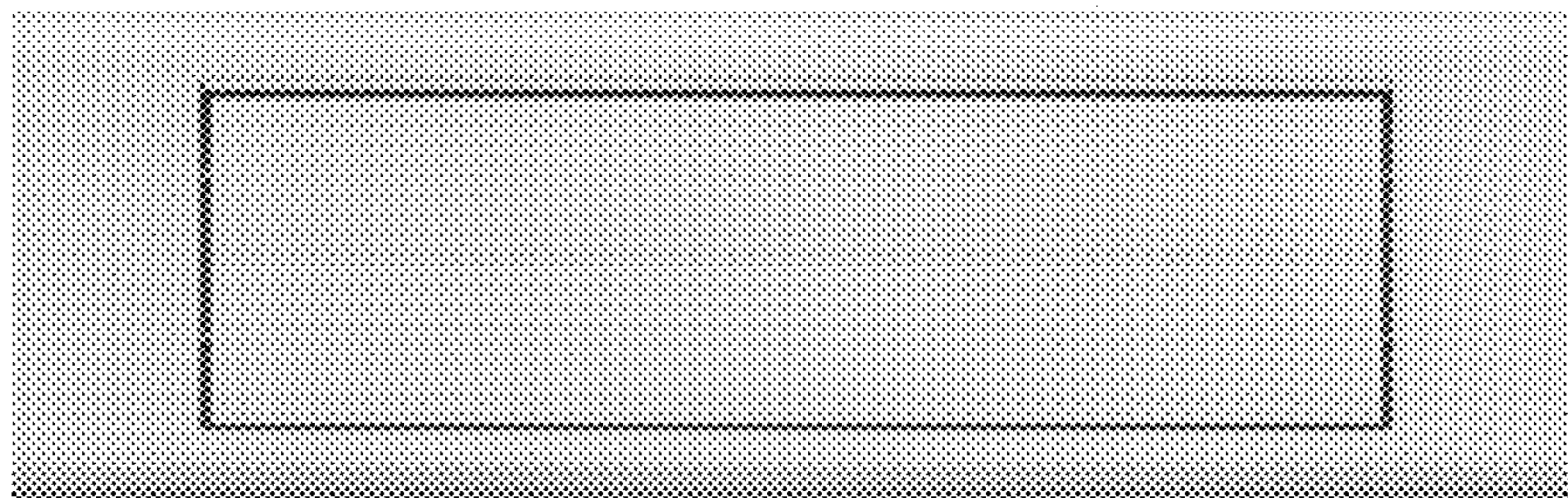

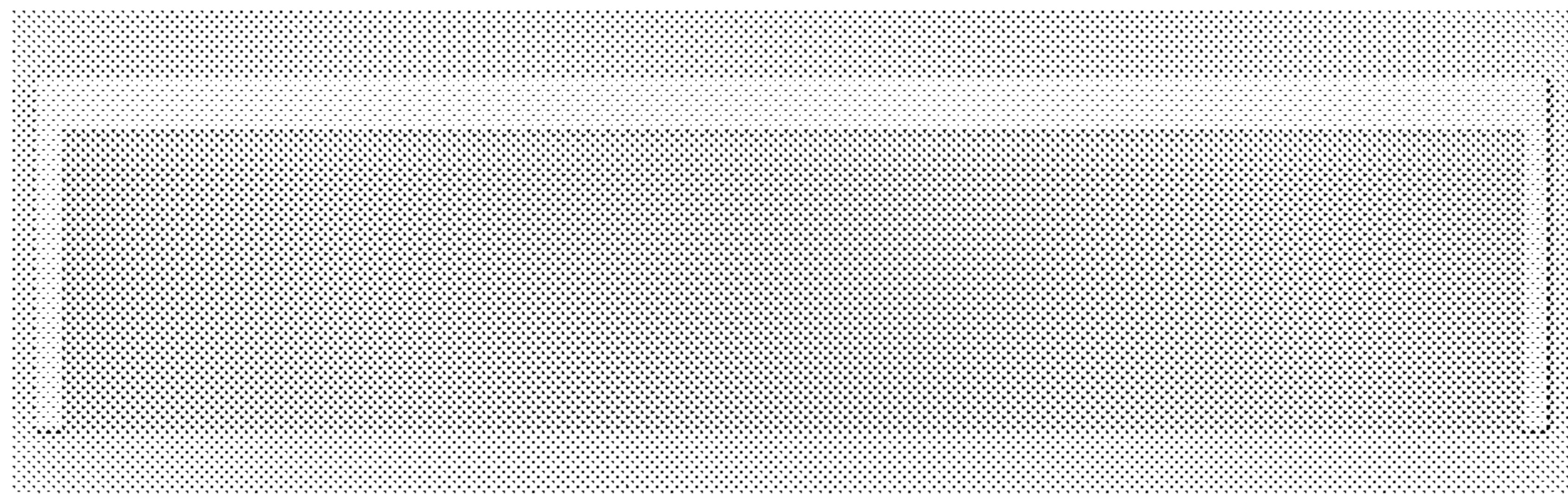

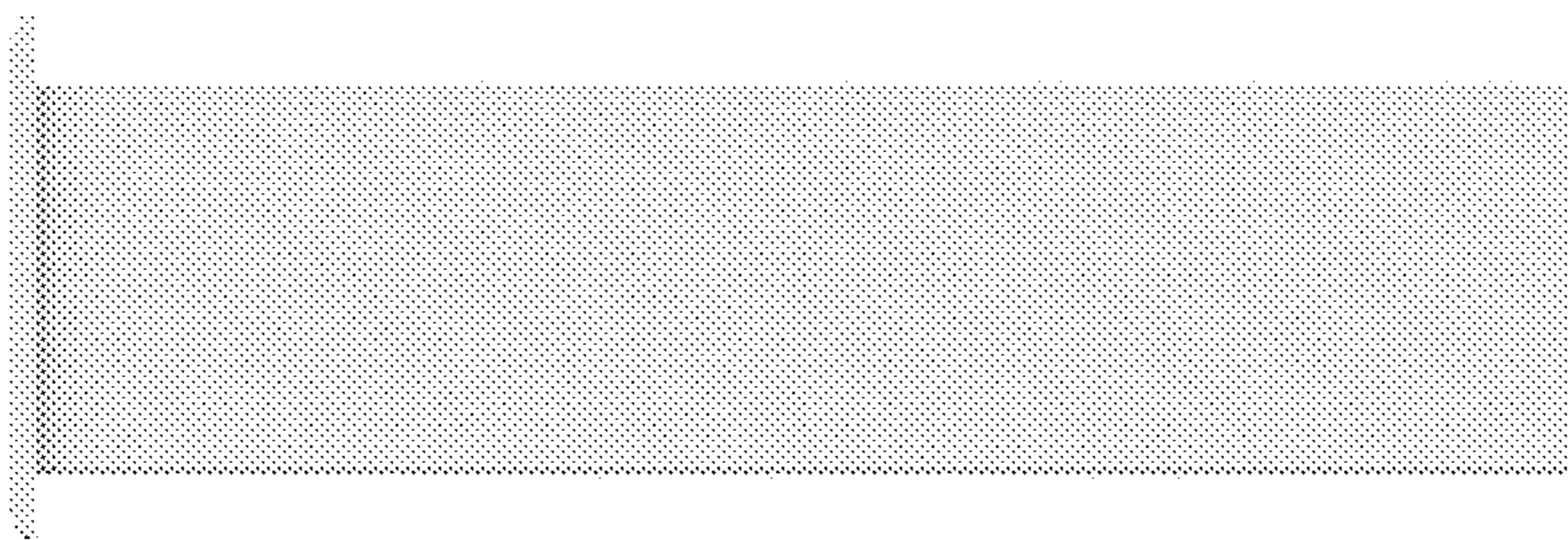

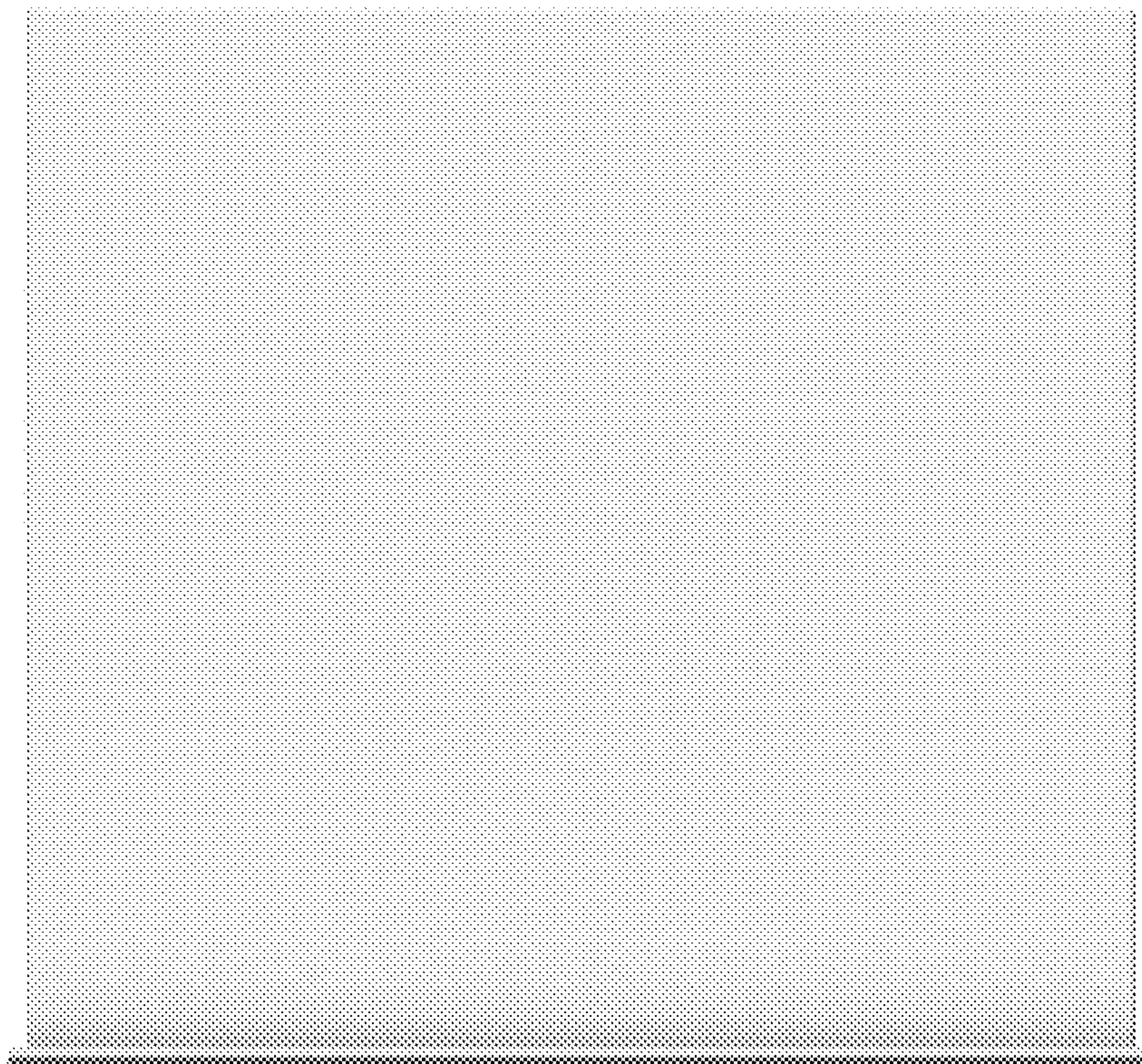

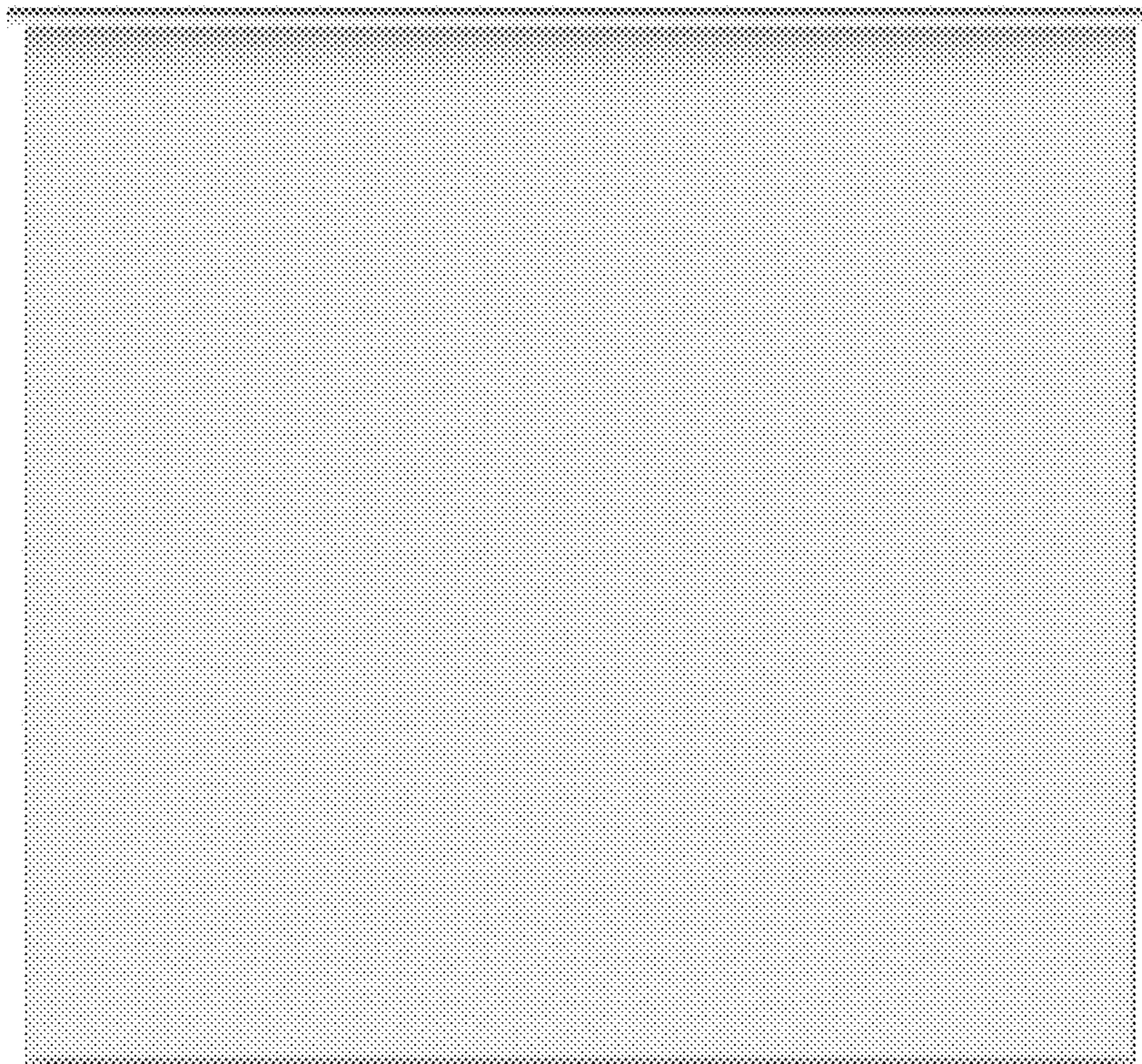

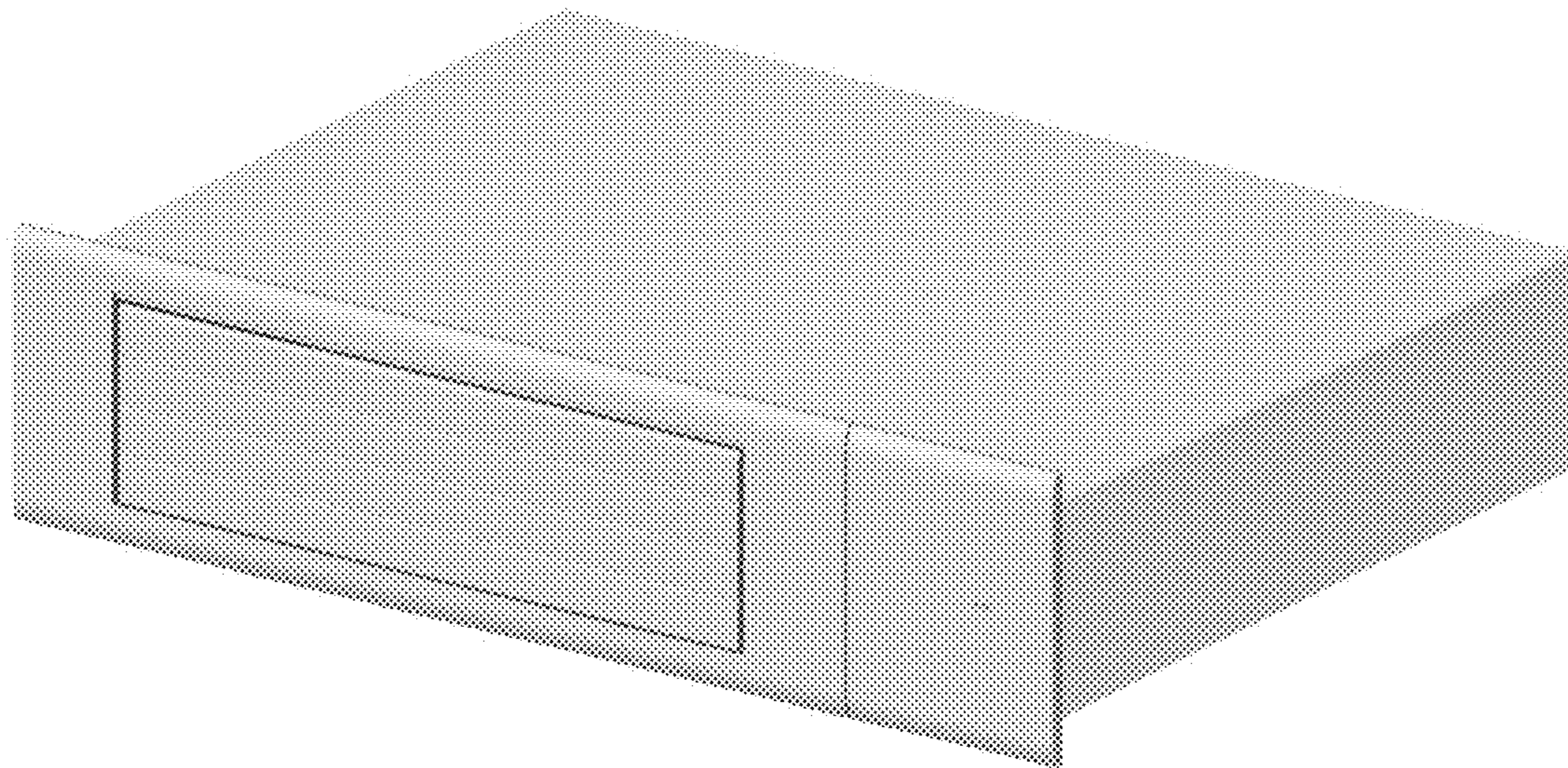

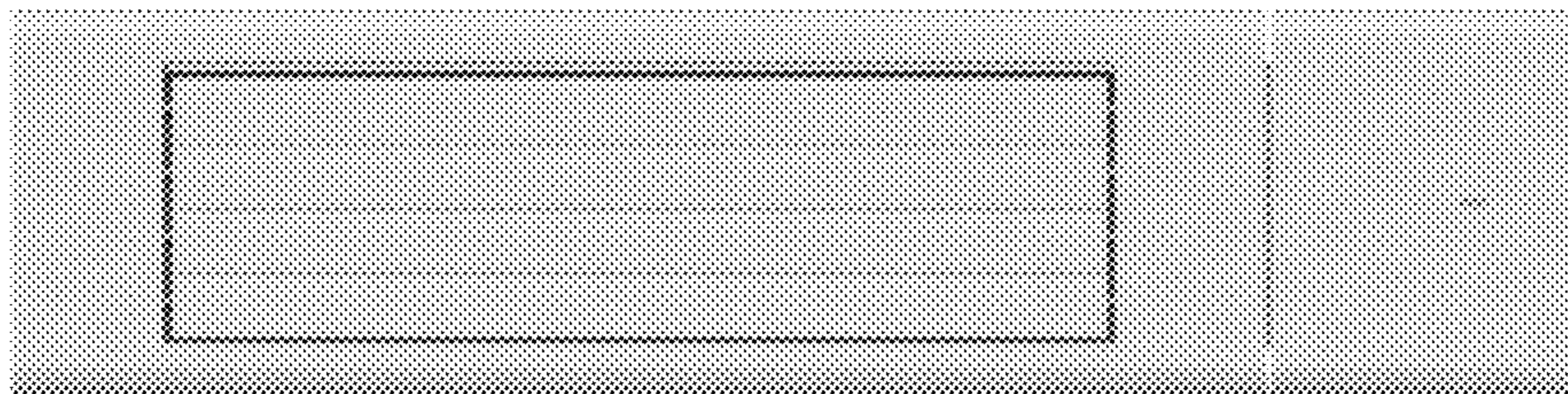

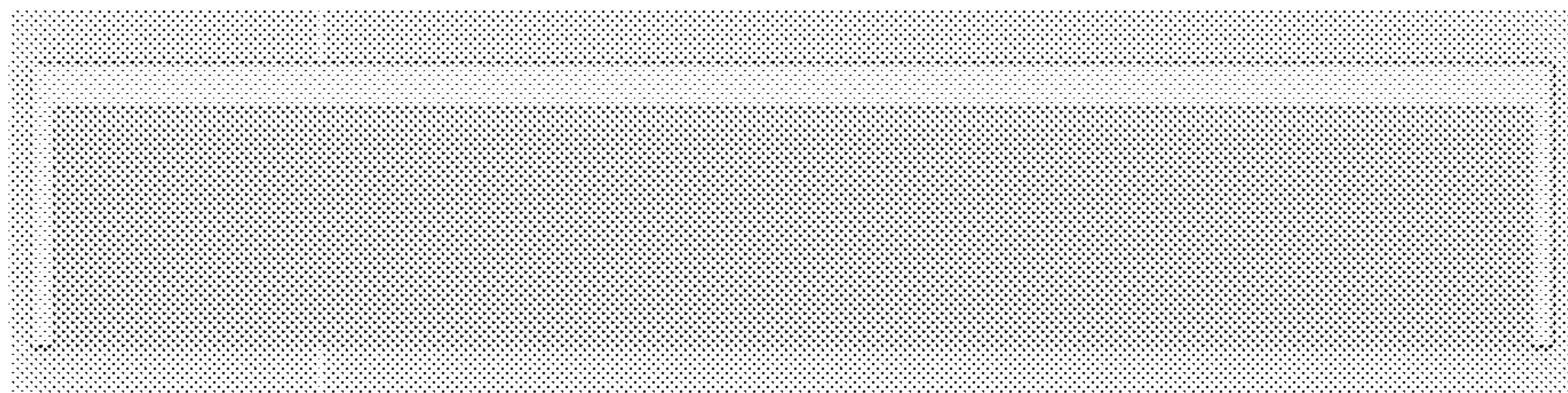

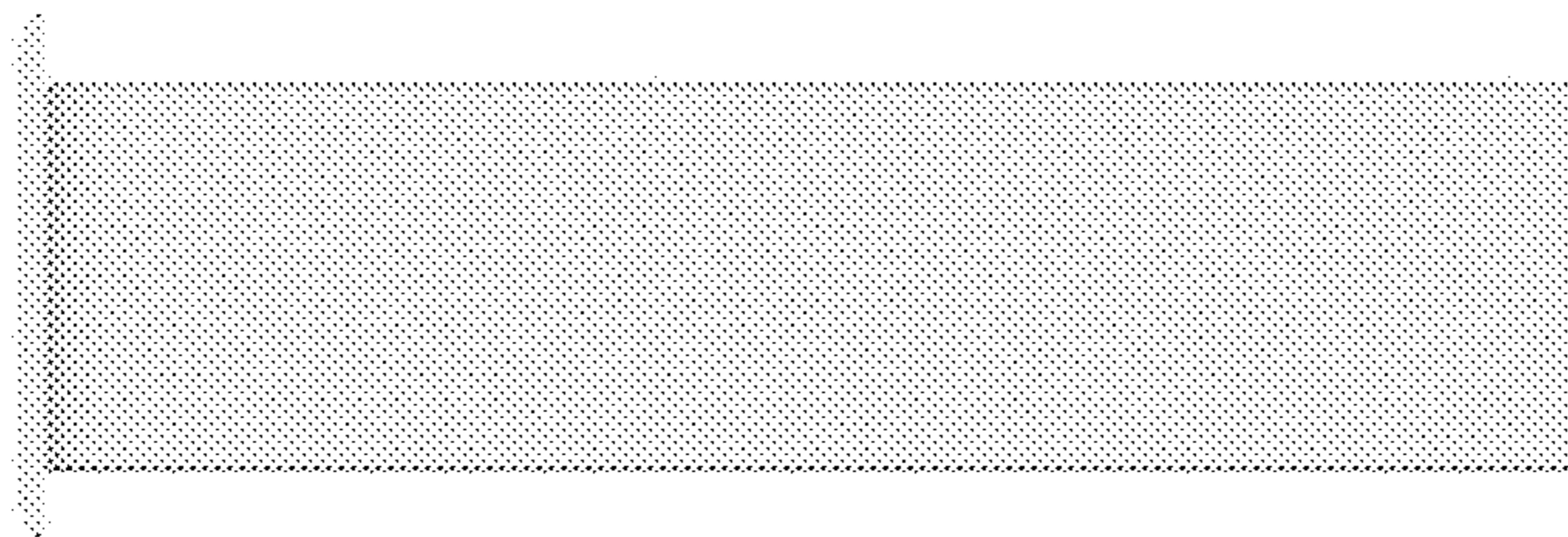

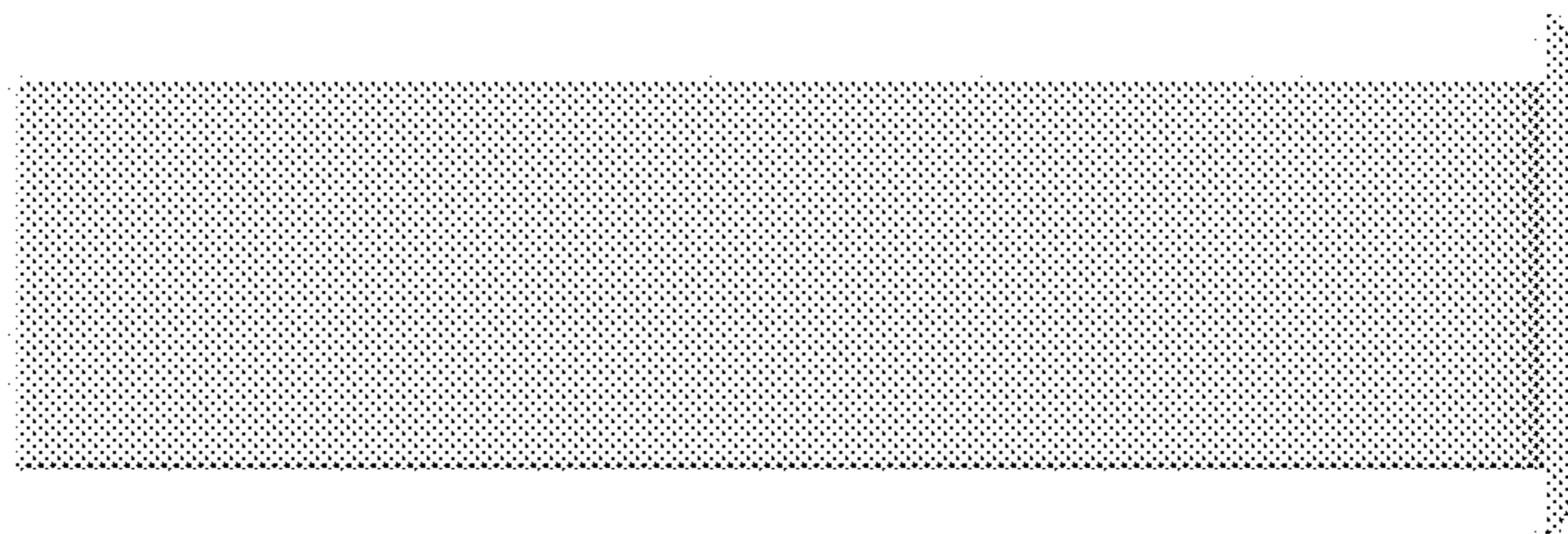

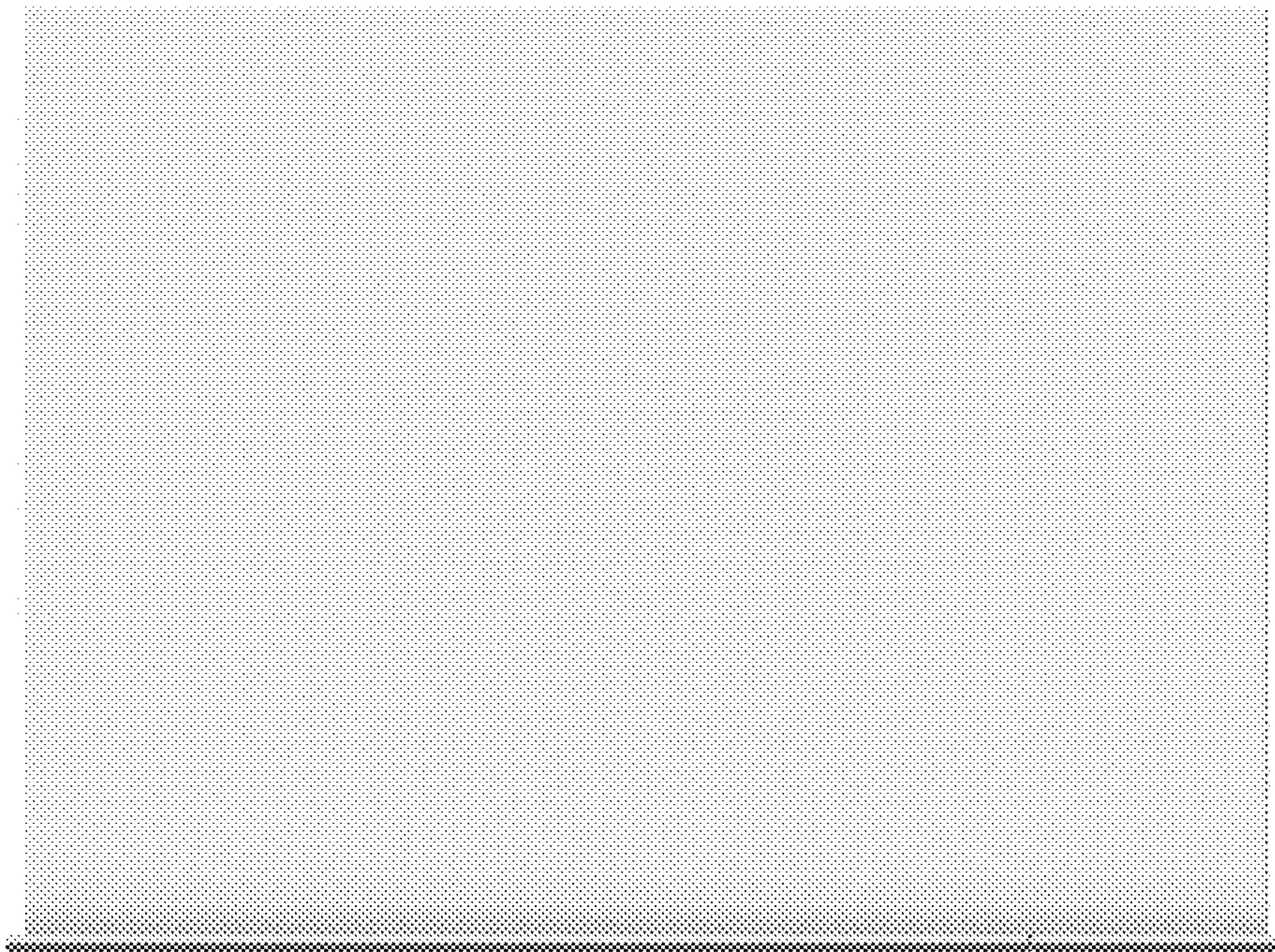

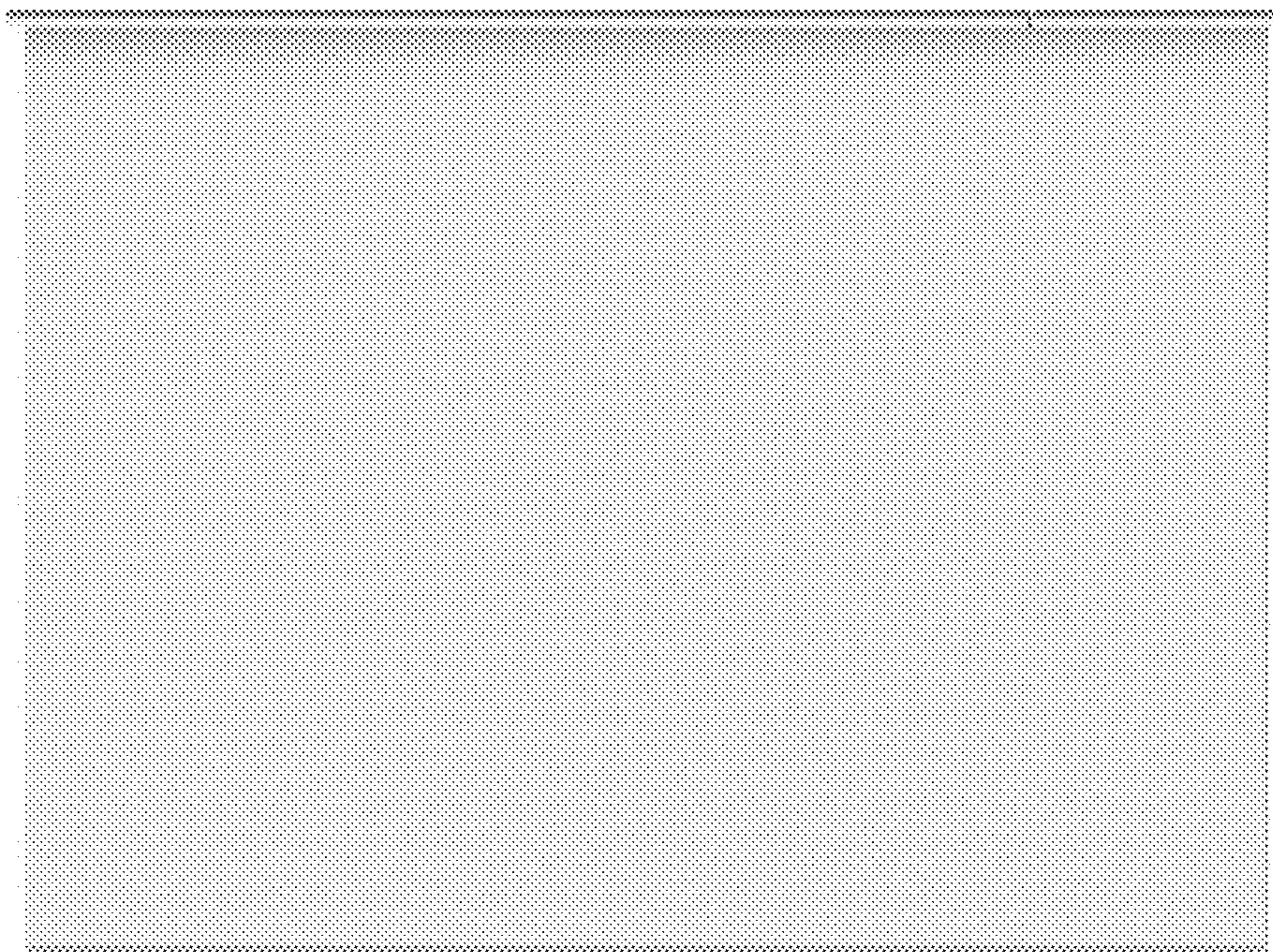

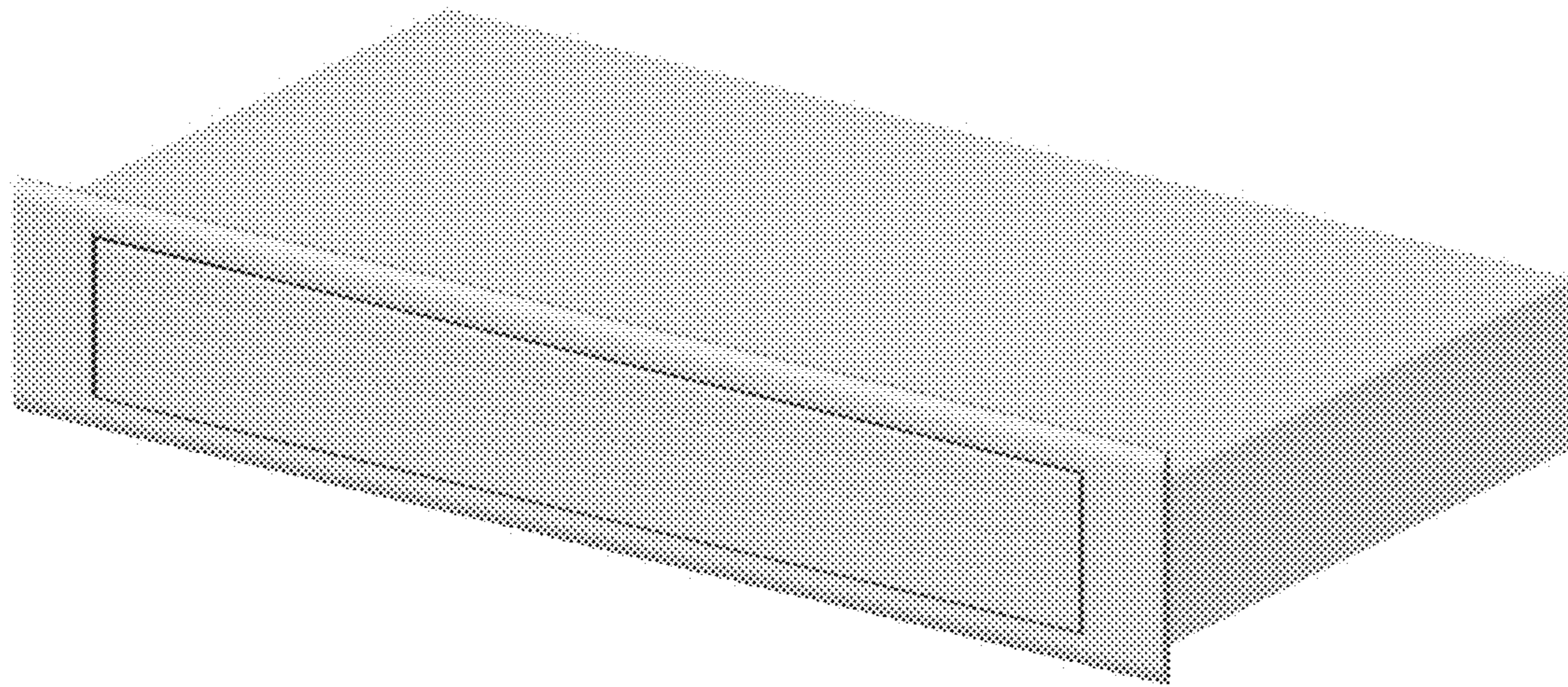

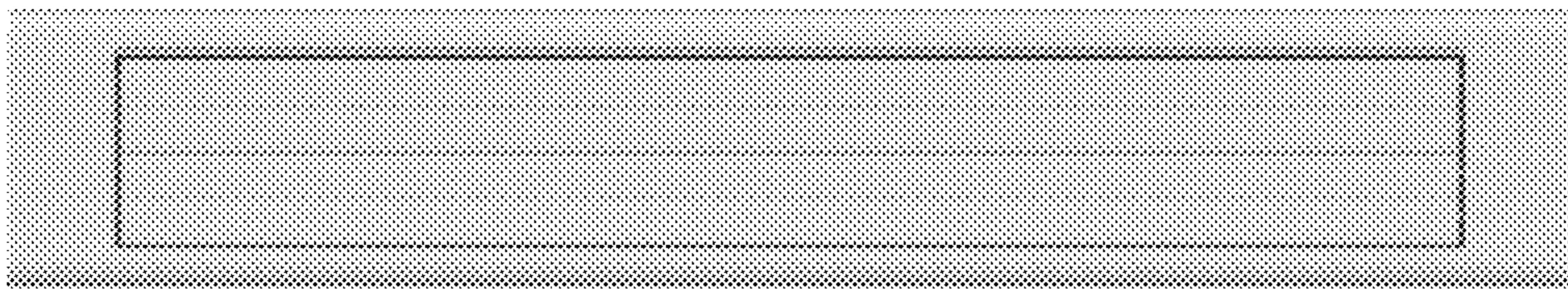

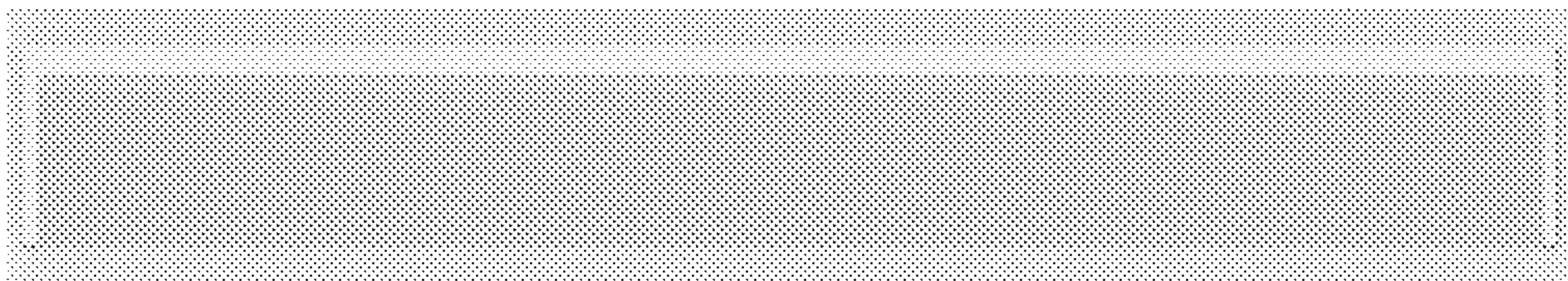

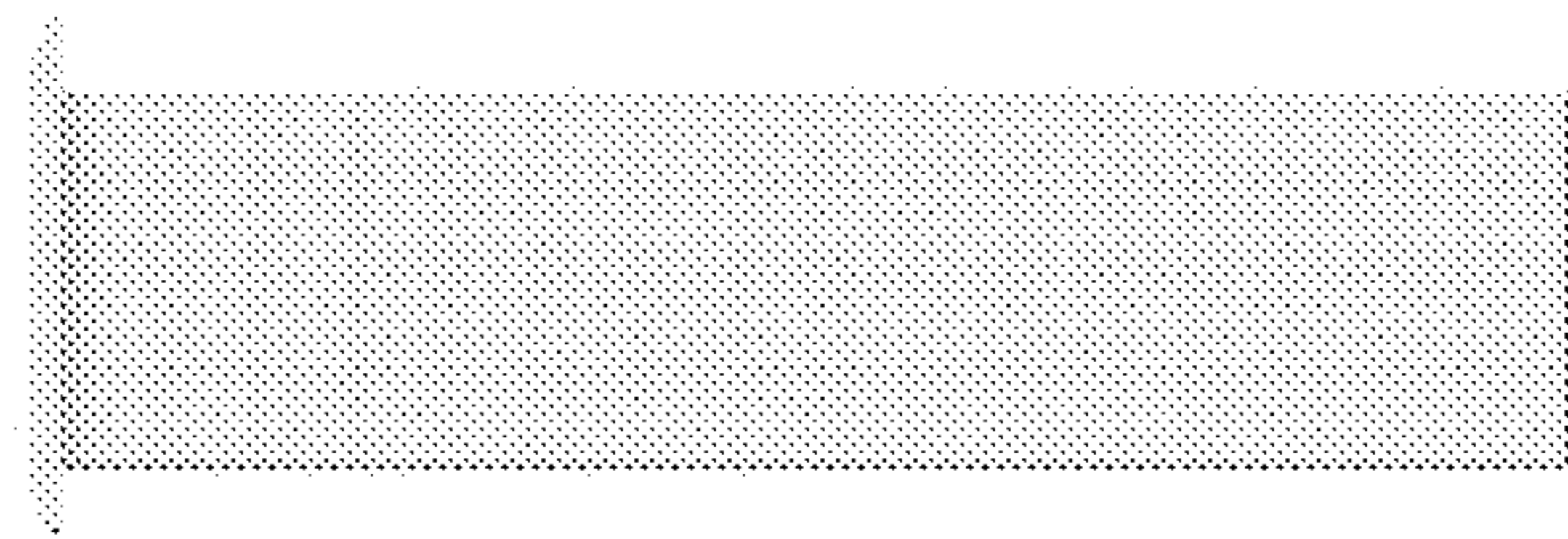

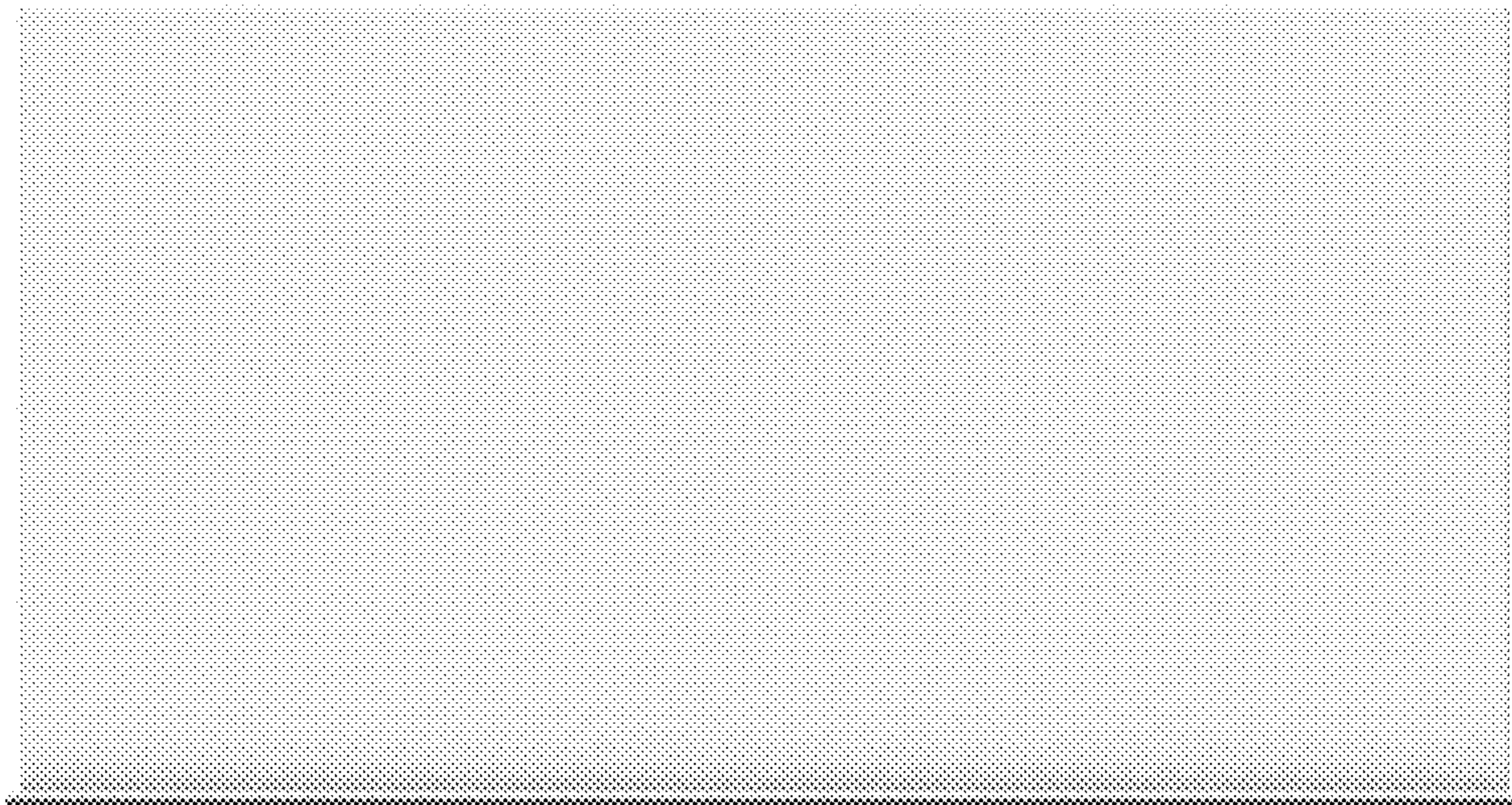
