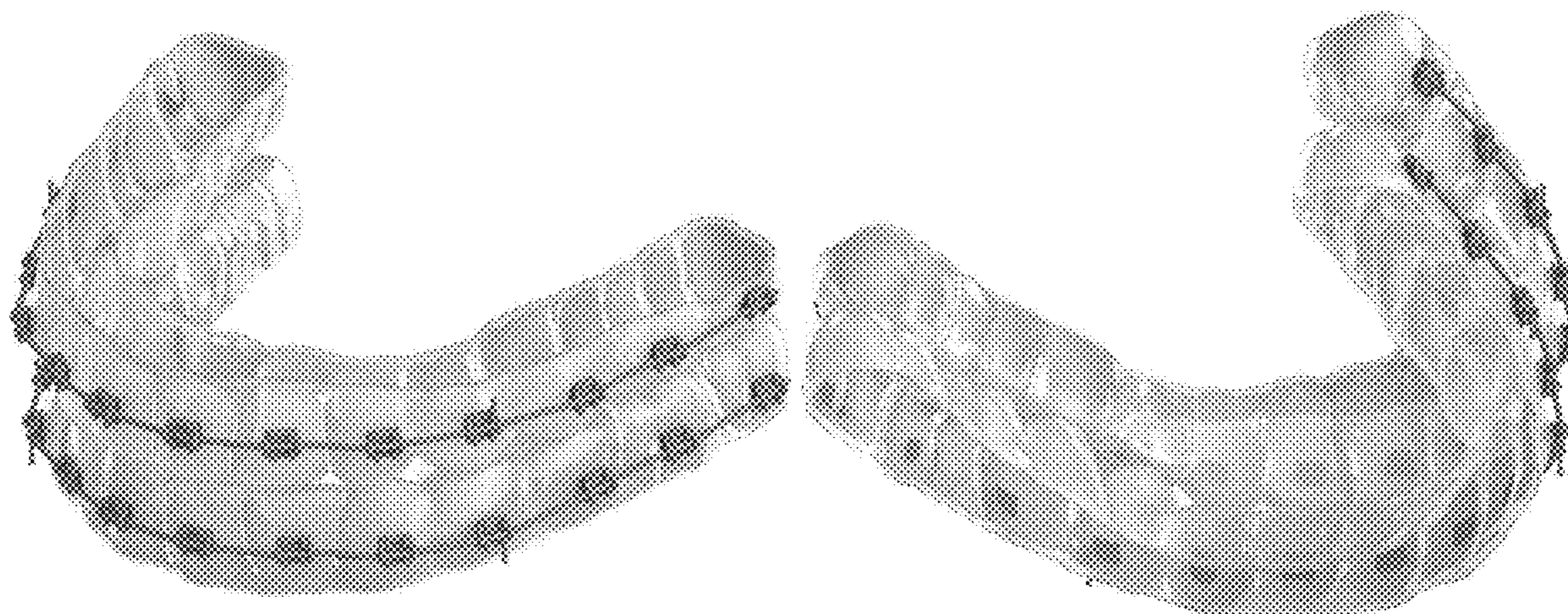
(57) **CLAIM**

The ornamental design for a pair of cosmetic orthodontic braces, as shown and described.

DESCRIPTION

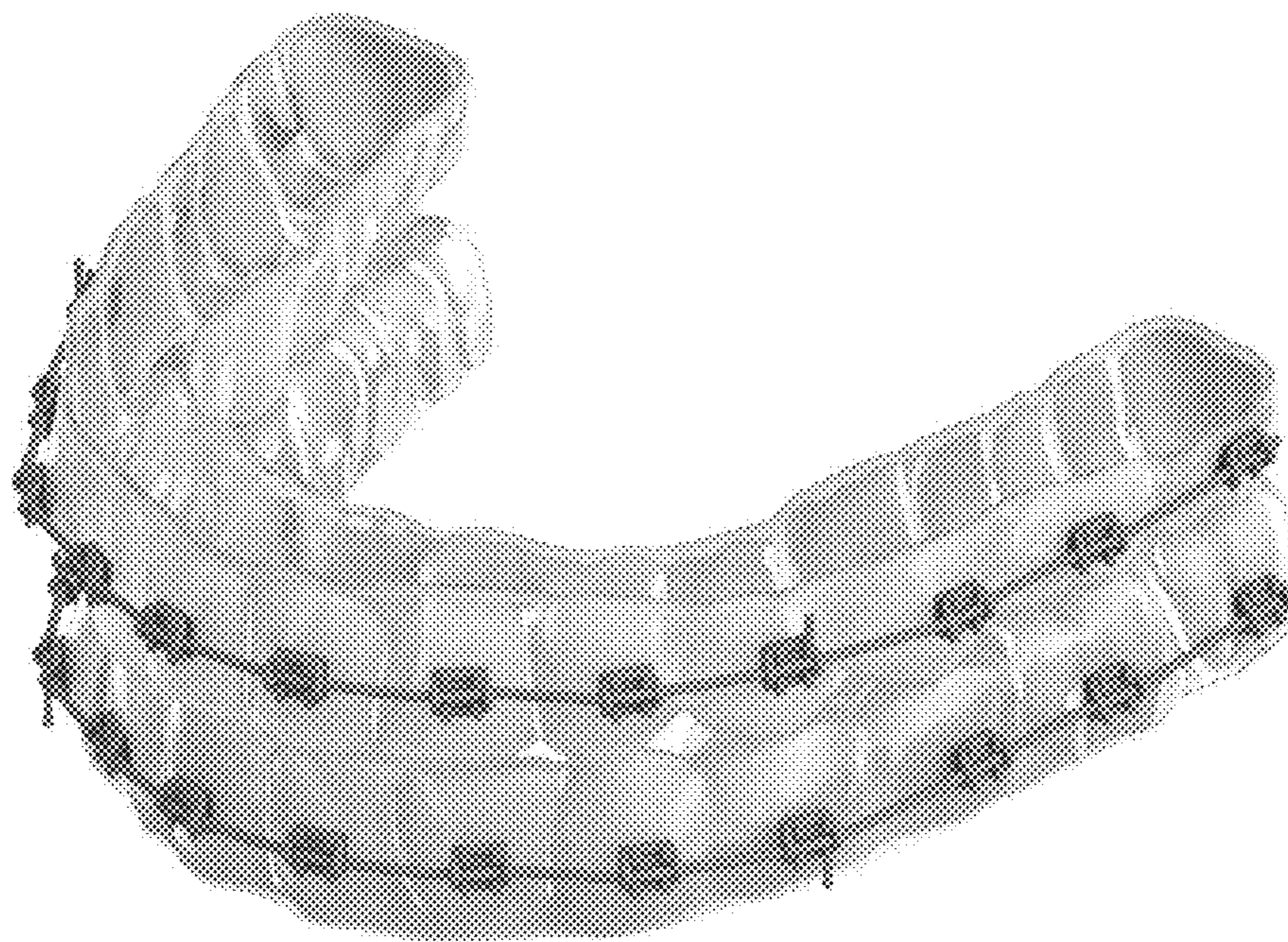

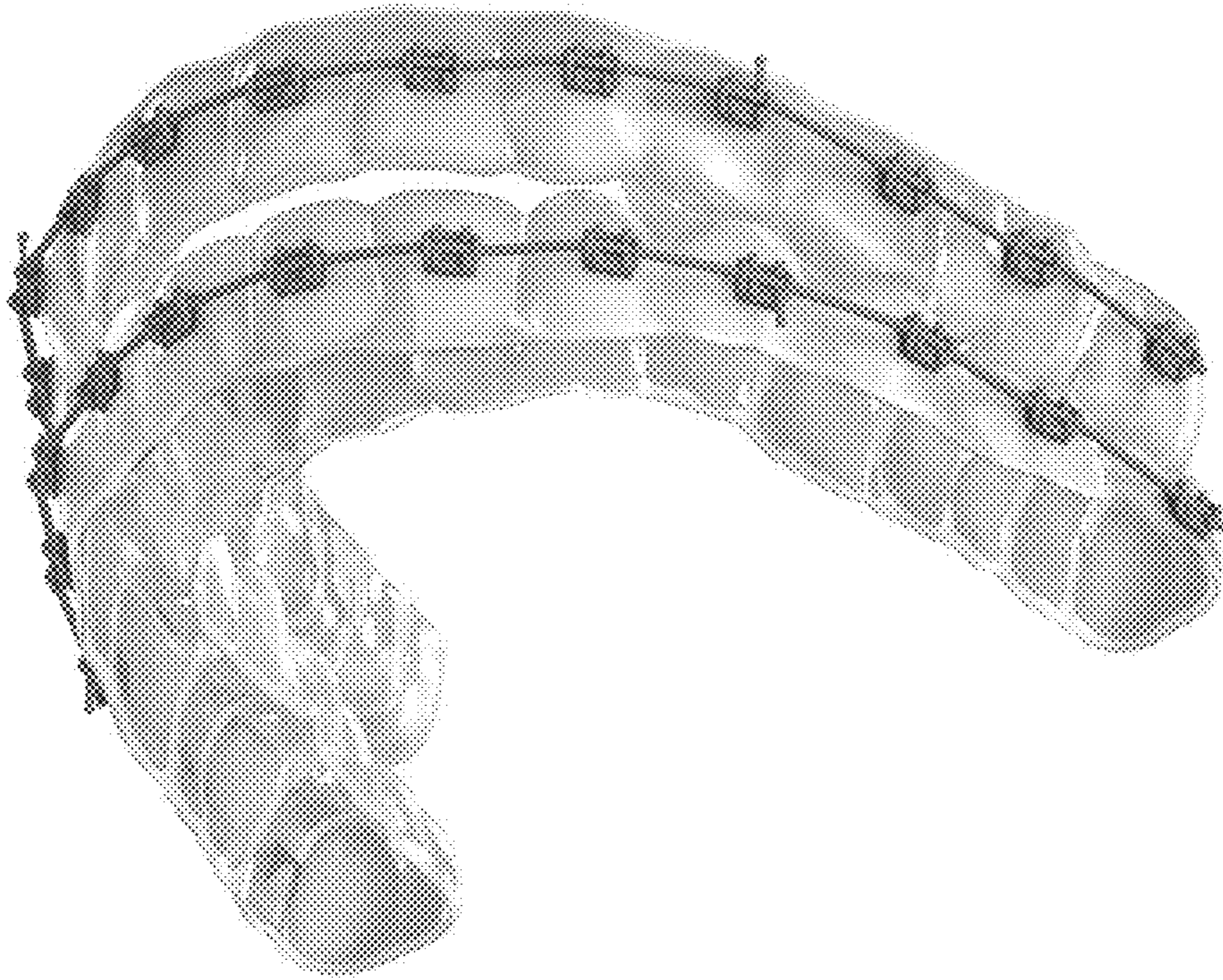

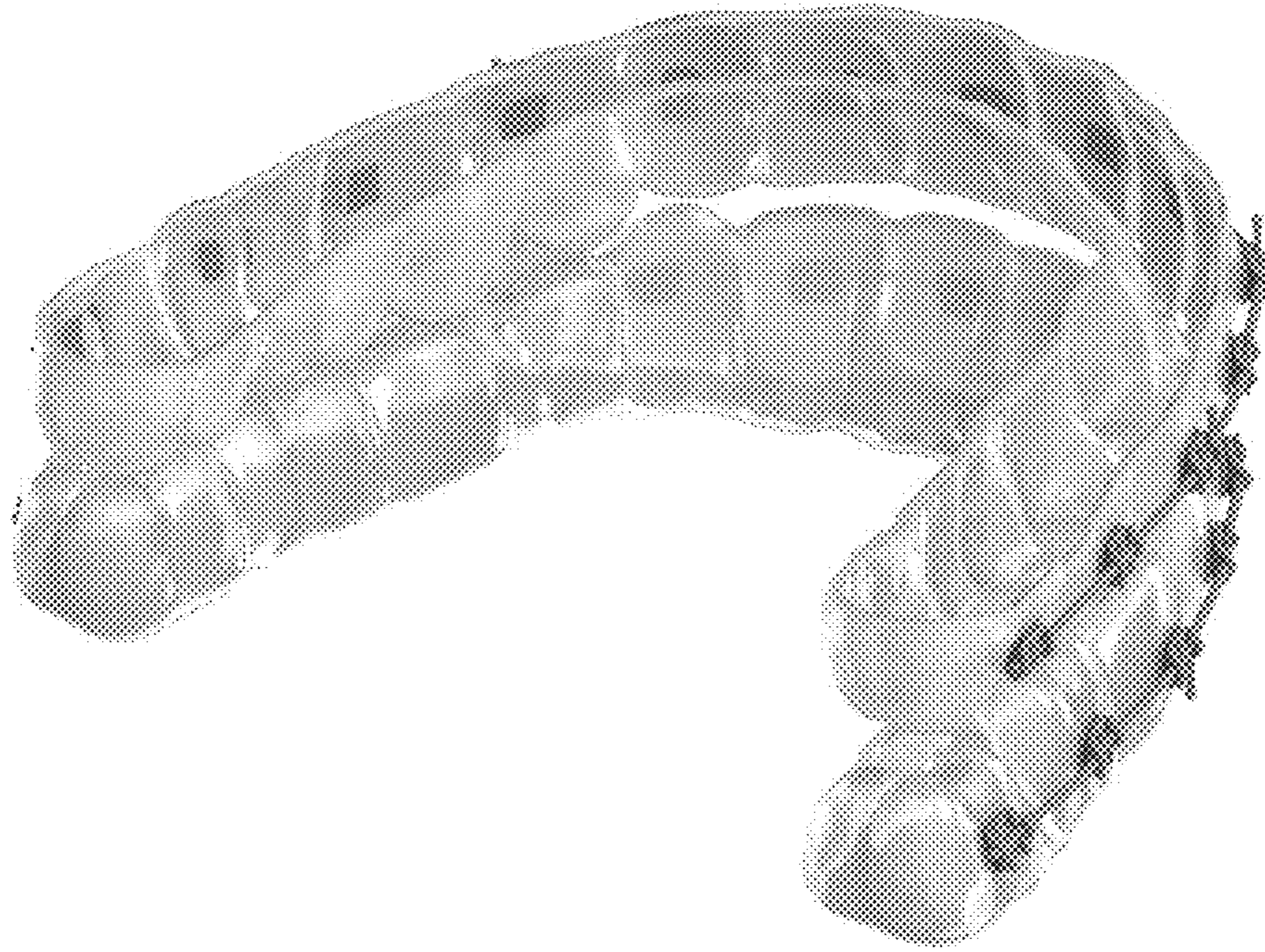

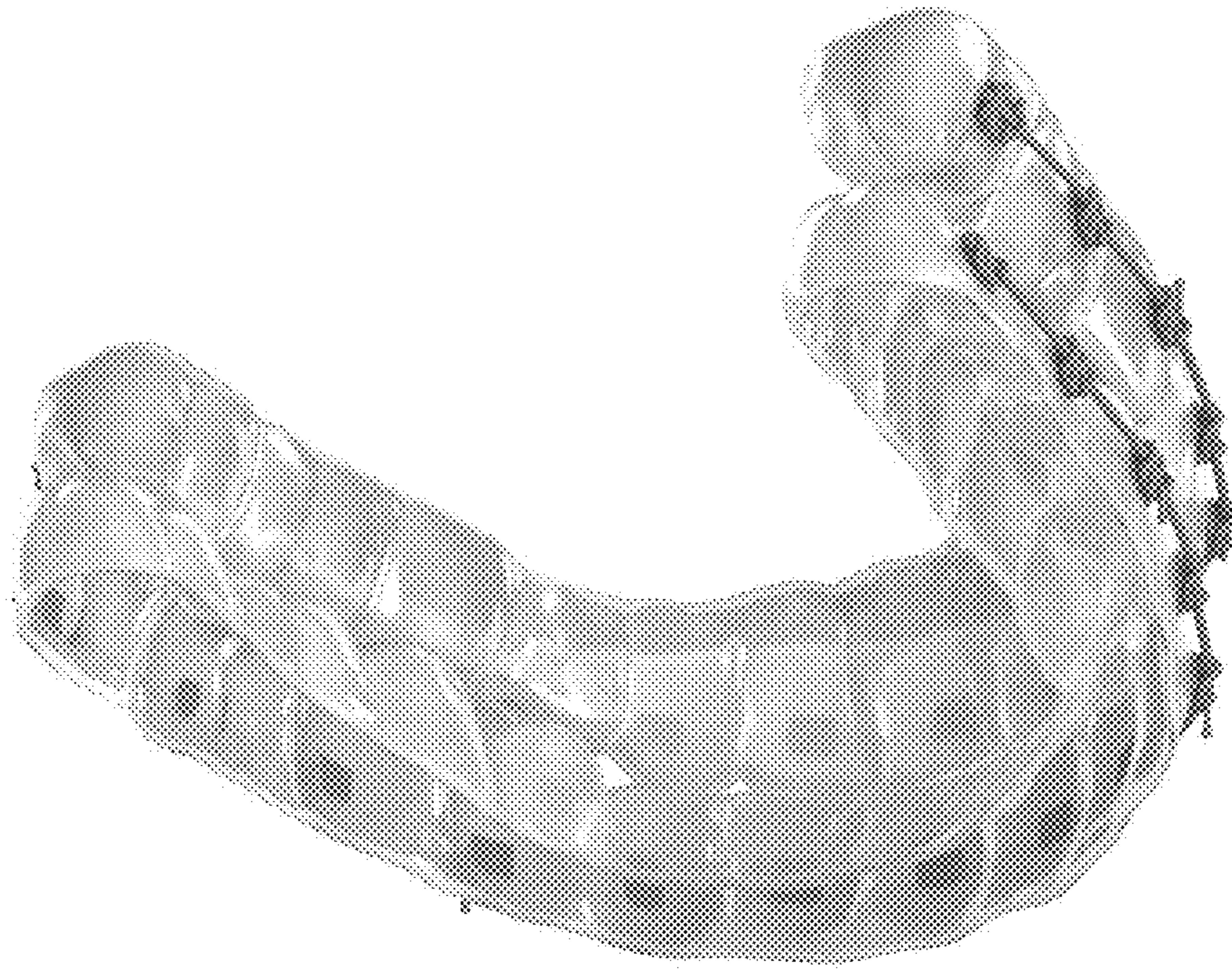

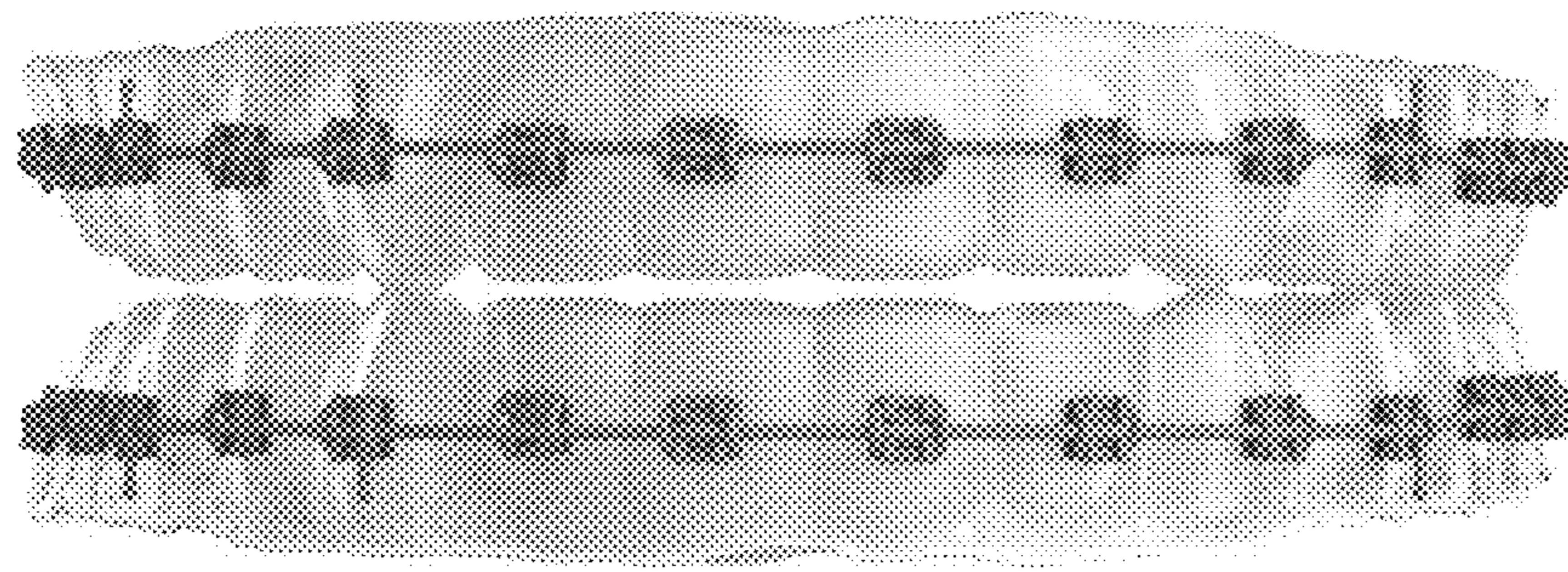

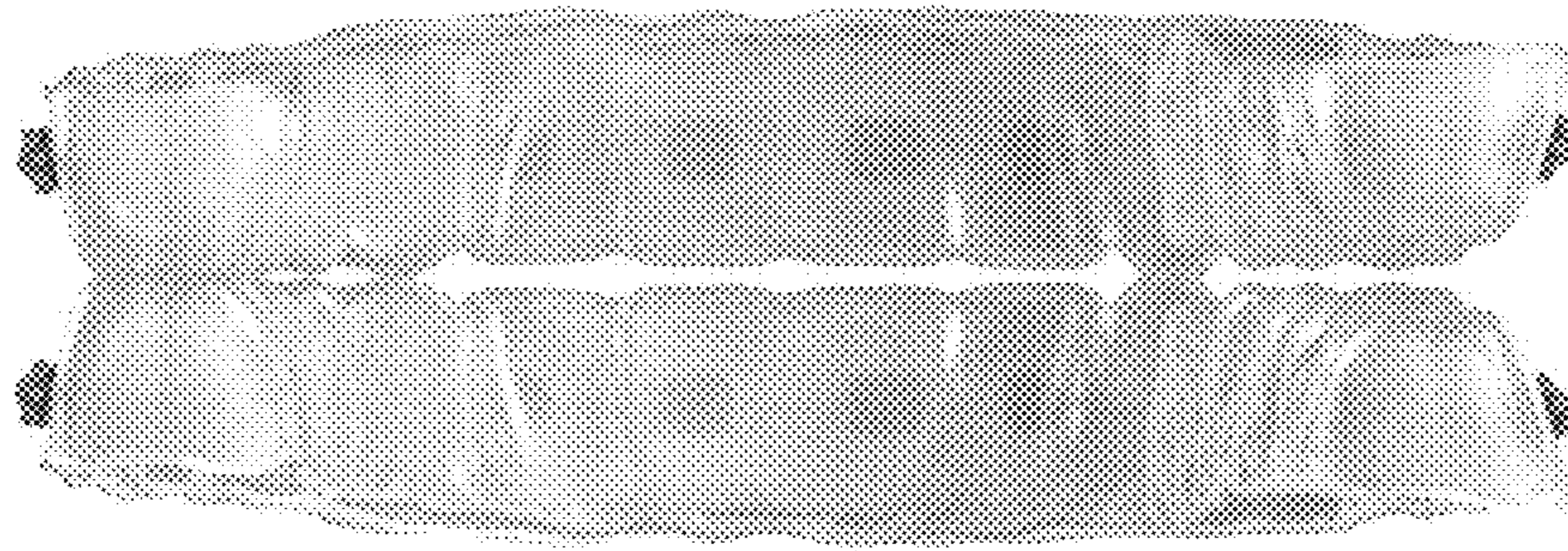

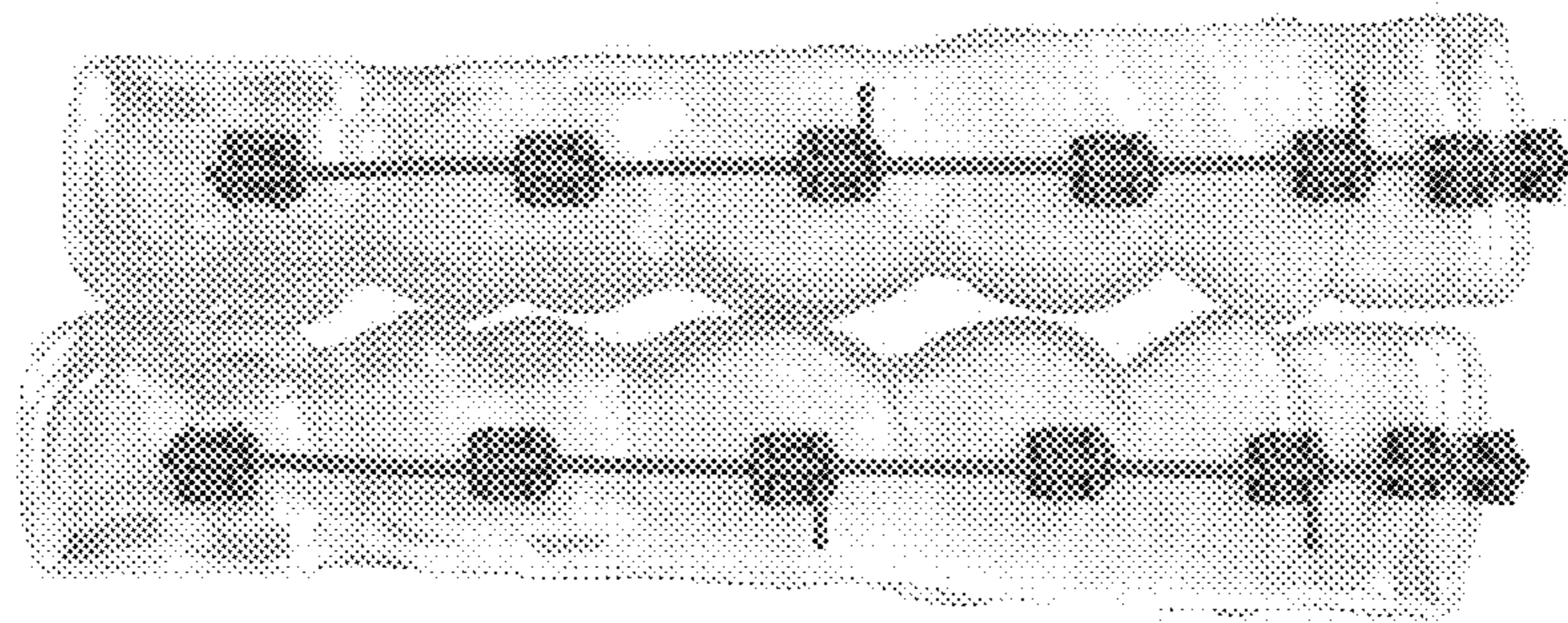

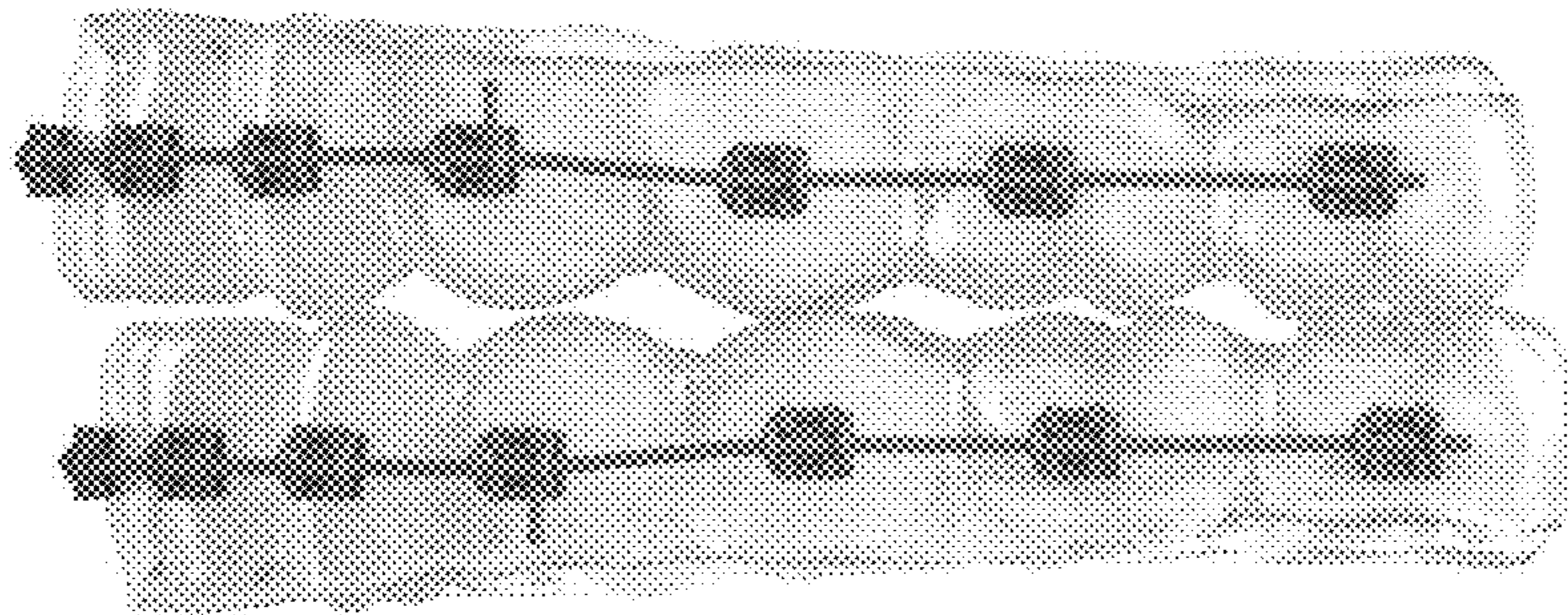

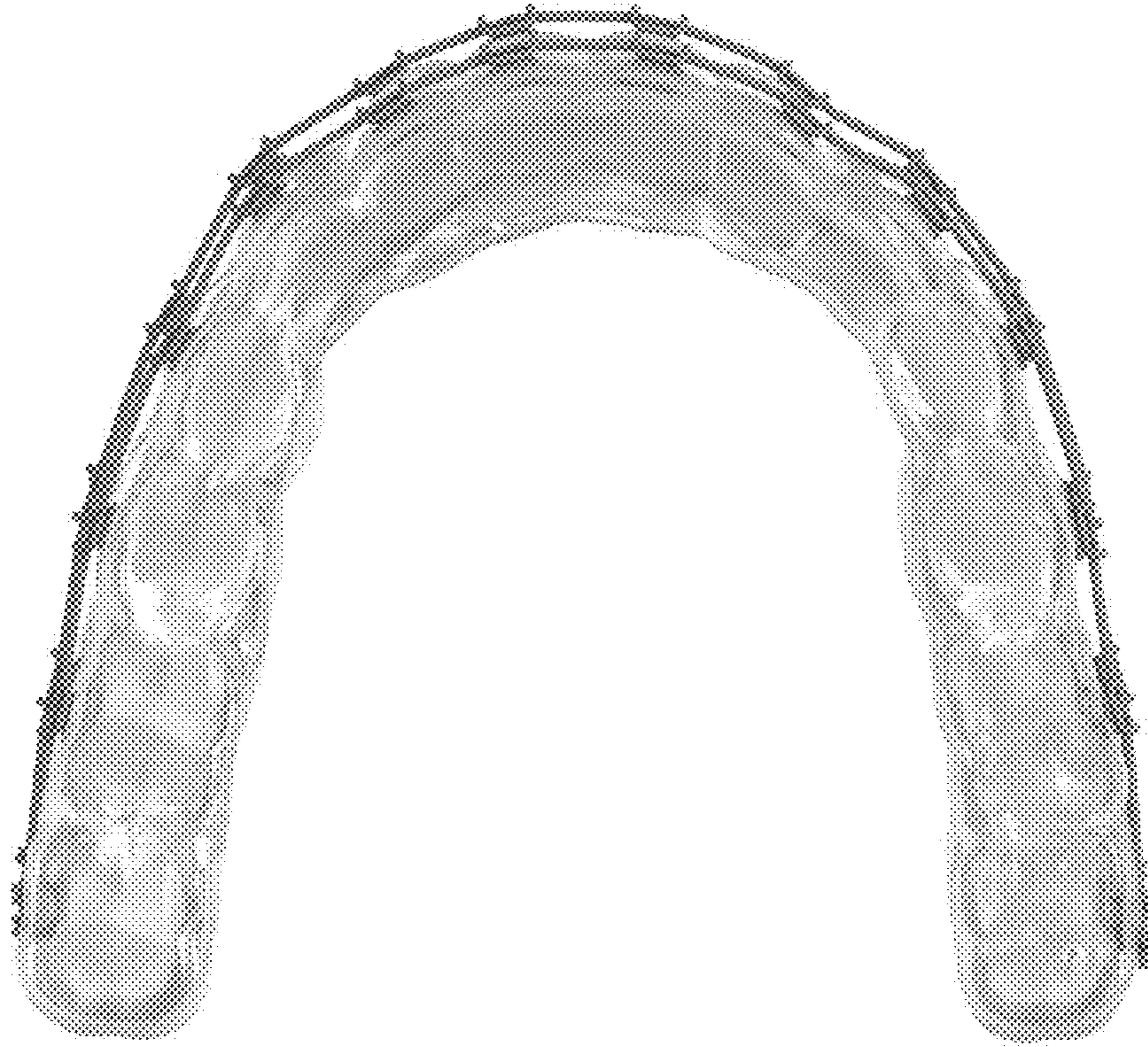
