**DESCRIPTION**

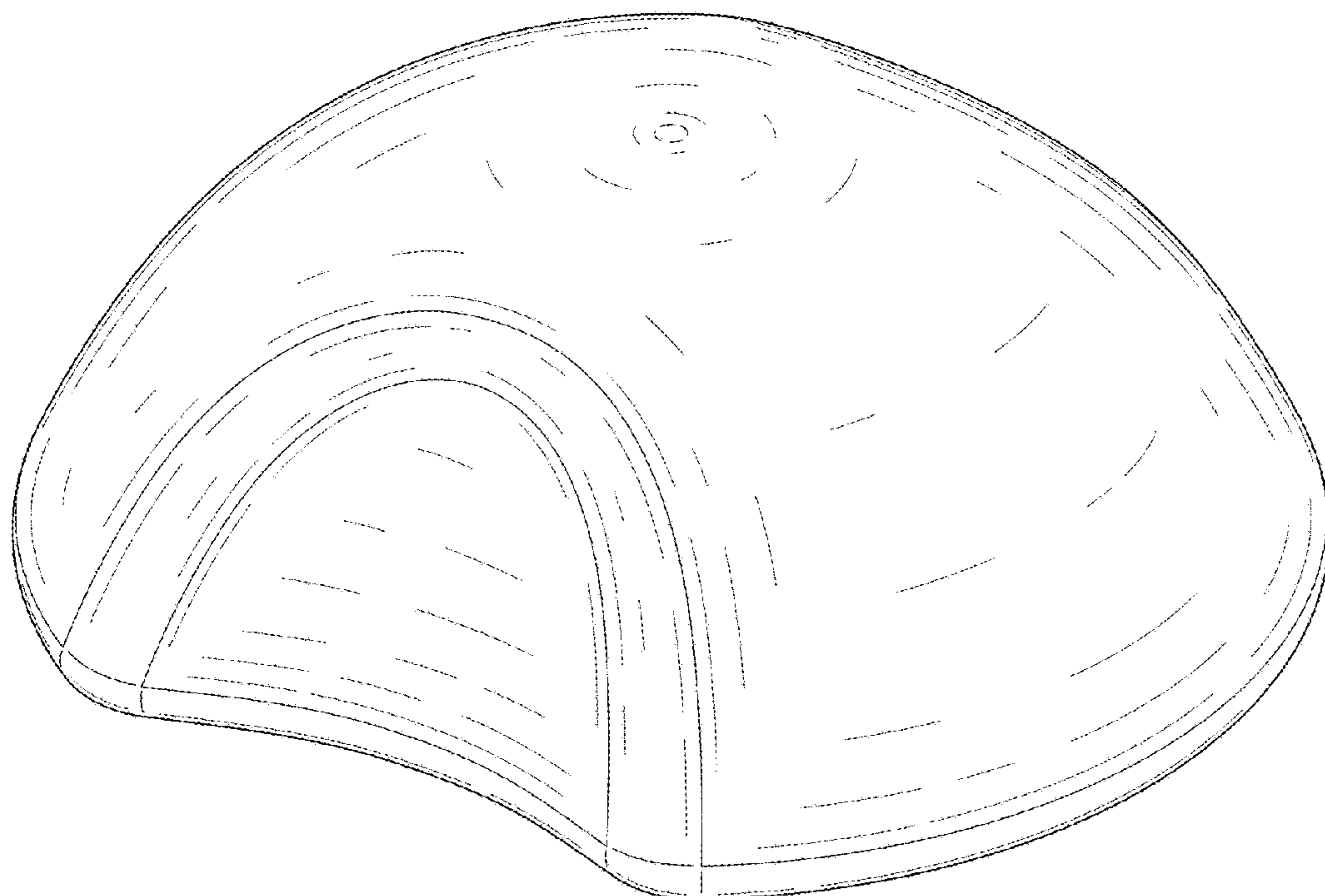
FIG. 1 is a top perspective view of a pet toy in accordance with our new design;

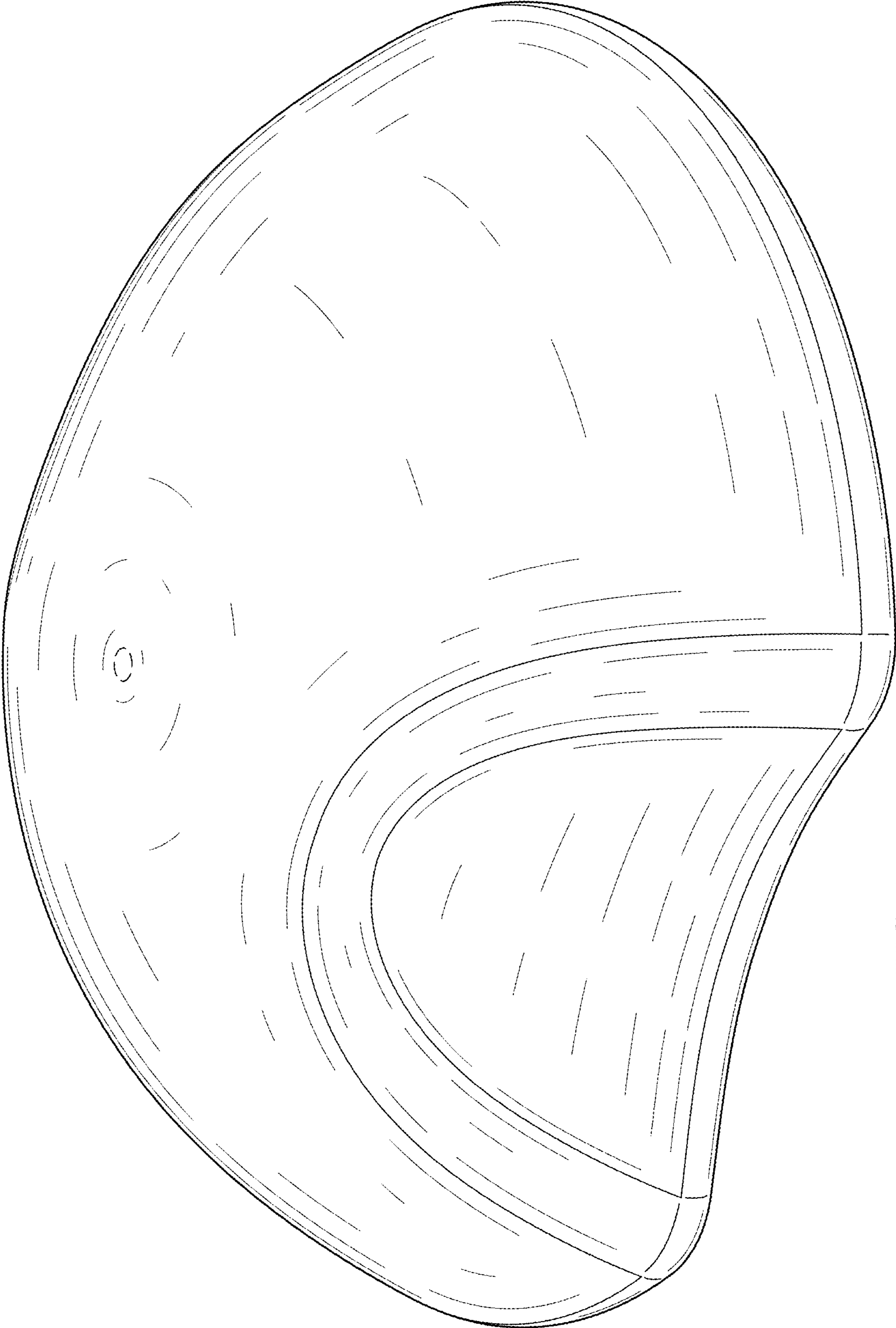

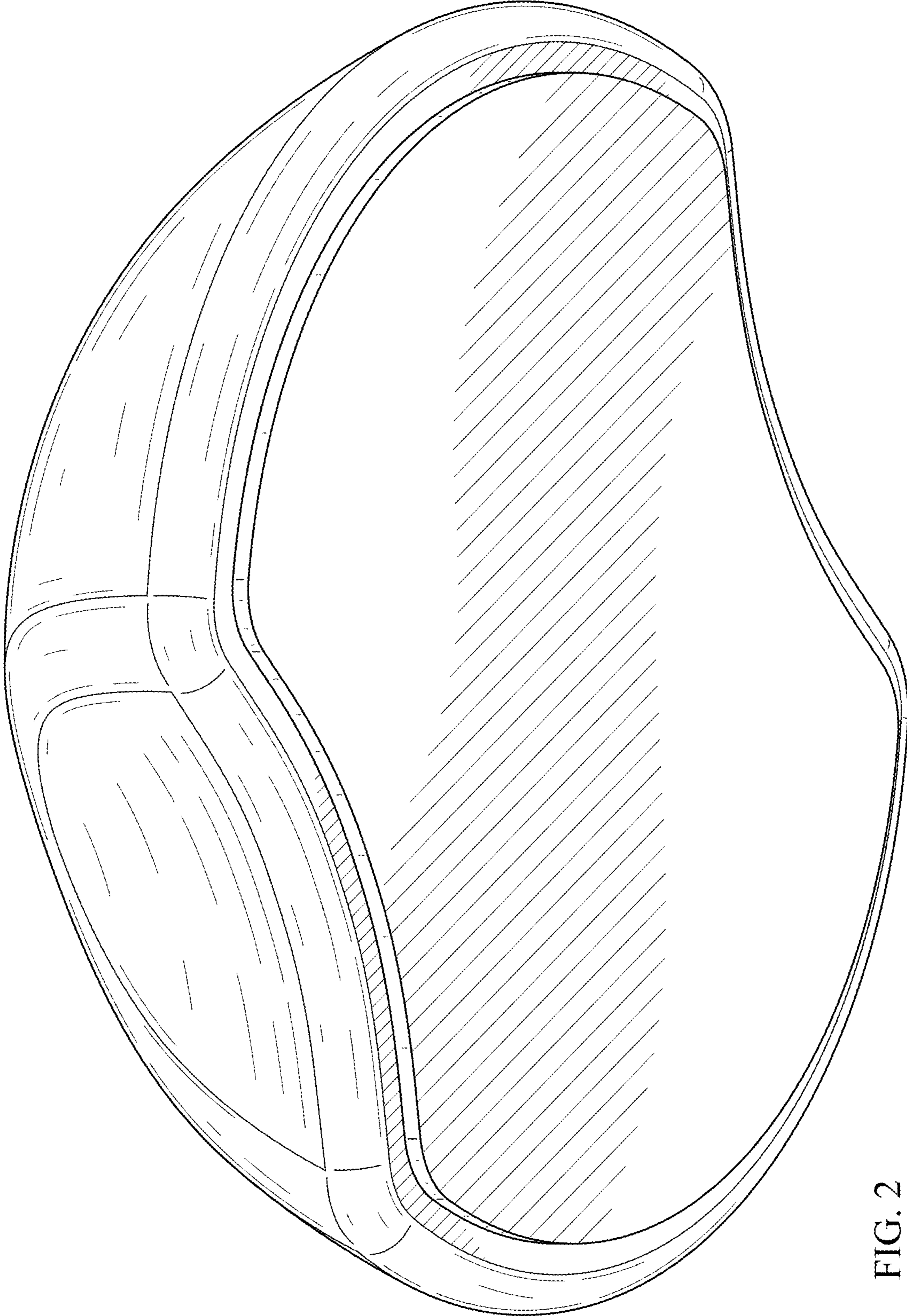

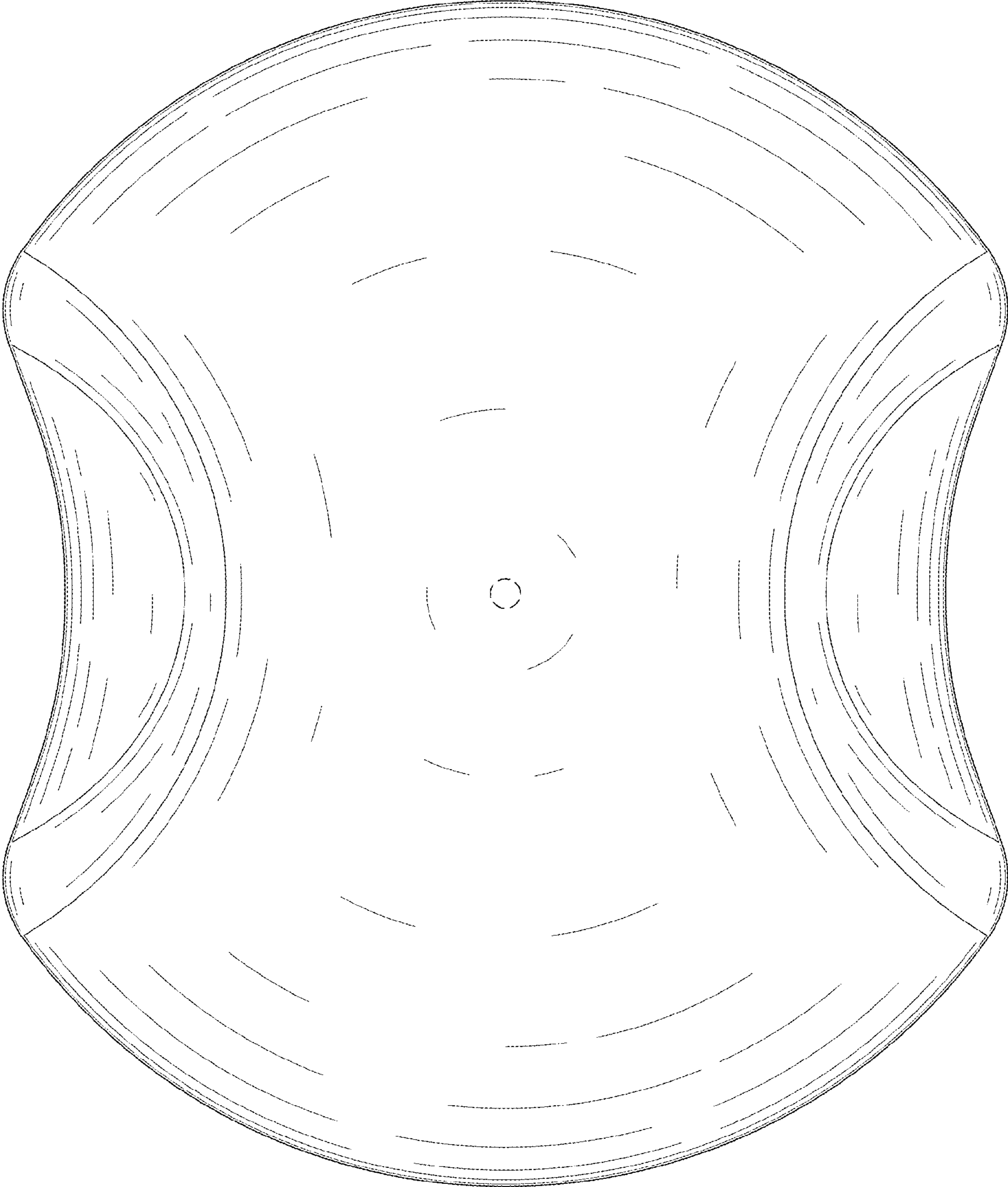

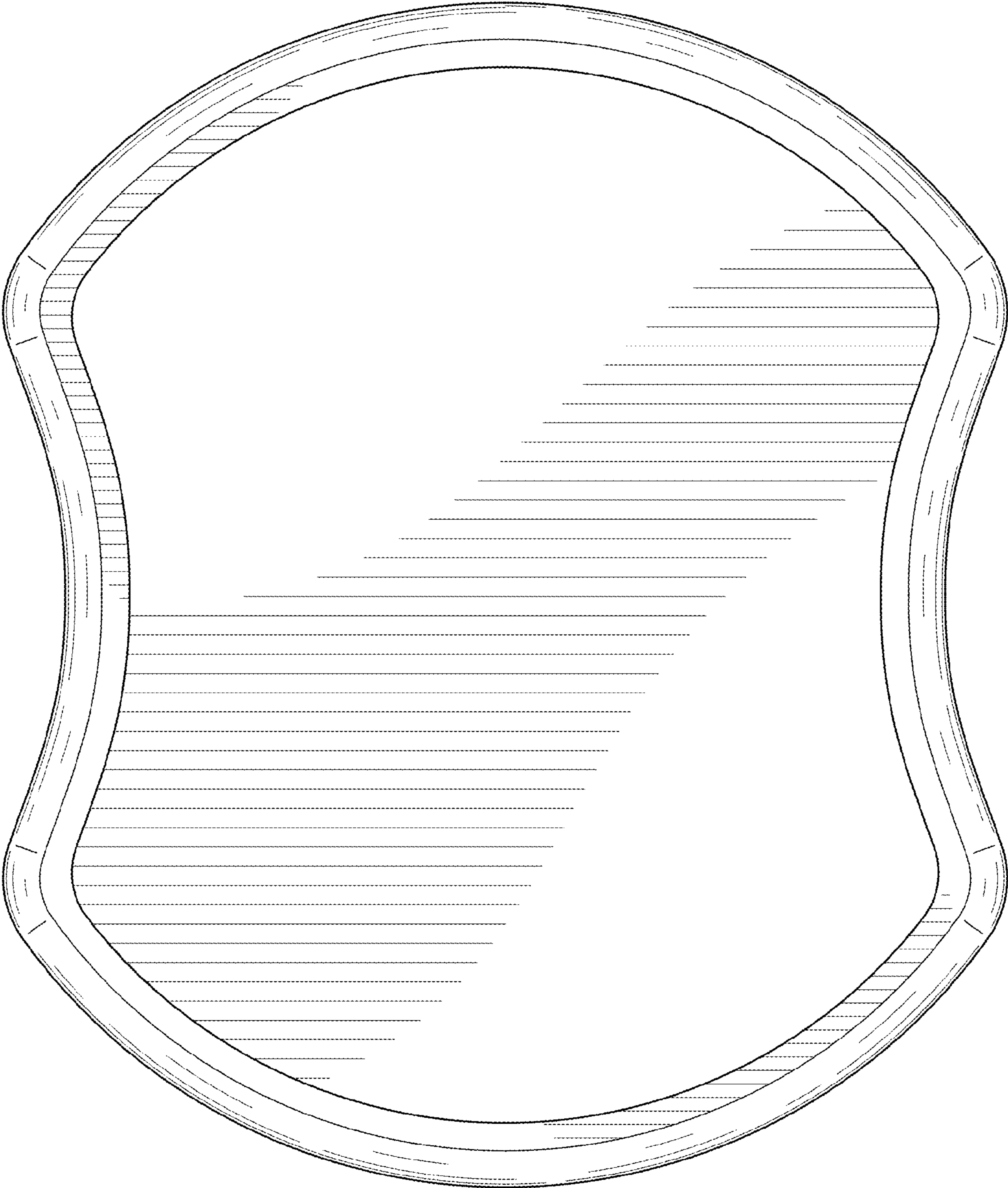

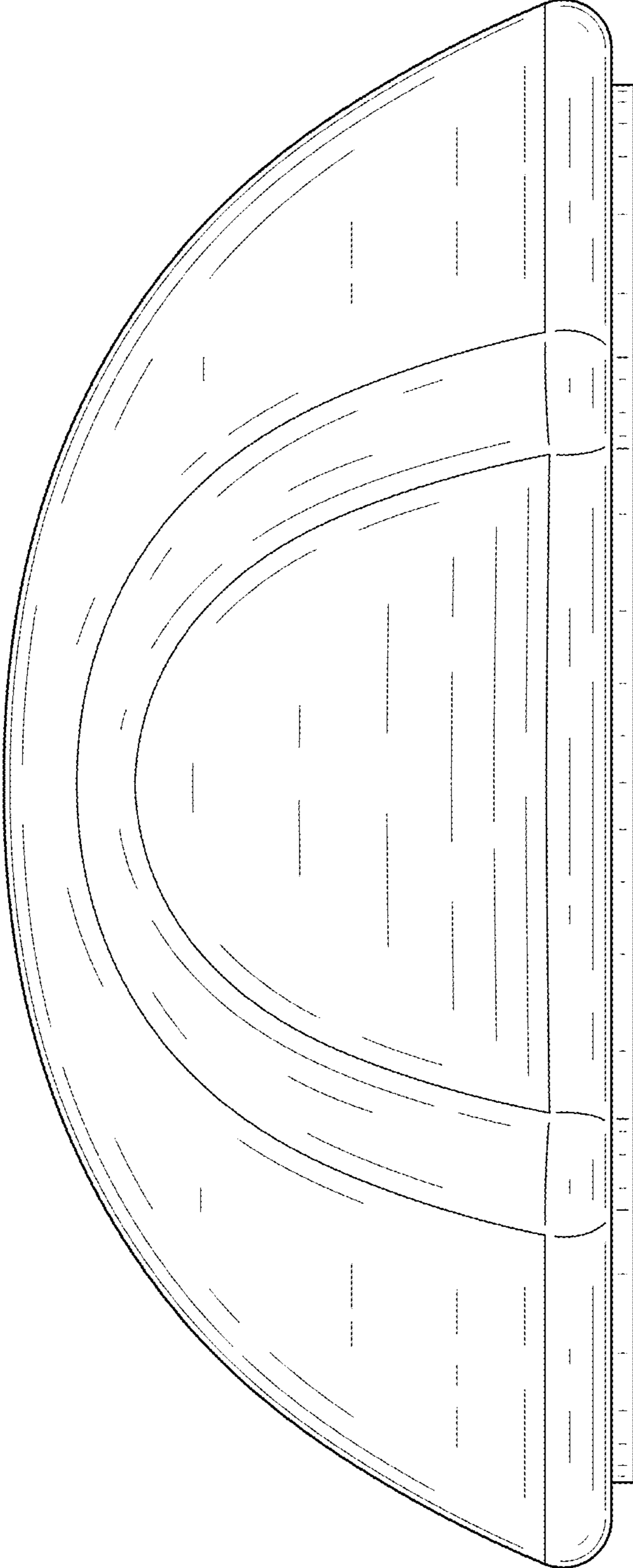

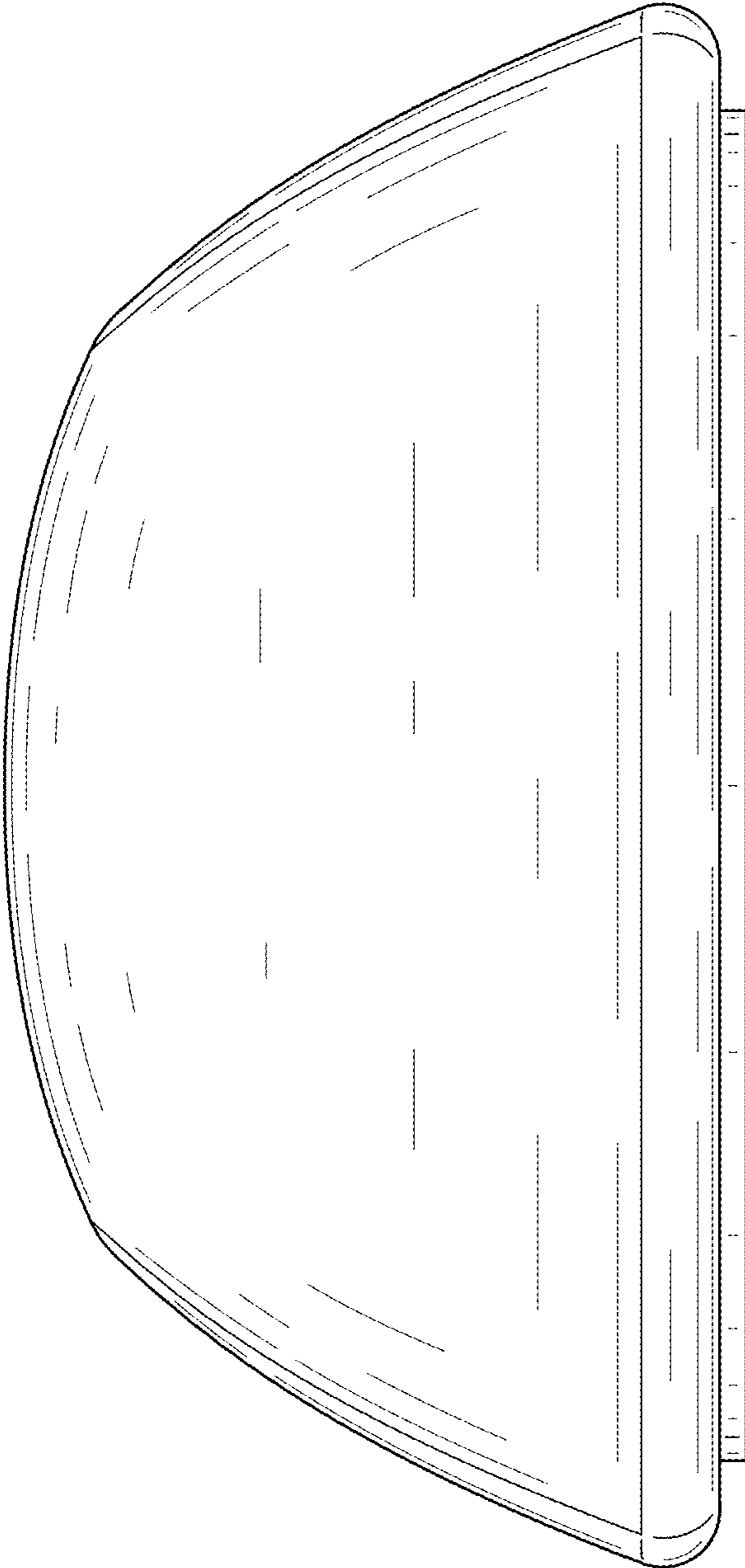
