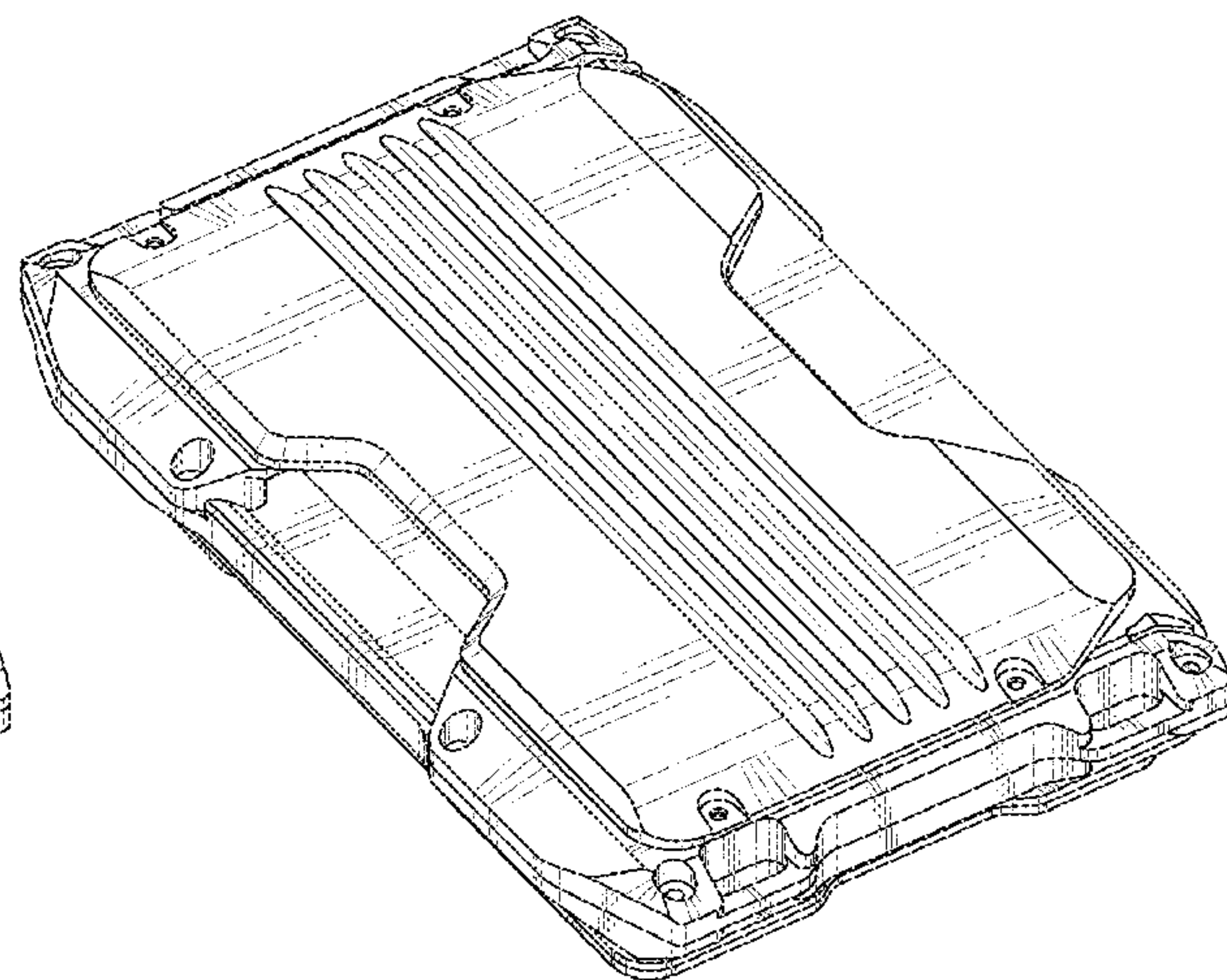
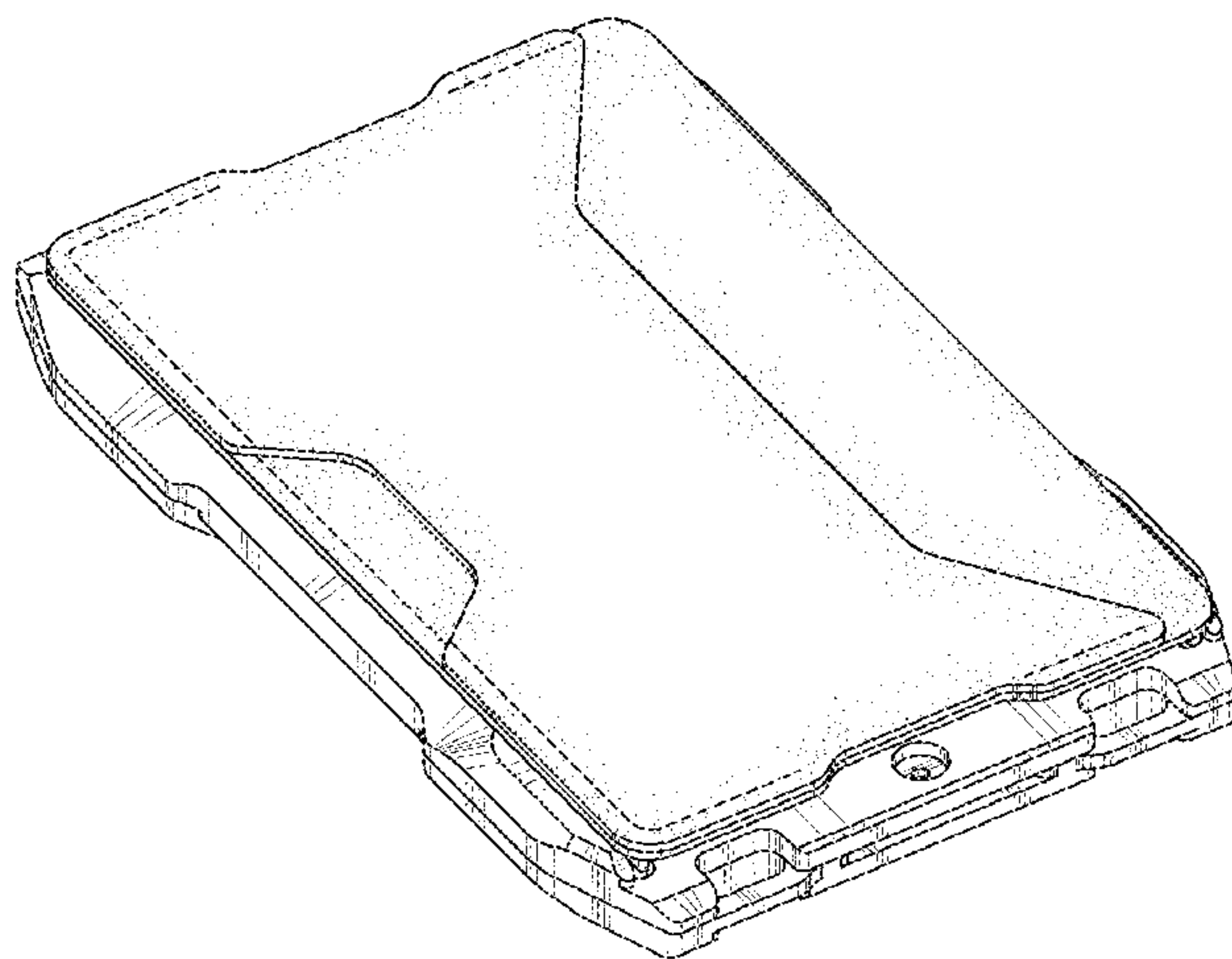
(57) **CLAIM**

The ornamental design for a wallet, as shown and described.

DESCRIPTION

FIG. 1 is a front, side, and top perspective view of a wallet embodying the new design; FIG. 2 is a back, side, and bottom perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a first side view thereof; FIG. 6 is a second side view thereof; FIG. 7 is a top view thereof; FIG. 8 is a bottom view thereof; FIG. 9 is a front, side, and bottom perspective view showing a card holder portion of the wallet slid back to reveal an inner storage area of the wallet; and, FIG. 10 is a front, side, and bottom perspective view showing the wallet whereby the card holder is detached. The uniform repeating broken lines on the front surface depict stitching and do not form part of the claimed design. The uniform repeating broken lines in FIGS. 9 and 10 showing paper money and cards depict environment and do not form part of the claimed design.

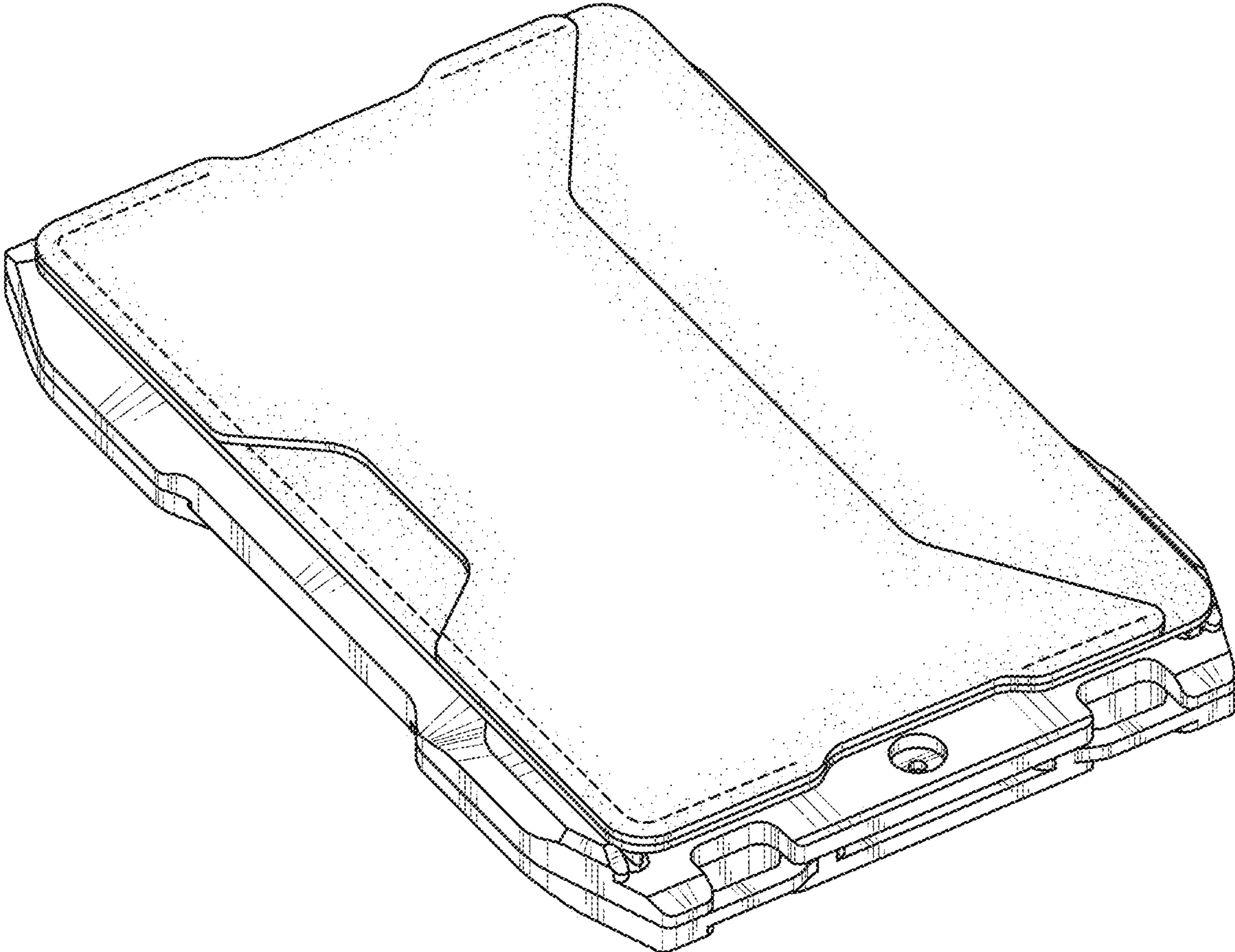

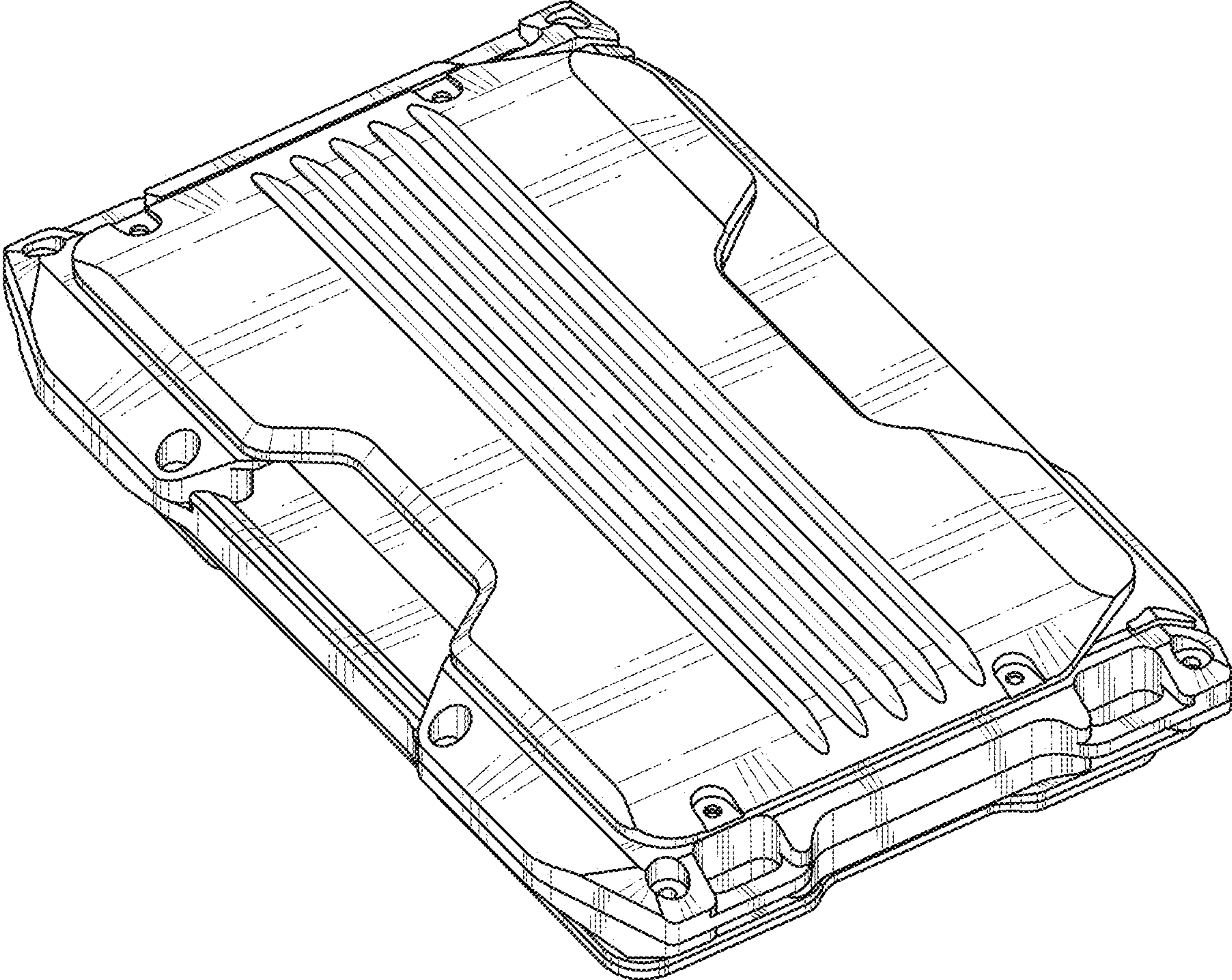

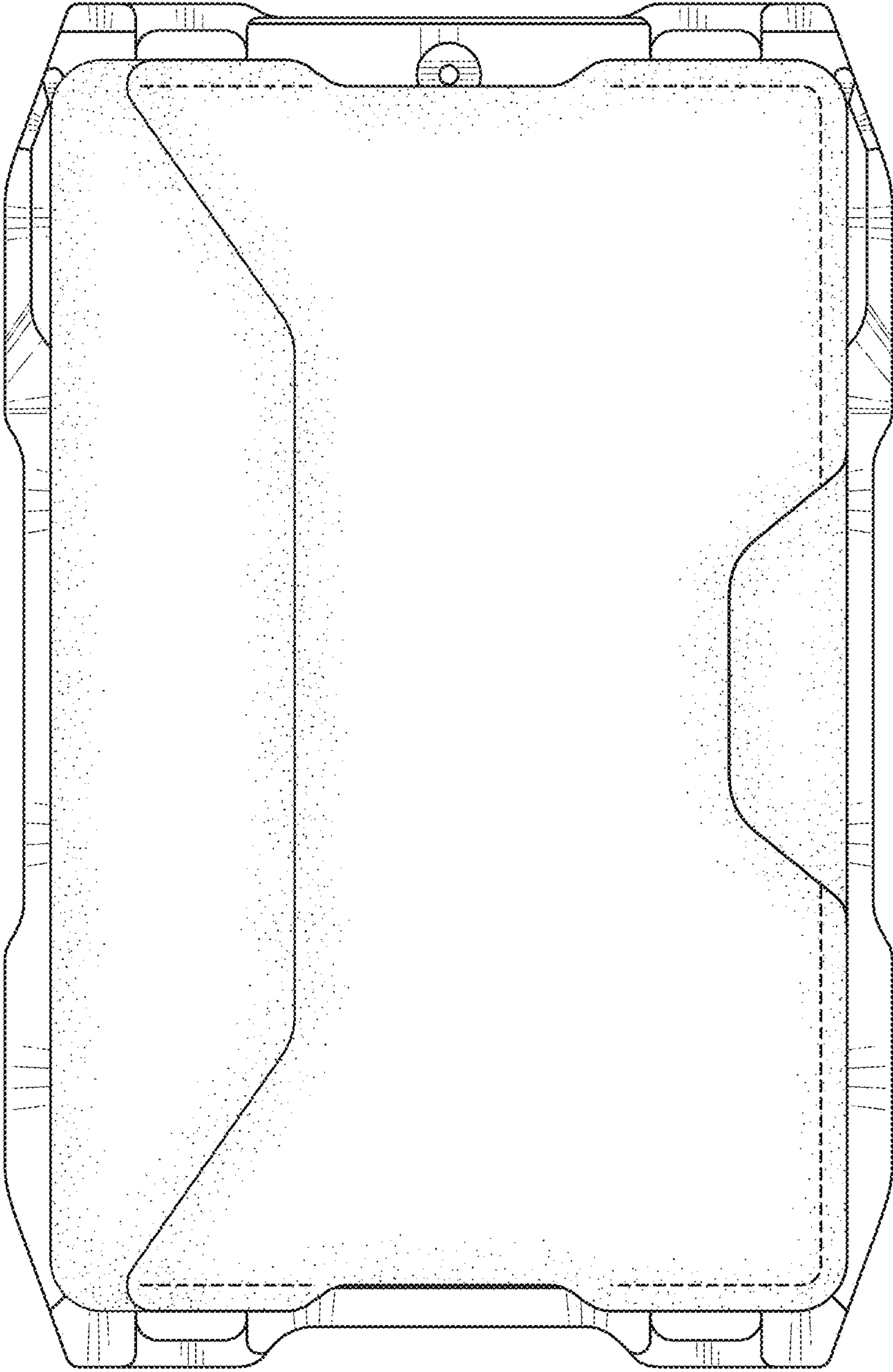

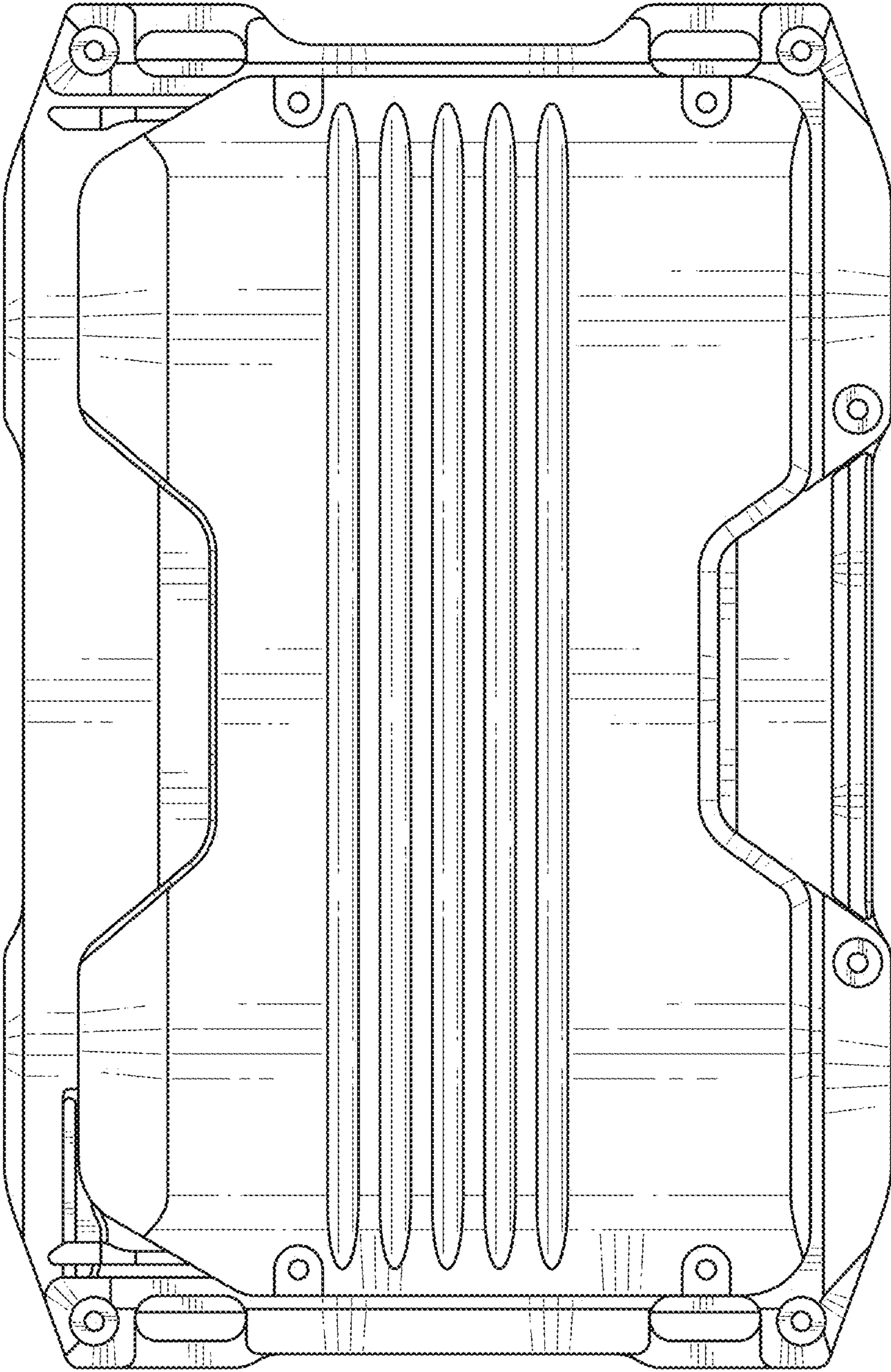

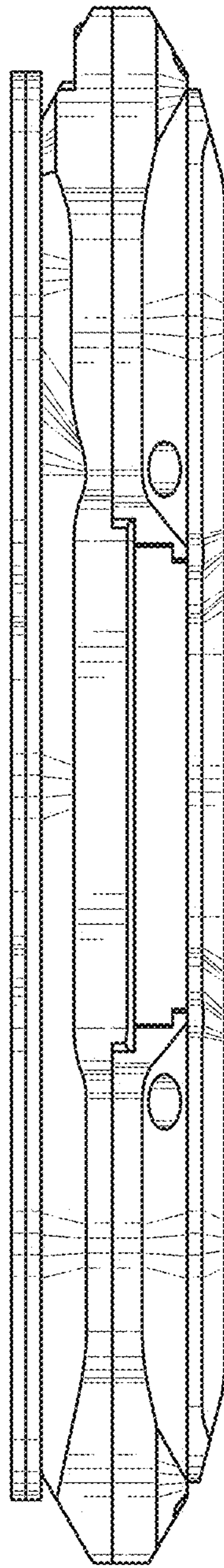

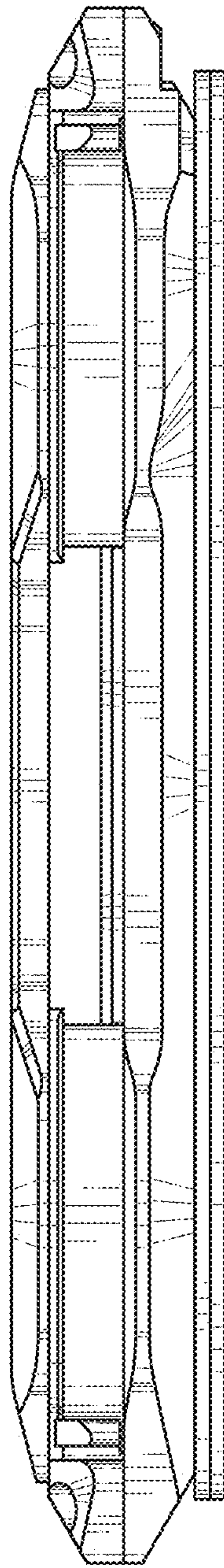

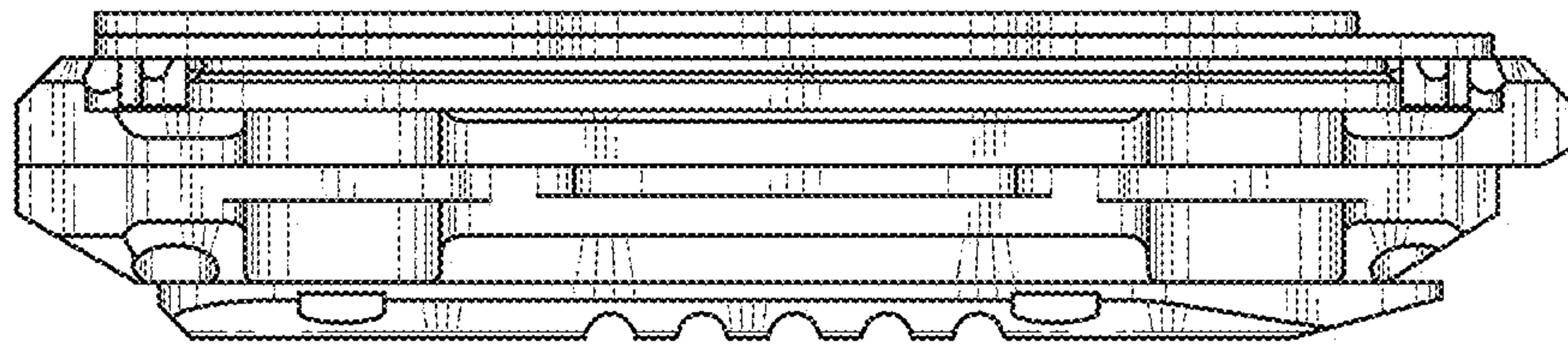

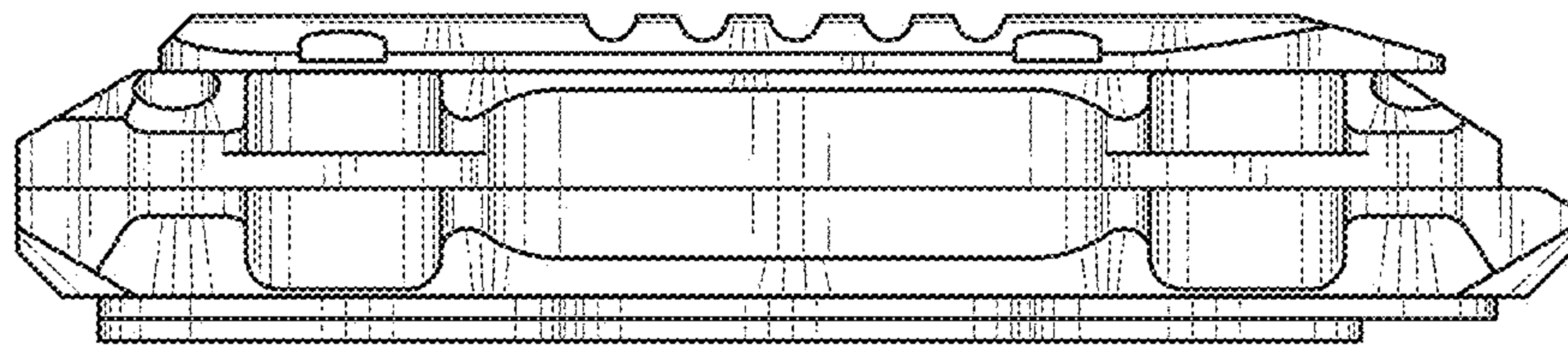

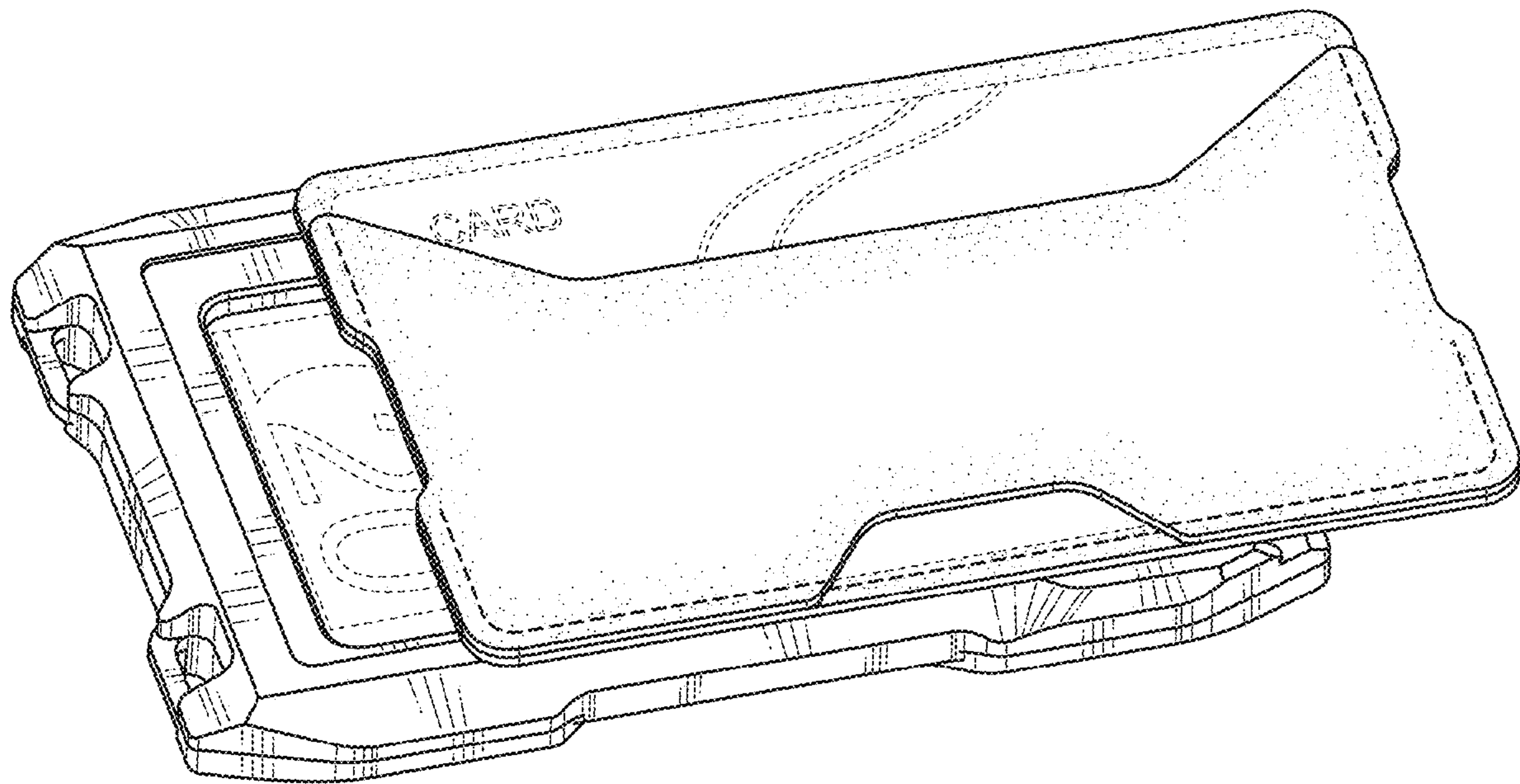

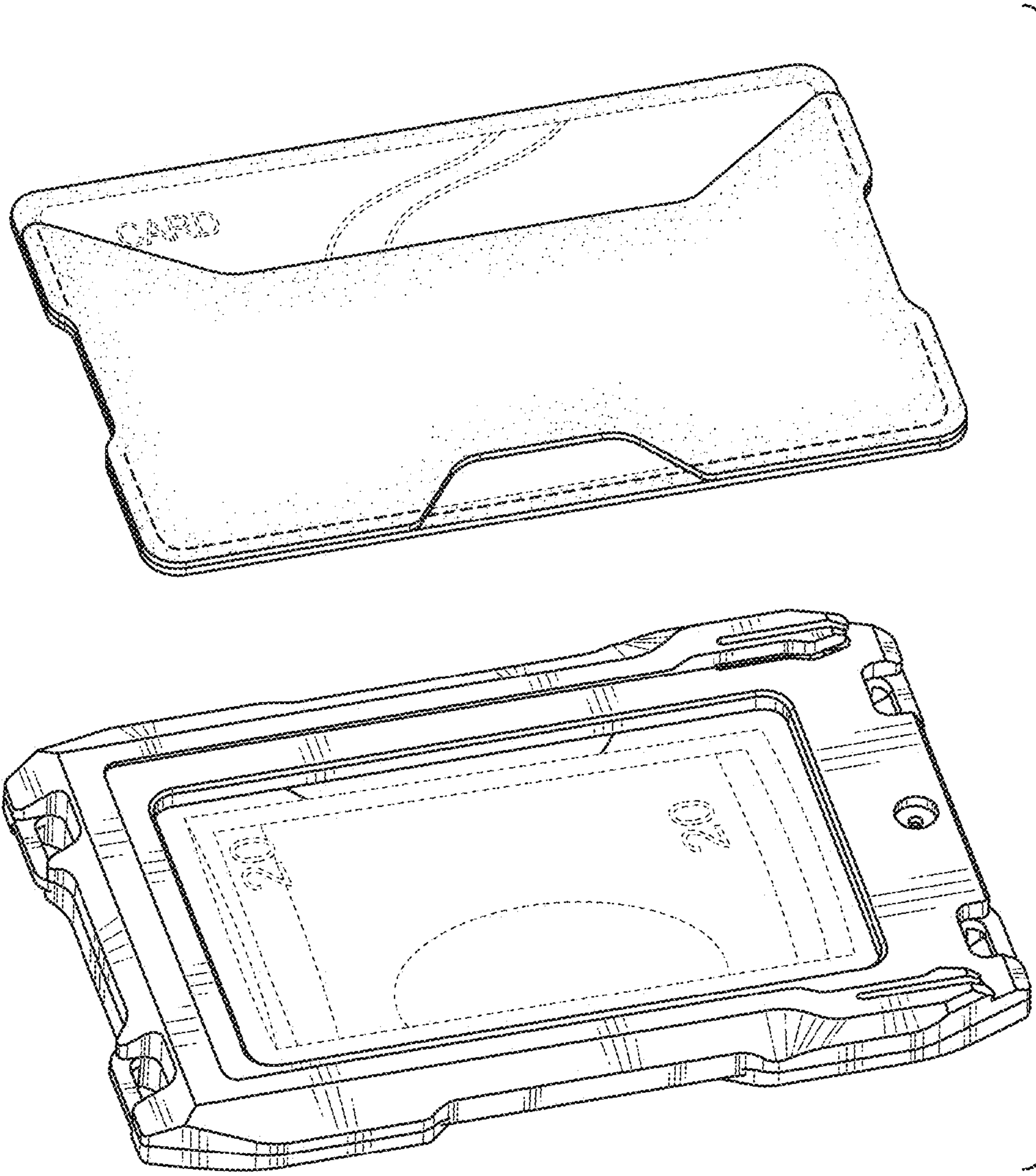
