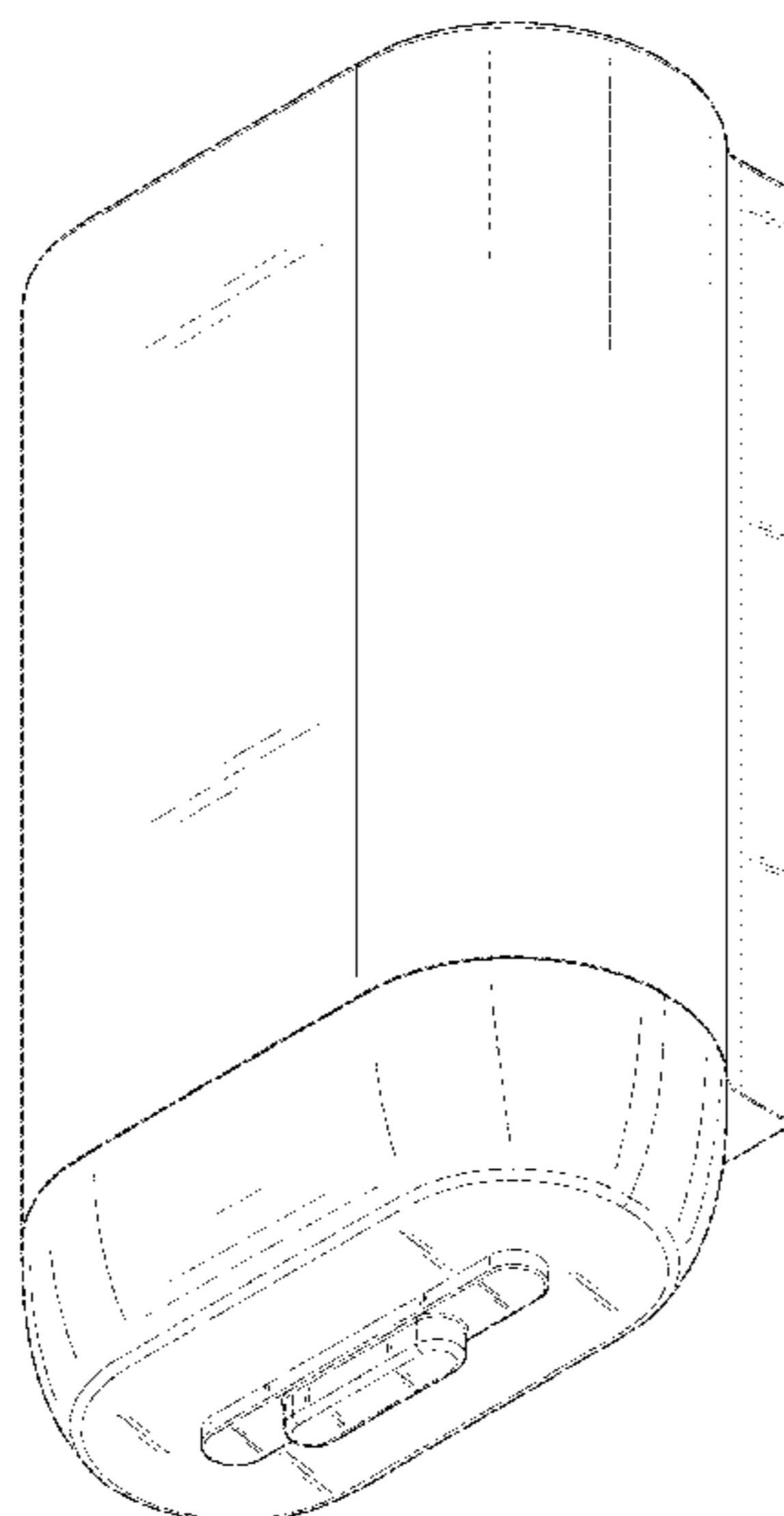
FIG. 1 is a front, raised perspective view of a soap dispenser according to a first embodiment of the invention;

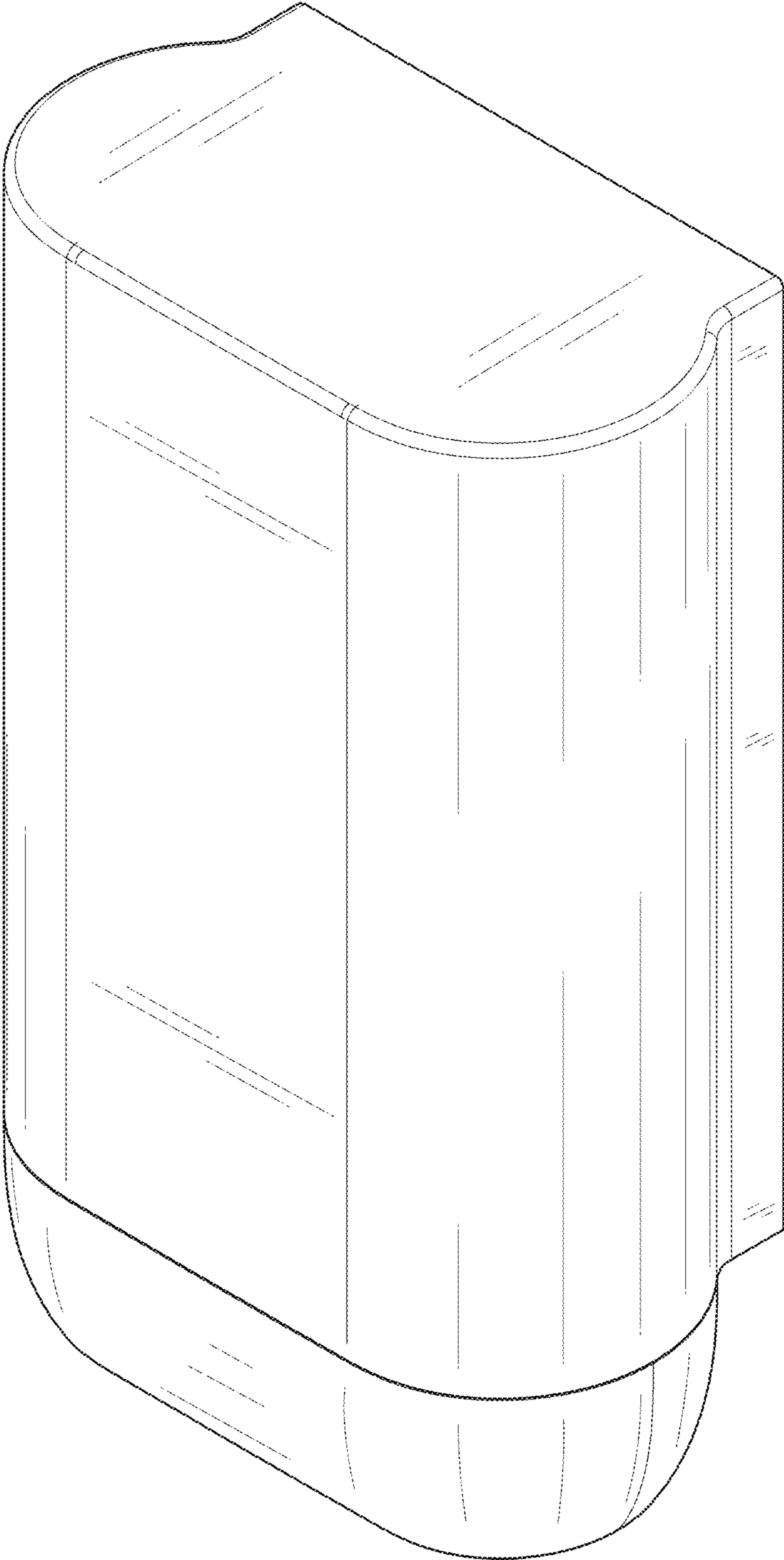

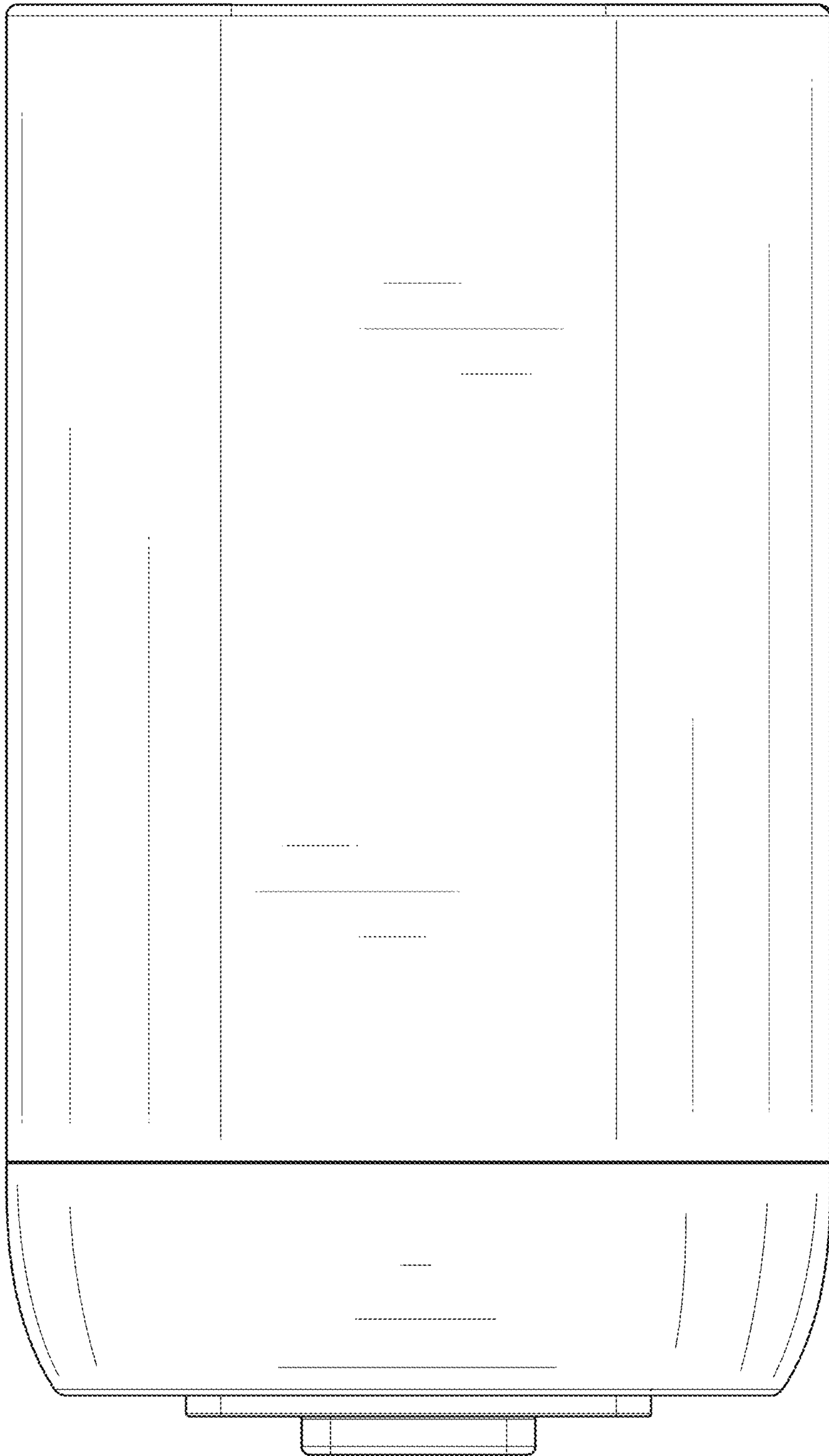

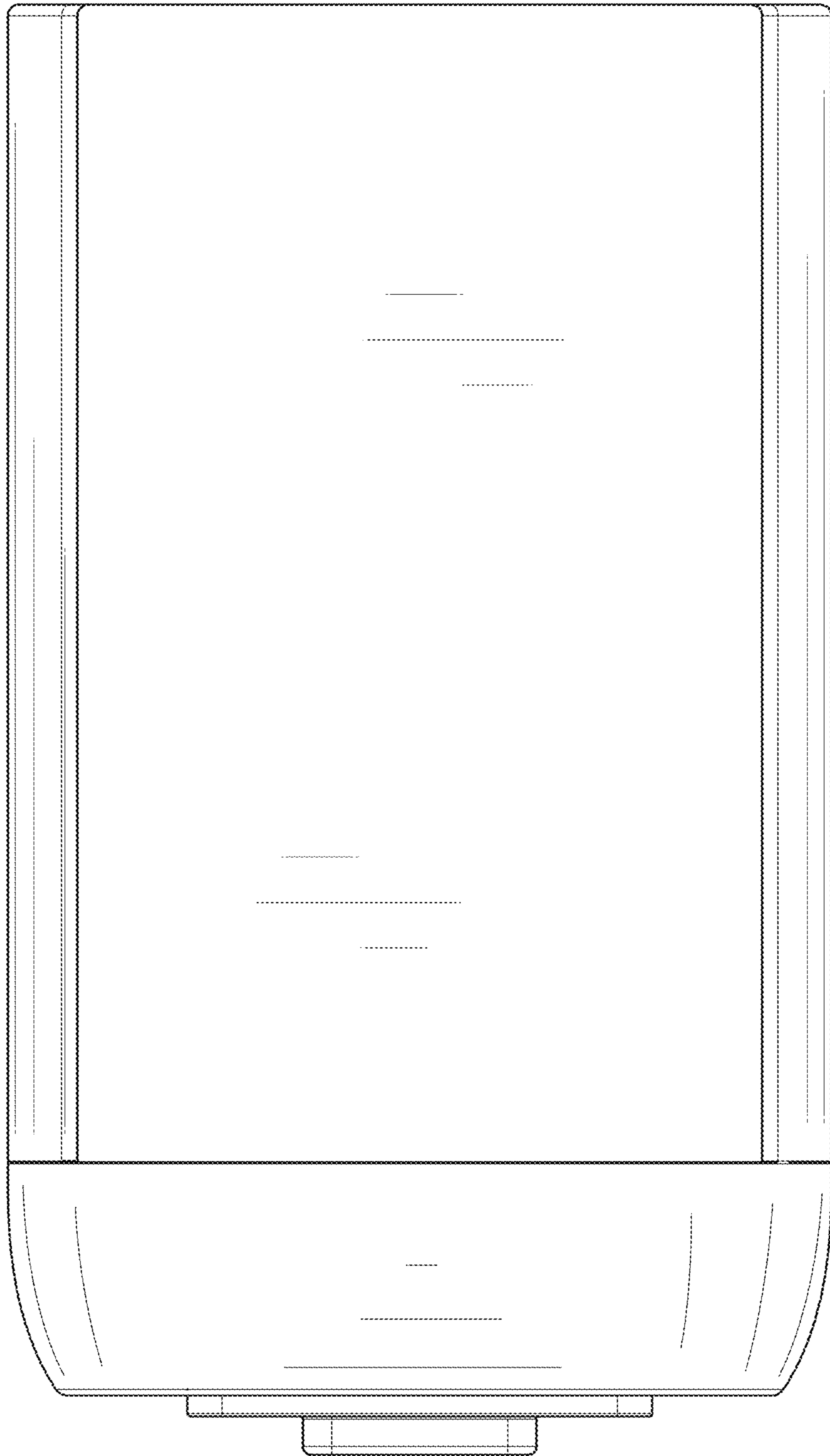

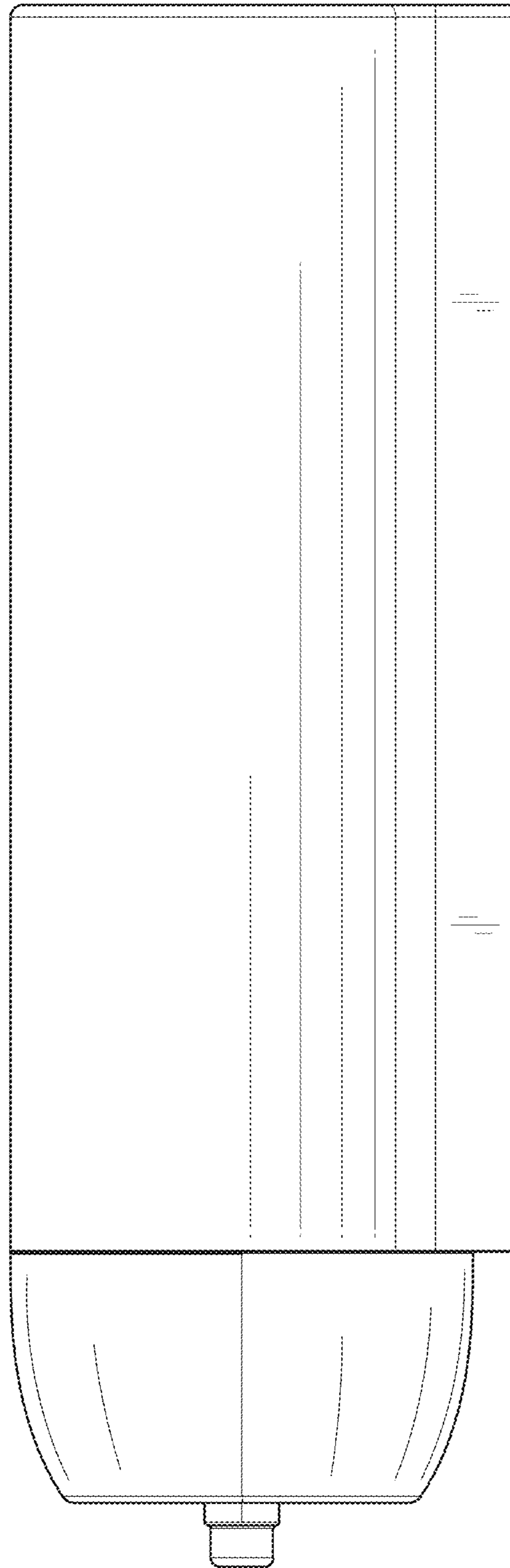

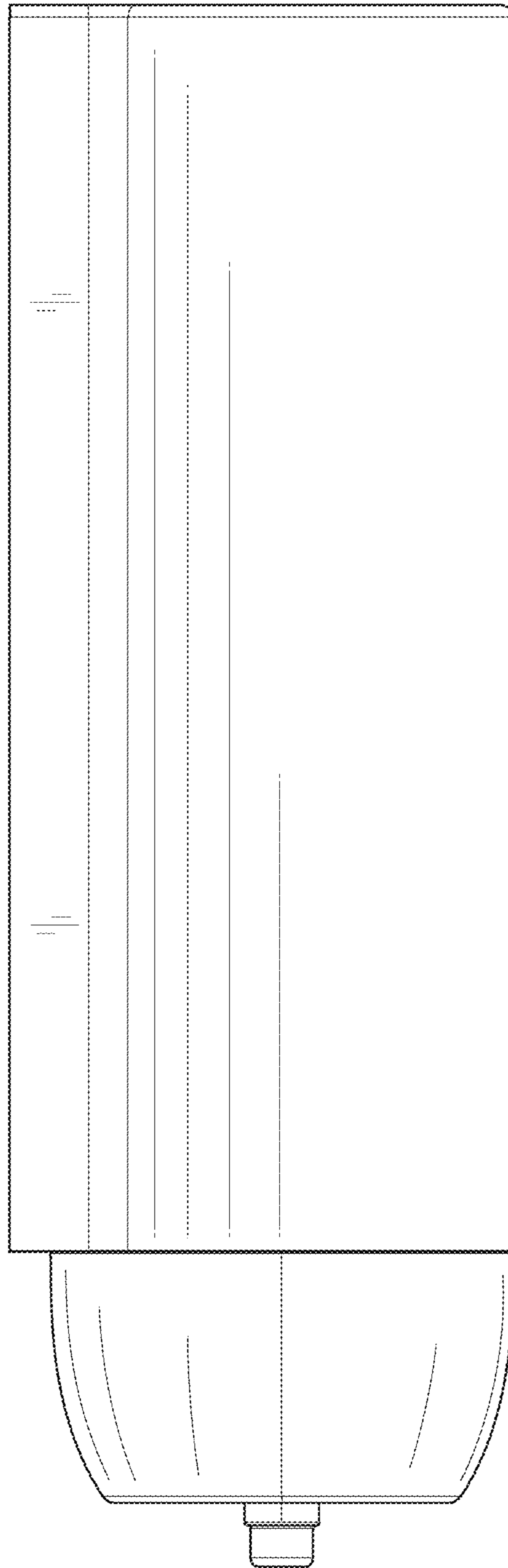

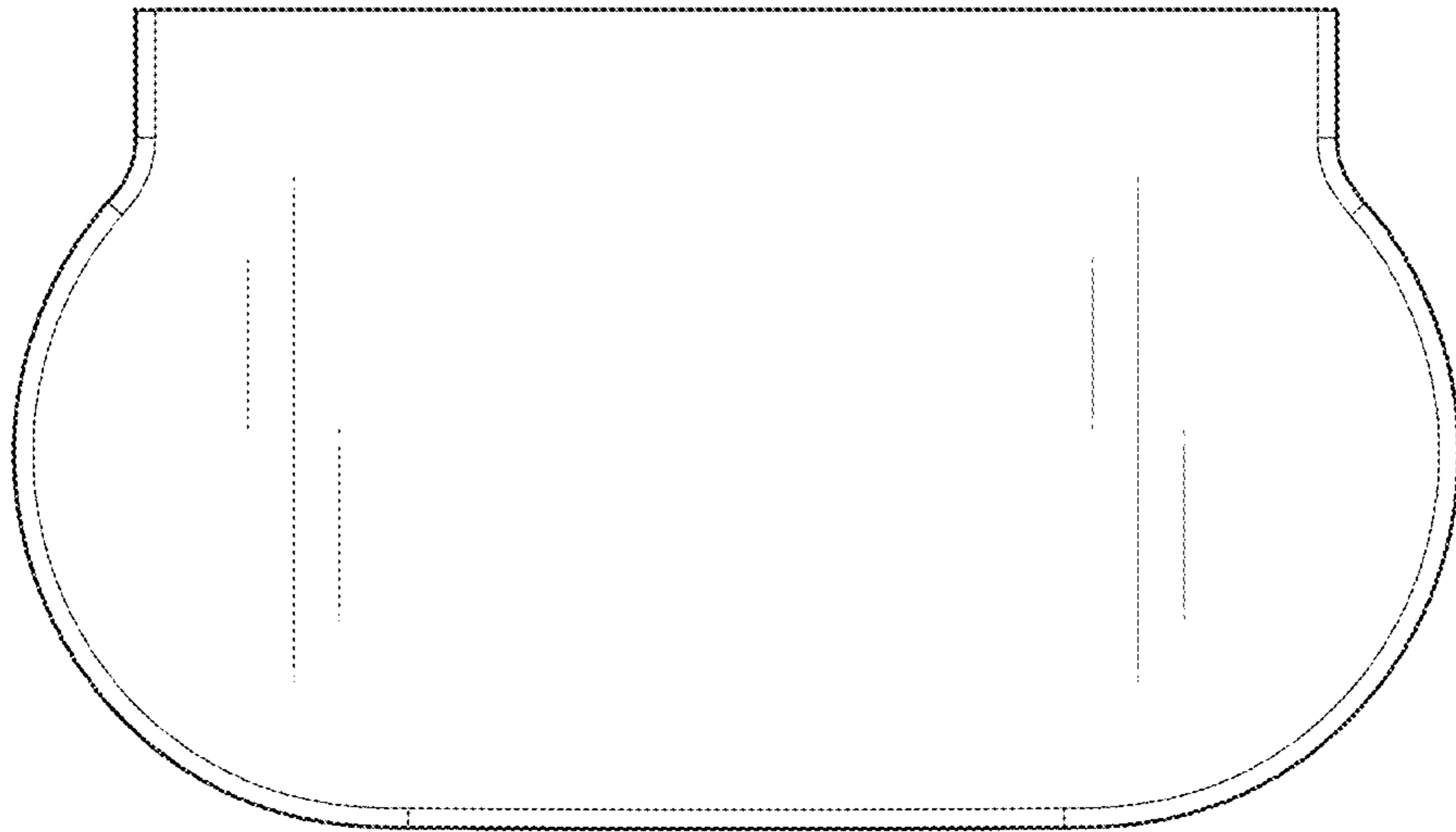

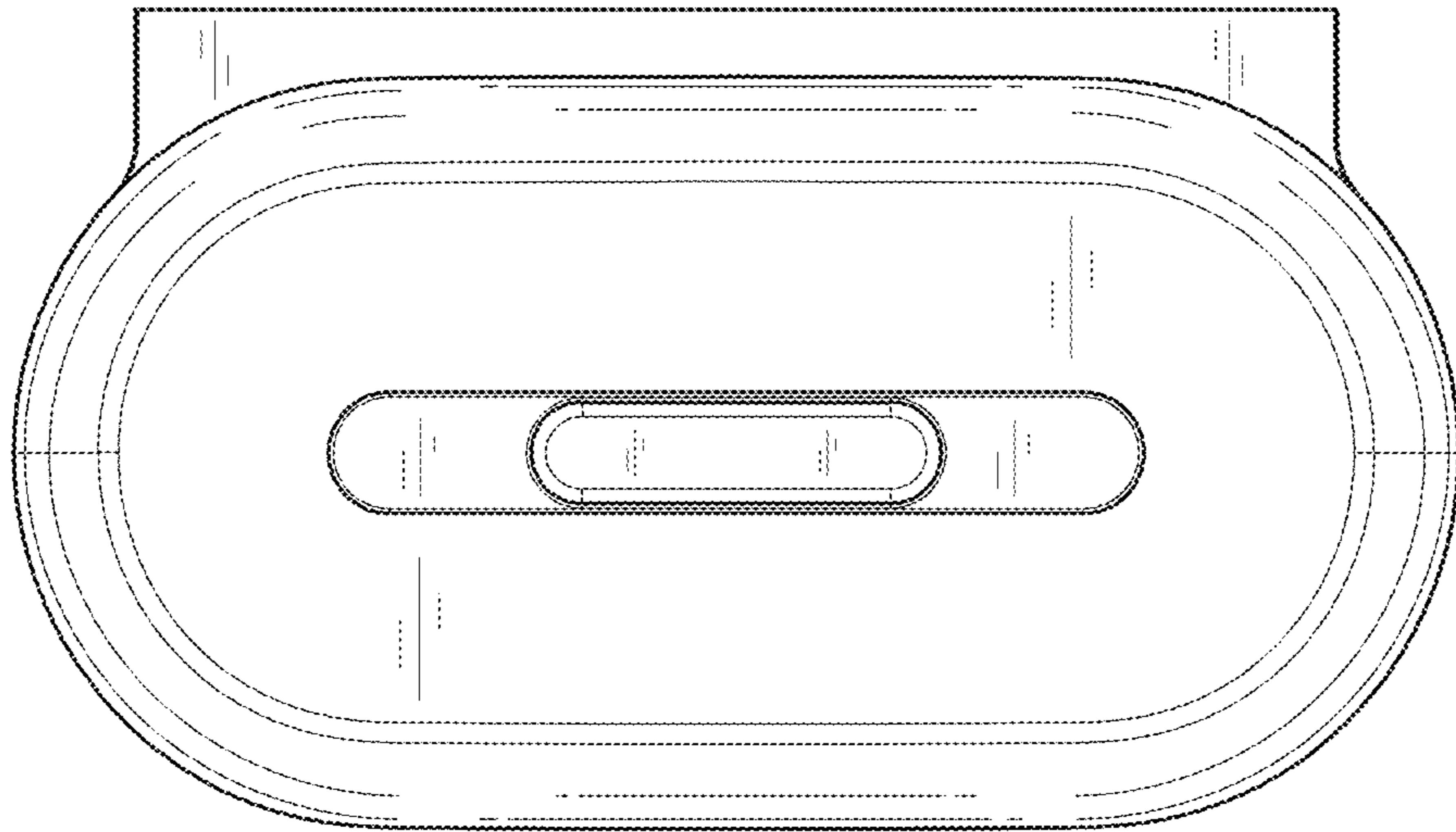

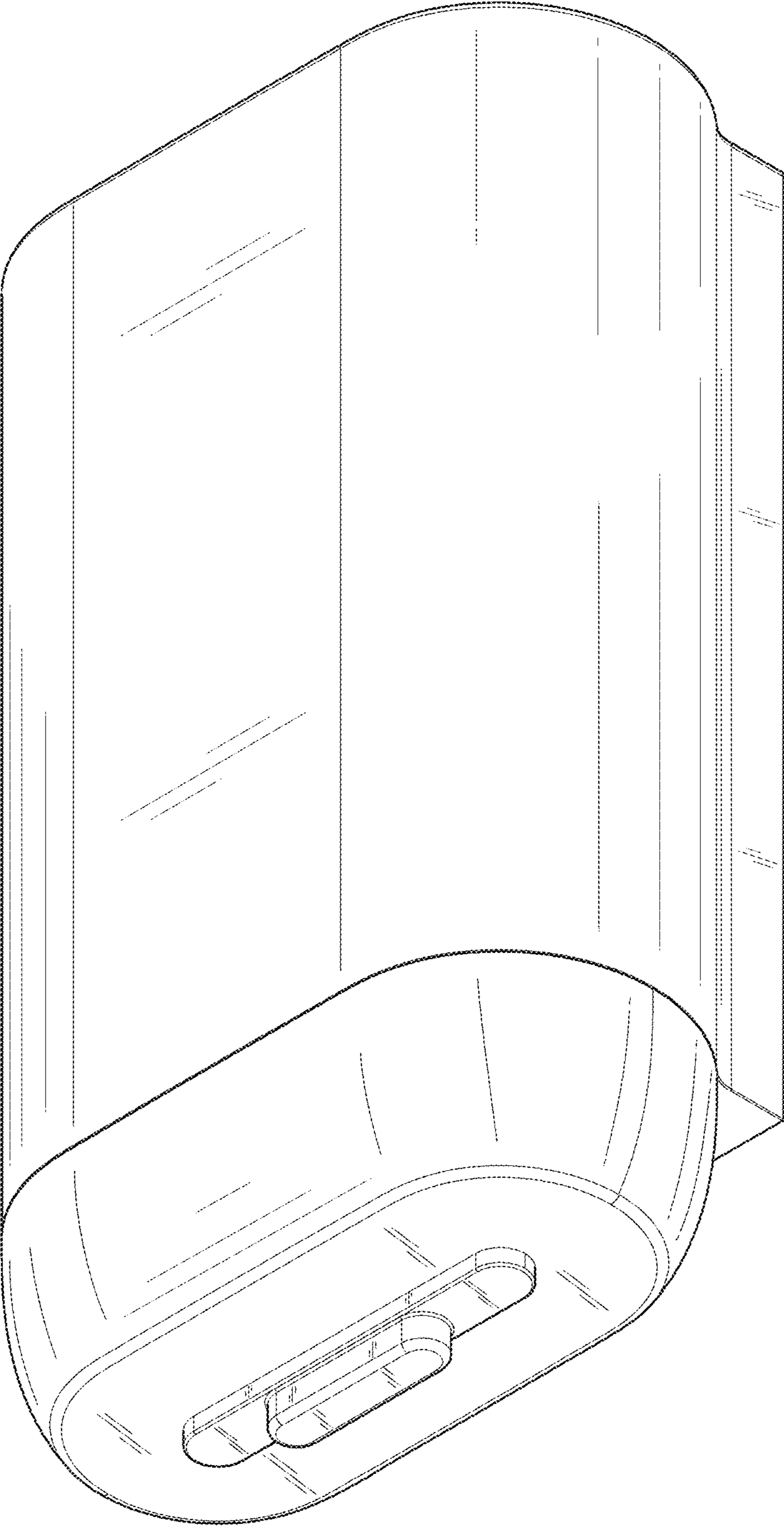

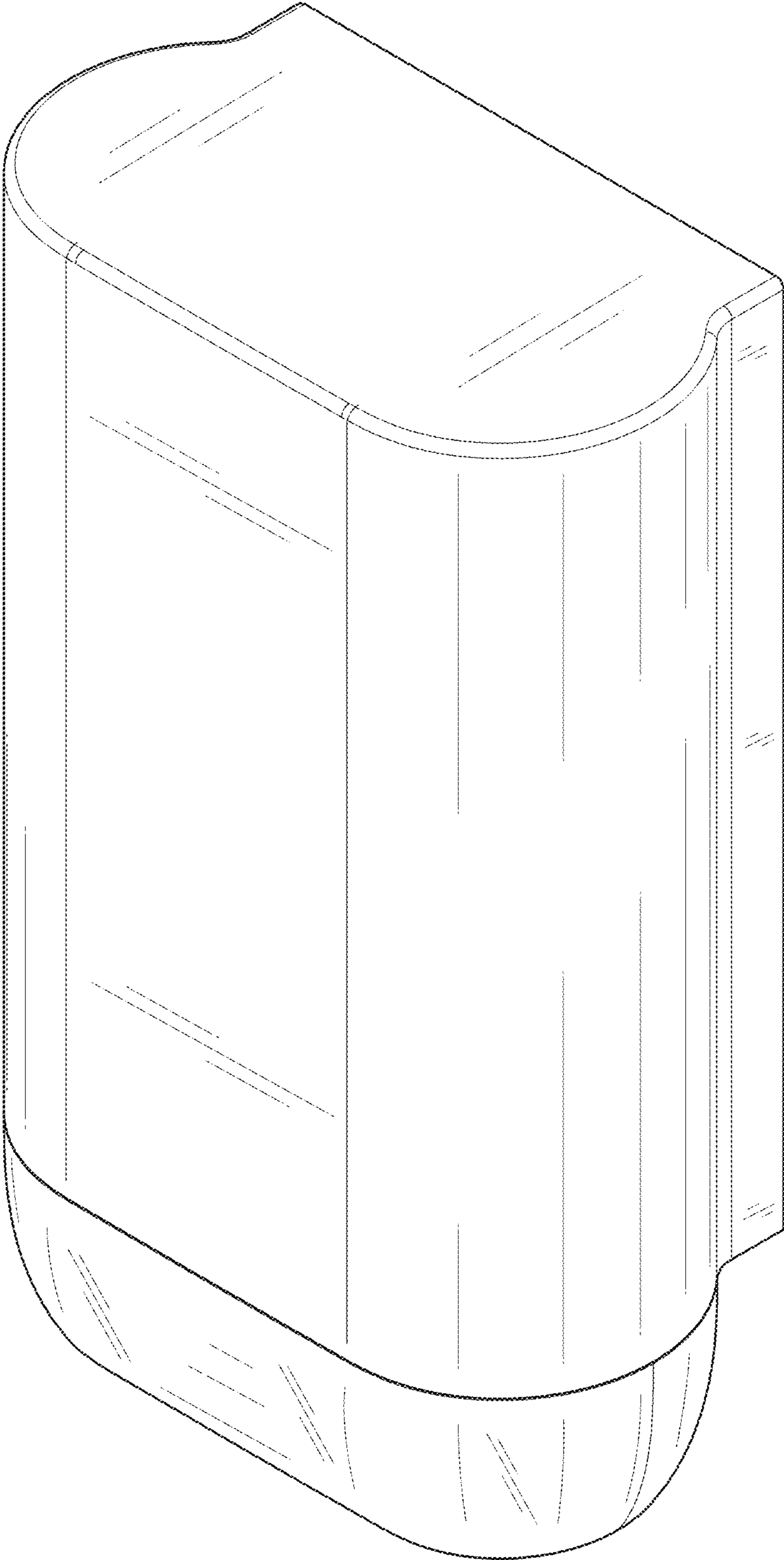

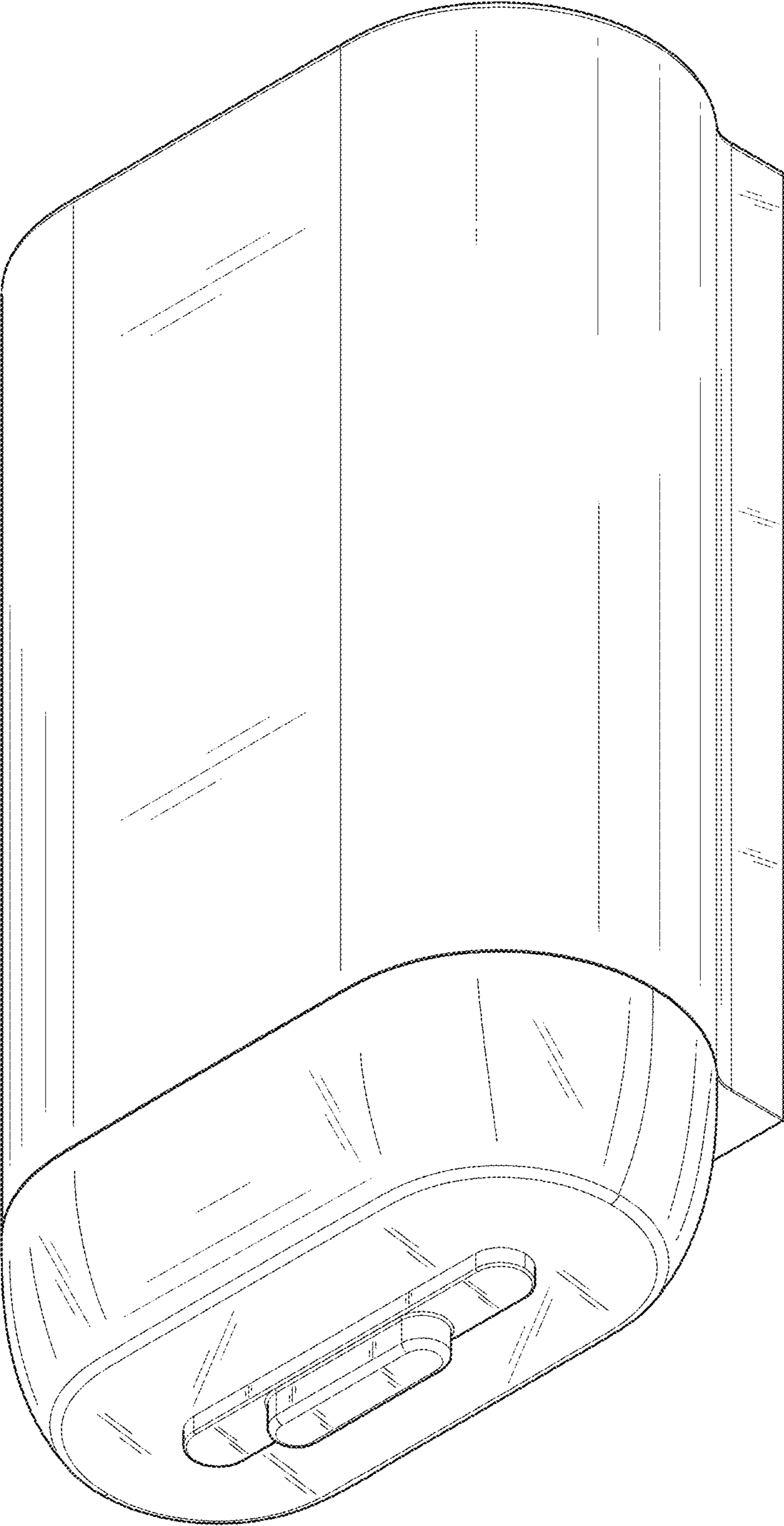
