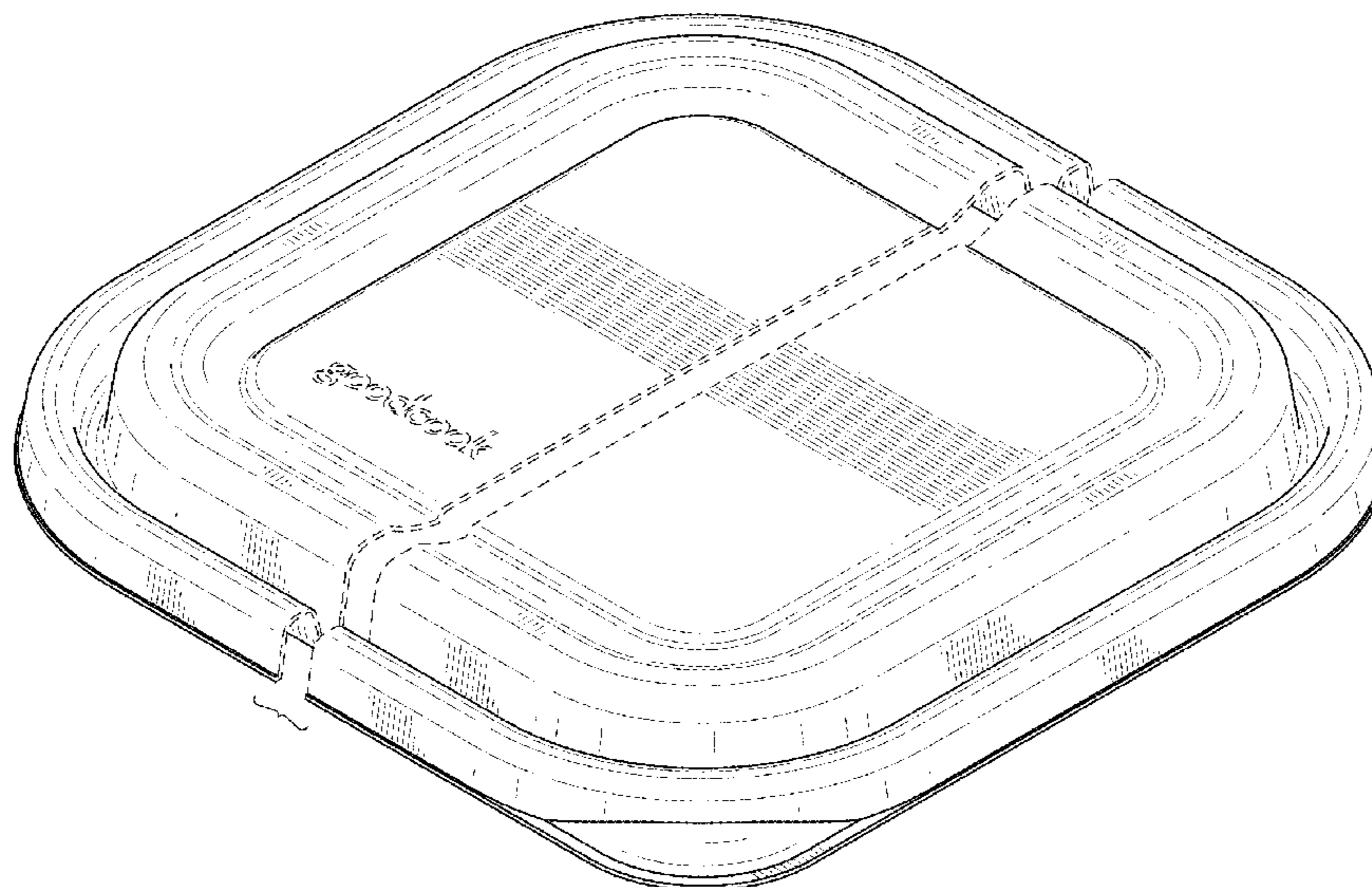
(57) **CLAIM**

The ornamental design for a lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right perspective view of a lid showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken line showing in the FIGS. 1 and 6 is for the purpose of illustrating portions of the lid that form no part of the claimed design. The dashed lines shown in the center of FIGS. 1-3, 6 and 7 represent a symbolic break in length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

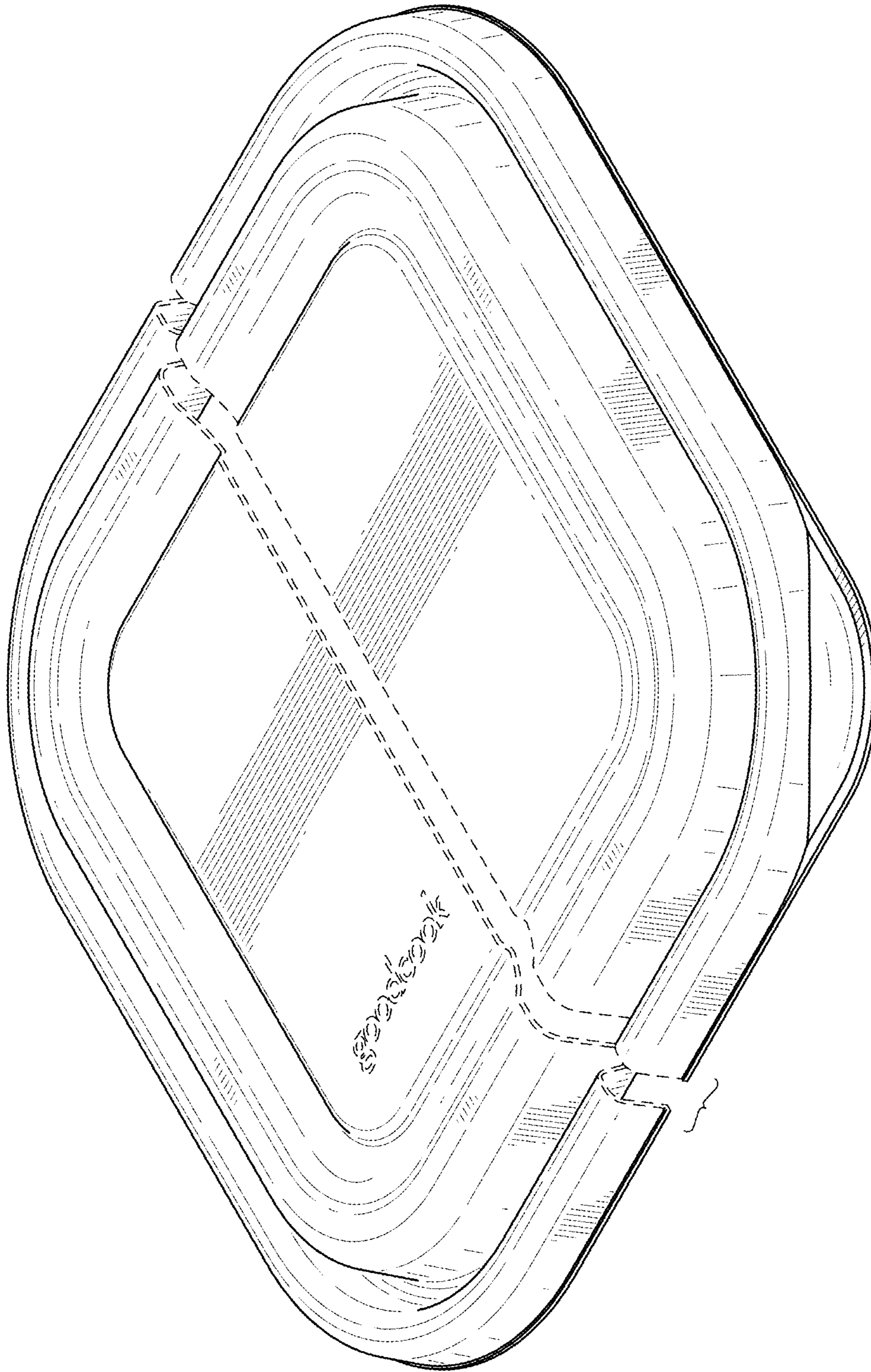

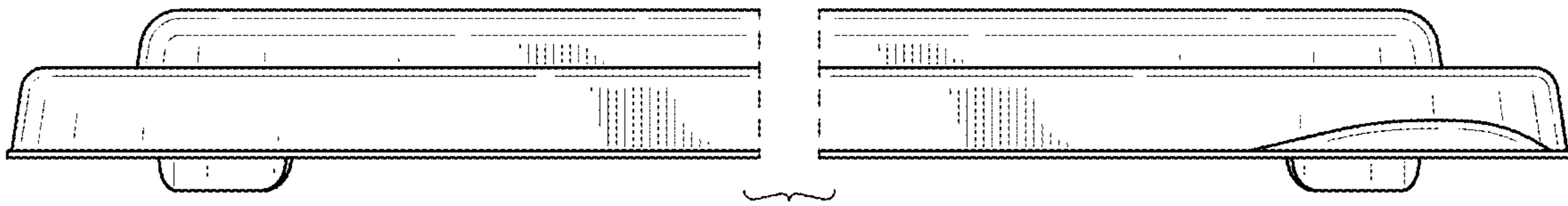

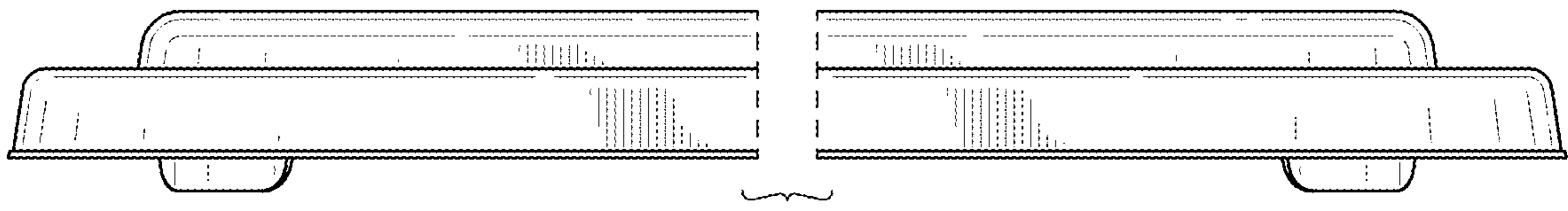

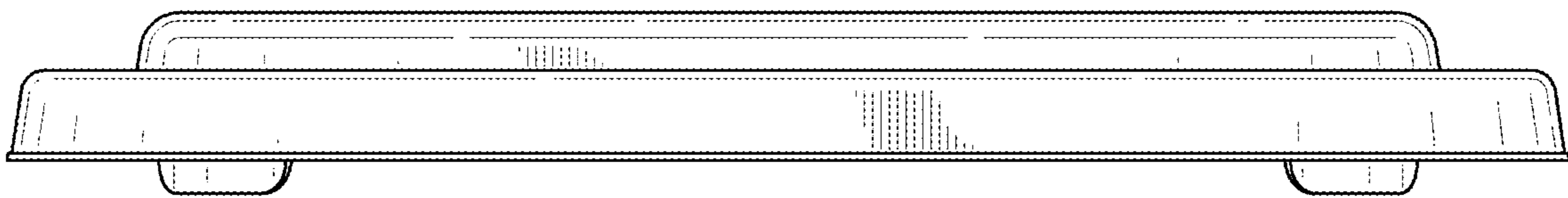

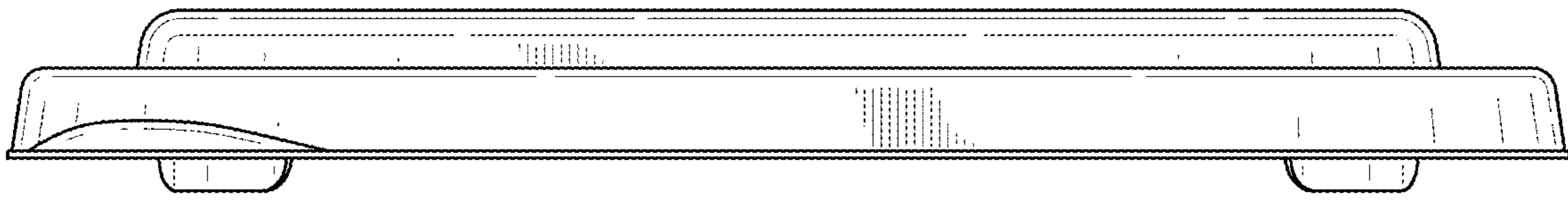

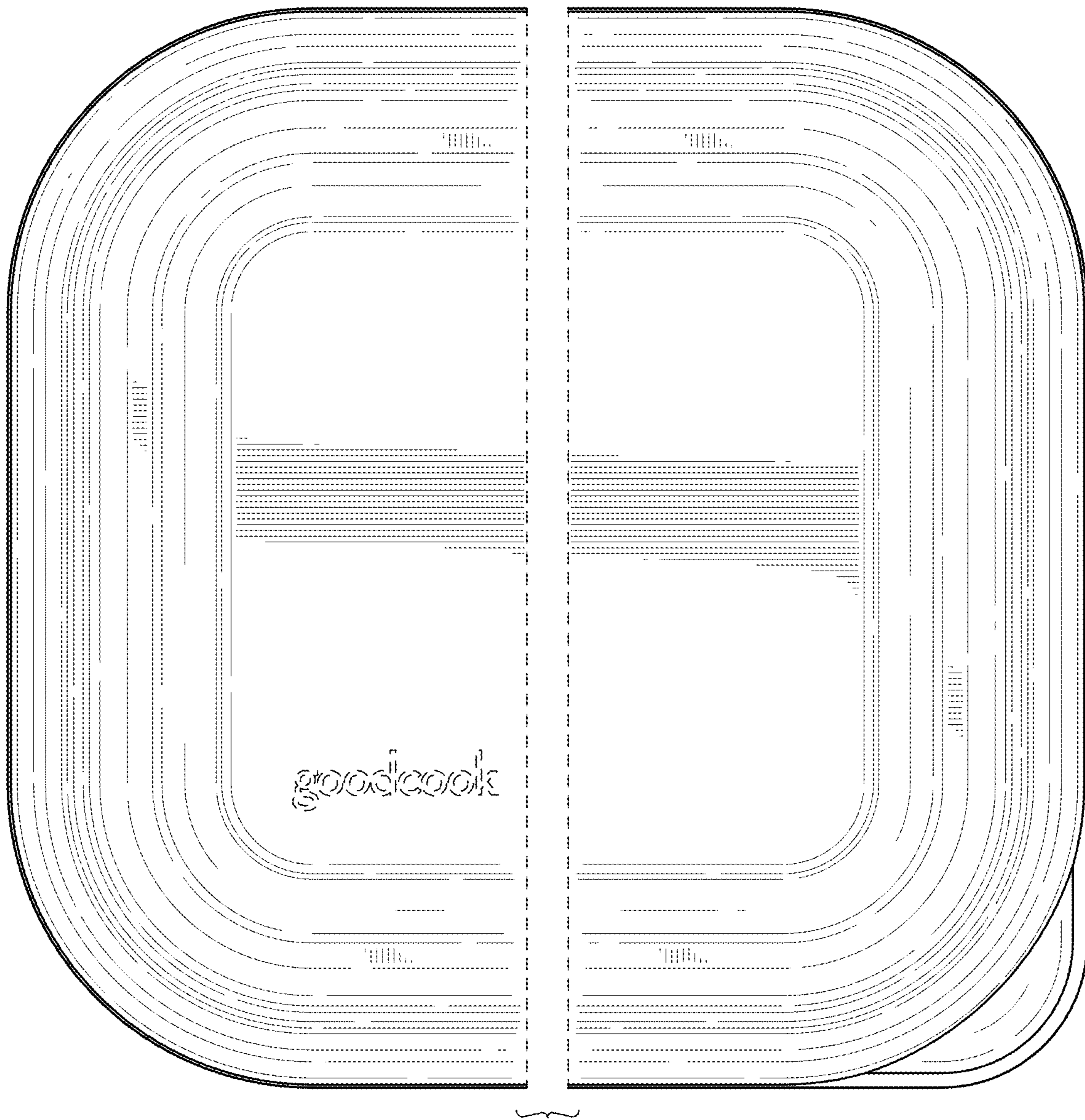

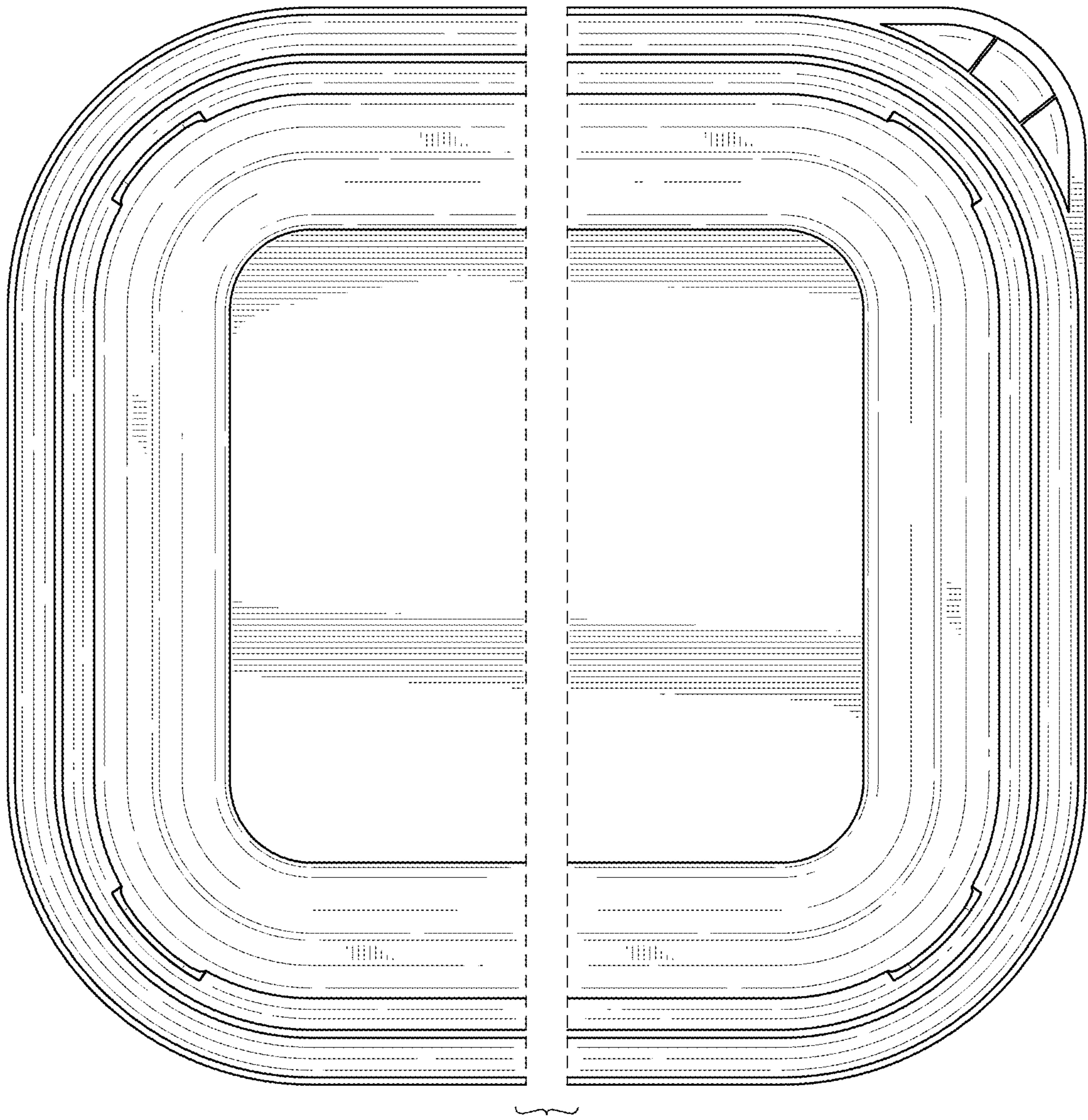
