**DESCRIPTION**

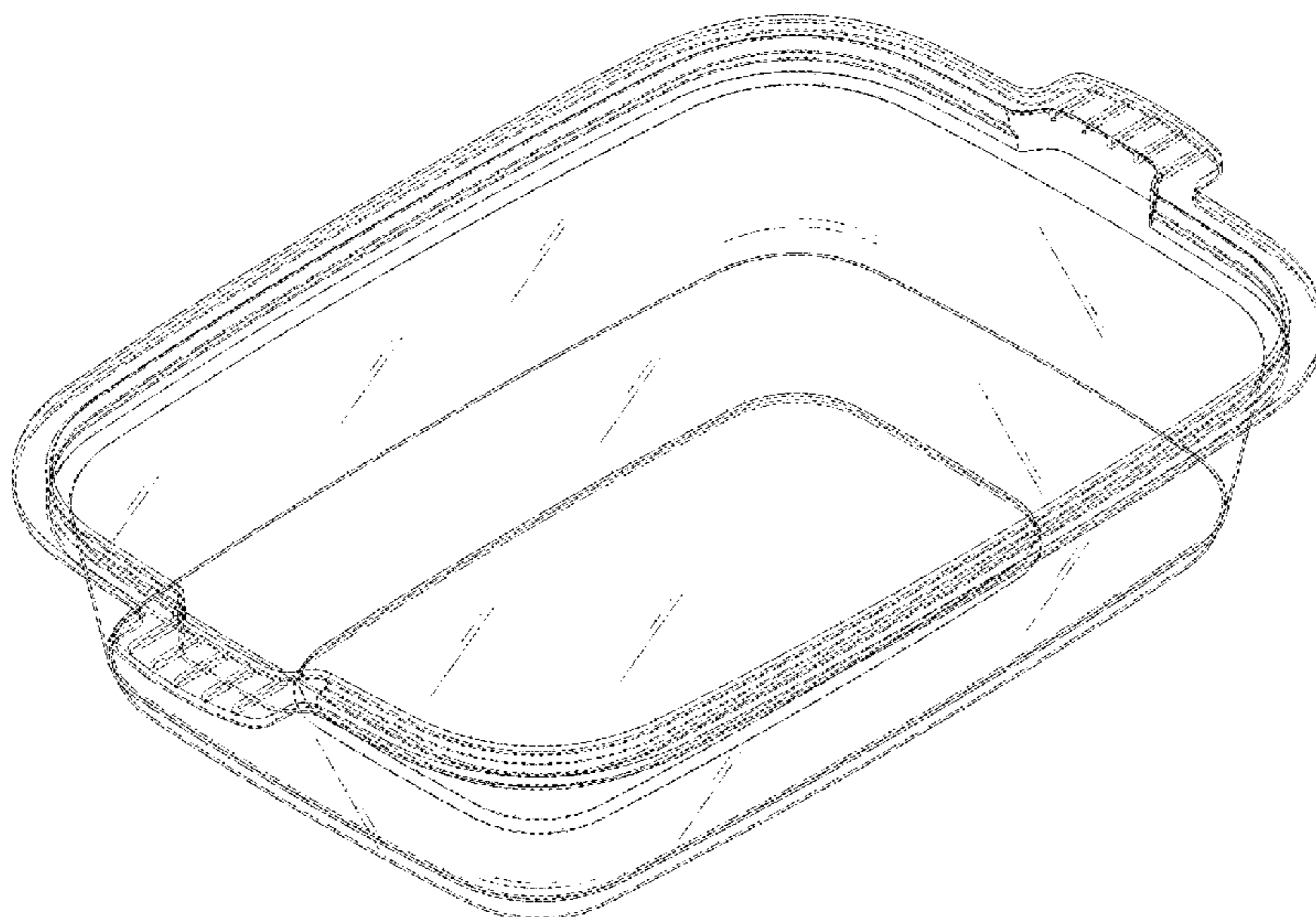
FIG. 1 is a top perspective view of a box showing my new design;

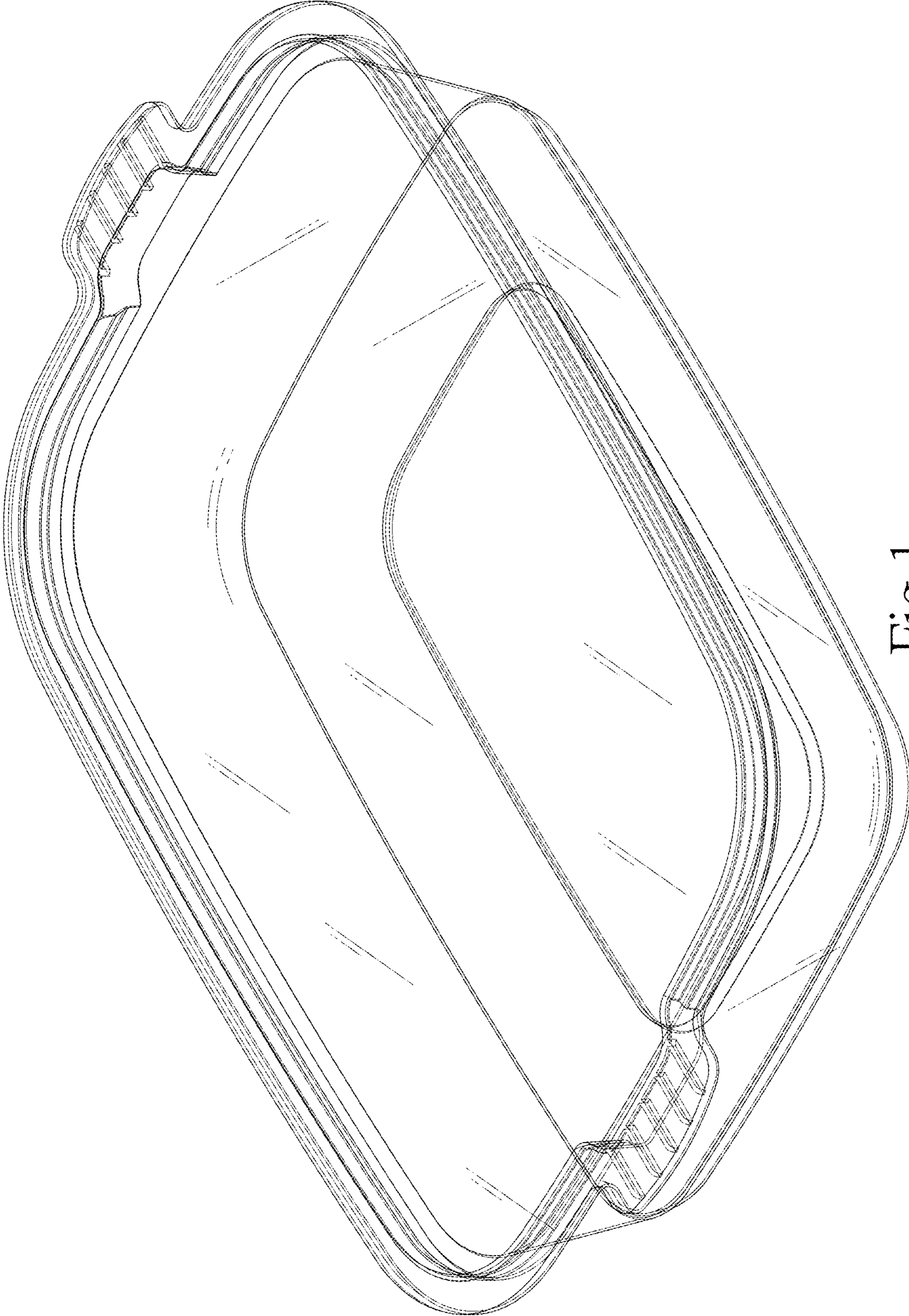

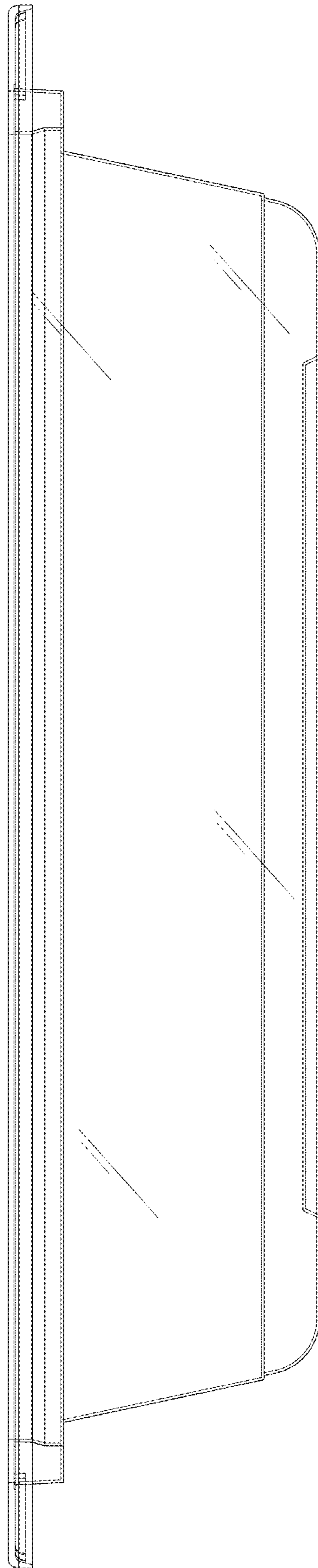

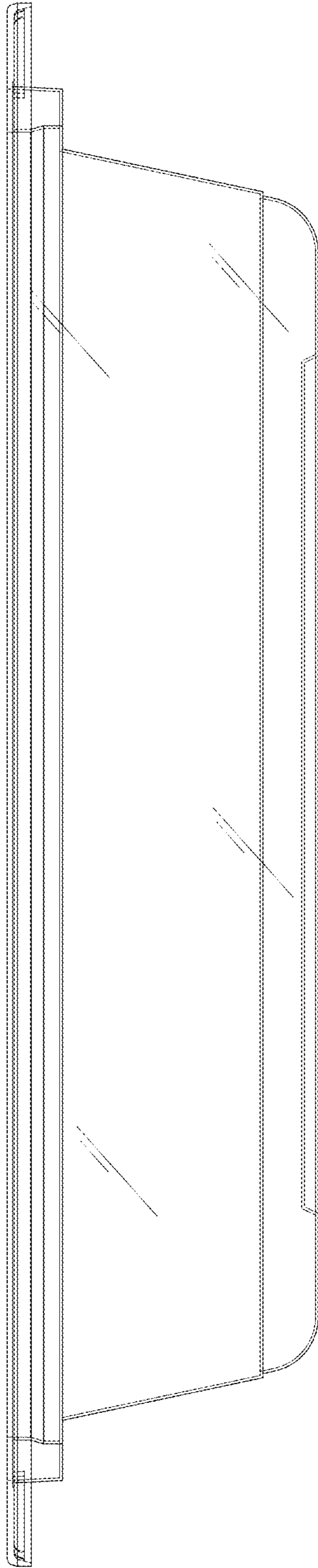

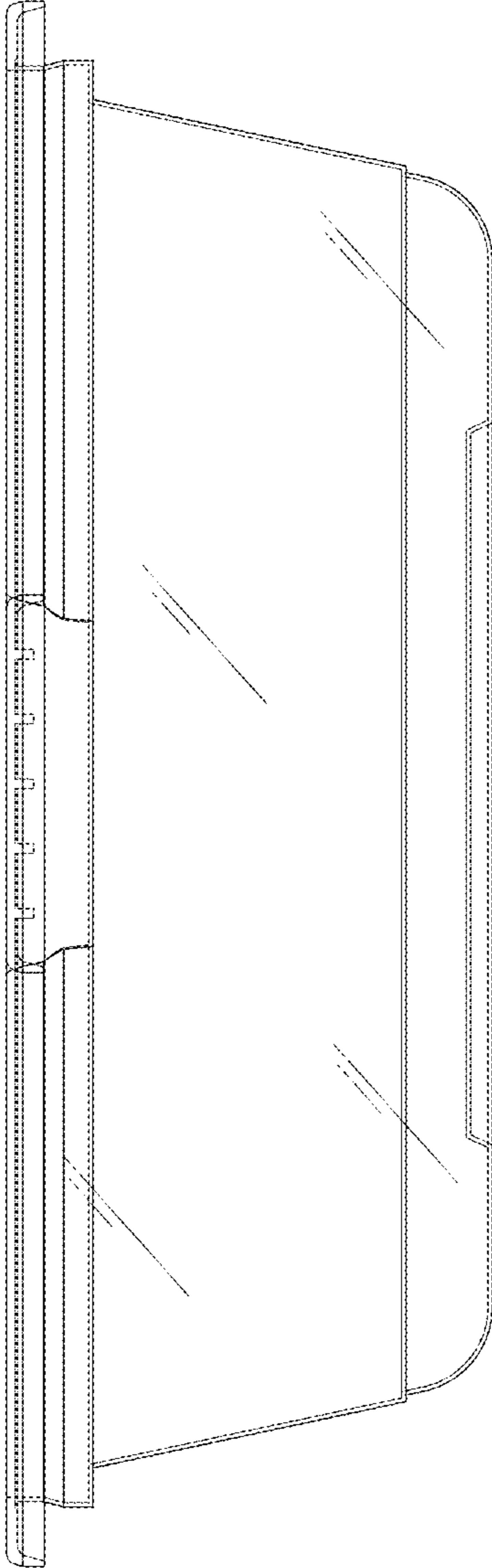

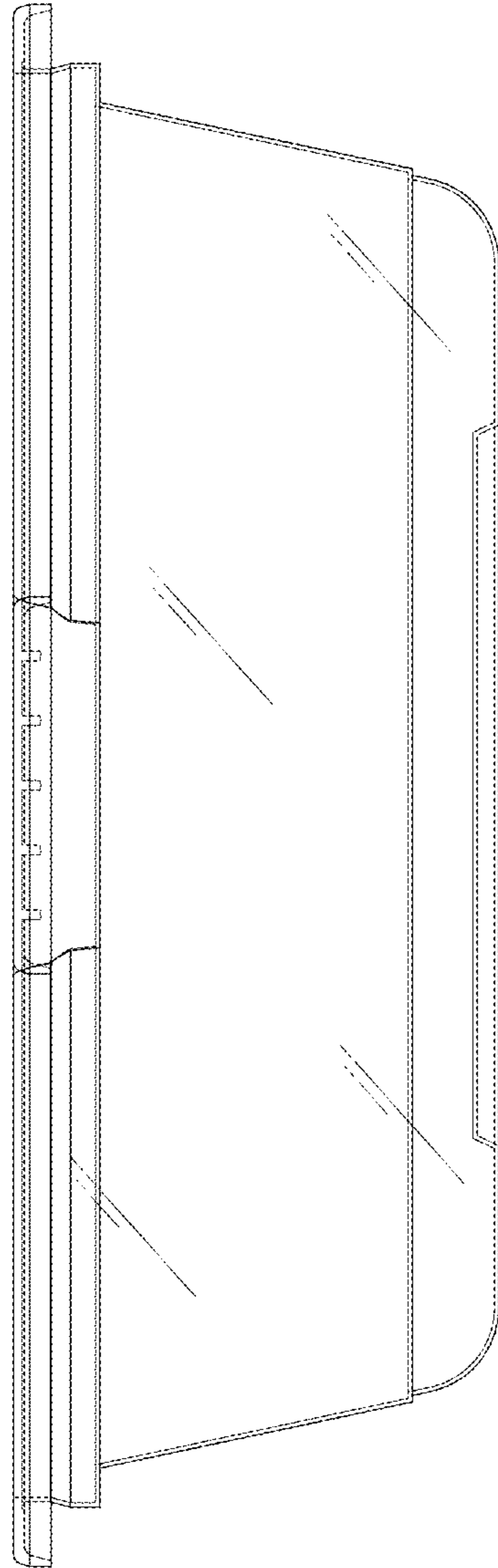

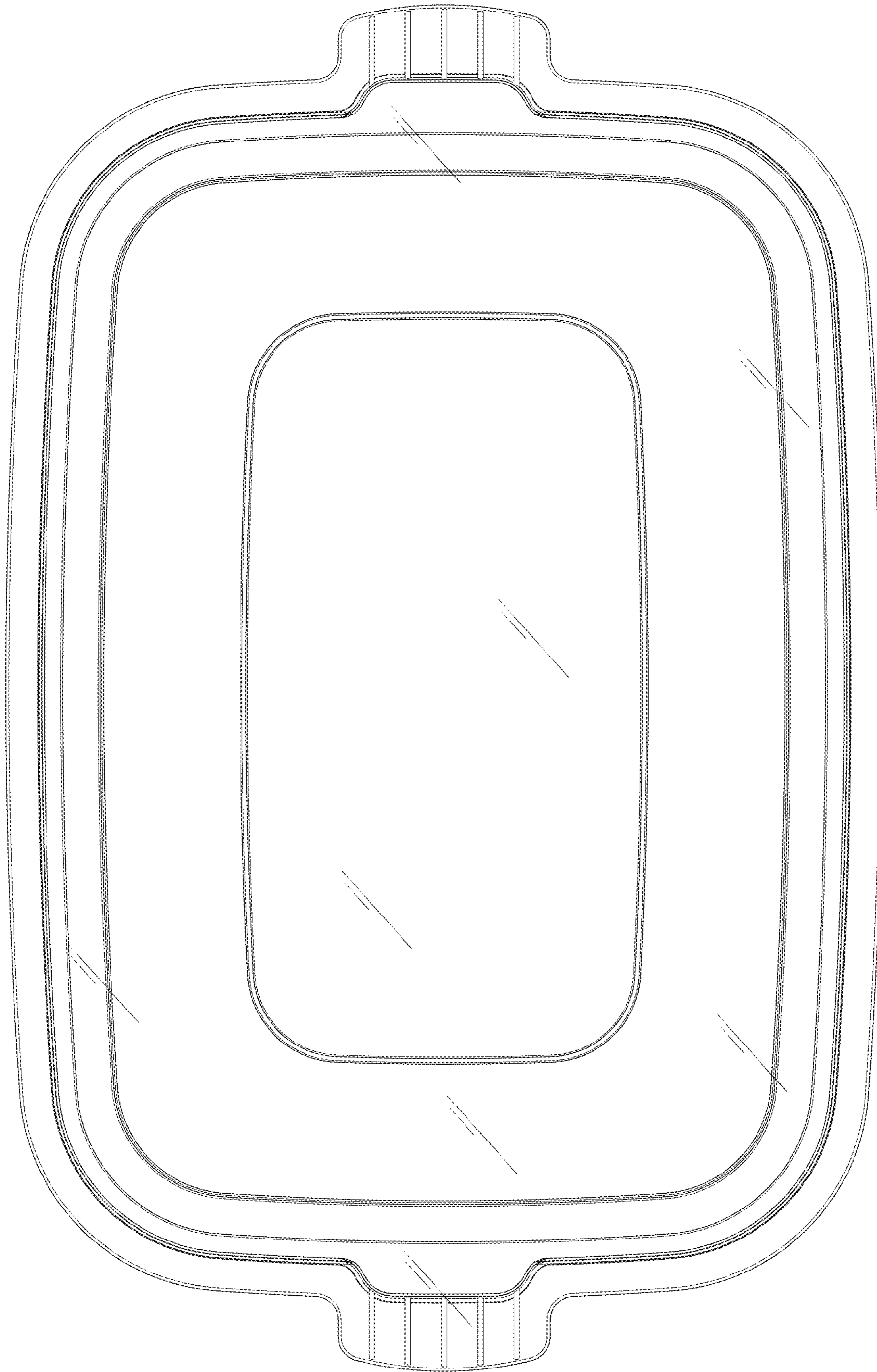

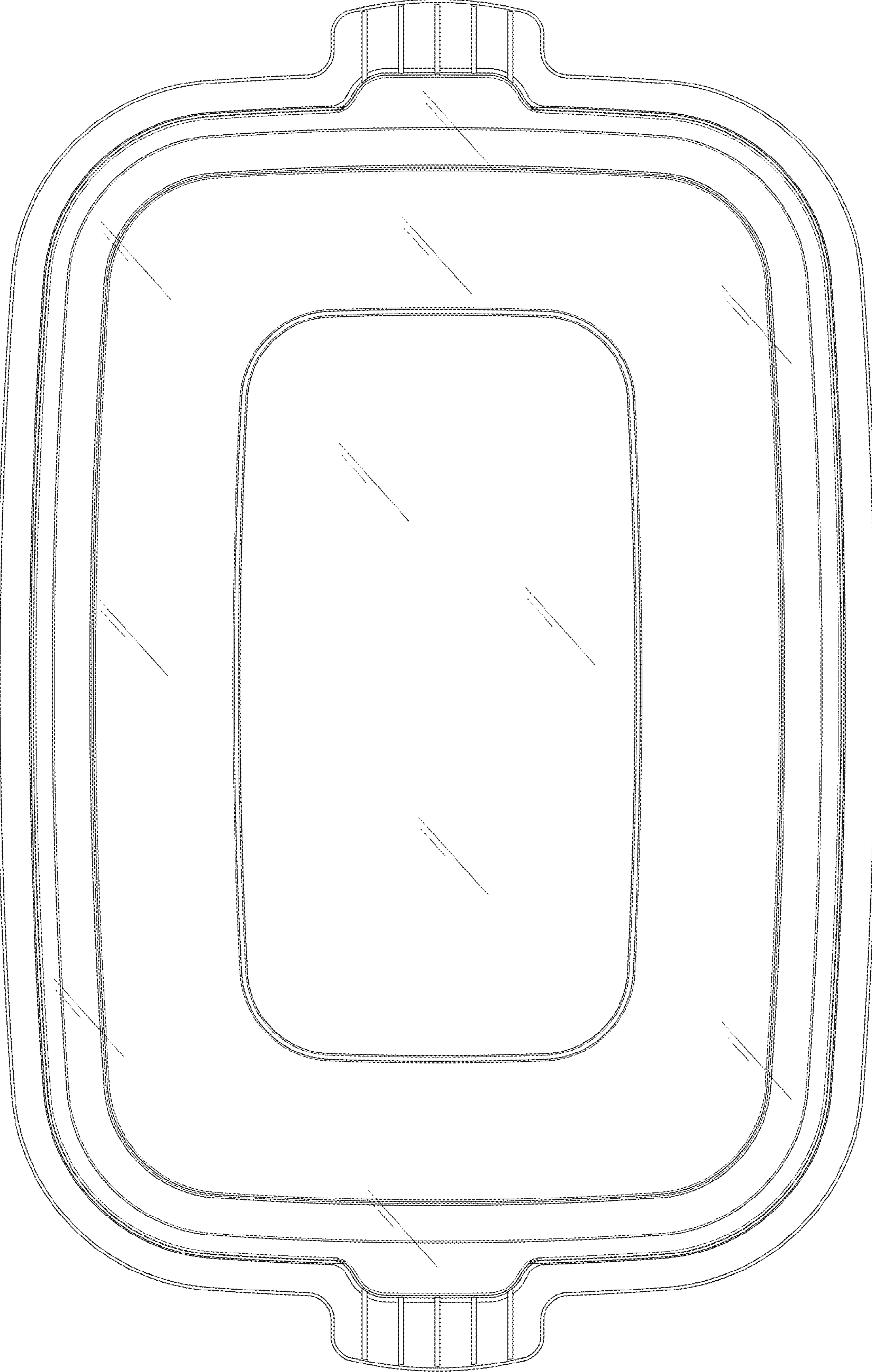
