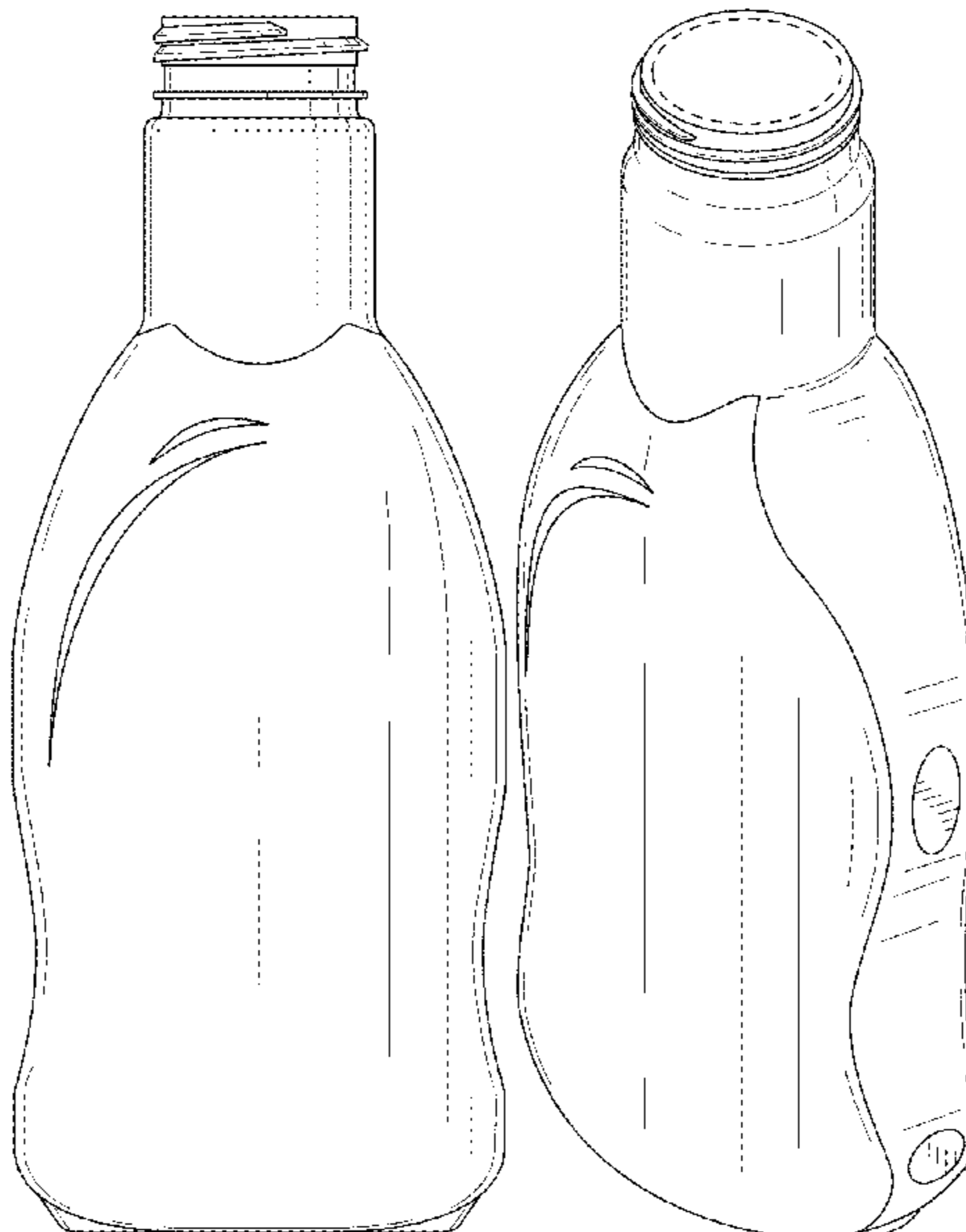
(57) **CLAIM**

I claim, the ornamental design for a dressing bottle, as shown and described.

DESCRIPTION

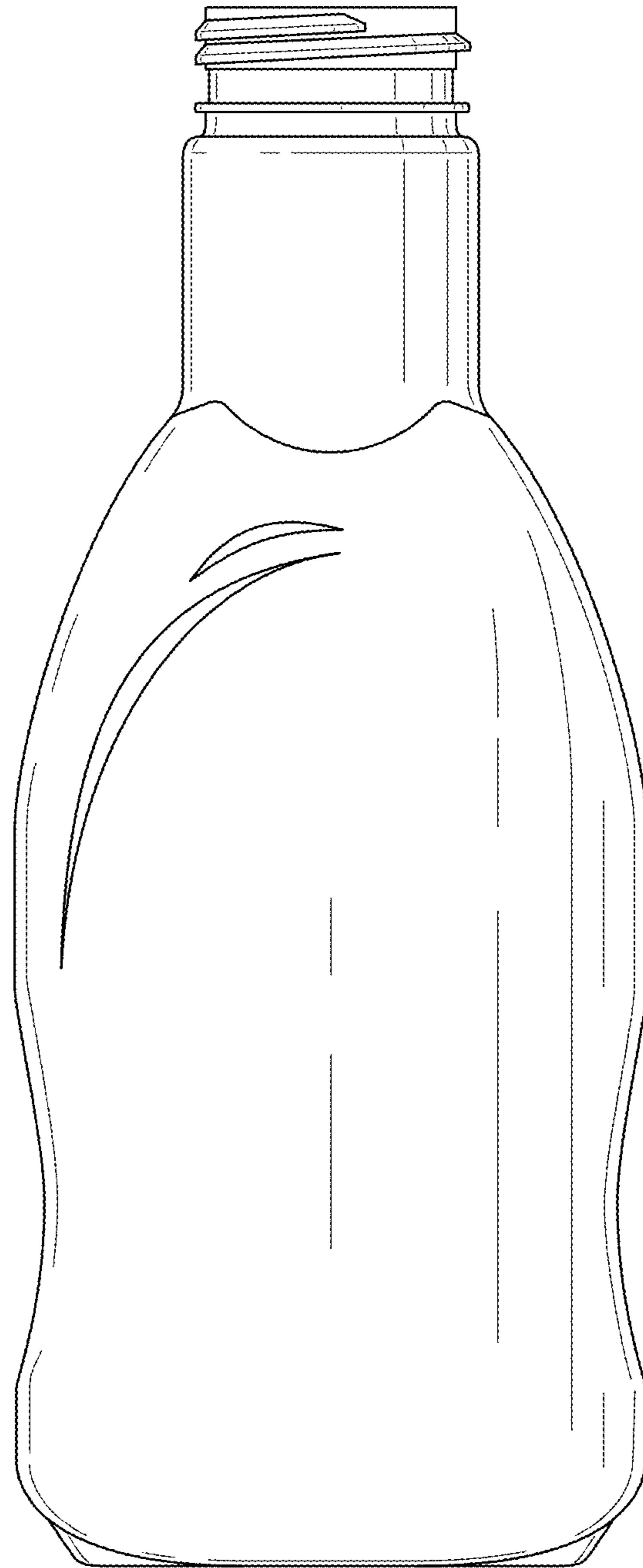

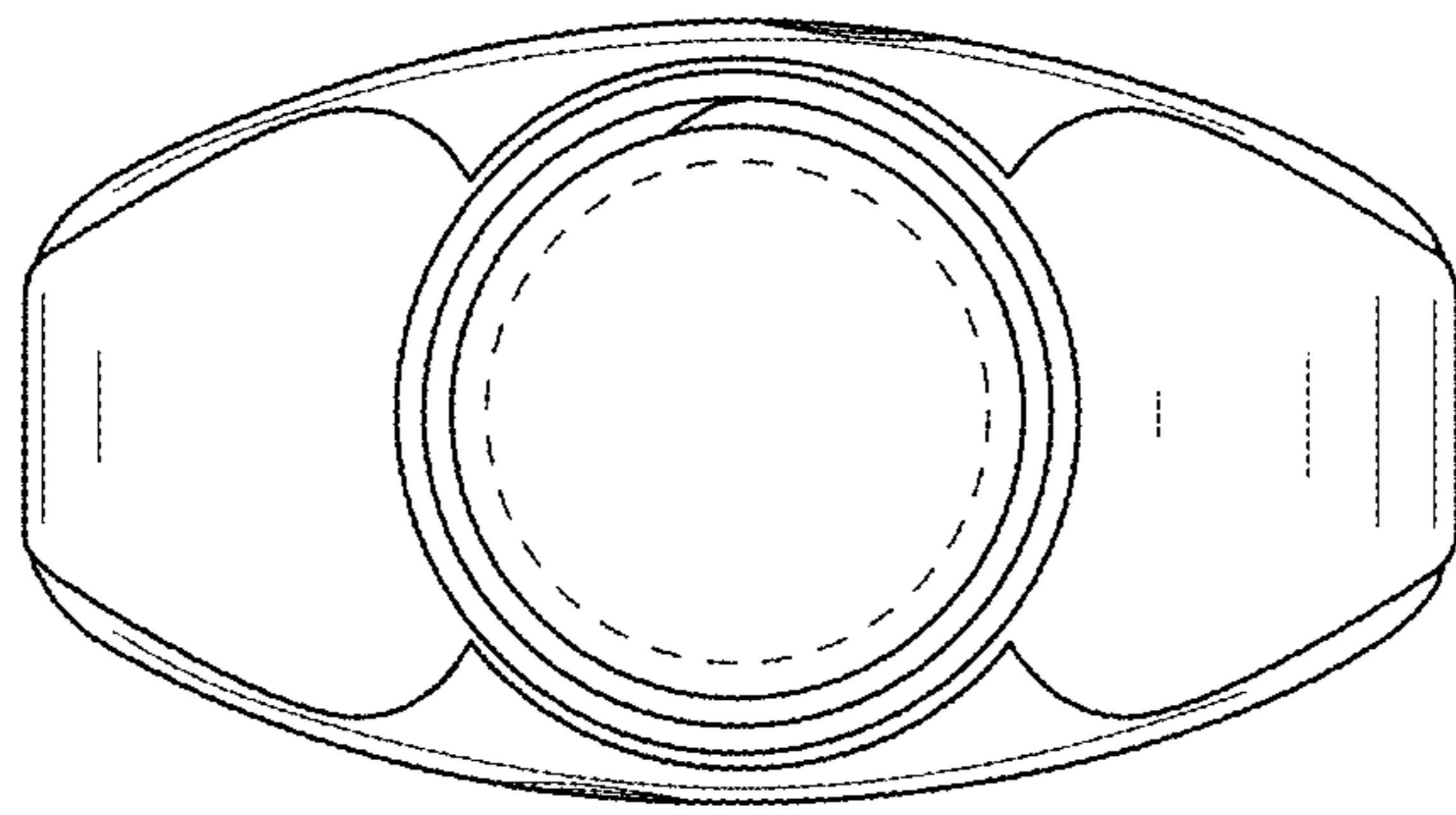

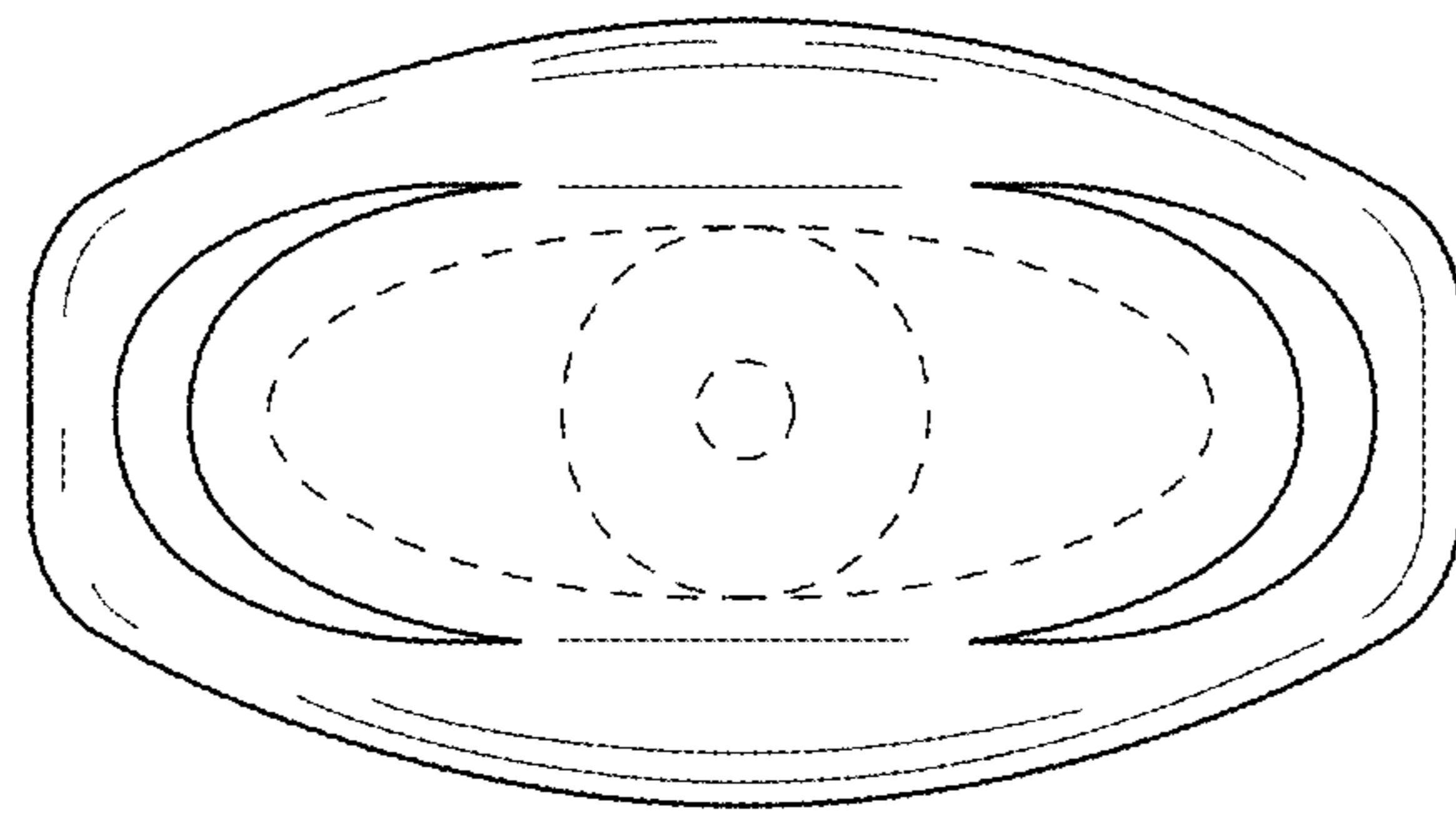

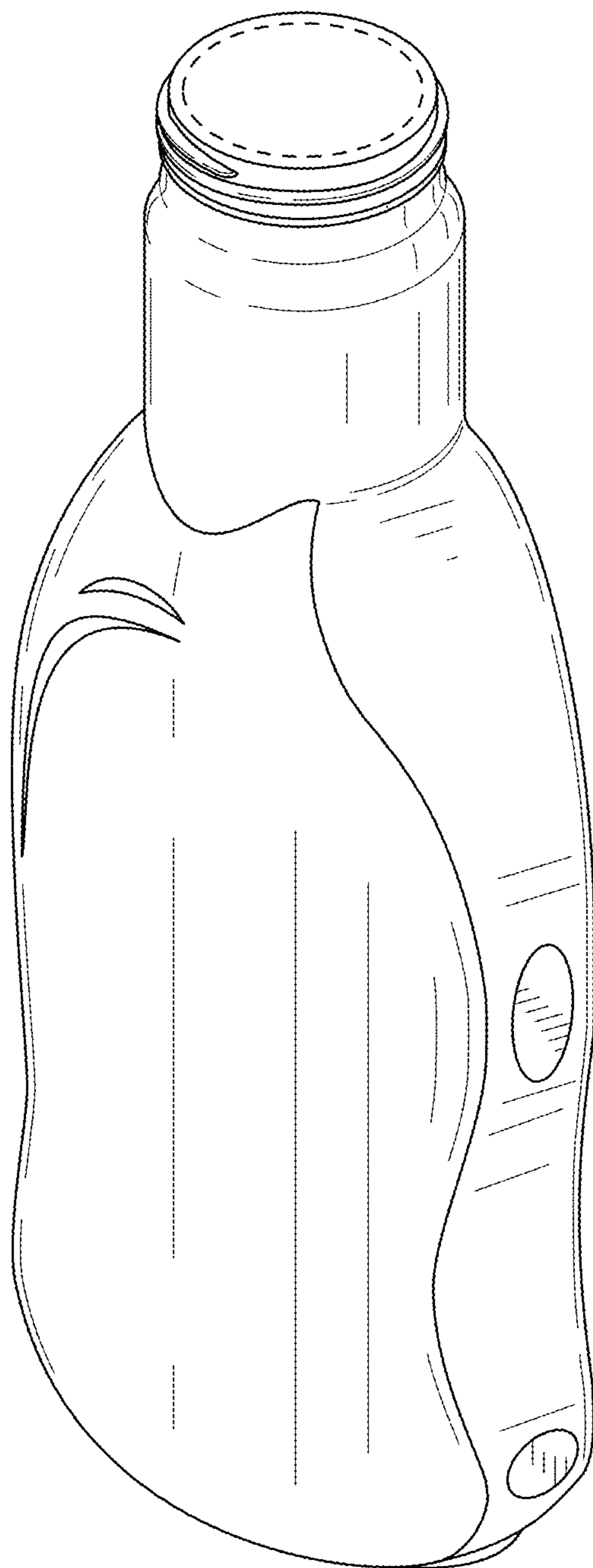
