(57) **CLAIM**

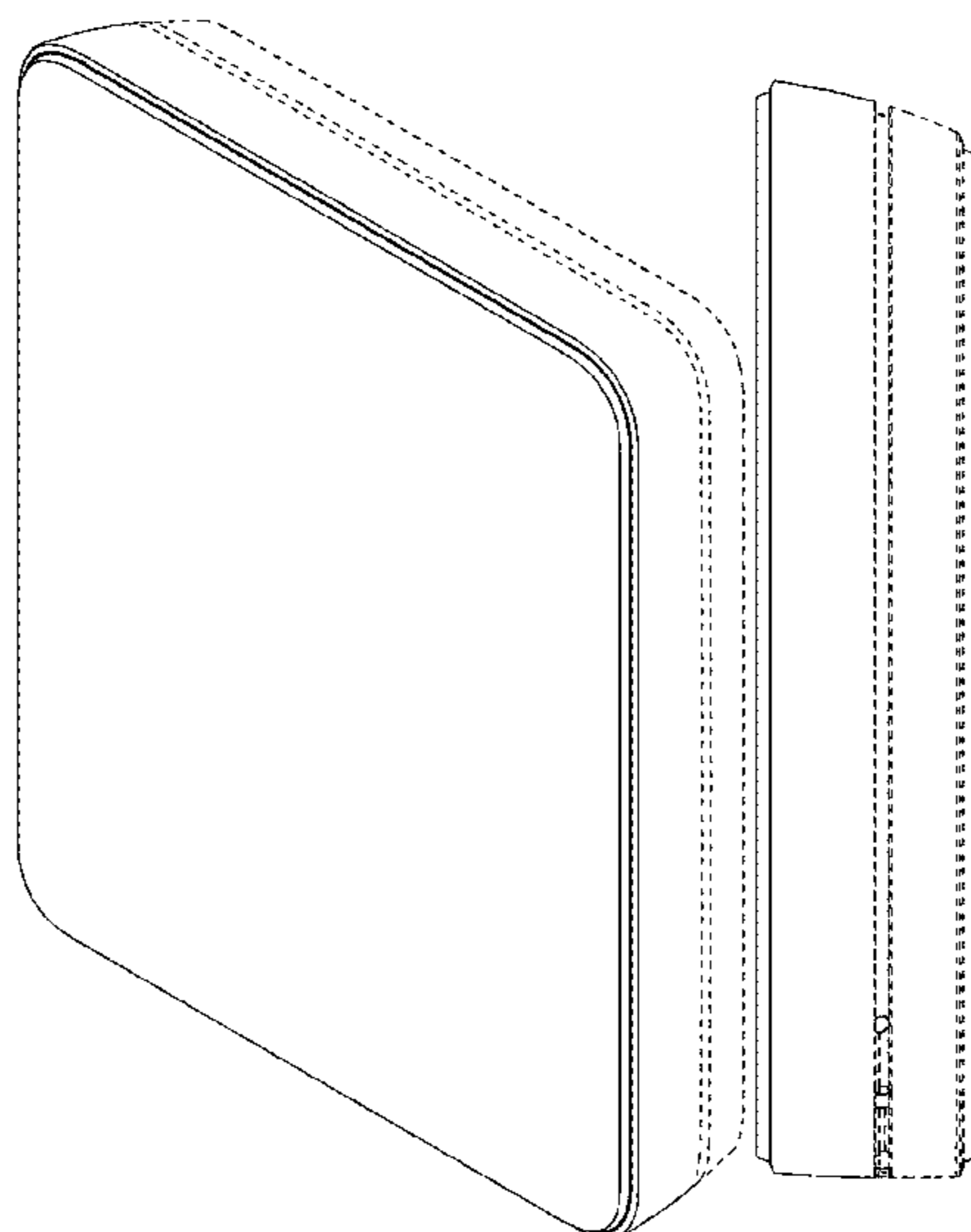
The ornamental design for a building controller, as shown and described.

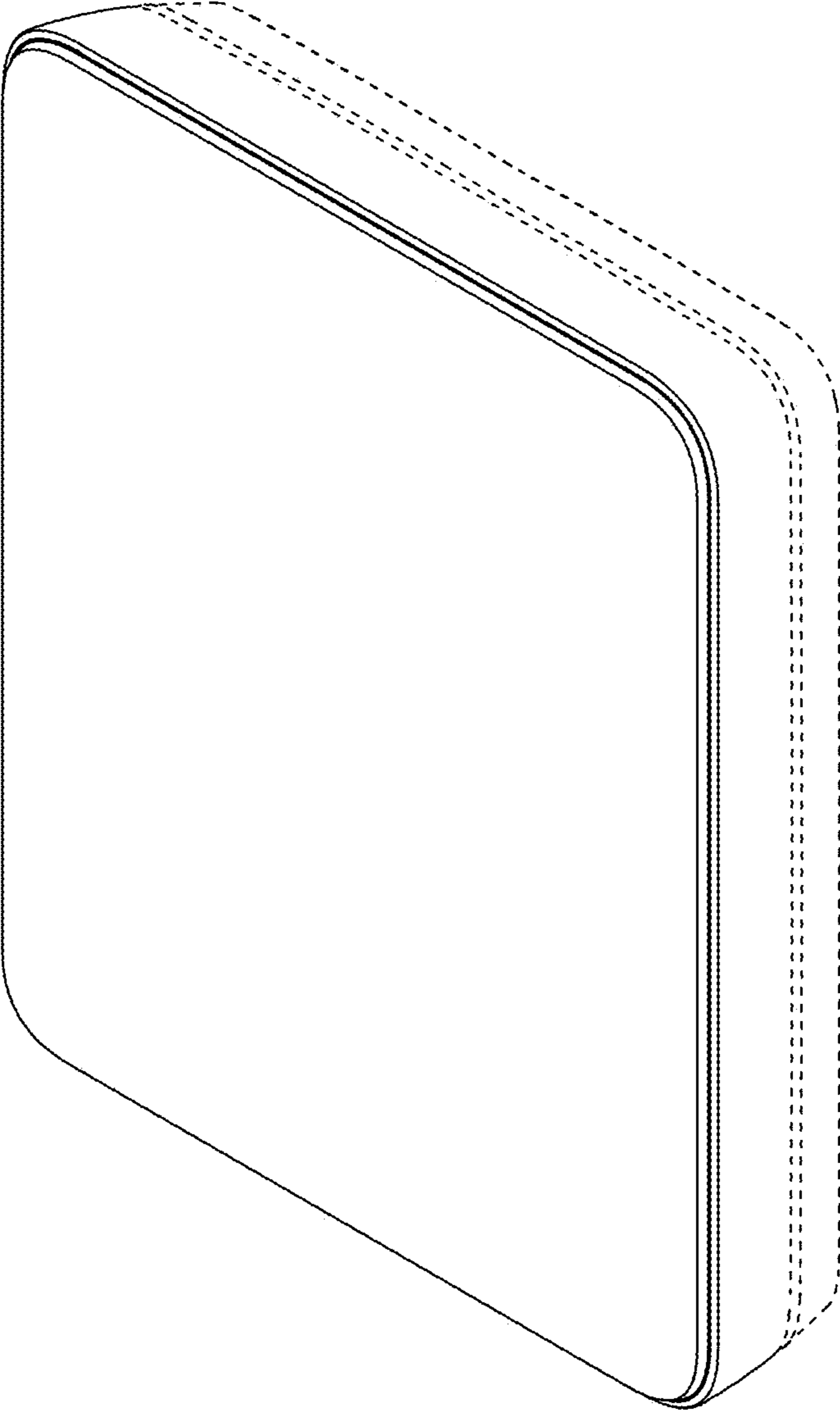

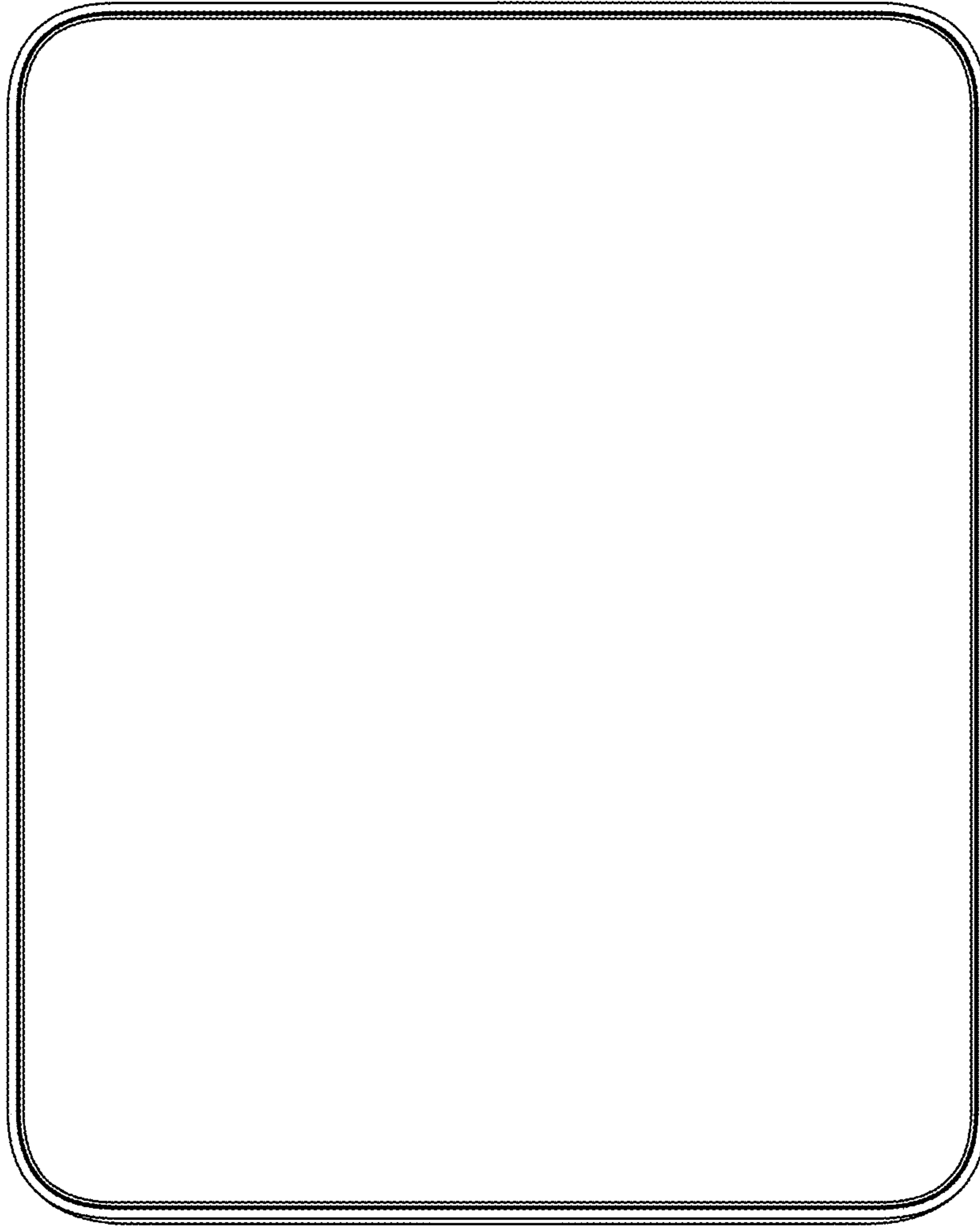

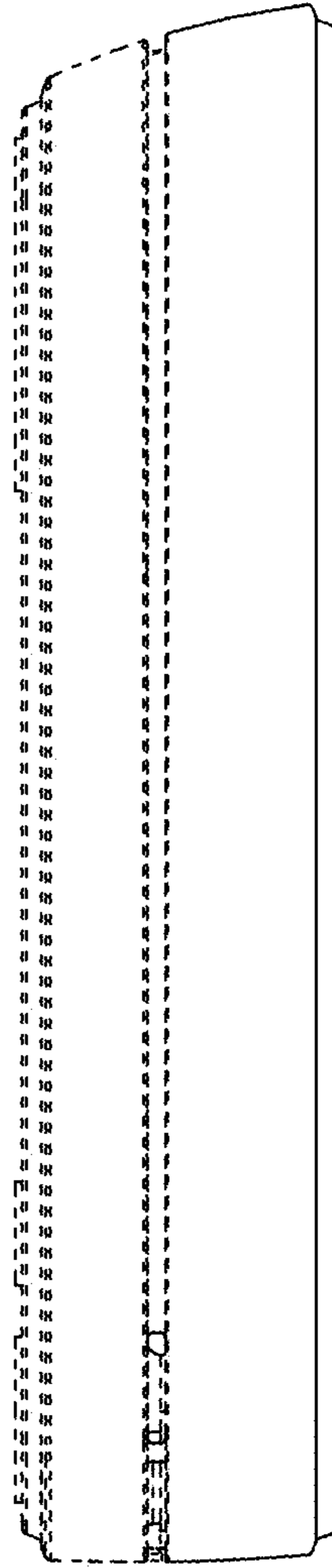

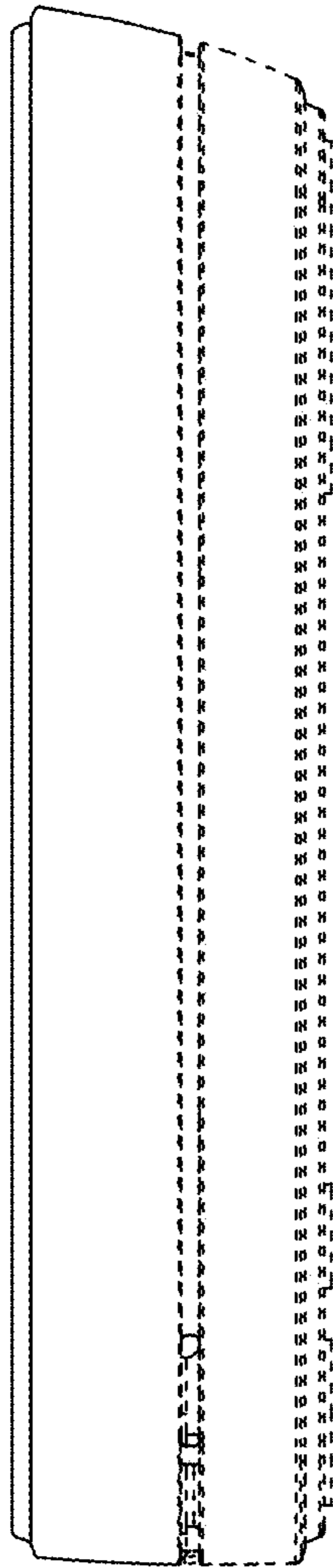

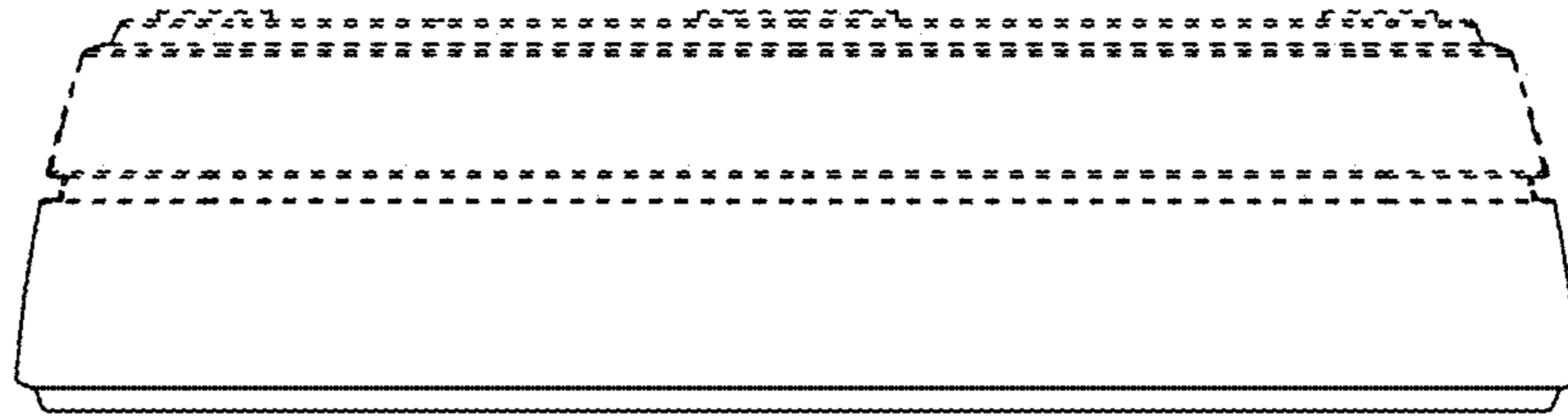

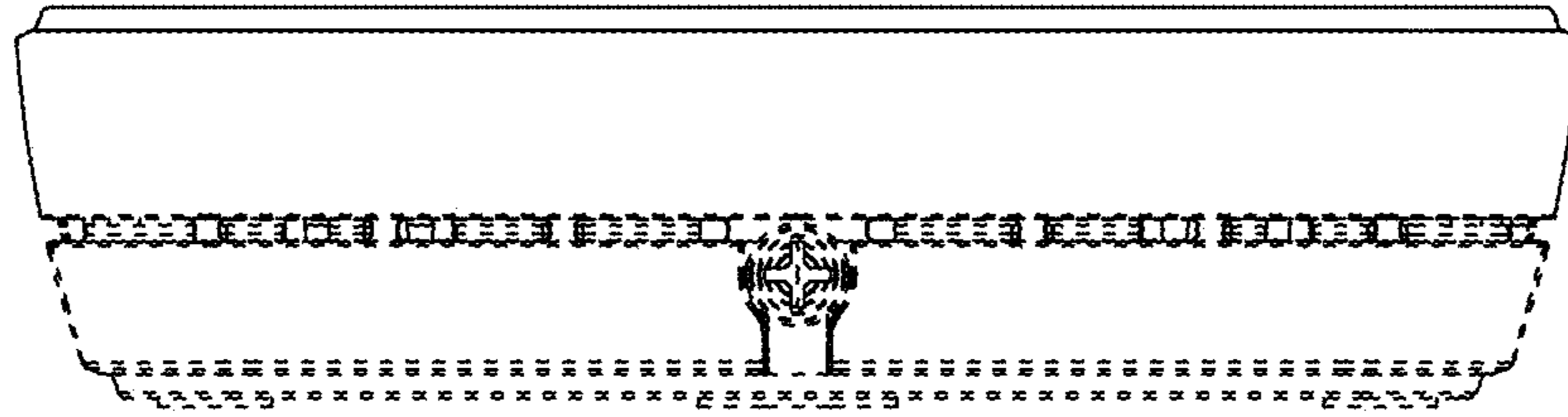
