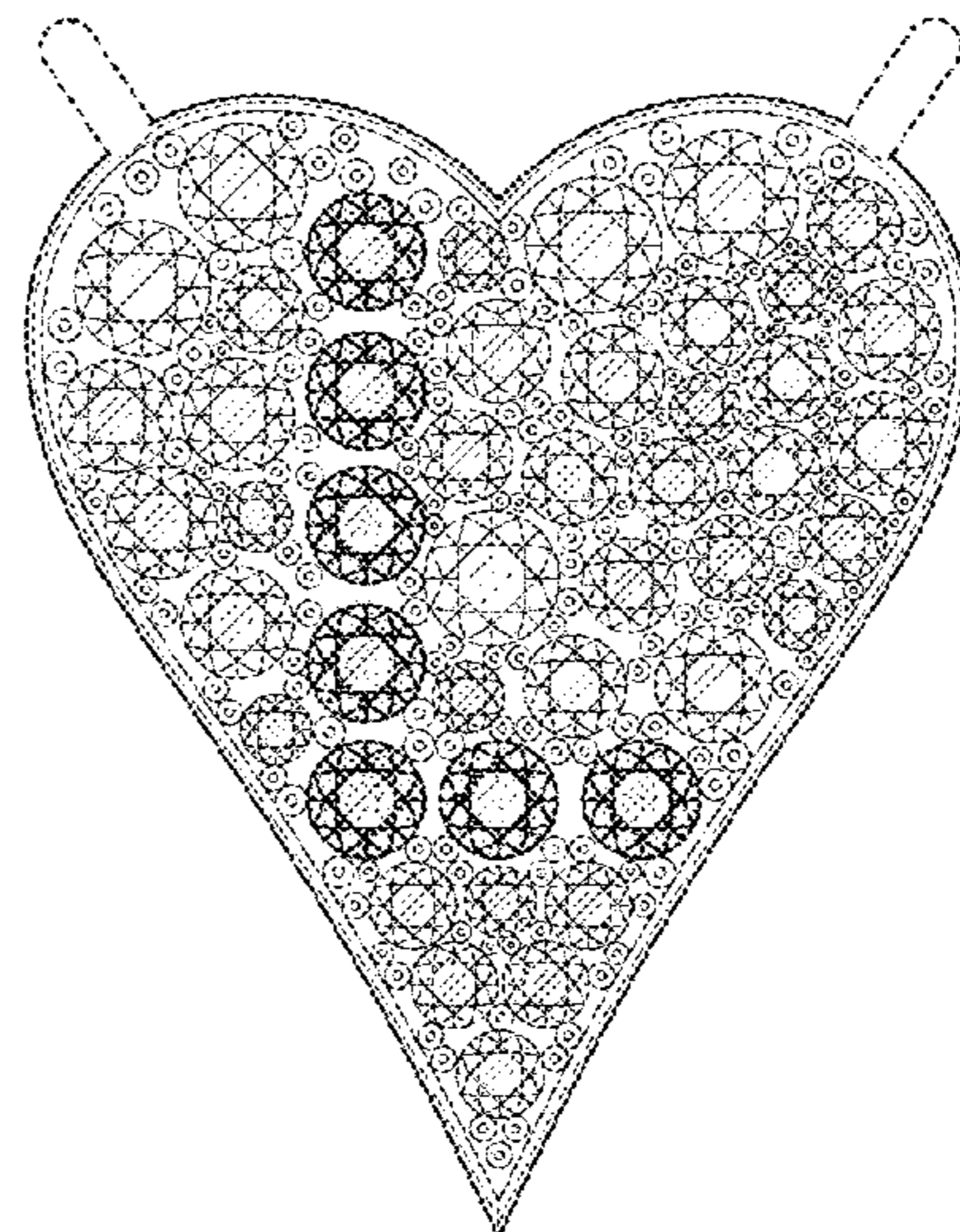
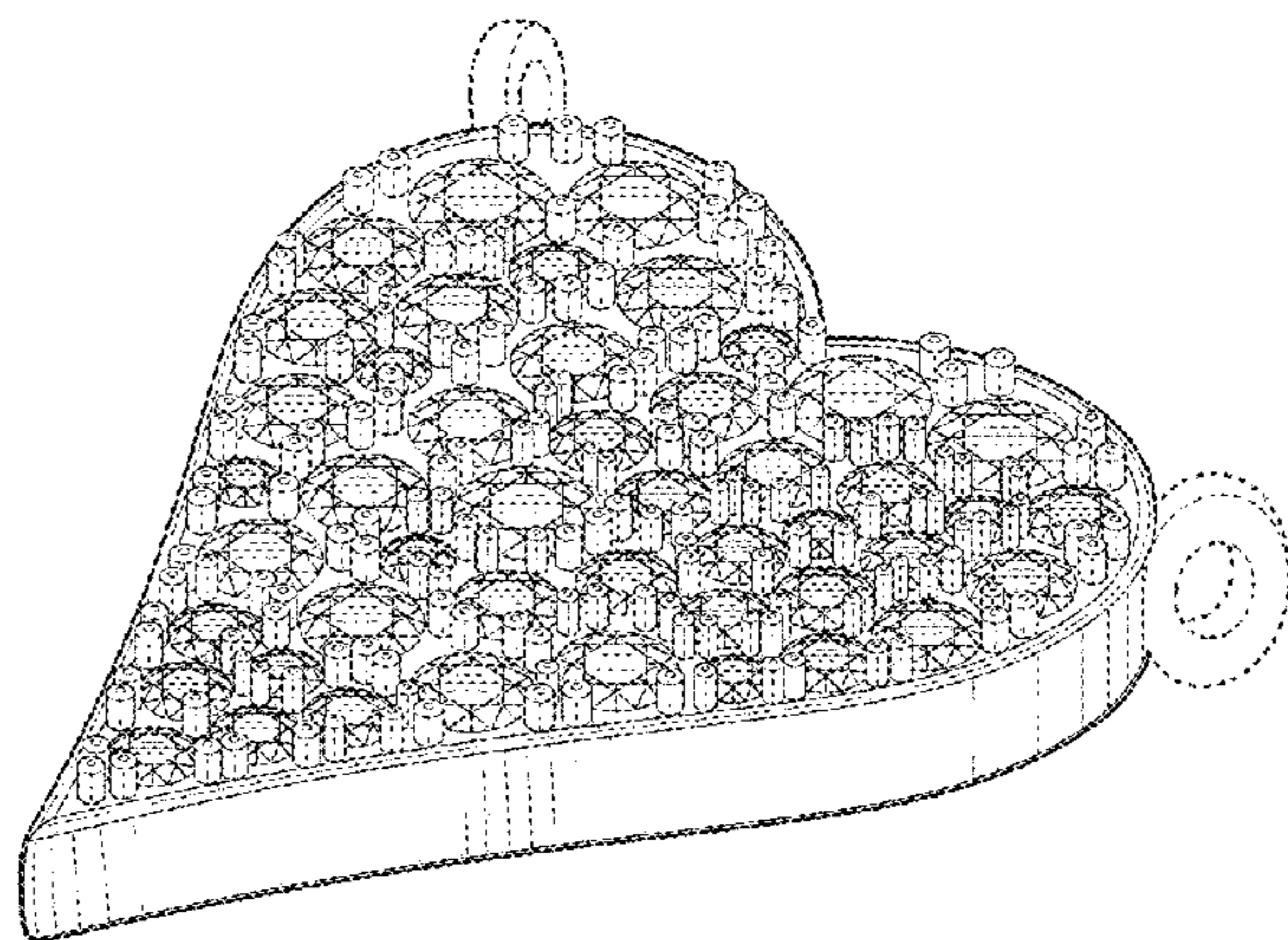
(57) **CLAIM**

The ornamental design for a pendant, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a pendant showing my new design;  
FIG. 2 is a right side view thereof;

FIG. 5 is a rear view thereof;  
FIG. 6 is a top view thereof;

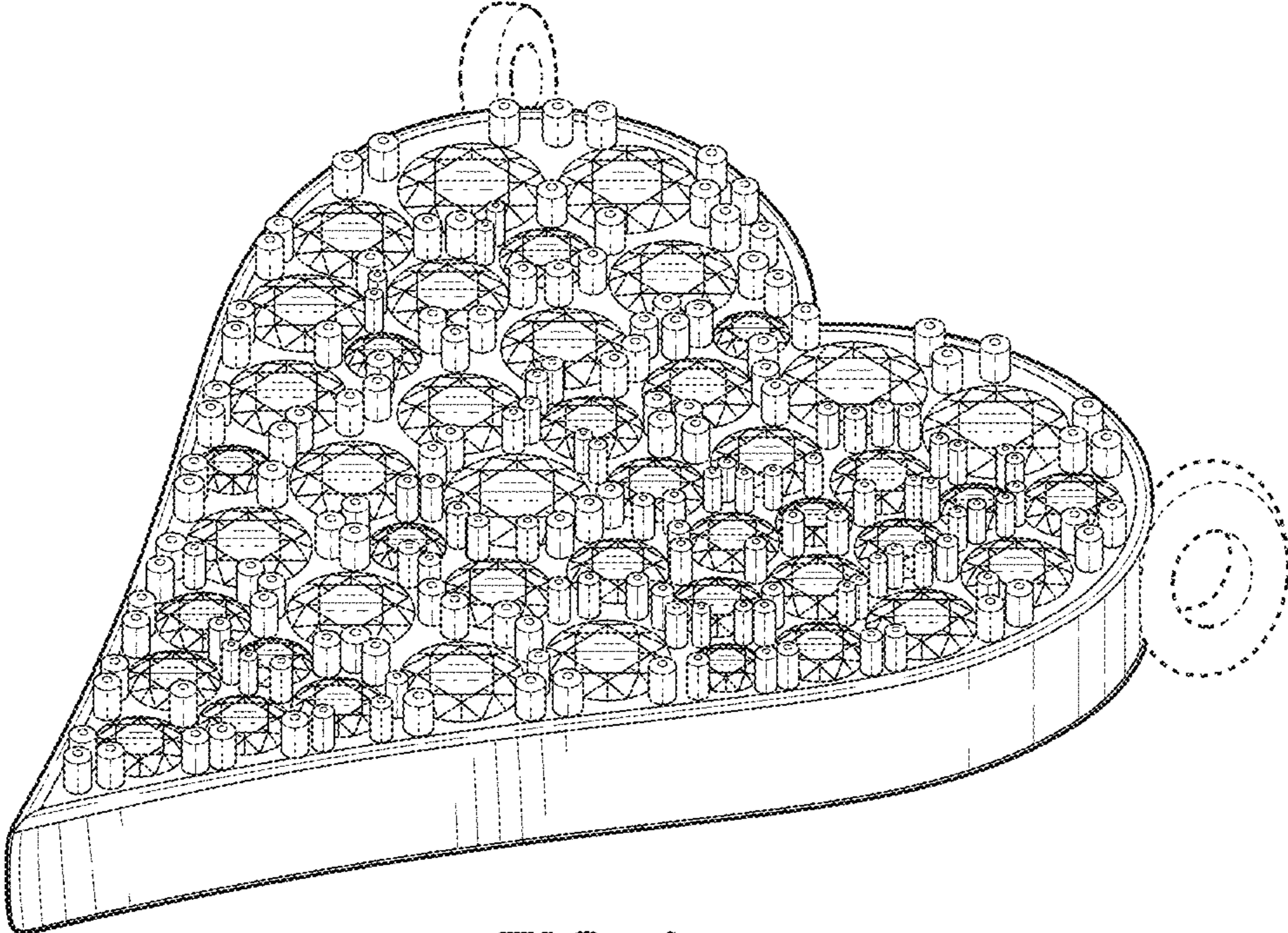
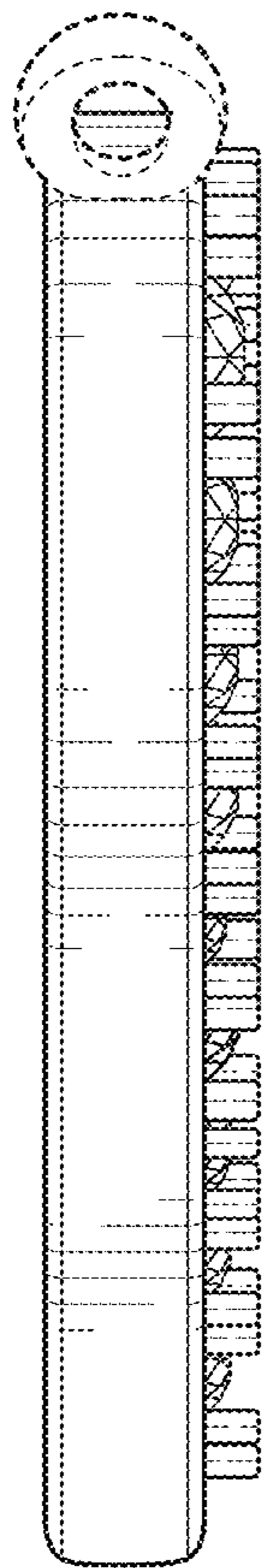
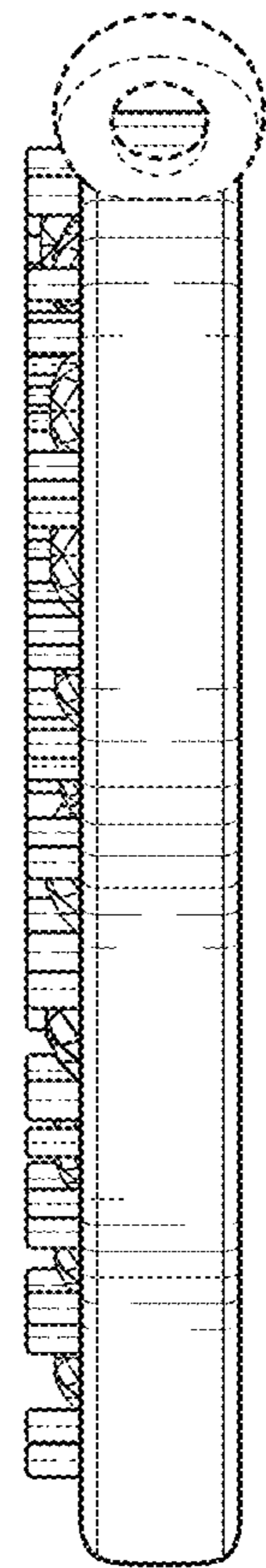

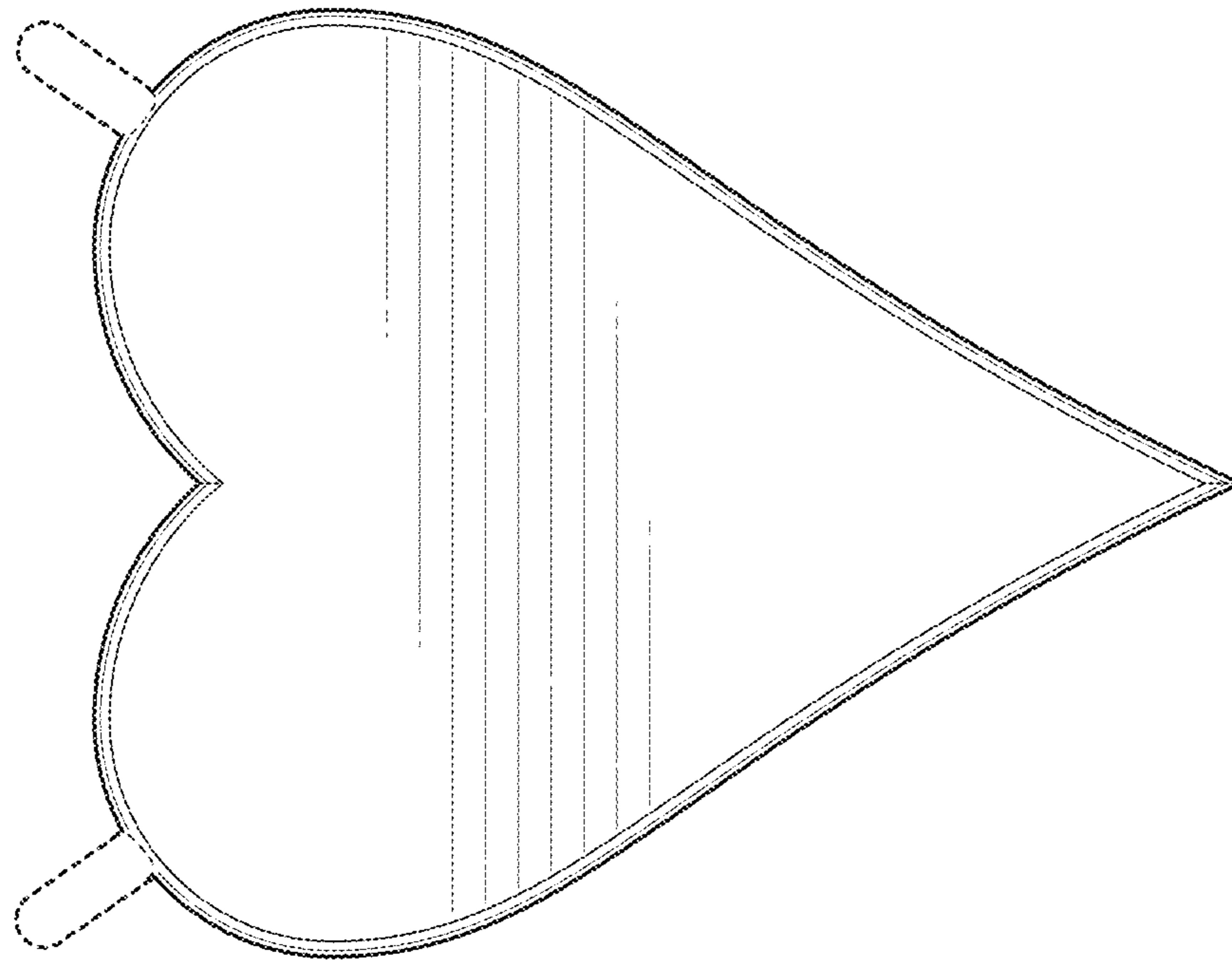

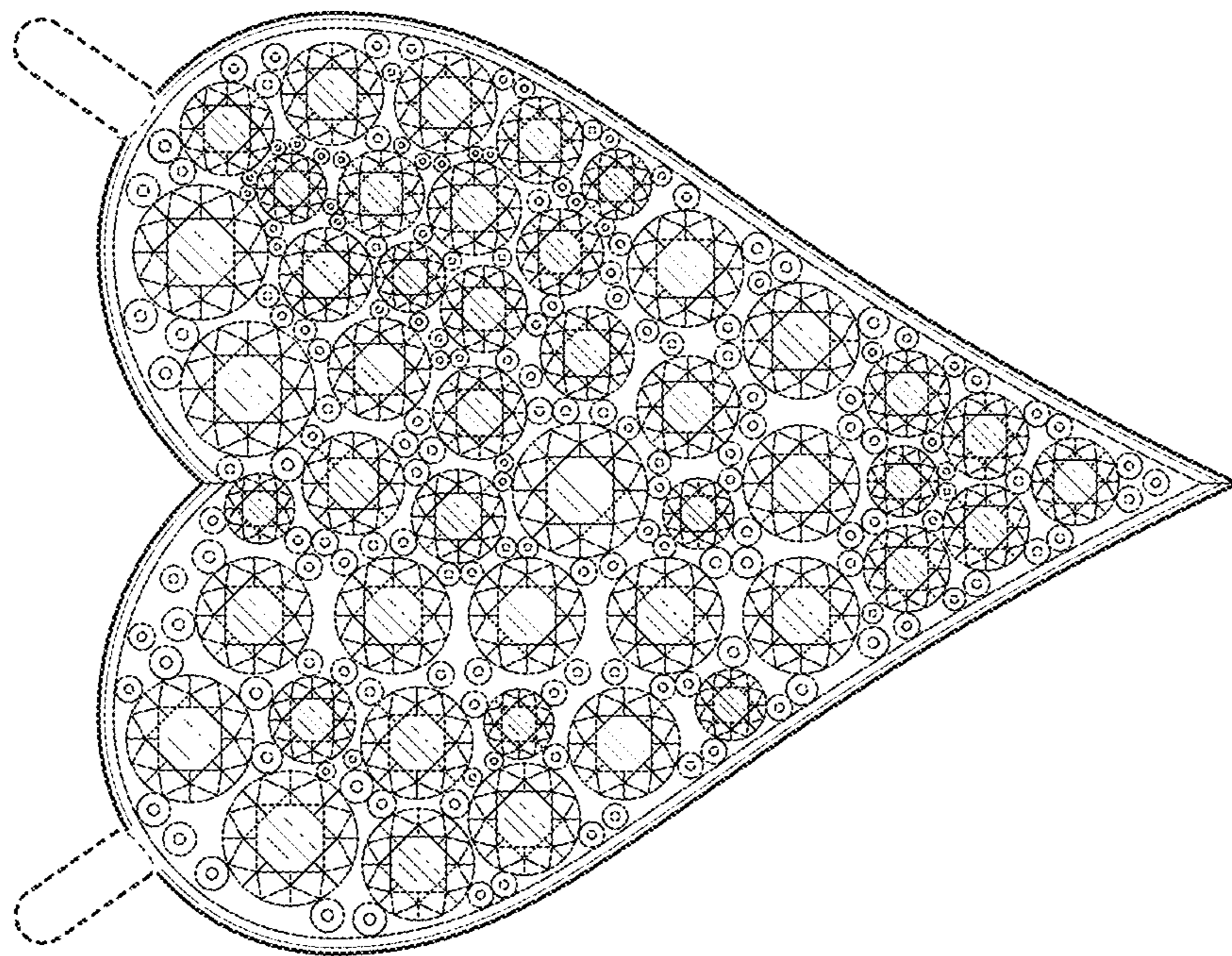
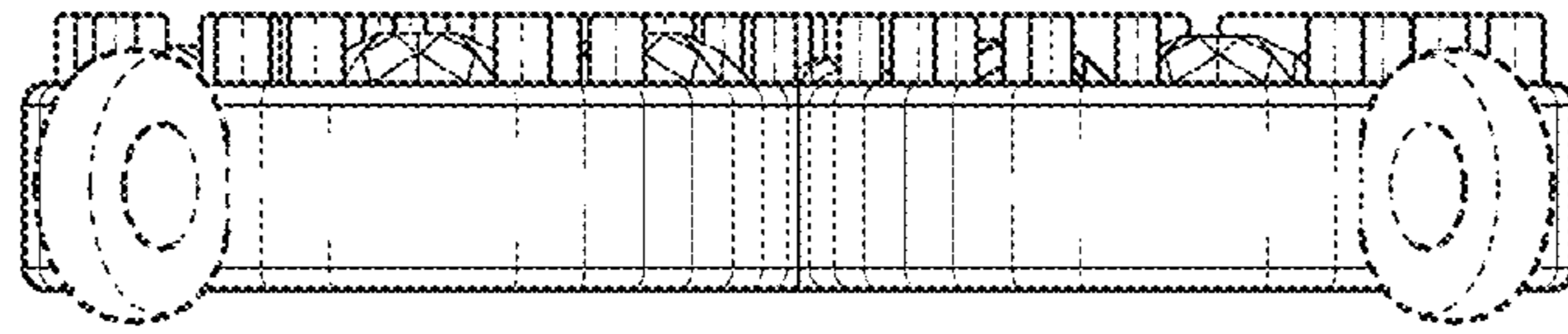
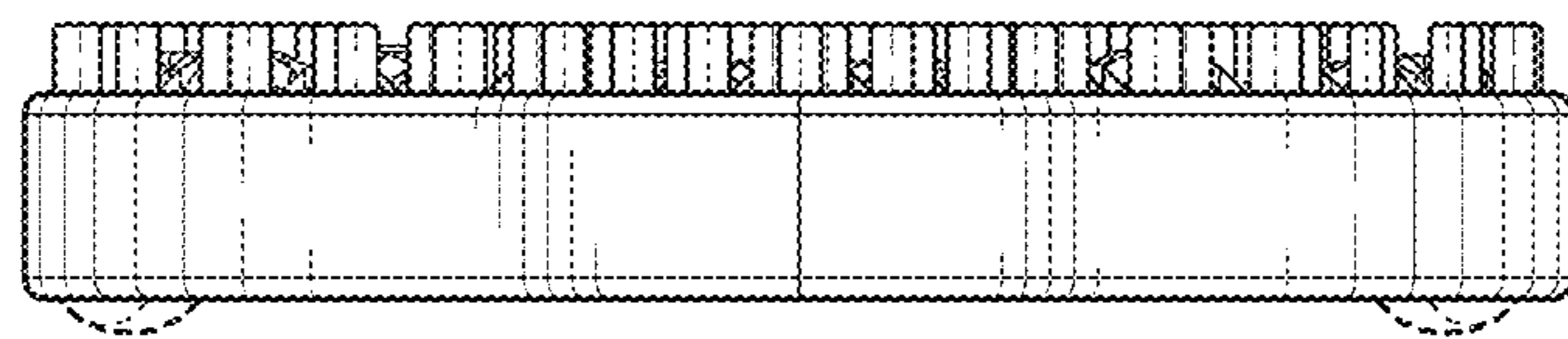

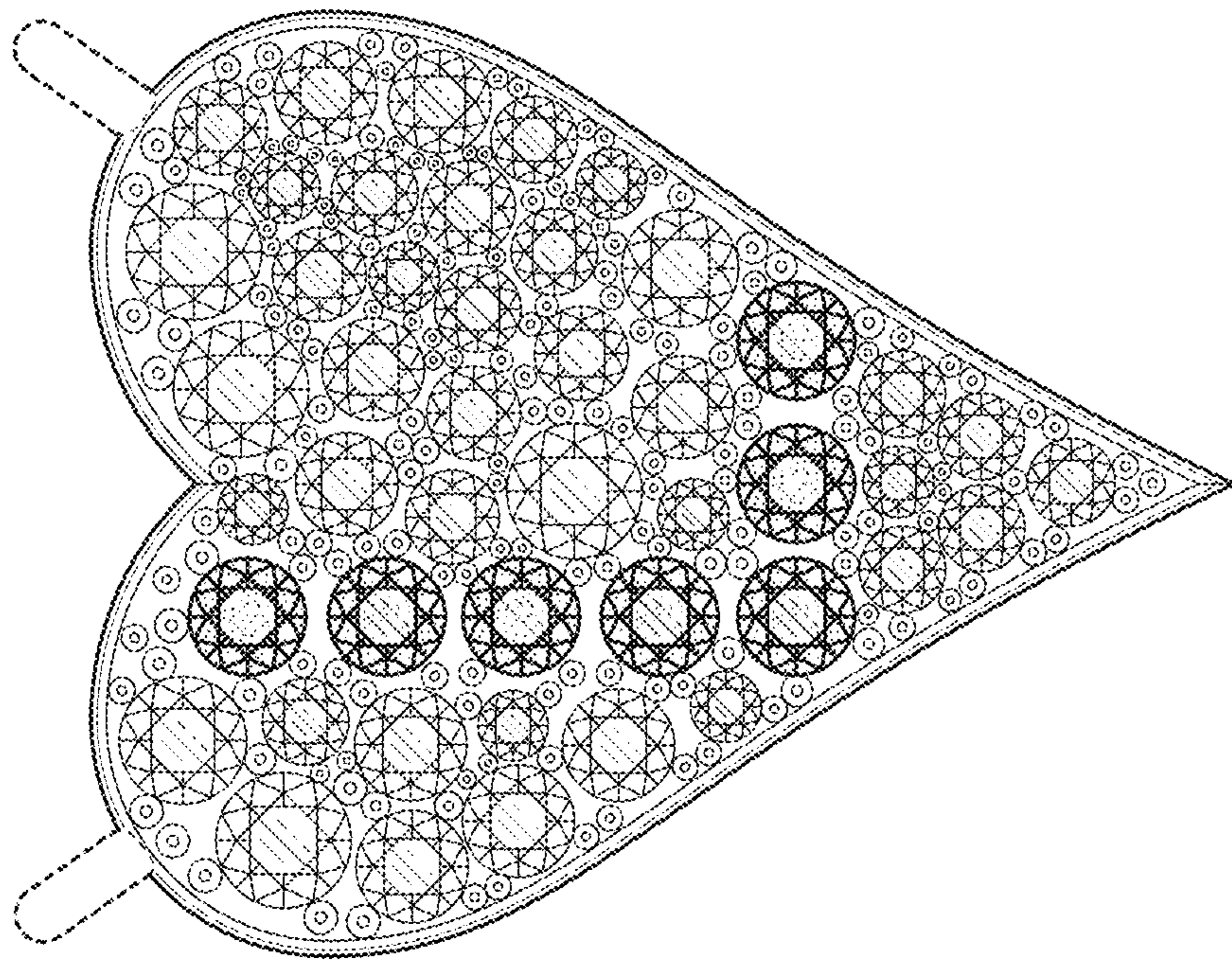
