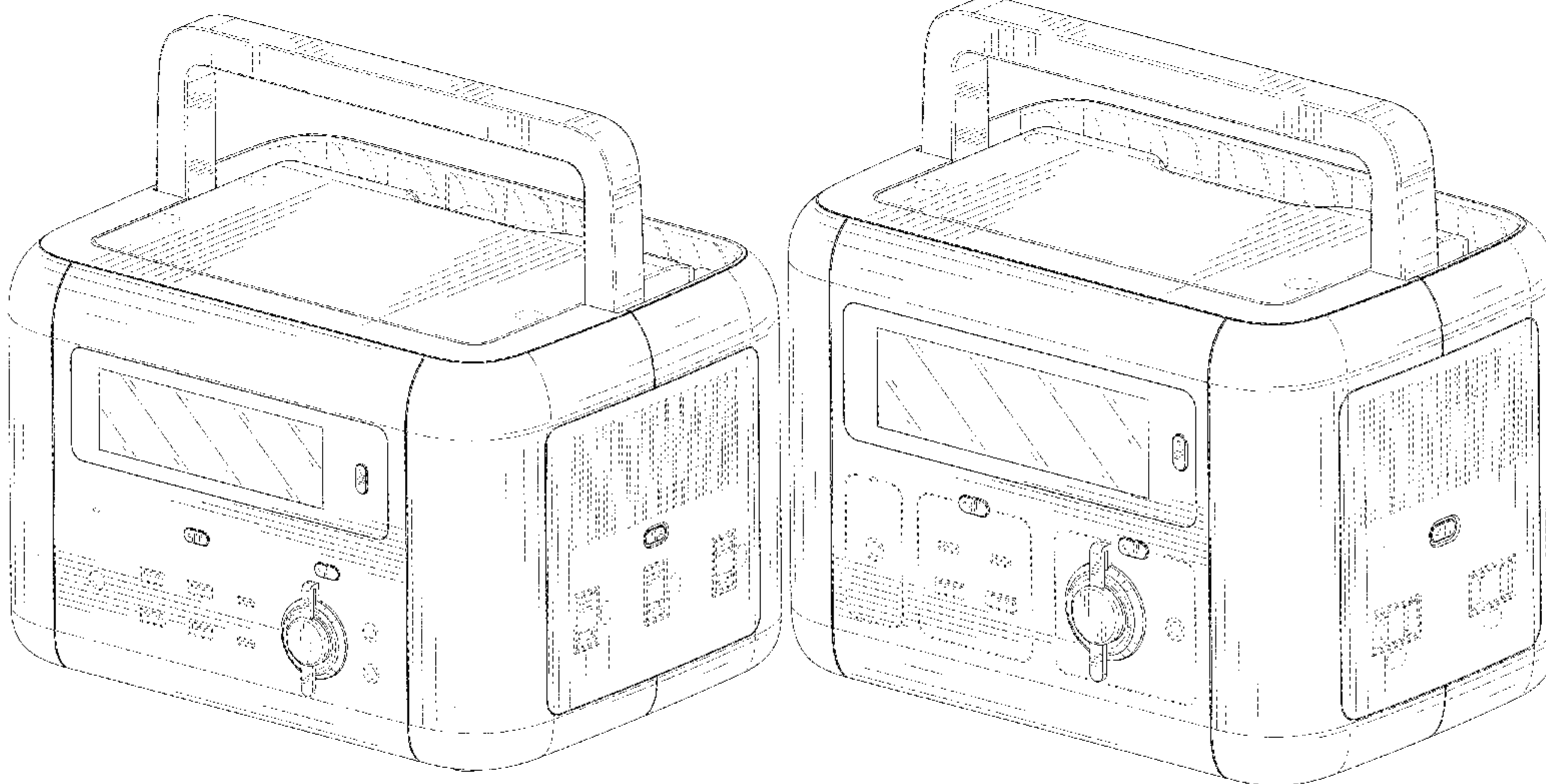
(57) **CLAIM**

The ornamental design for a portable power station, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a portable power station showing my new design; FIG. 2 is another perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a perspective view of the portable power station where the portable power station is in a configuration of use; FIG. 10 is a perspective view of a second embodiment of the portable power station; FIG. 11 is another perspective view thereof; FIG. 12 is a front elevational view thereof; FIG. 13 is a rear elevational view thereof; FIG. 14 is a left side elevational view thereof; FIG. 15 is a right side elevational view thereof; FIG. 16 is a top plan view thereof; FIG. 17 is a bottom plan view thereof; and, FIG. 18 is a perspective view of the portable power station where the portable power station is in a configuration of use. 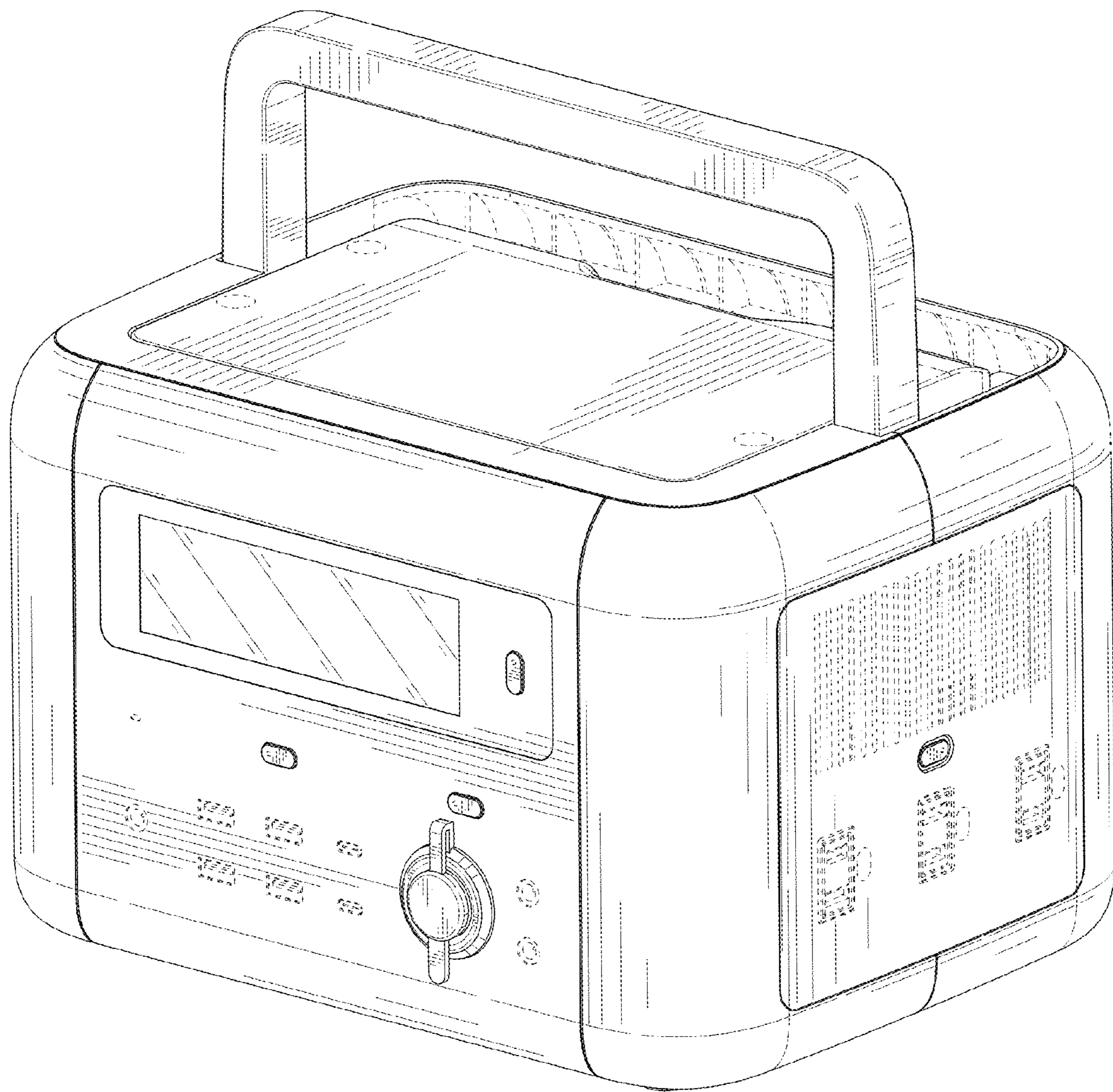

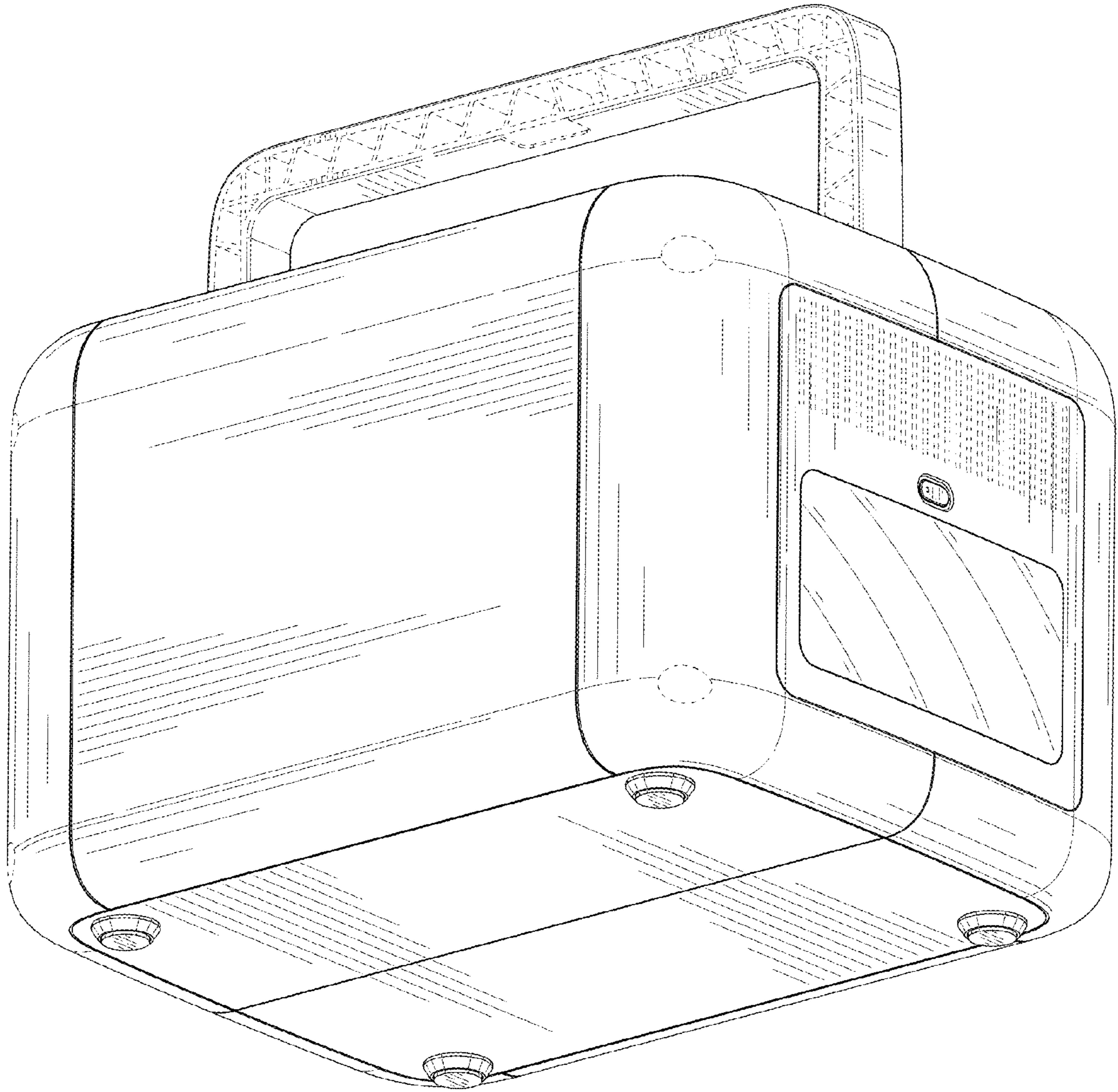

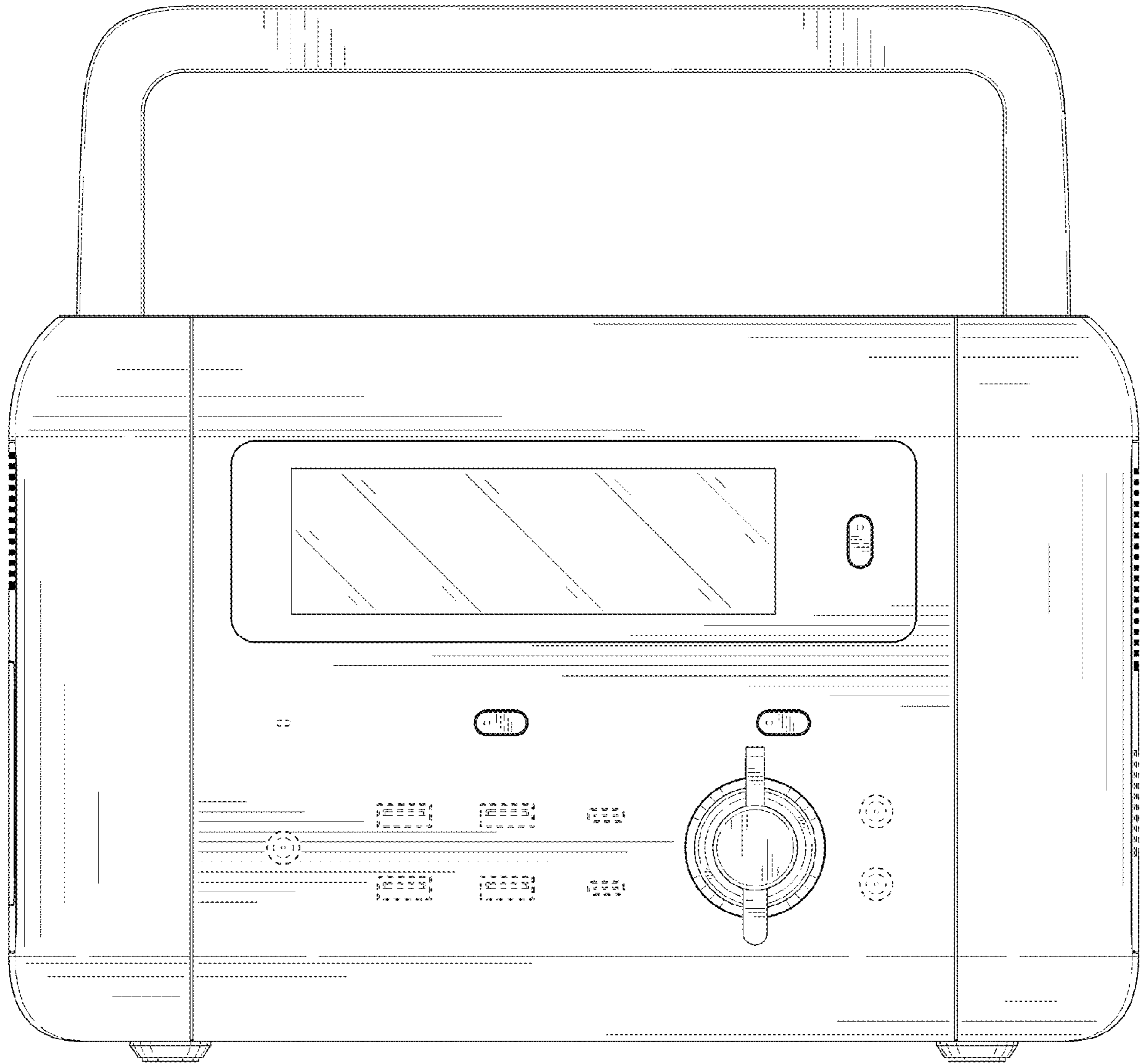

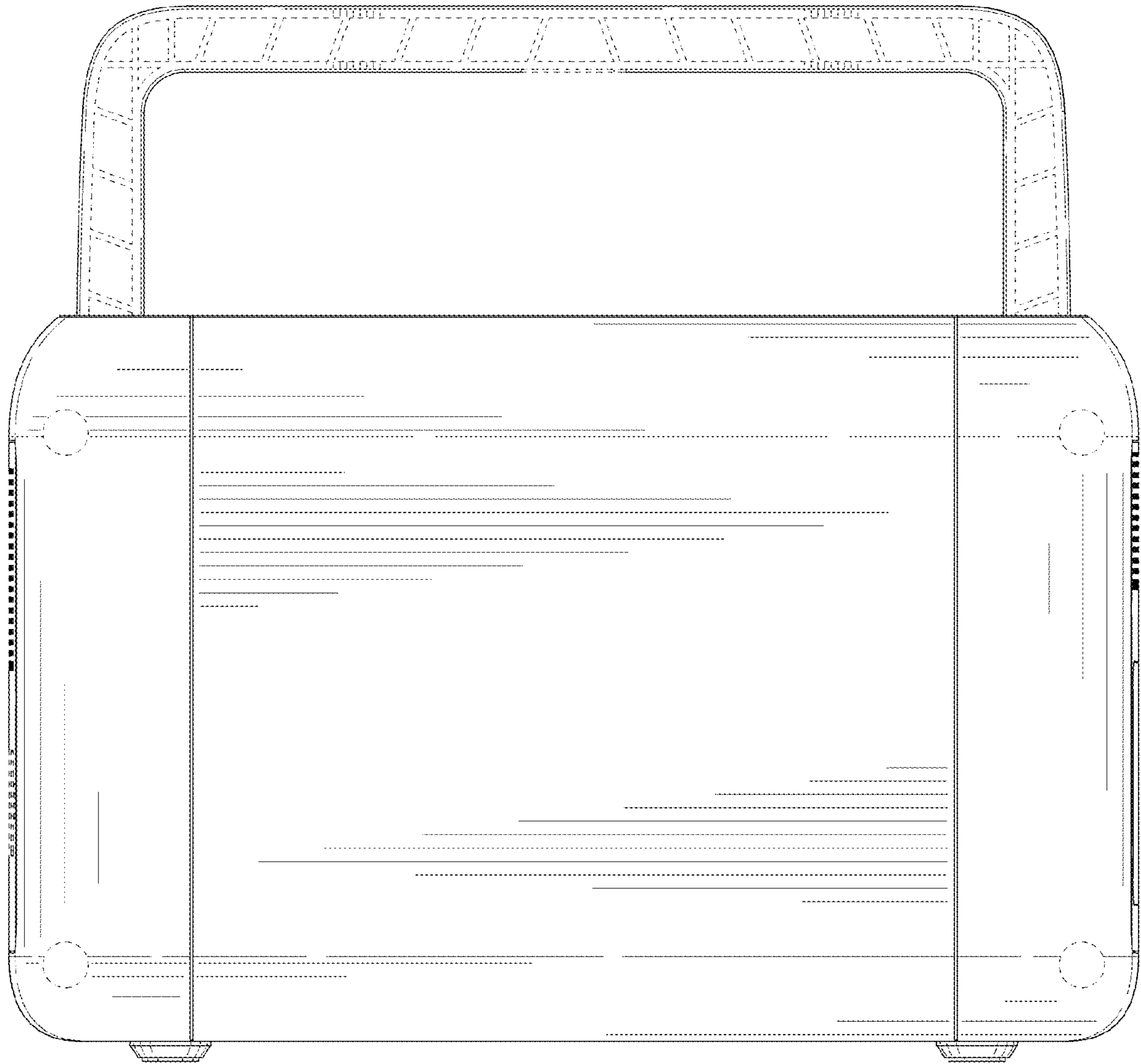

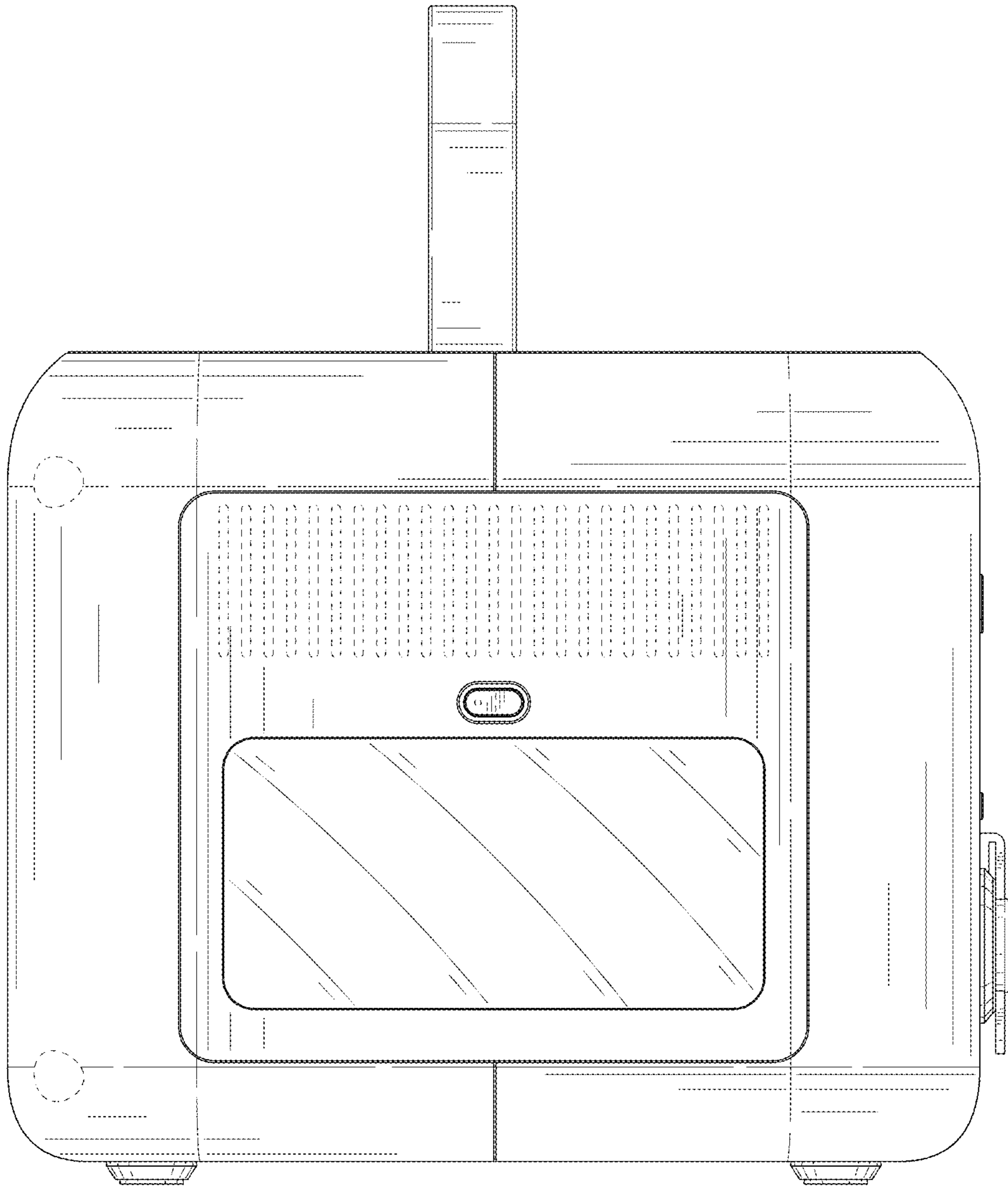

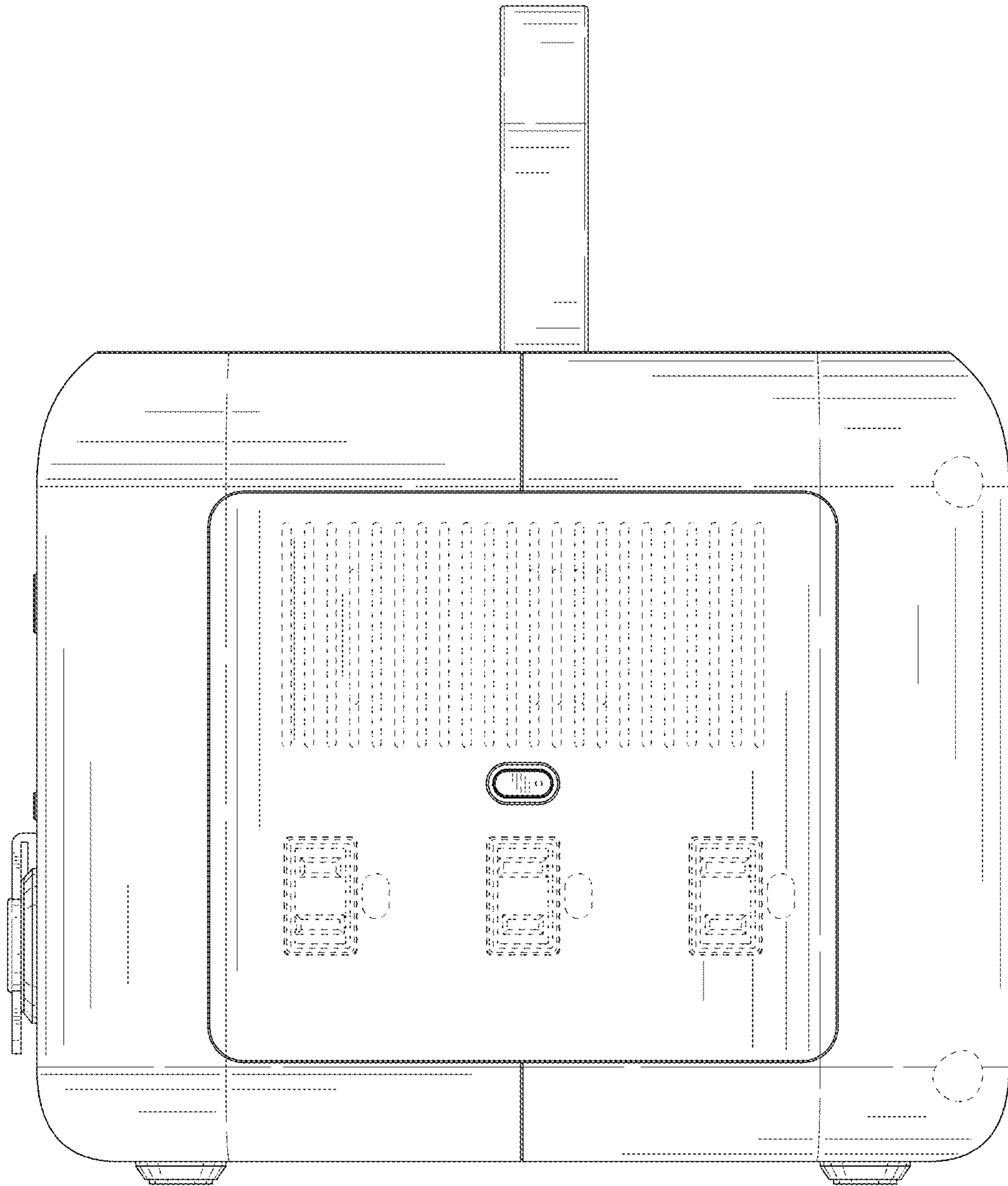

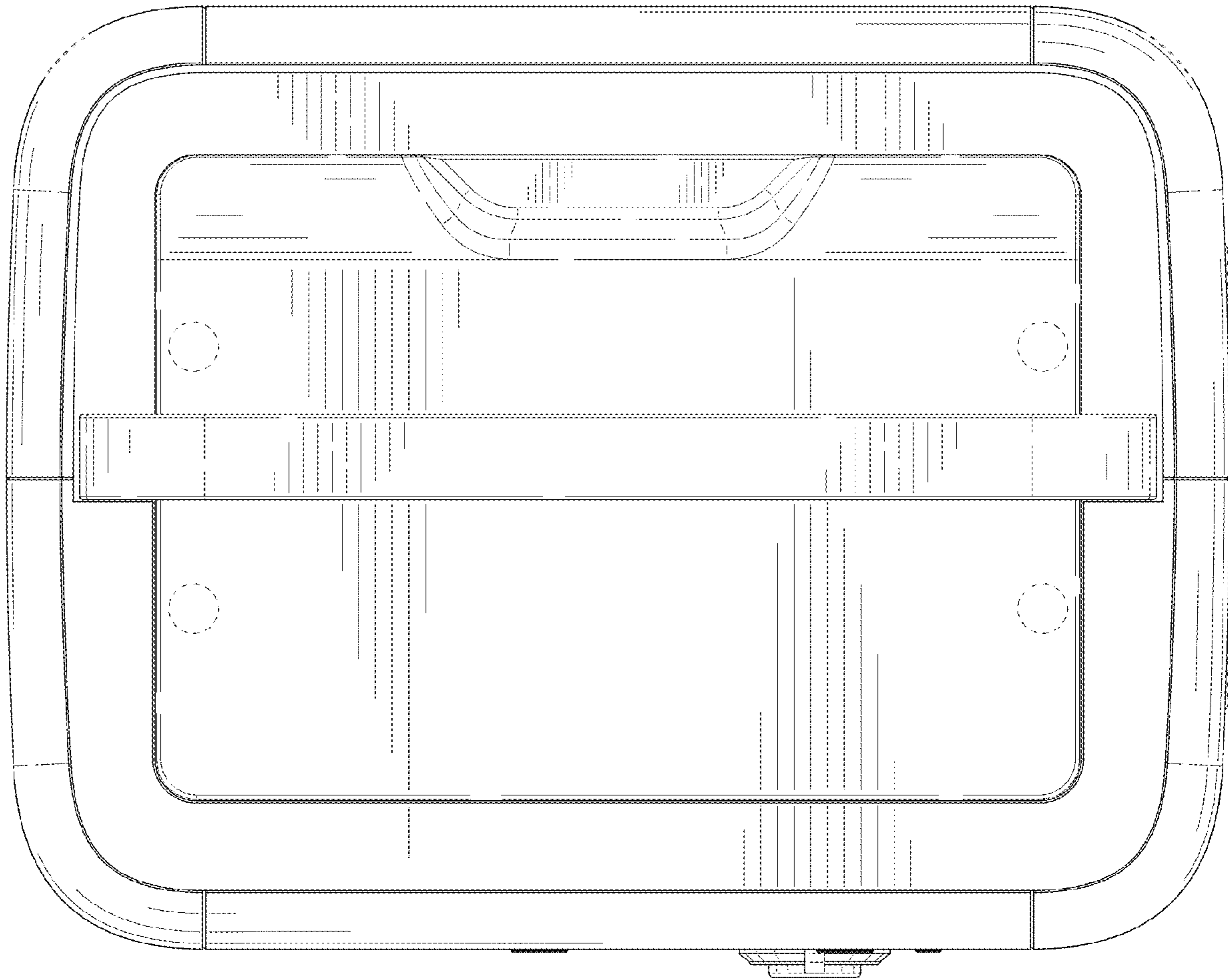

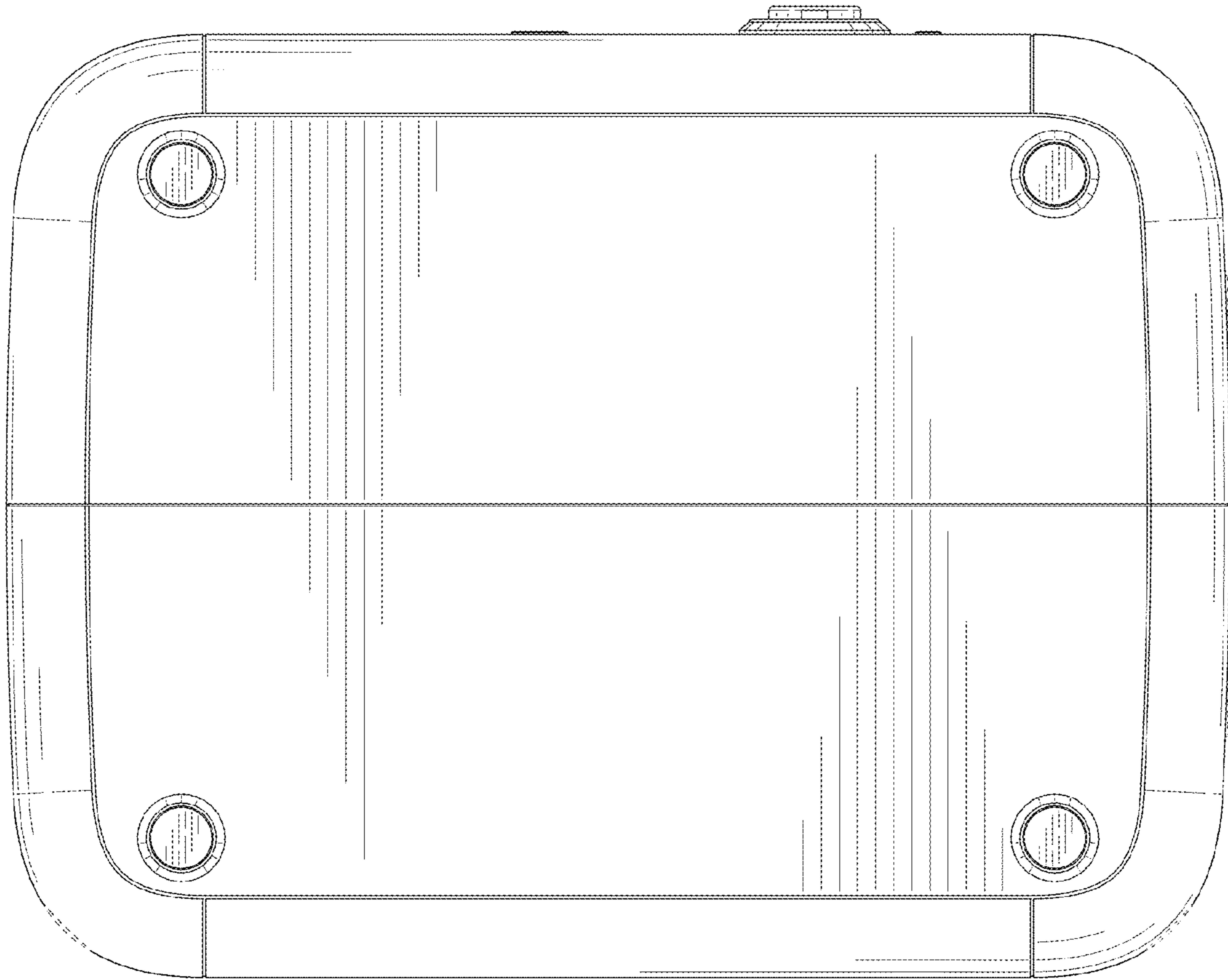

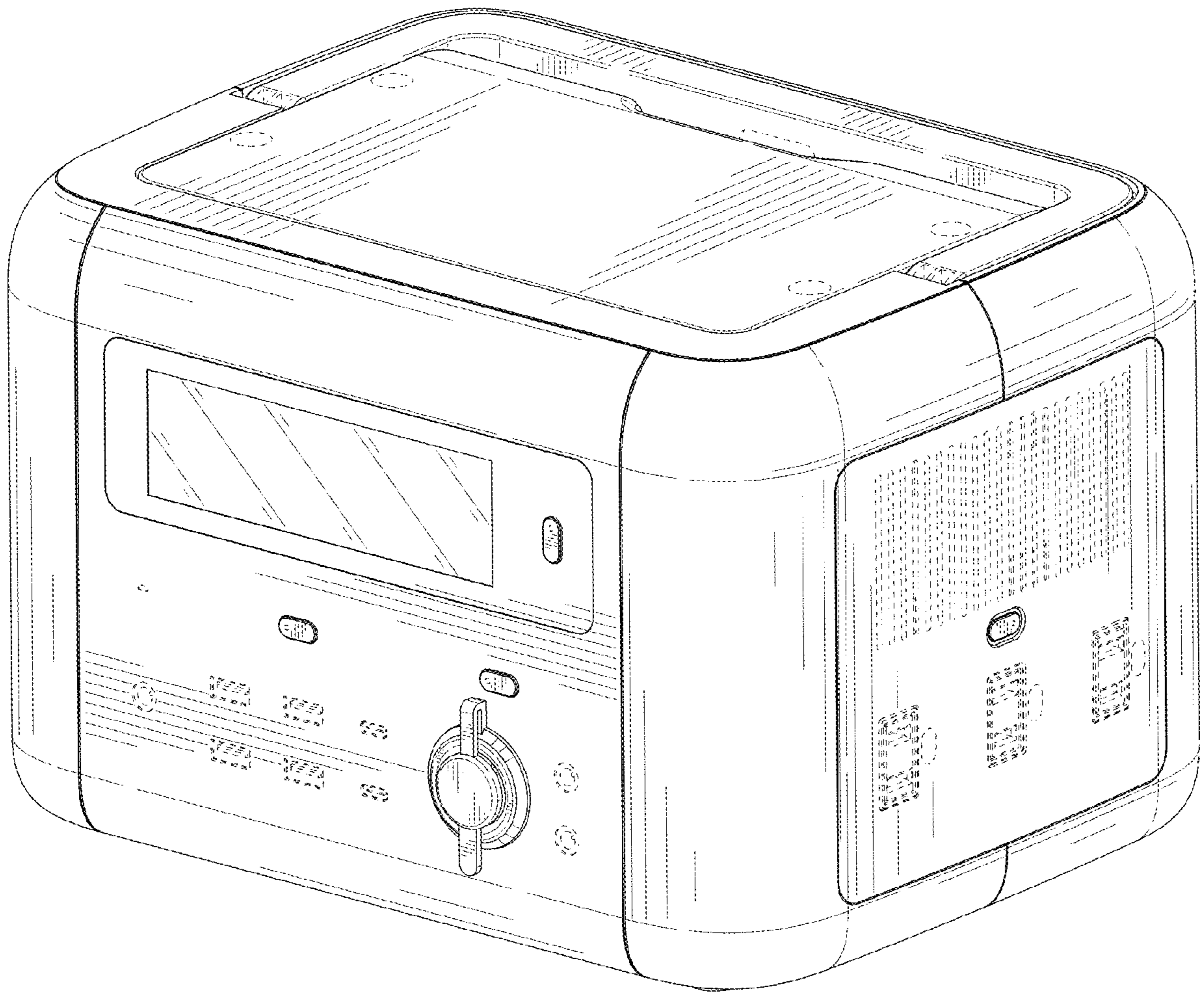

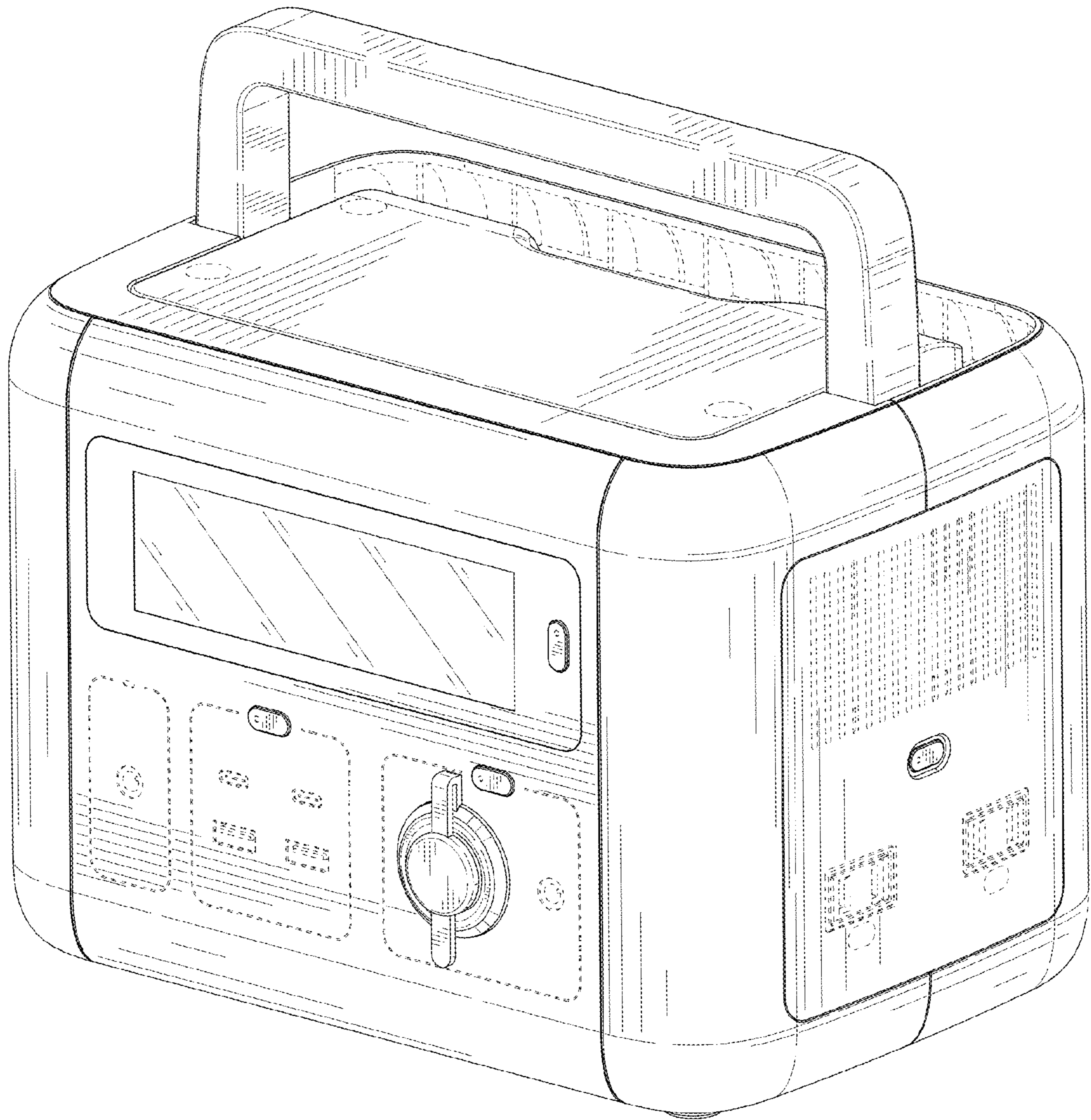

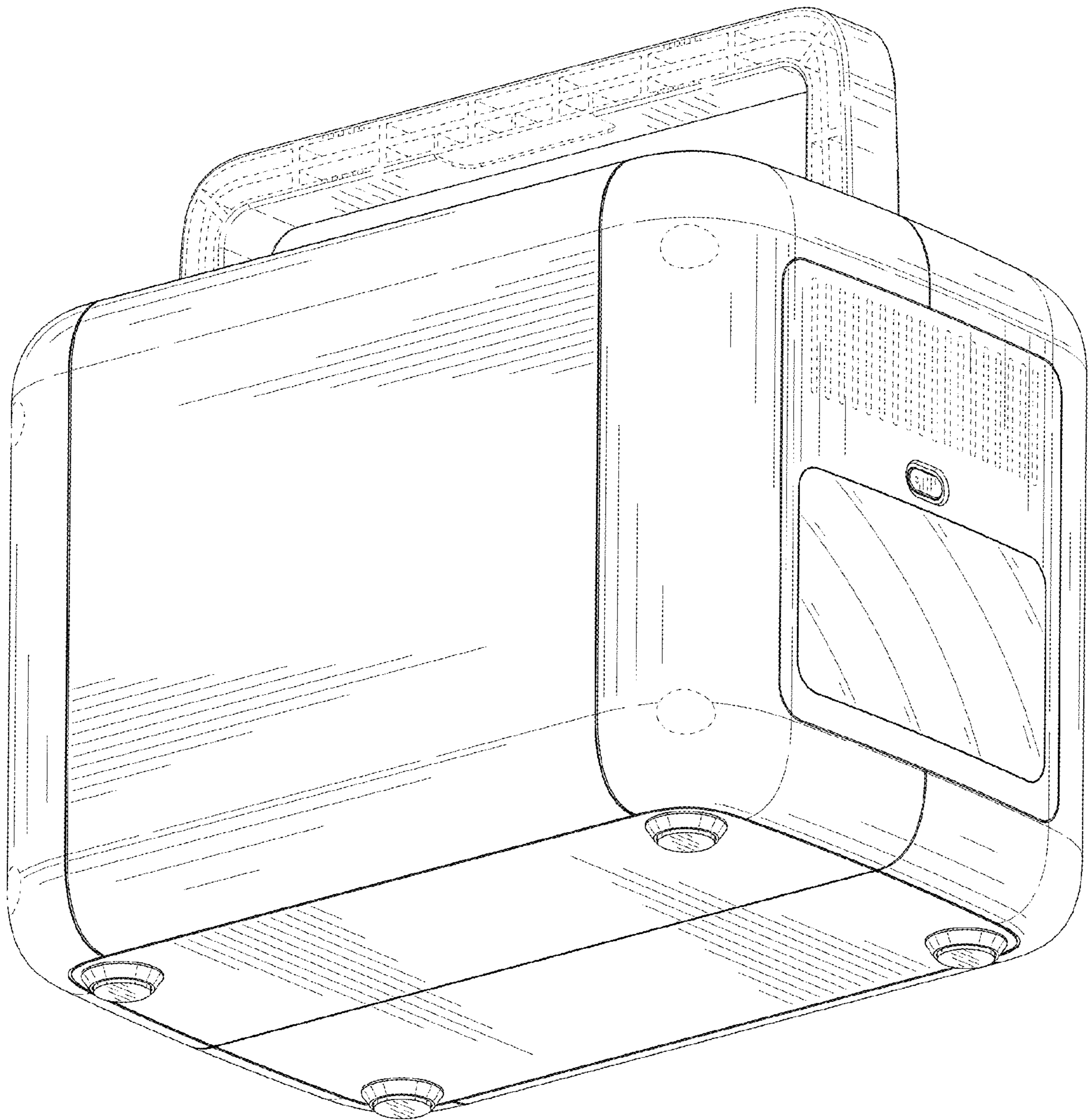

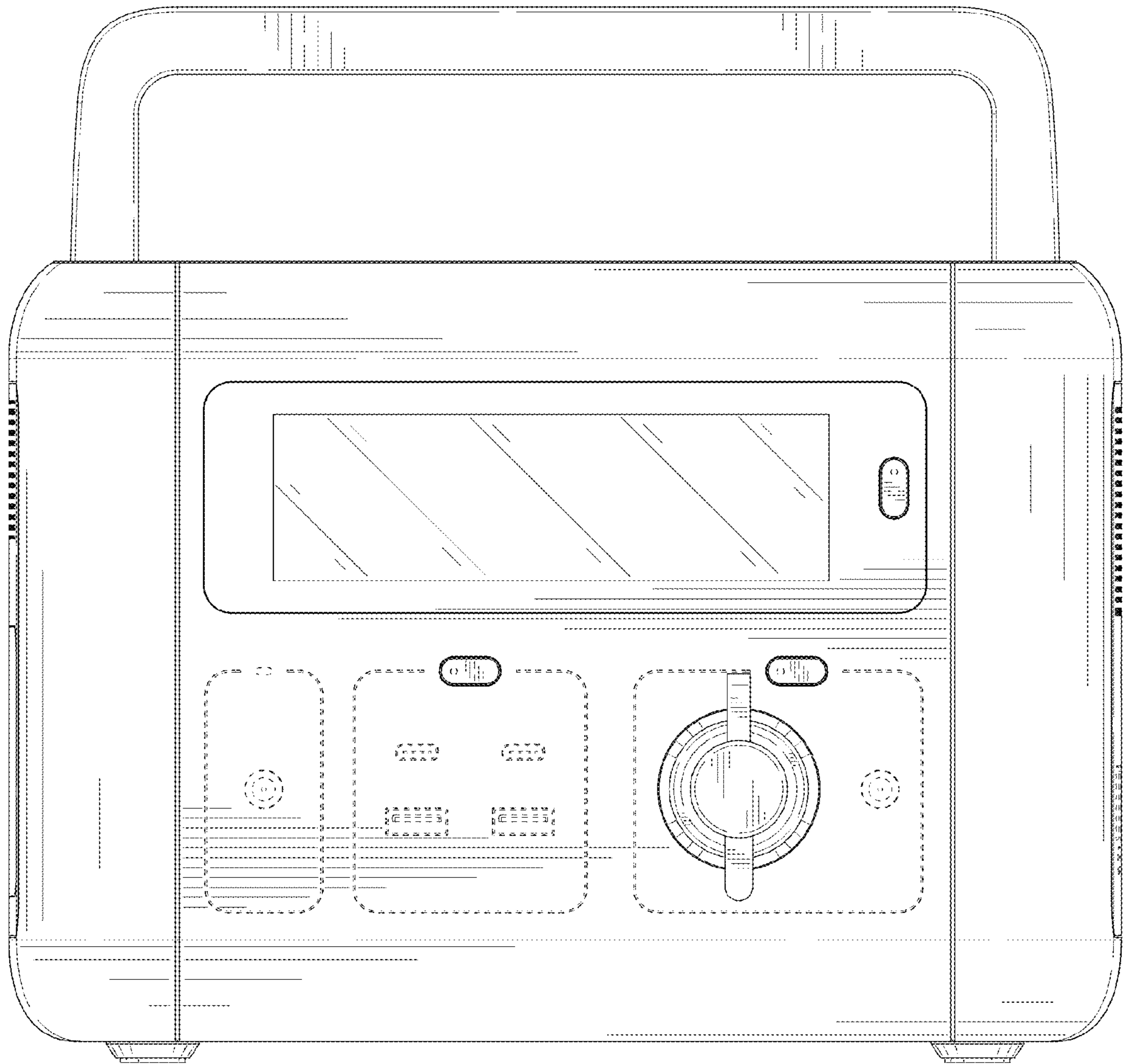

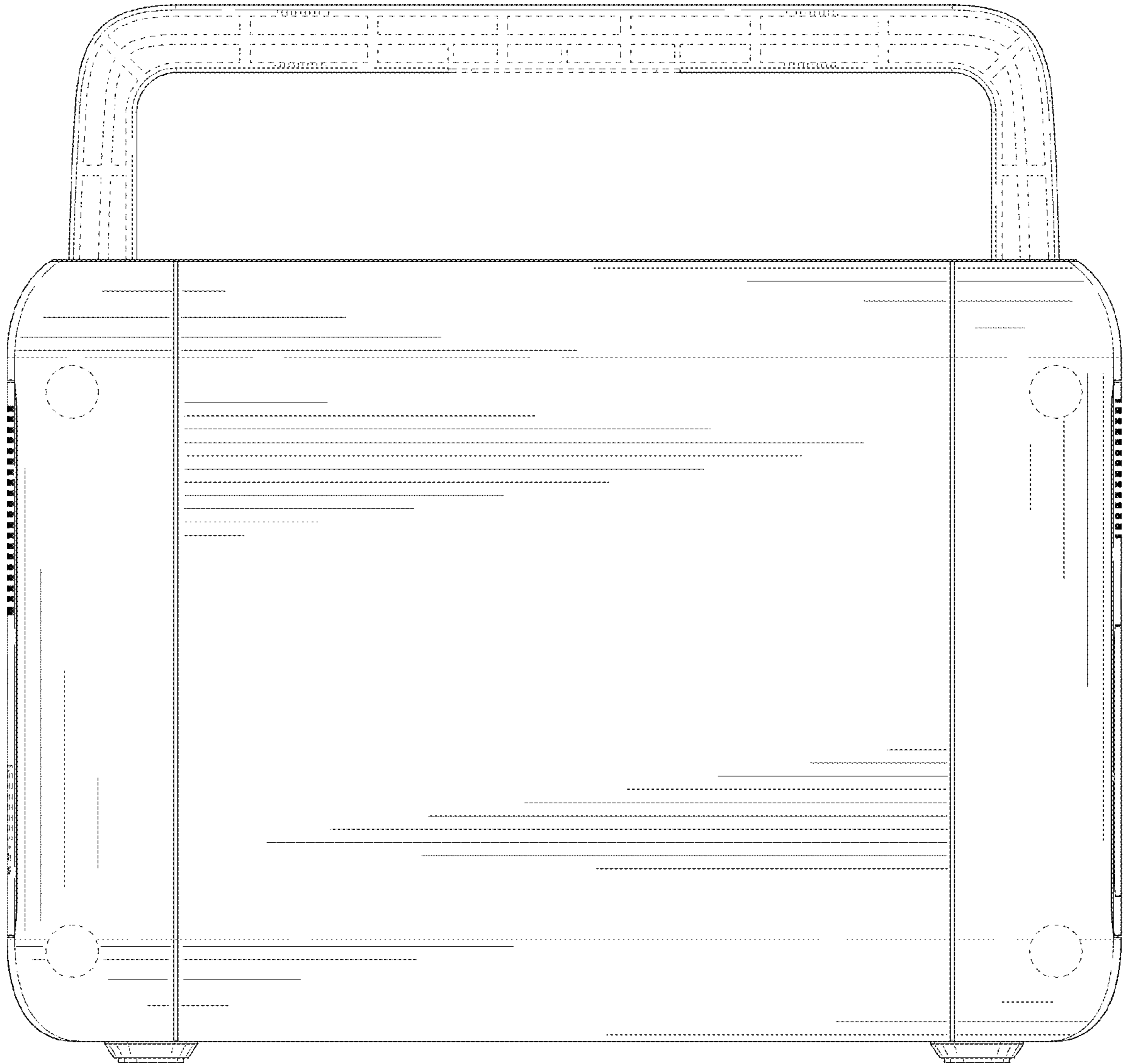

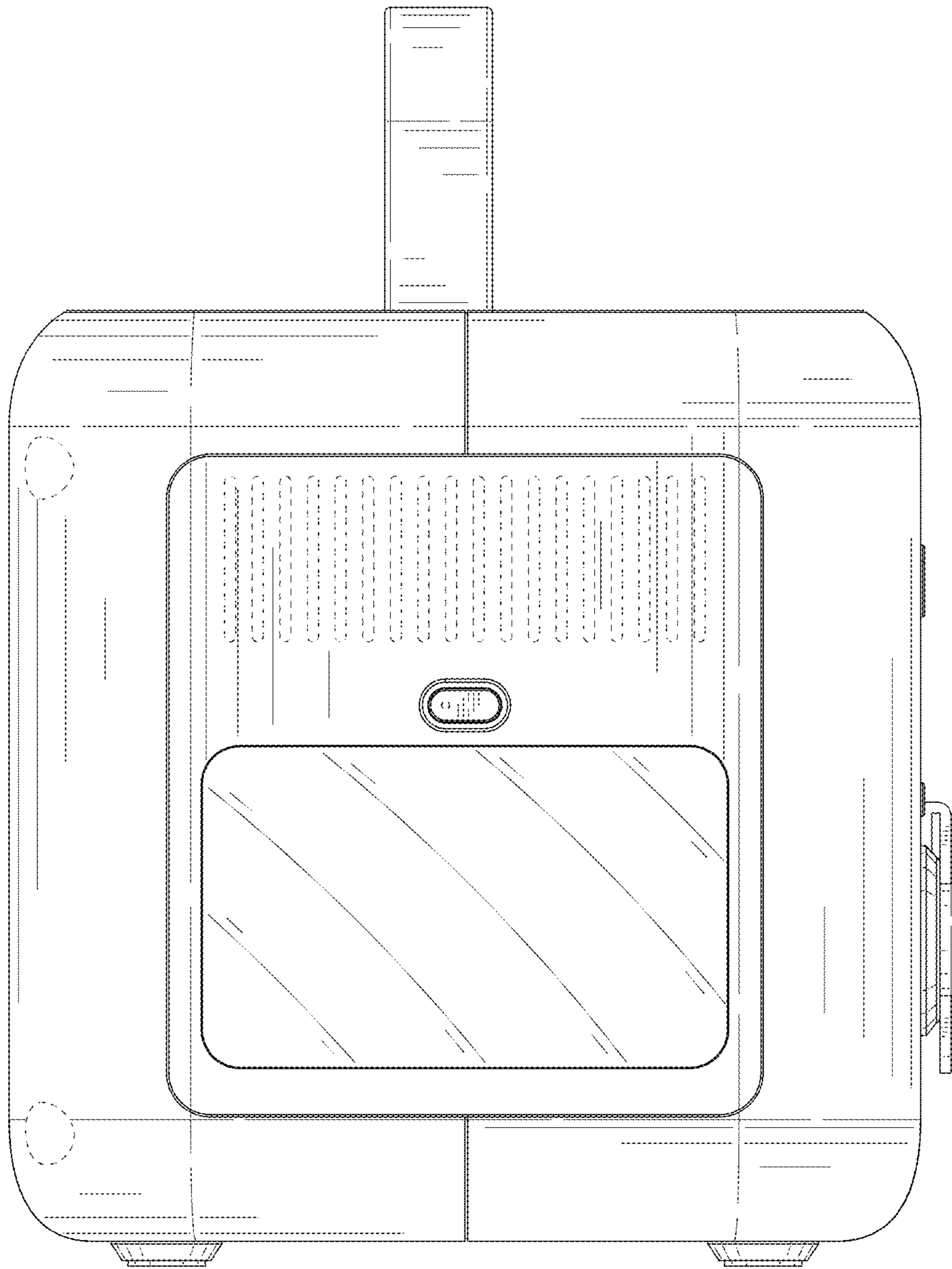

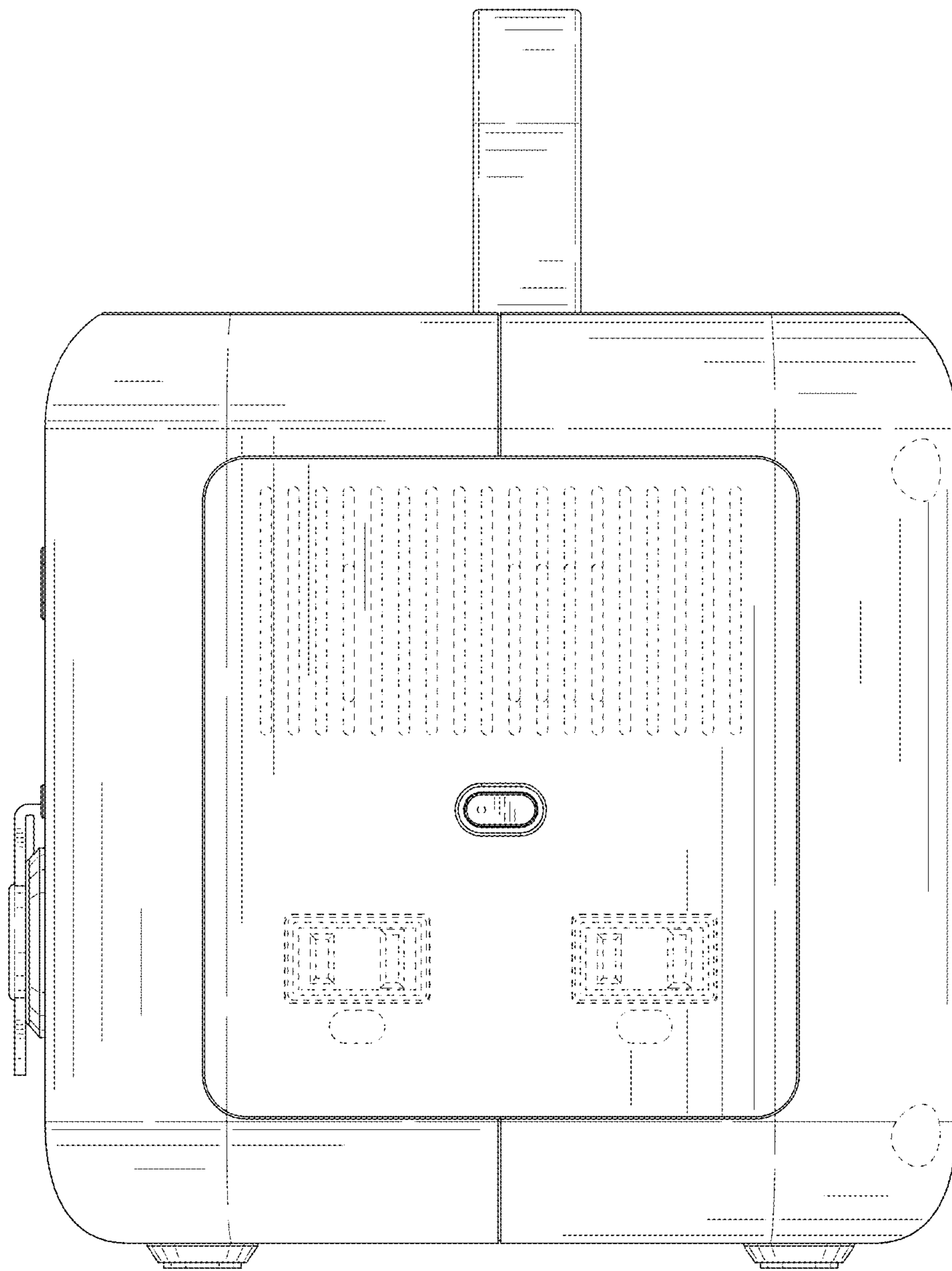

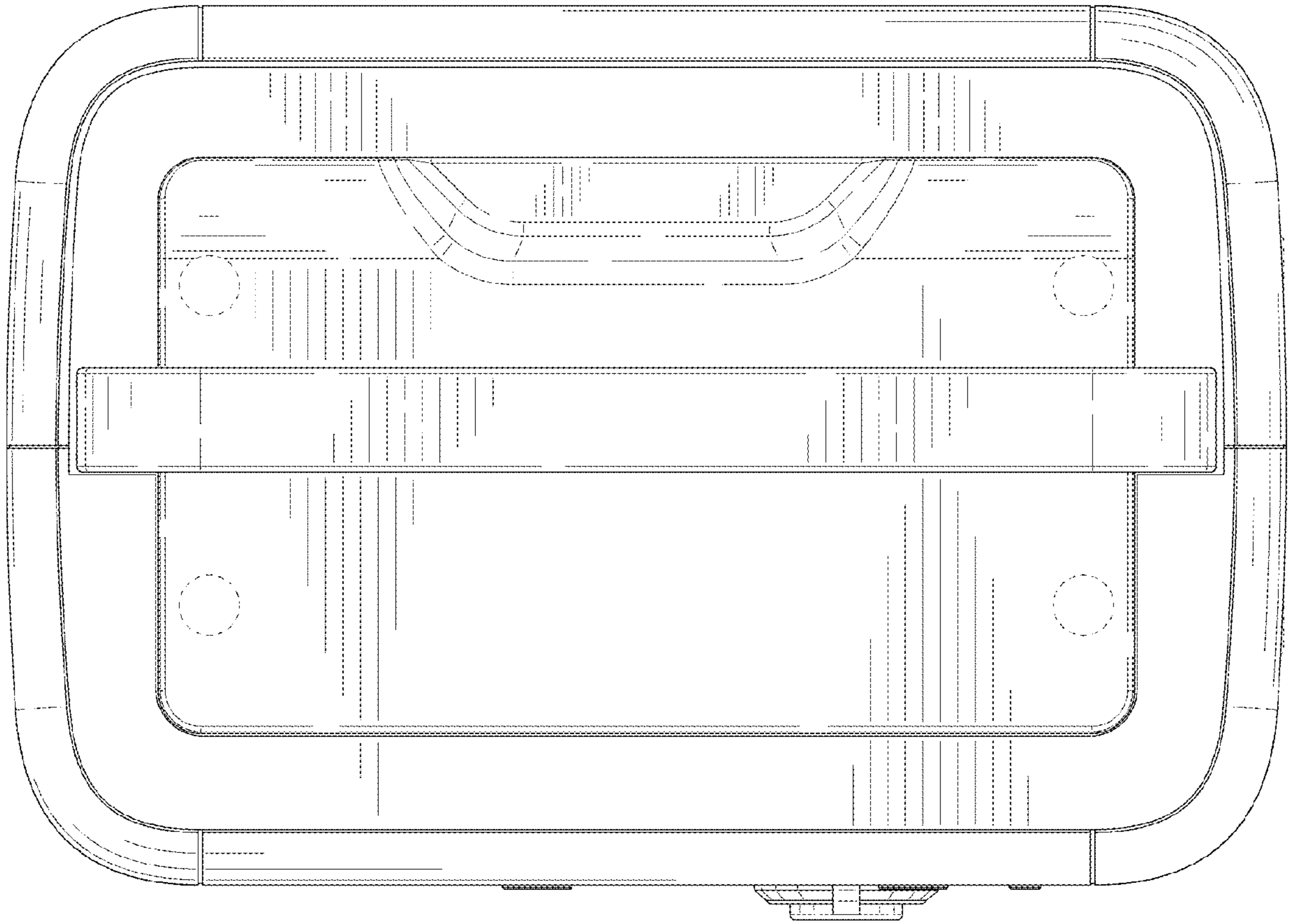

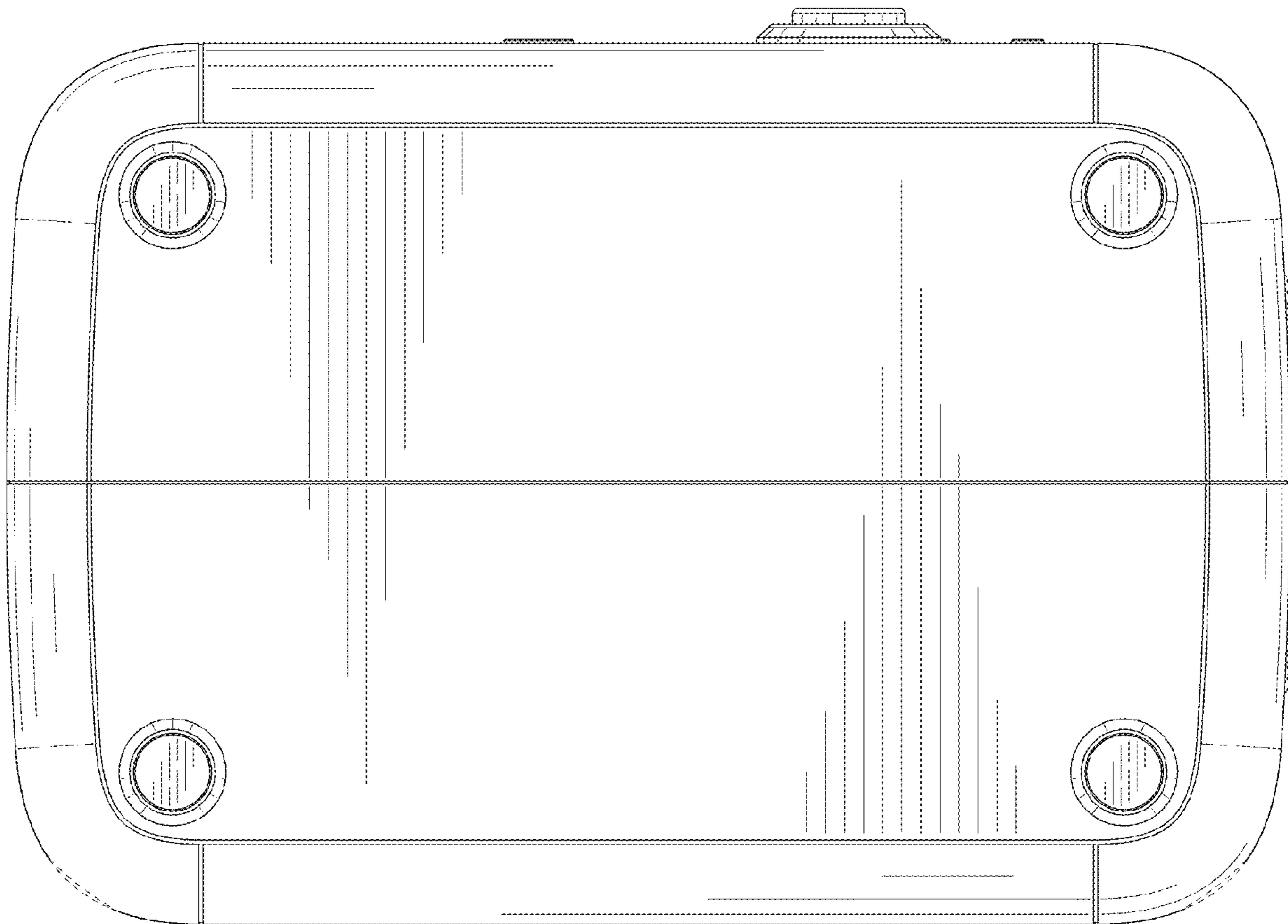

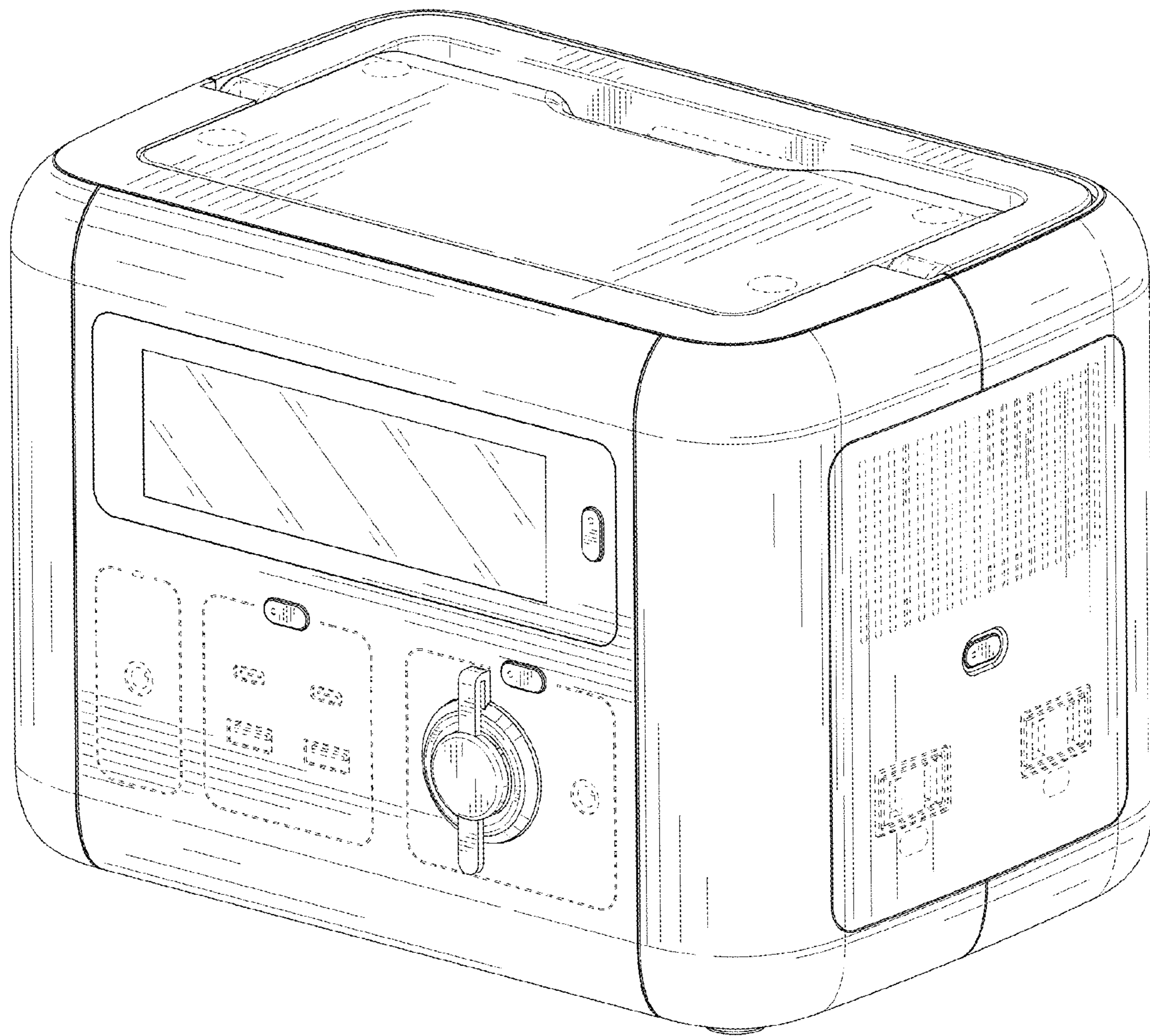
