(57) **CLAIM**

I claim the ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with a graphical user interface showing our new design; and,

FIG. 2 is a front view of a second embodiment thereof. The outermost broken line rectangle illustrates a display screen or portion thereof and forms no part of the claimed design.
