The ornamental design for an air compressor, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of an air compressor in accordance with my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a right-side elevation view thereof;
FIG. 5 is a left-side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

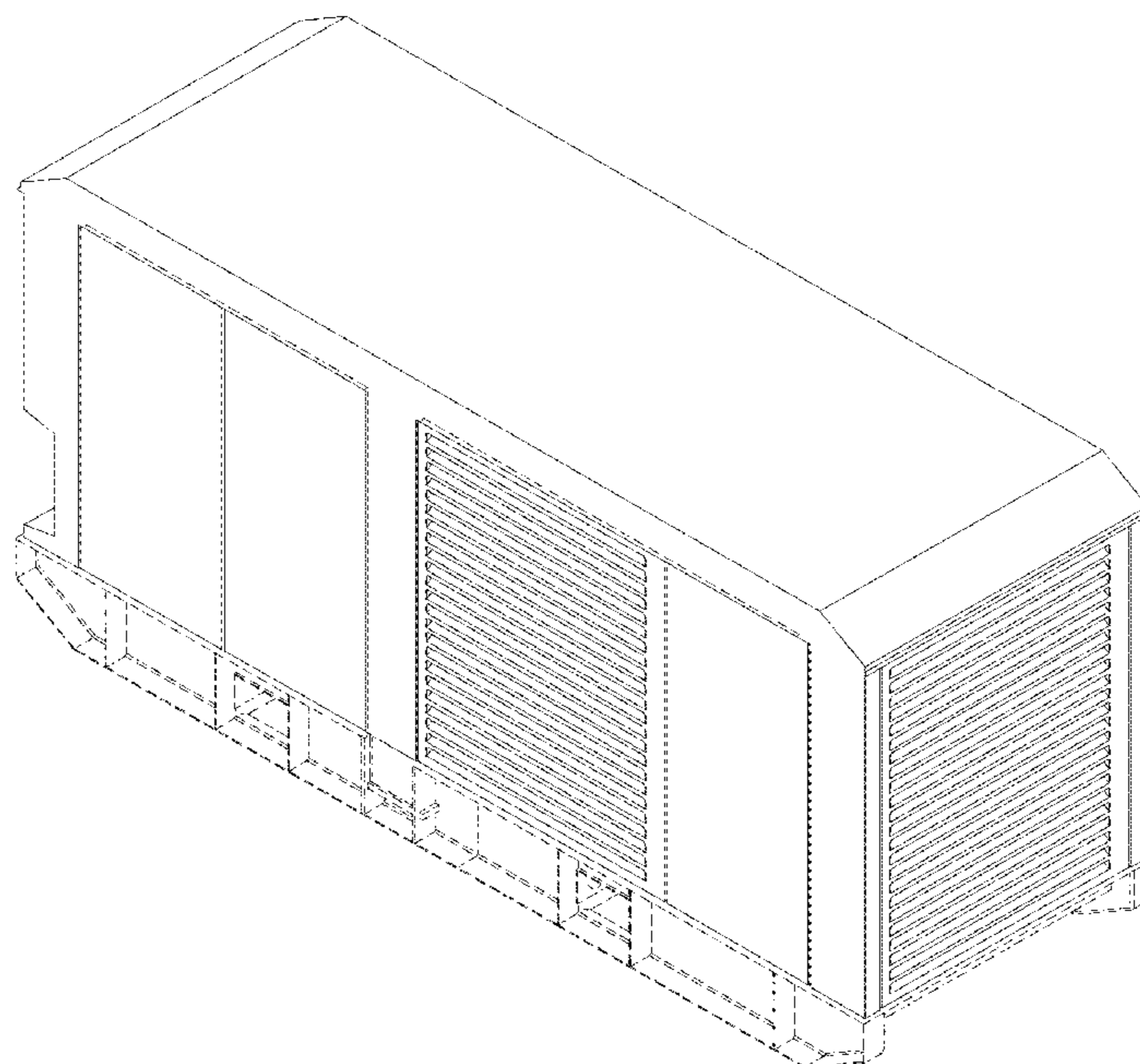
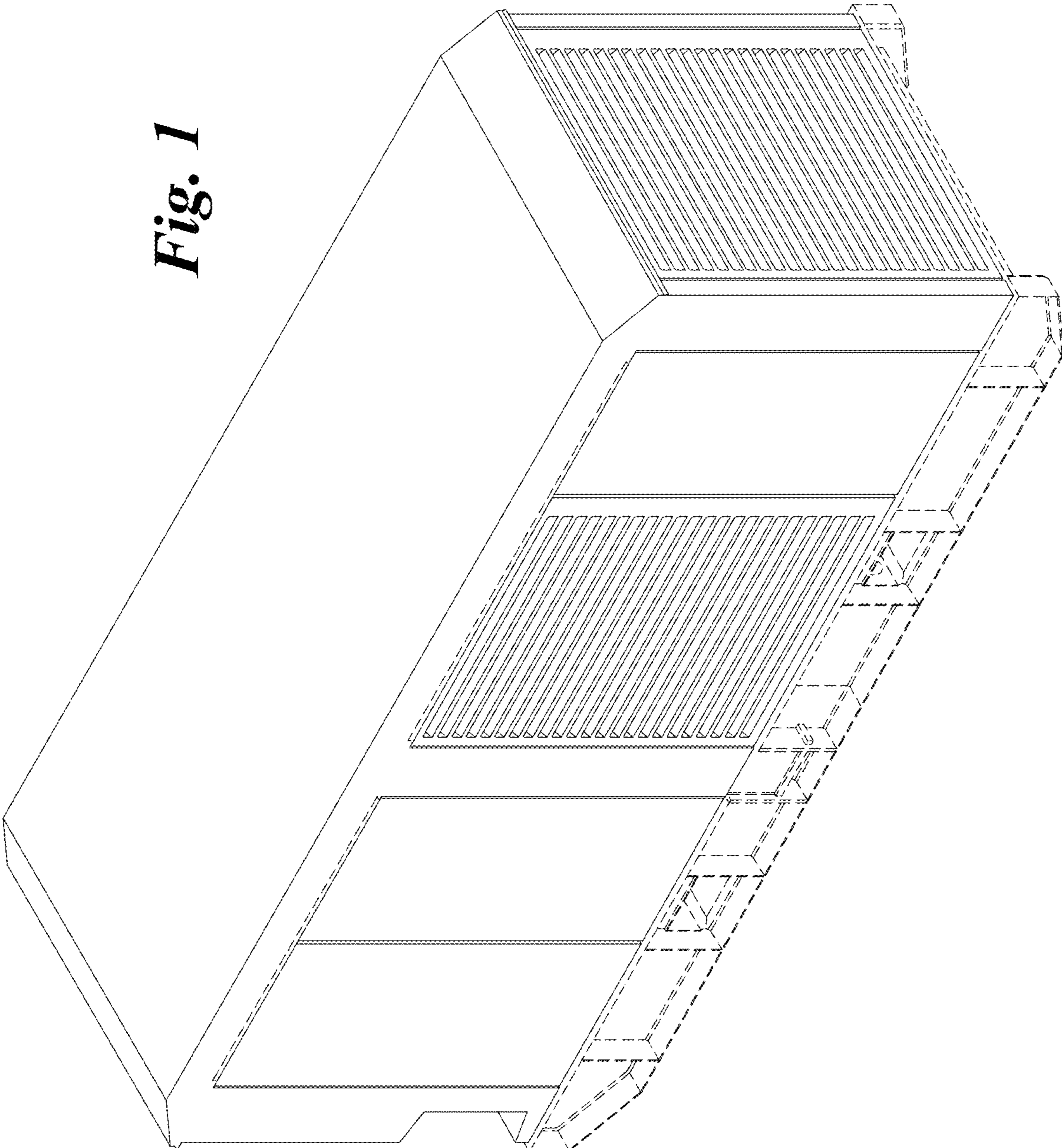

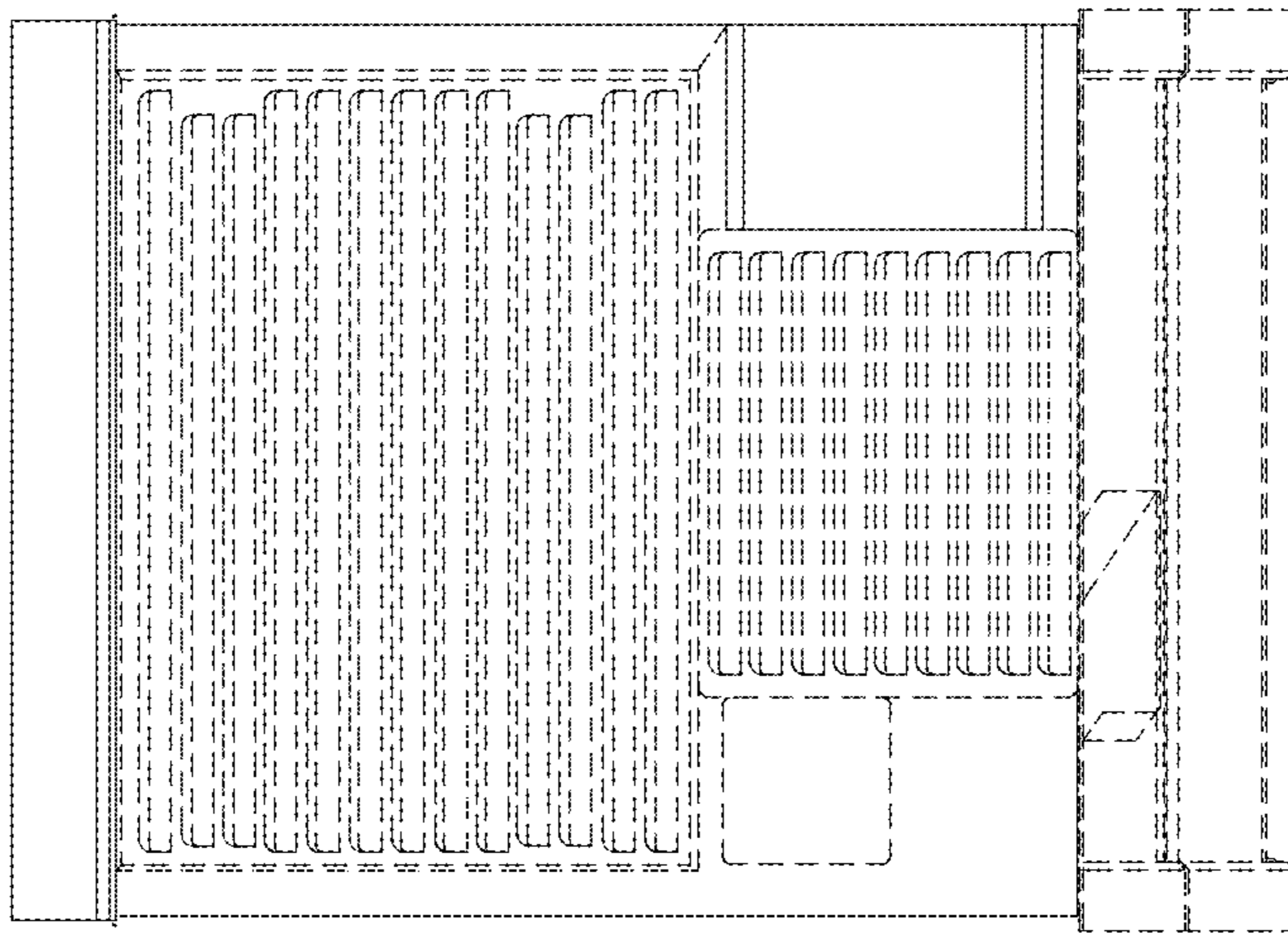

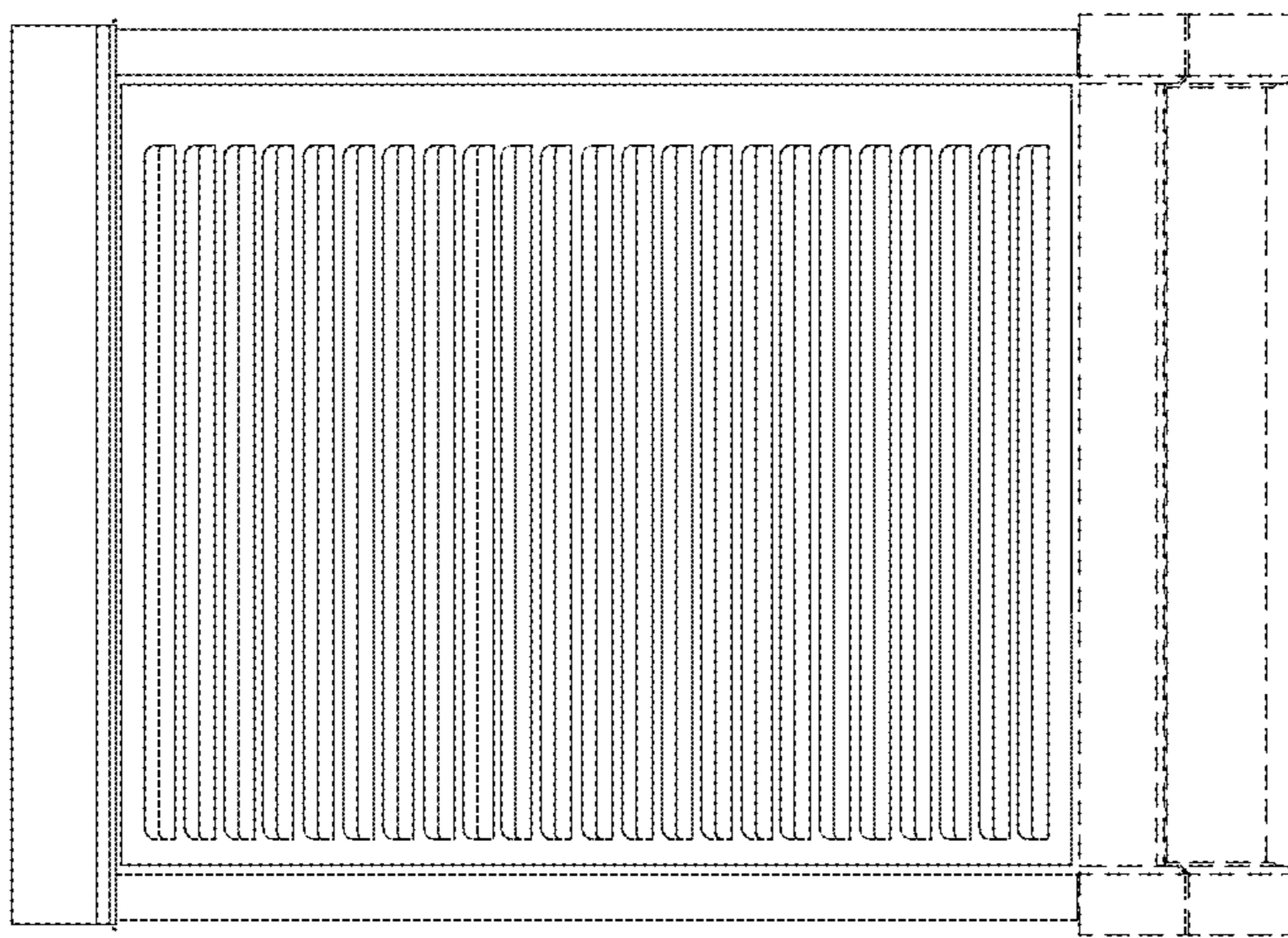

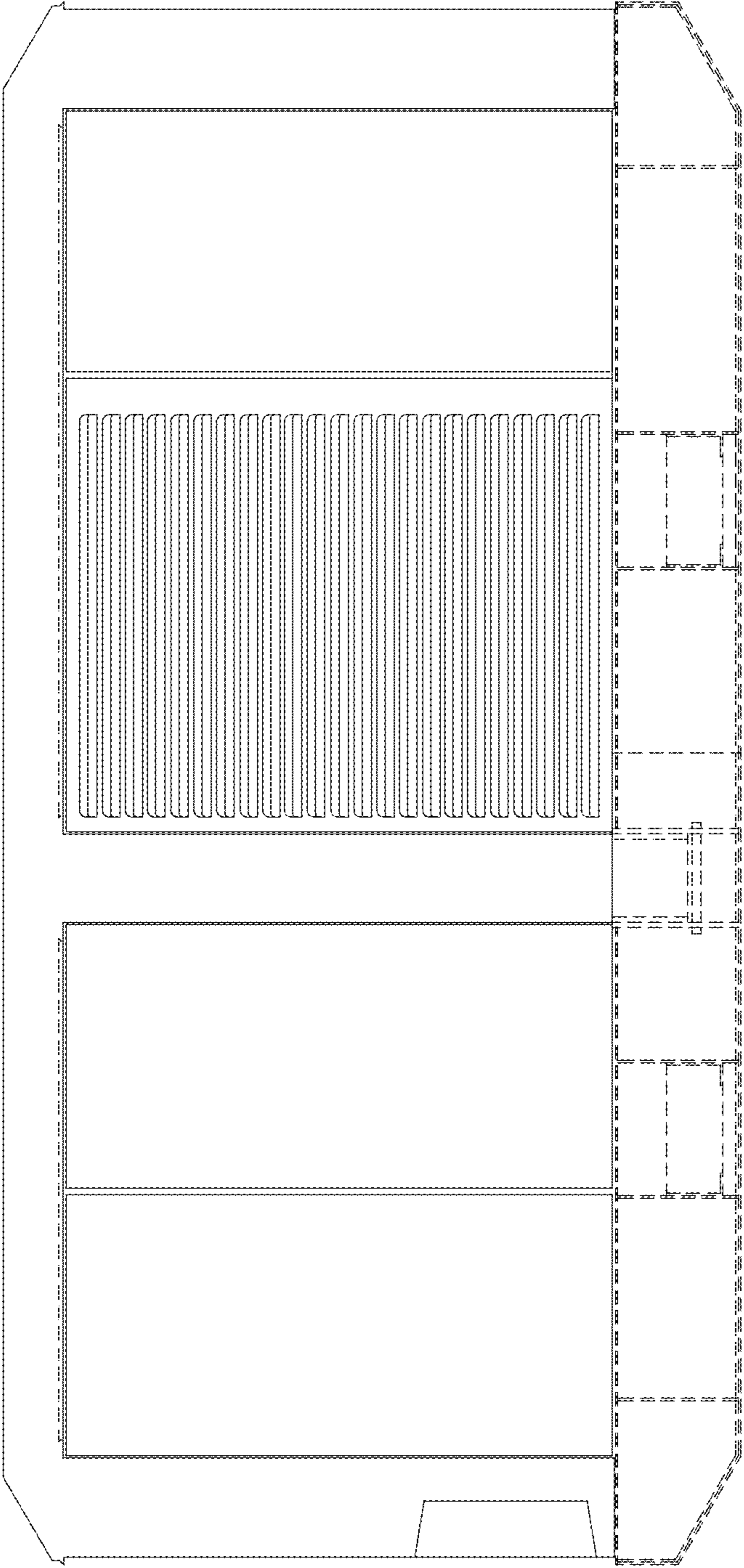

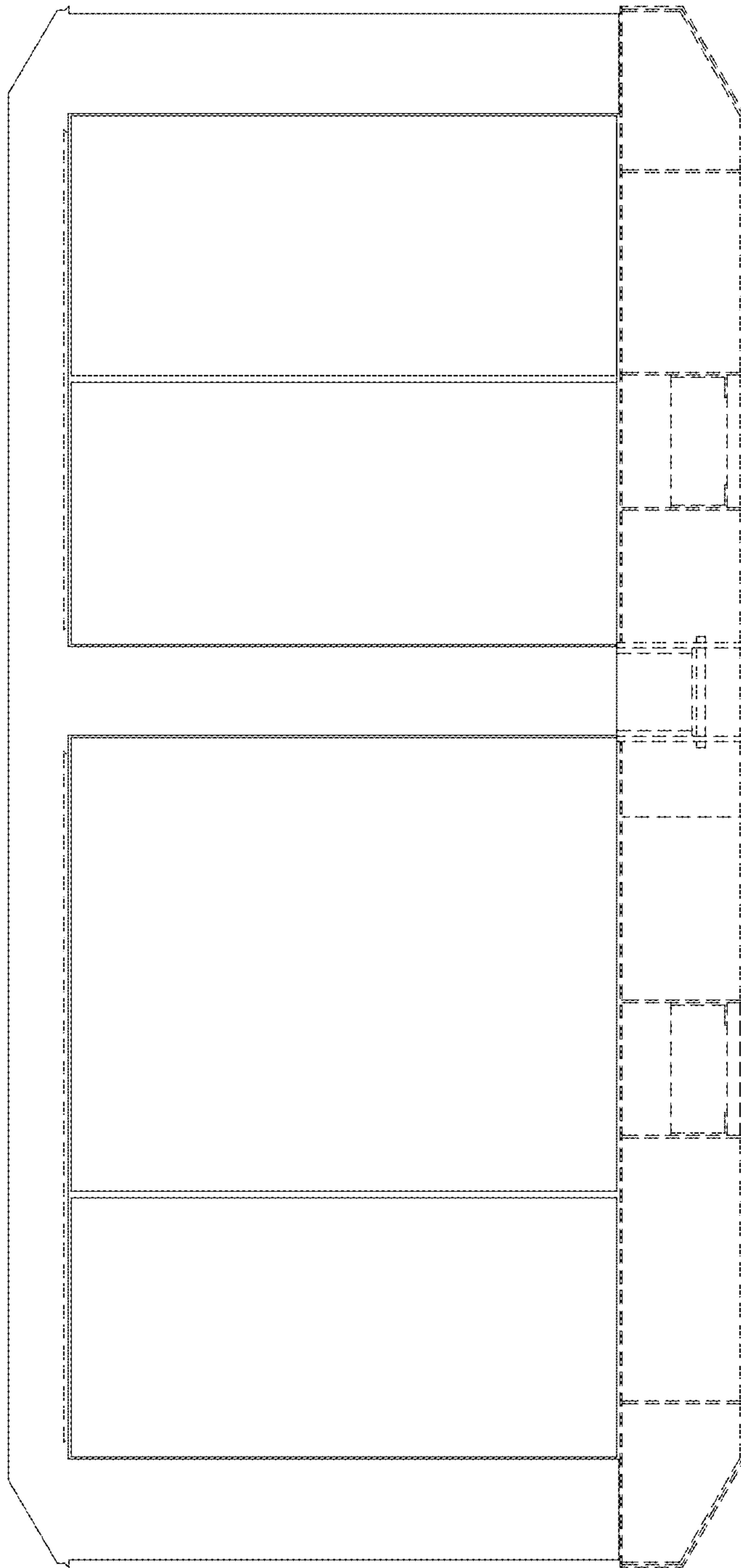

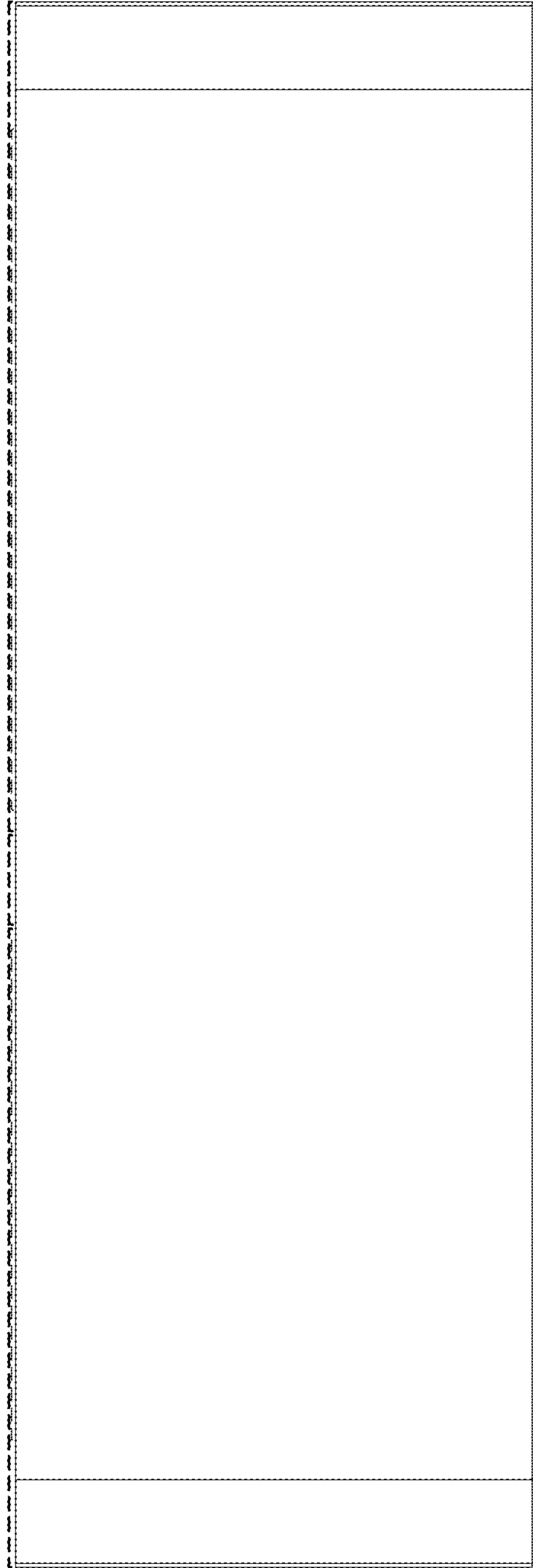

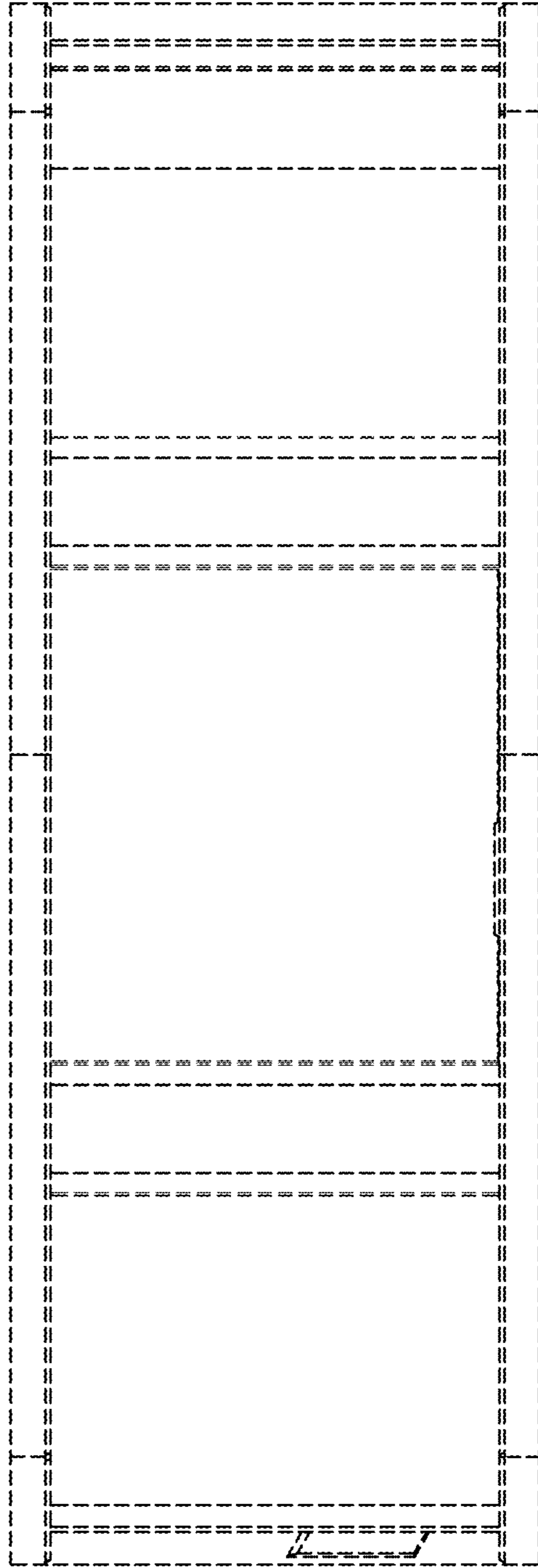
