FIG. 5 is a side elevation view of the right side of the projector of FIG. 1.

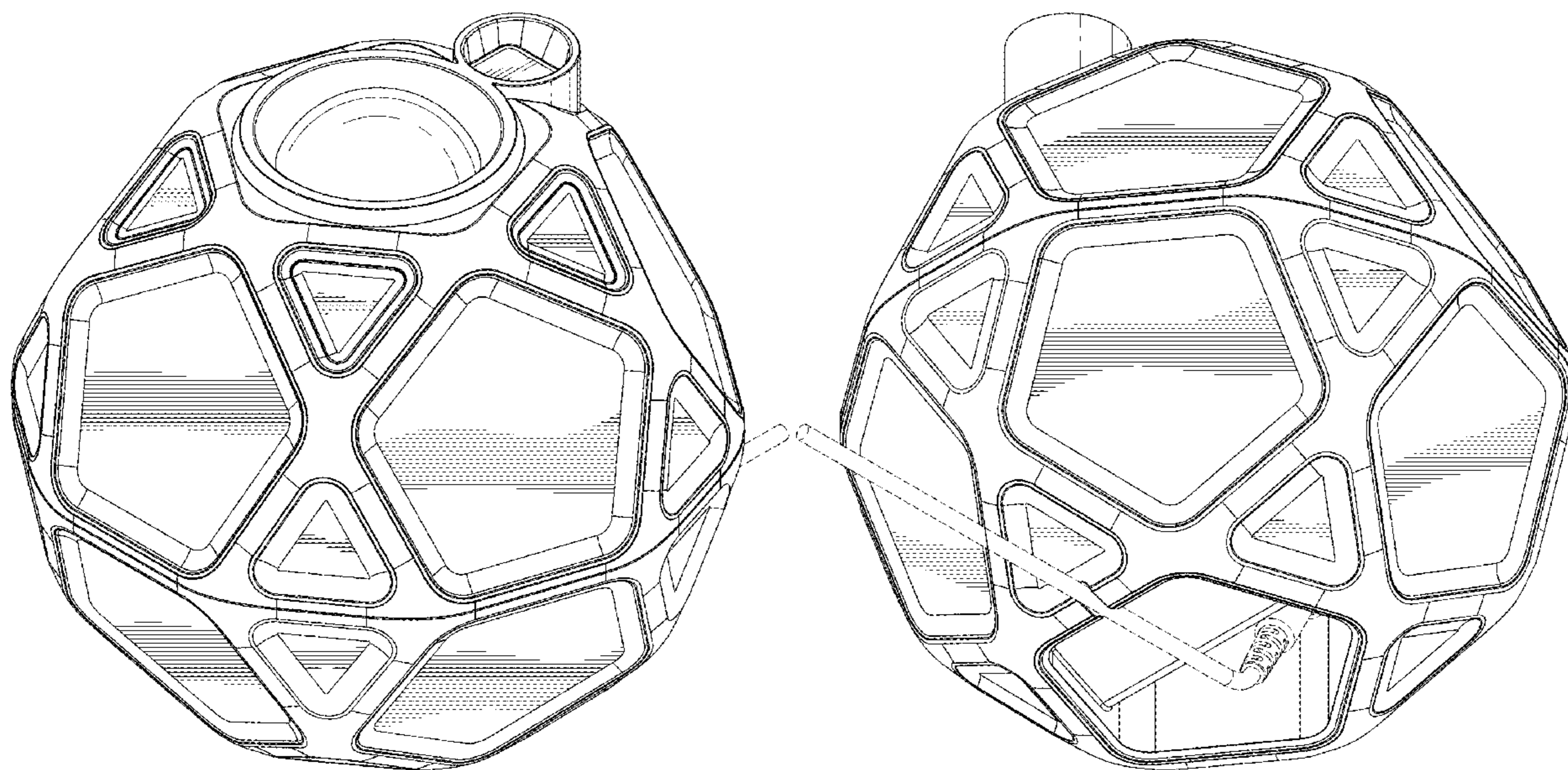
FIG. 6 is a side elevation view of the left side of the projector of FIG. 1.

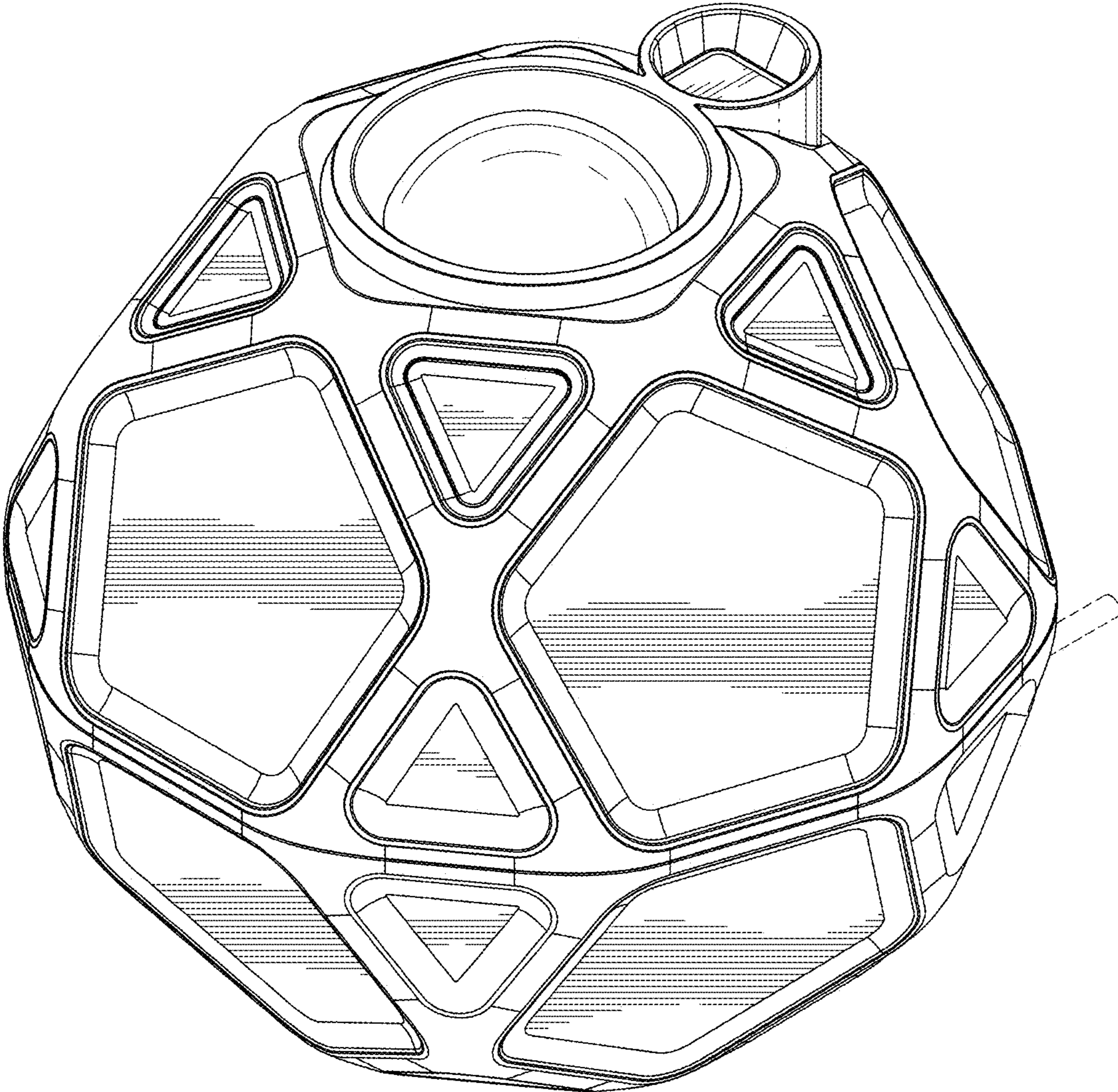
FIG. 7 is a top plan view of the projector of FIG. 1; and,

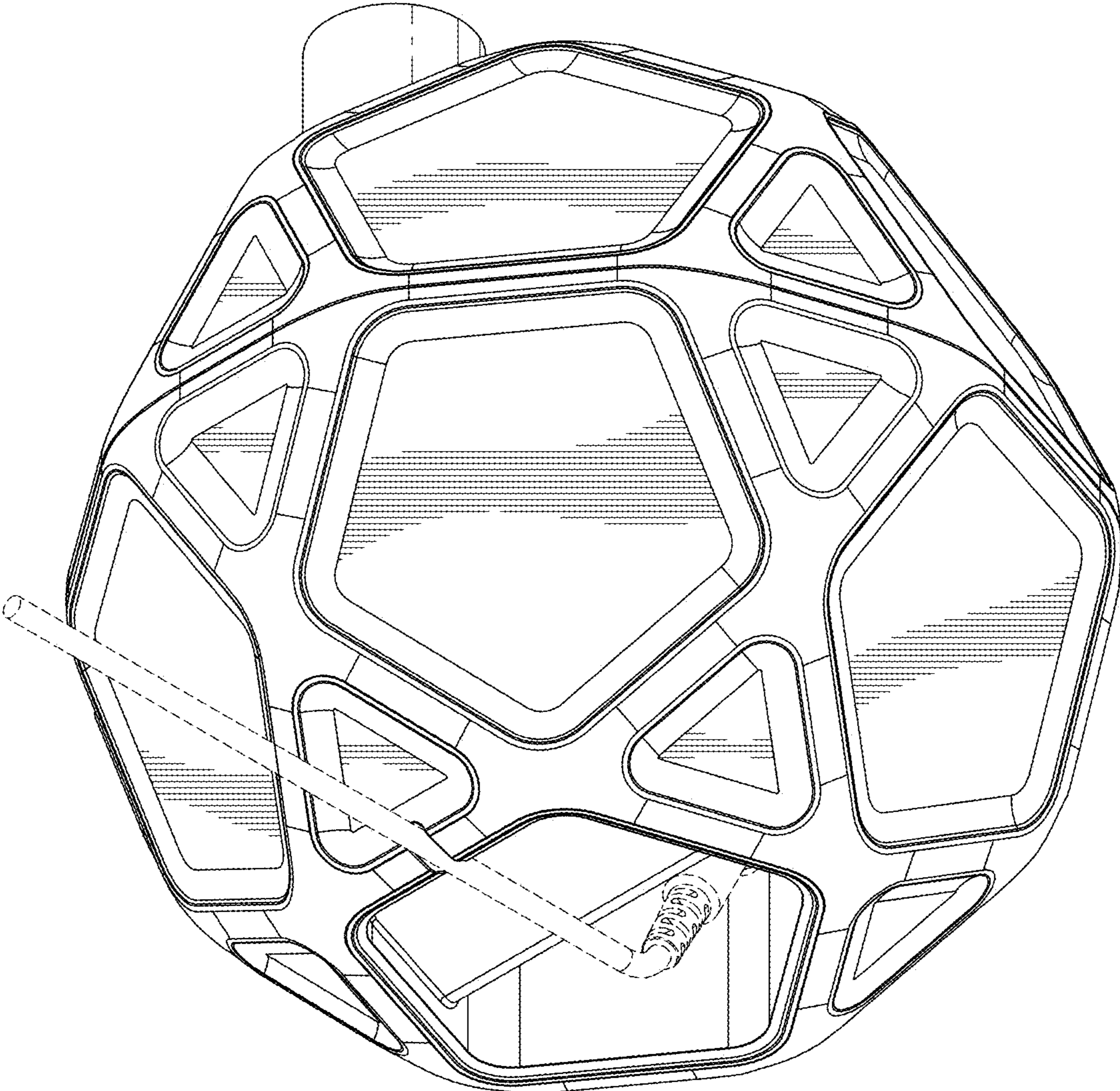

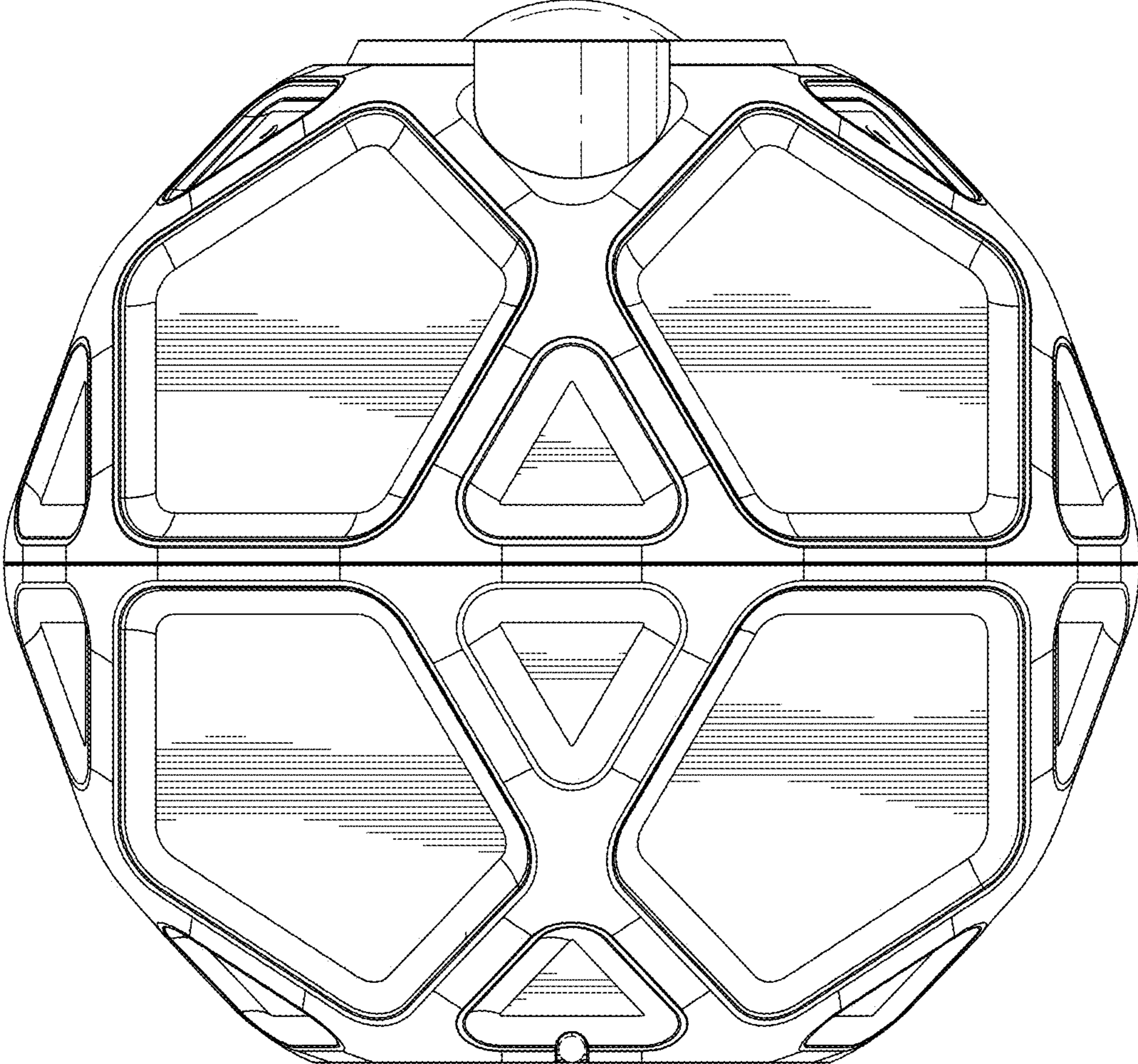

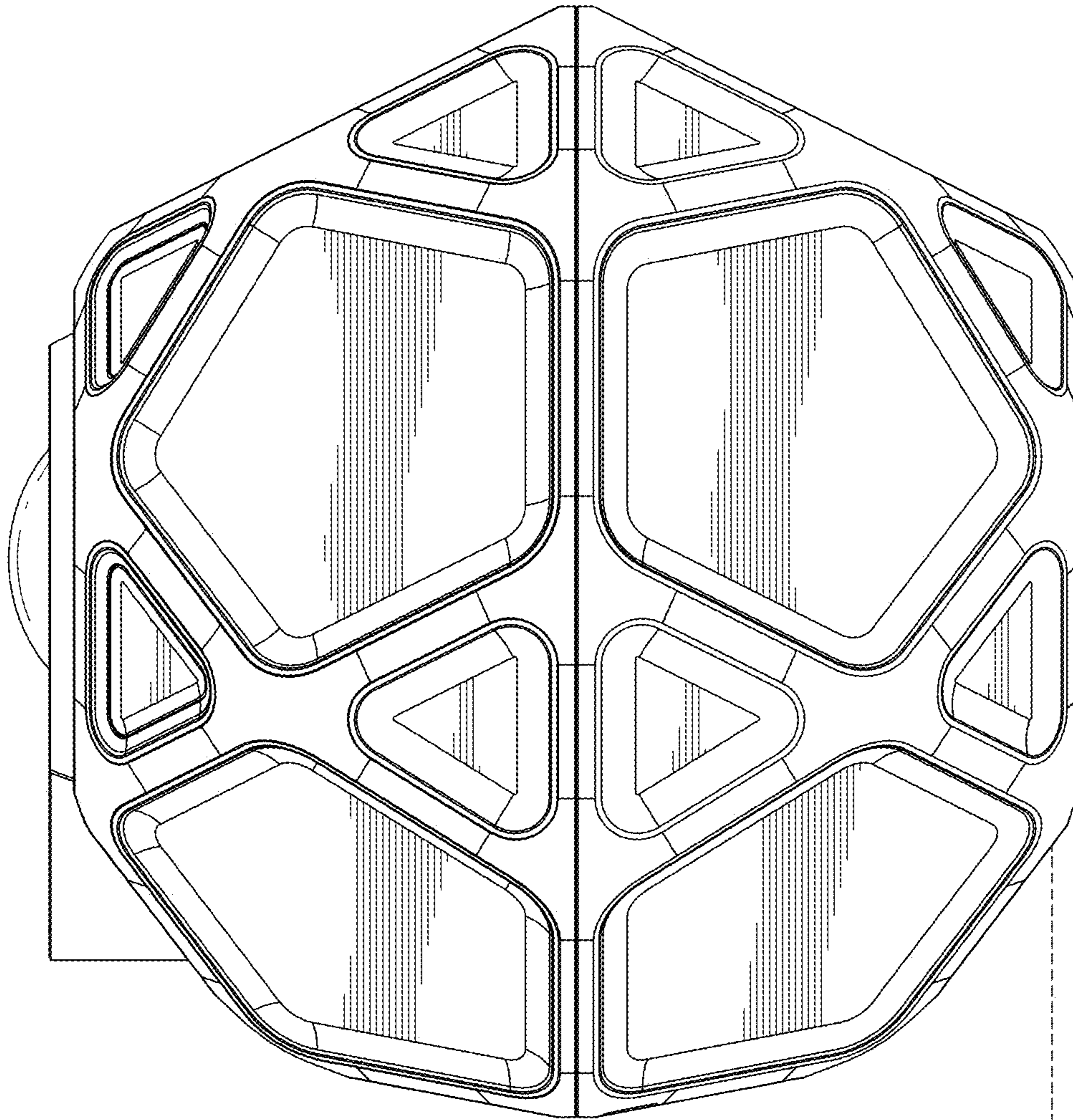
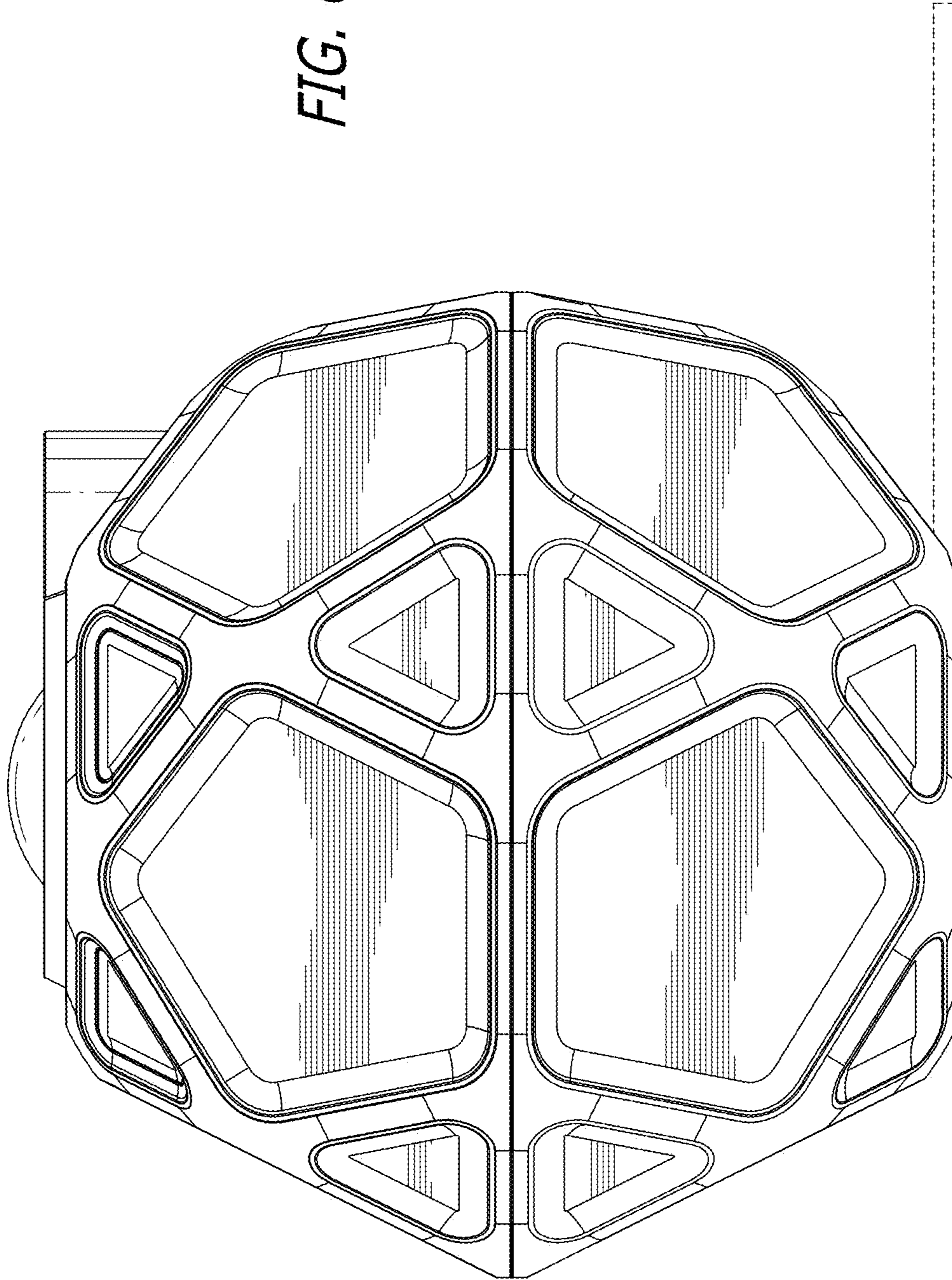
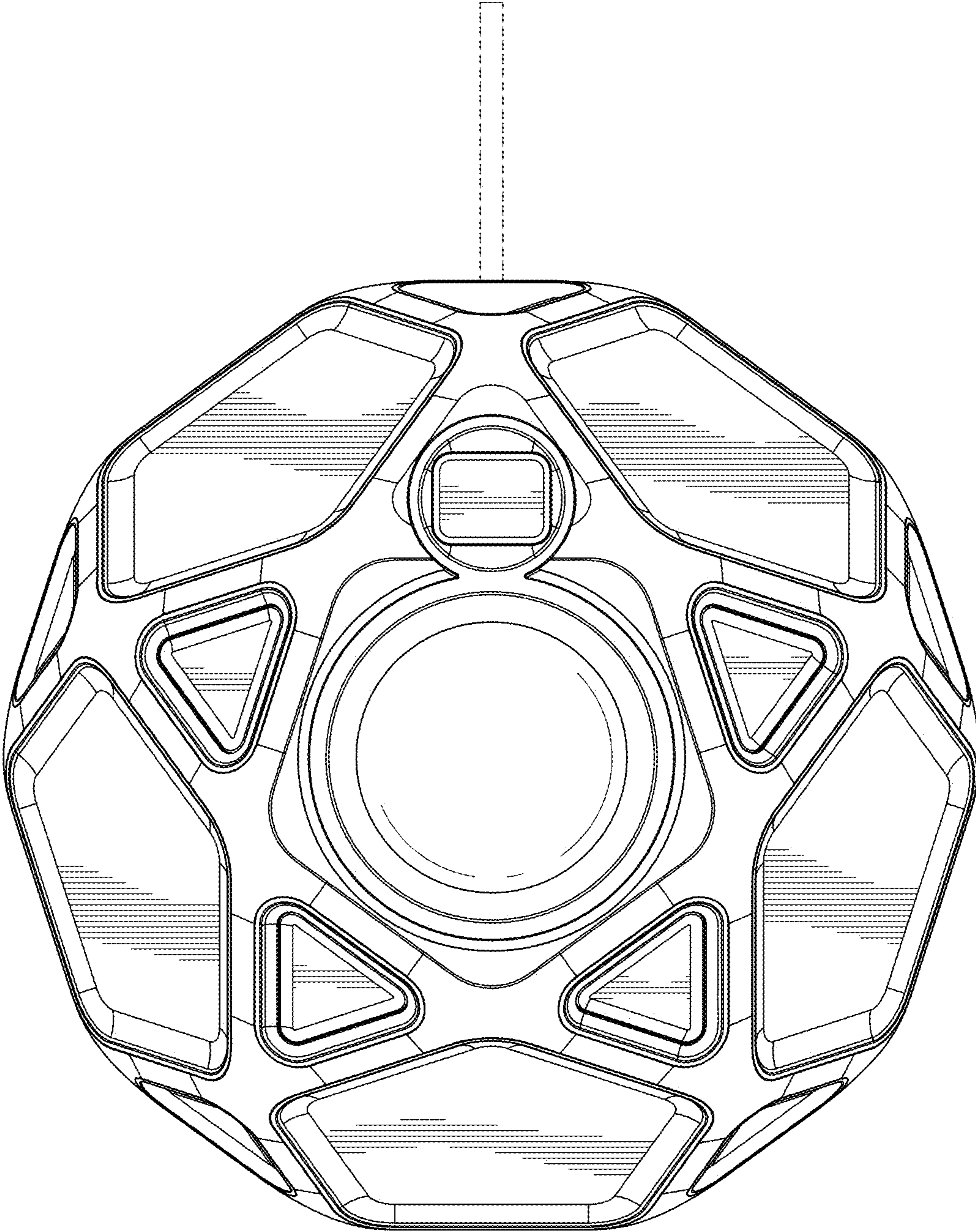

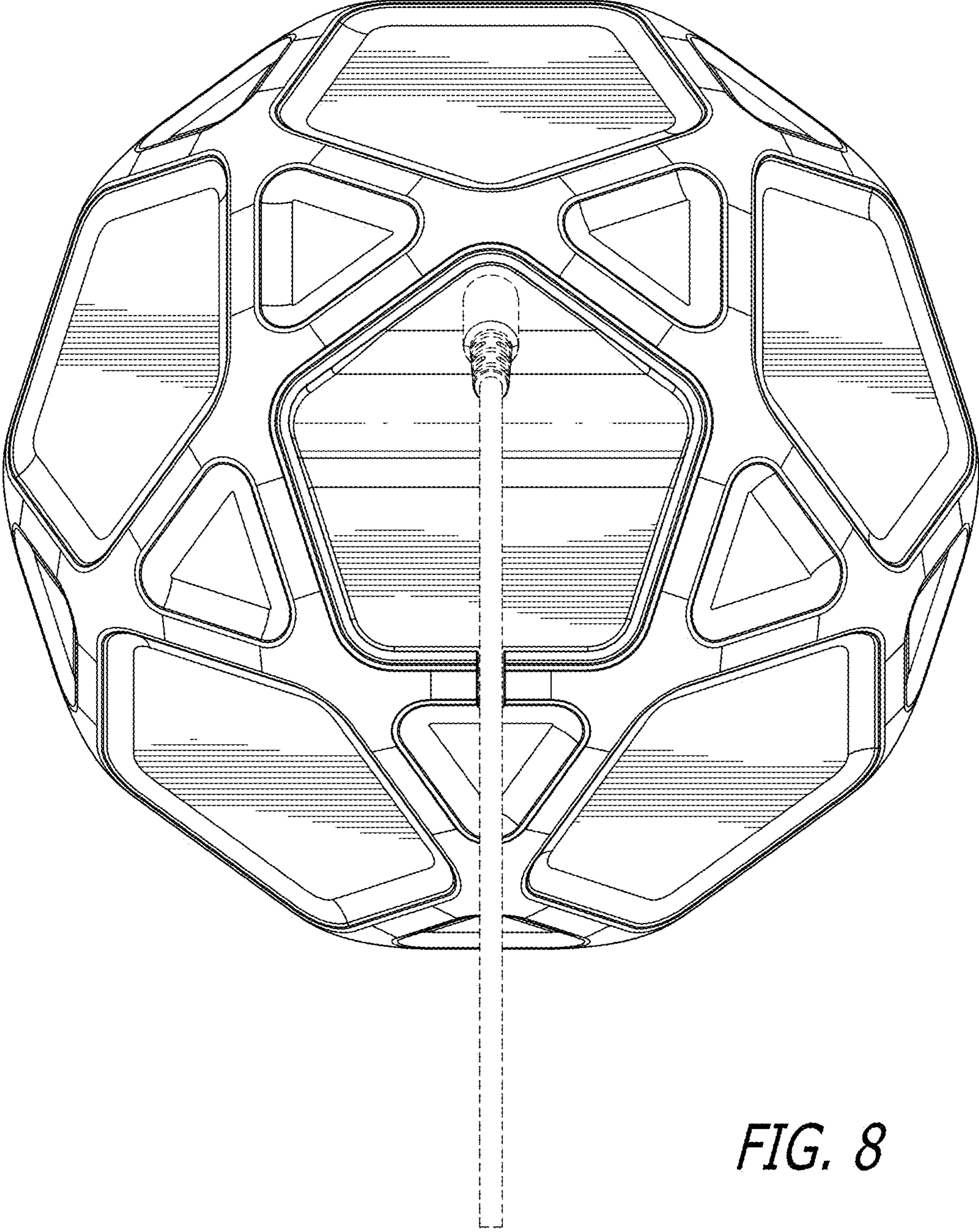
