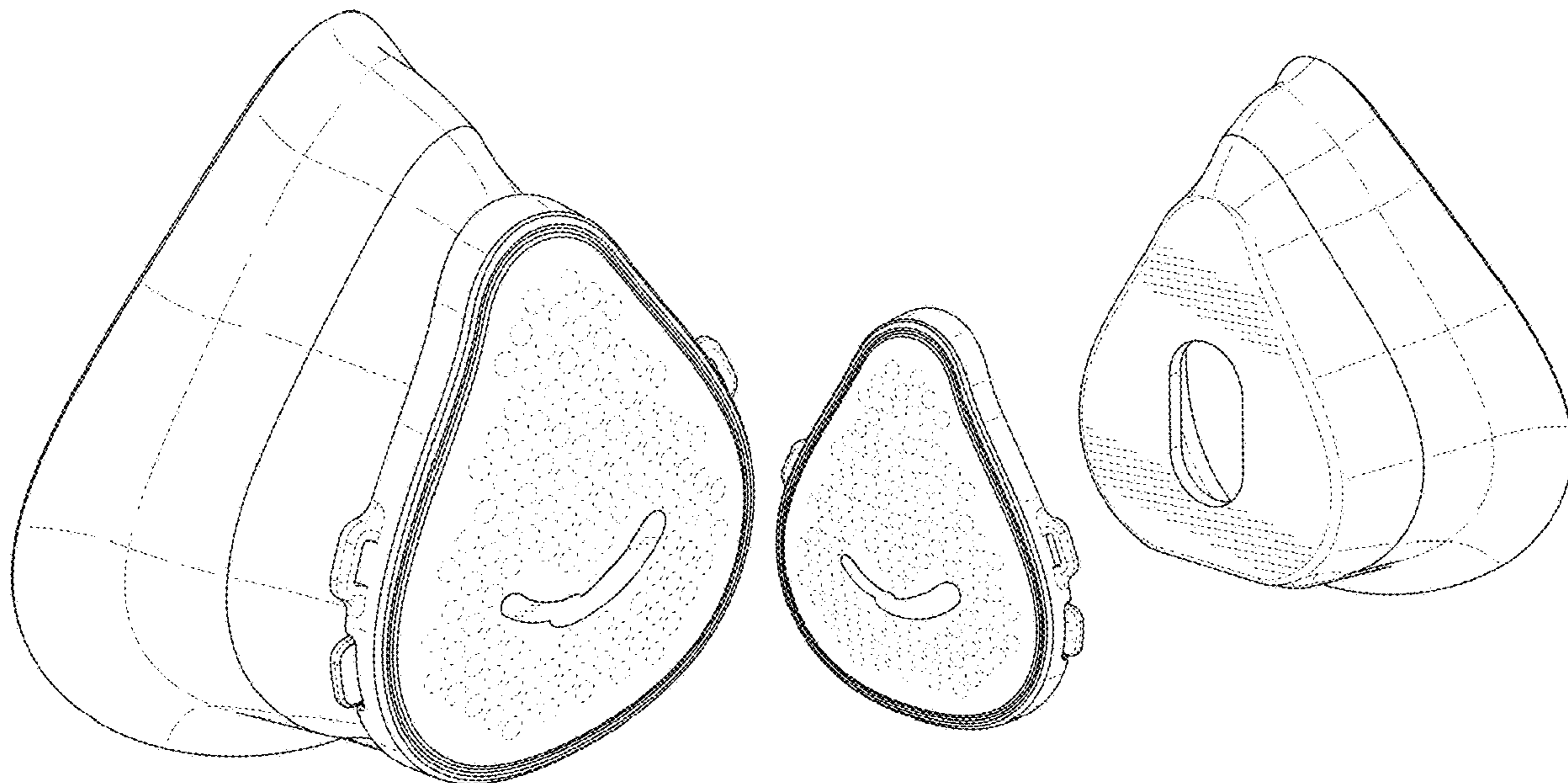
(57) **CLAIM**

The ornamental design for a respiratory mask, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a respiratory mask showing my new design;

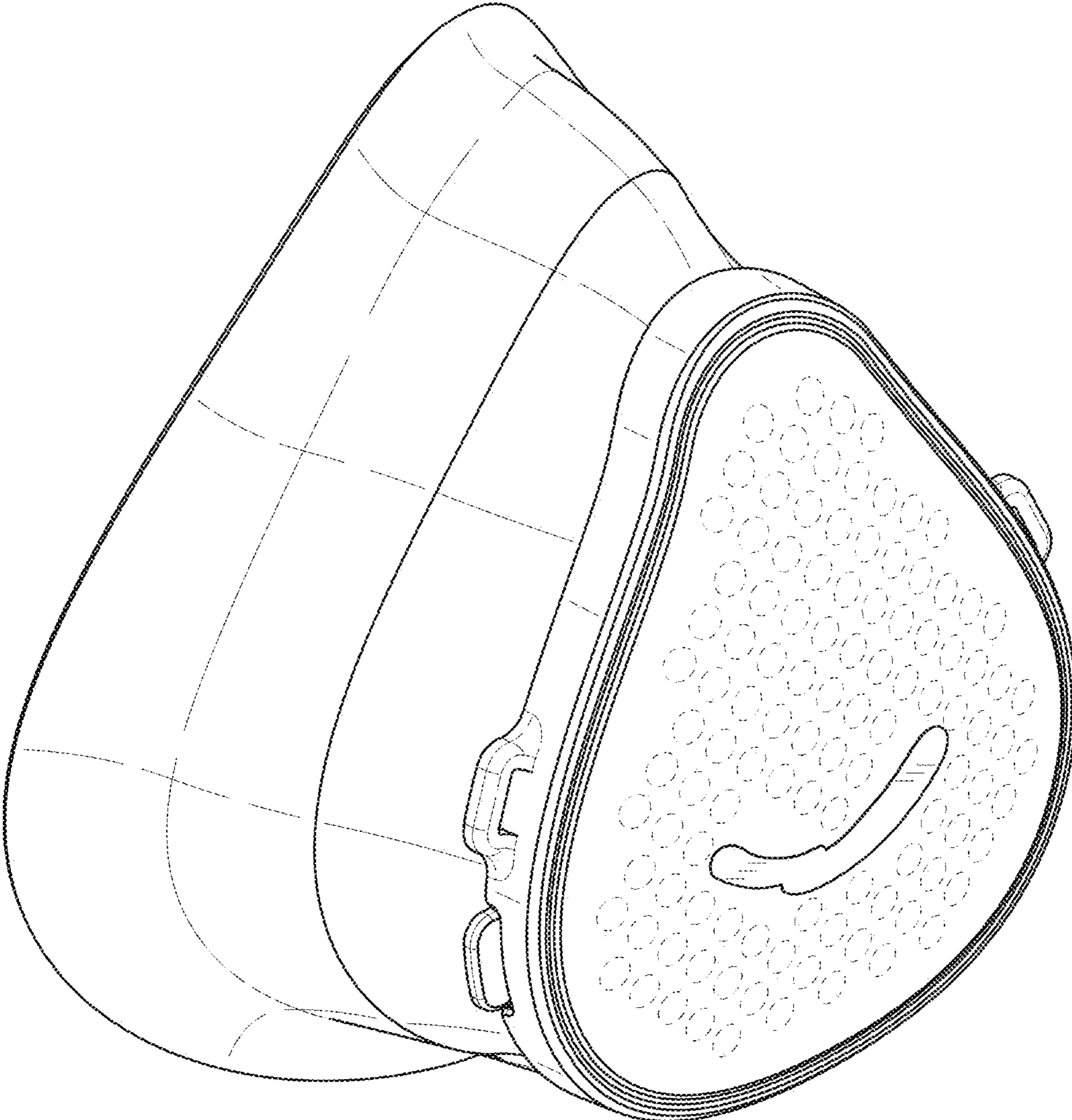

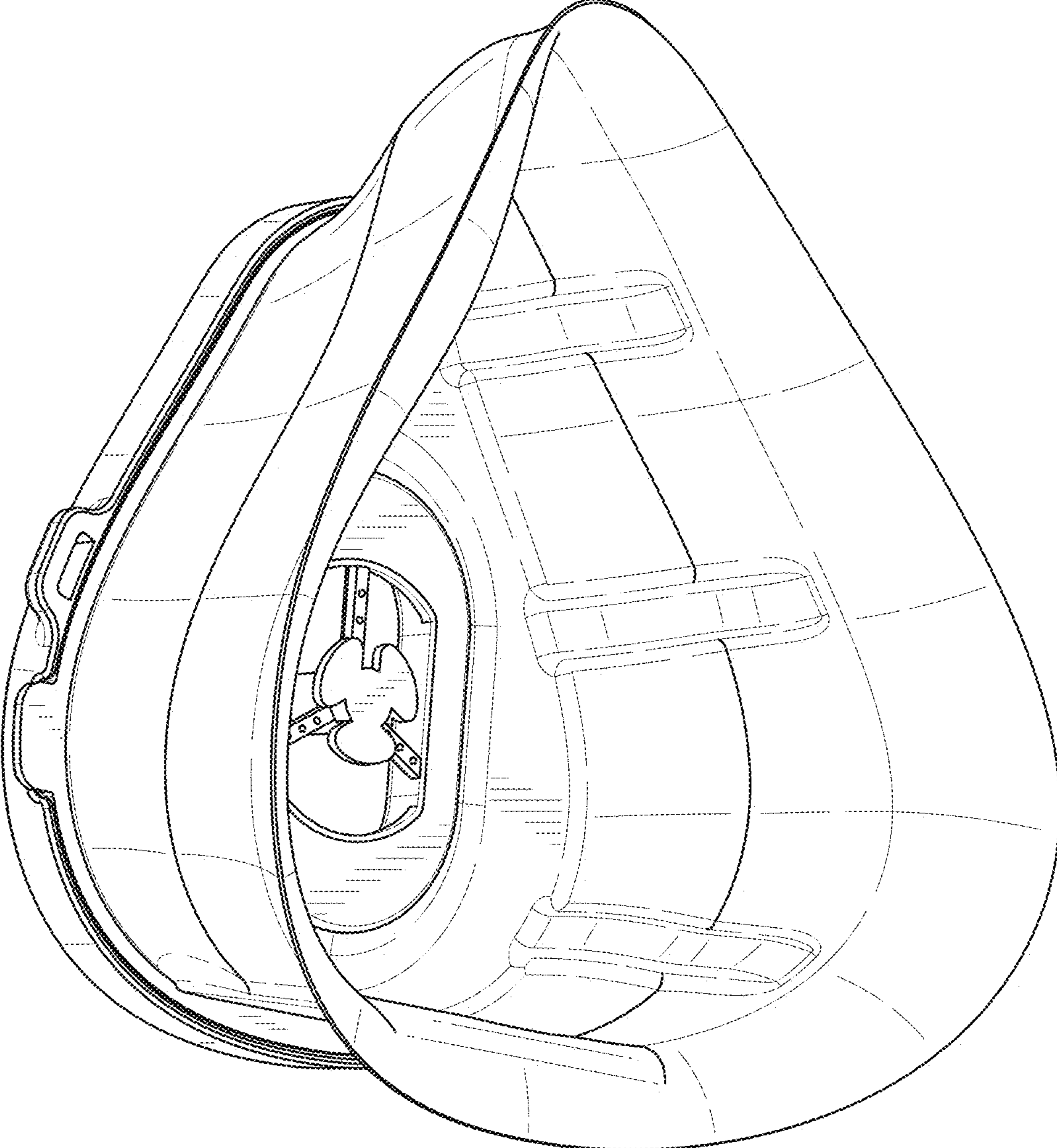

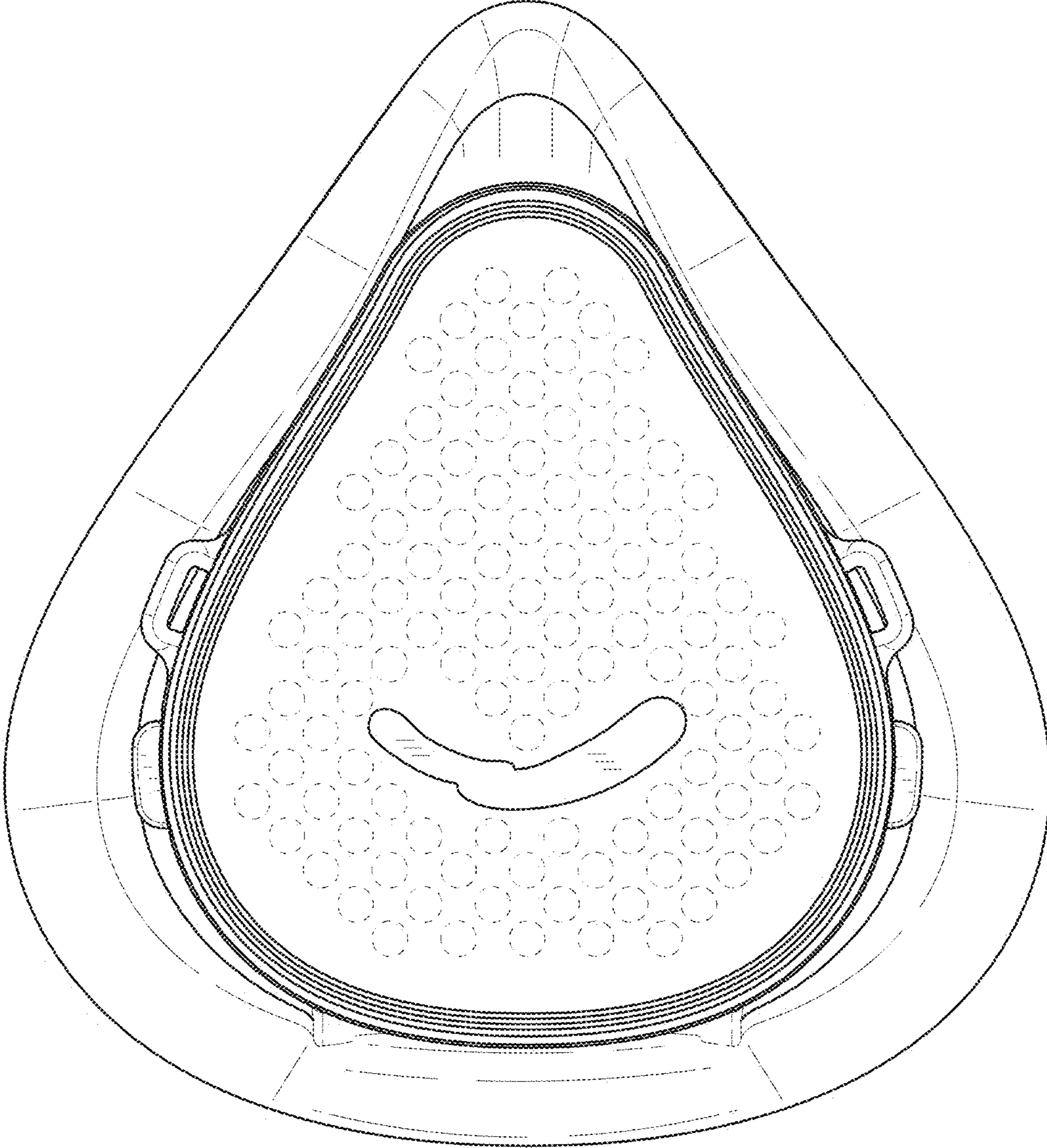

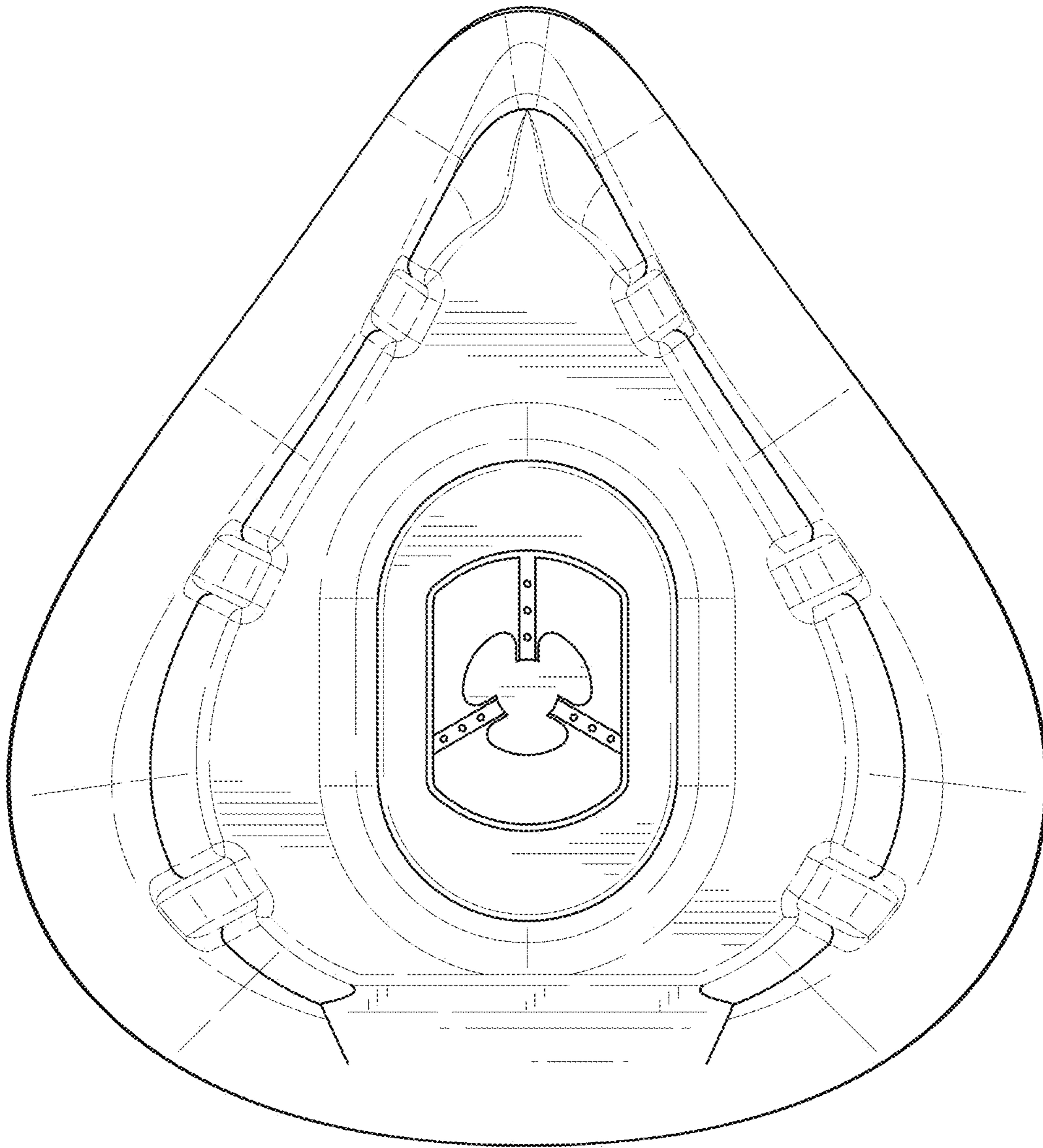

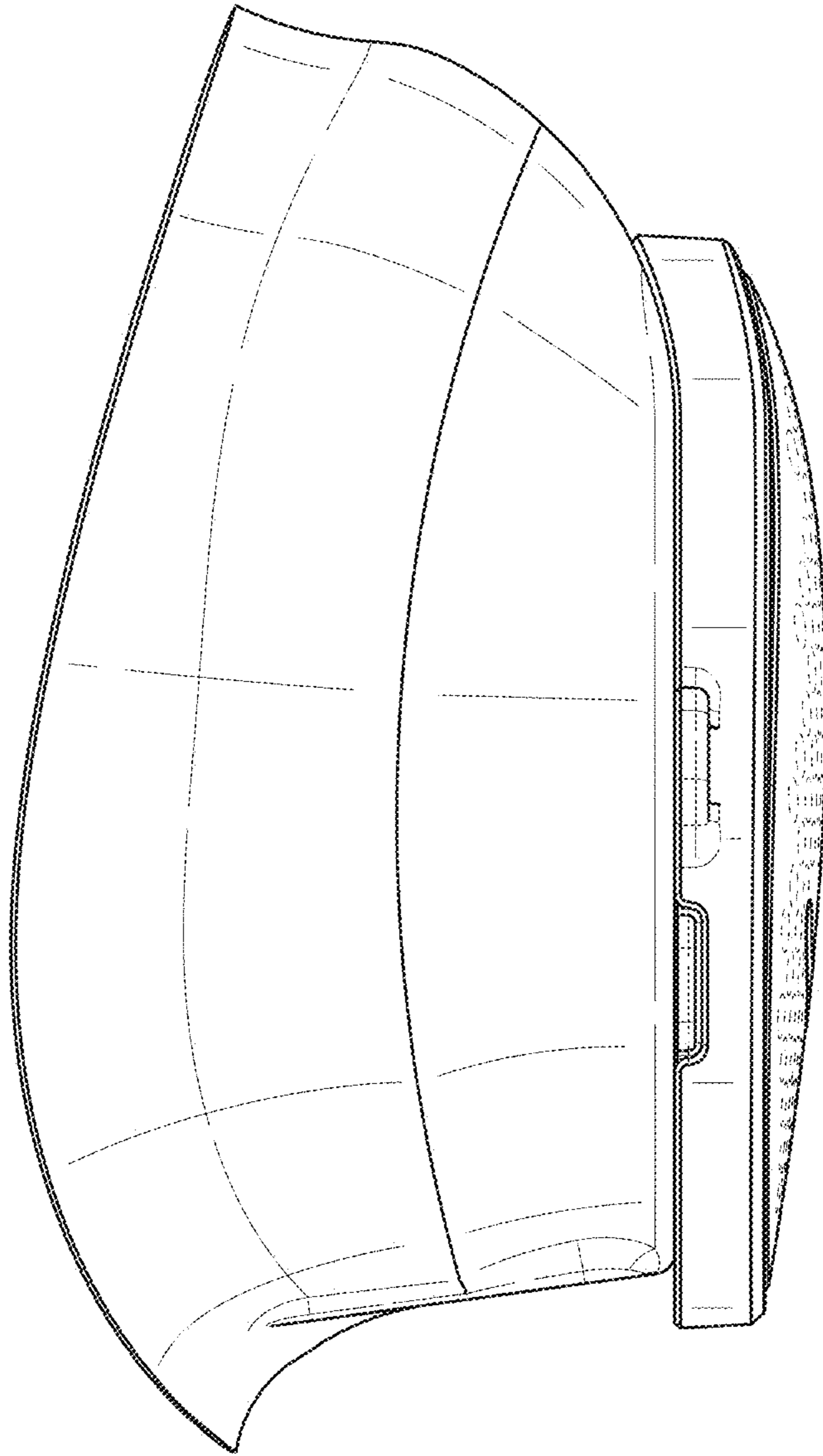

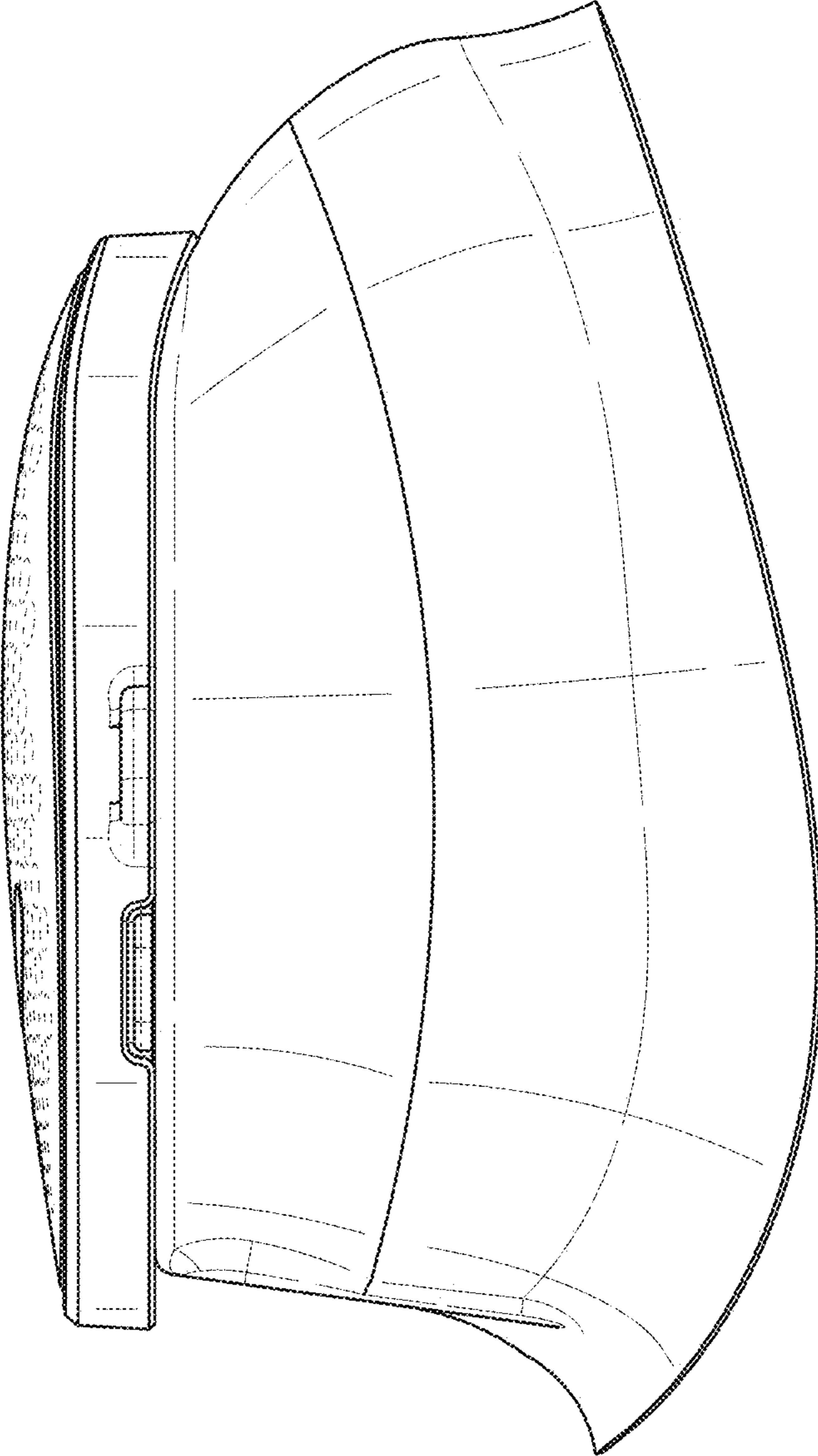

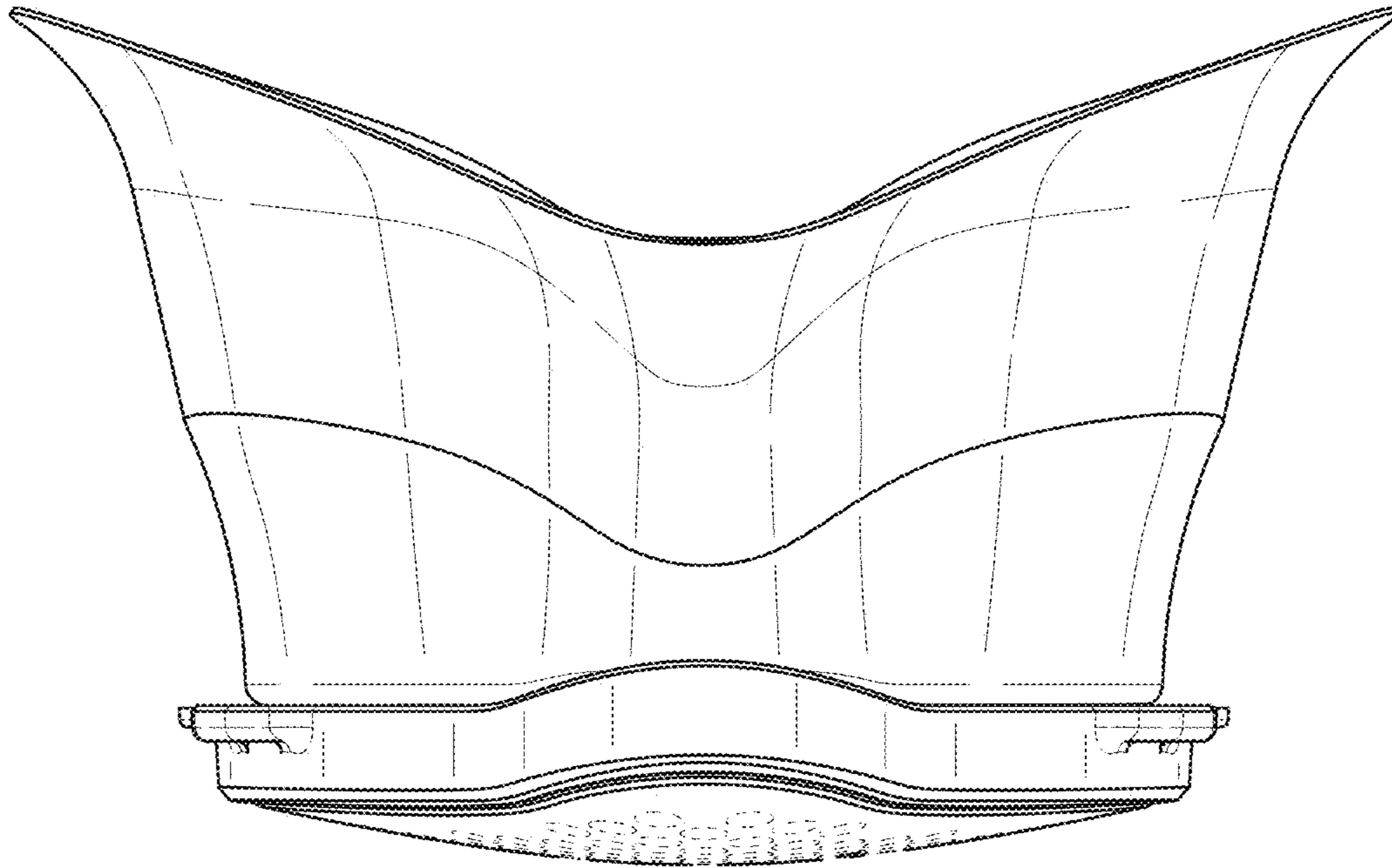

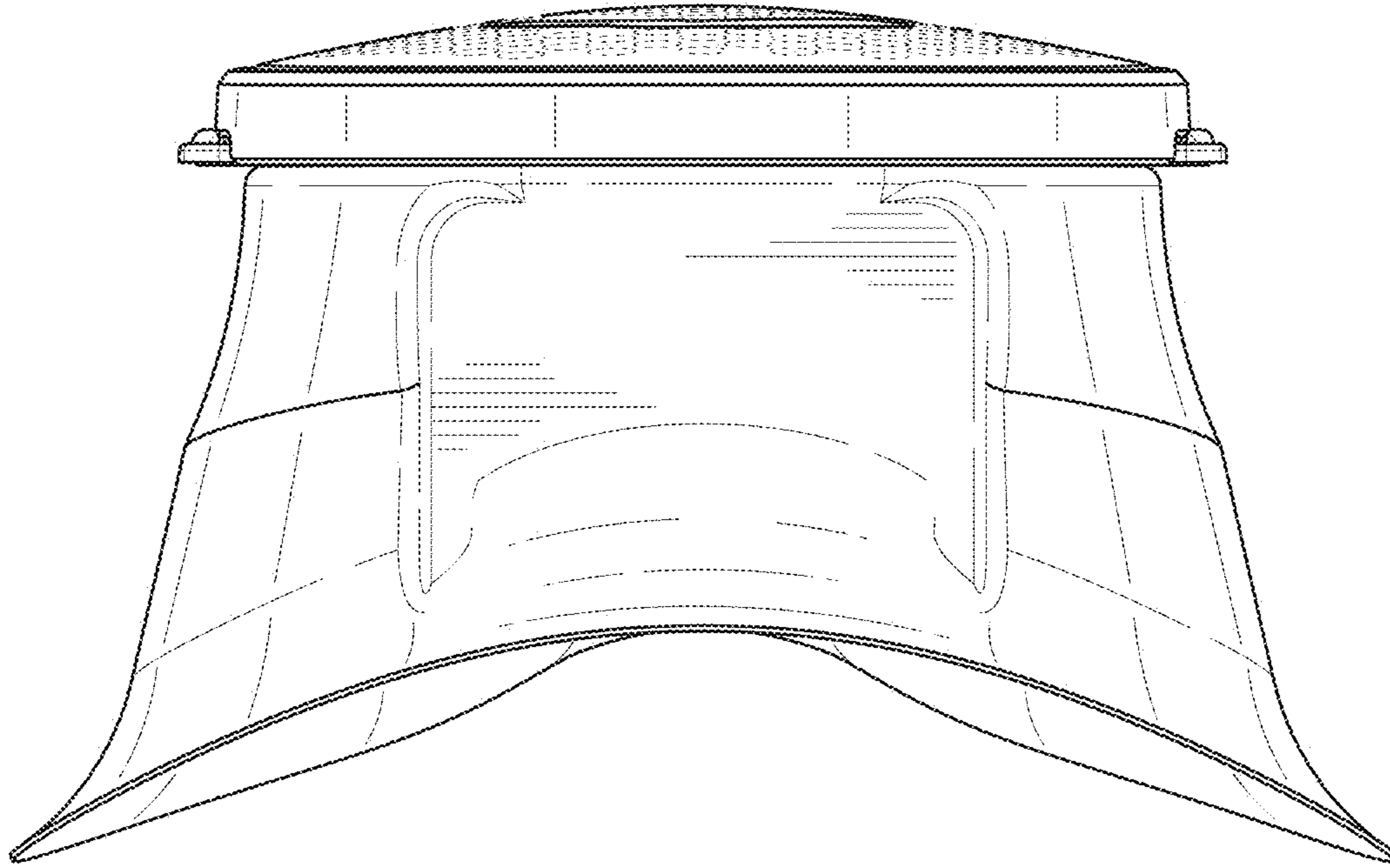

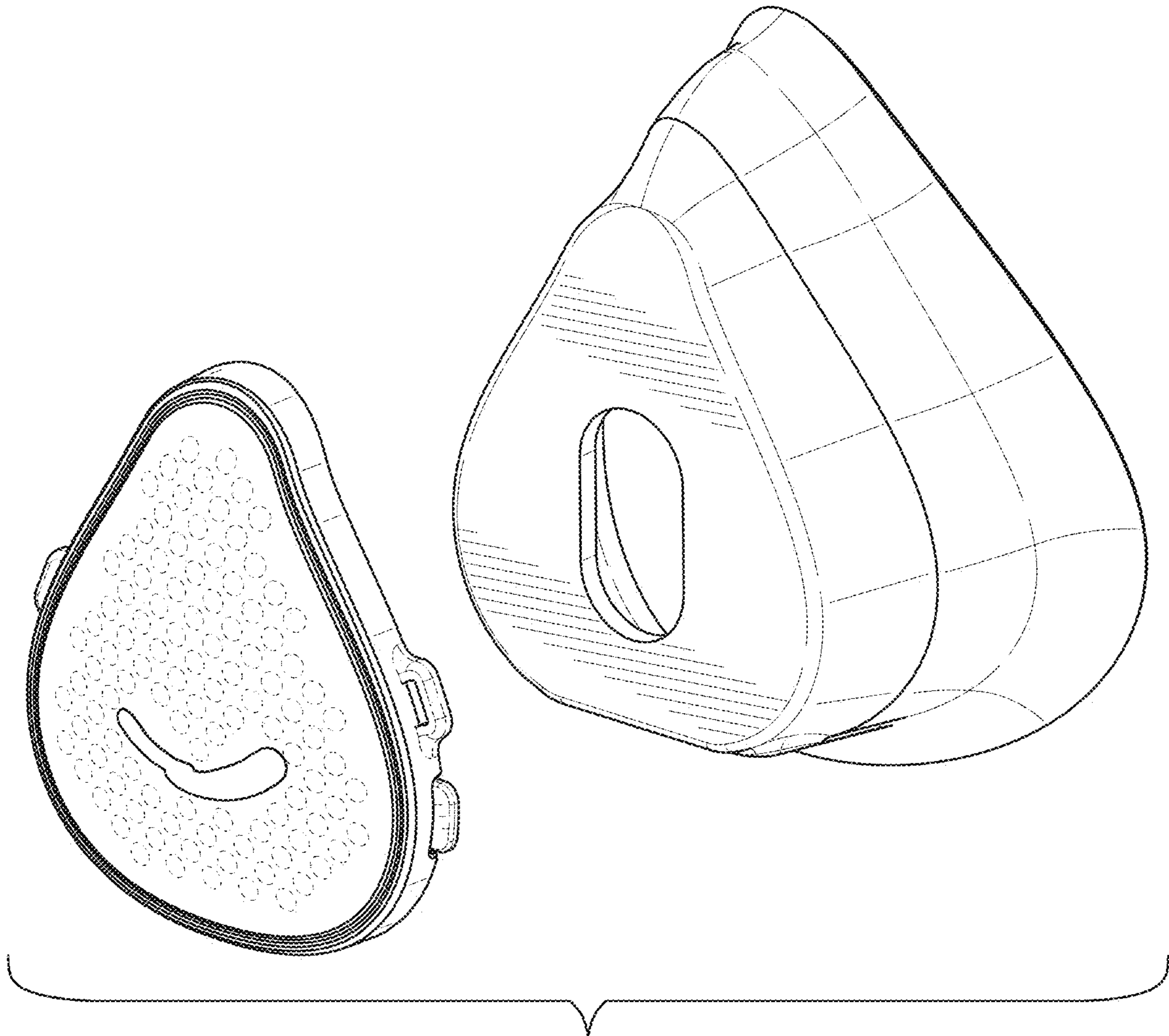
