(57) **CLAIM**

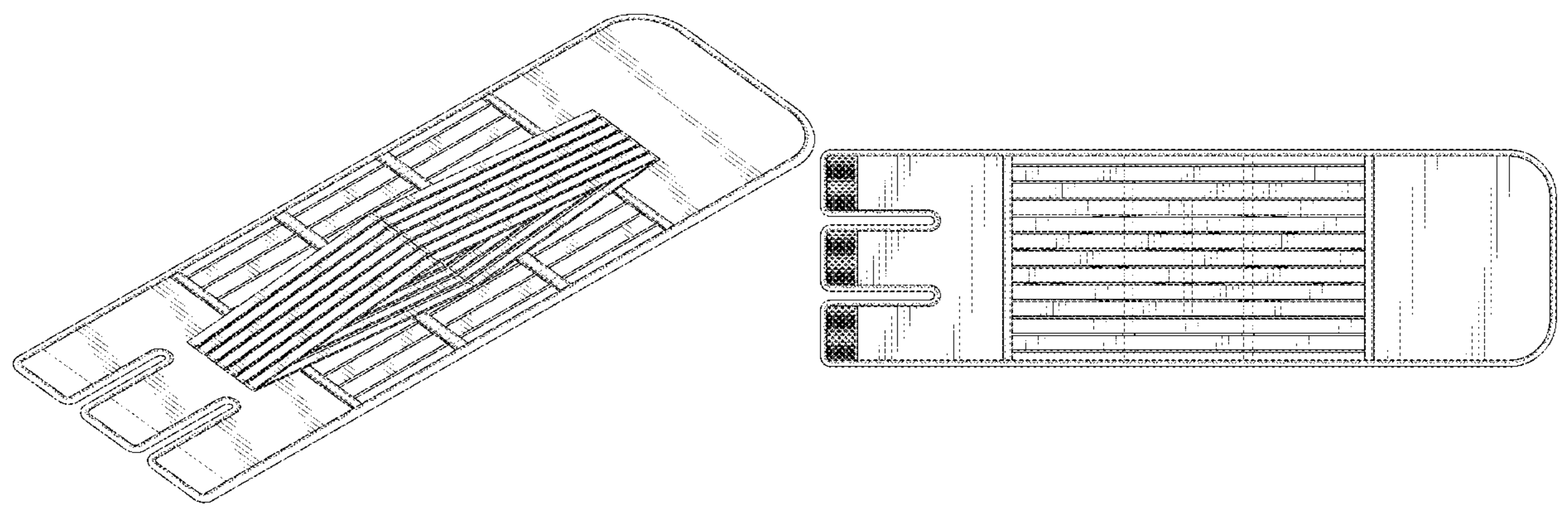
The ornamental design for a waist belt, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a waist belt, showing the new design;
FIG. 2 is a front elevational view of the waist belt thereof;
FIG. 3 is a rear elevational view of the waist belt thereof;
FIG. 4 is a right side elevational view of the waist belt thereof;
FIG. 5 is a left side elevational view of the waist belt thereof;
FIG. 6 is a top plan view of the waist belt thereof; and,
FIG. 7 is a bottom plan view of the waist belt thereof.
The broken lines in the figure views depict stitching, which does form a part of the claimed design.

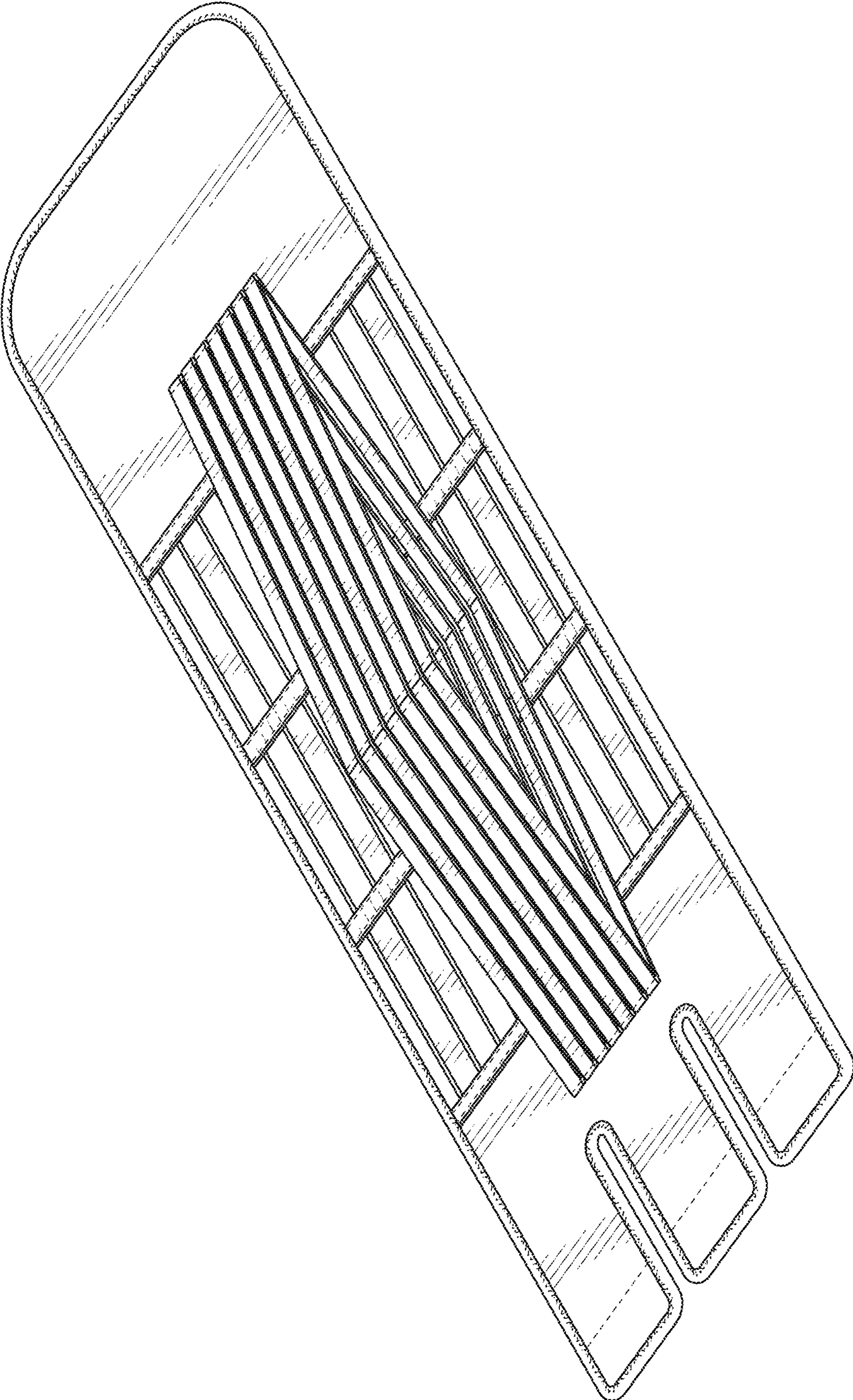

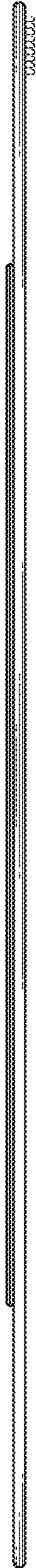

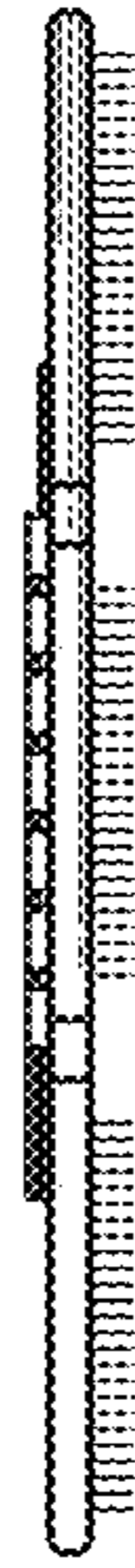

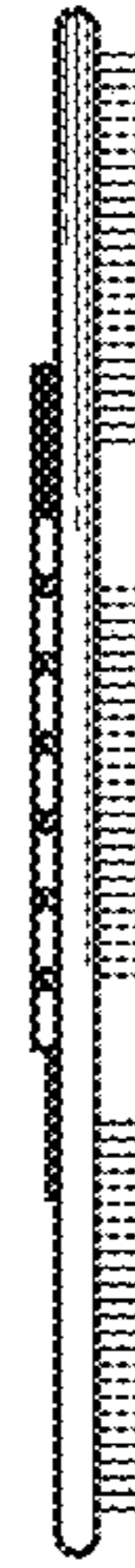

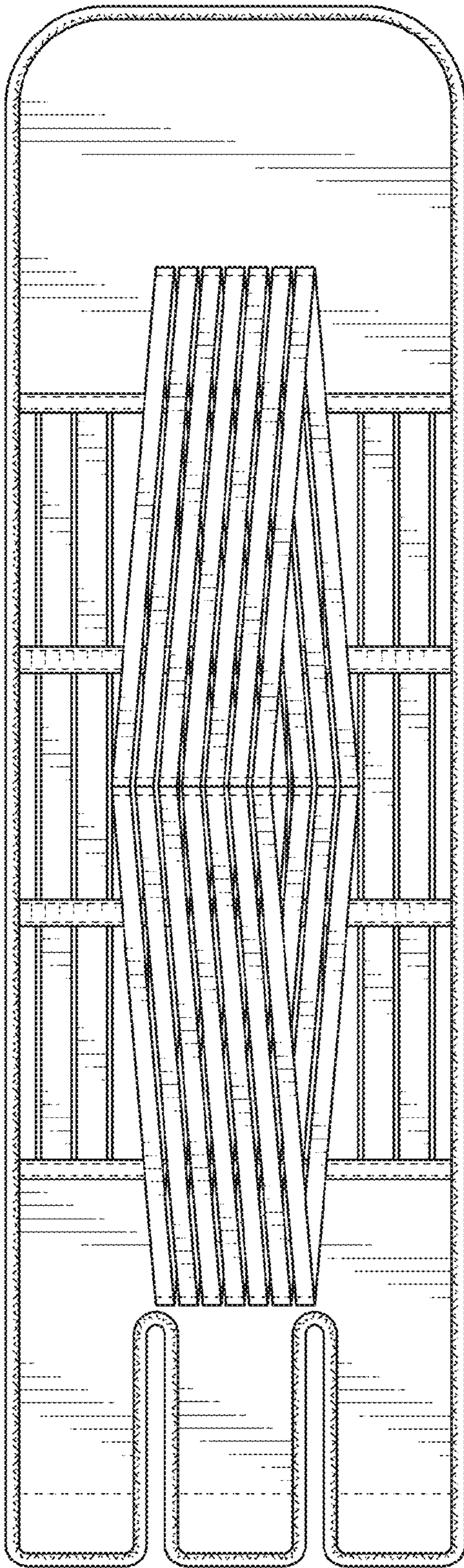

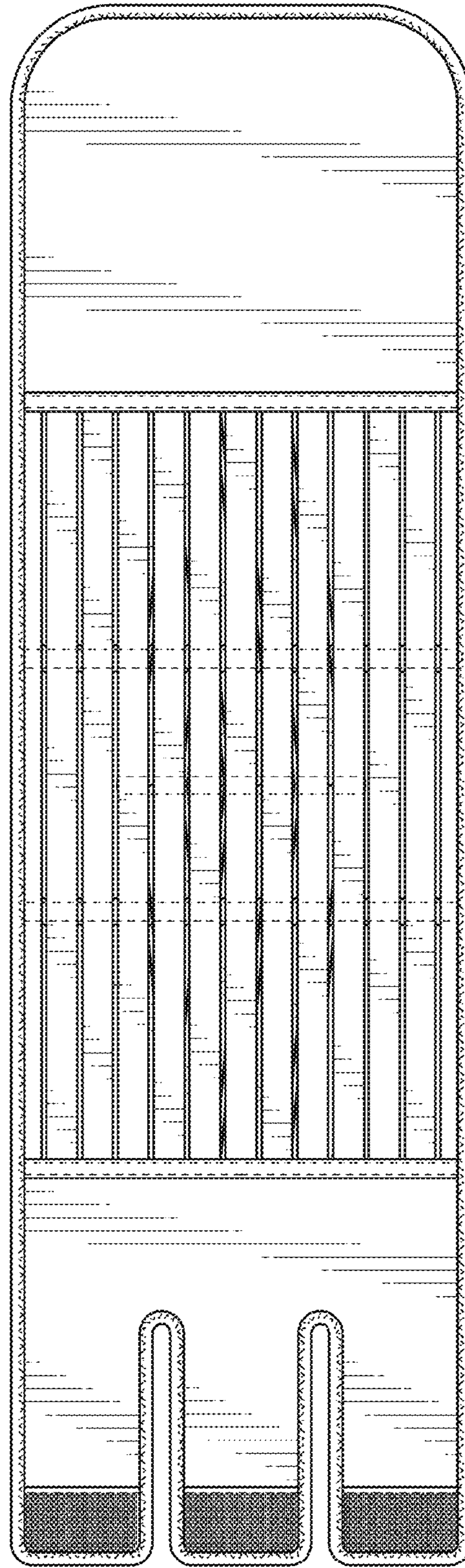
