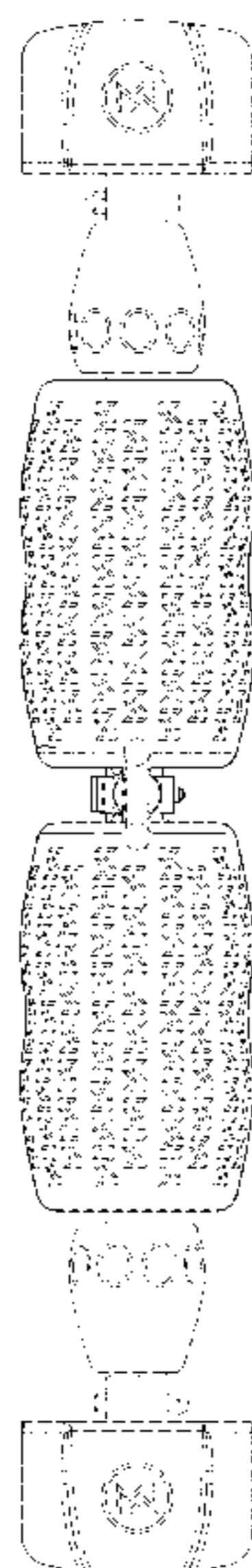
(57) **CLAIM**

The ornamental design of a door frame mounted massager, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a door frame mounted massager showing the new design;  
FIG. 2 is a rear view thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a left side view thereof; and,  
FIG. 7 is a rear perspective view thereof.

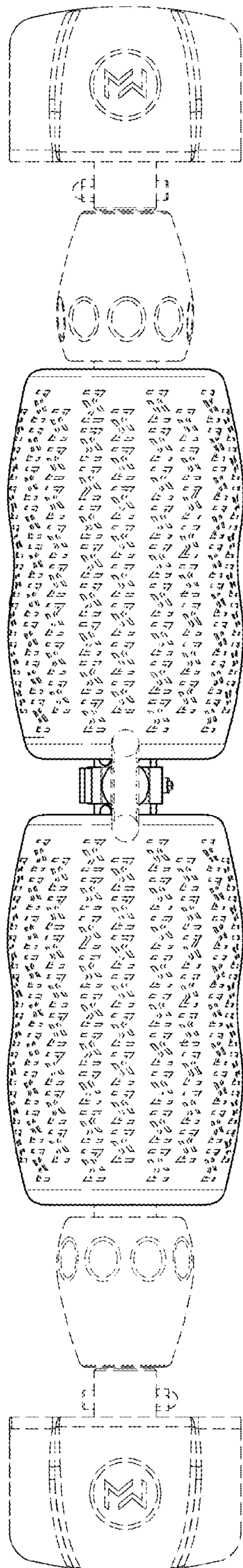

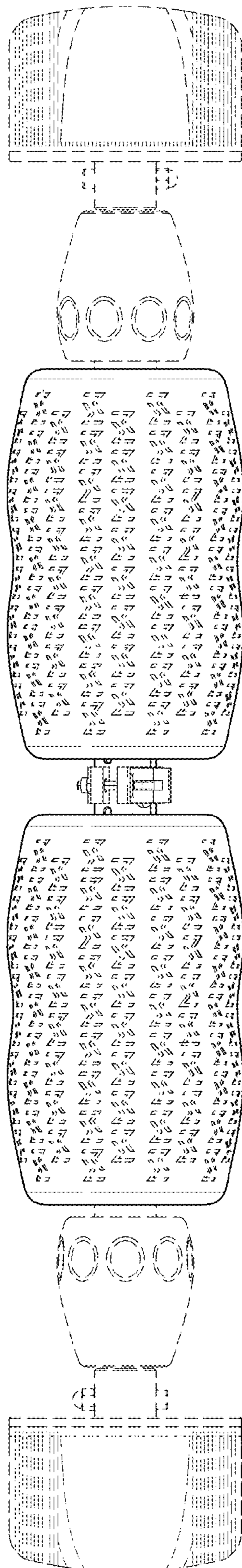

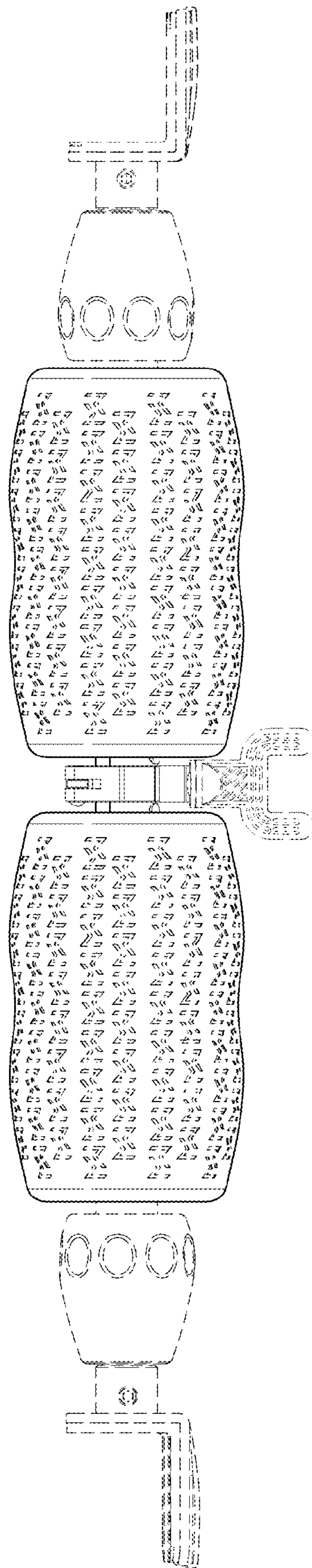

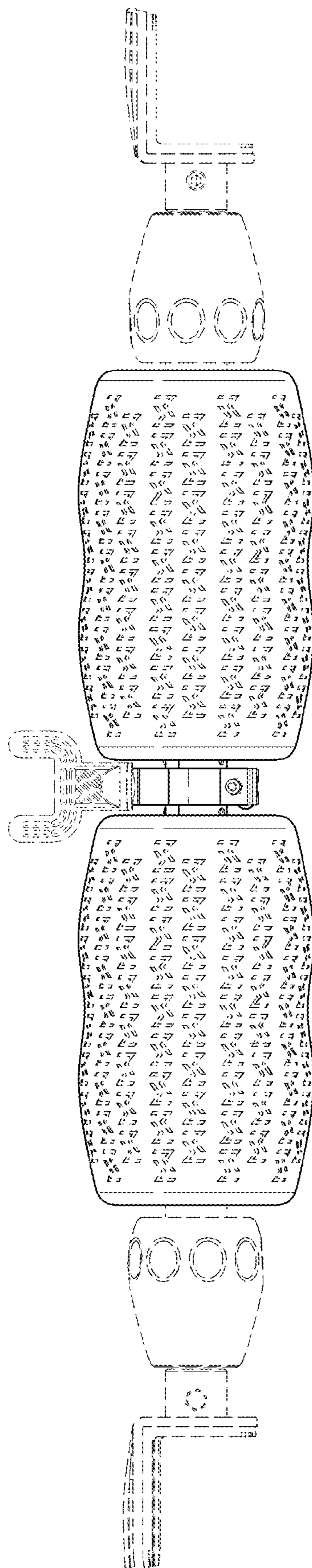
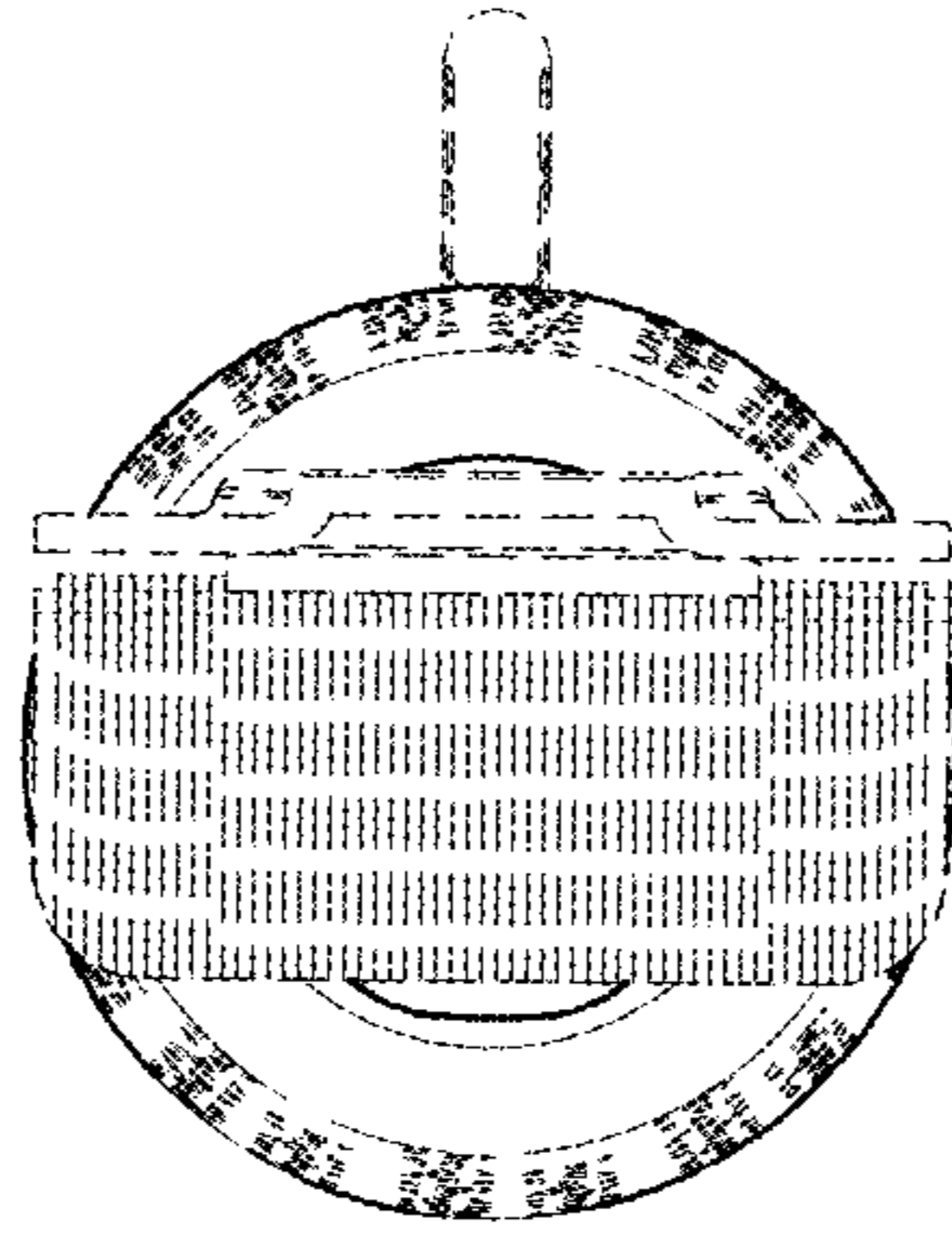
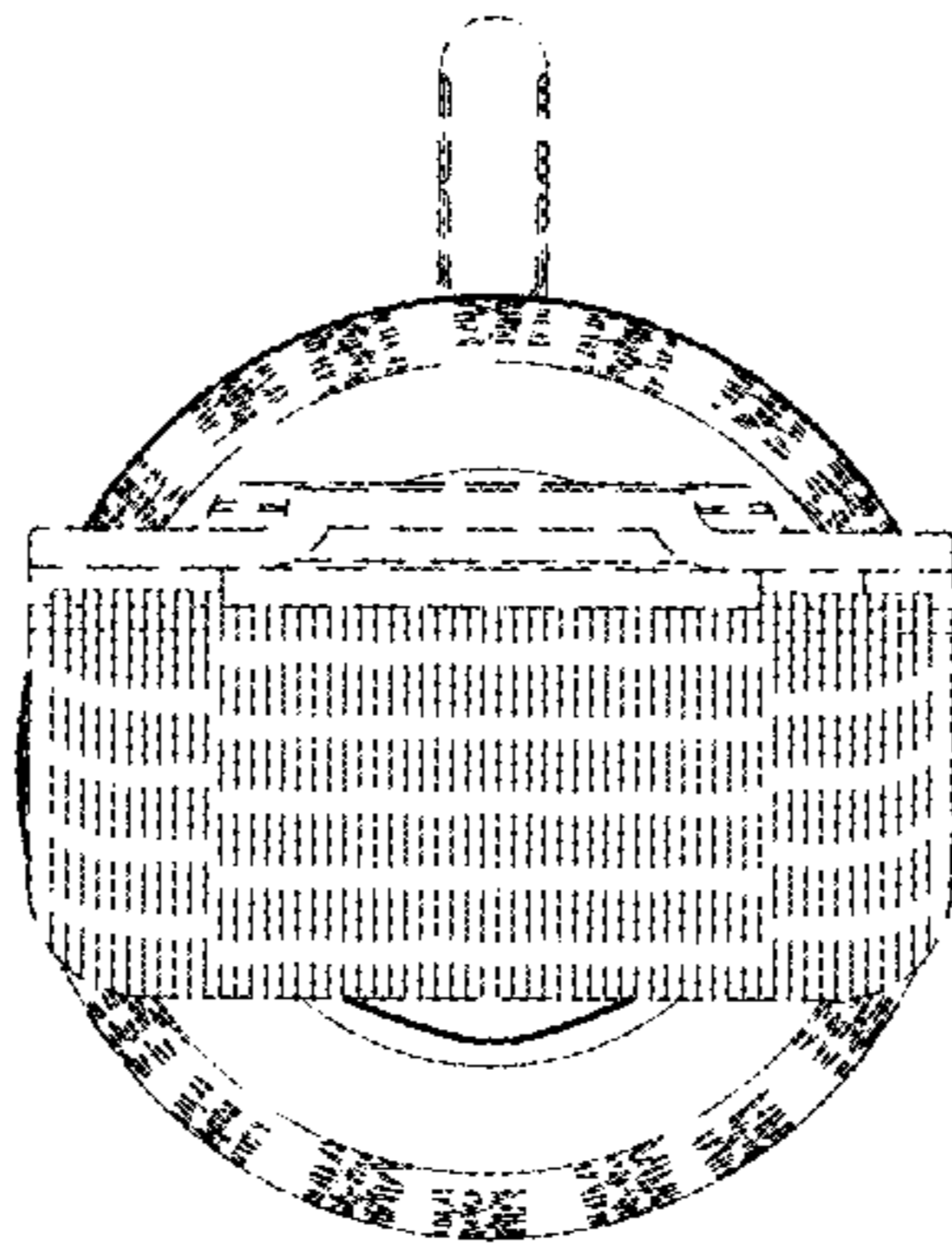

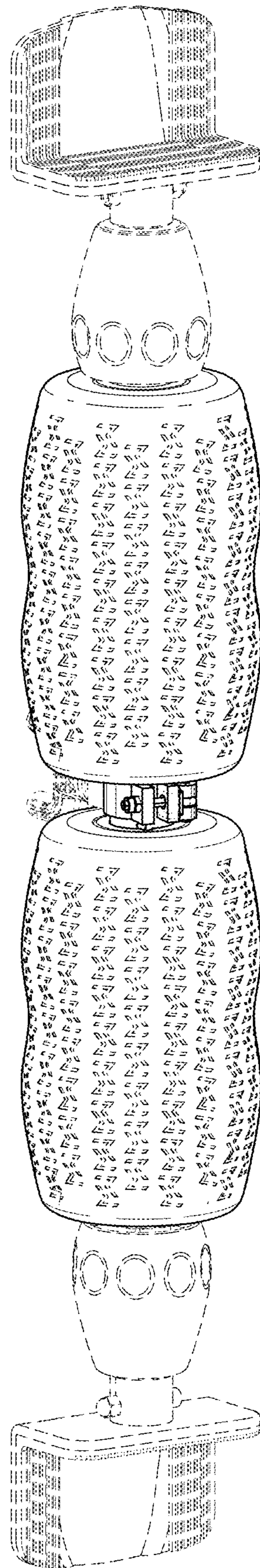
